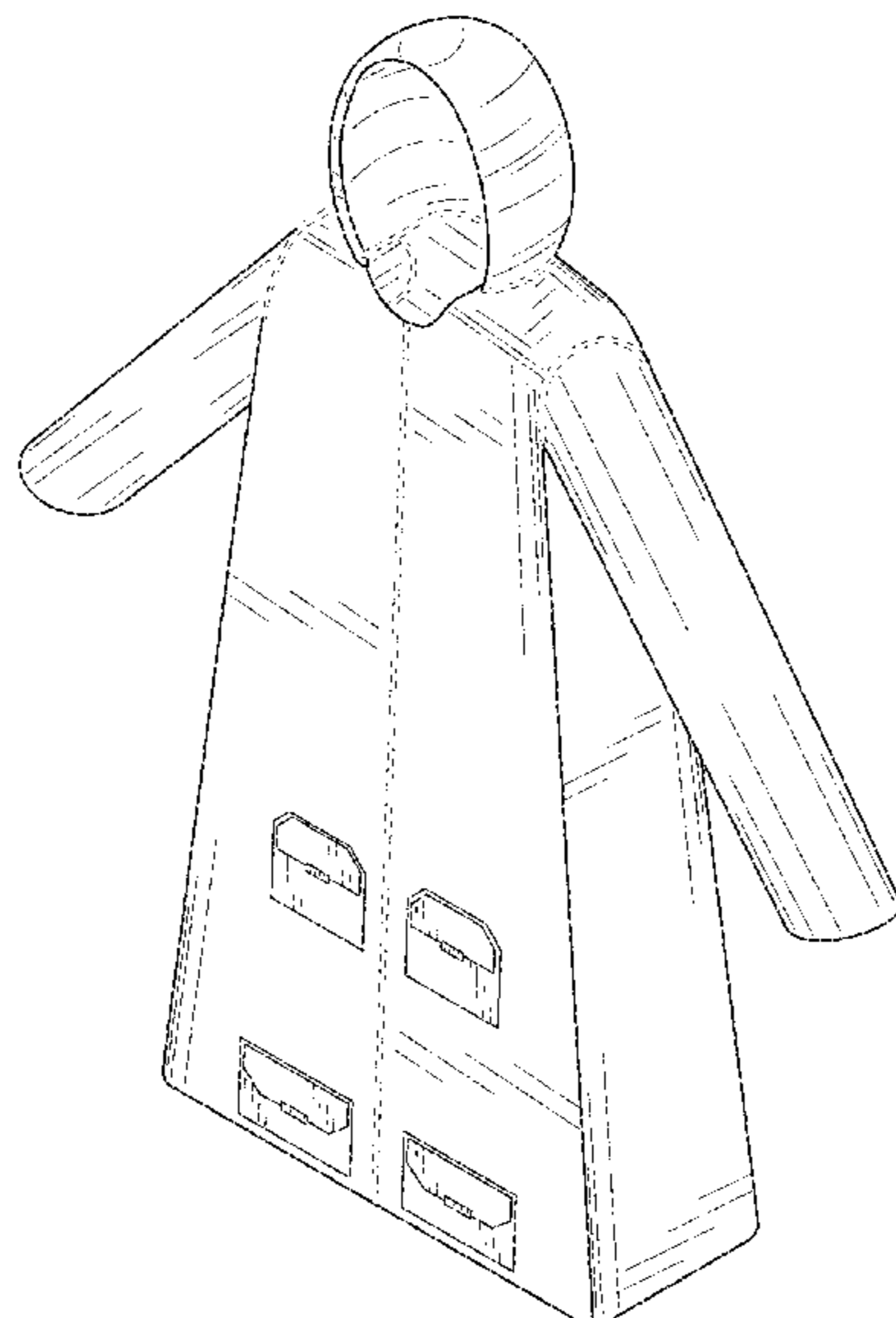
(57) **CLAIM**

The ornamental design for a combination article of clothing and sleeping bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top front left view of a combination article of clothing and sleeping bag, showing my new design;
FIG. 2 is a perspective top rear right view thereof;
FIG. 3 is a front elevation view thereof,
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a right elevation view thereof, with a left elevation view being a mirror image thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines represent the boundary area of unclaimed fasteners such as zippers and form no part of the claimed design.

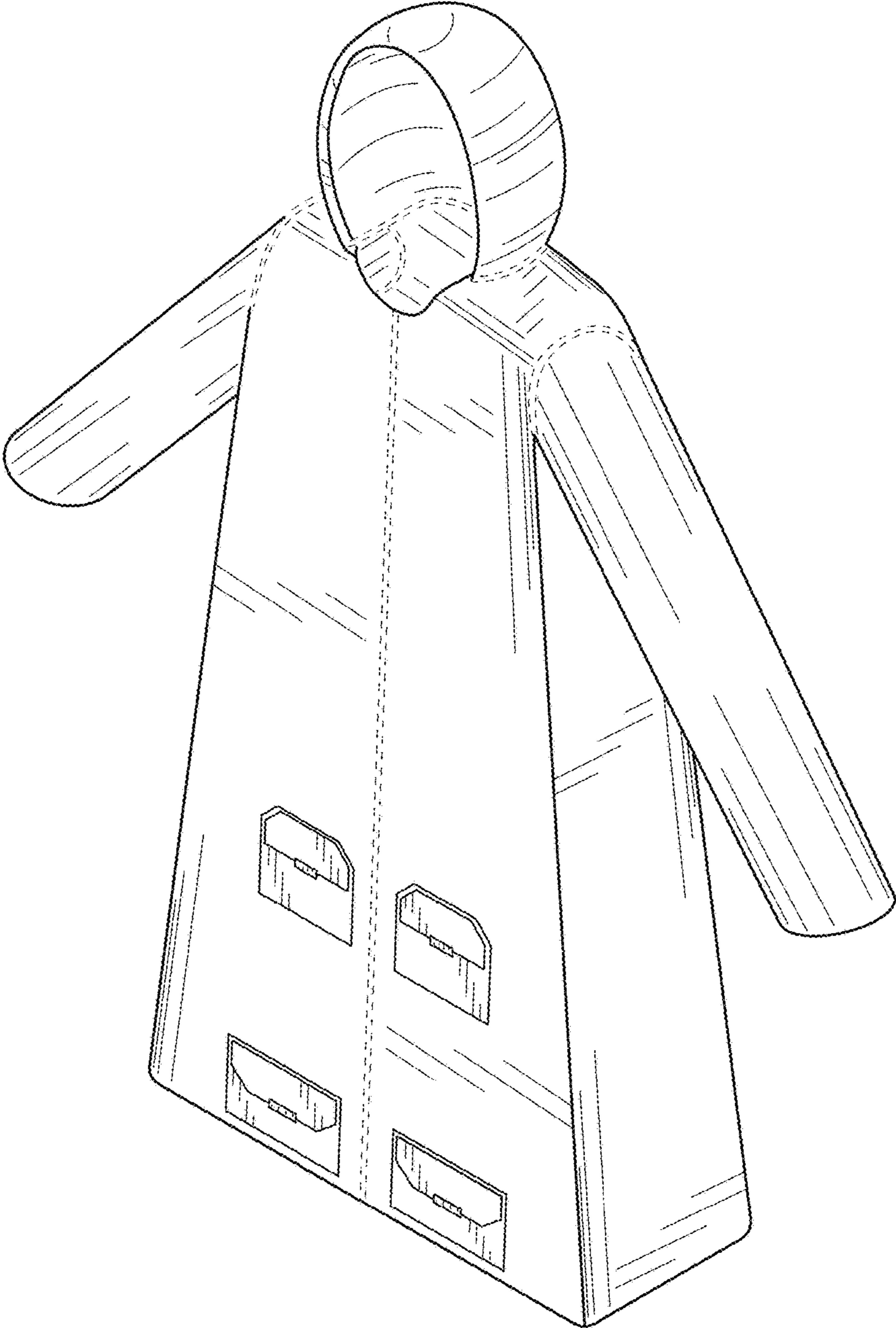

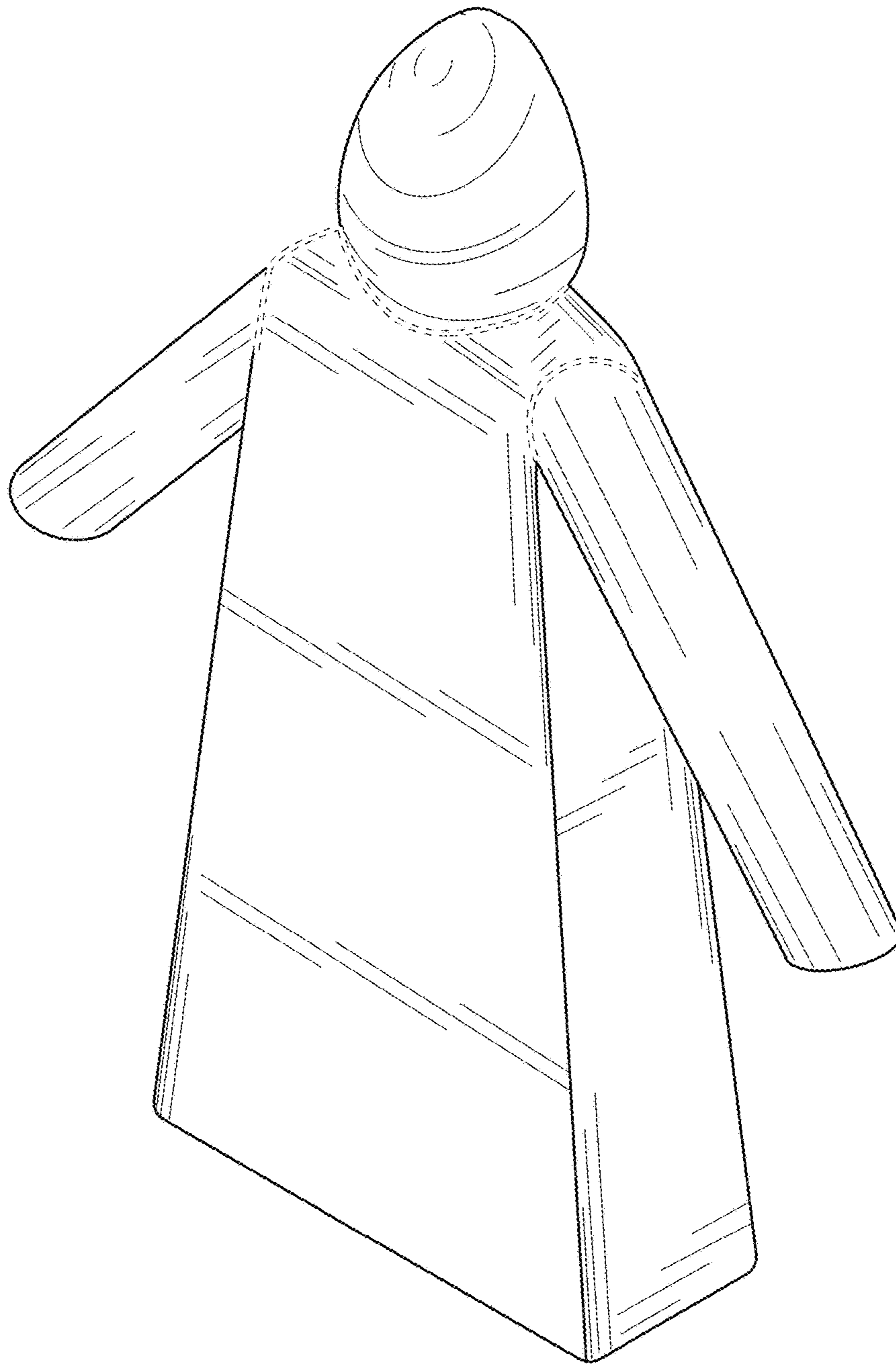

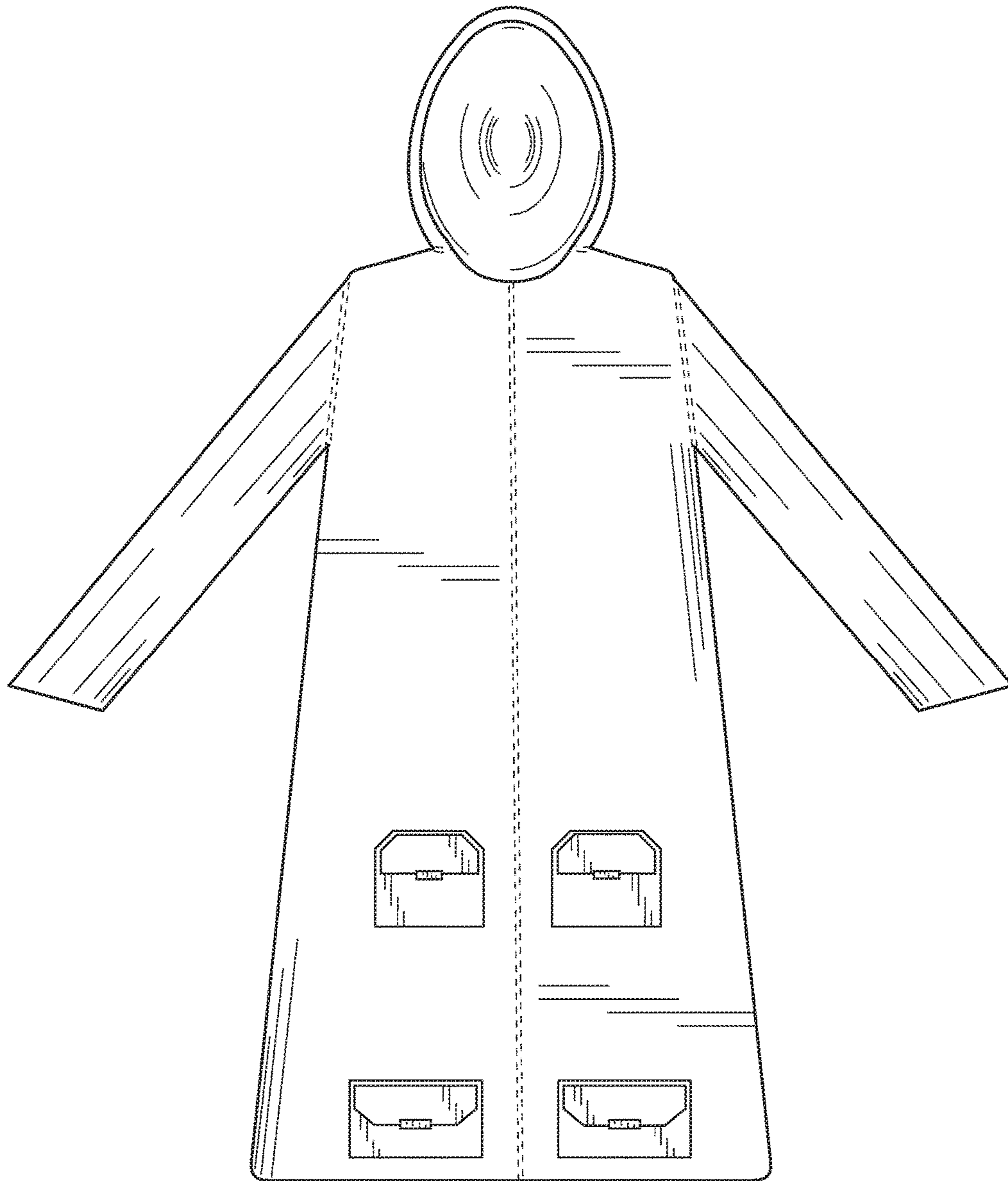

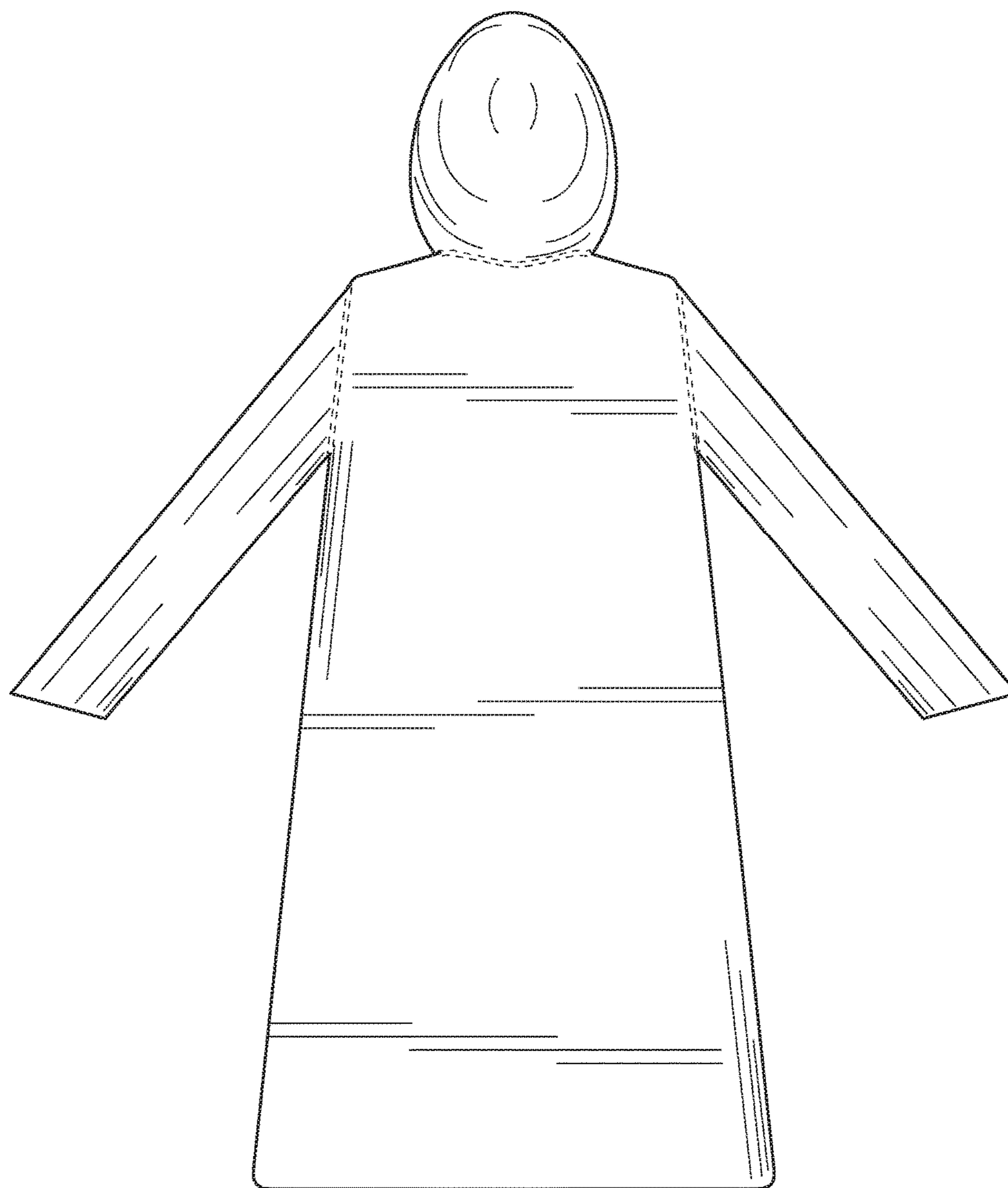

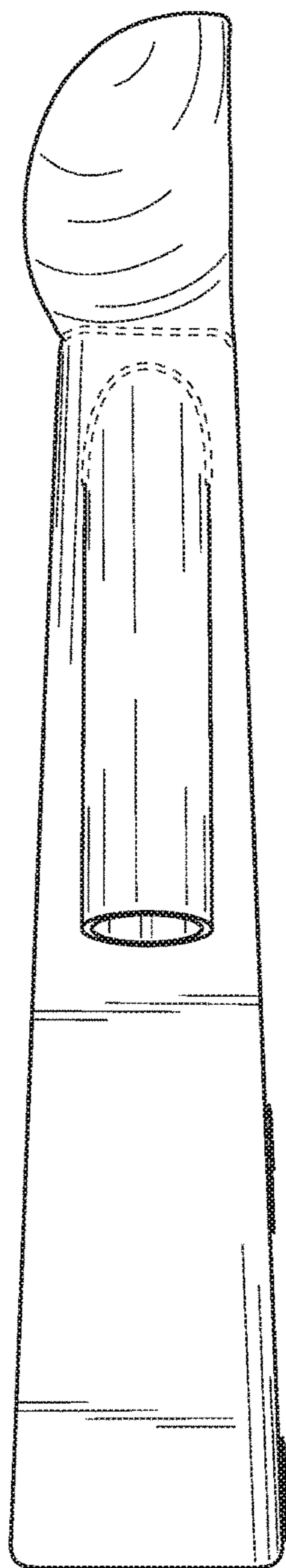

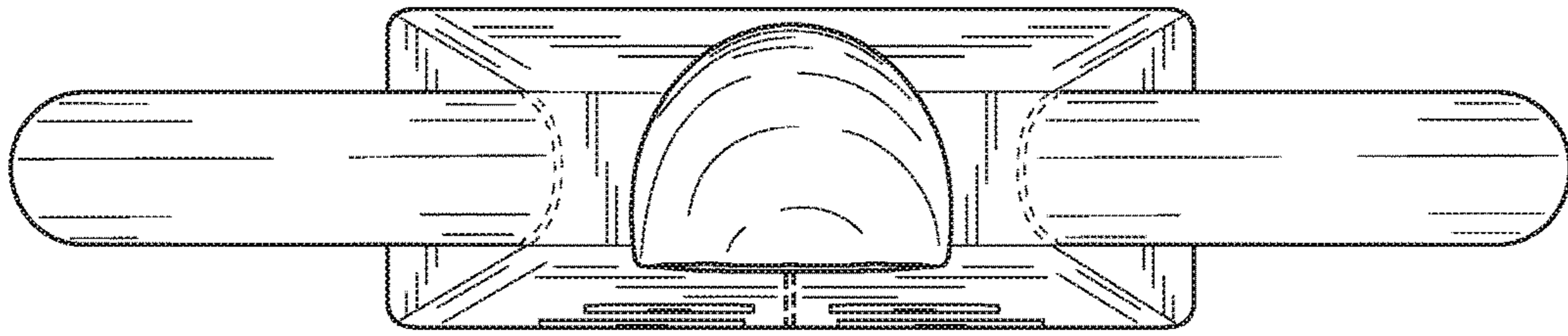

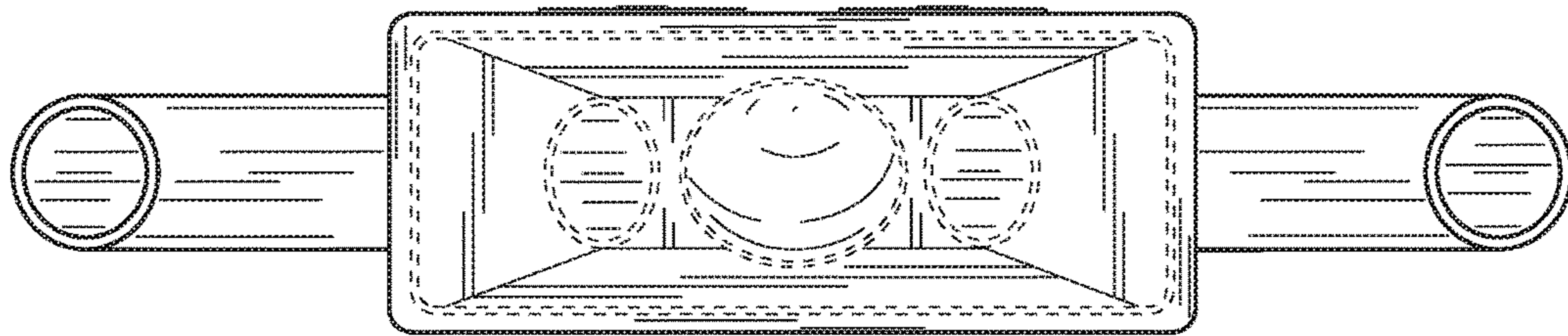
