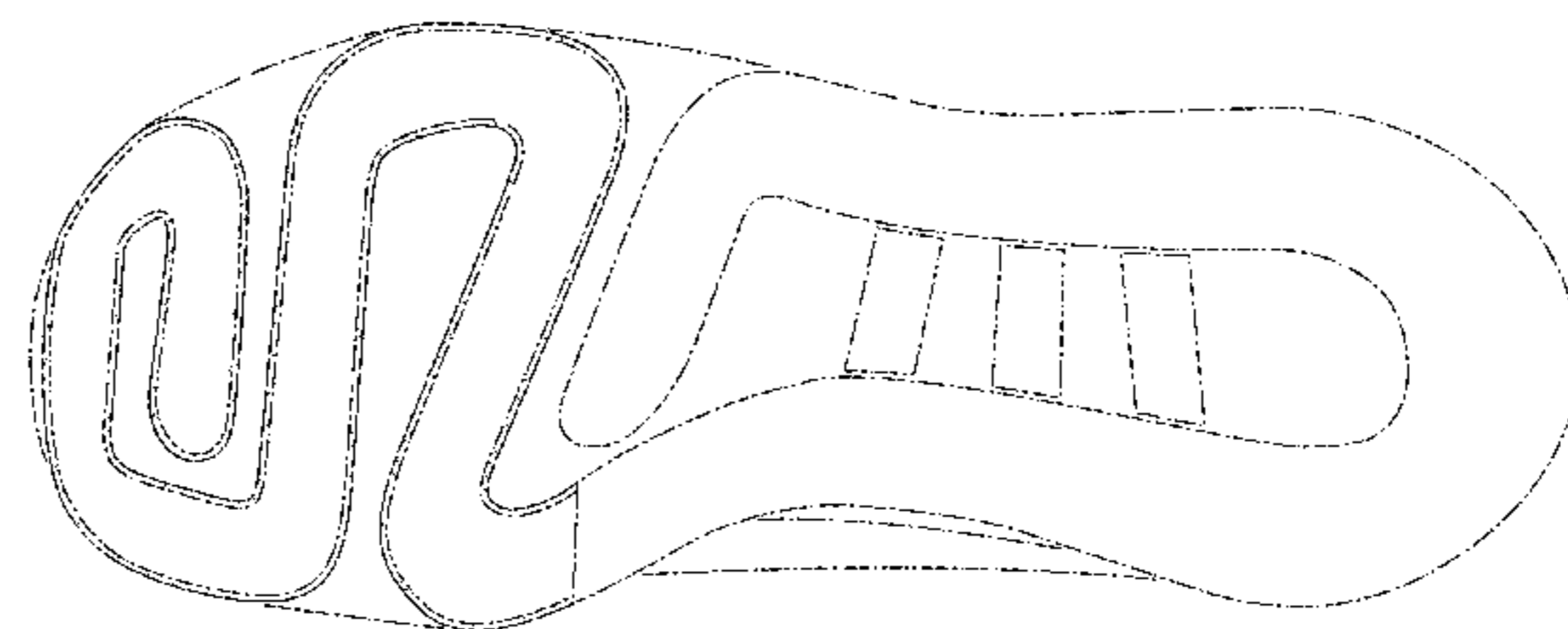
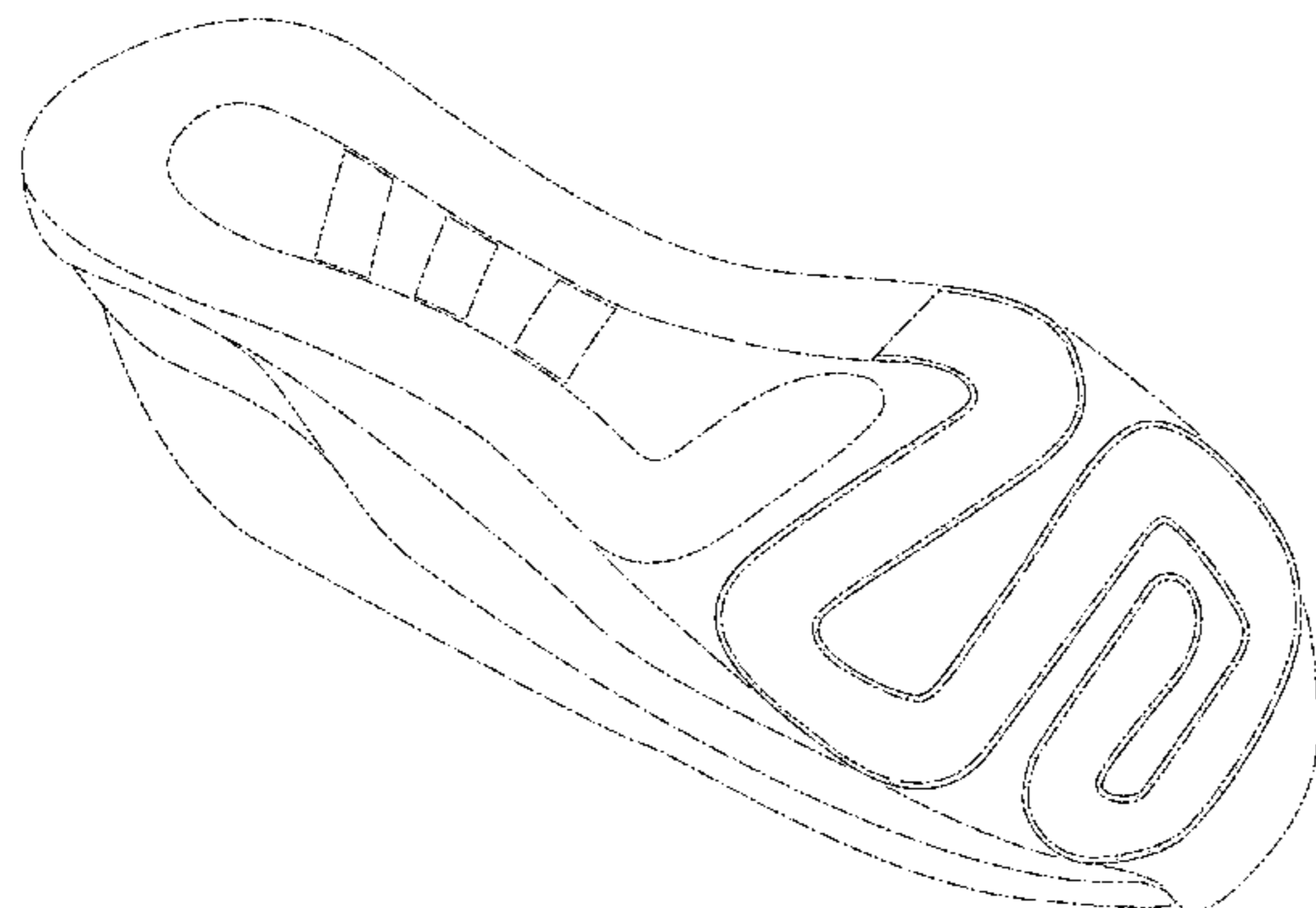
The ornamental design for a shoe outsole, as shown and

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe outsole showing  
our new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is an opposite side front perspective view thereof;  
and,  
FIG. 5 is an opposite side rear perspective view thereof.

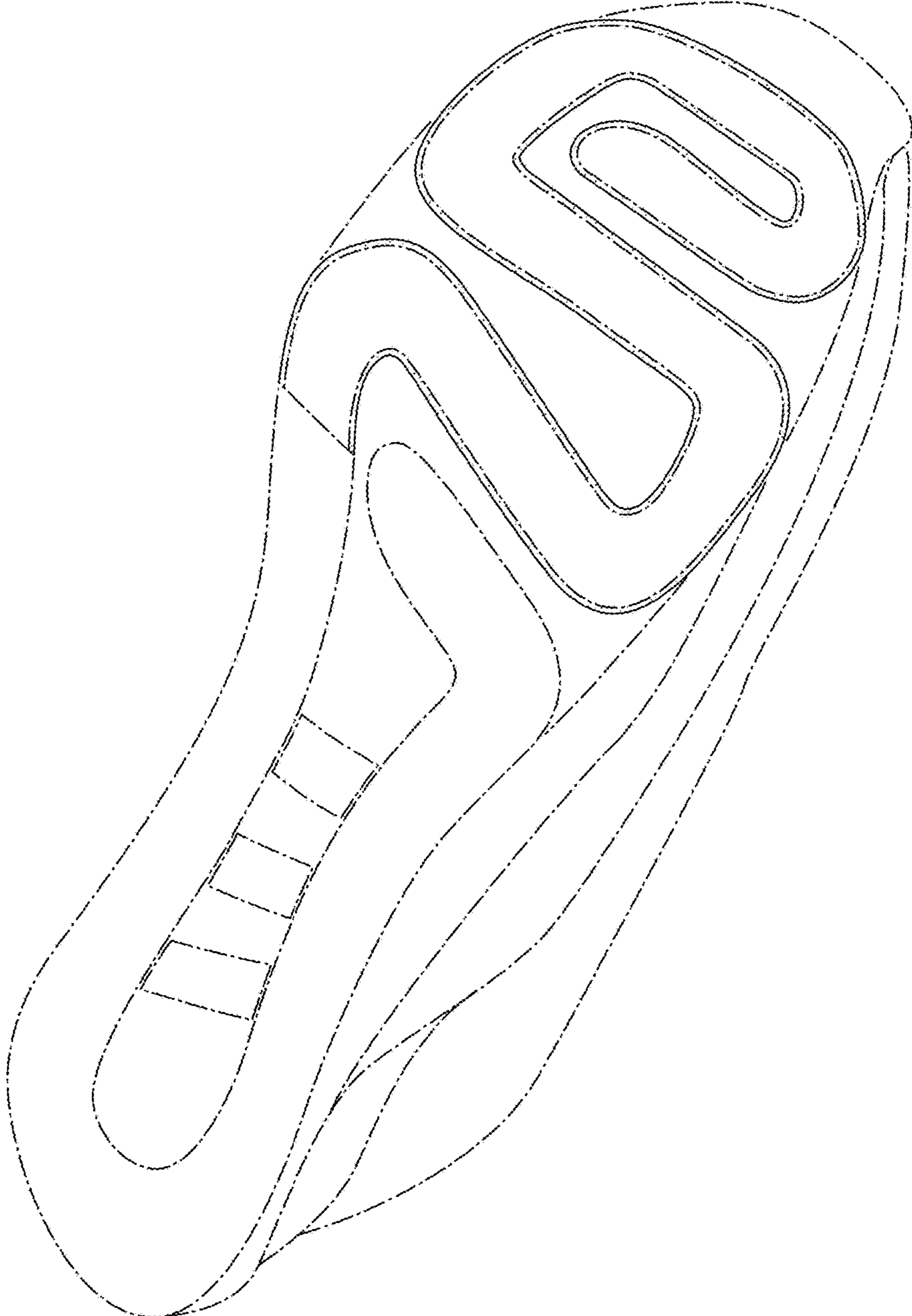

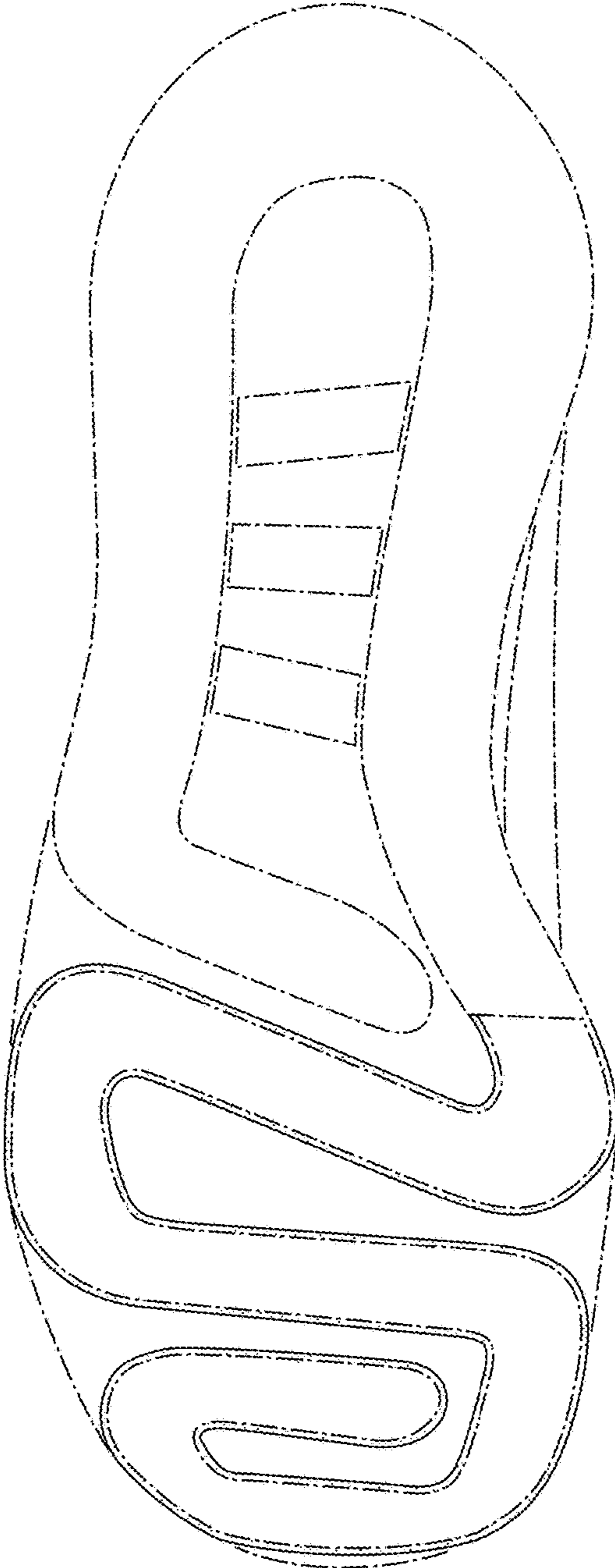

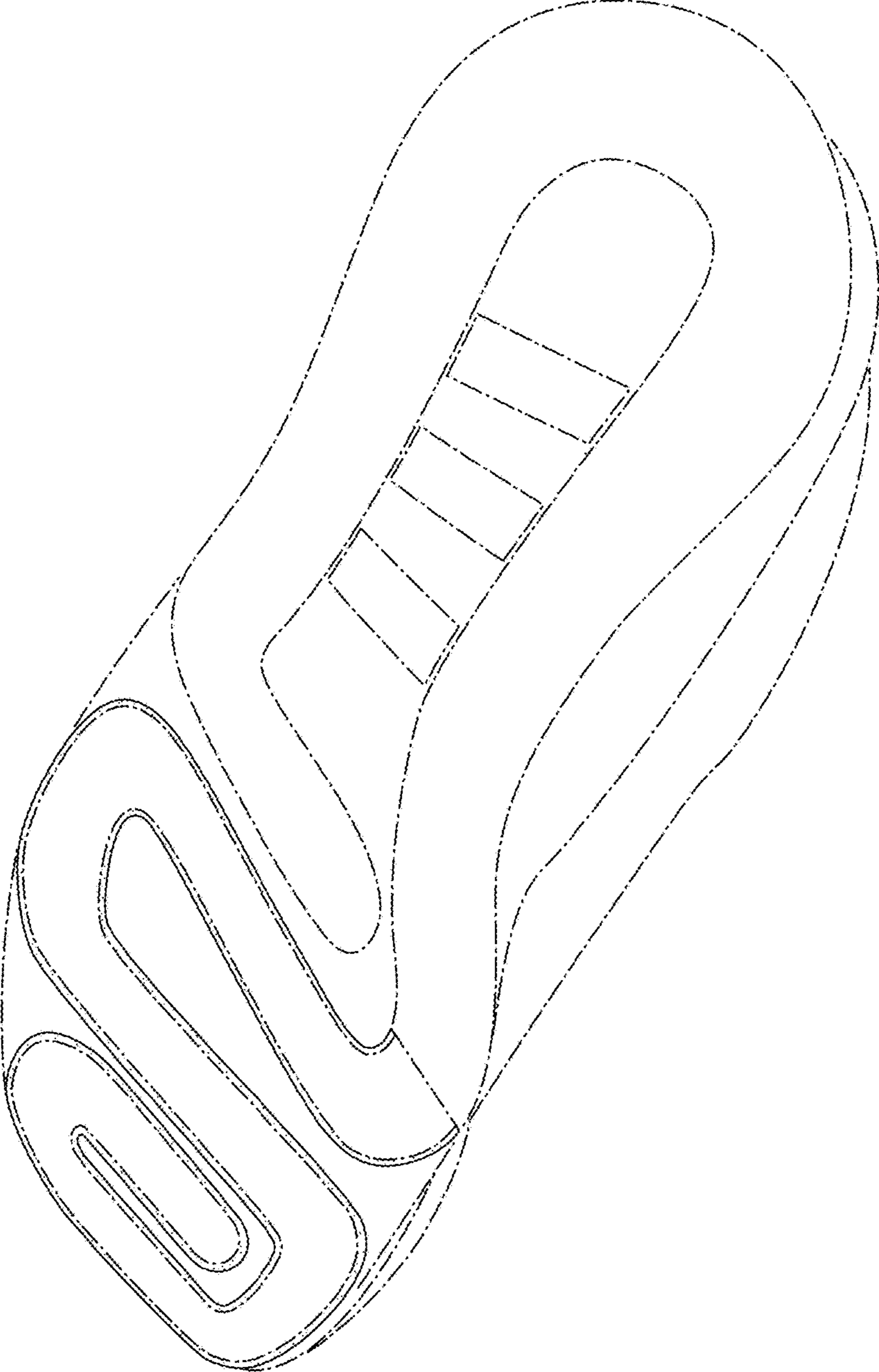

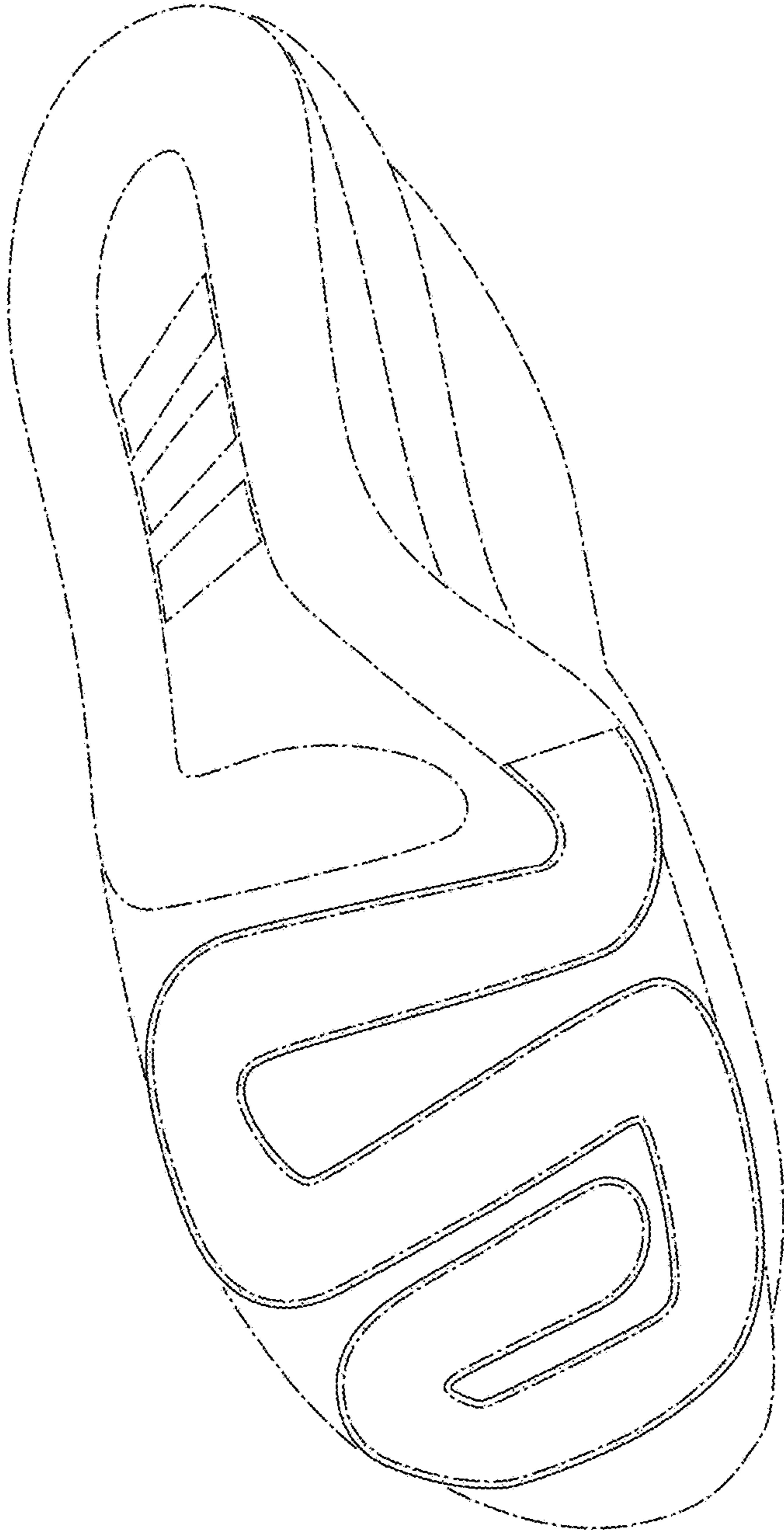

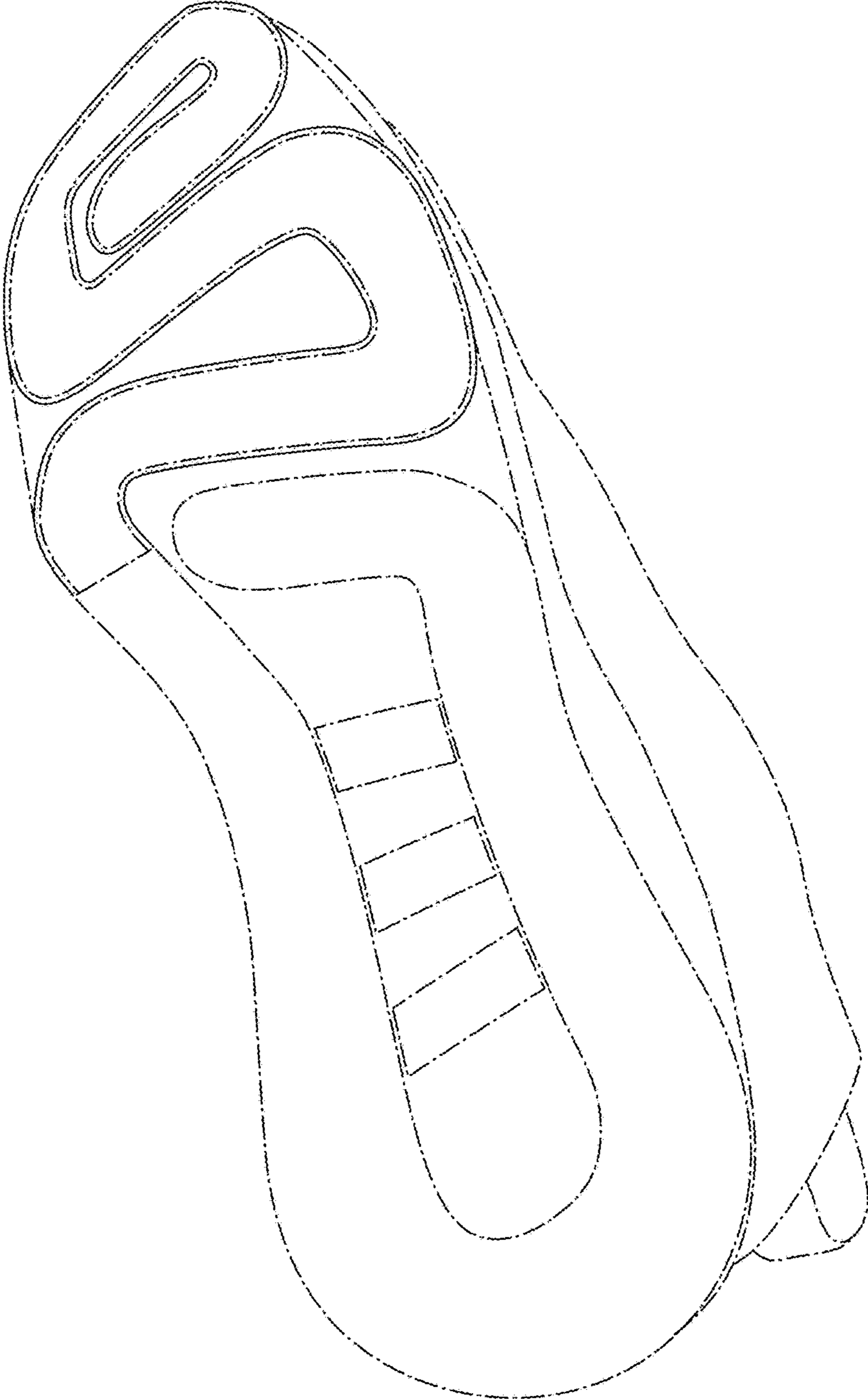
