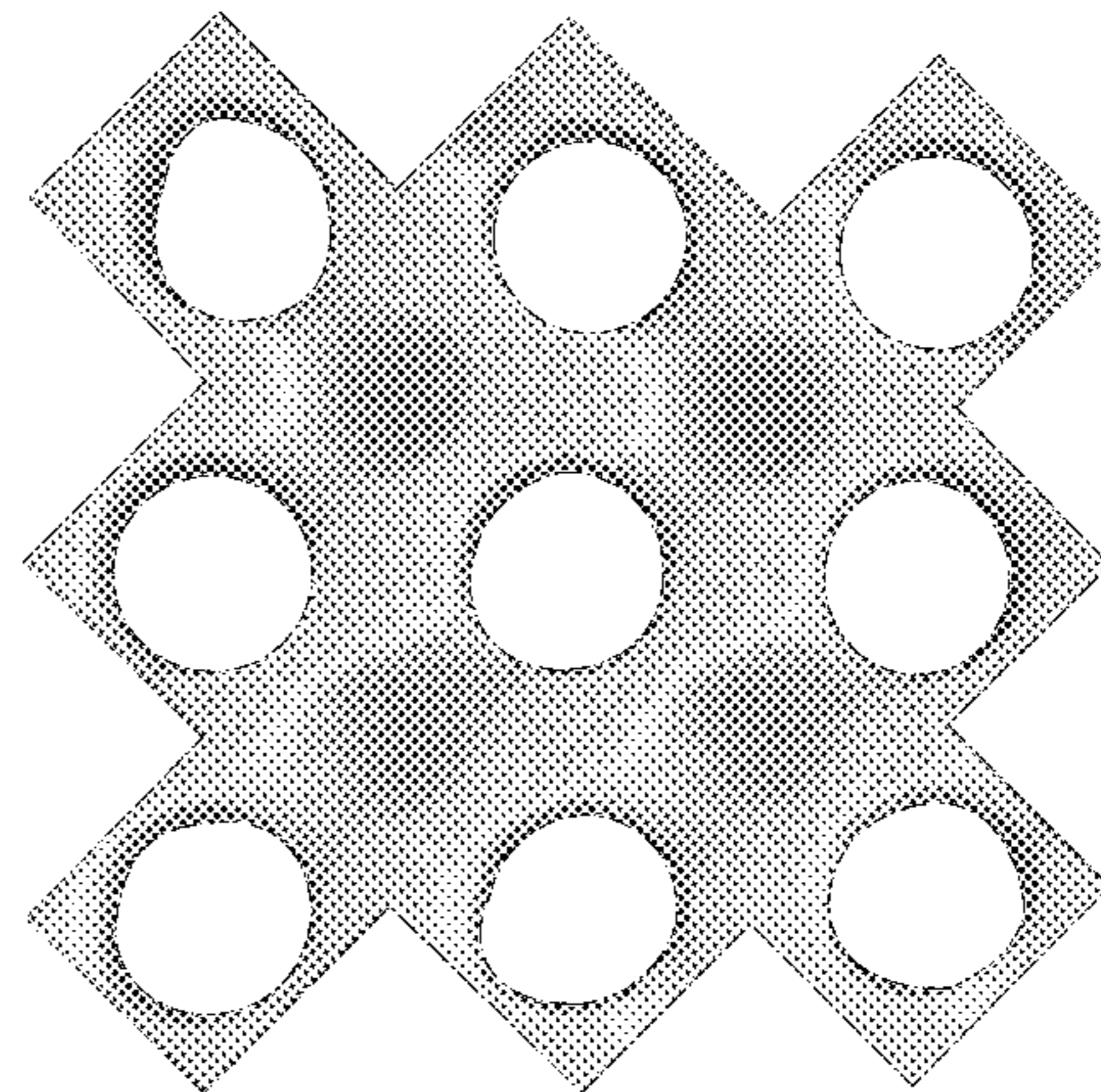
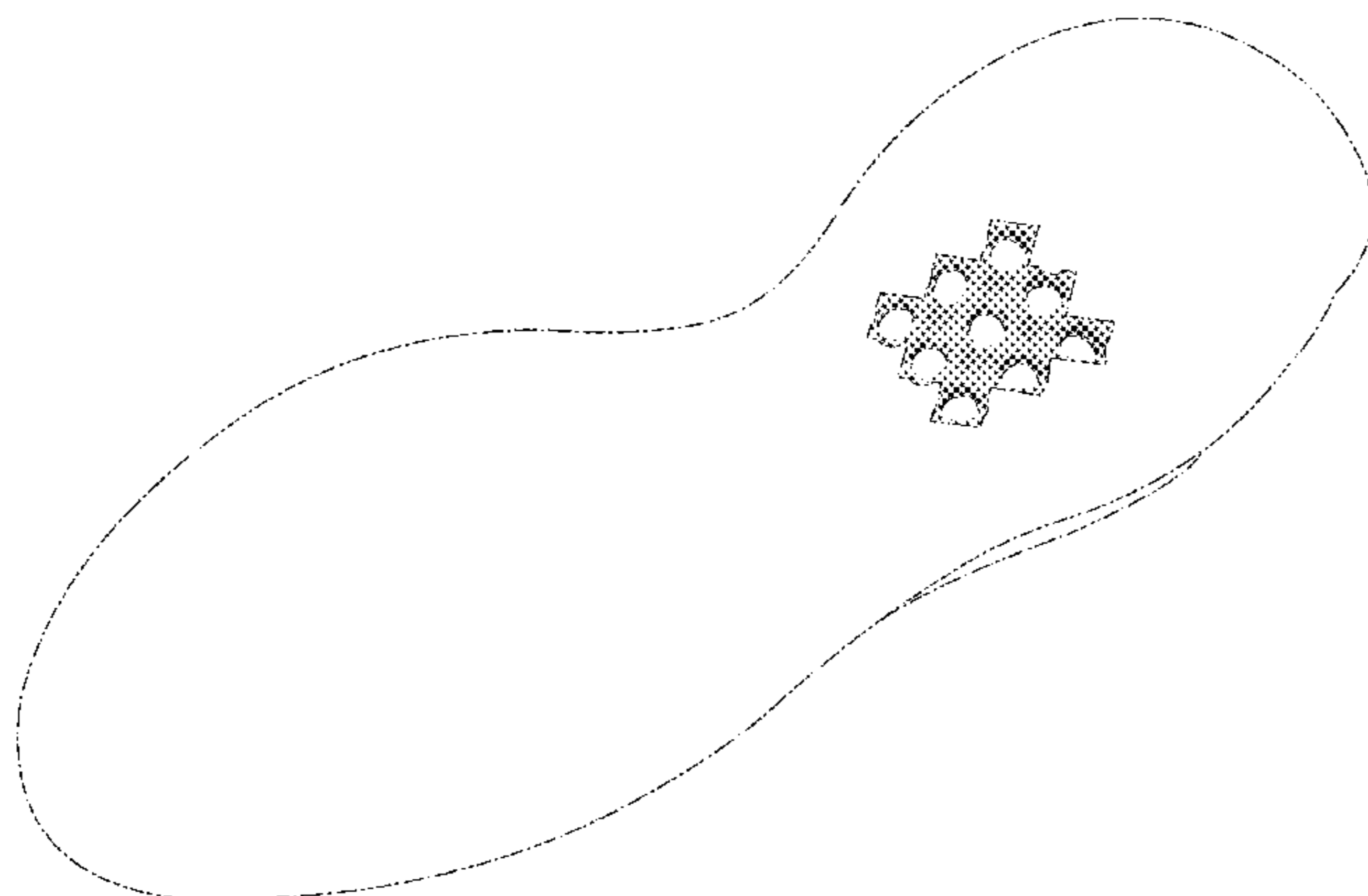
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing our new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is an enlarged partial view of FIG. 1; and,  
FIG. 5 is an enlarged partial view of FIG. 2.  
The broken lines immediately adjacent to the photographic area define the bounds of the claimed design and form no part thereof. The unshaded regions within the photographic area that are demarcated by broken lines form no part of the claimed design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

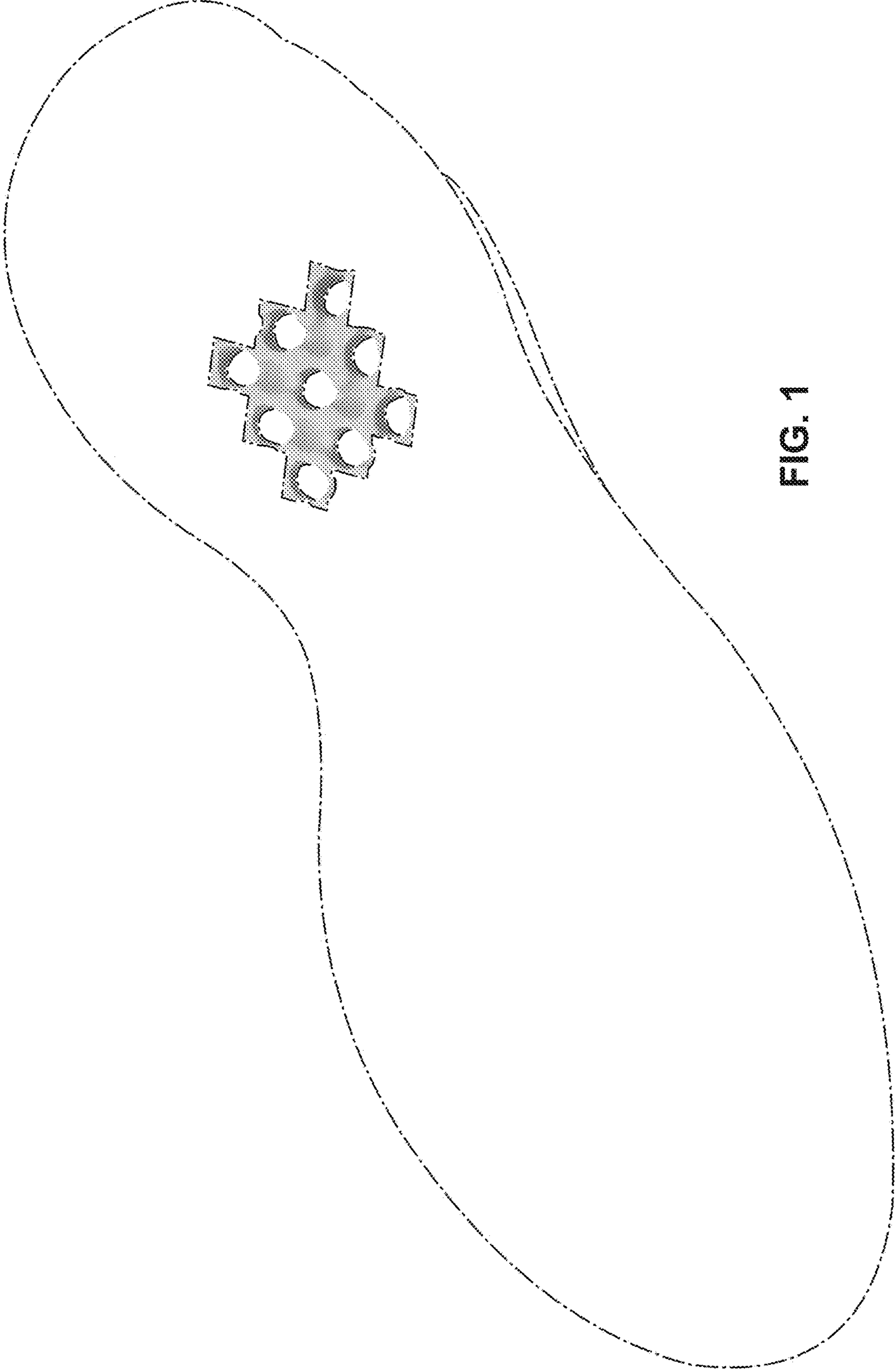

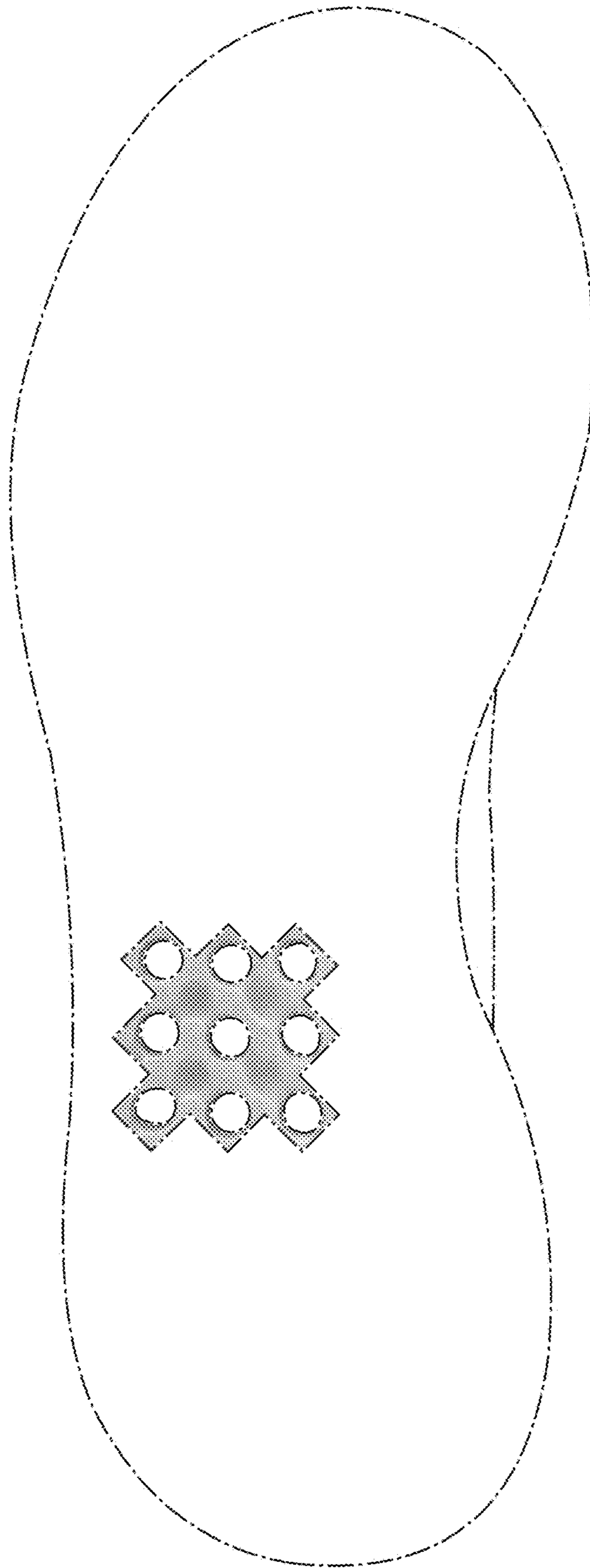

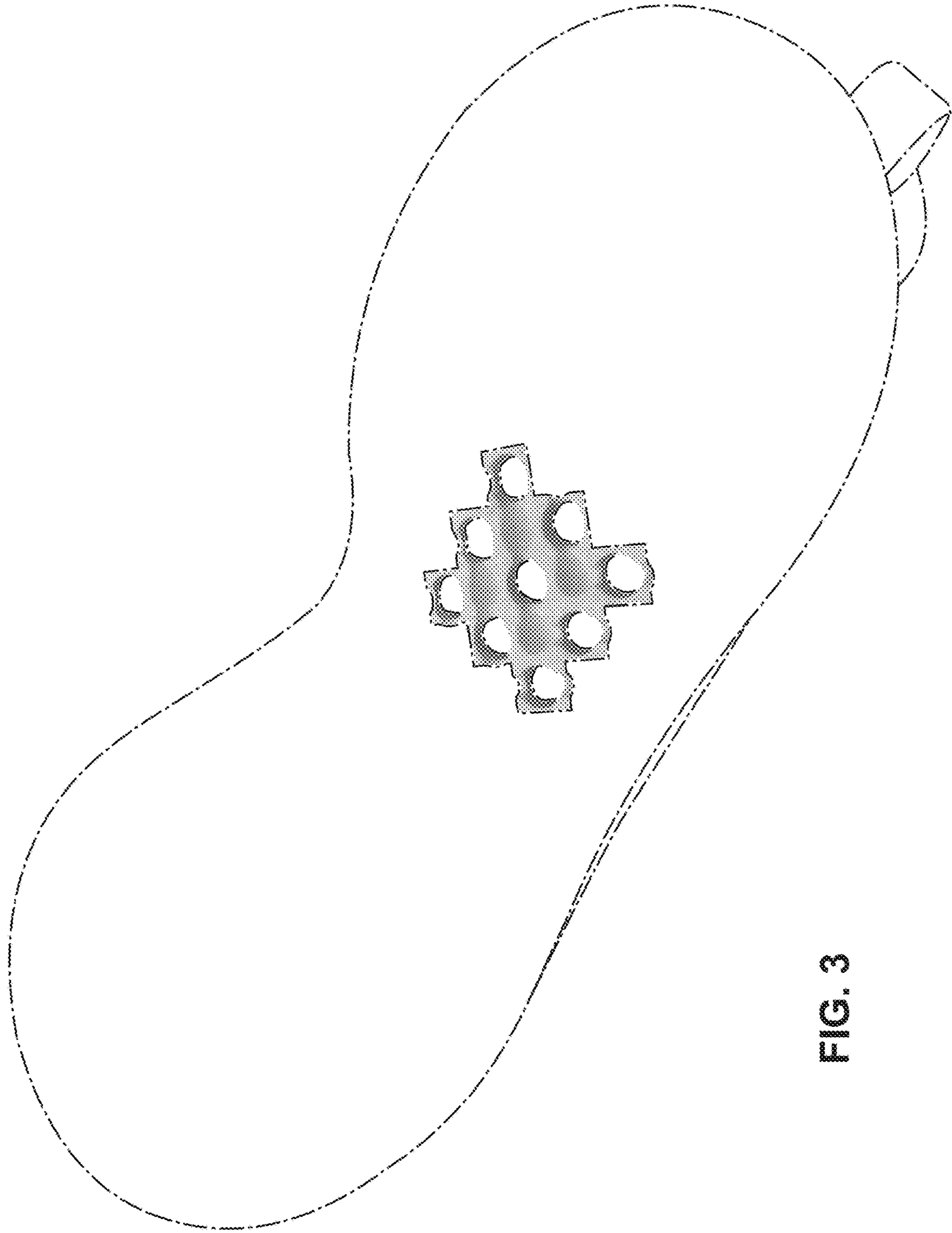
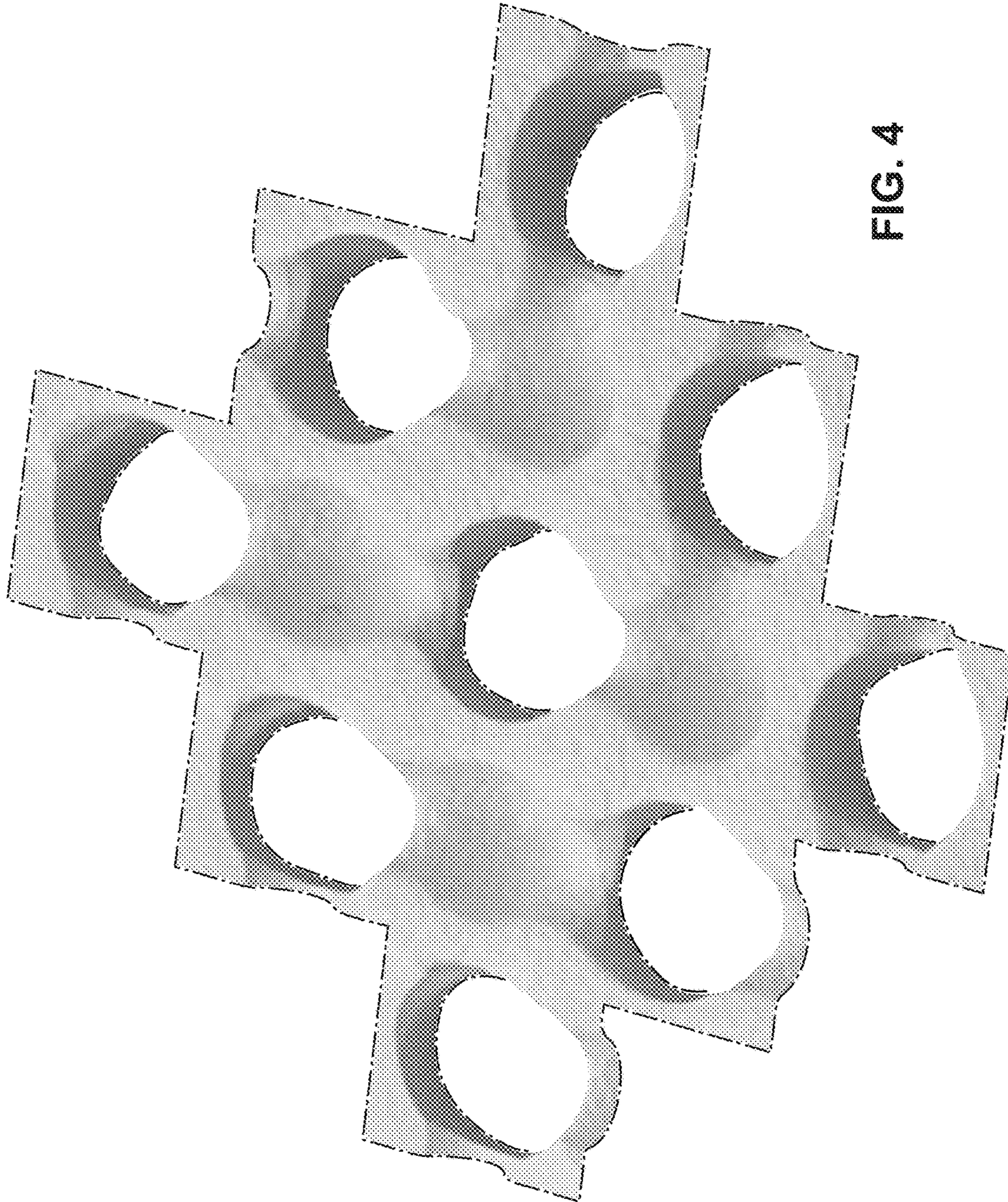

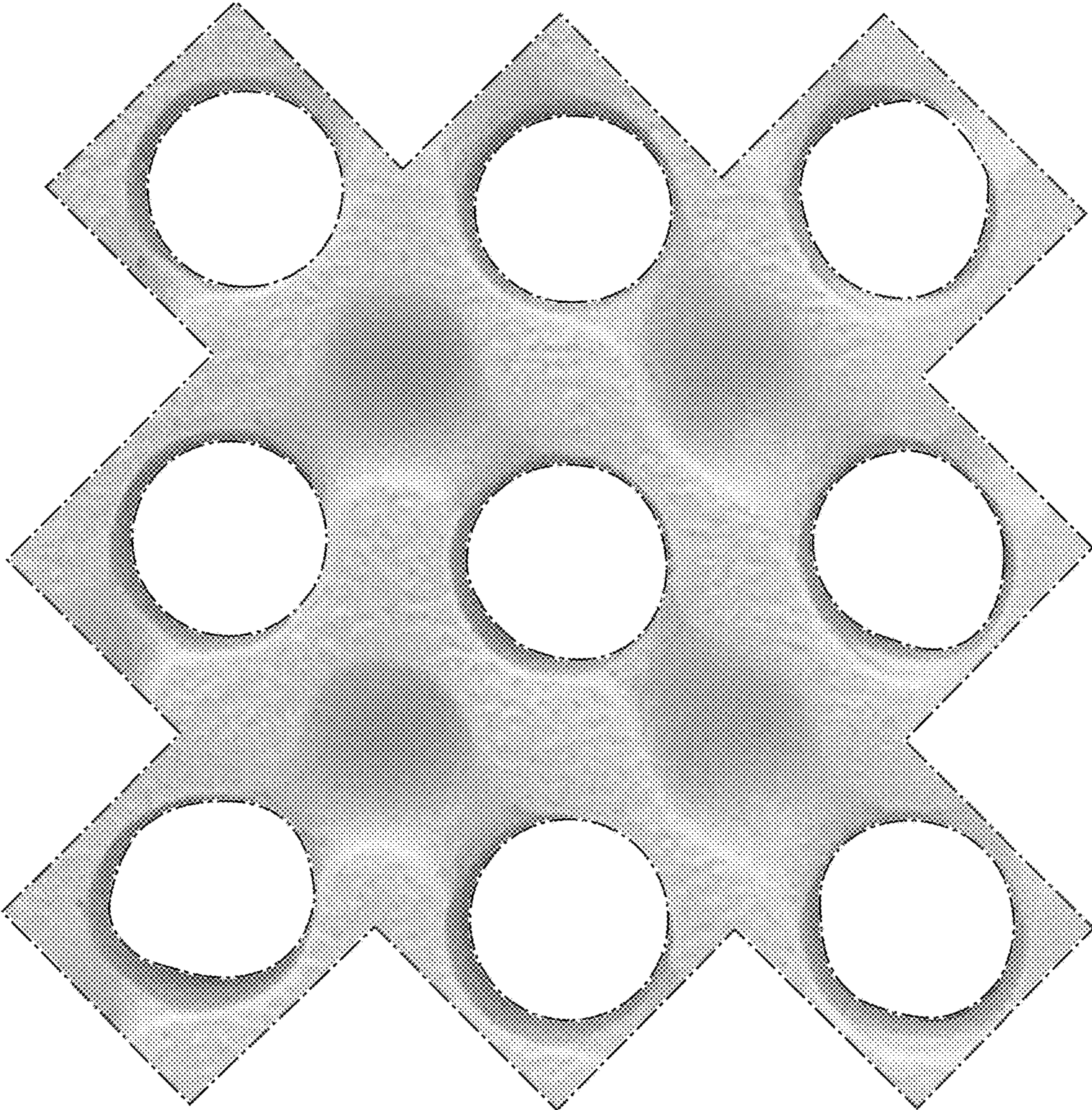
