FIG. 3 is a bottom view thereof;

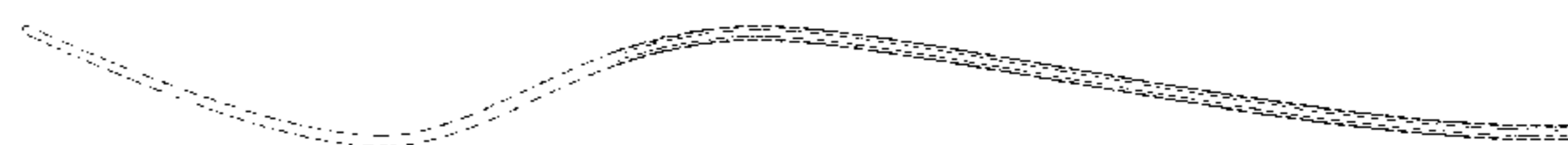
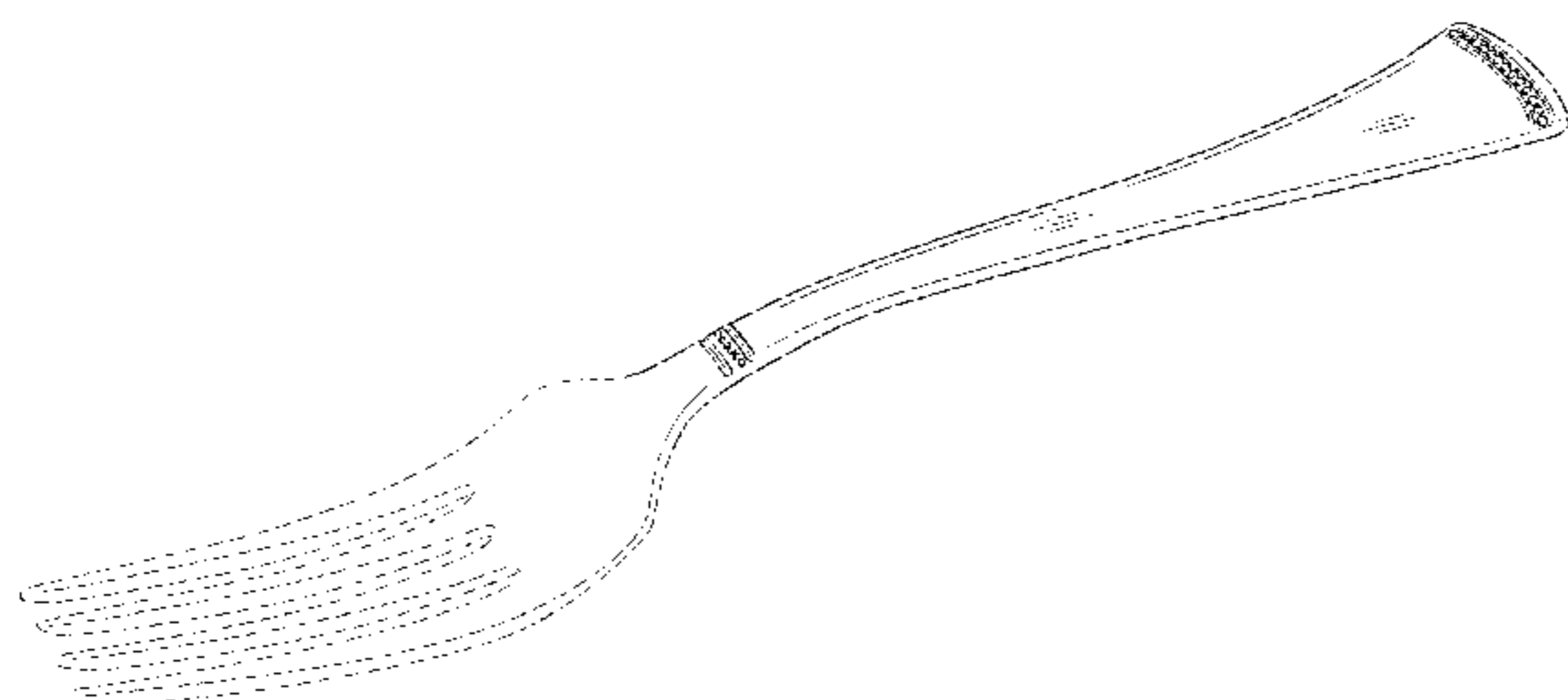
FIG. 4 is a left side view thereof, the right side being a mirror image of the left side;

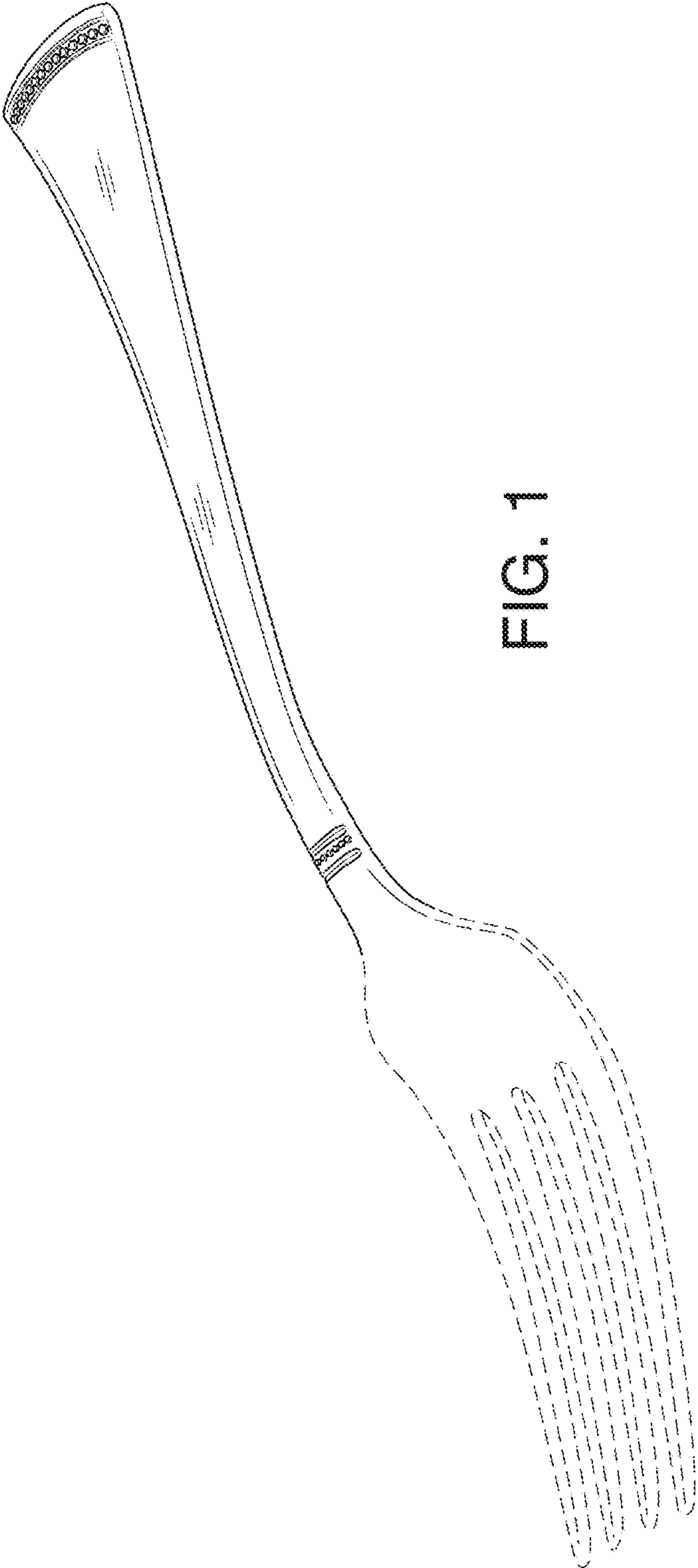

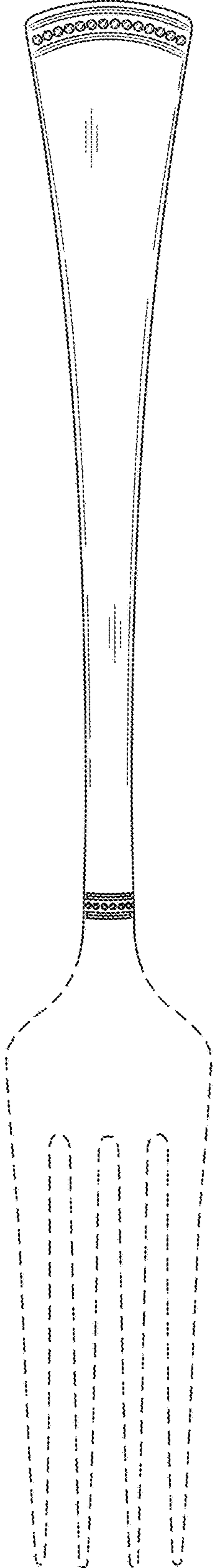

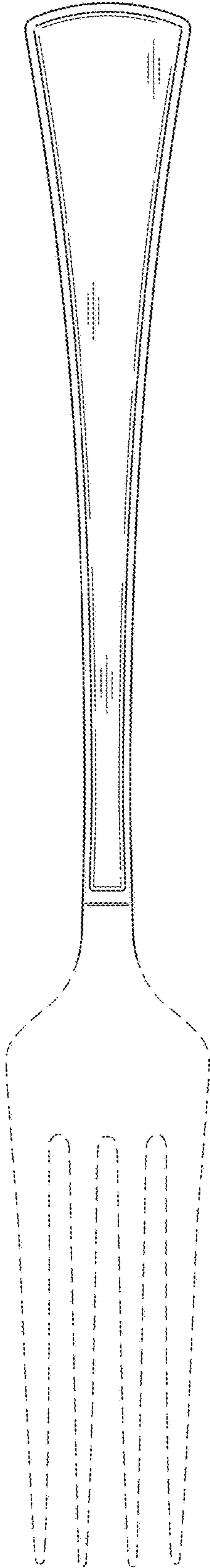

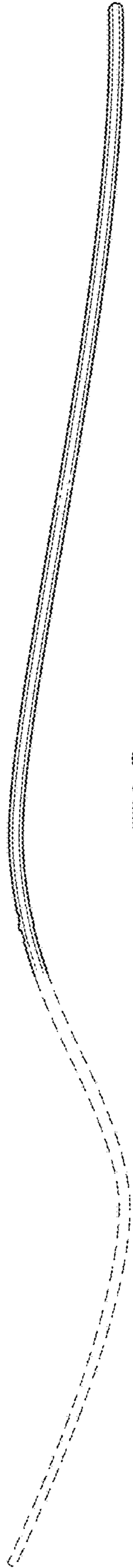

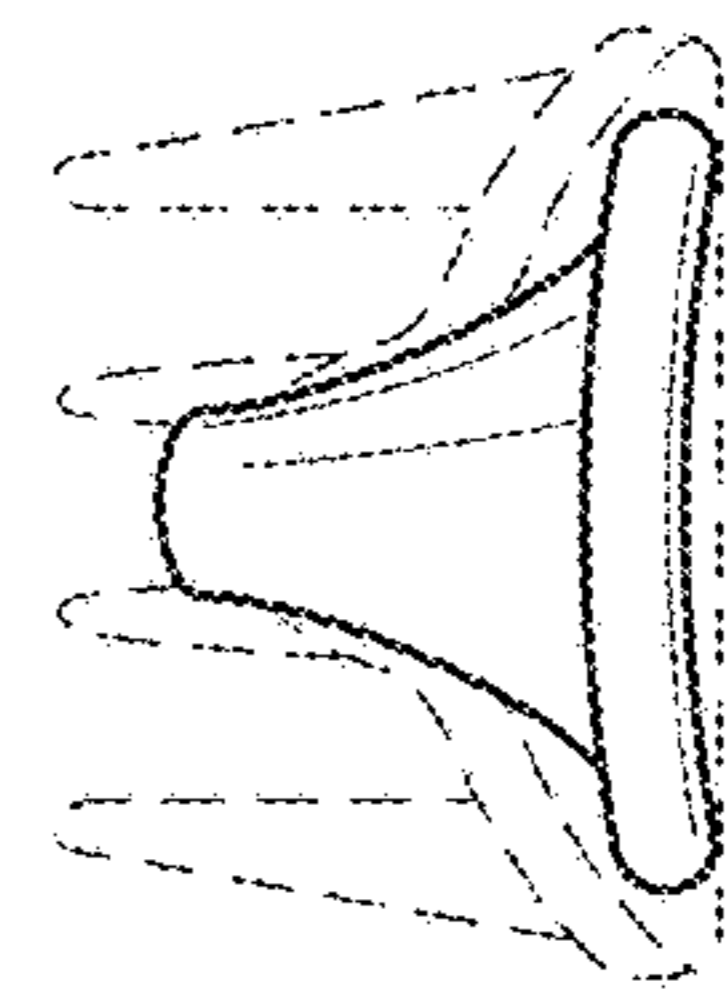

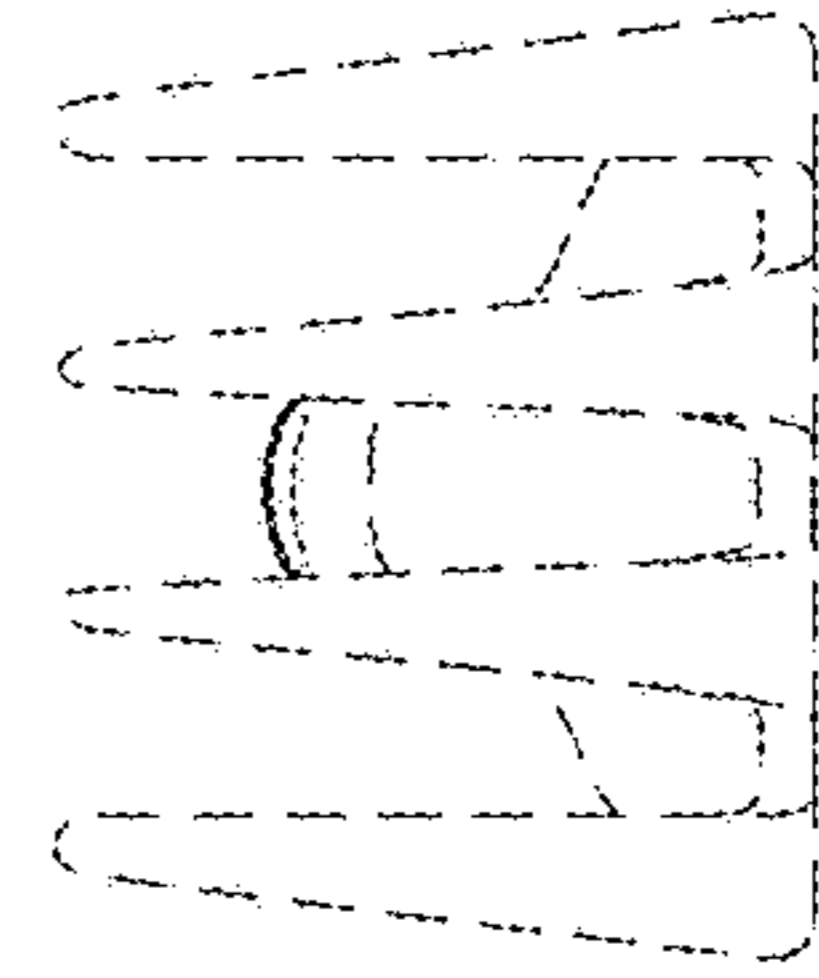
