**DESCRIPTION**

FIG. 1 is front and side perspective view of a bottle showing my new design;

FIG. 4 is an opposite side elevational view thereof;

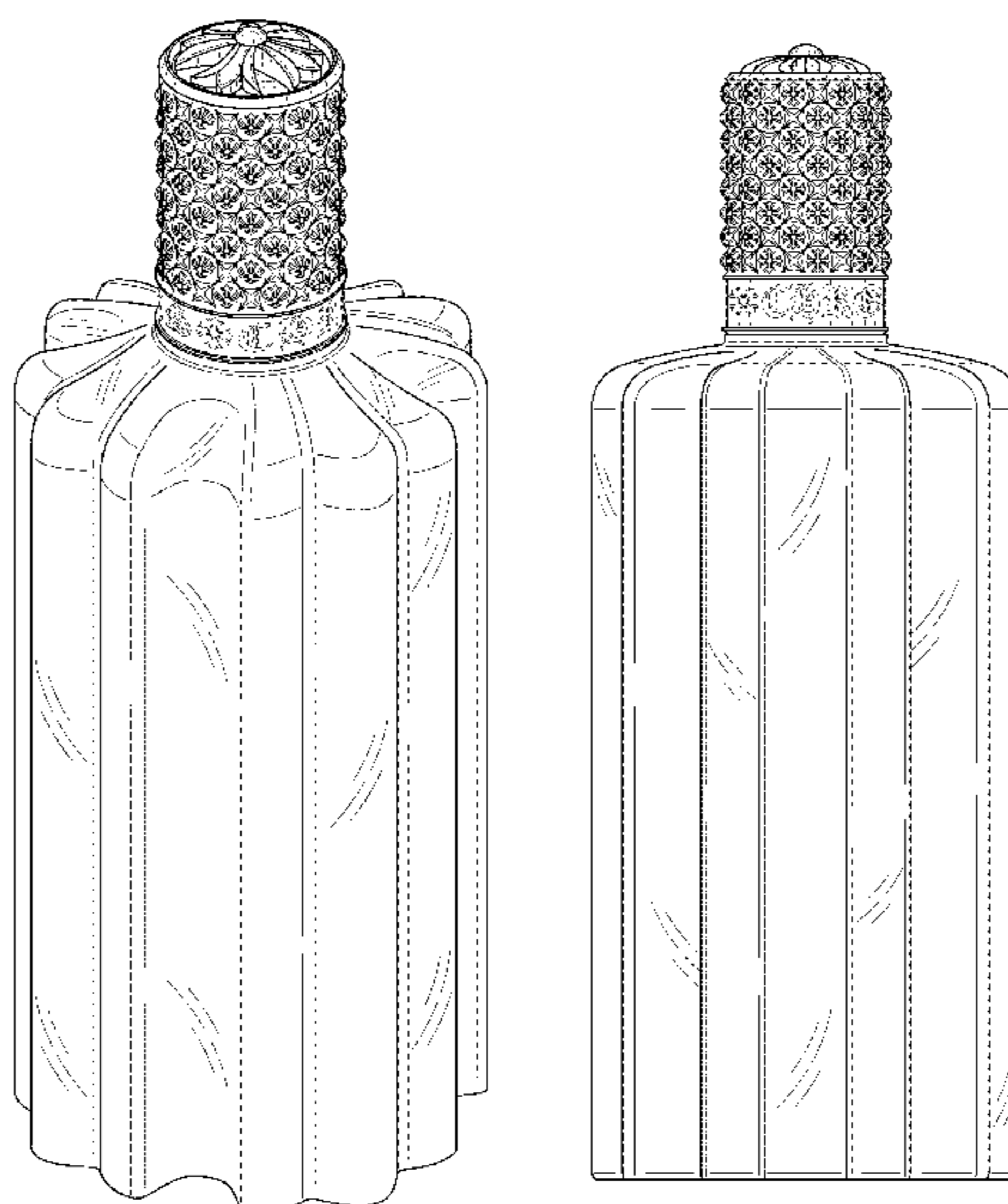
FIG. 5 is a rear elevational view thereof;

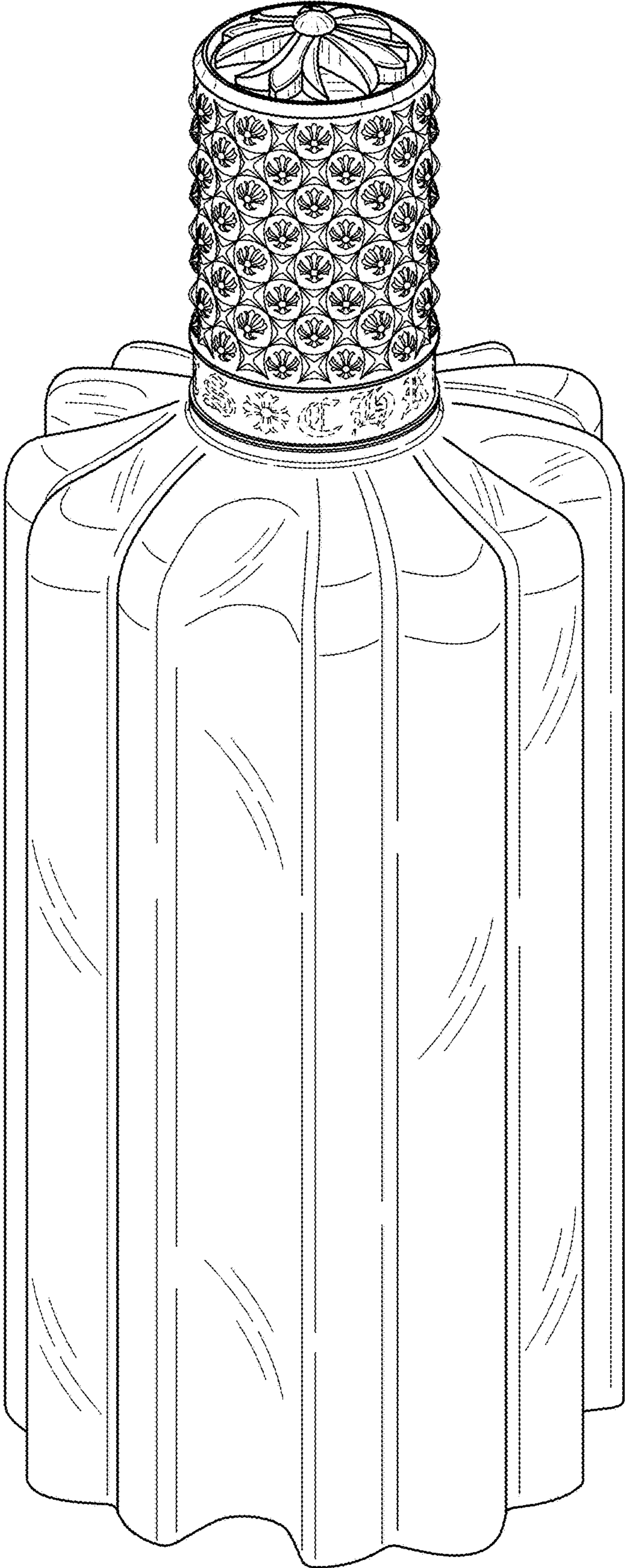

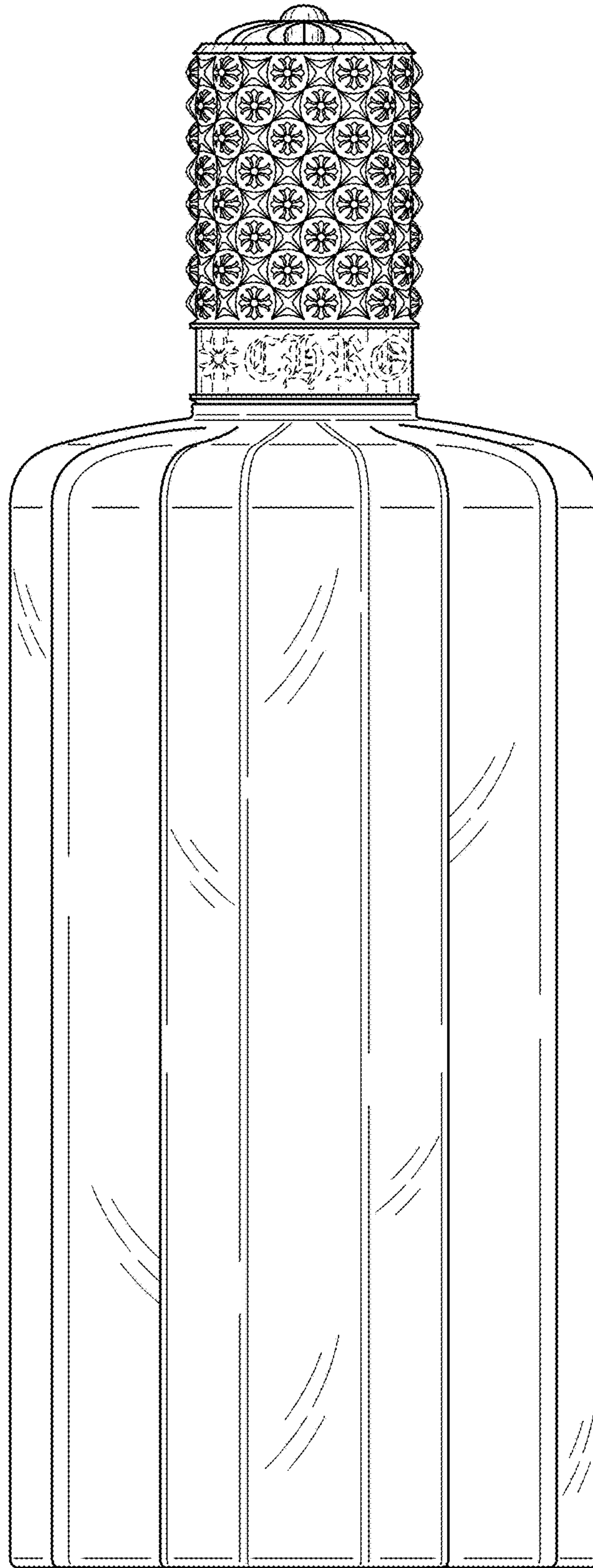

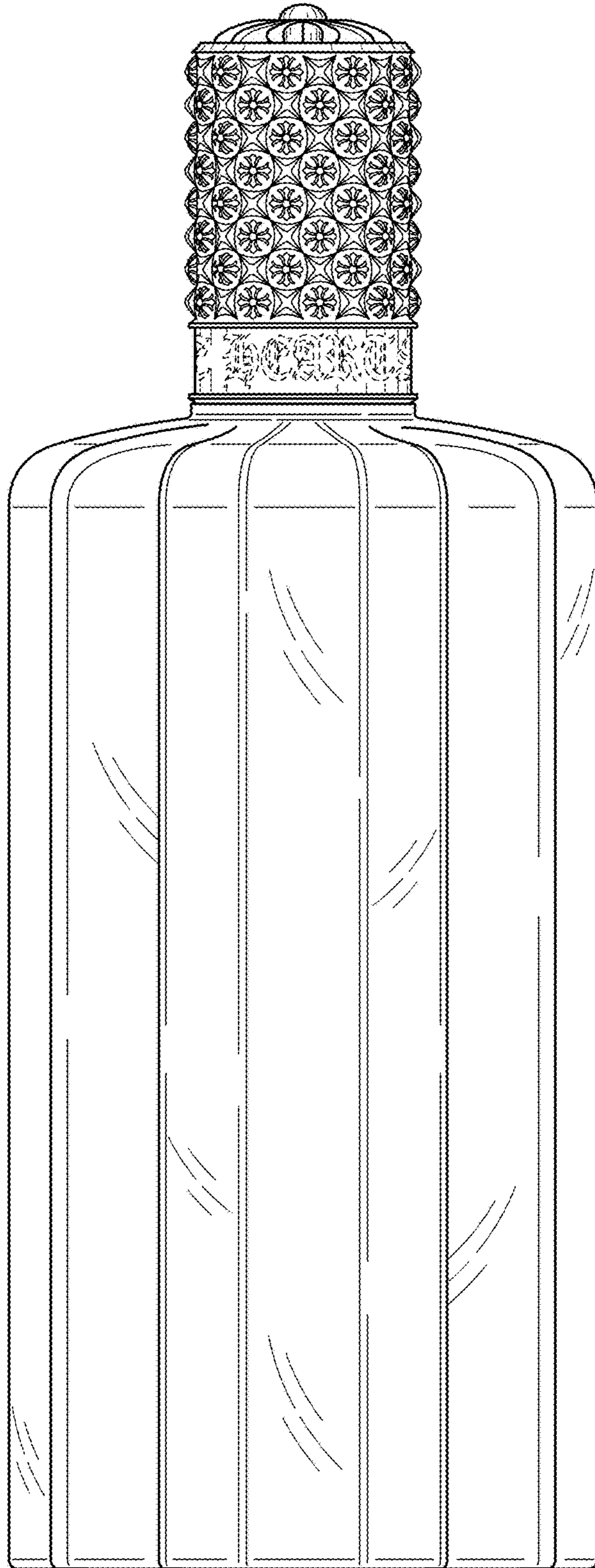

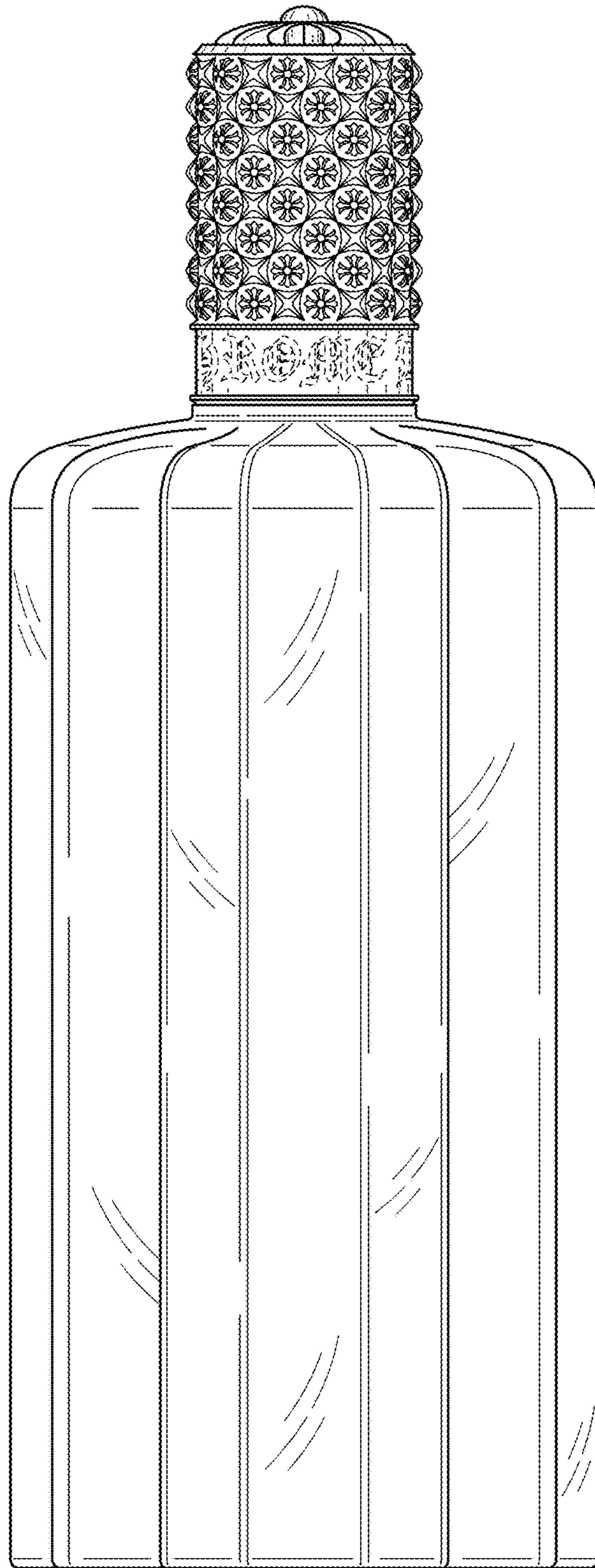

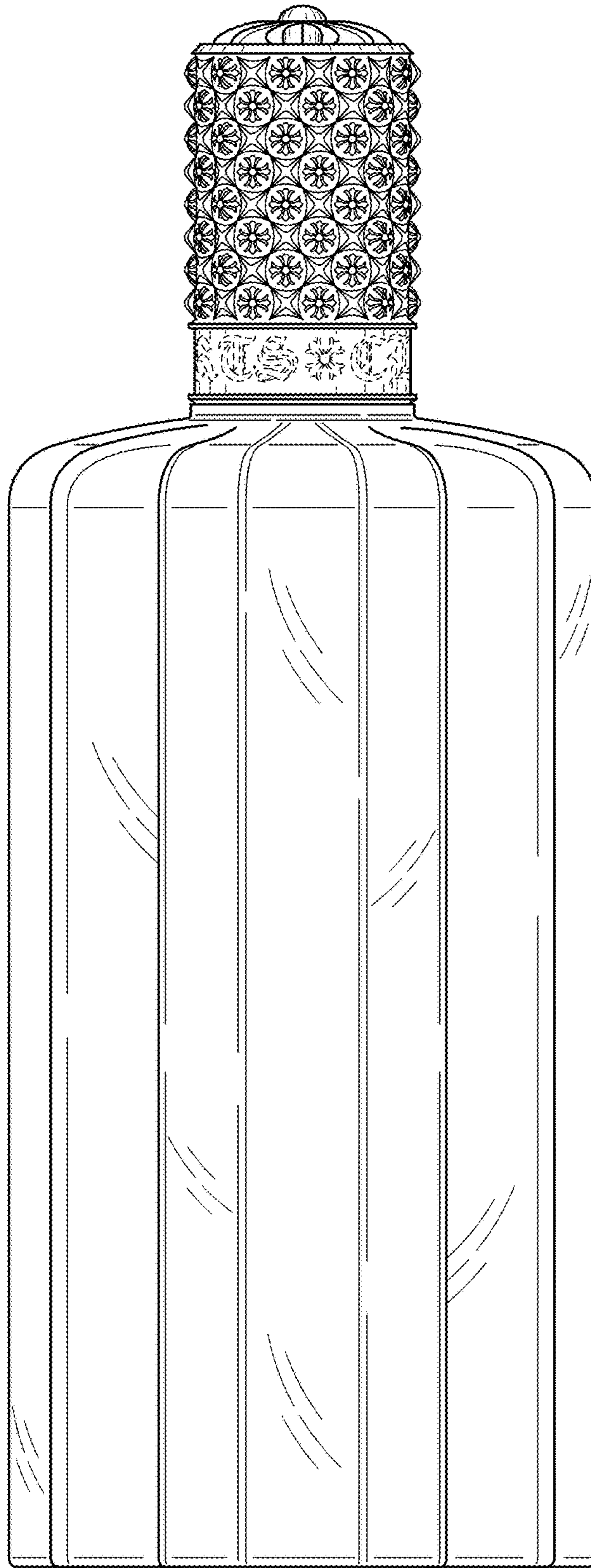
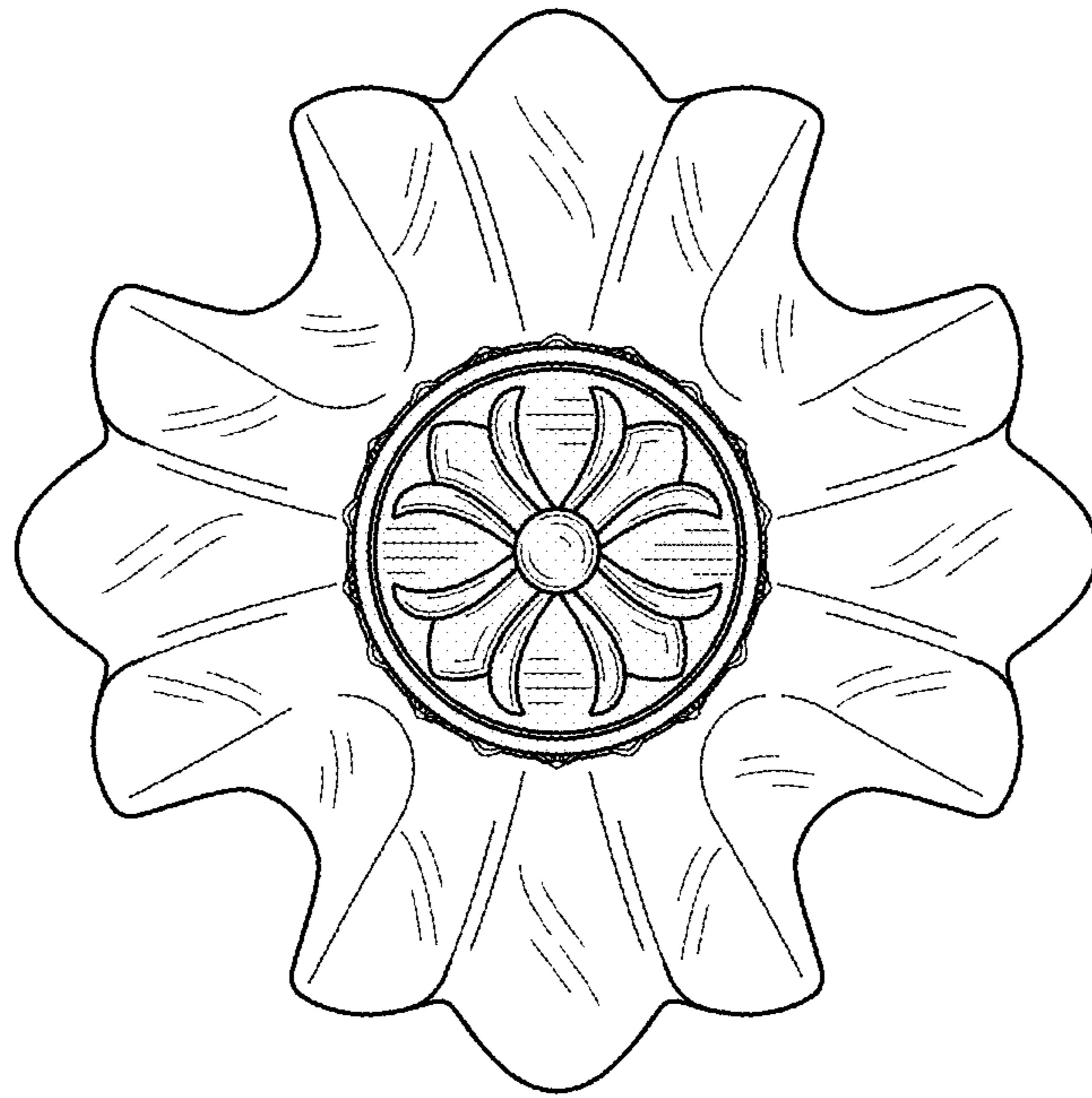
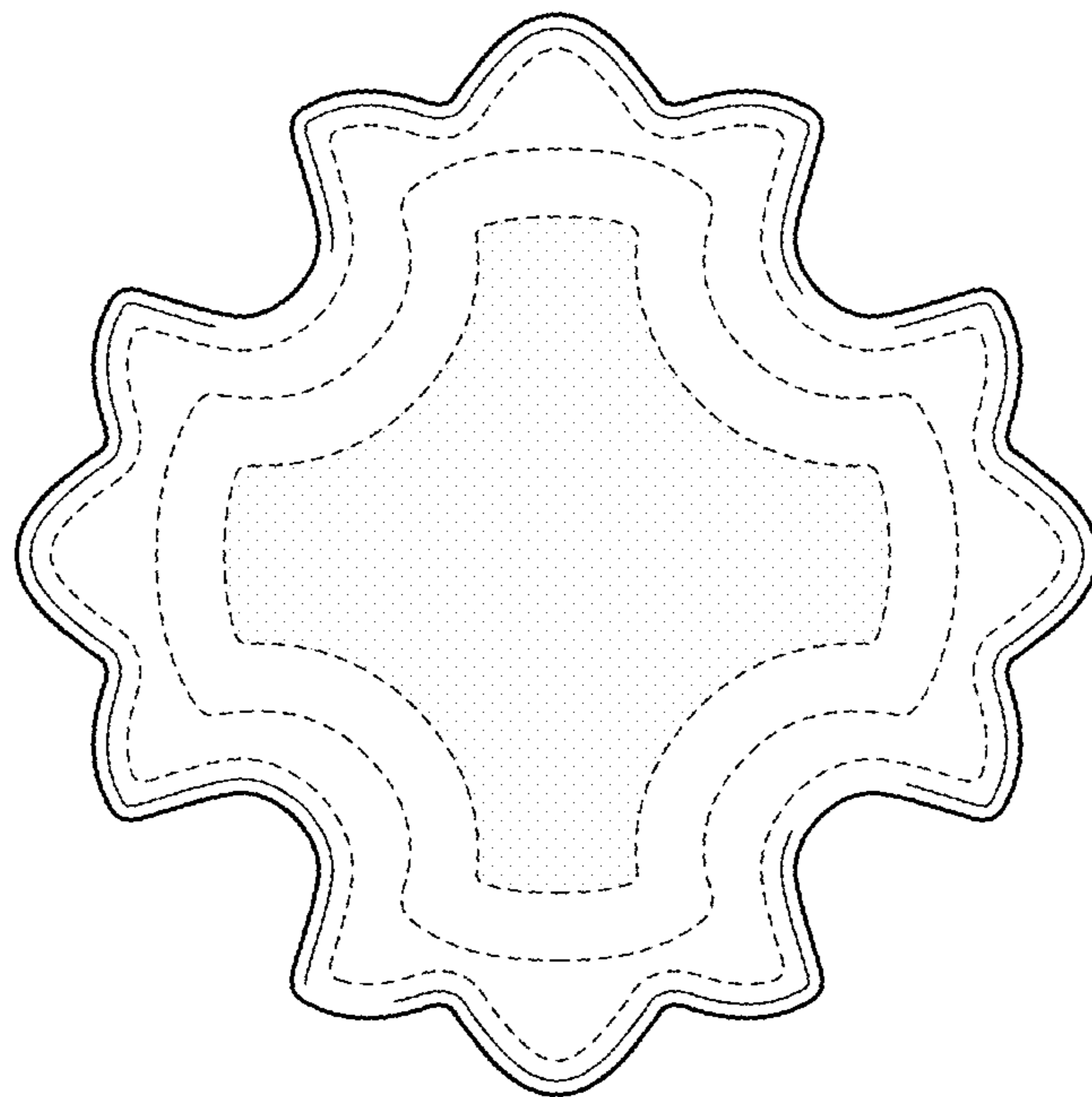
