**DESCRIPTION**

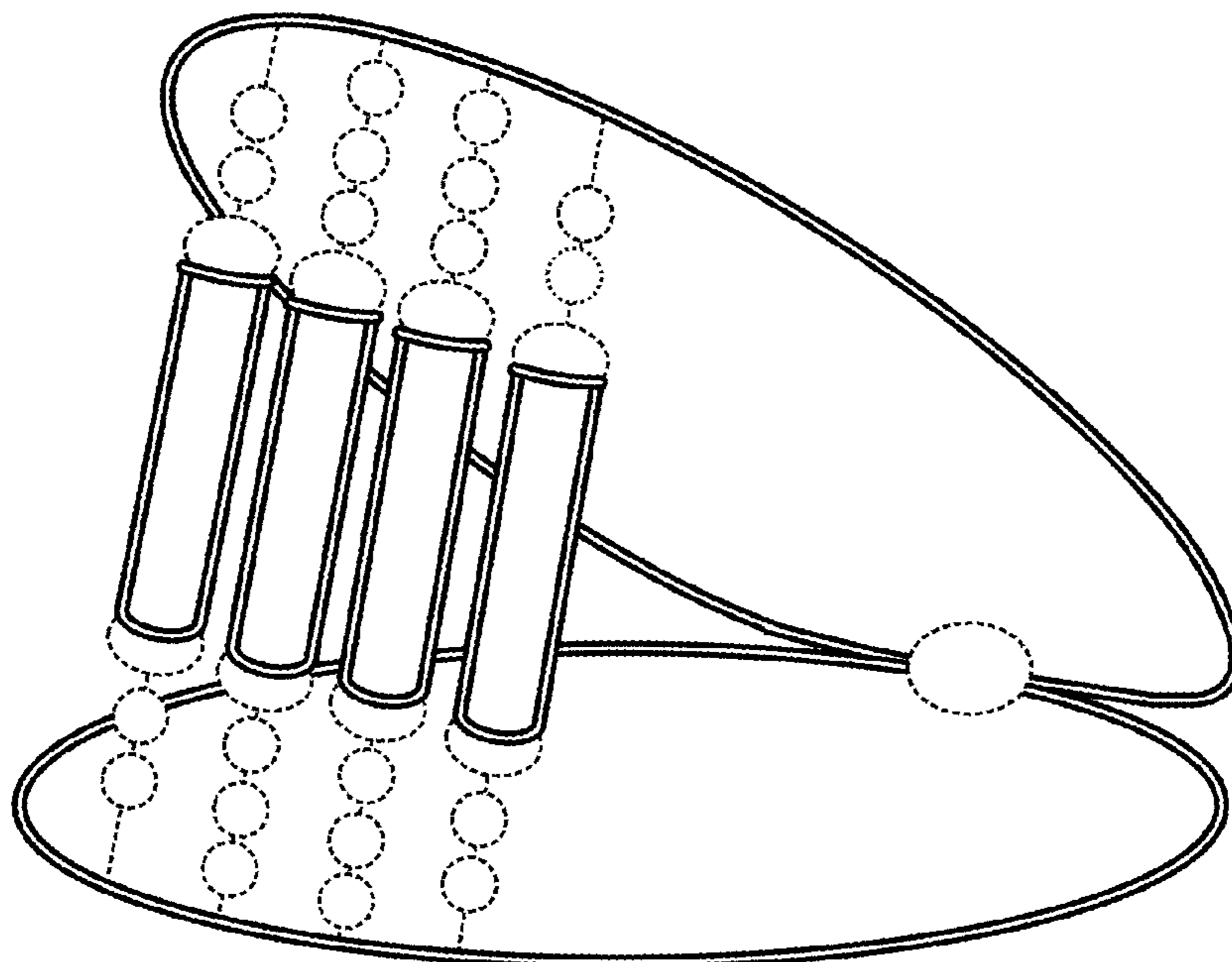
FIG. 1 is a perspective view of a bullet casing bracelet, showing my new design;

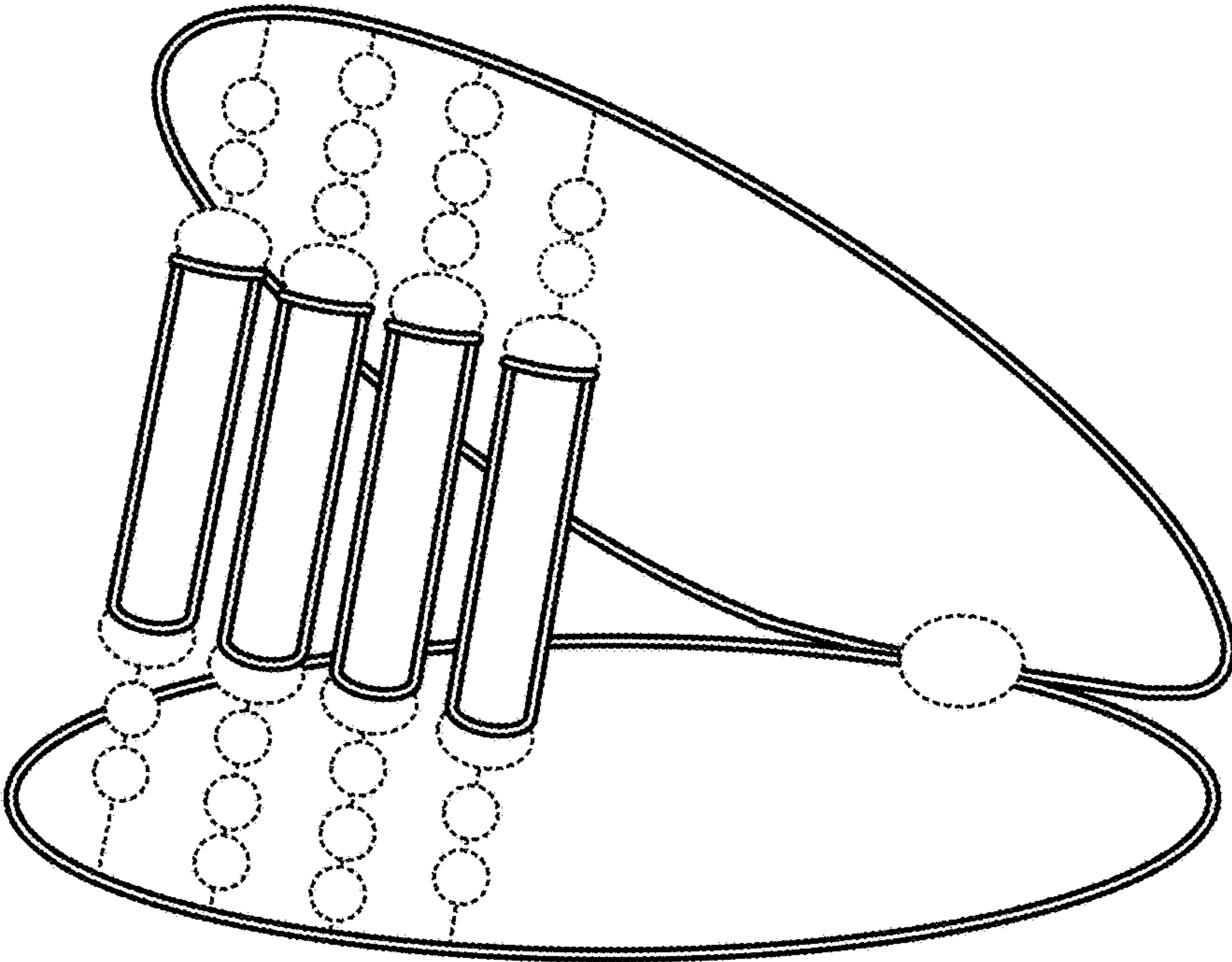

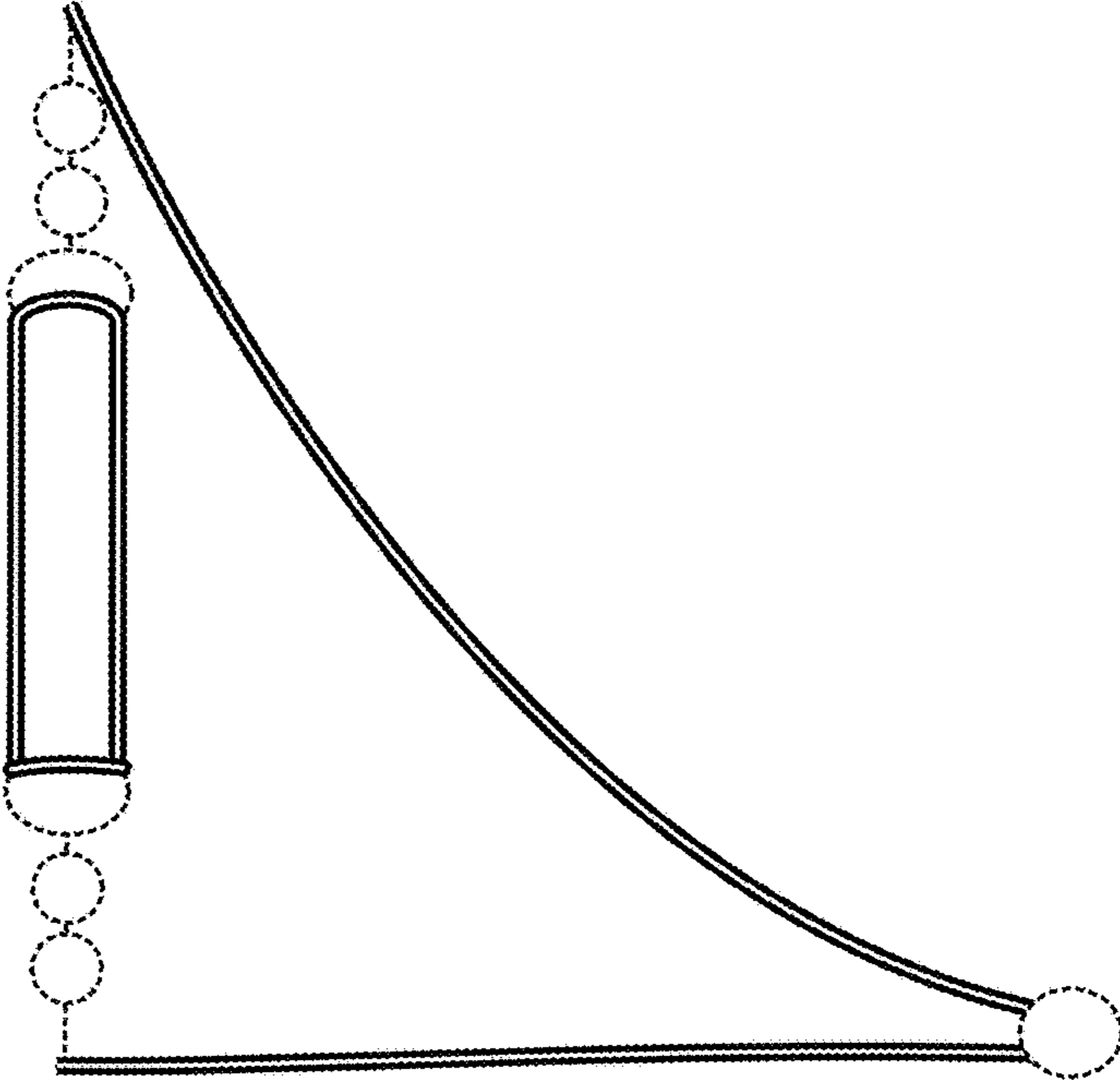

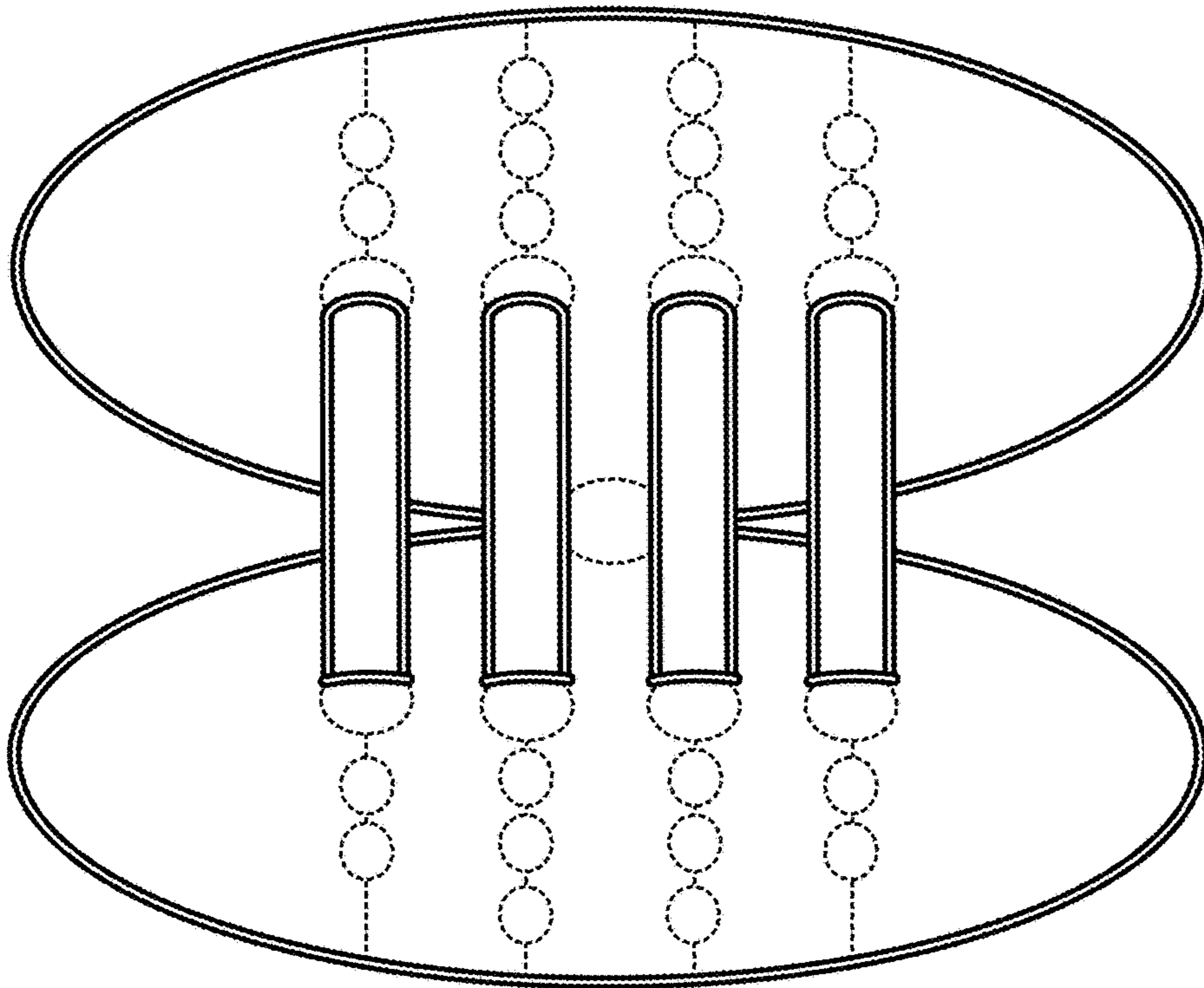

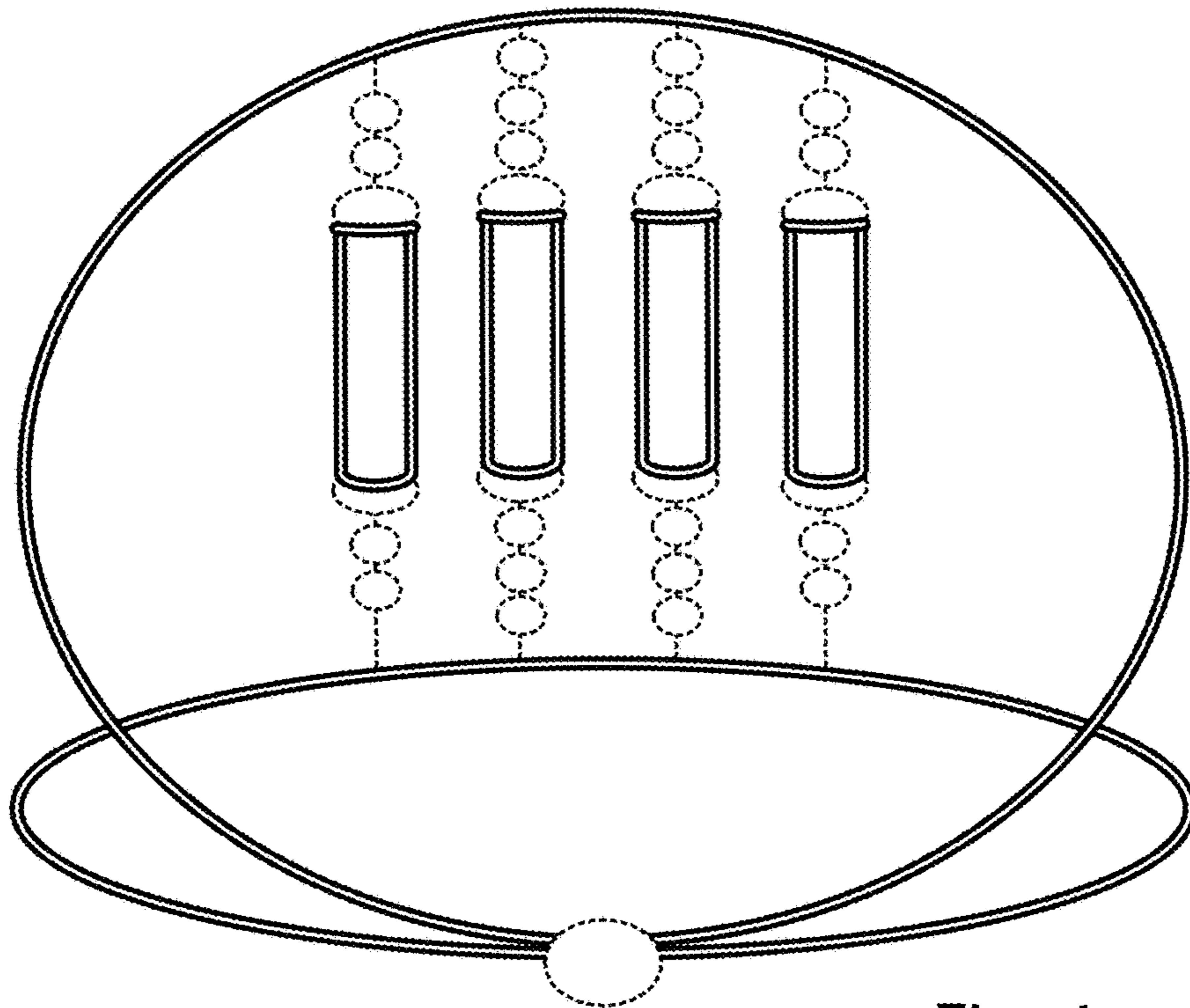

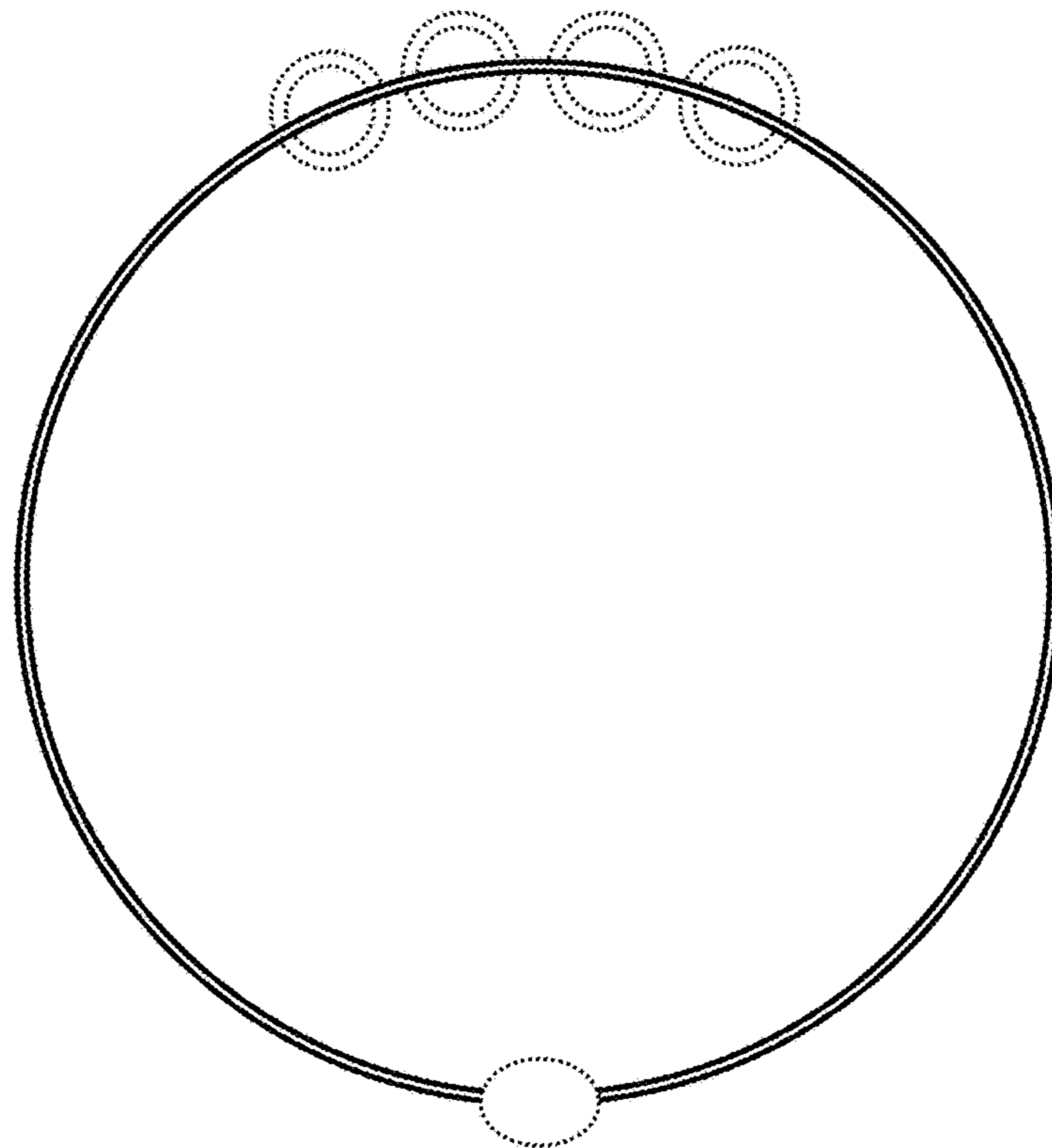
