FIG. 7 is a right side elevational view thereof.

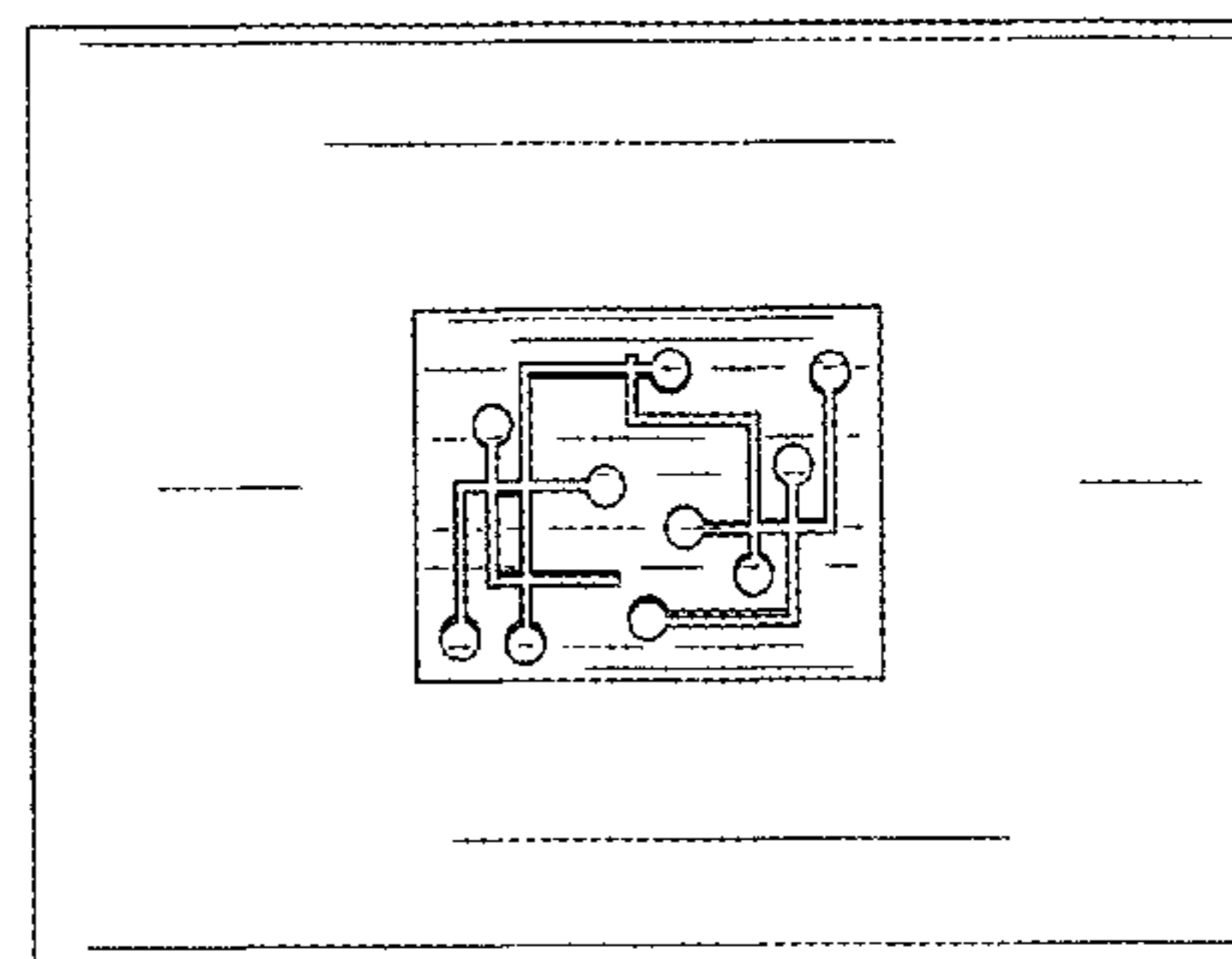
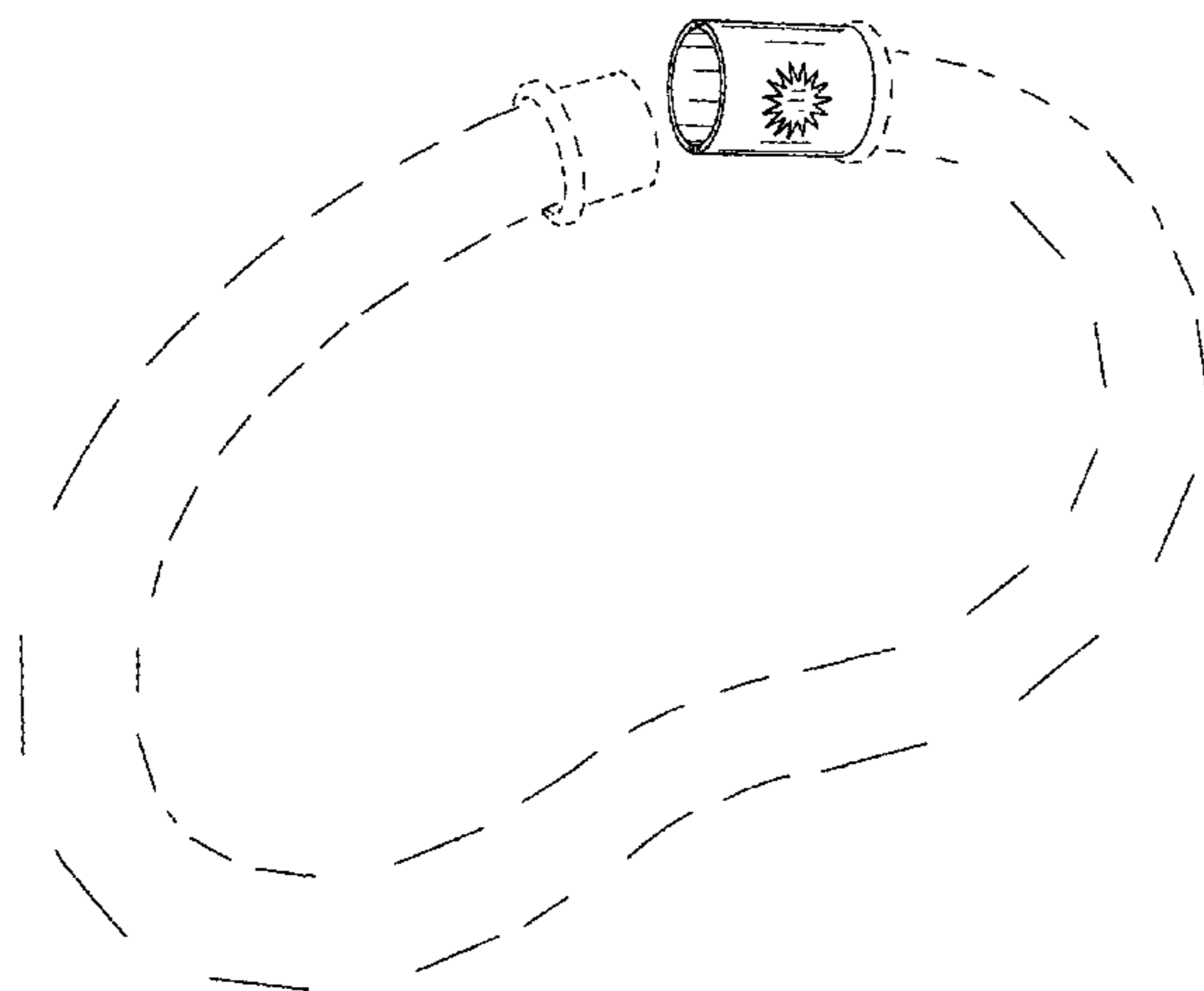
The broken line element of FIG. 1, showing a bracelet, forms no part of my new design.

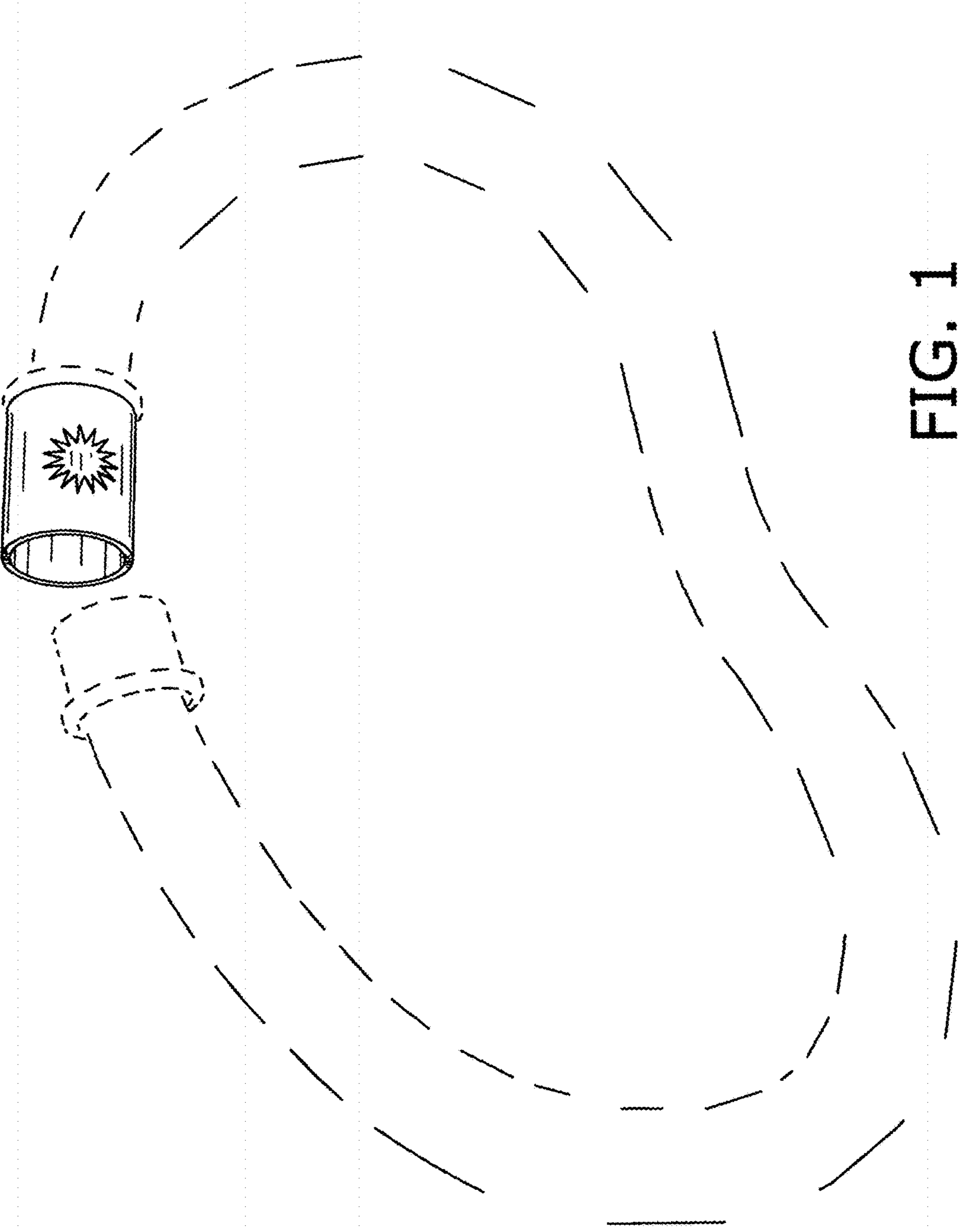

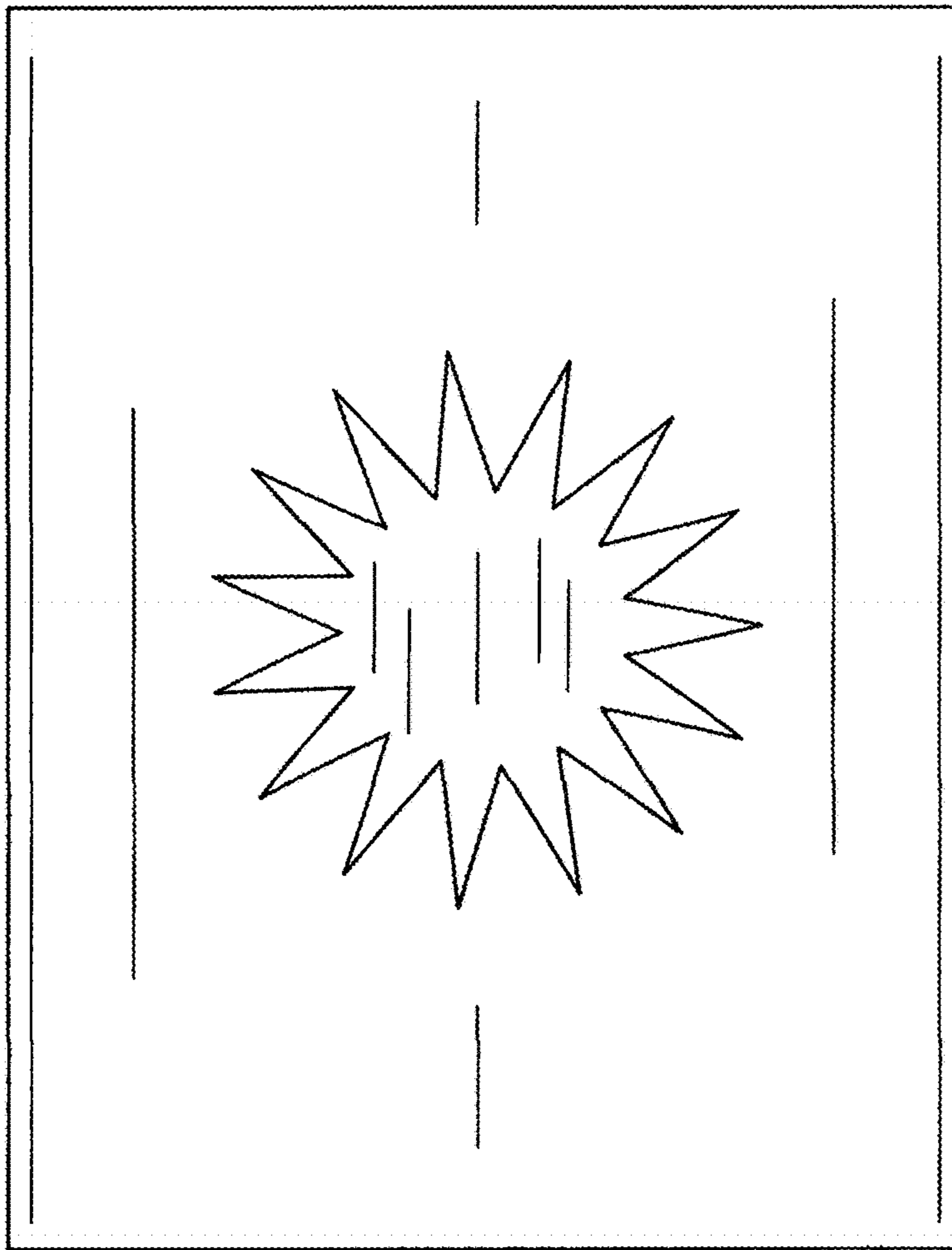

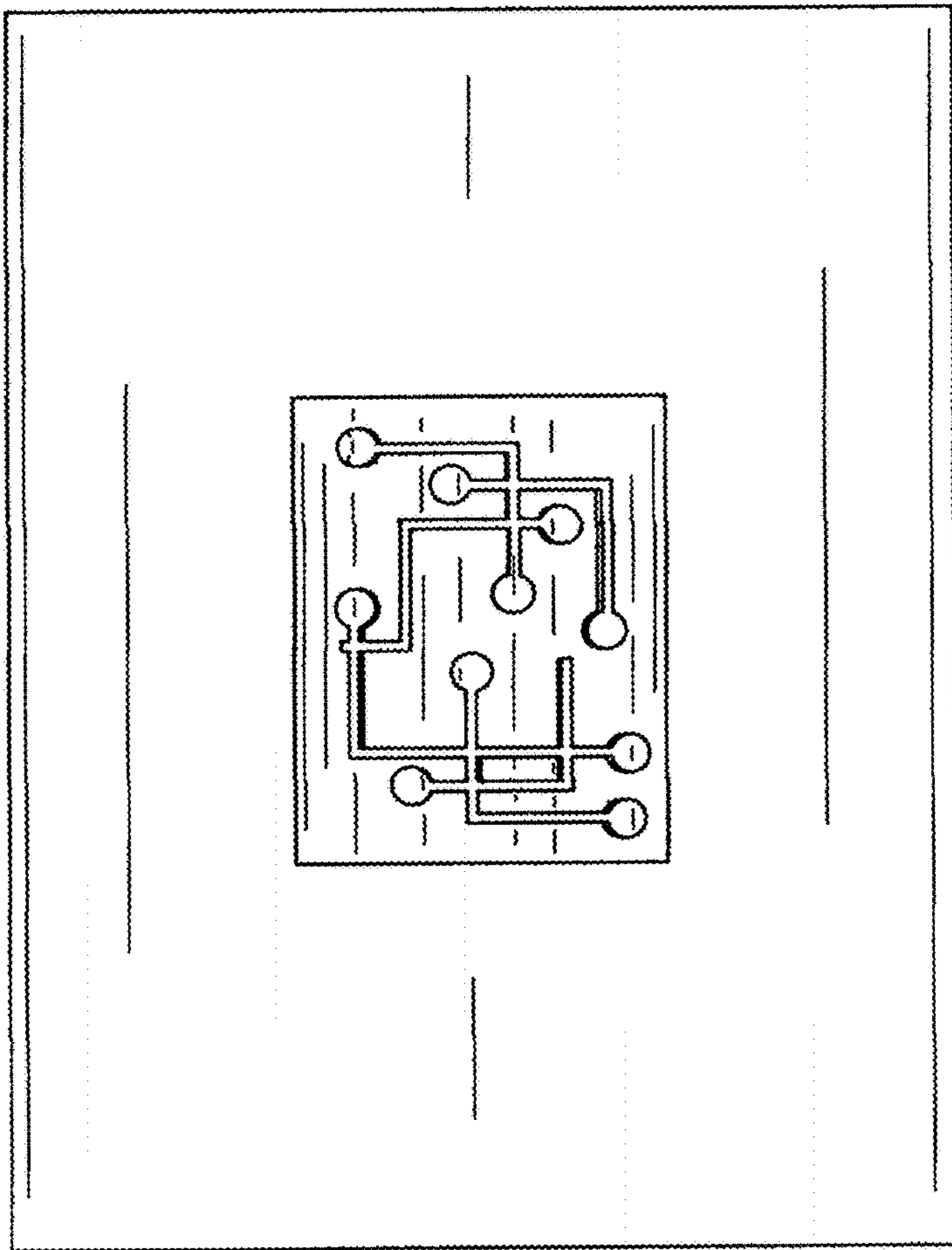

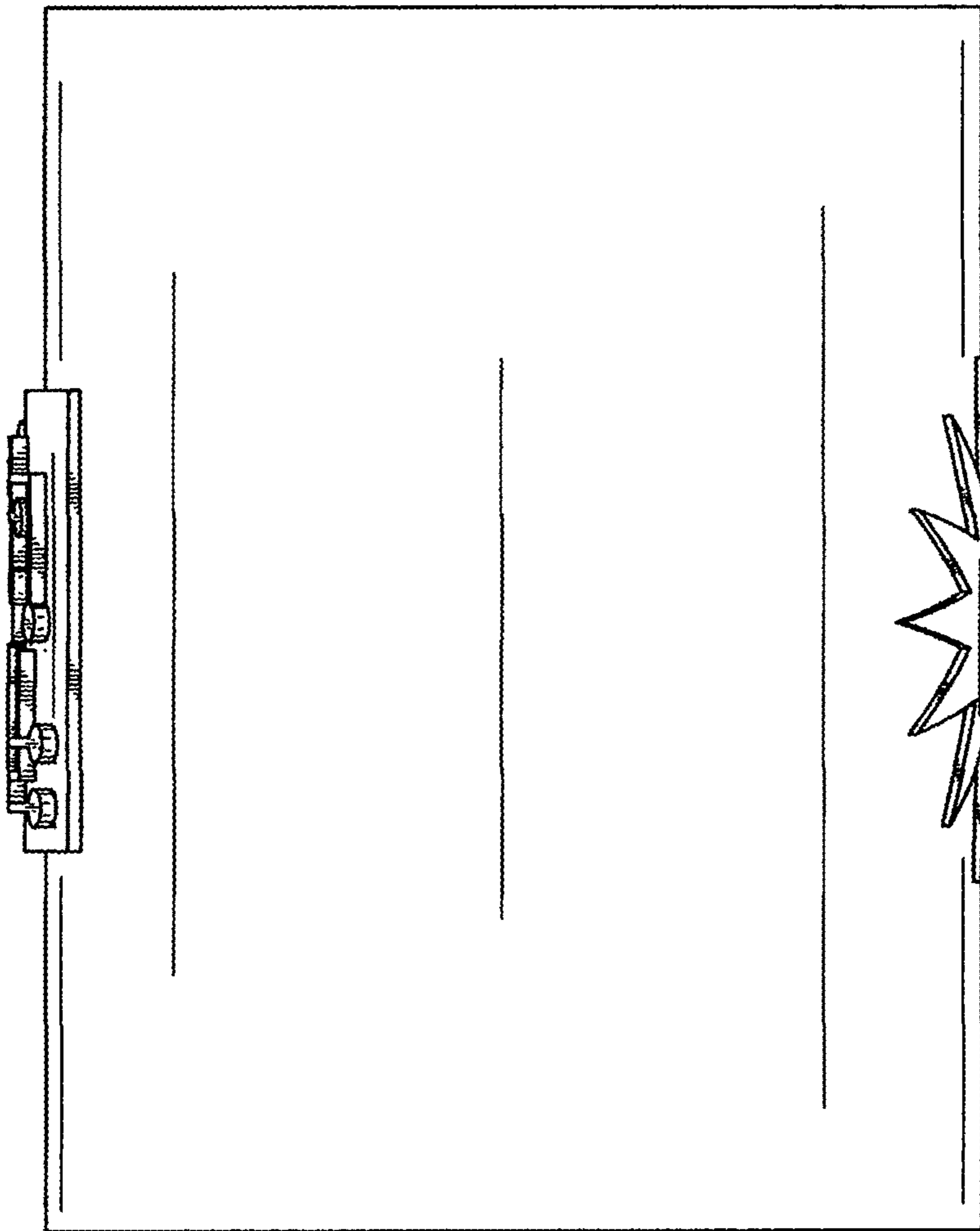

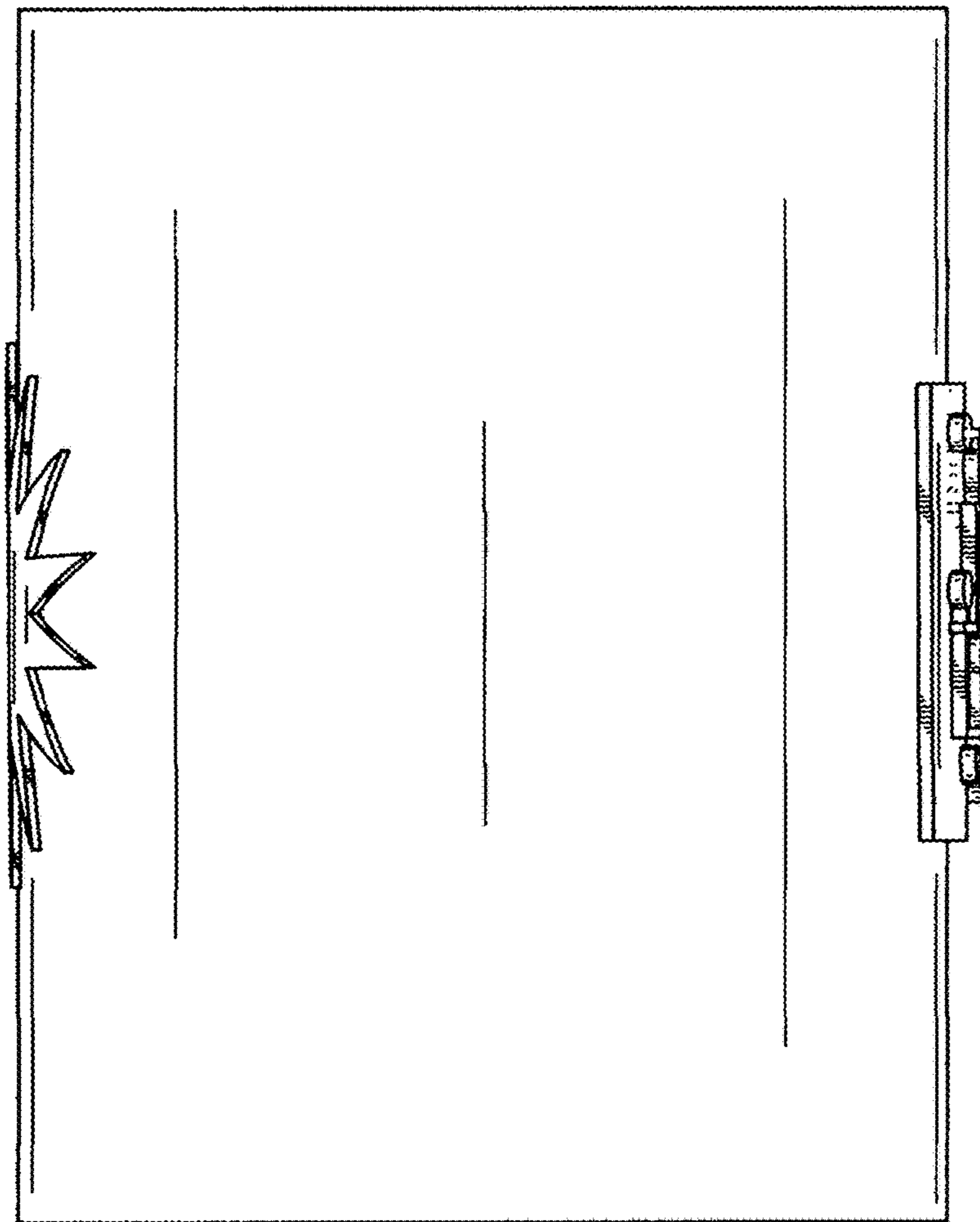

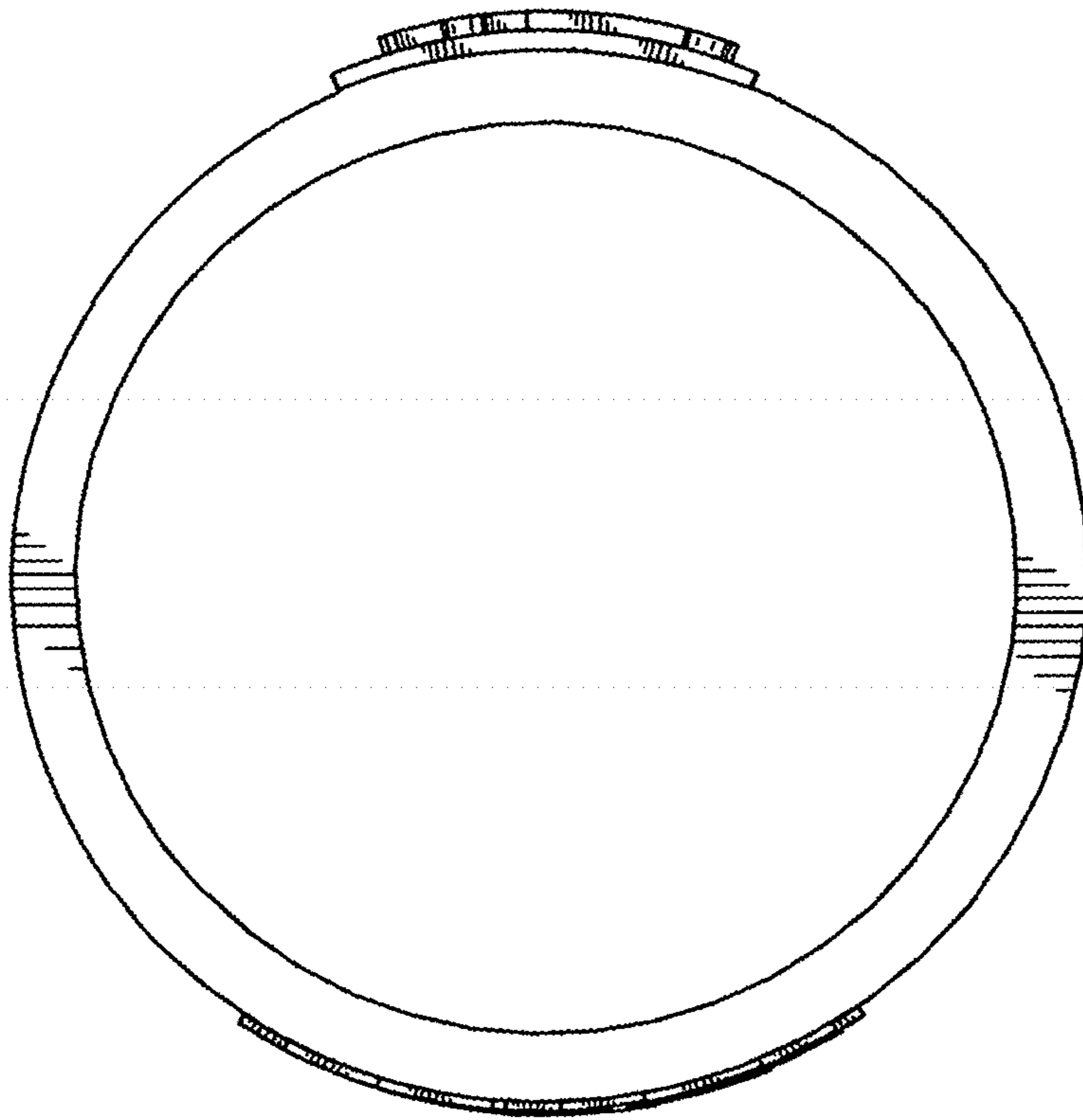

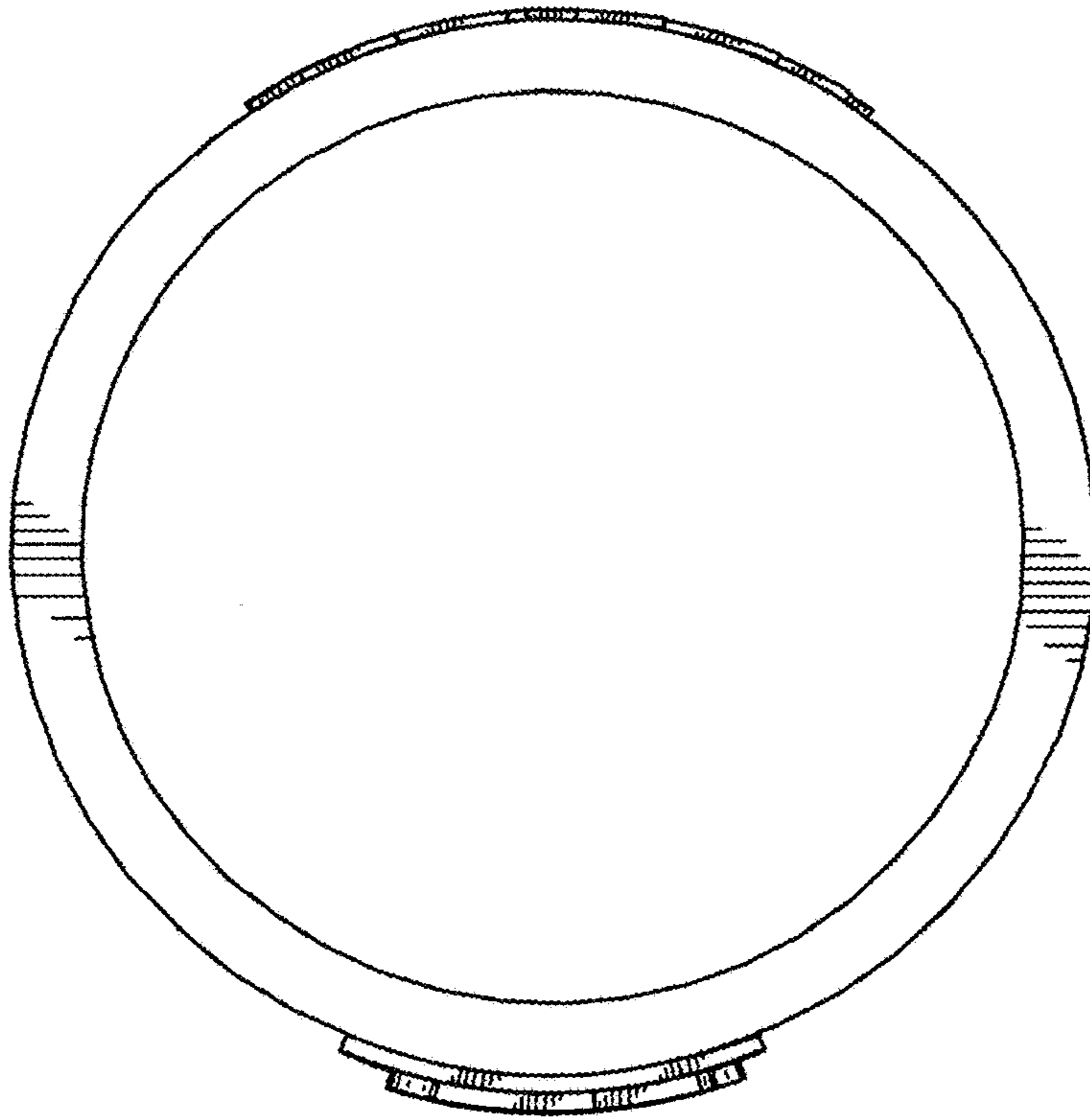
