(57) **CLAIM**

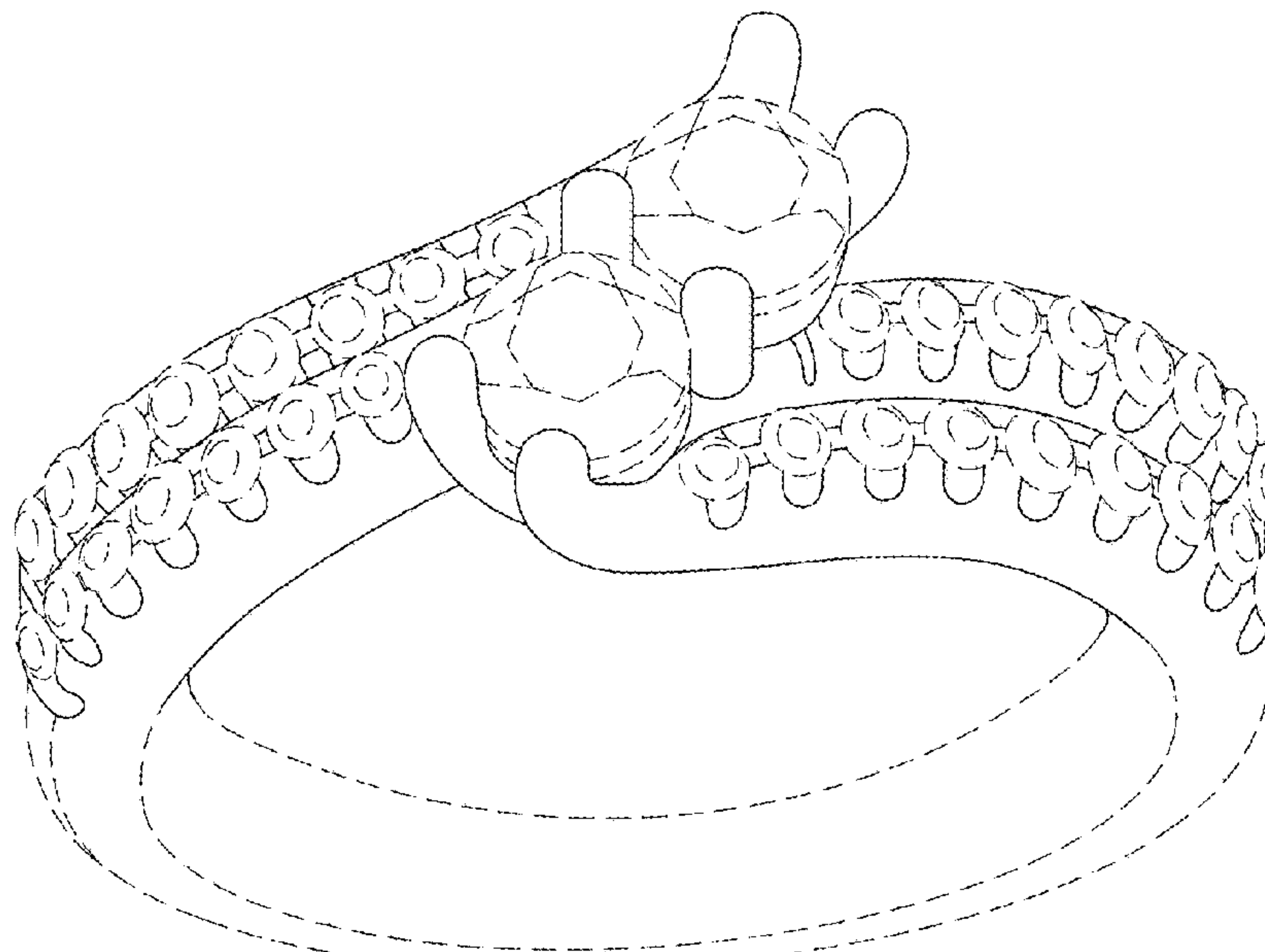
The ornamental design for a ring, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a ring showing my new design;

The broken lines showing a portion of the shank and gemstones represent portions of the ring which form no part of the claimed design.

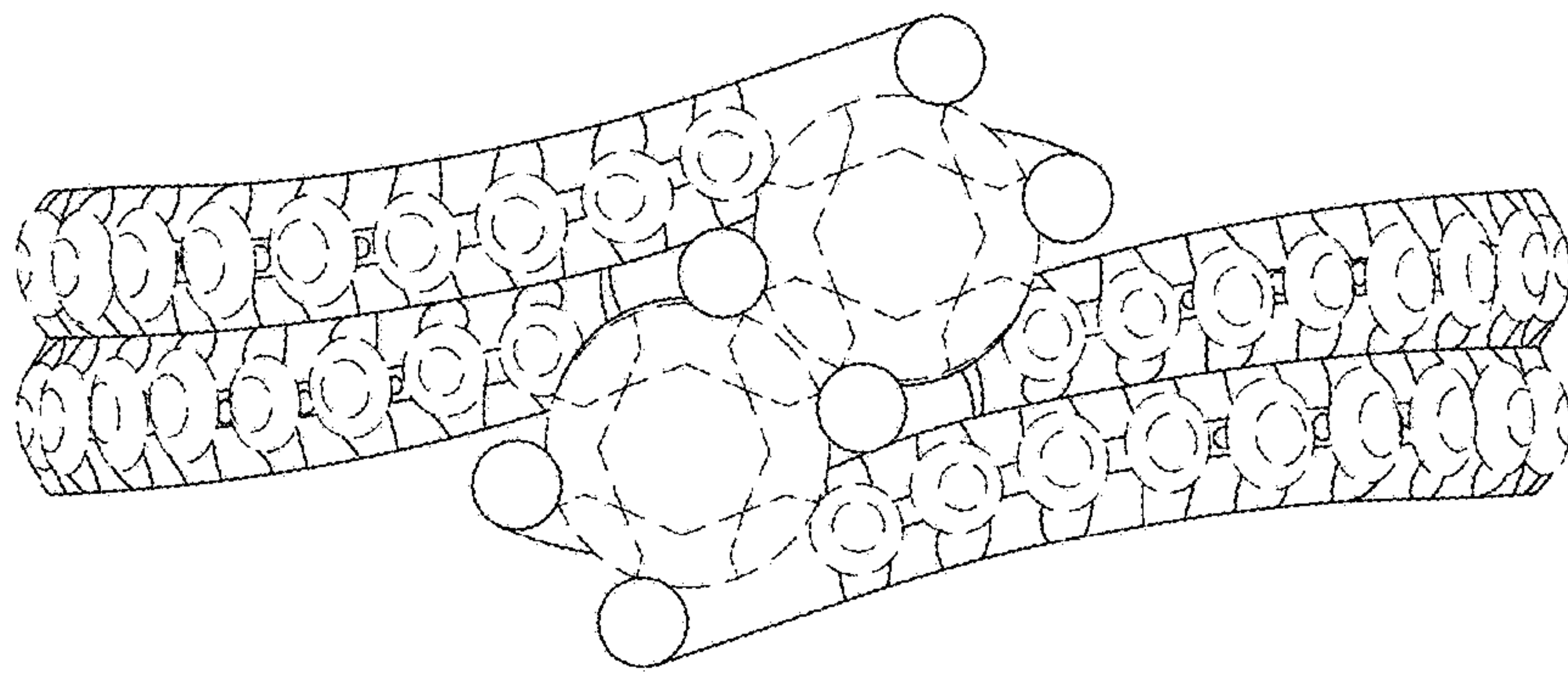

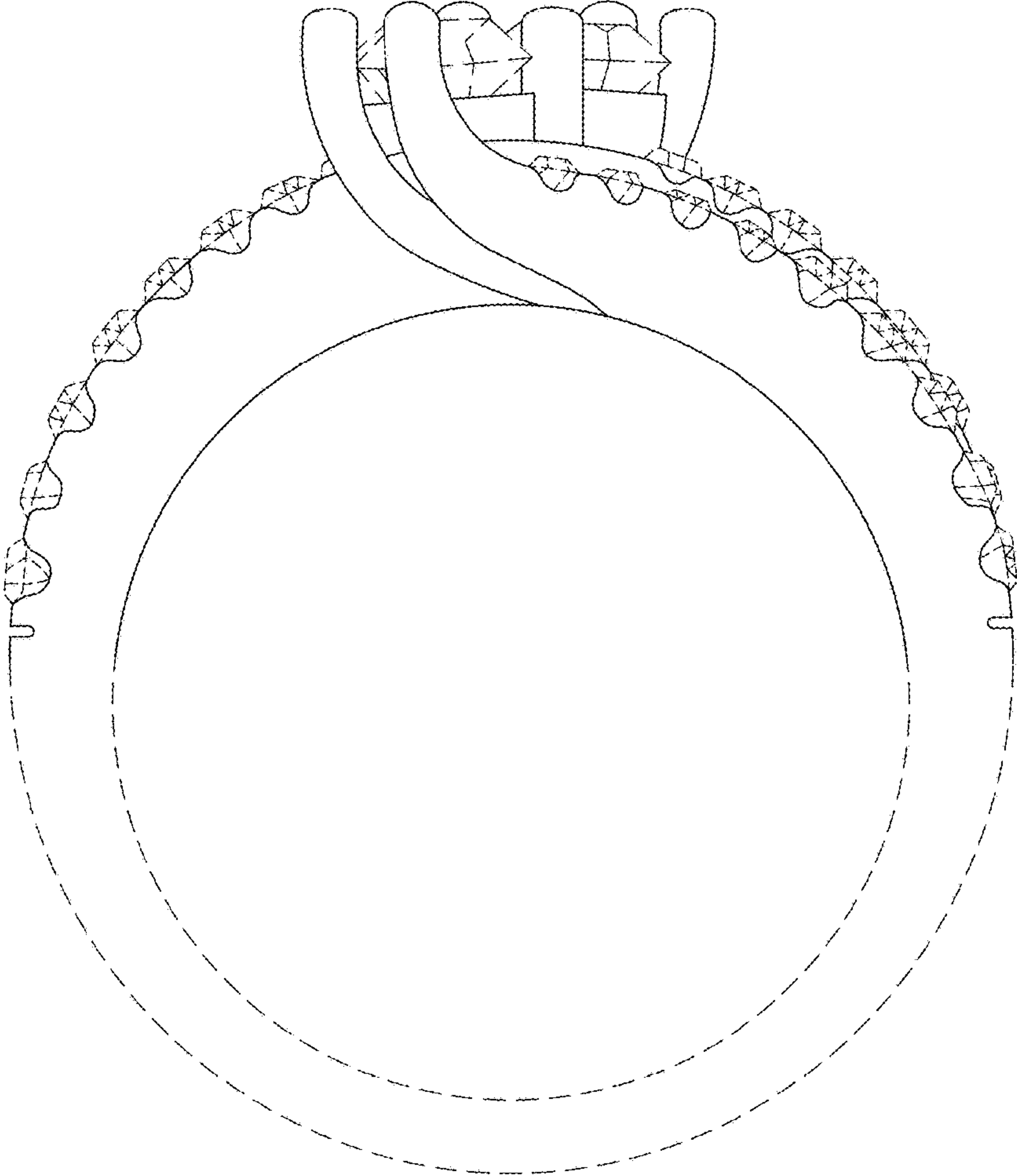

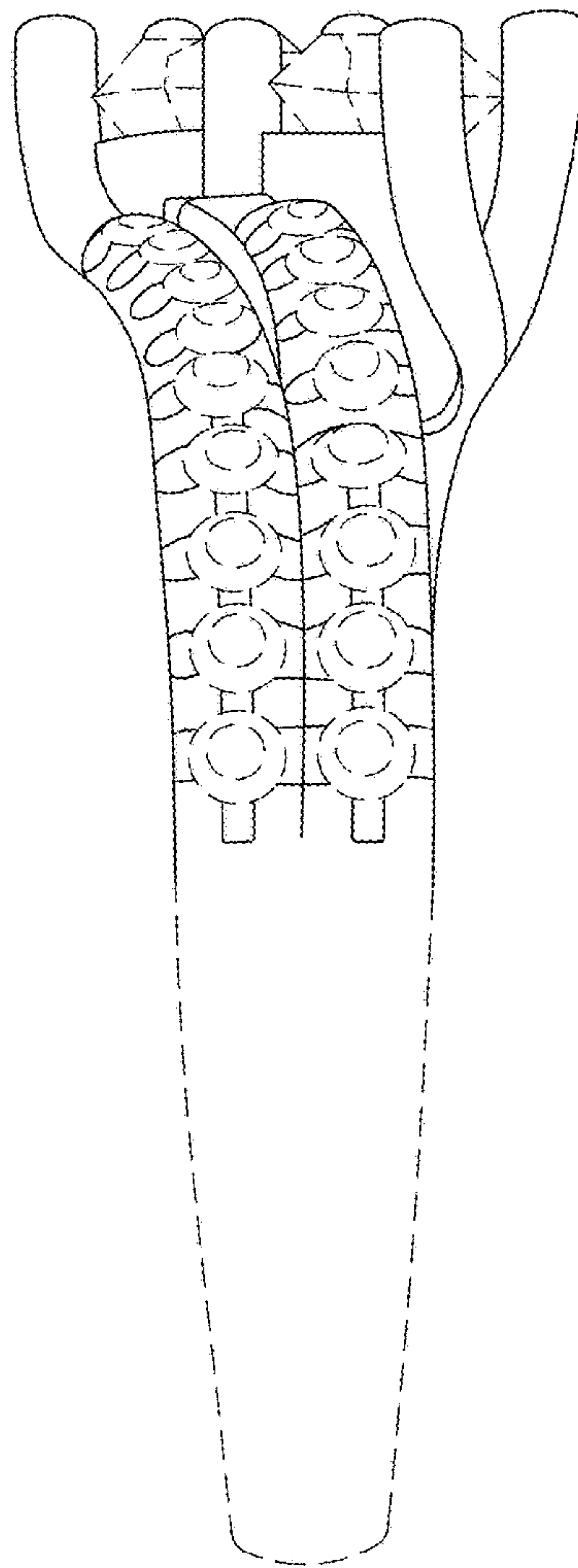

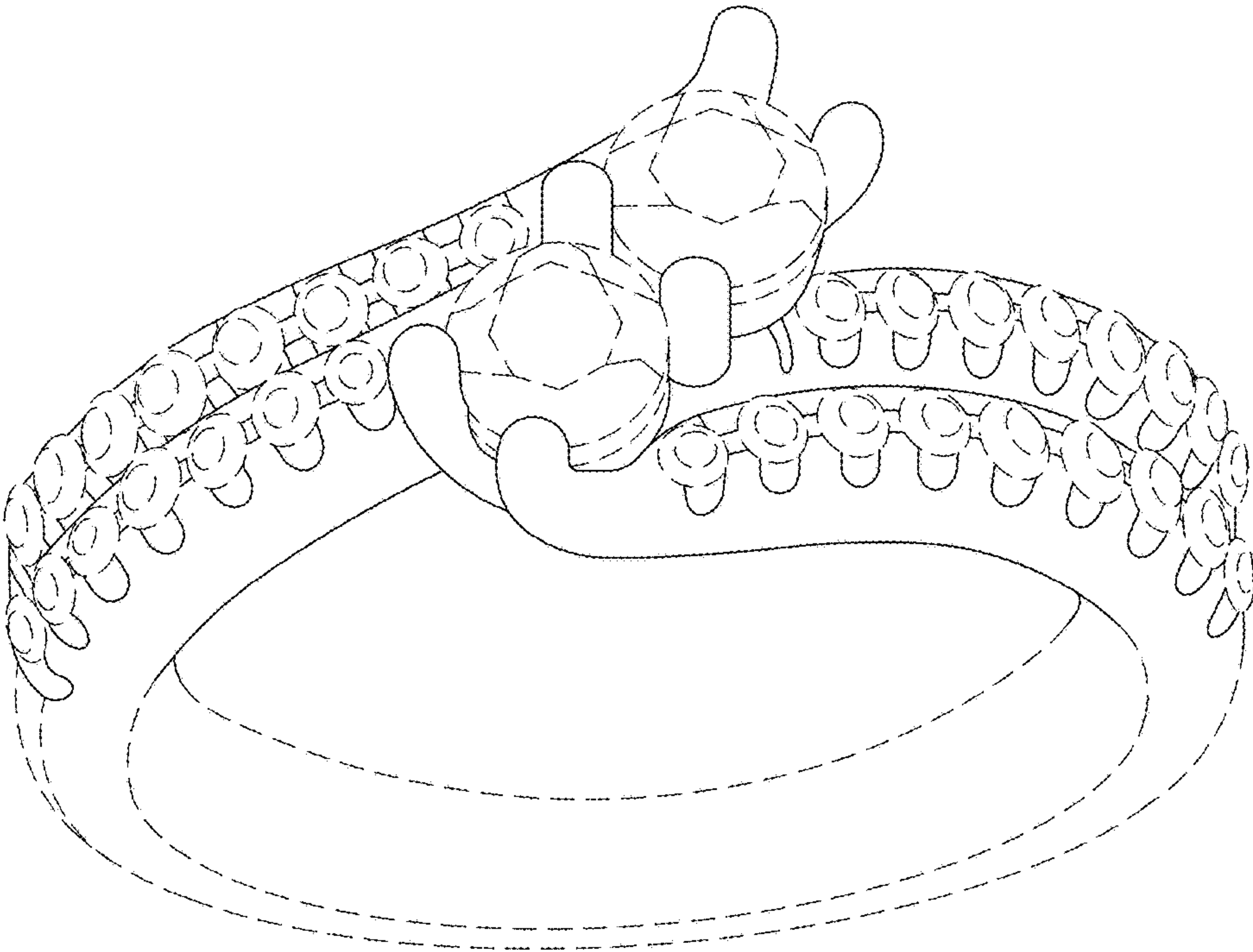

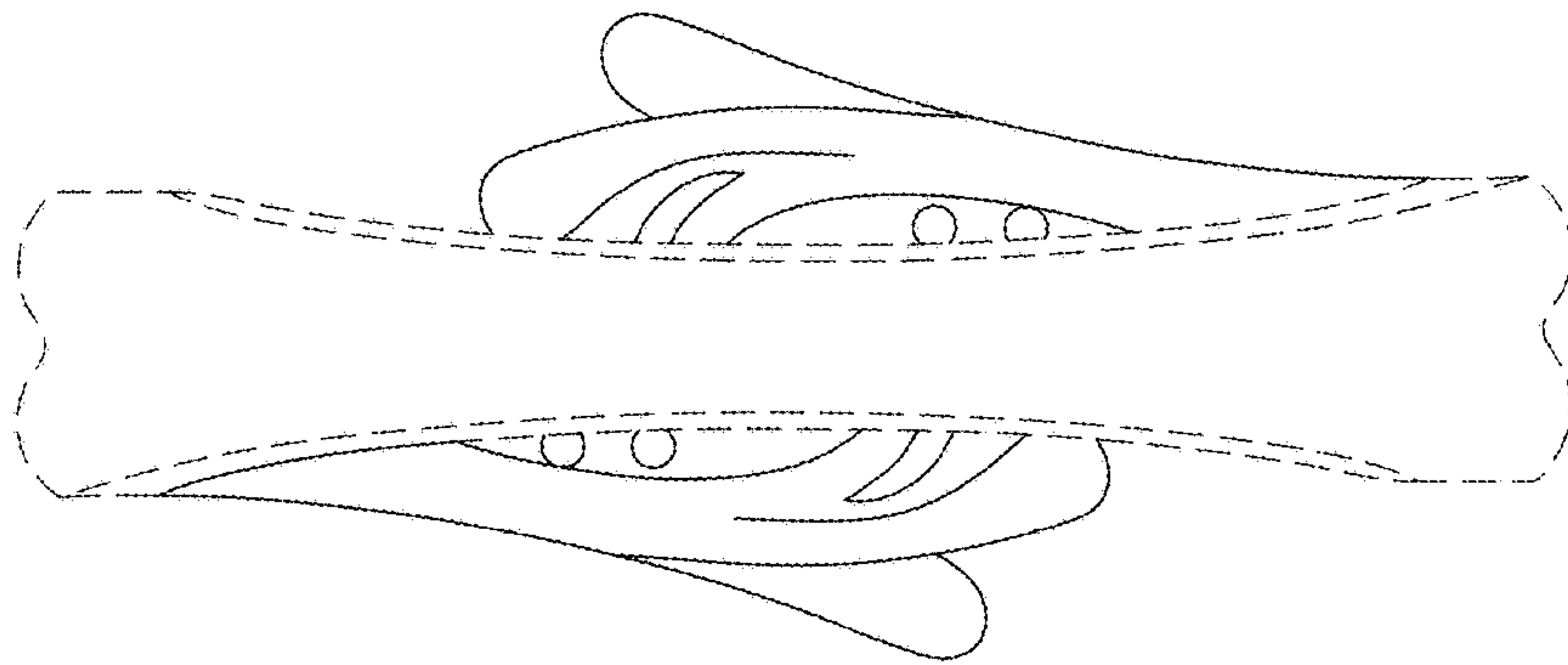
