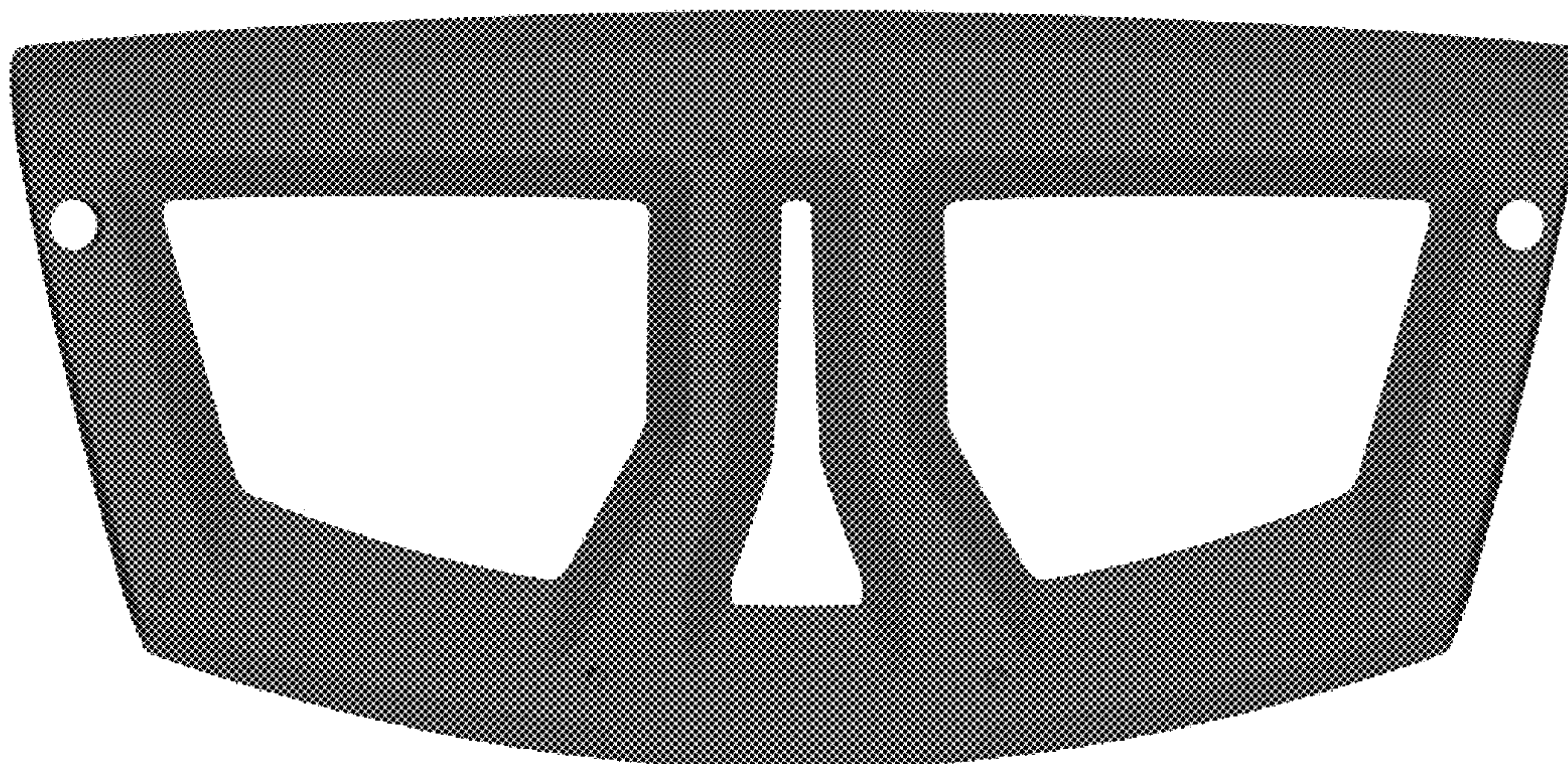
(57) **CLAIM**

The ornamental design for an instrument panel for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front right perspective view of an instrument panel for a vehicle according to the present invention. FIG. 2 is a front left perspective view thereof. FIG. 3 is a rear left perspective view thereof. FIG. 4 is a rear right perspective view thereof. FIG. 5 is a front top perspective view thereof. FIG. 6 is a rear top perspective view thereof. 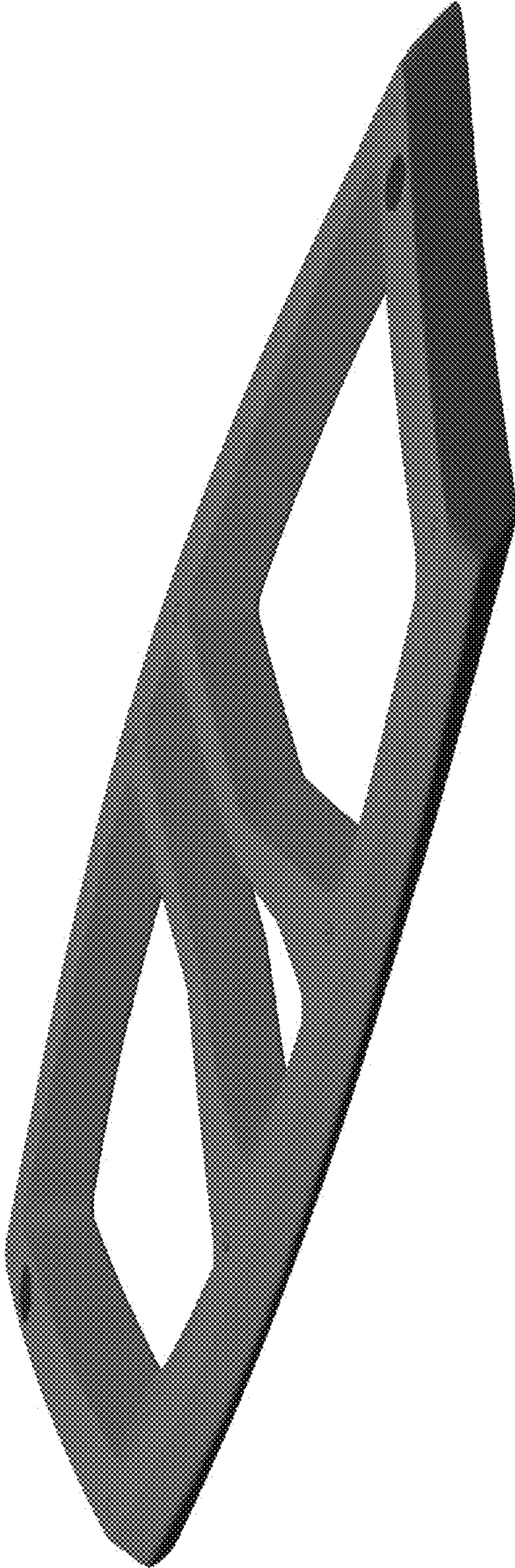

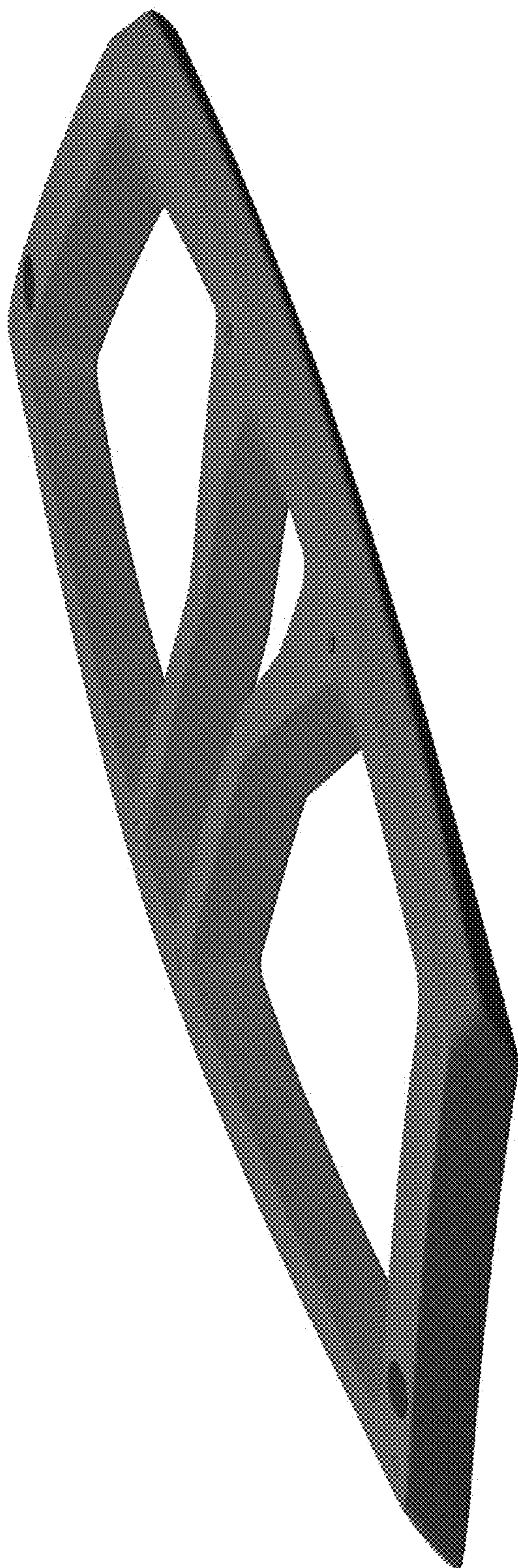

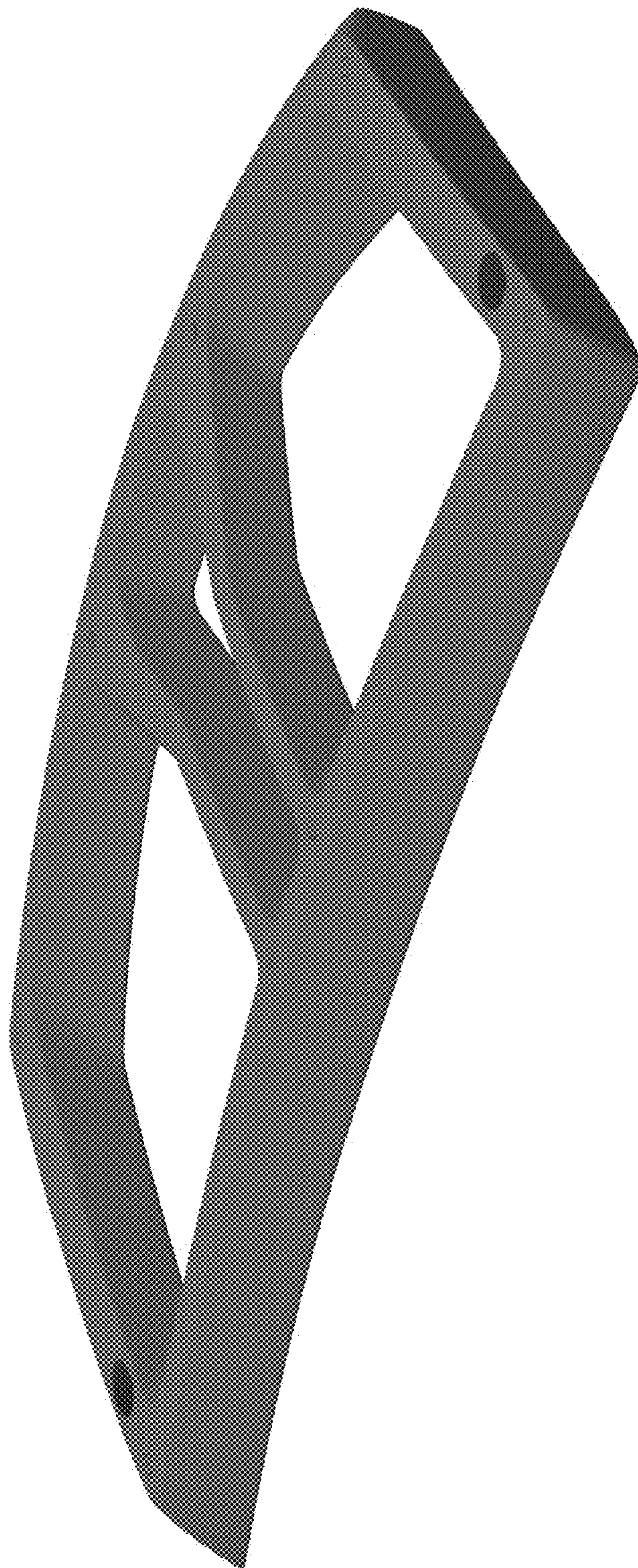

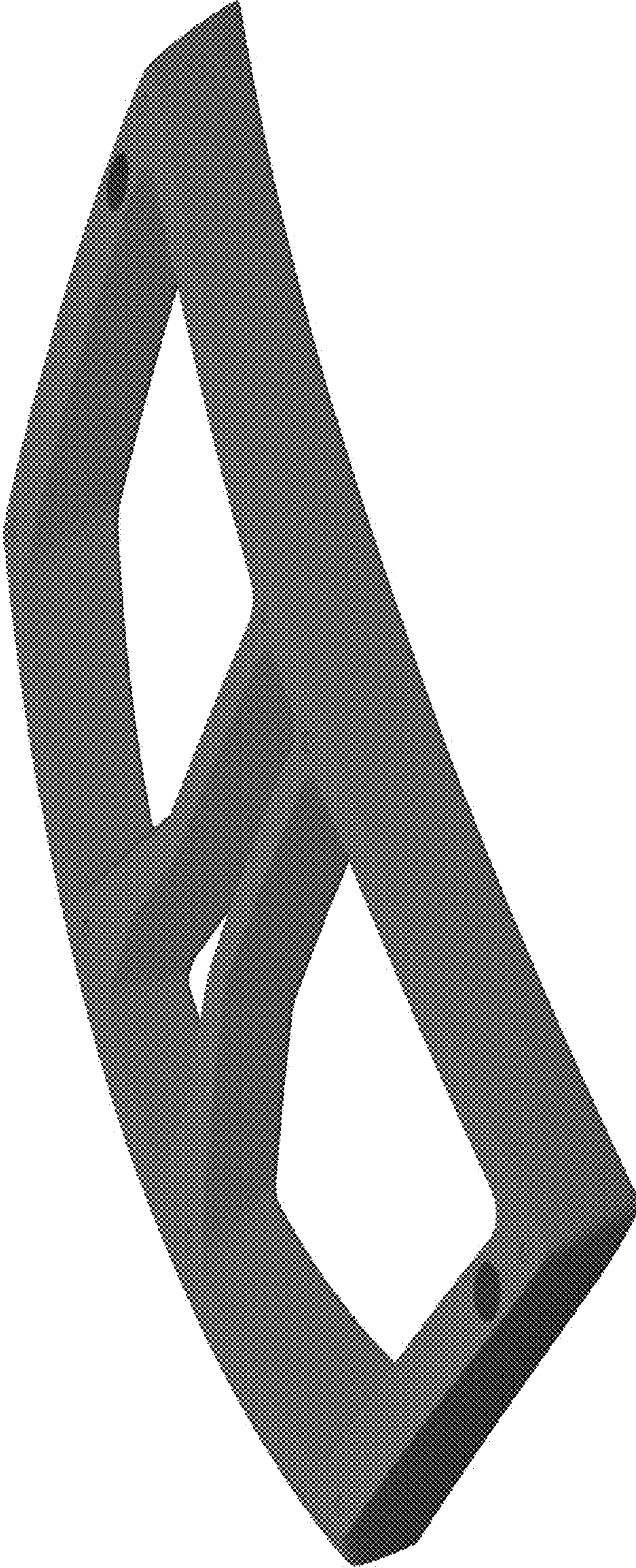

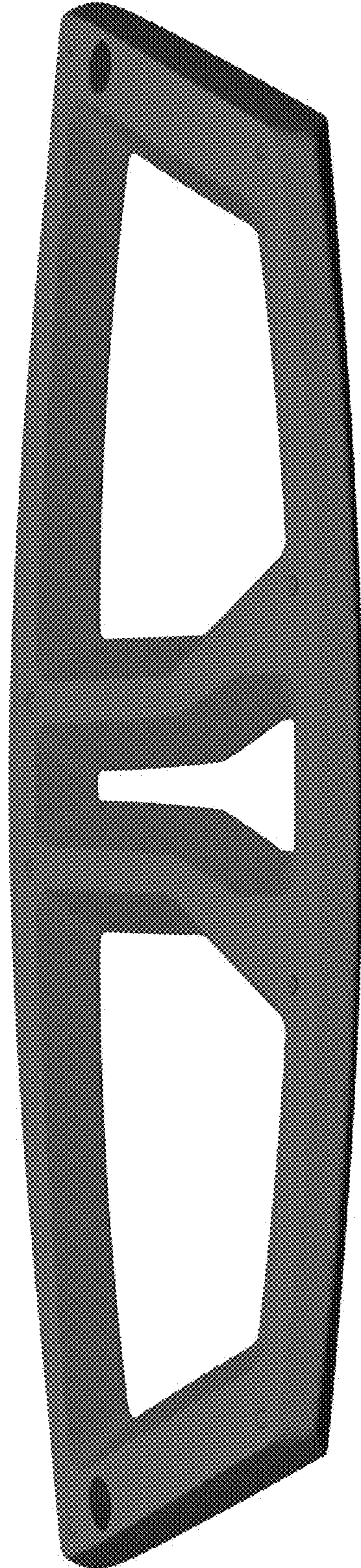

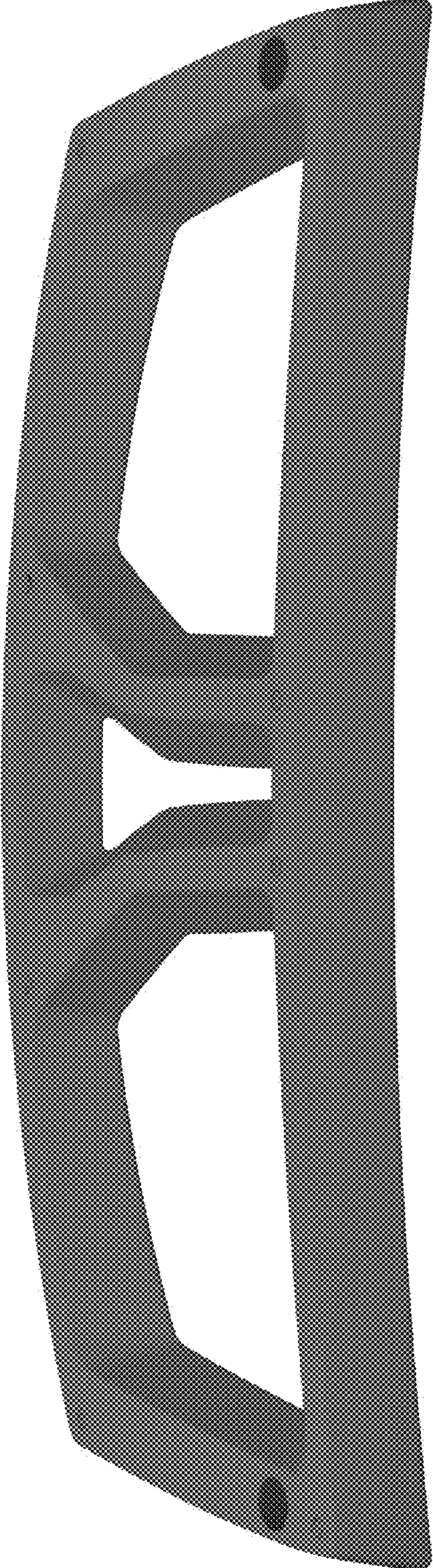

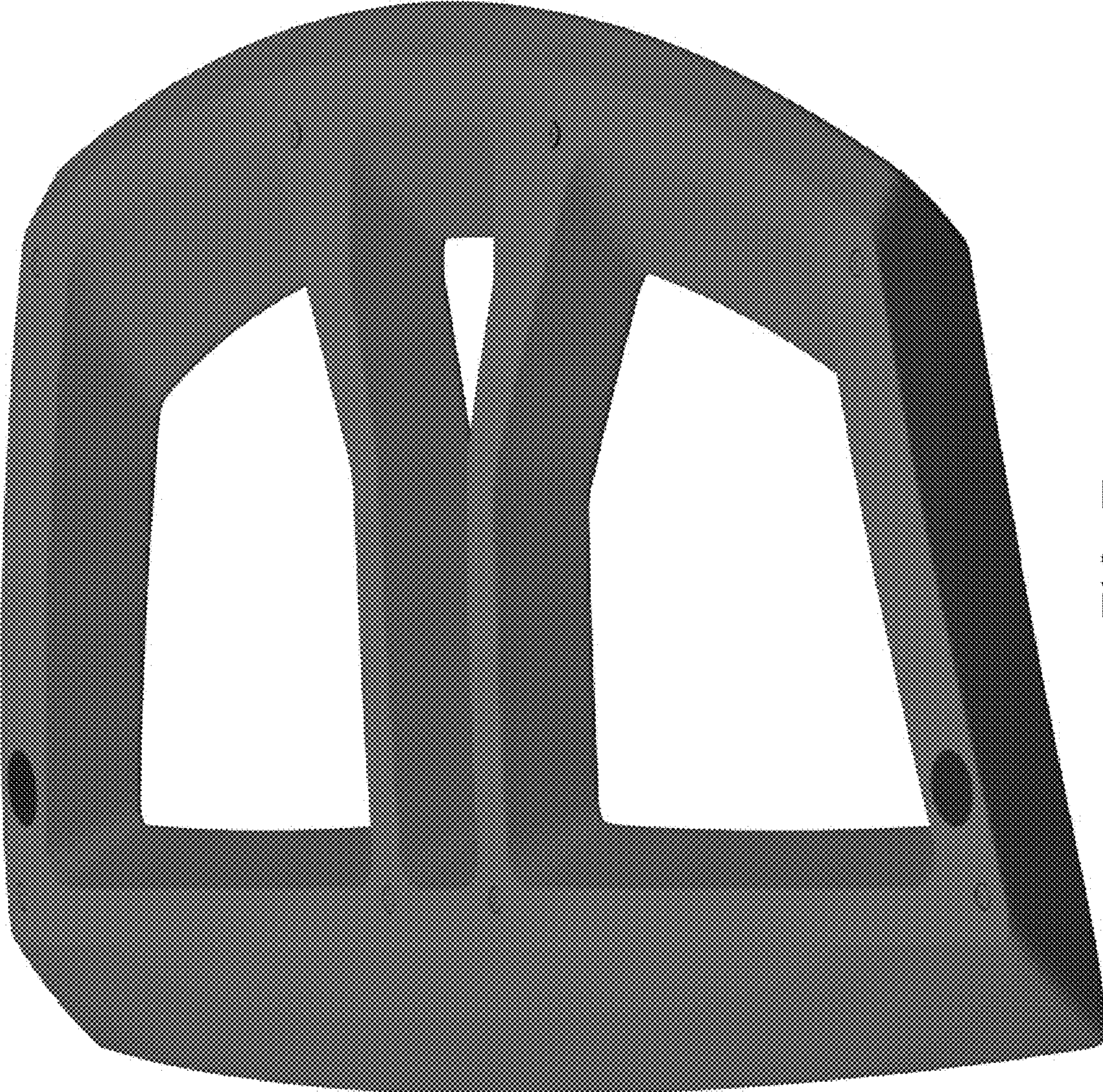

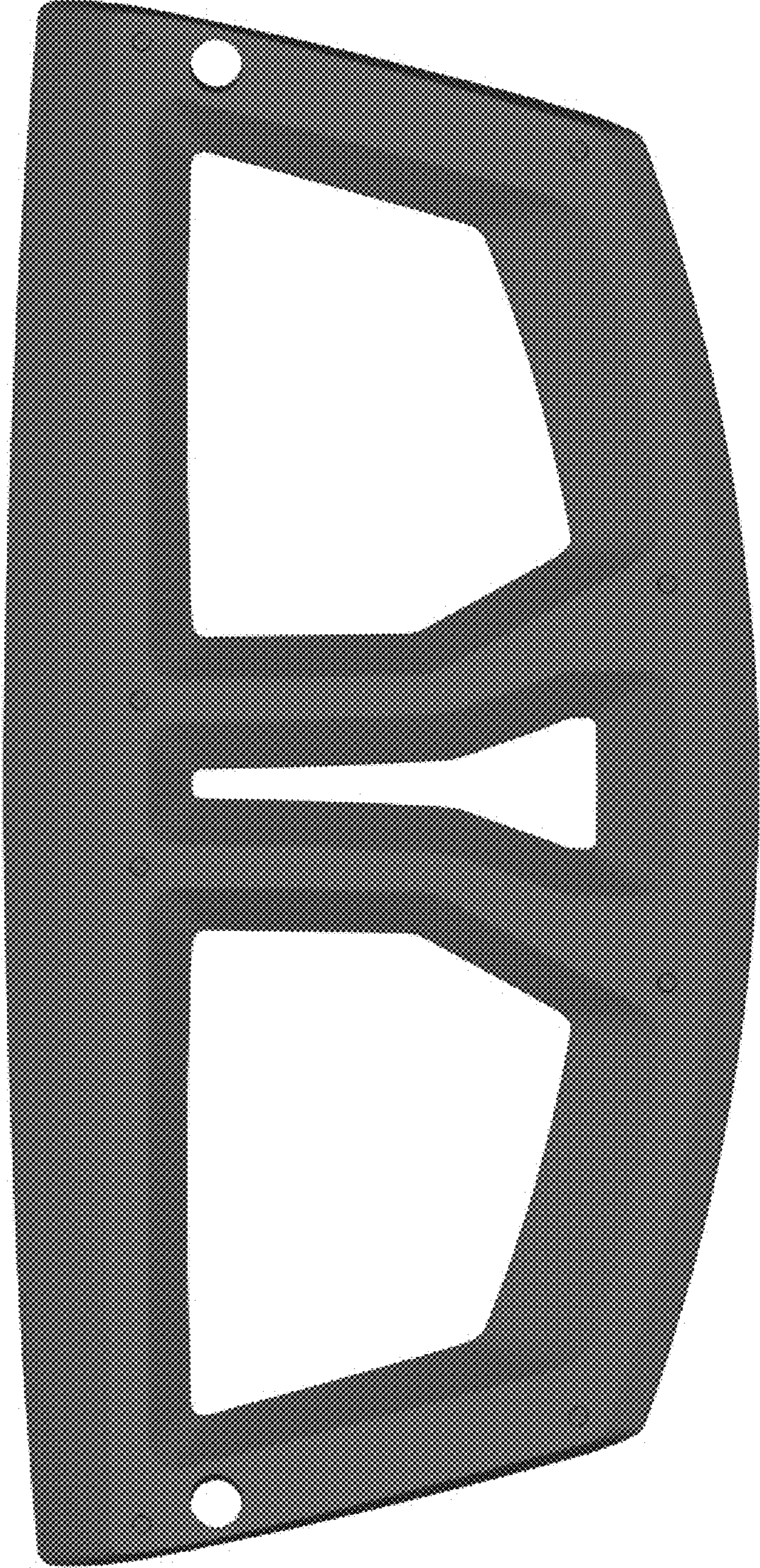

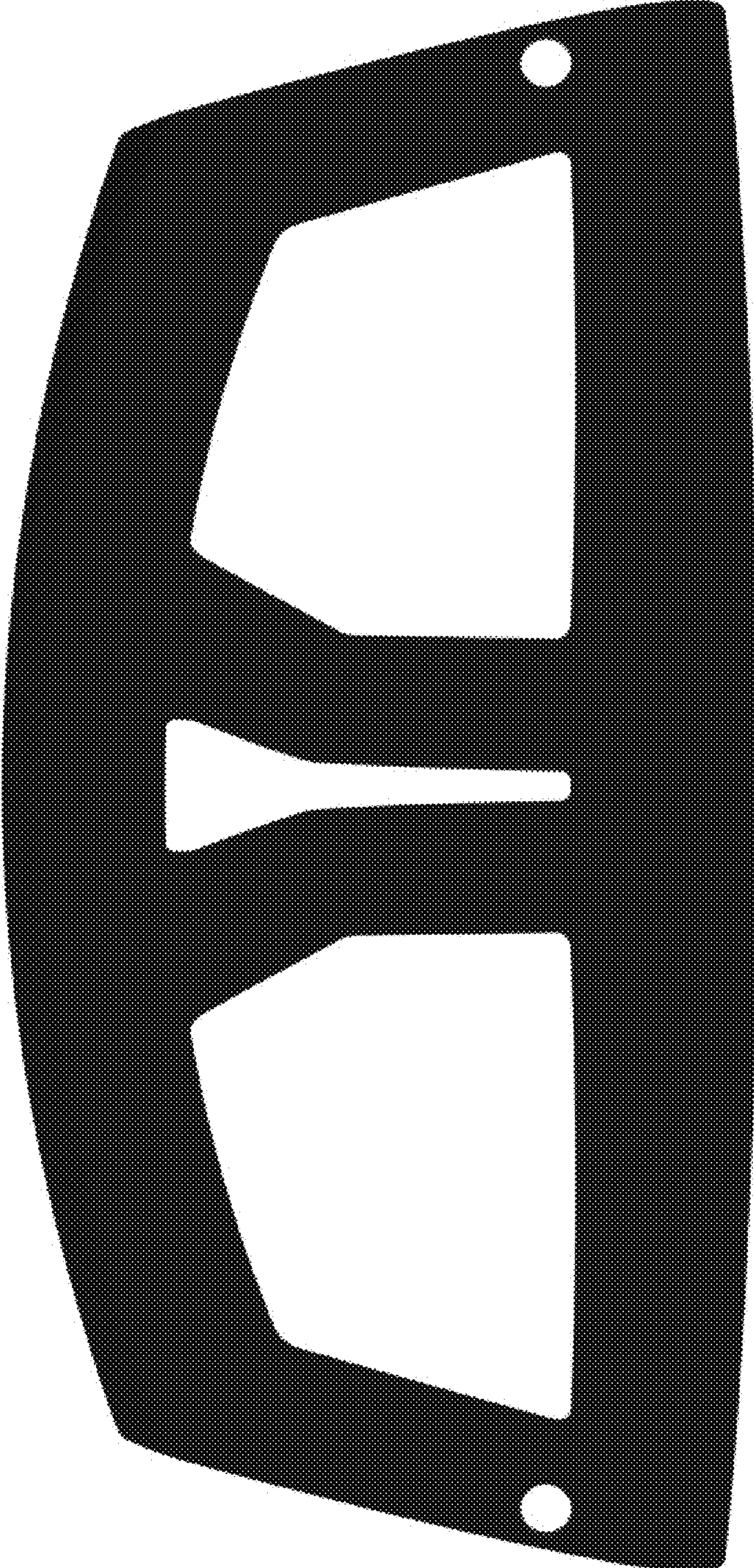
