The ornamental design for a vehicle wheel, toy vehicle wheel, and/or replicas thereof, as shown and described.

DESCRIPTION

FIG. 3 is an additional perspective view thereof;

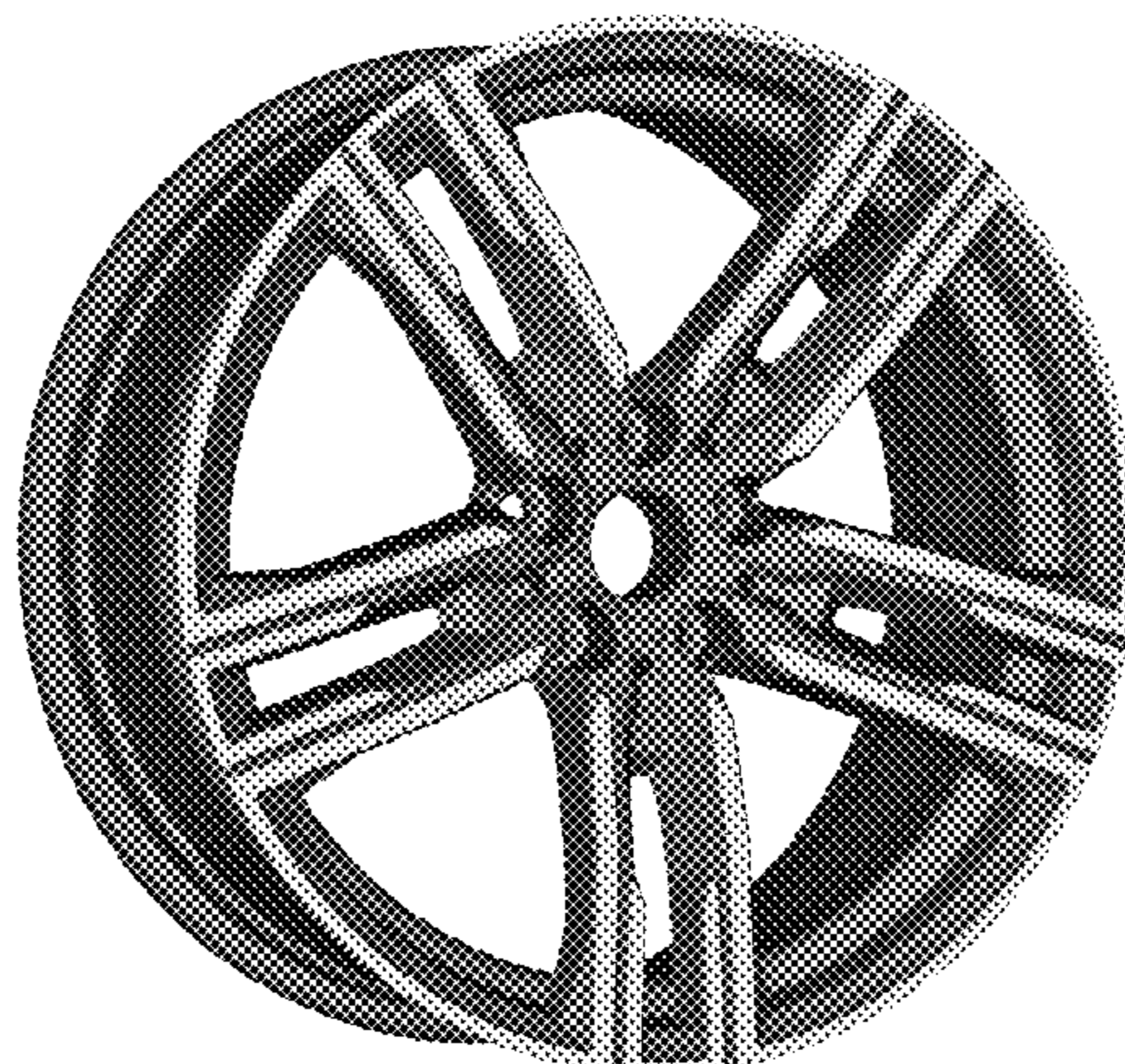
FIG. 4 is a front view thereof;

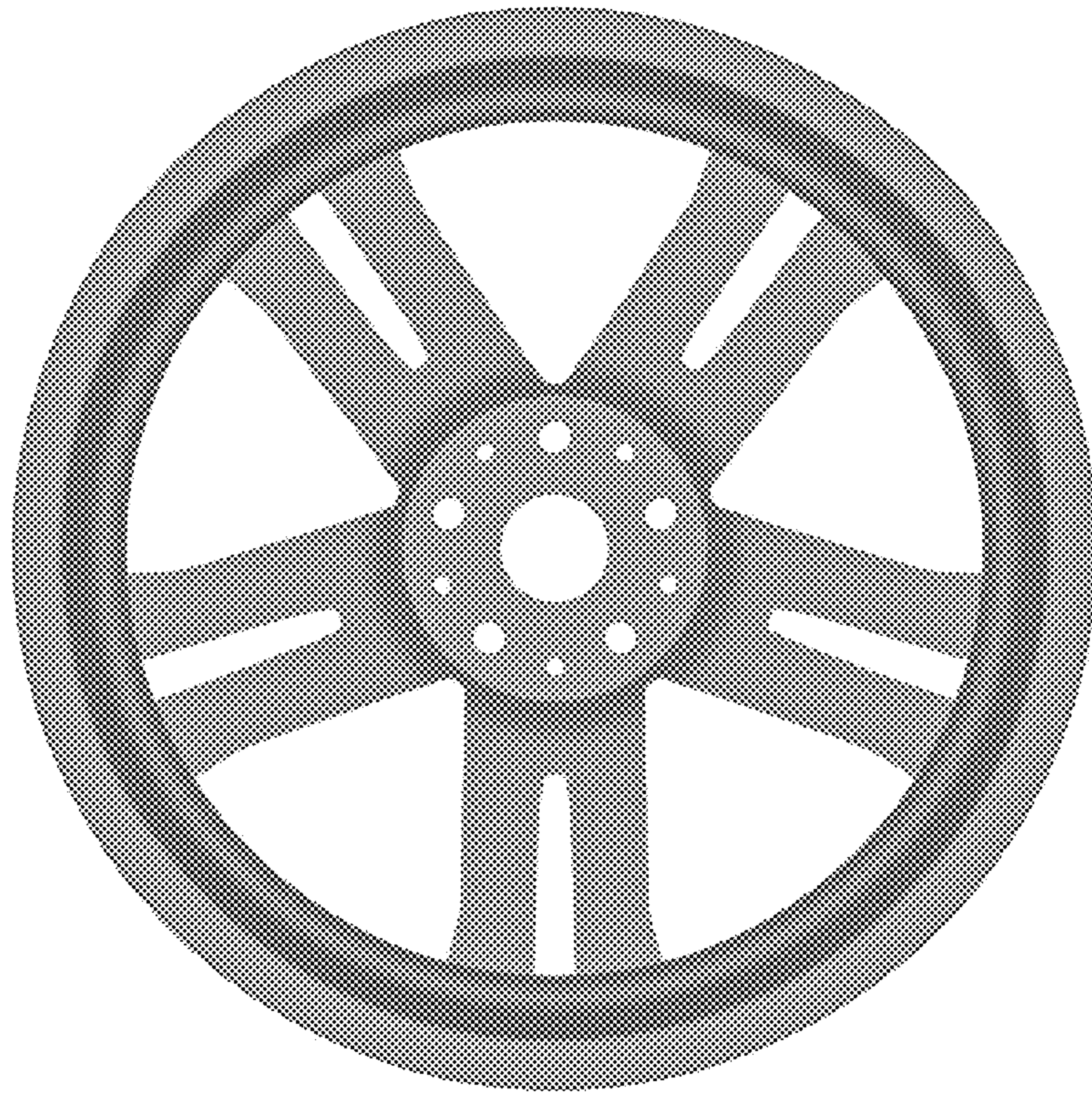

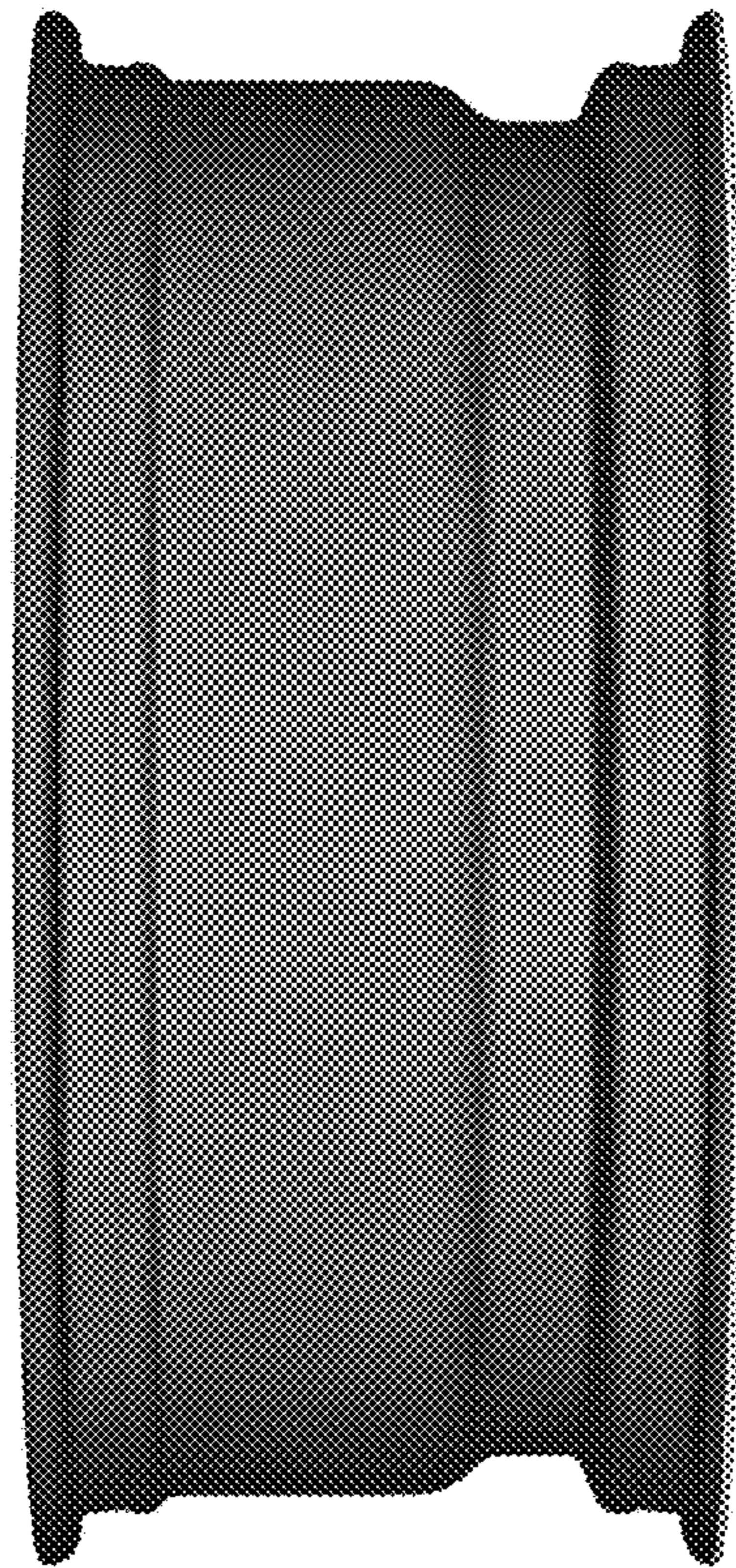
