 FIG. 10 is a rear perspective view of thereof showing the lower portion in the open position.

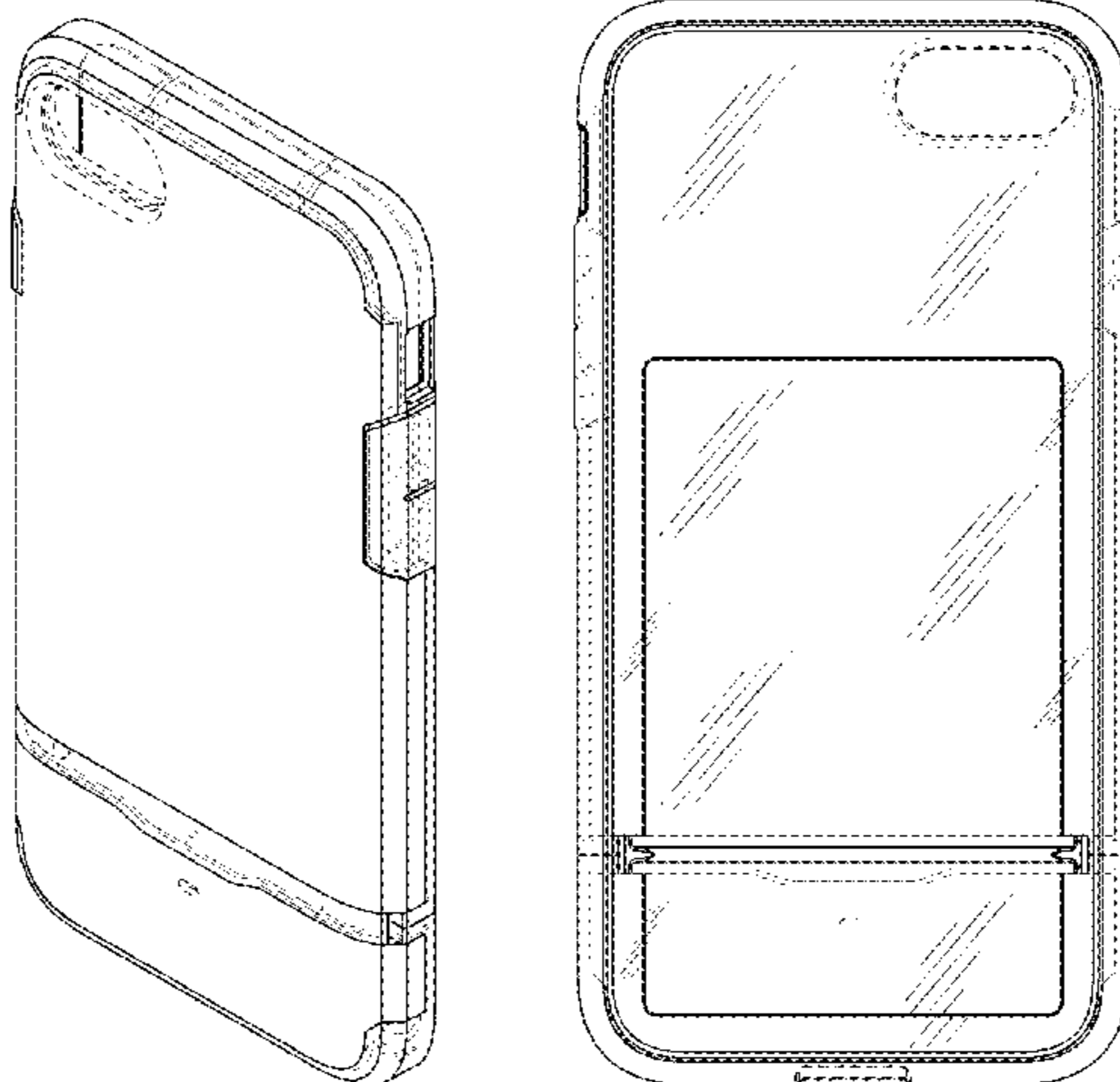

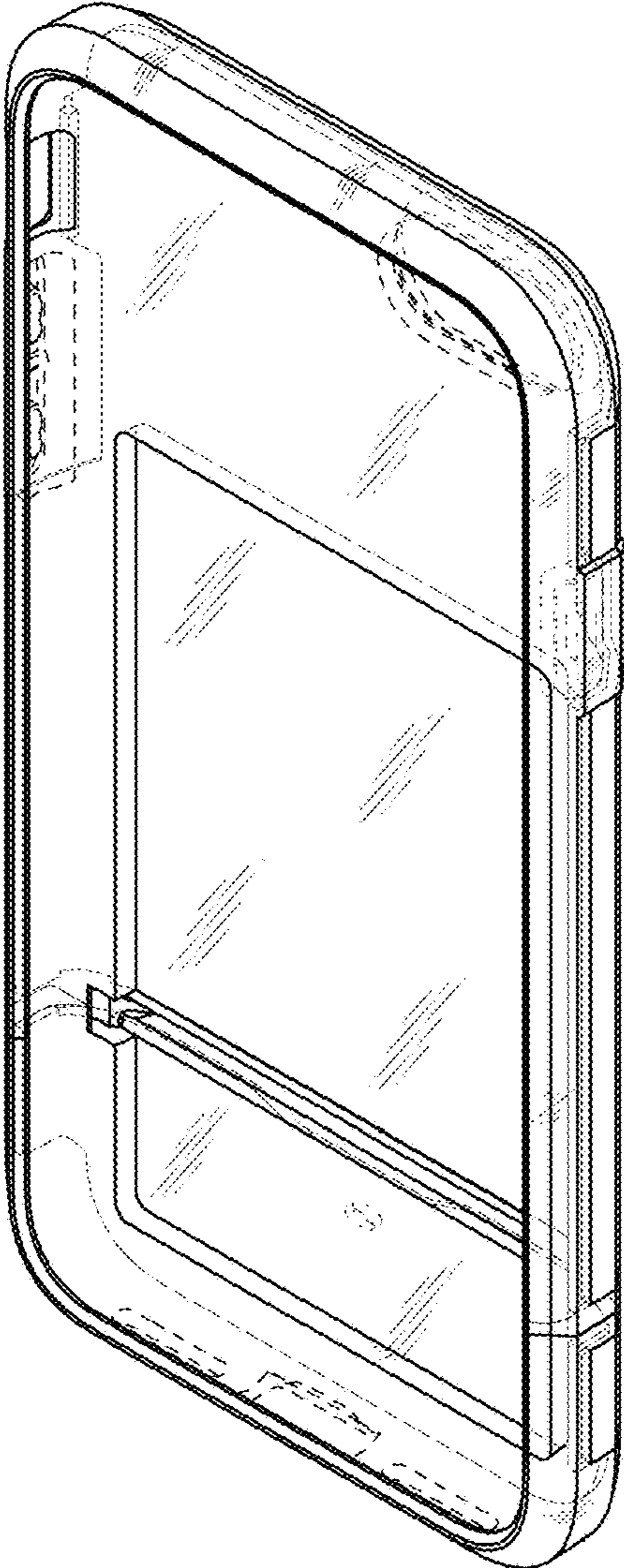

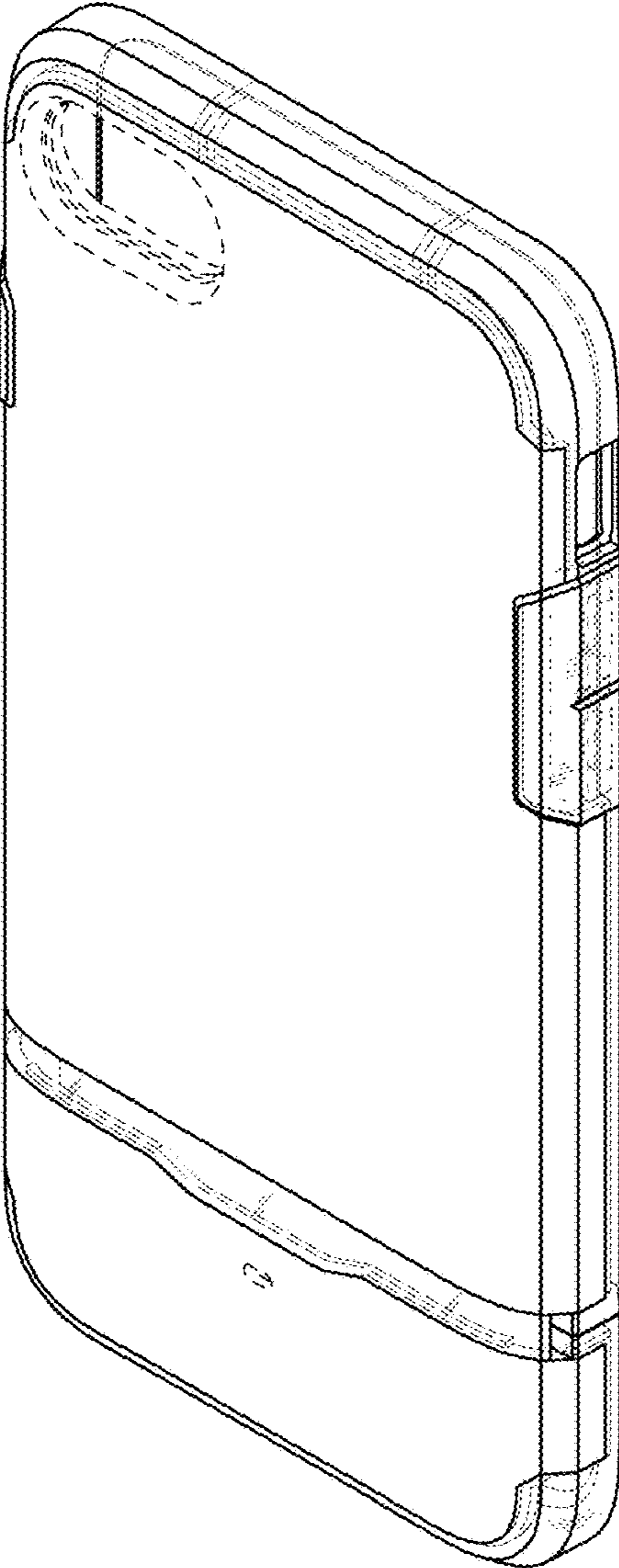

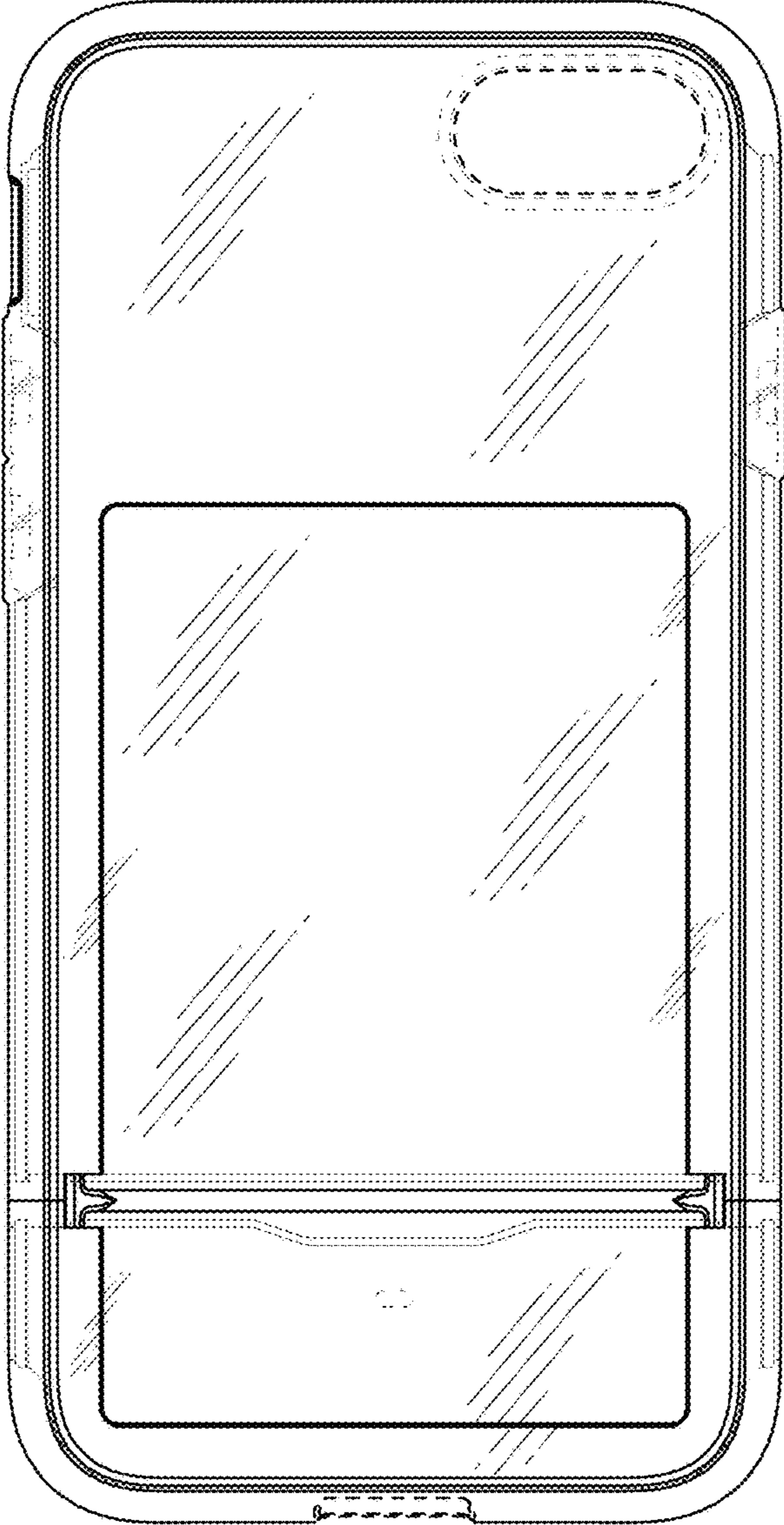

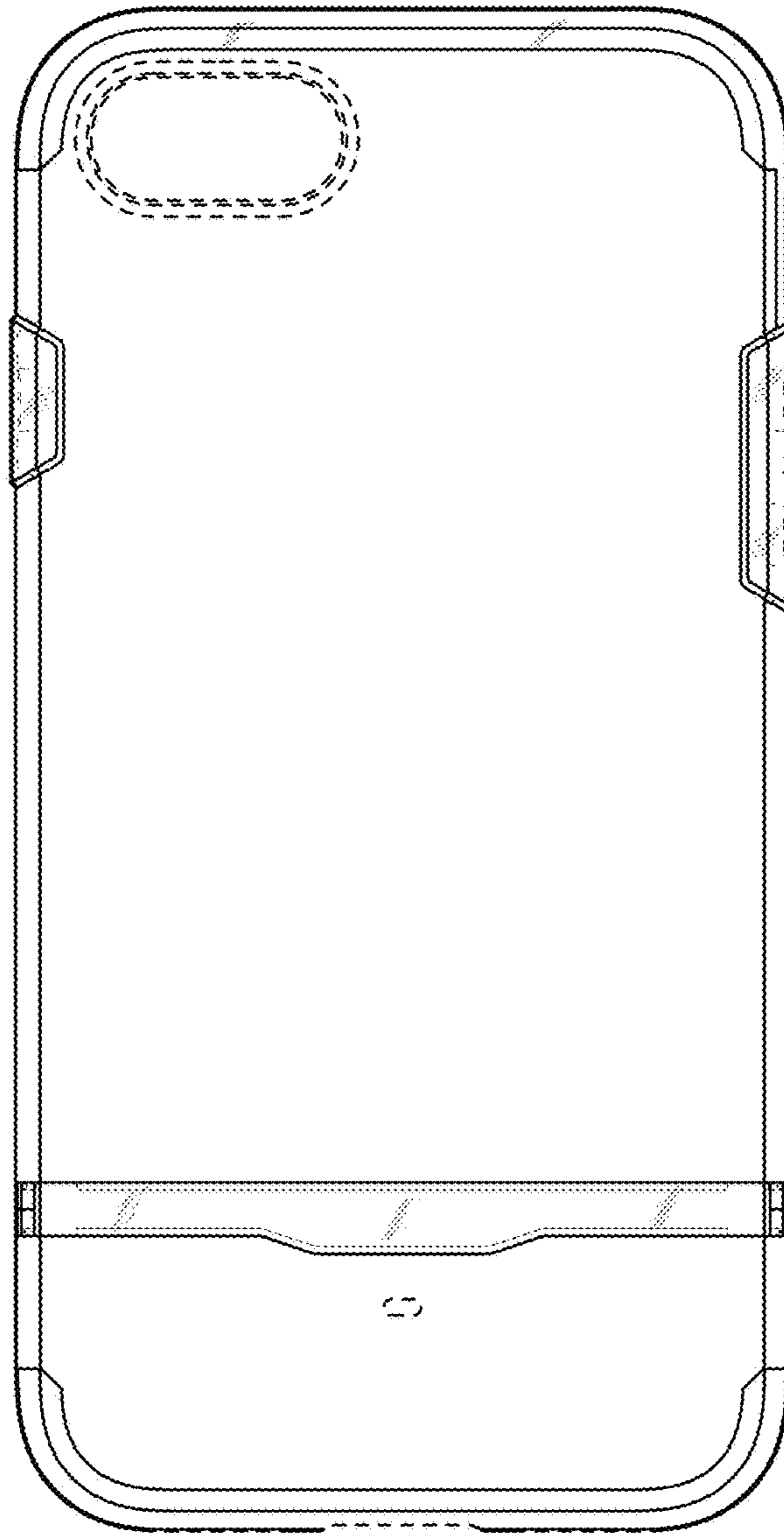

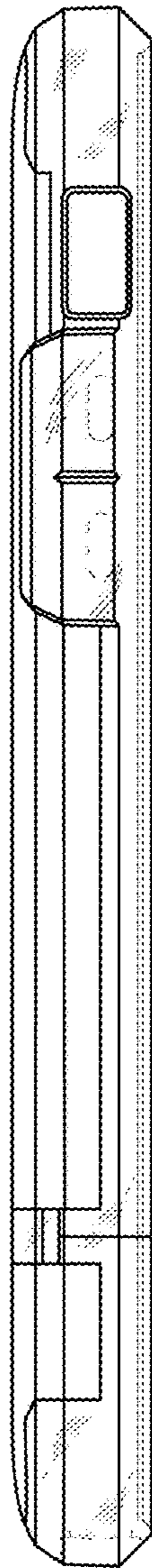

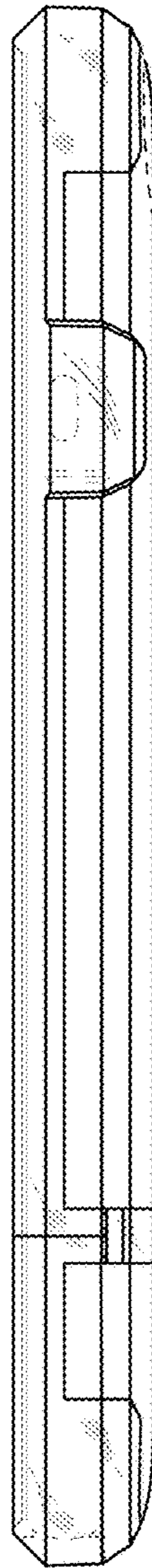

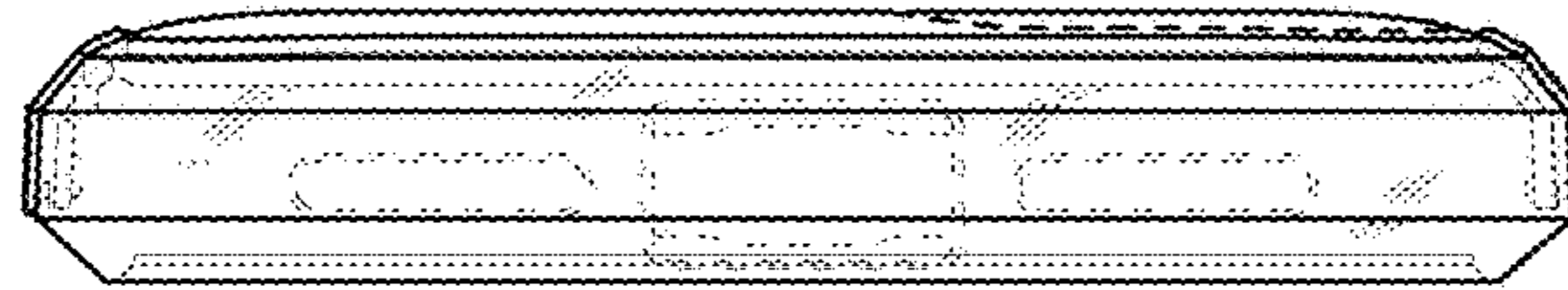

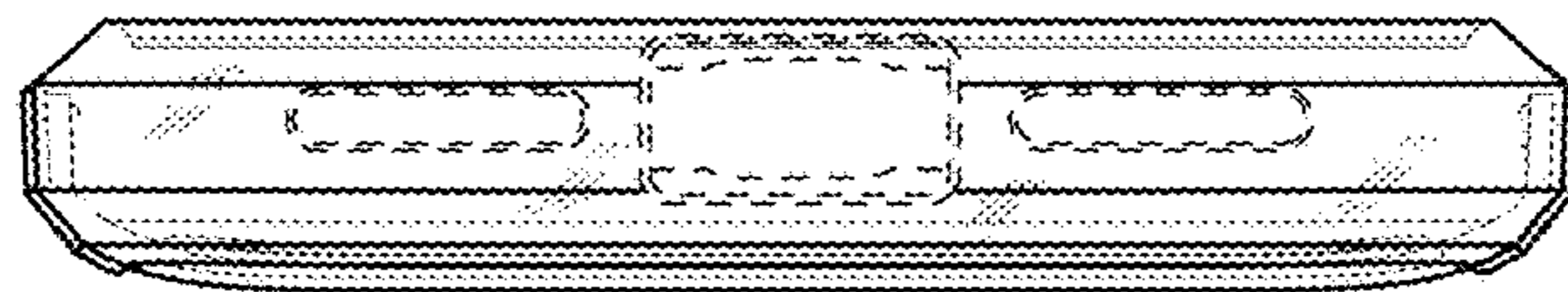

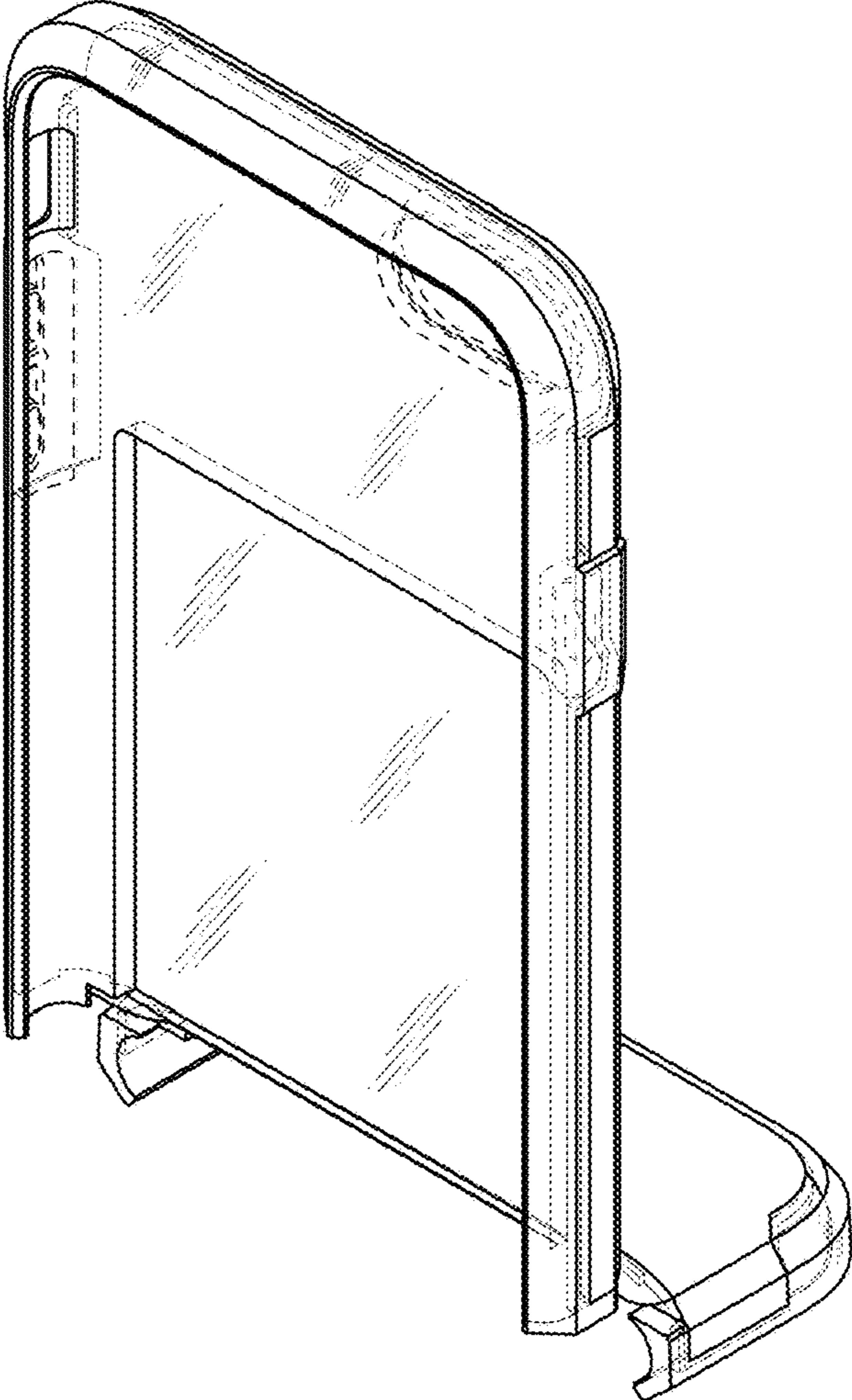
