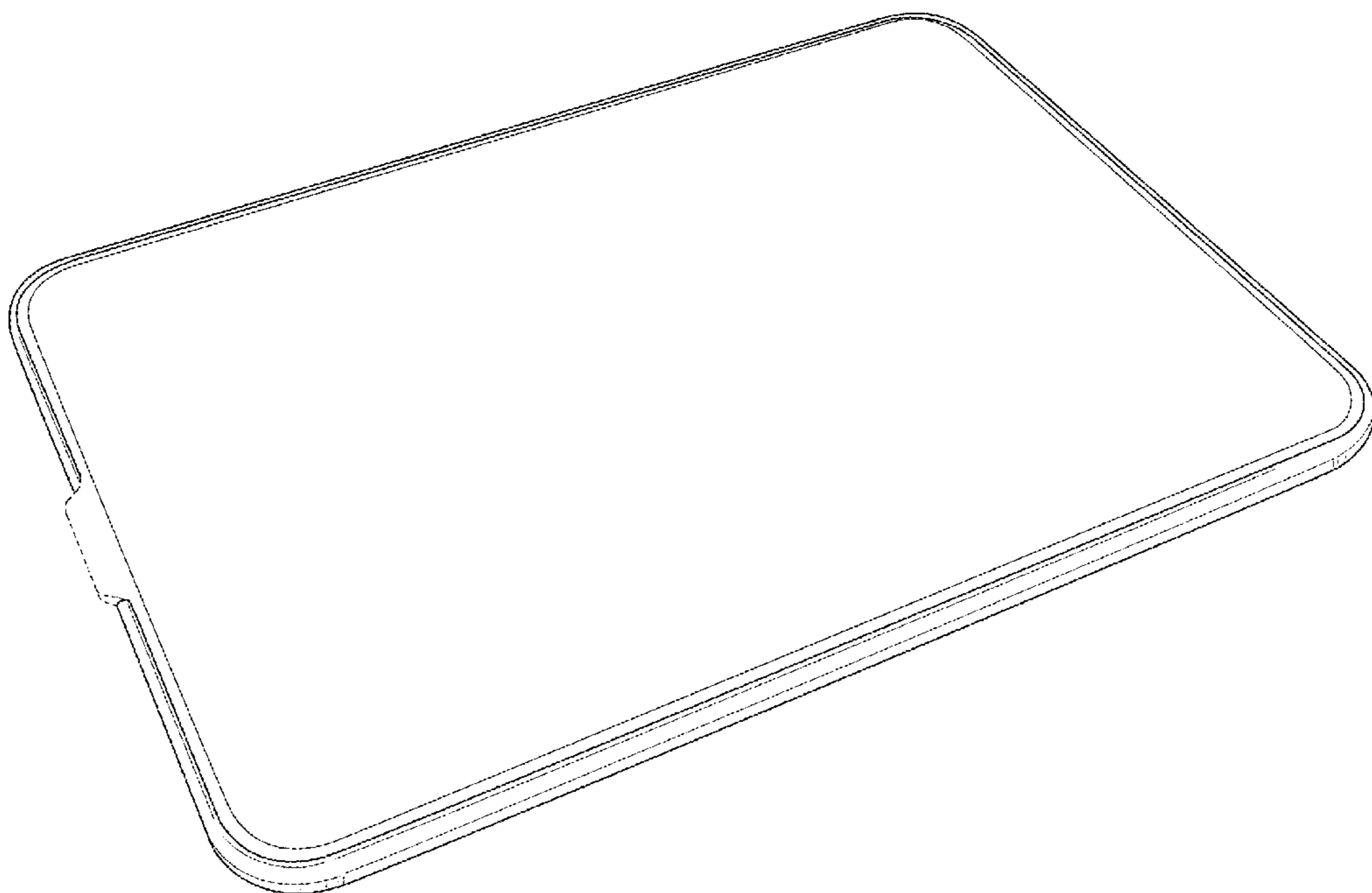
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of an electronic device sleeve showing our new design.  
FIG. 2 is a back view thereof.  
FIG. 3 is an upper-side view thereof.  
FIG. 4 is a lower-side view thereof.

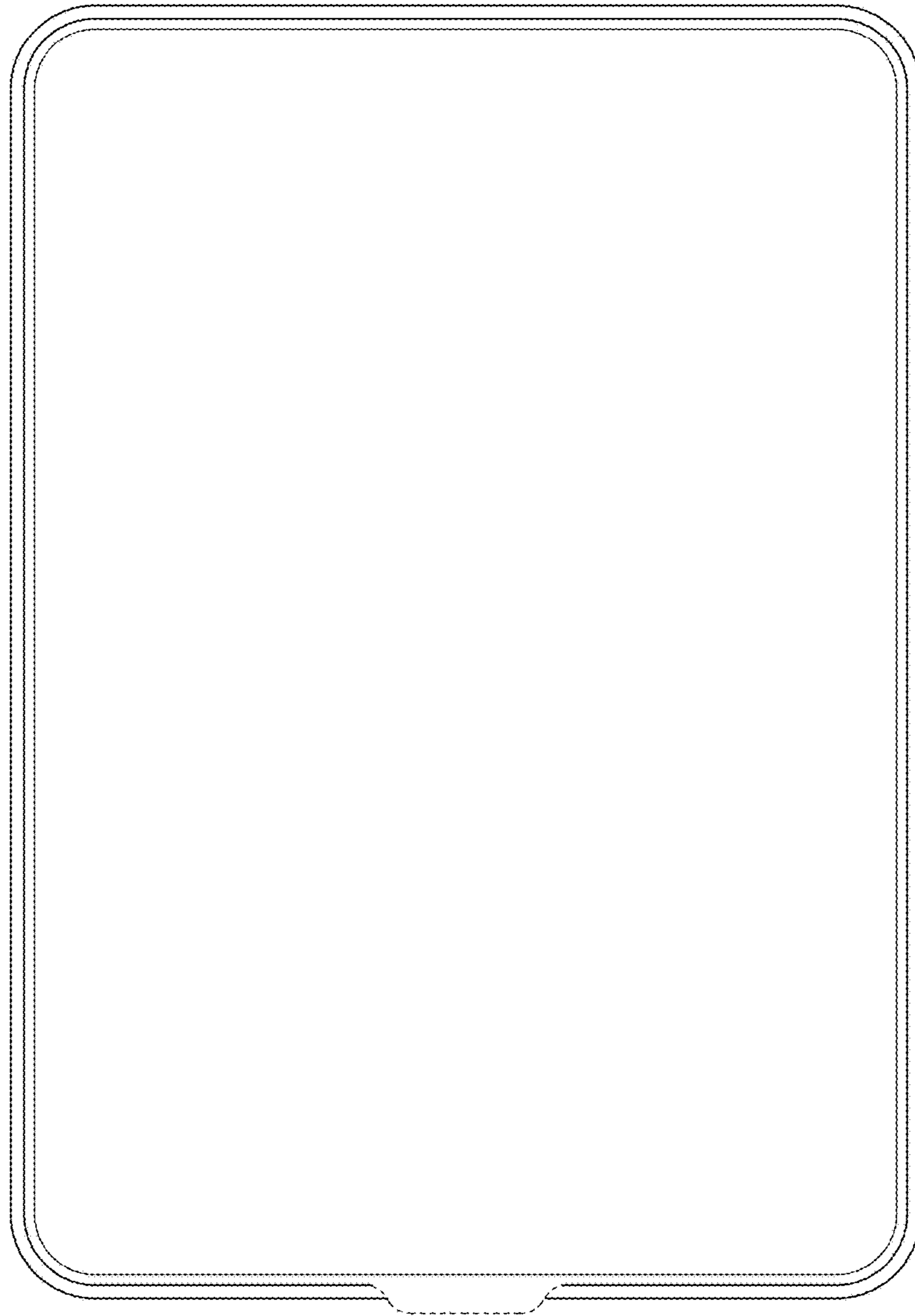

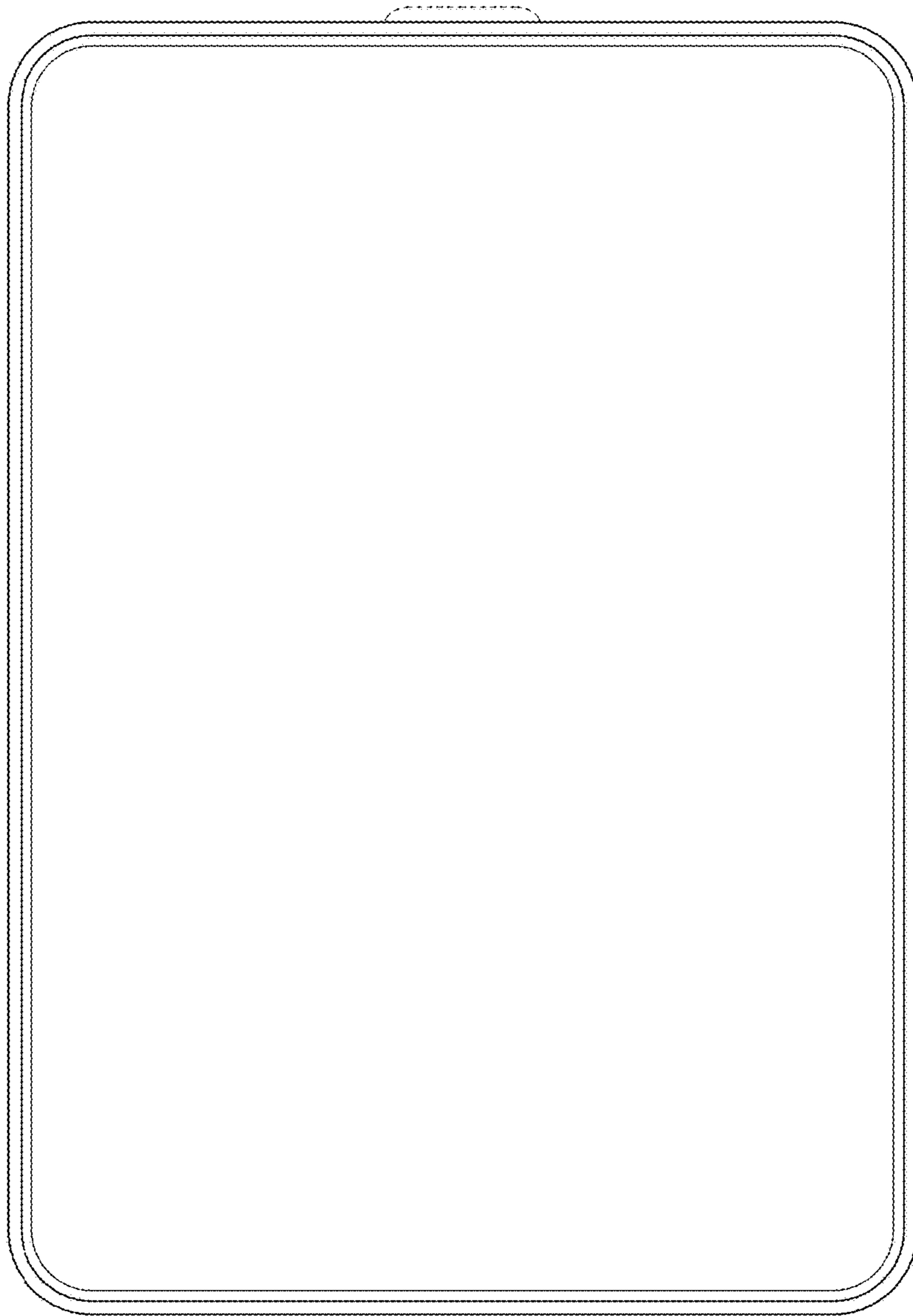

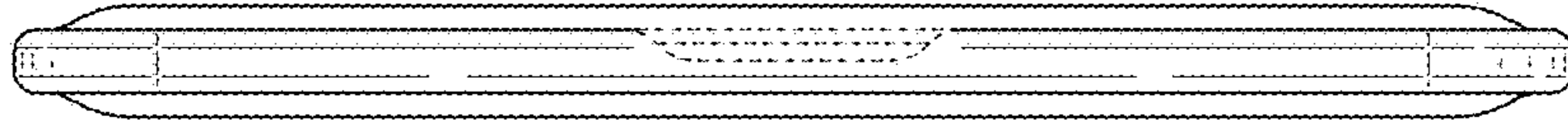

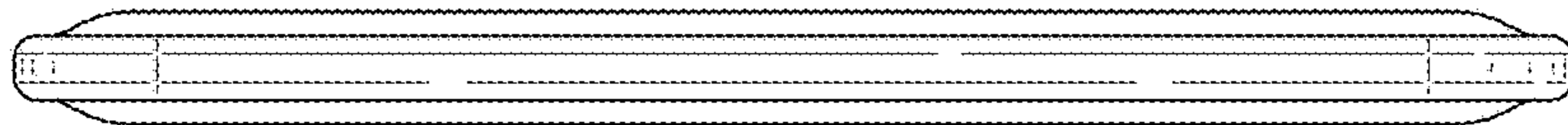

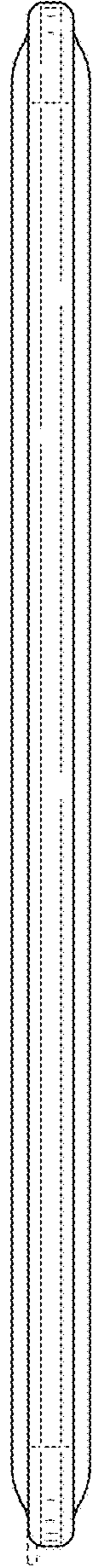

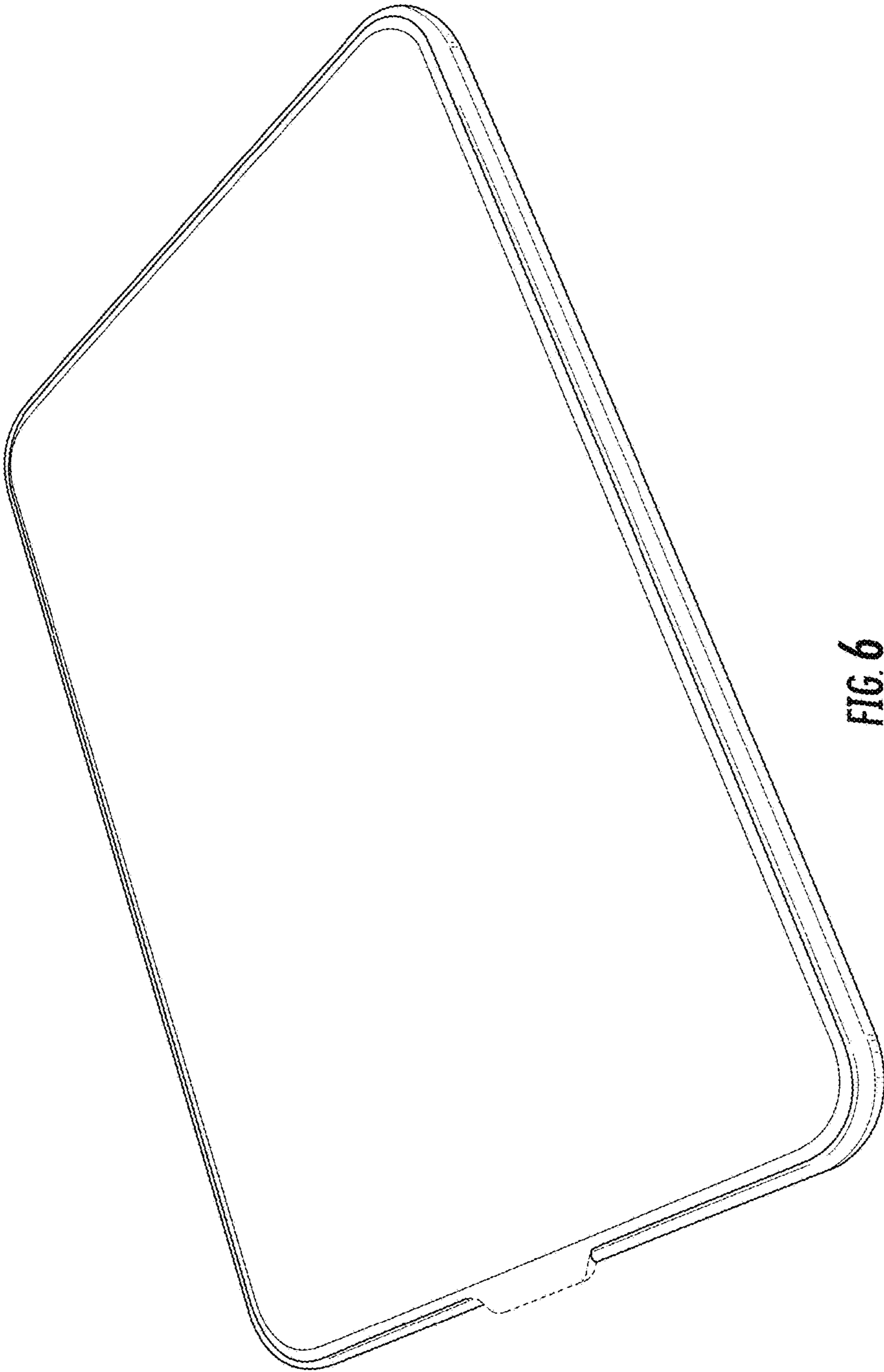
