(57) **CLAIM**

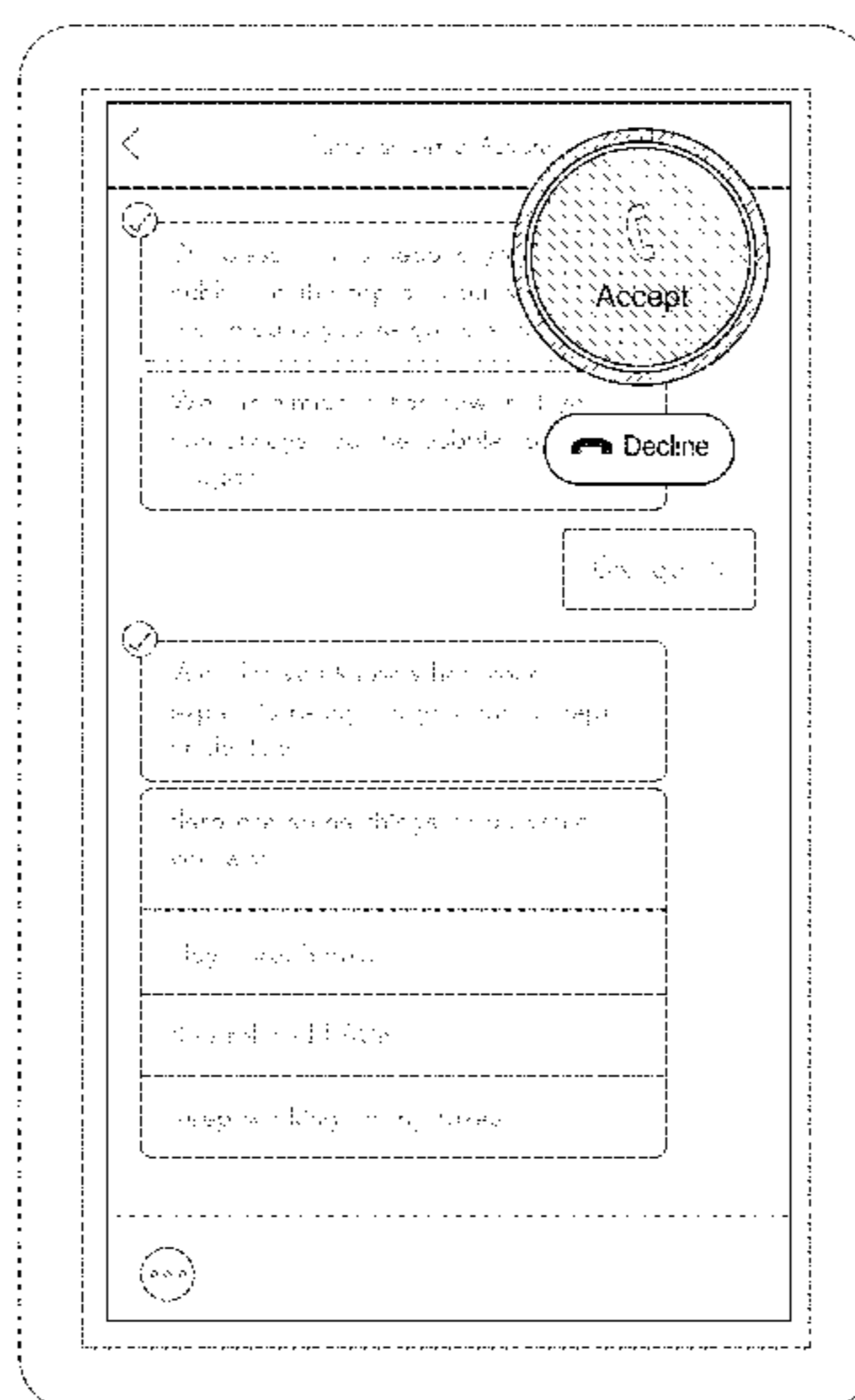
The ornamental design for a display device with a graphical user interface presenting a decline option, as shown and described.
