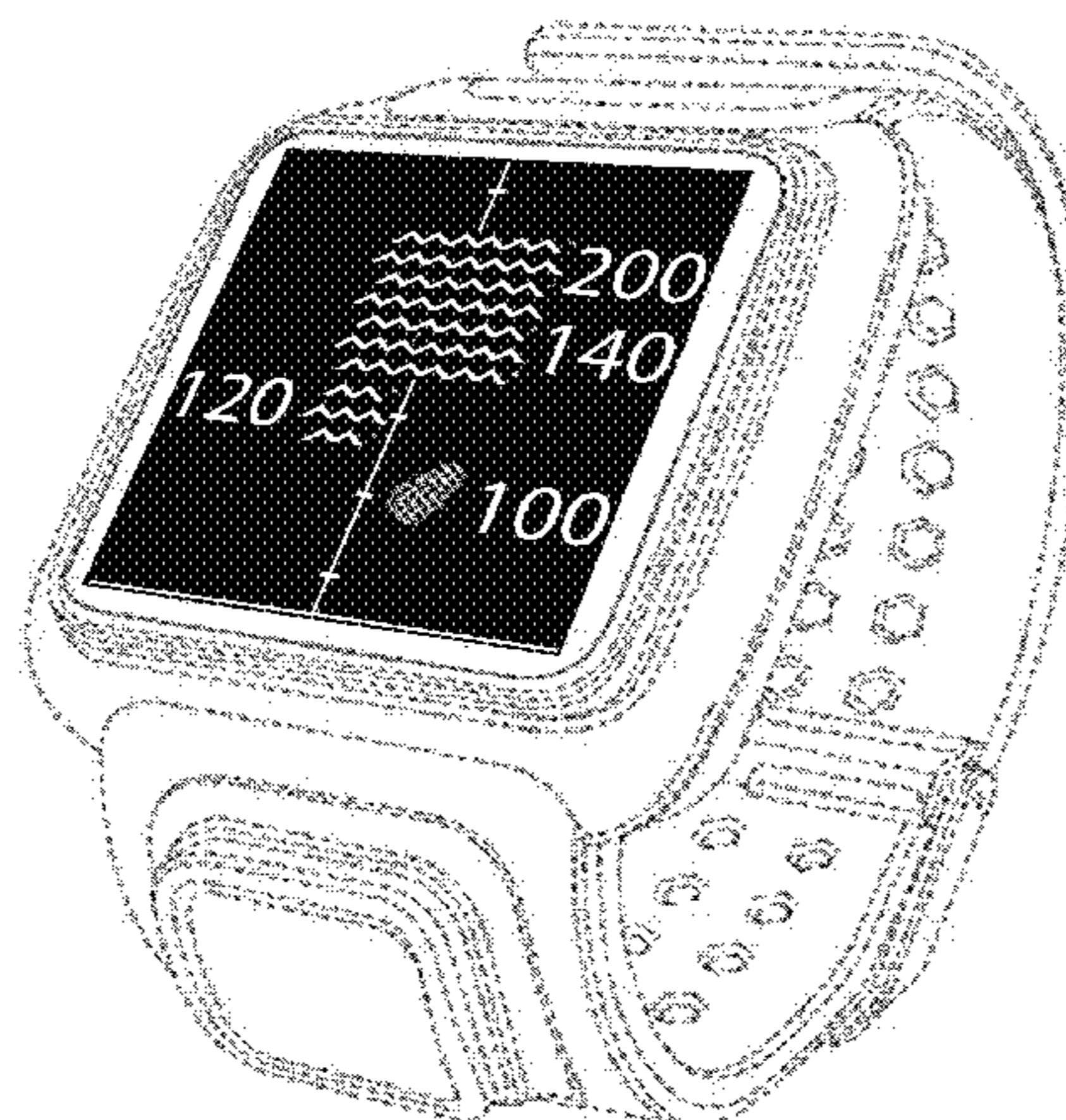
(57) **CLAIM**

The ornamental design for a display panel of an electronic golf device with a computer generated icon, as shown and described.

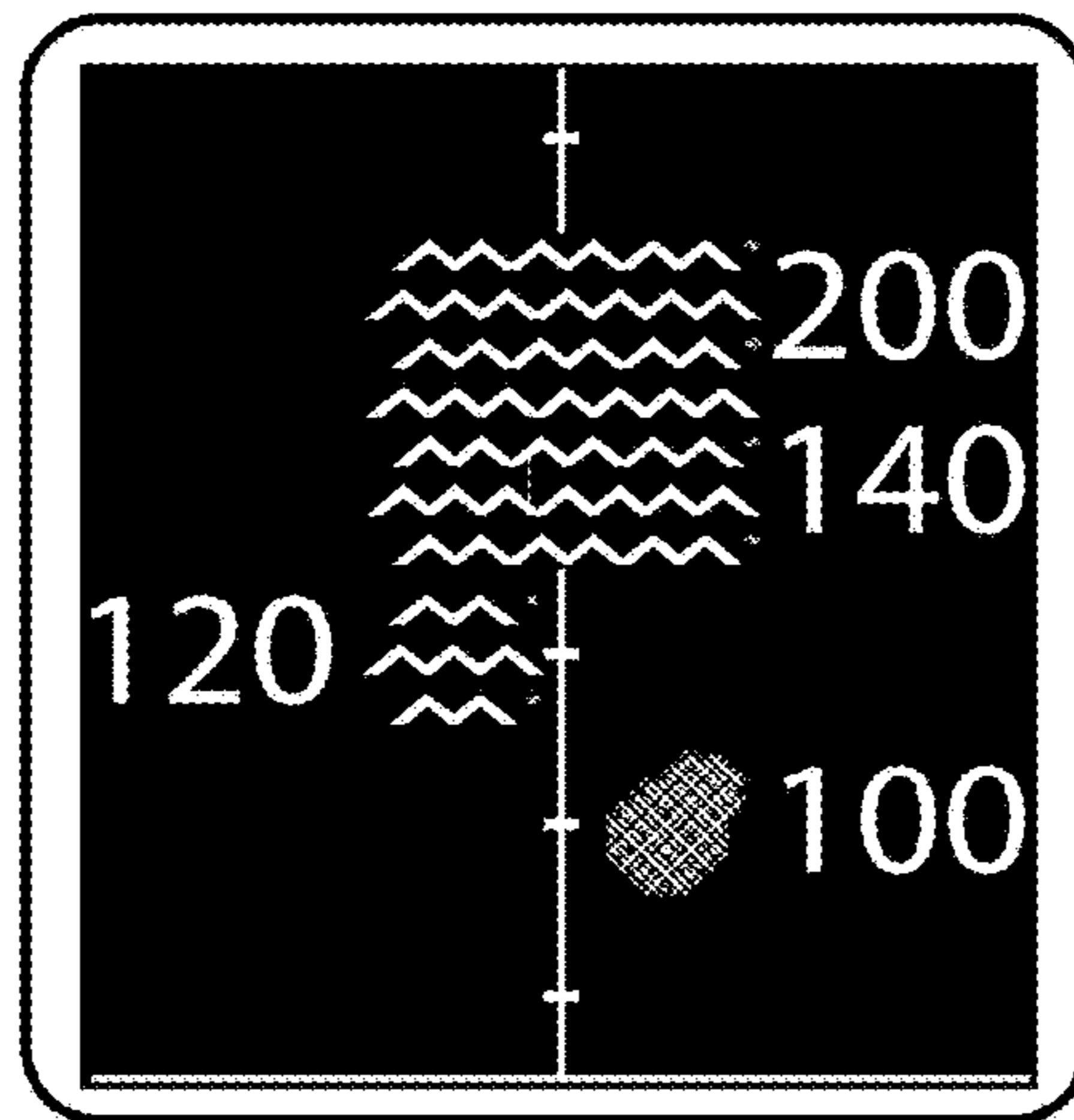
