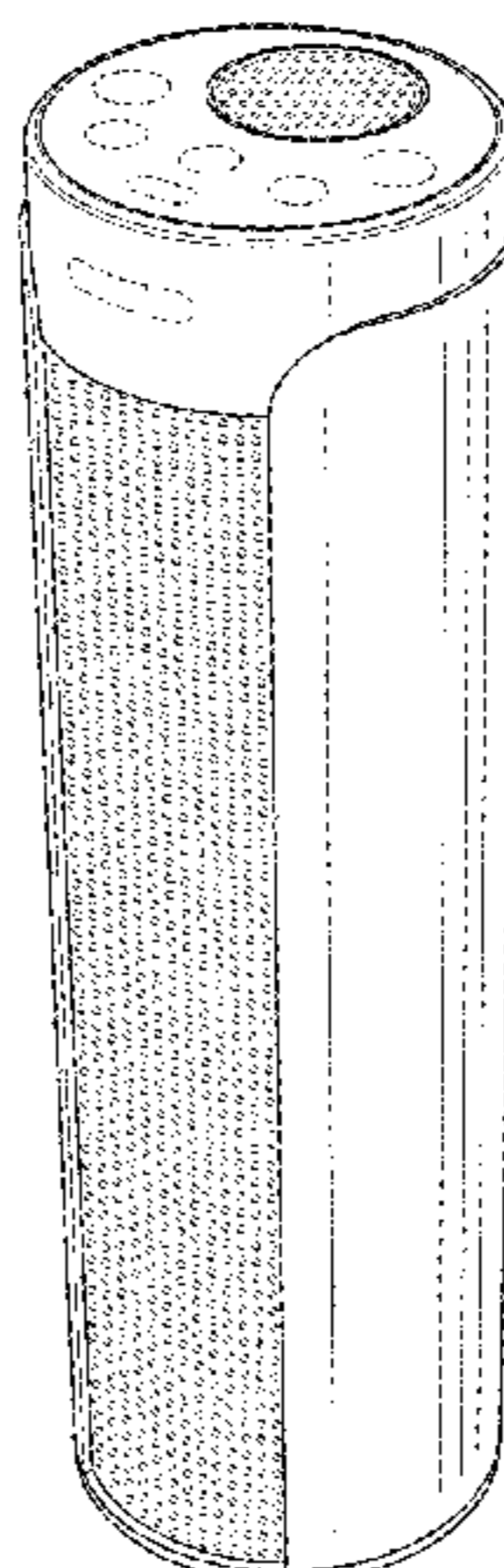
(57) **CLAIM**

The ornamental design for a karaoke device, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a karaoke device showing my new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top perspective view thereof with a broken line portion of the article shown in an alternate position;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a left side elevational view thereof;
FIG. 8 is a top plan view thereof; and,
FIG. 9 is a bottom plan view thereof.
The broken lines show portions of the karaoke device which form no part of the claimed design.

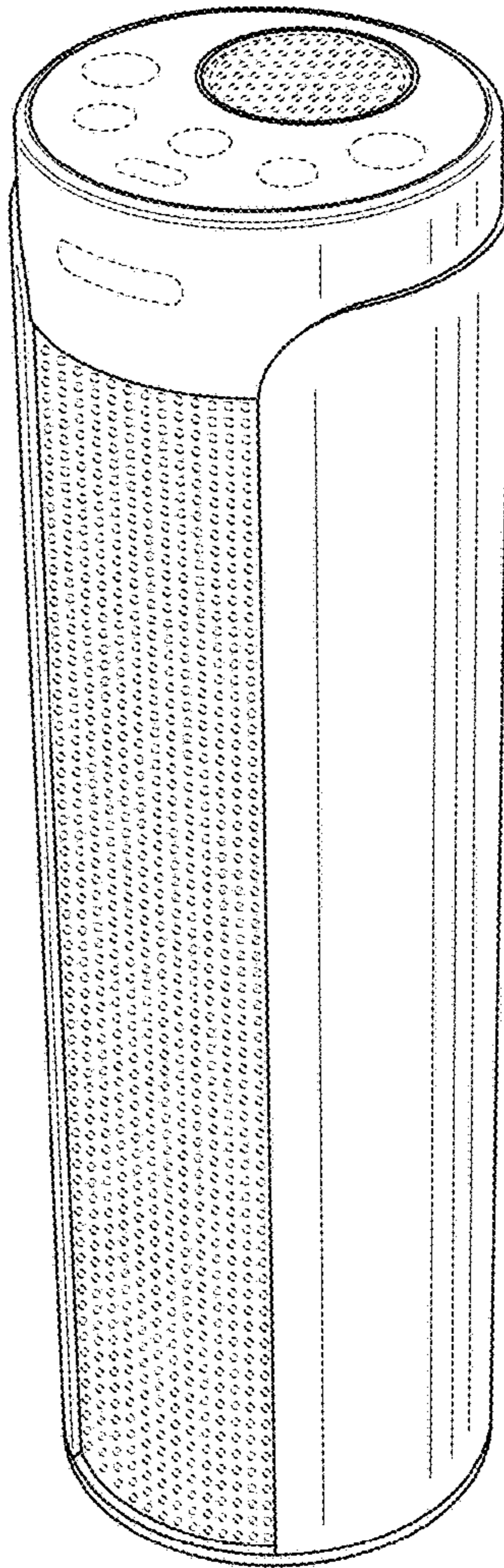

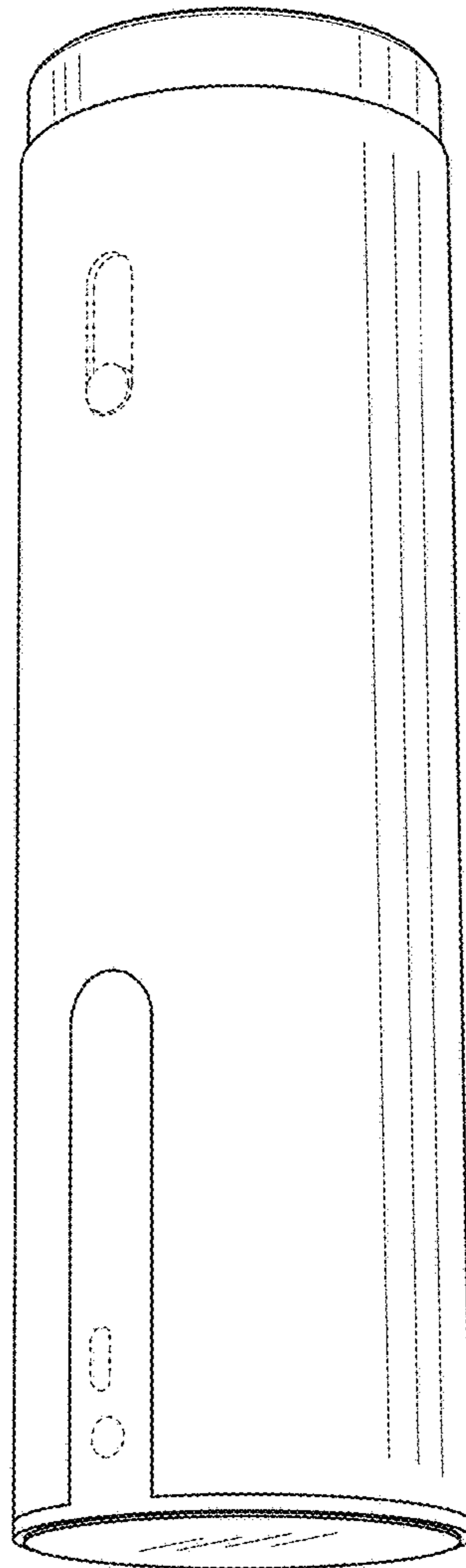

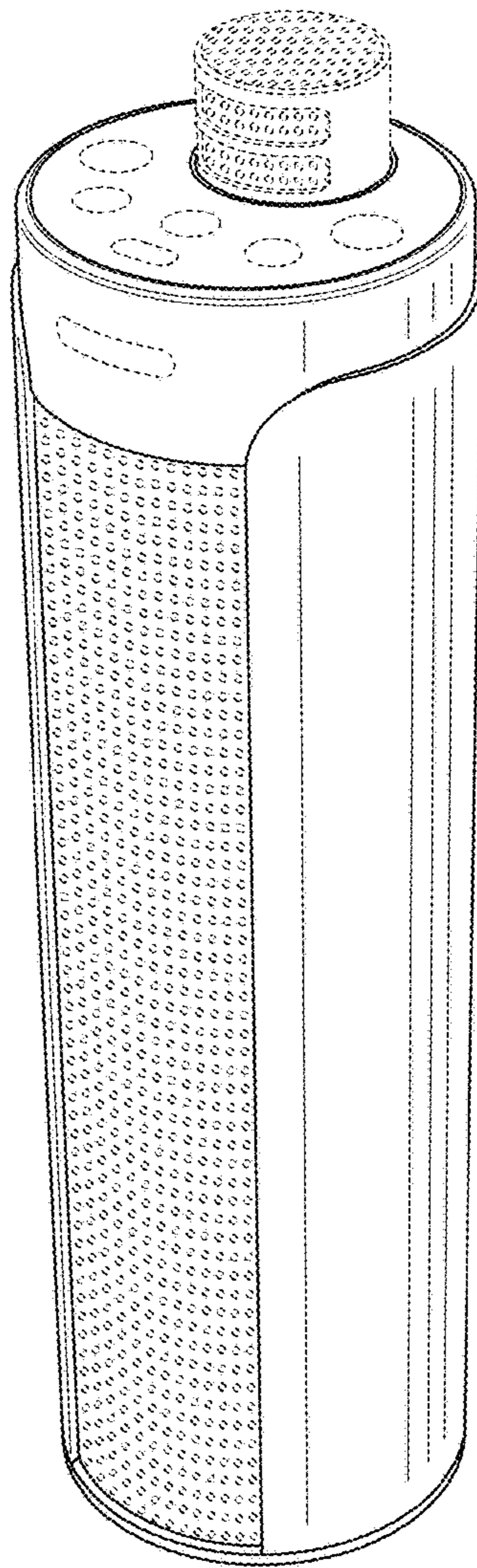

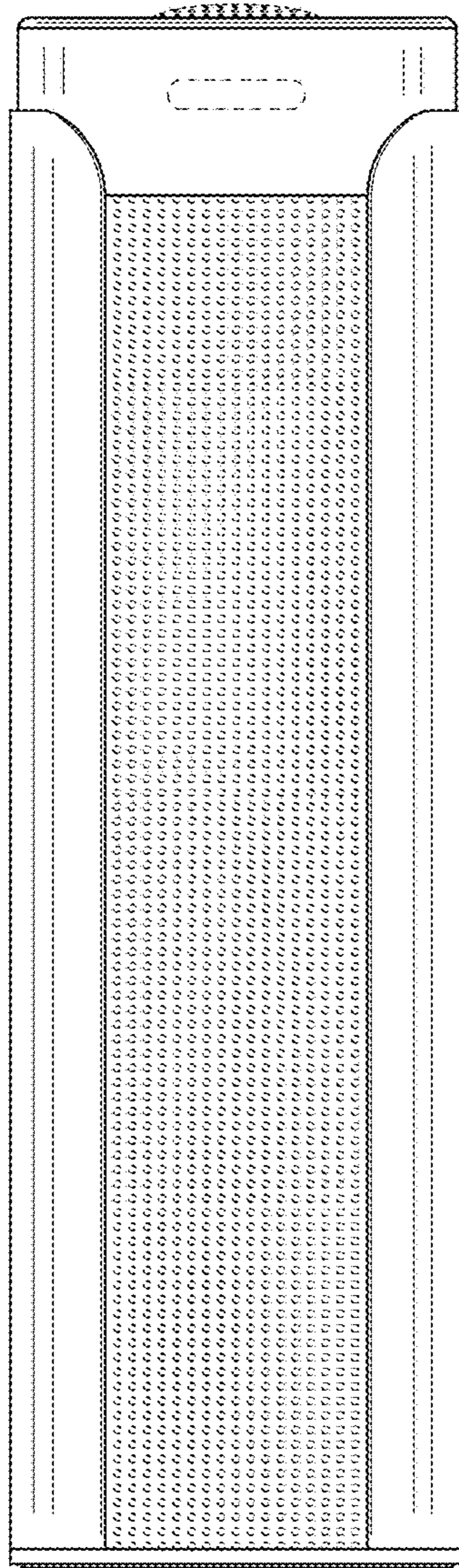

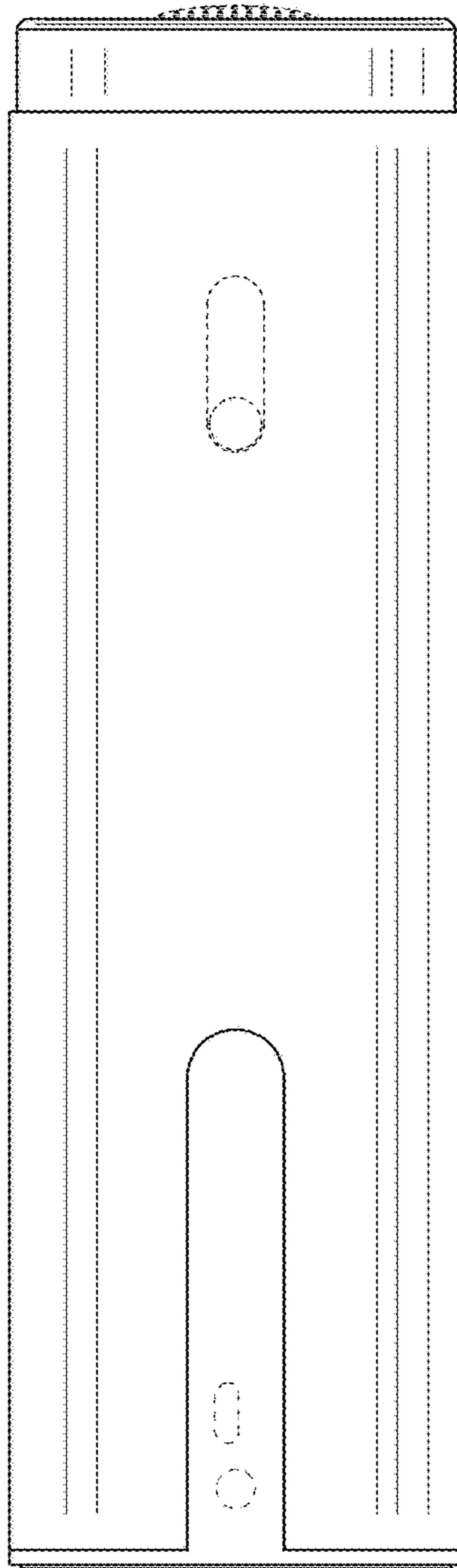

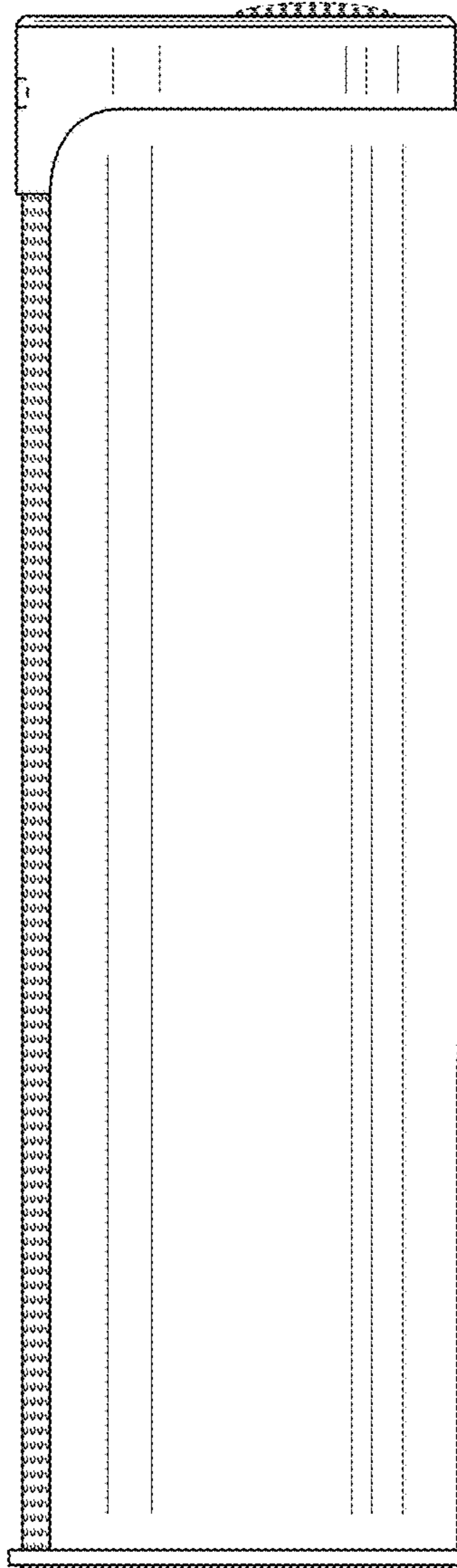

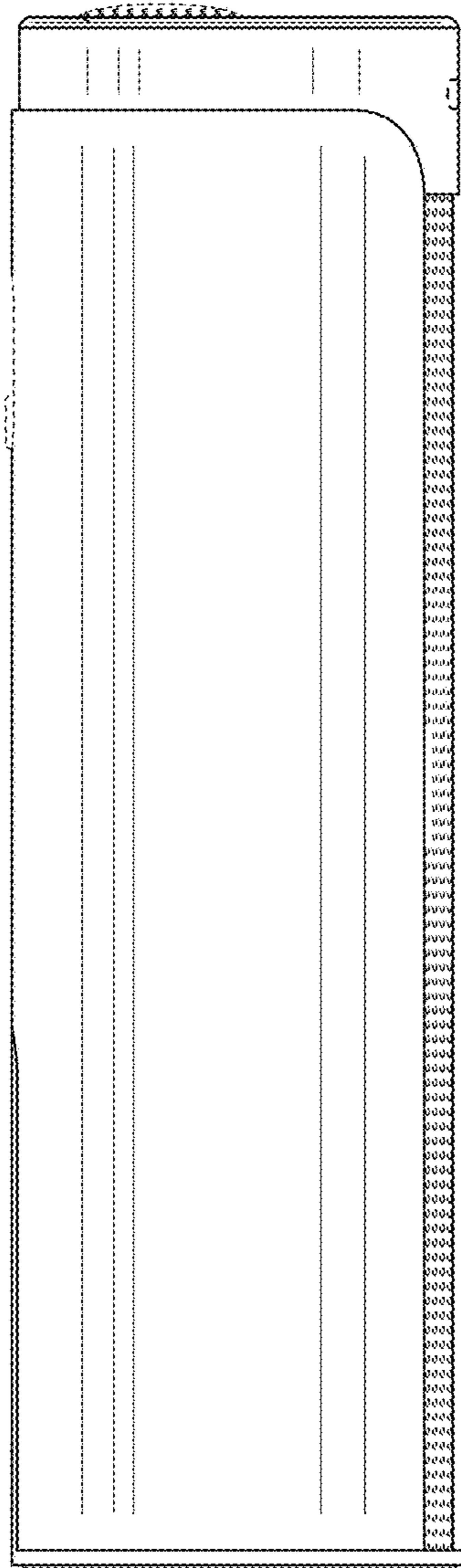

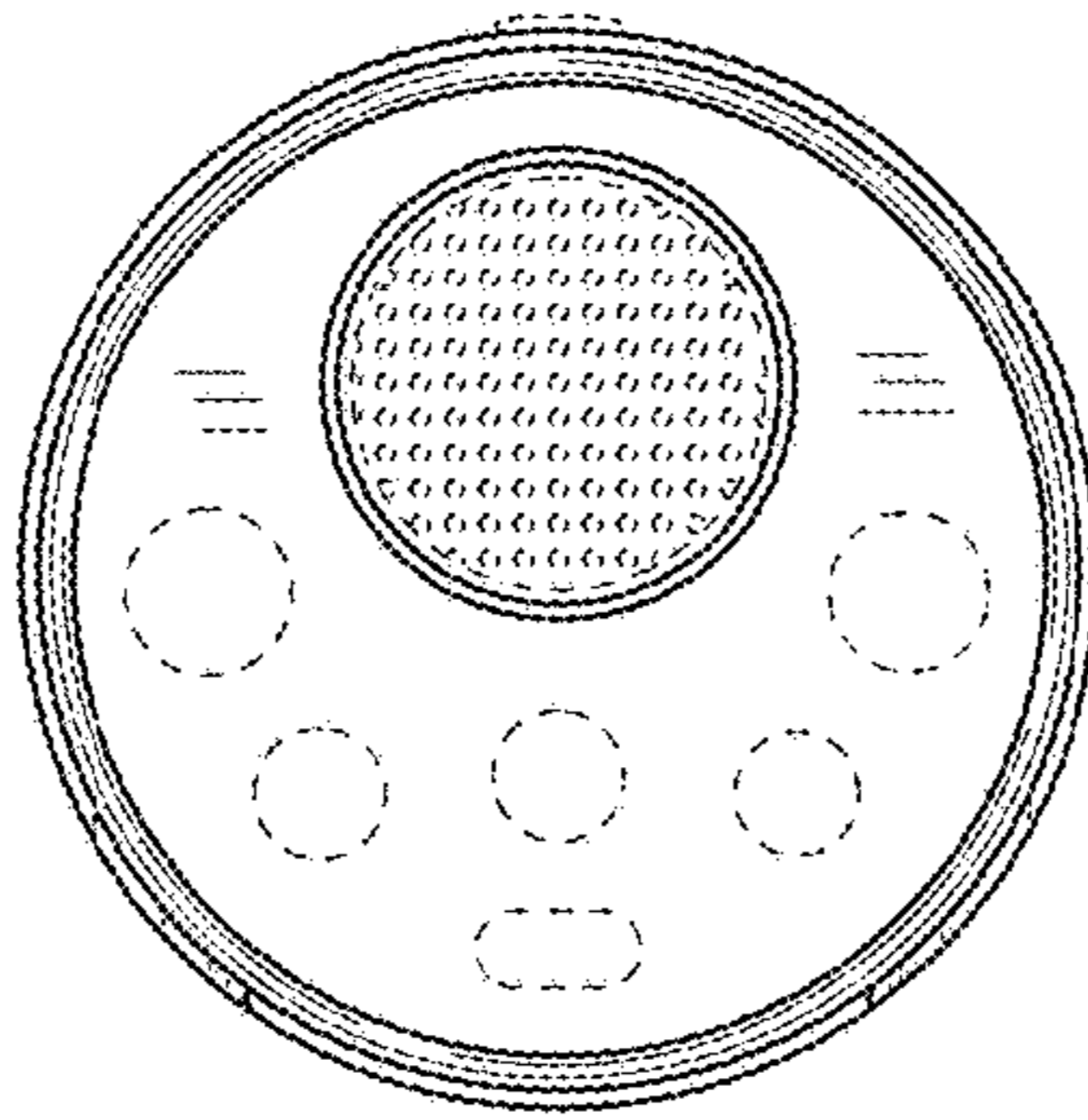

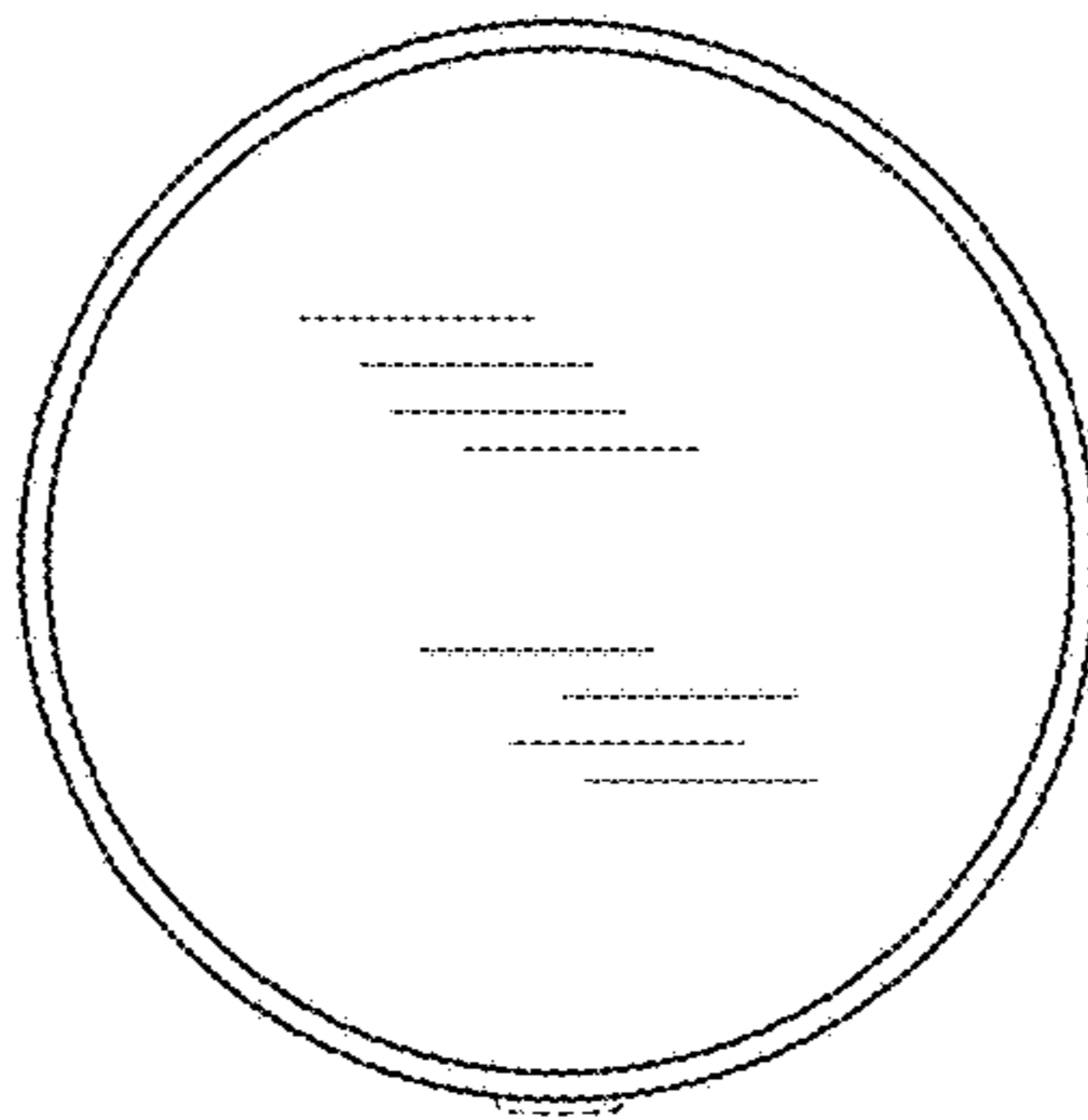
