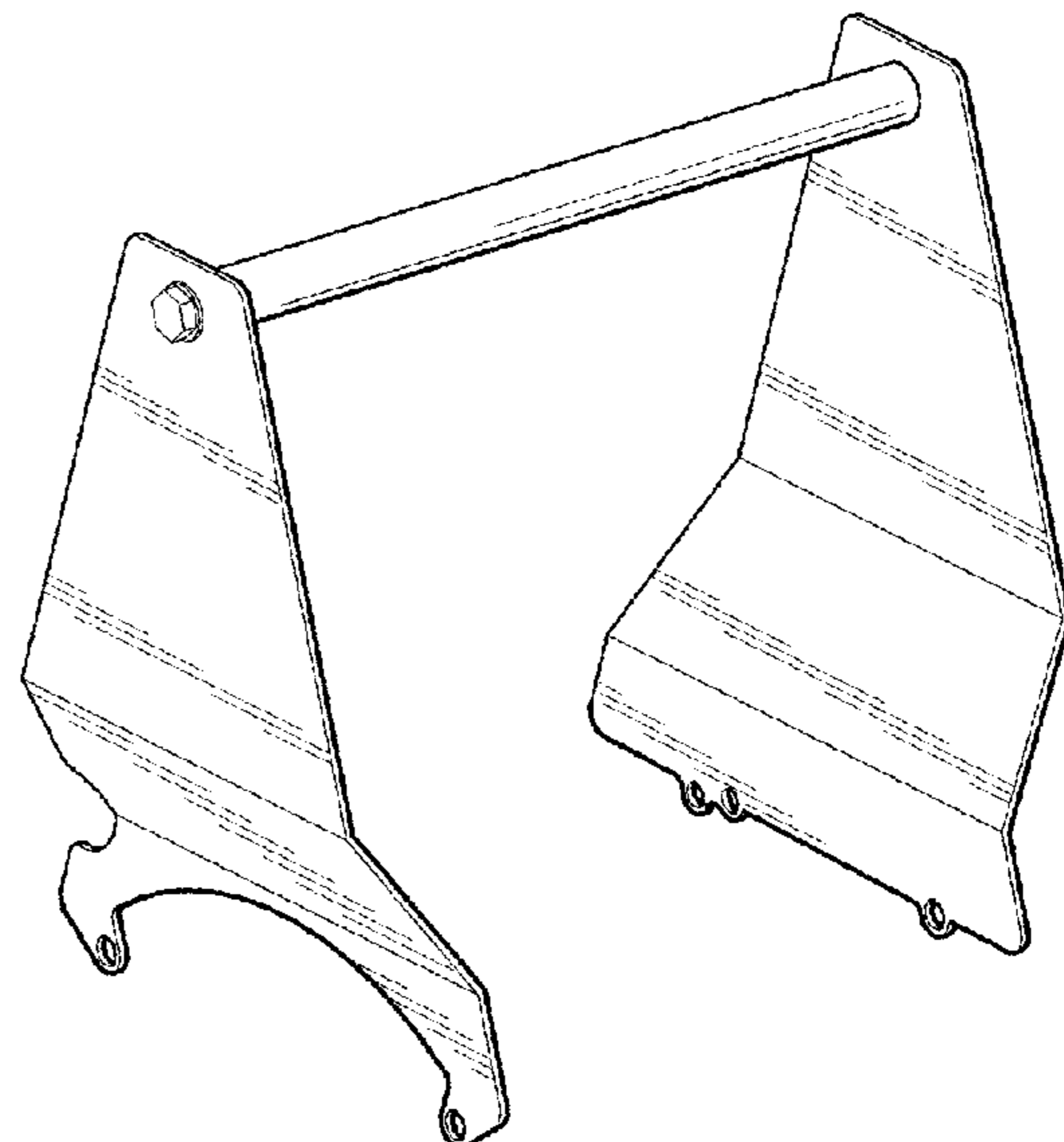
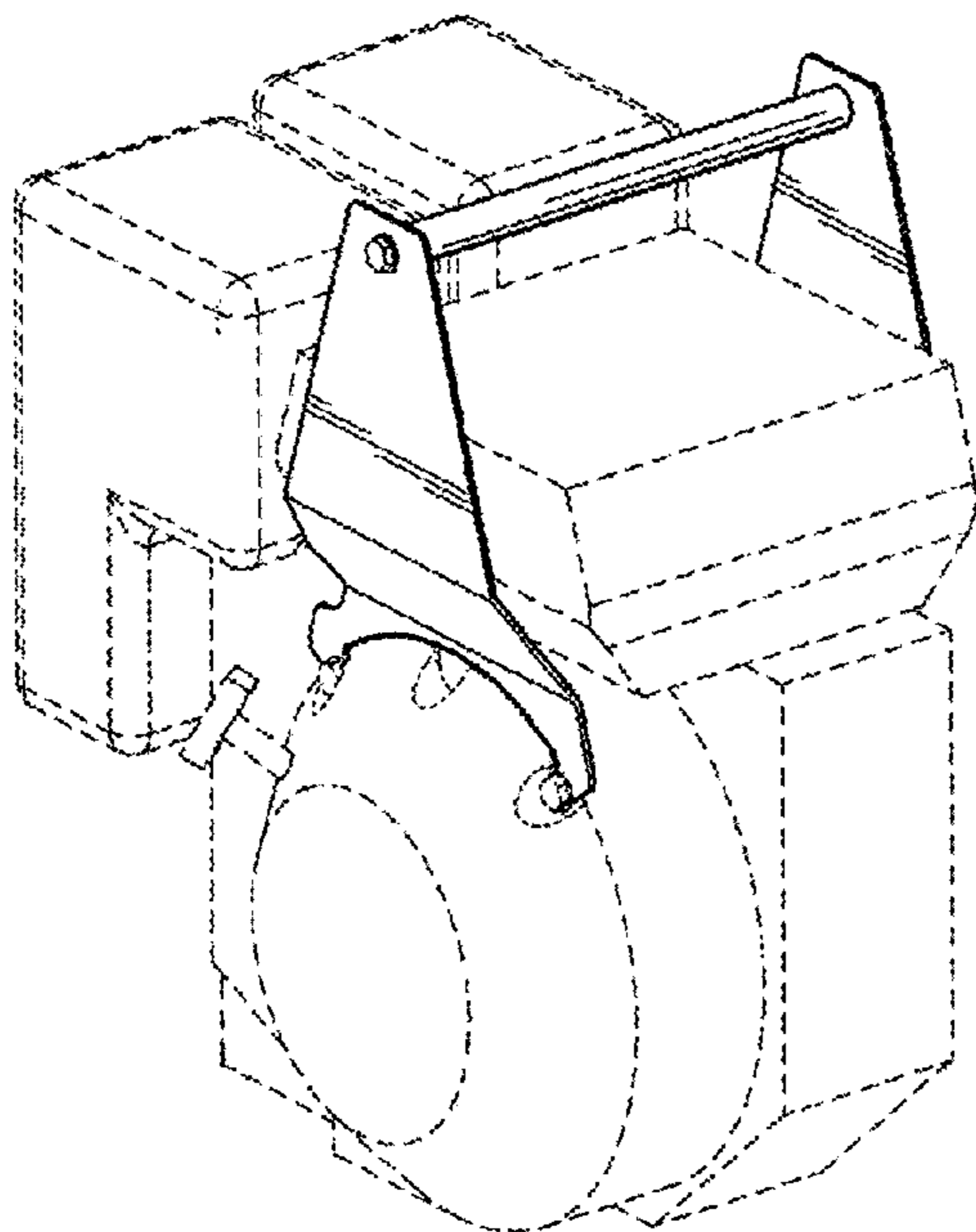
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a handle for carrying small engines showing our new design in an environment of use.

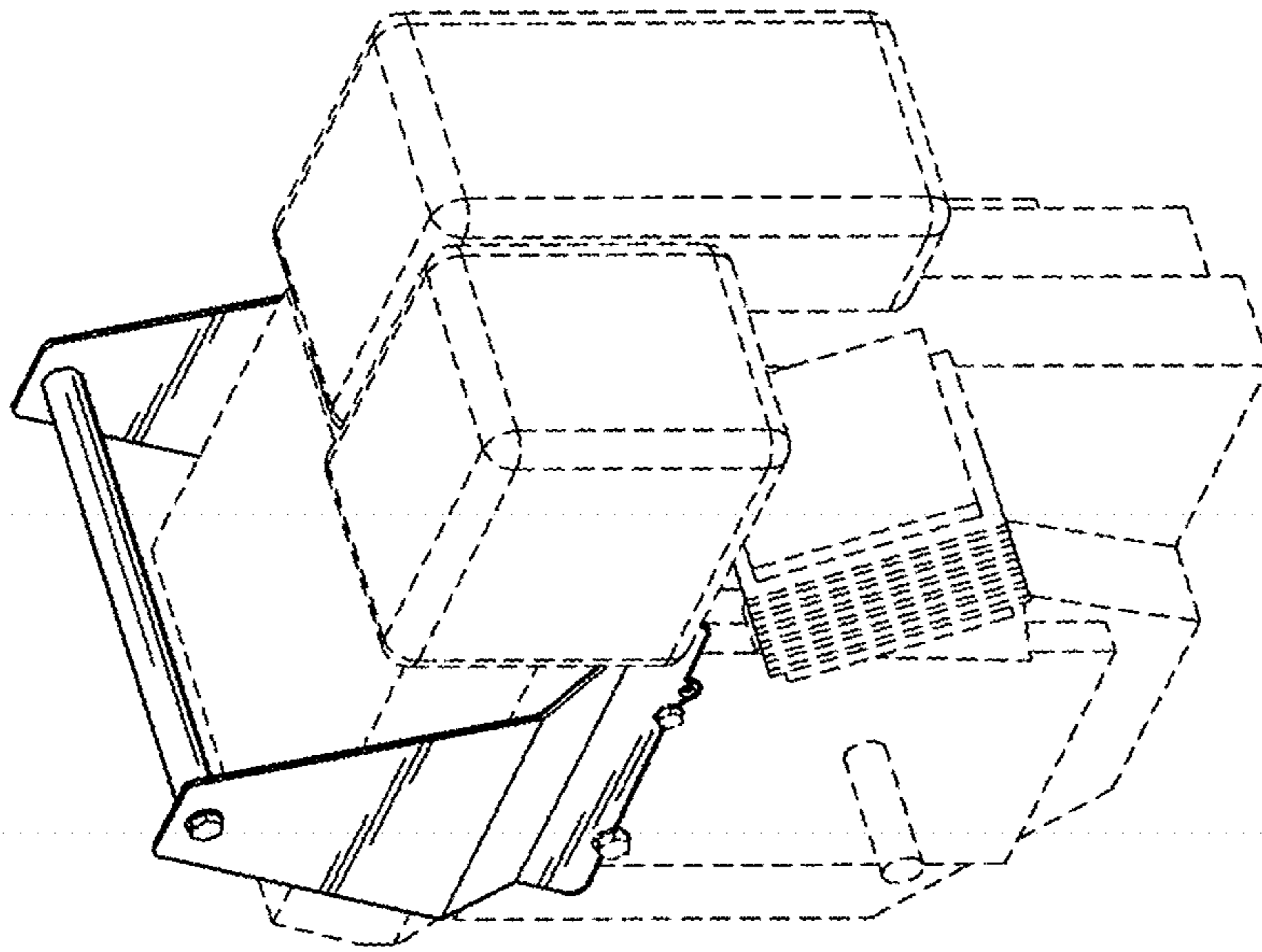

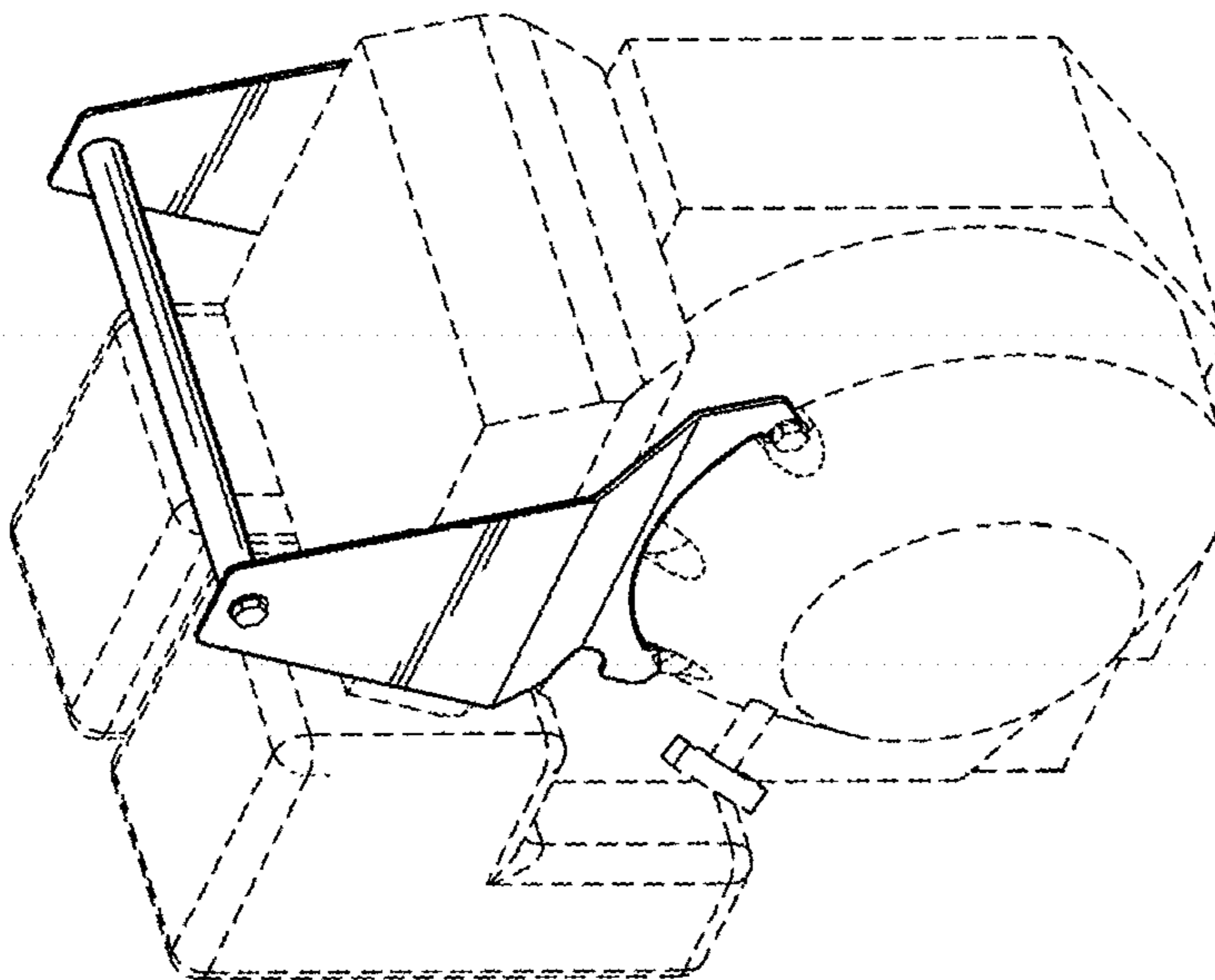

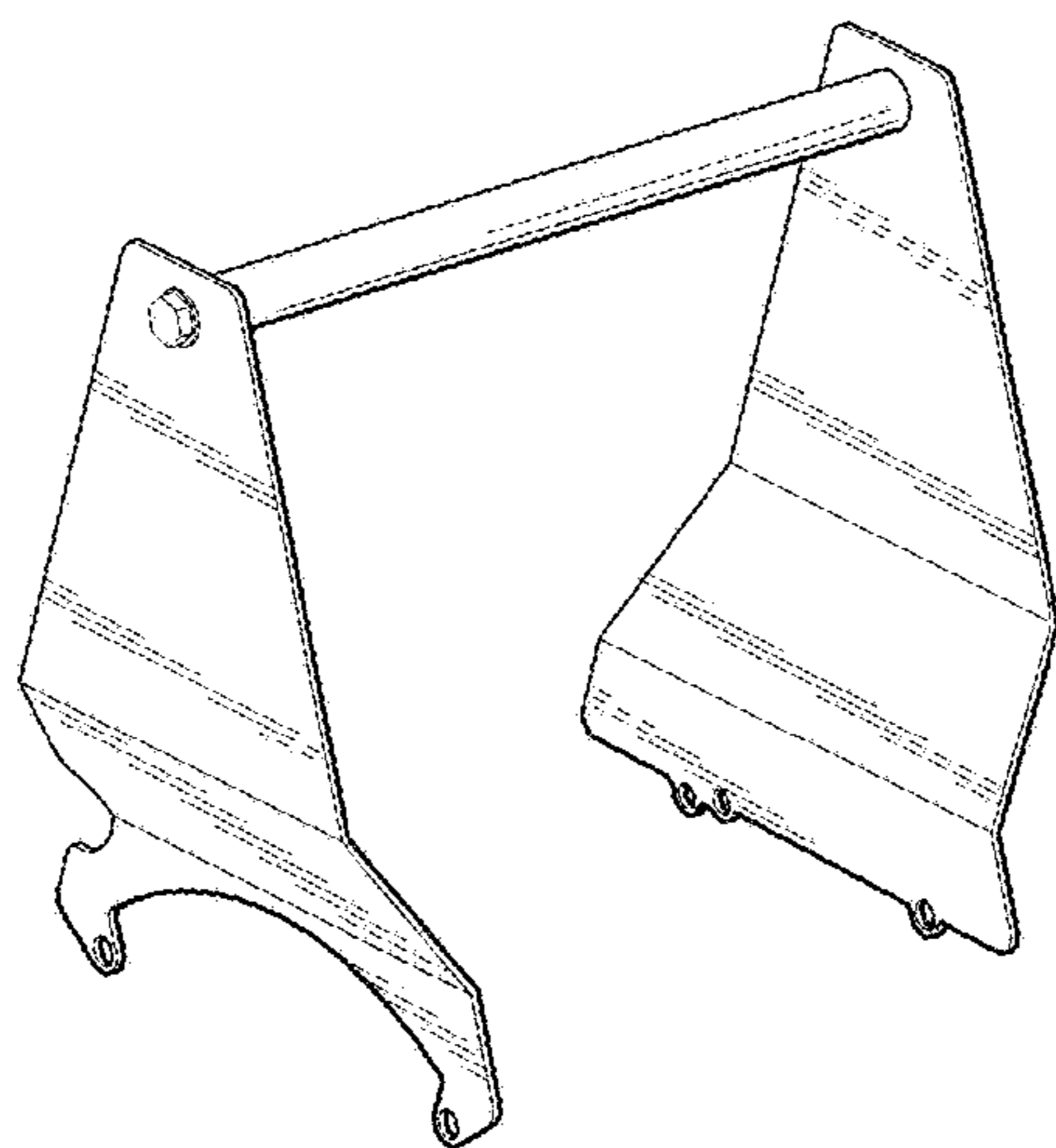

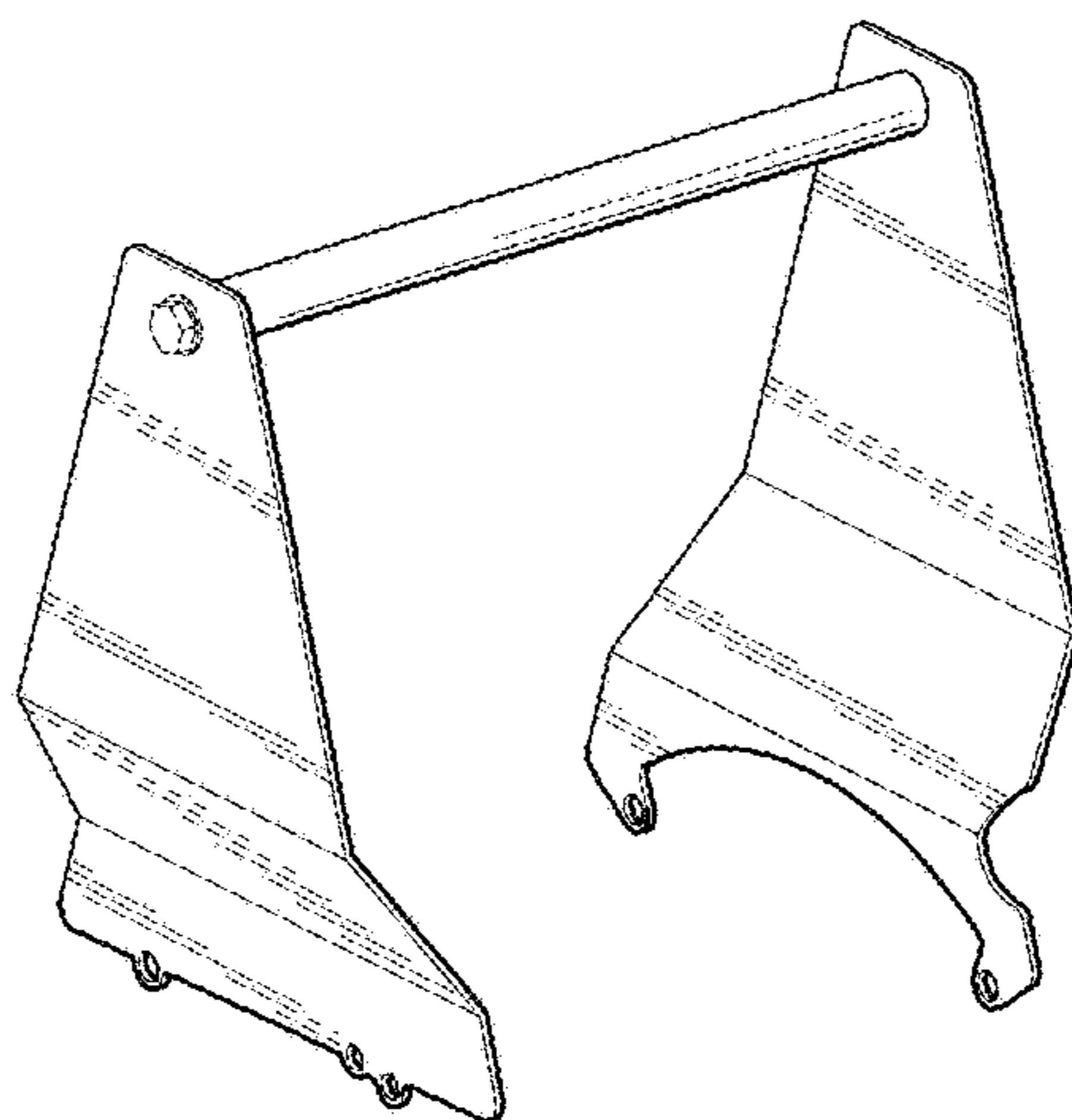

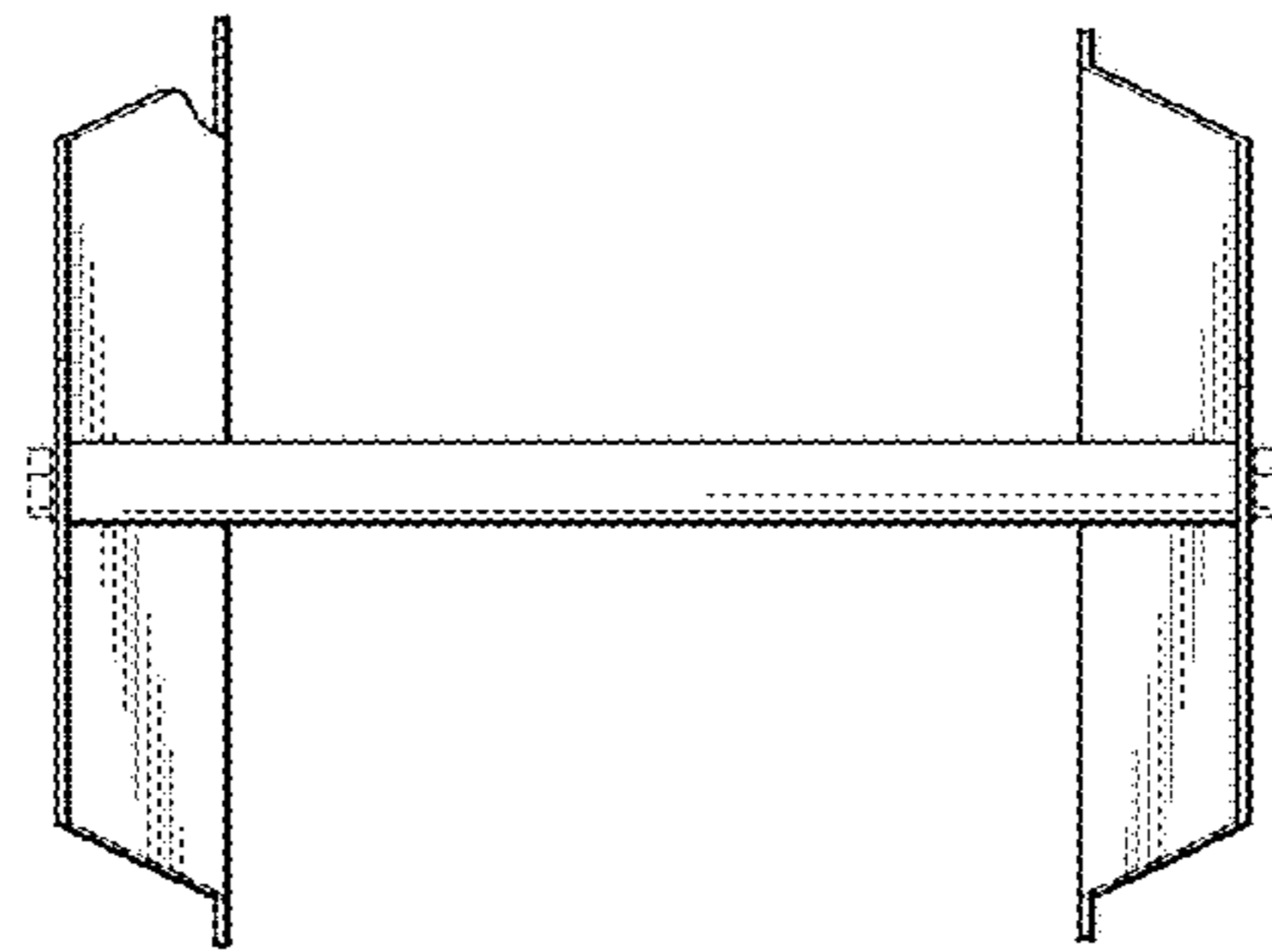

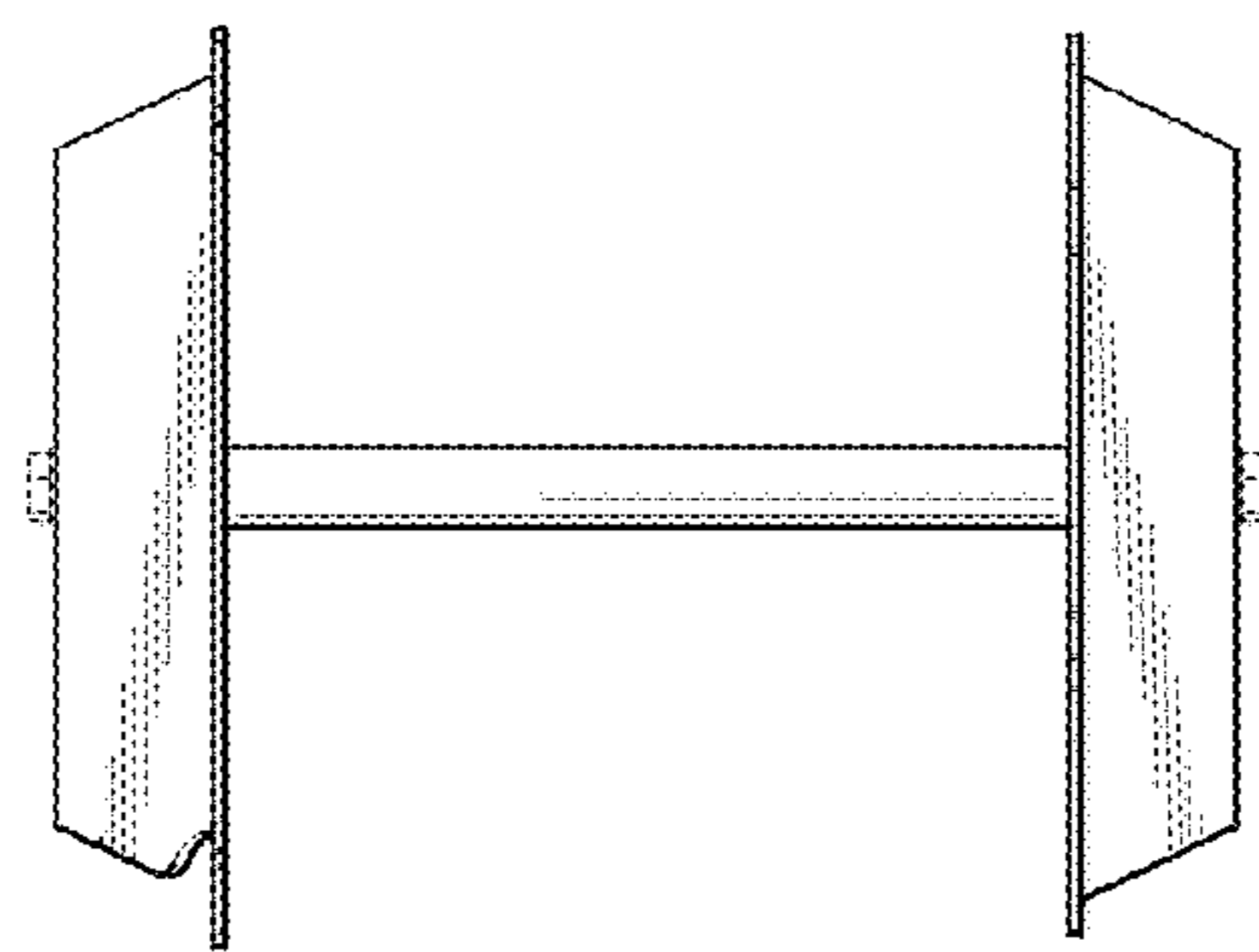

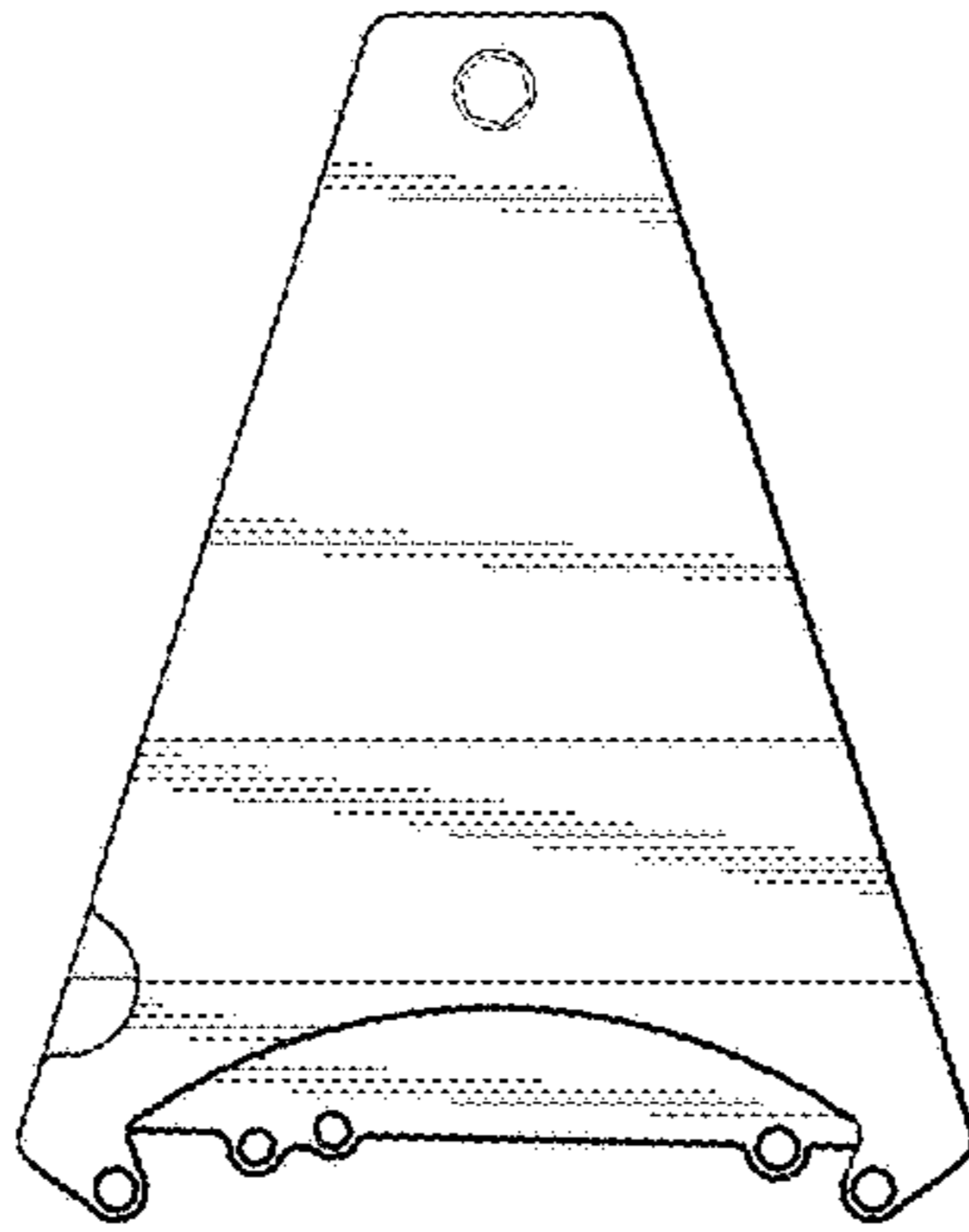

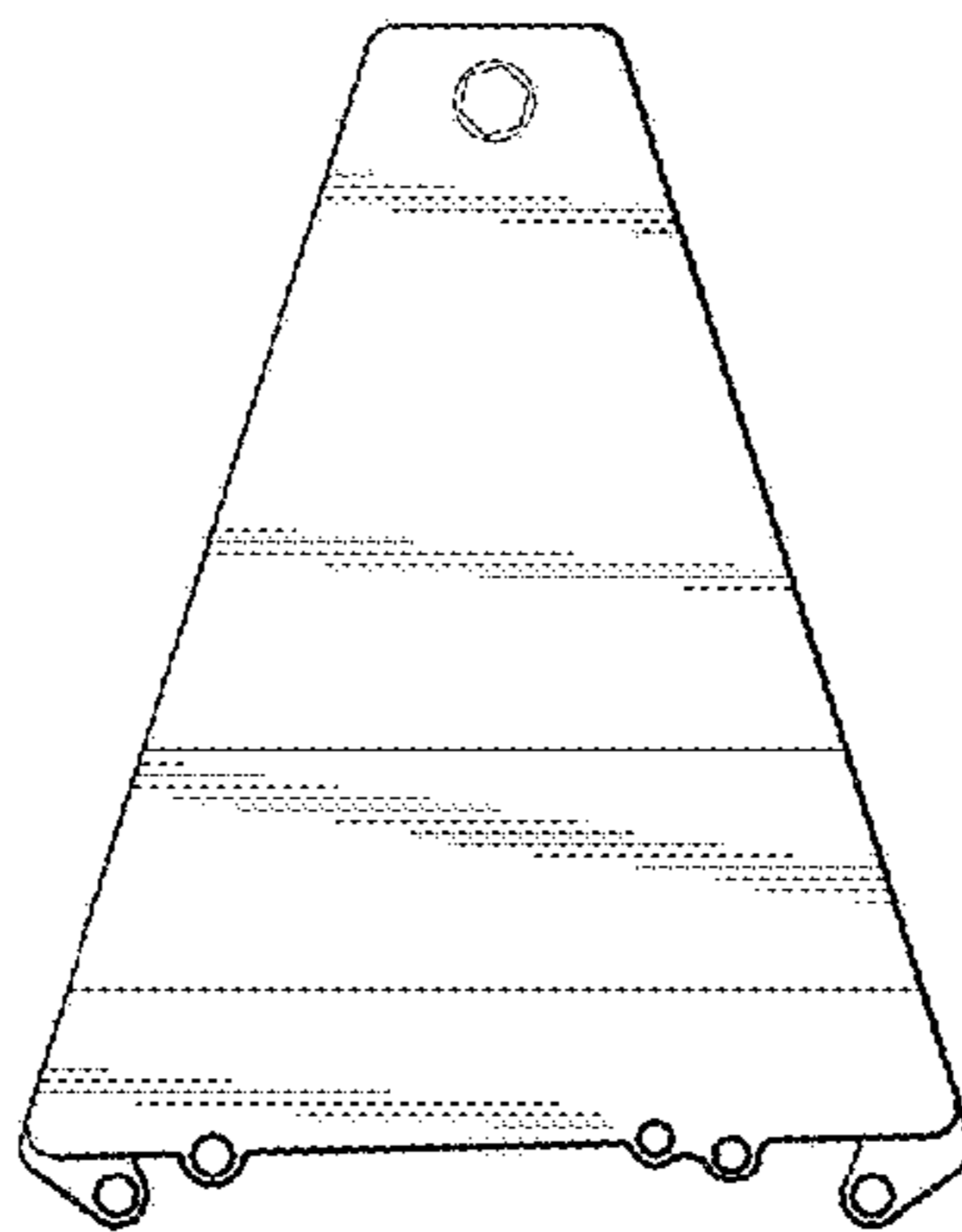

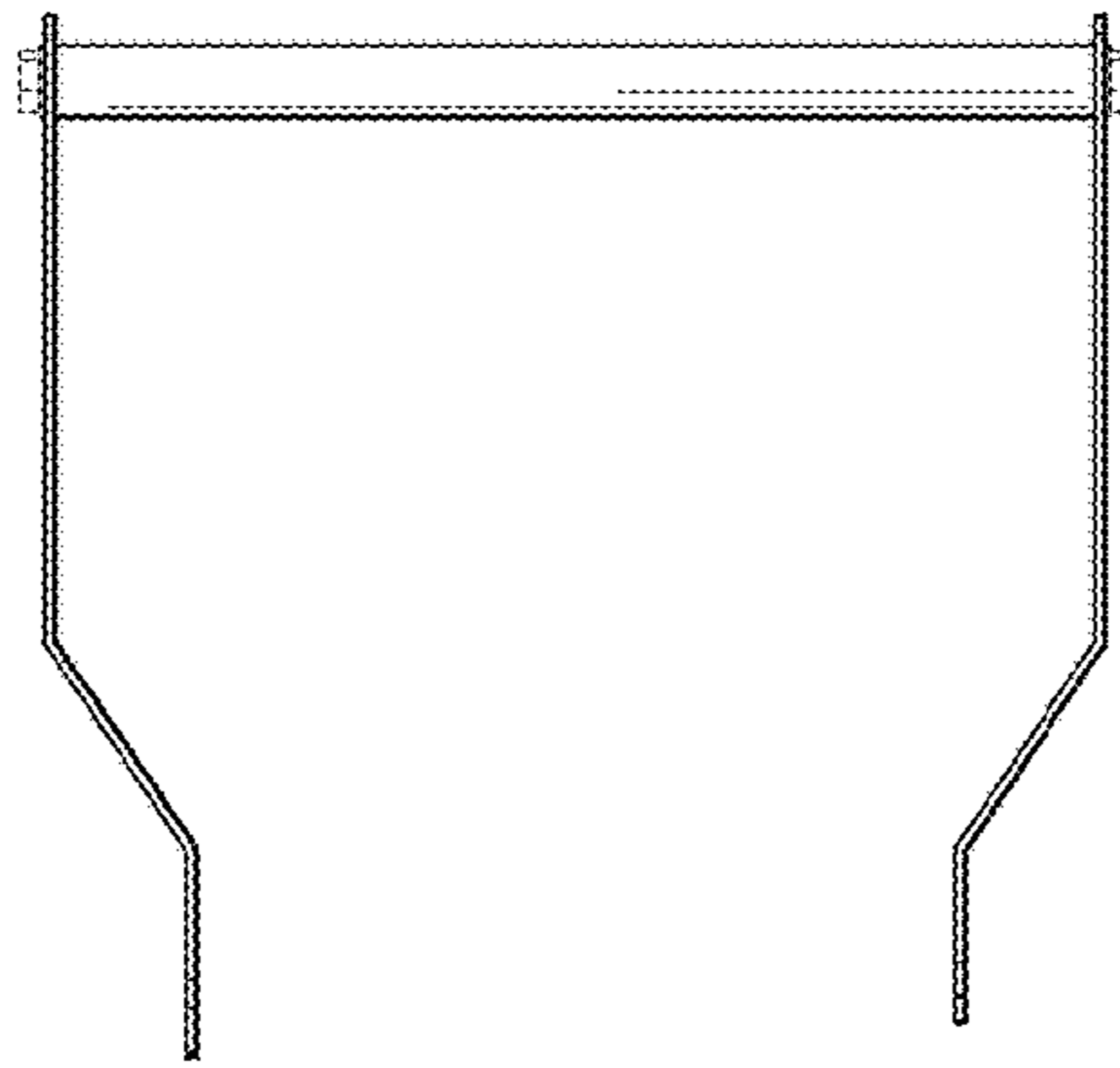

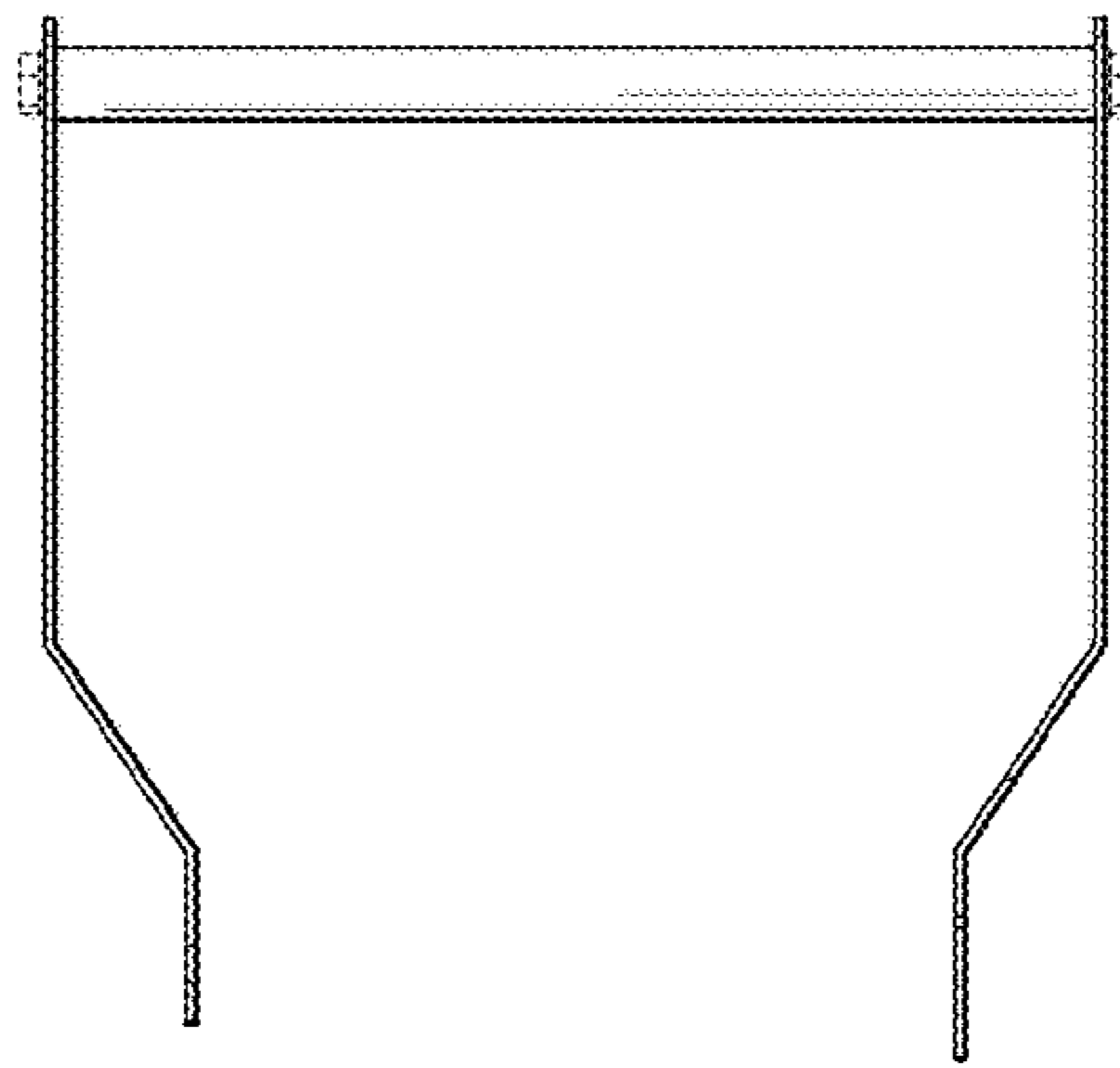
