FIG. 5 is a left side view of the light.

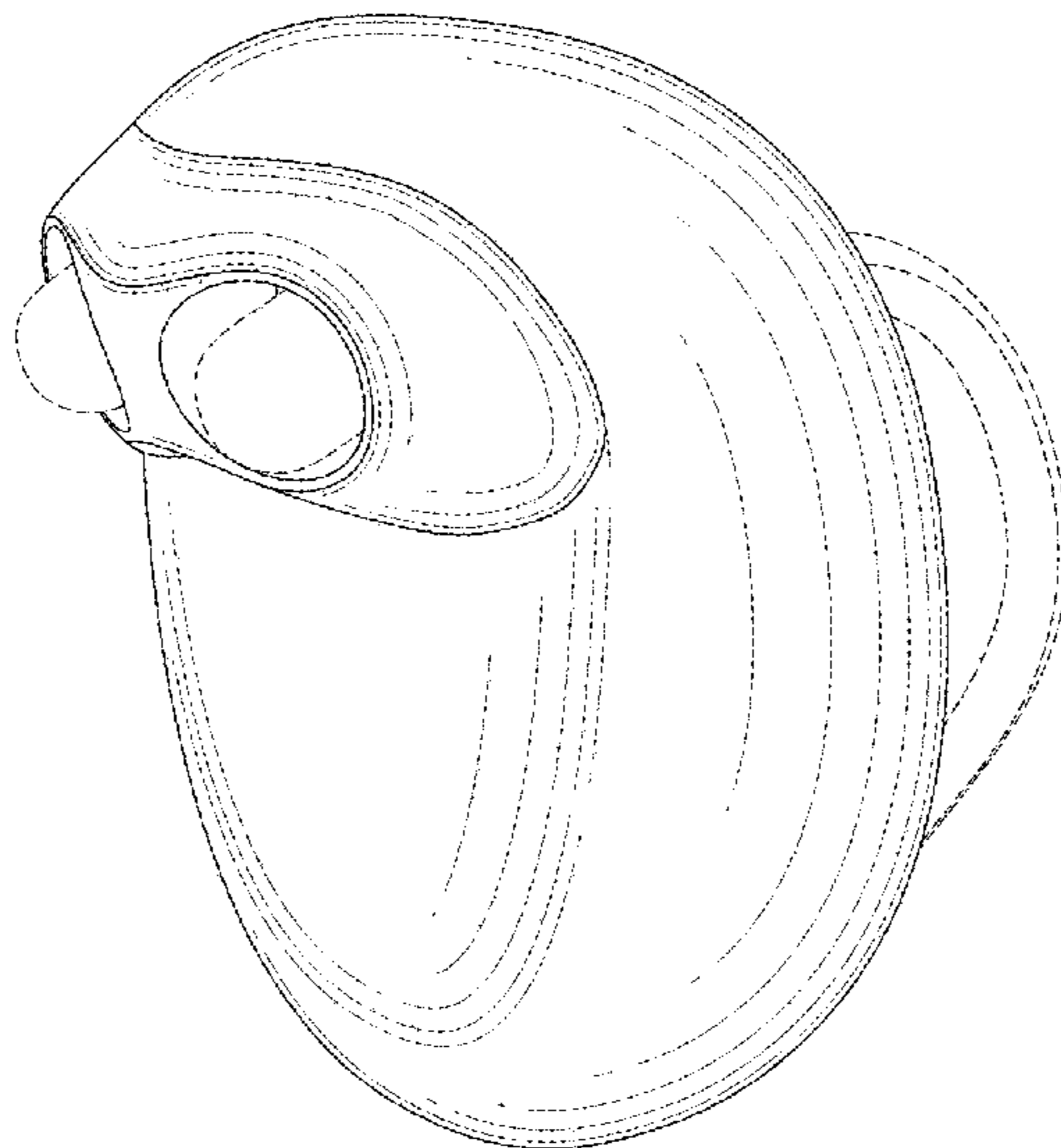
FIG. 6 is a right side view of the light.

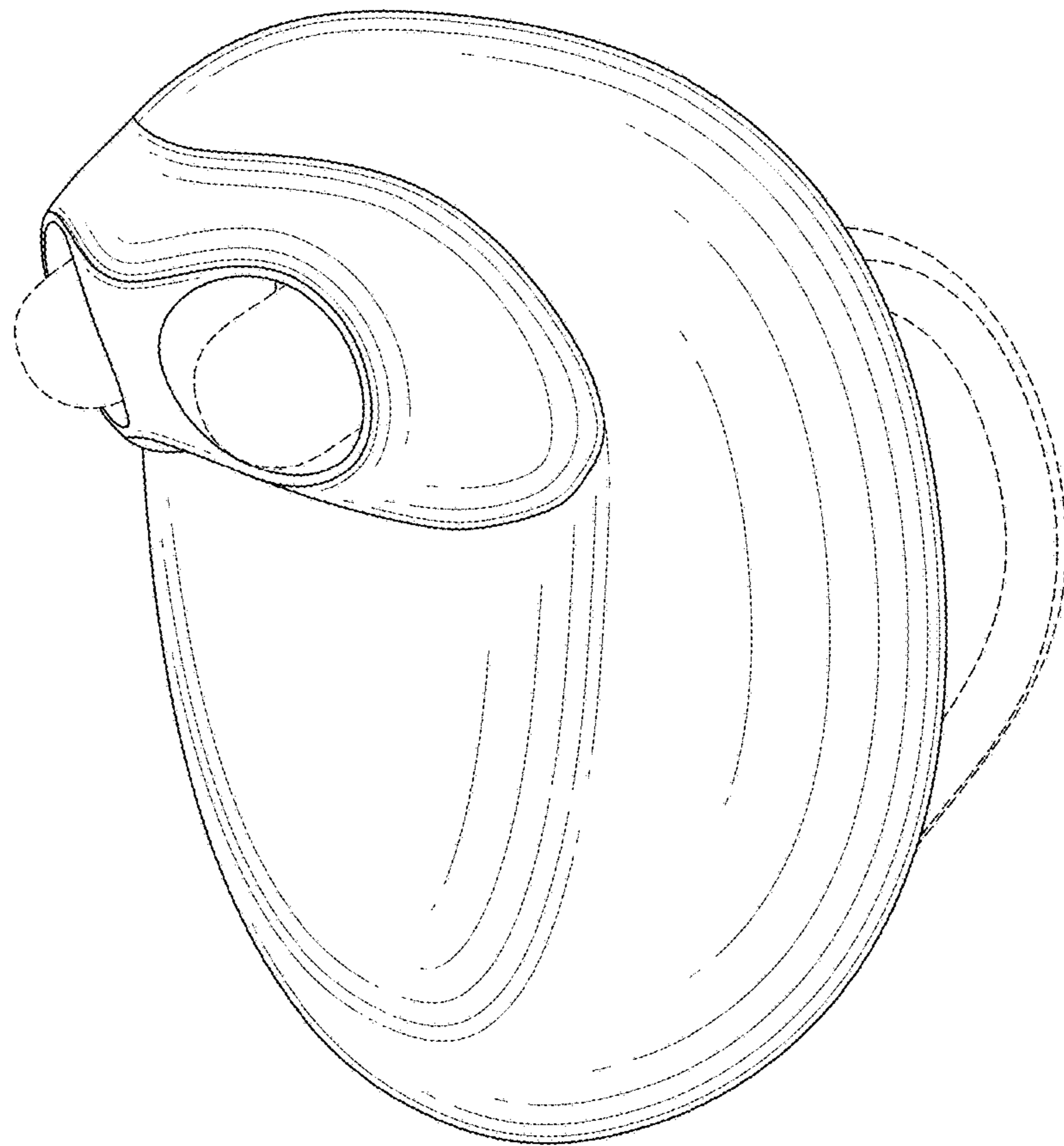

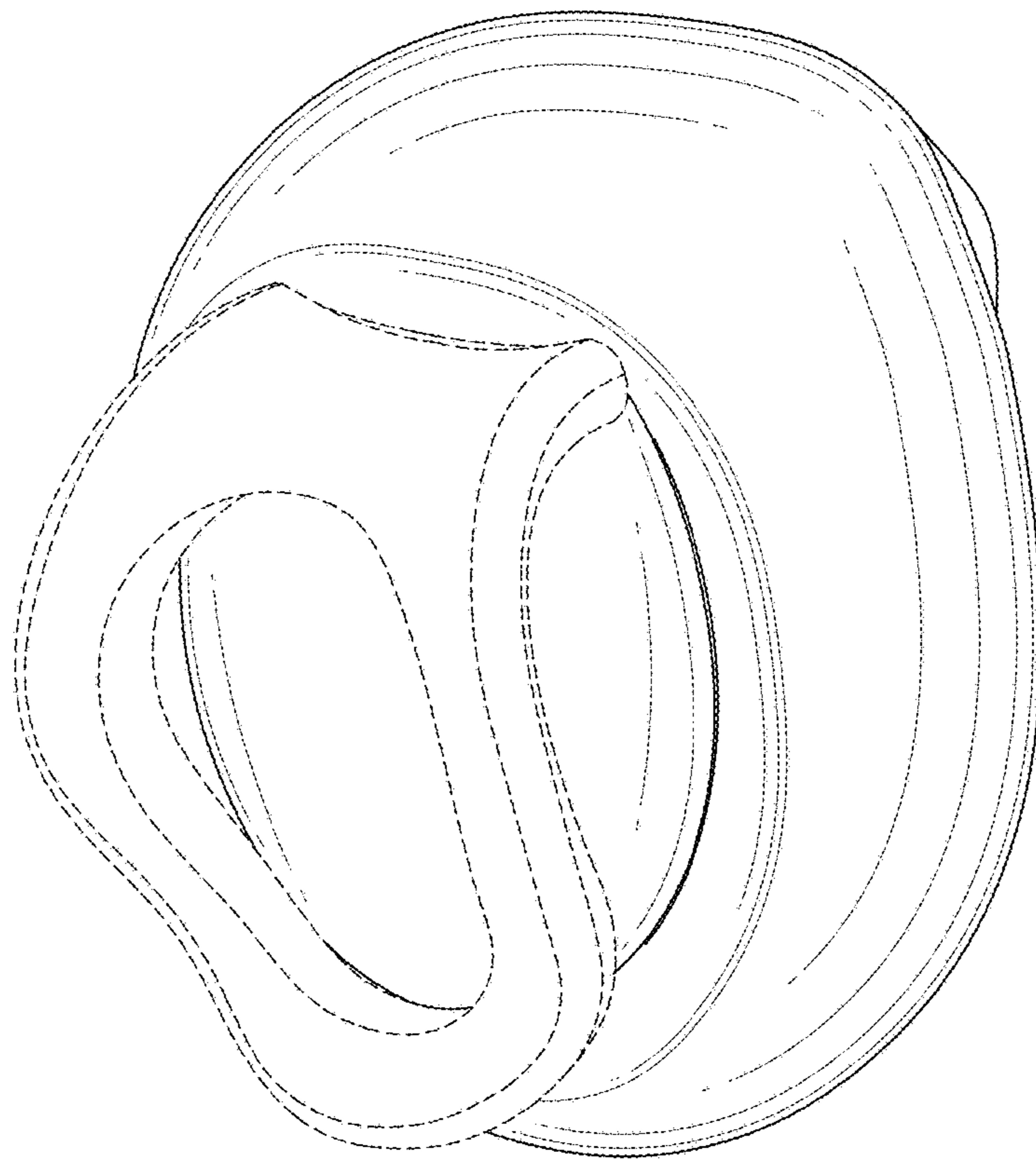

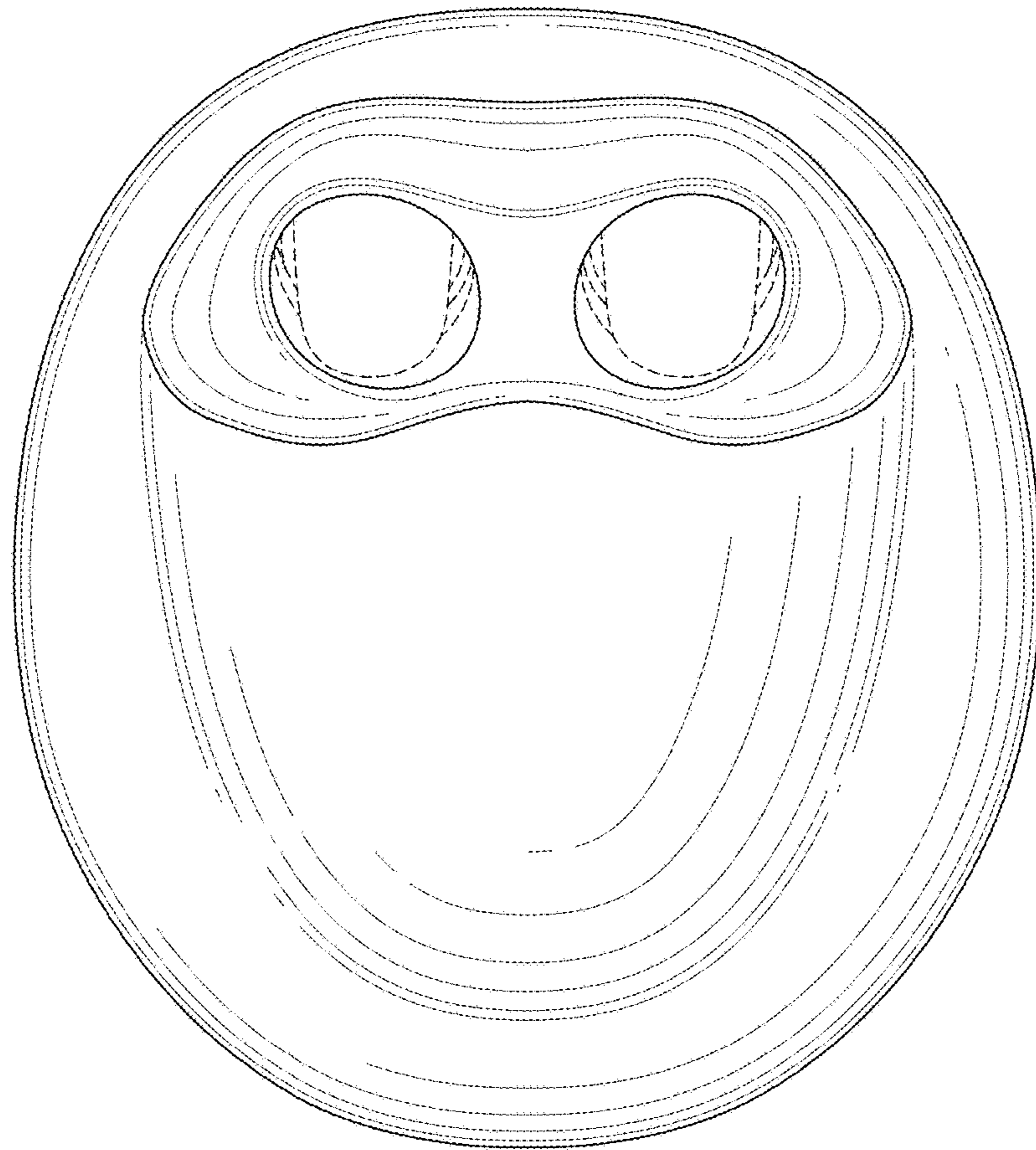

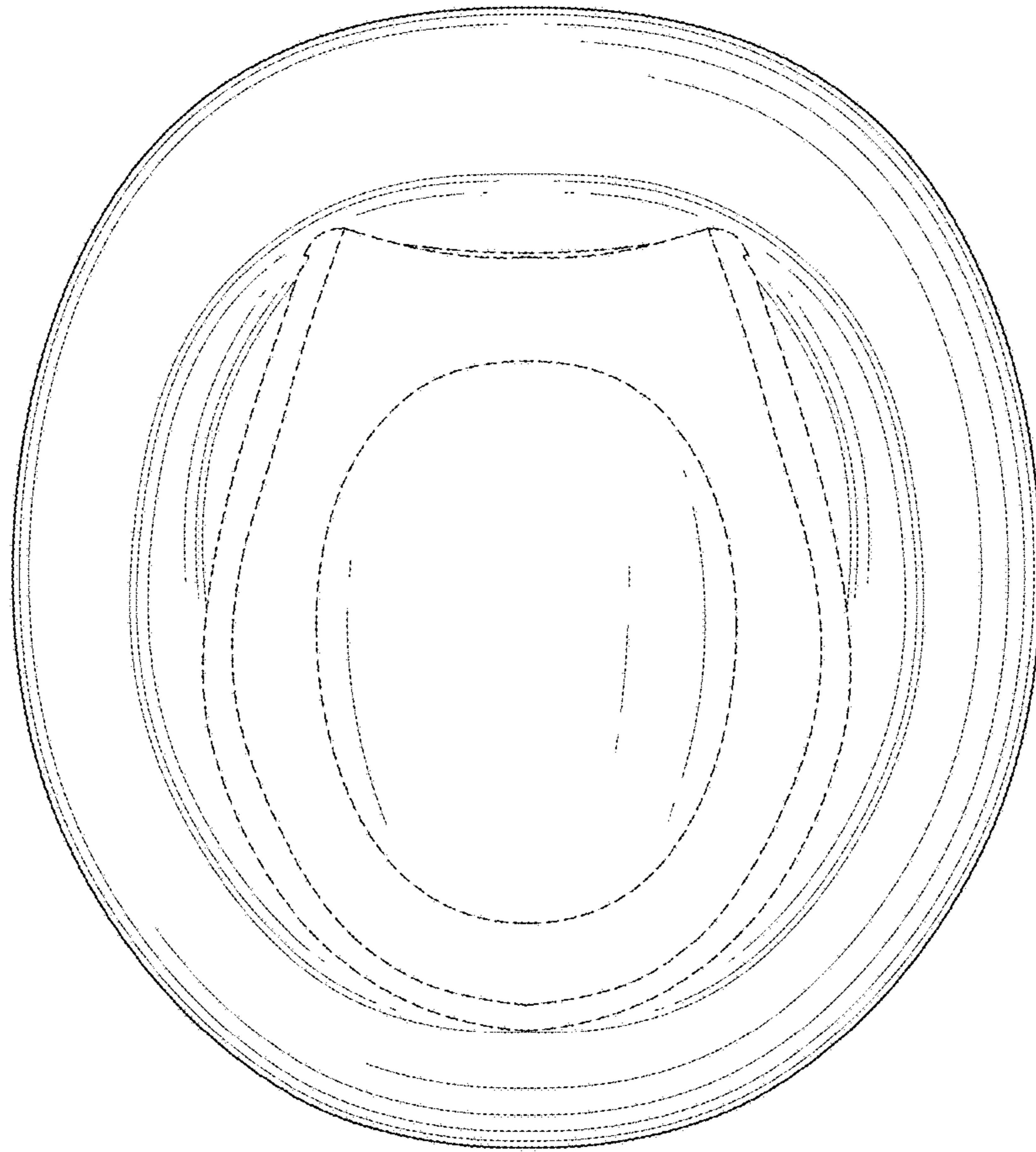

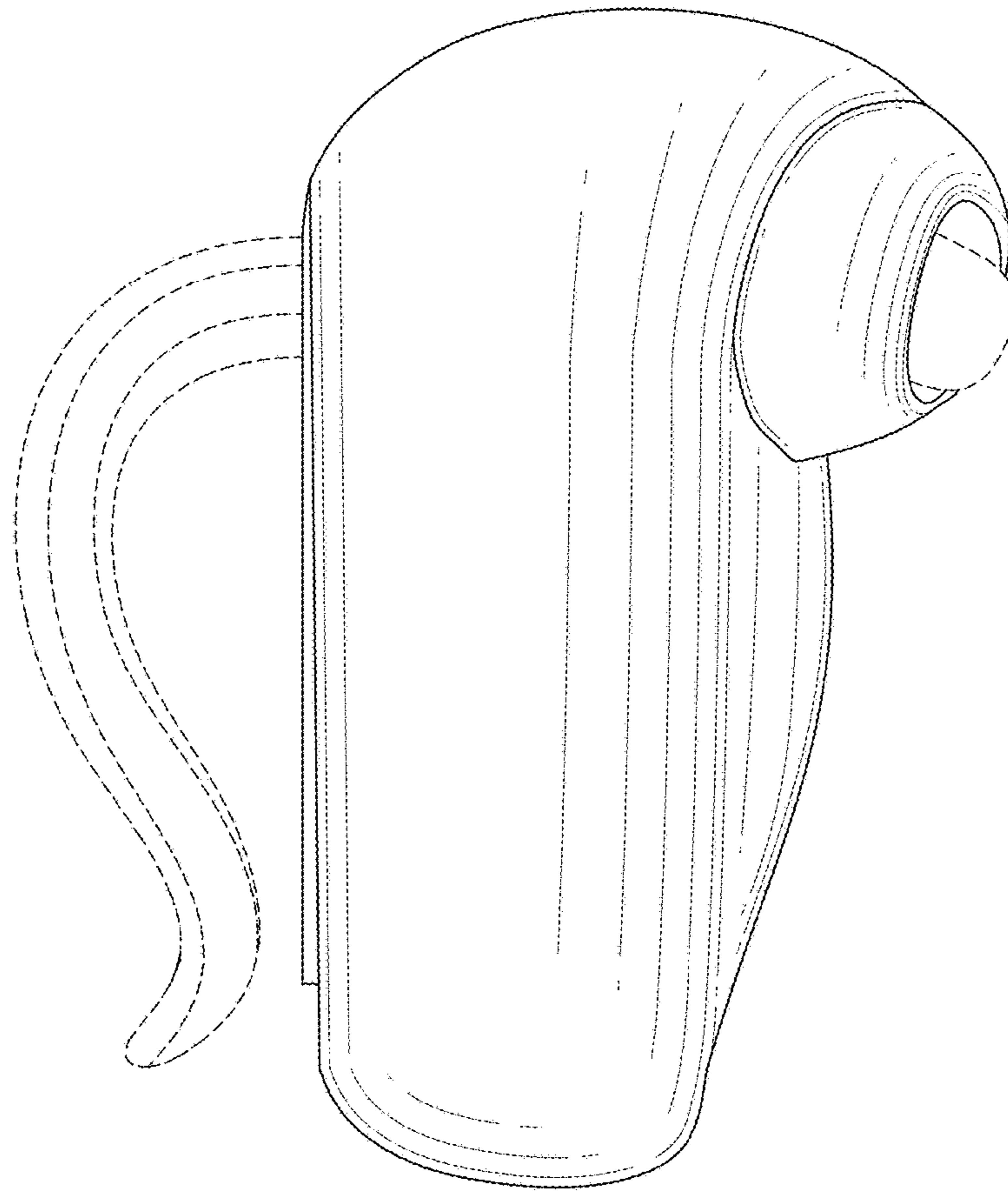

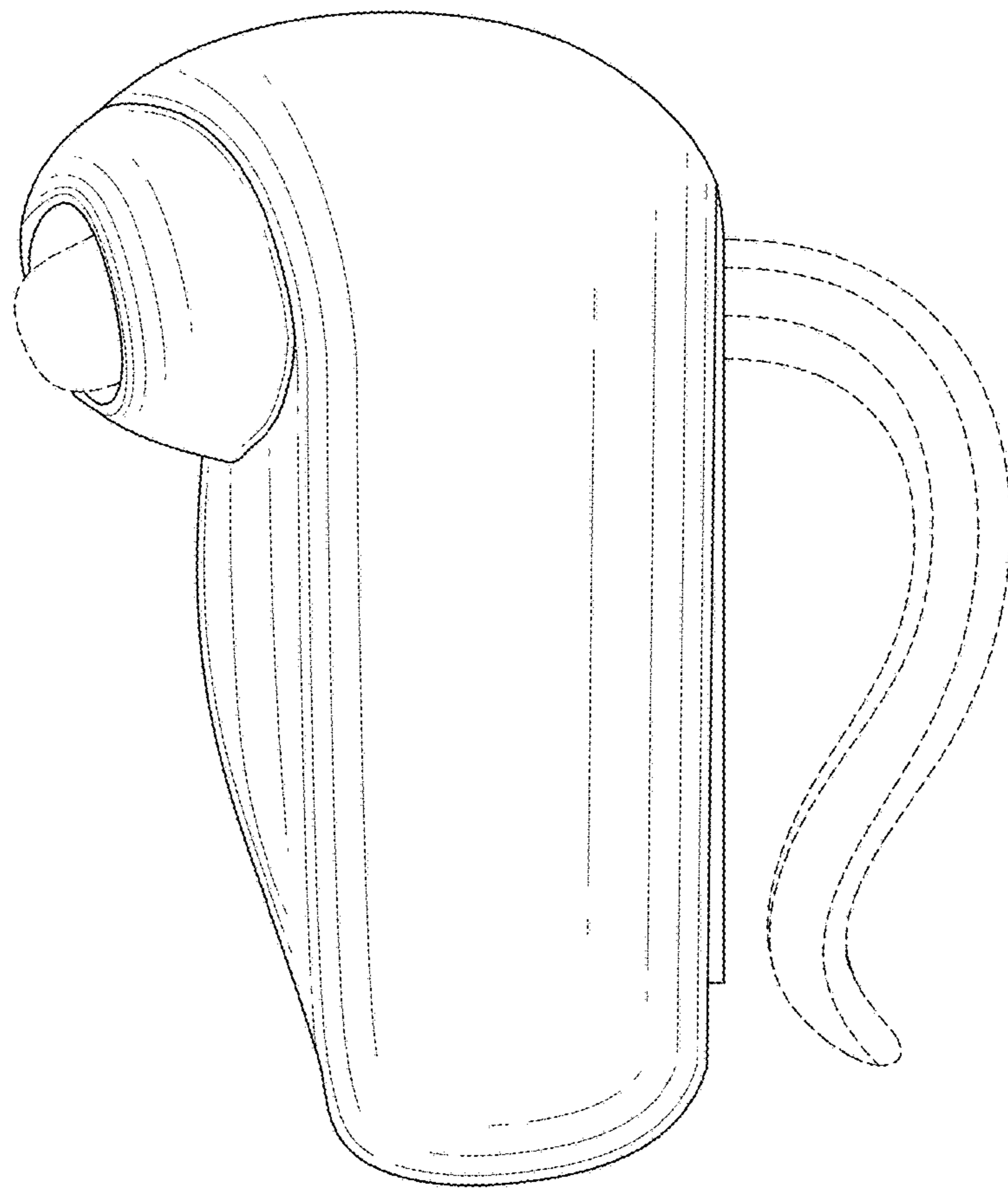

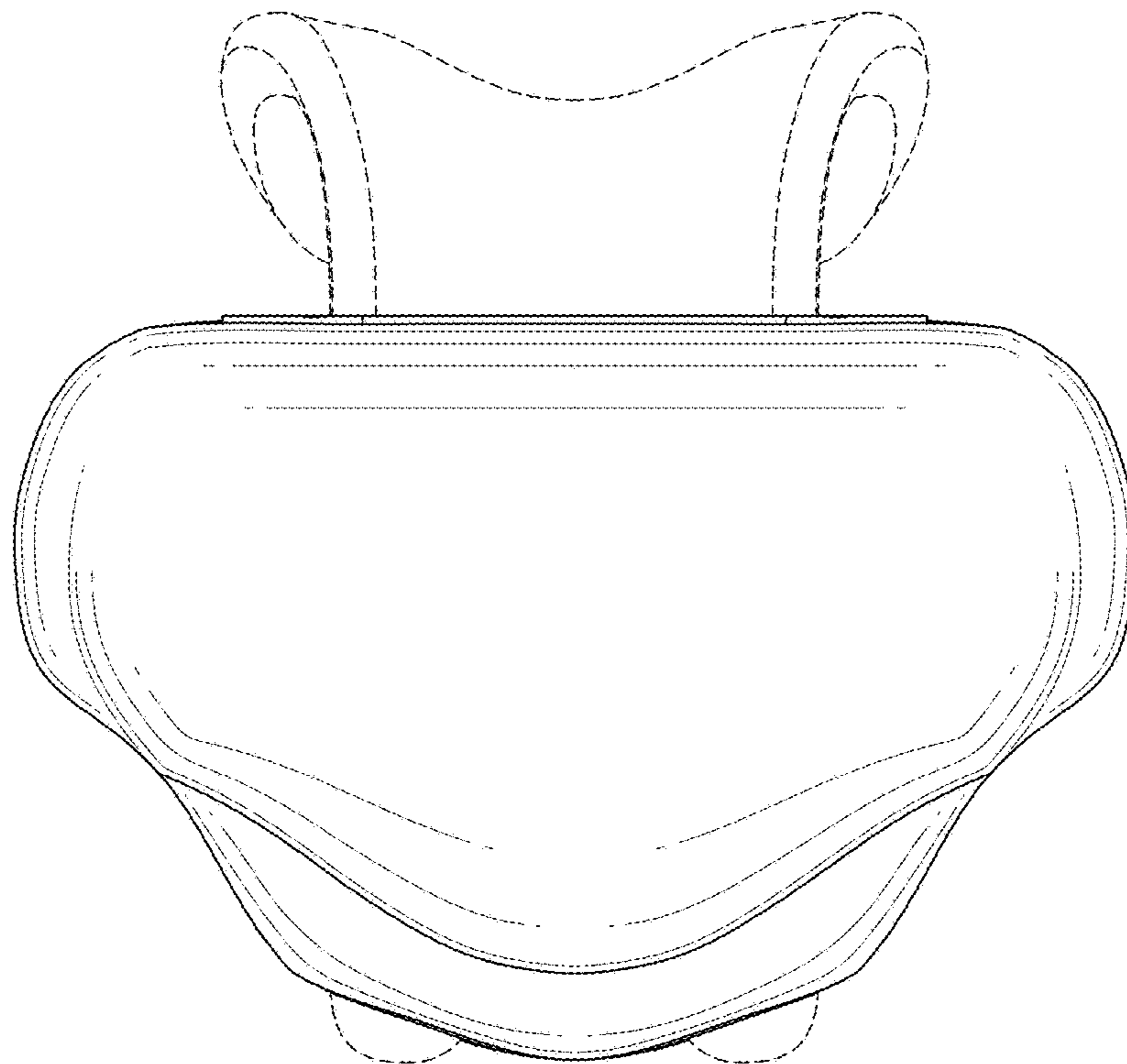

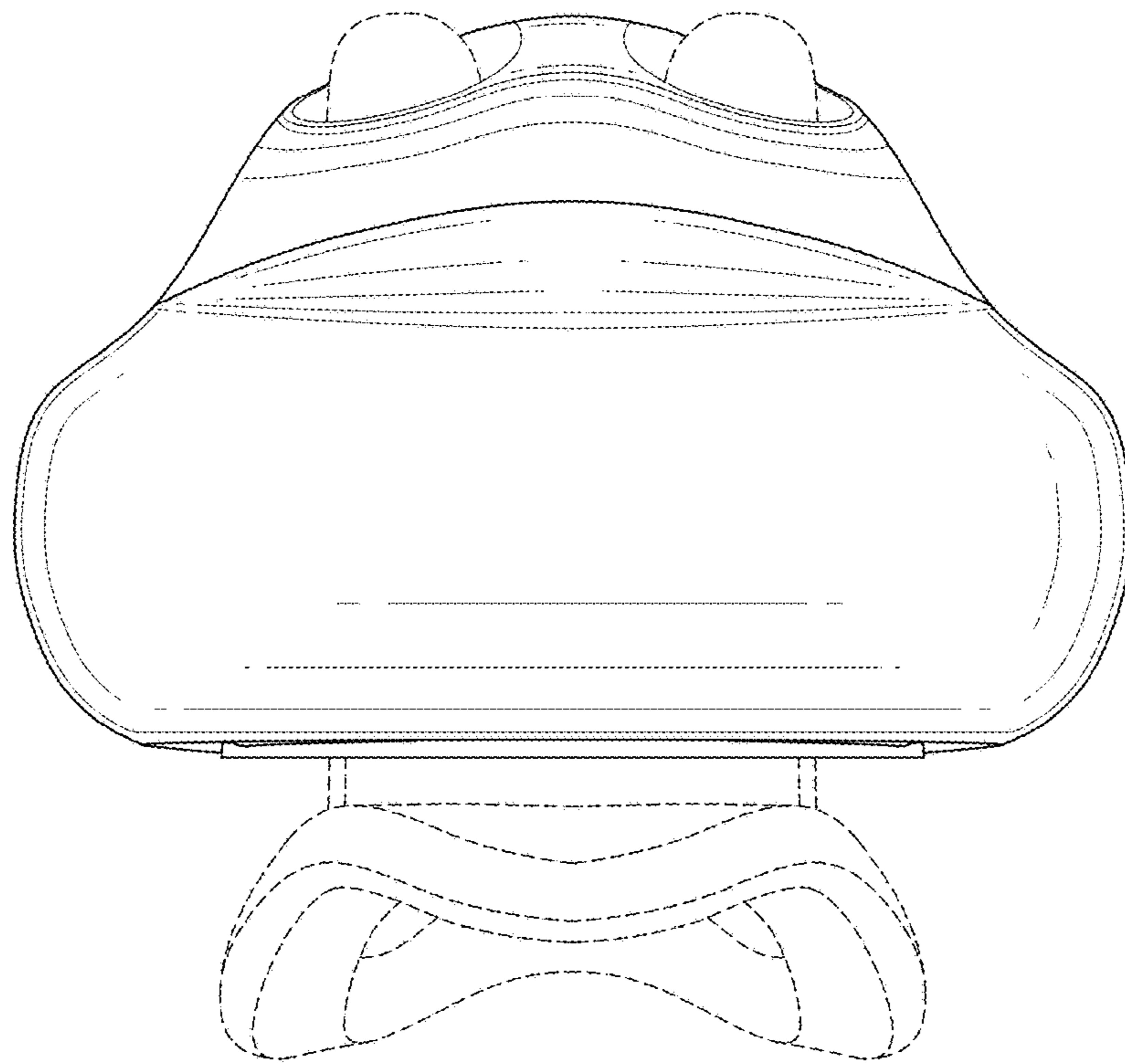
