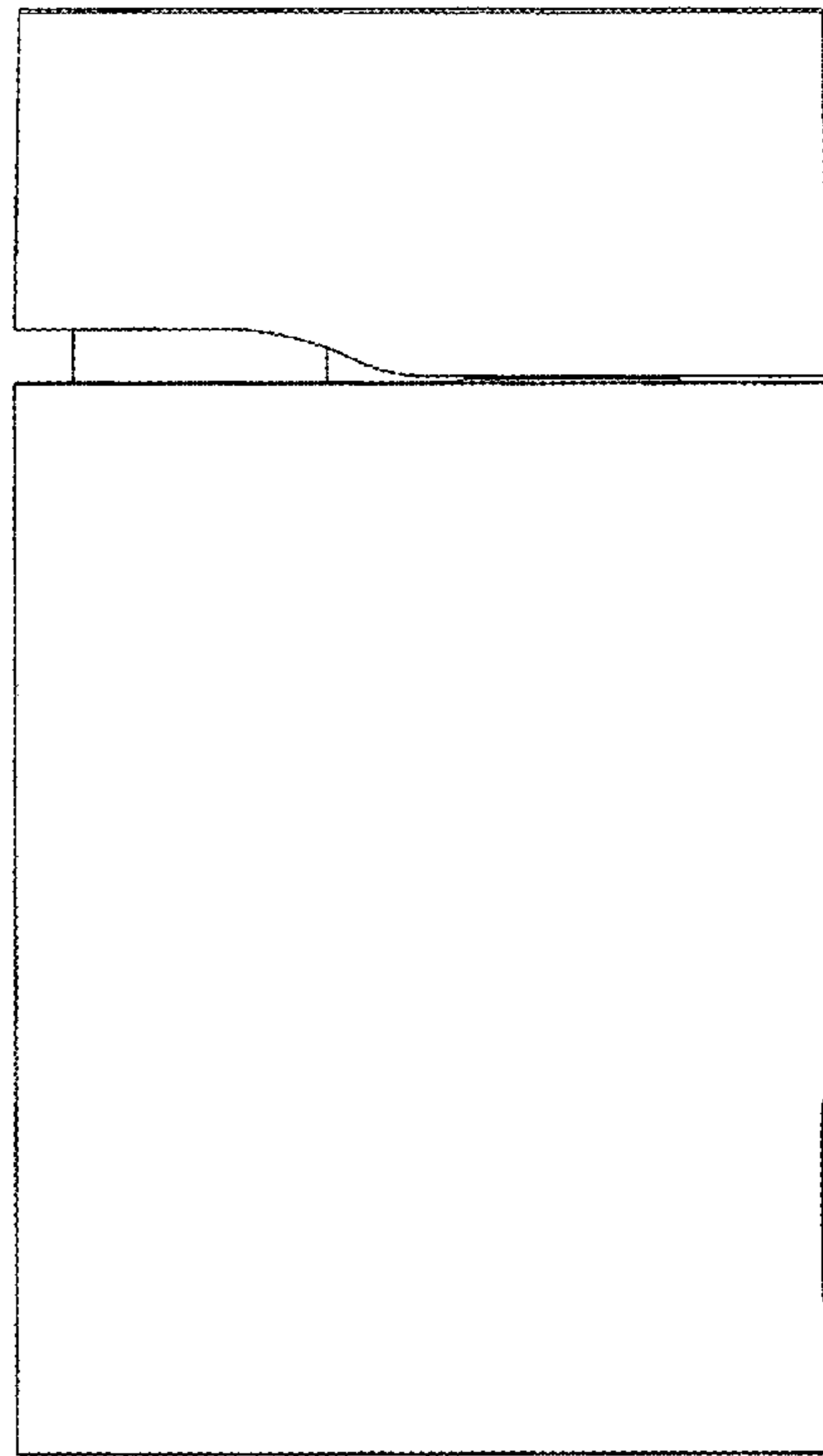

I claim the ornamental design for a tobacco evaporator, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a tobacco evaporator showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines in the drawings depict portions of the tobacco evaporator that form no part of the claimed design.

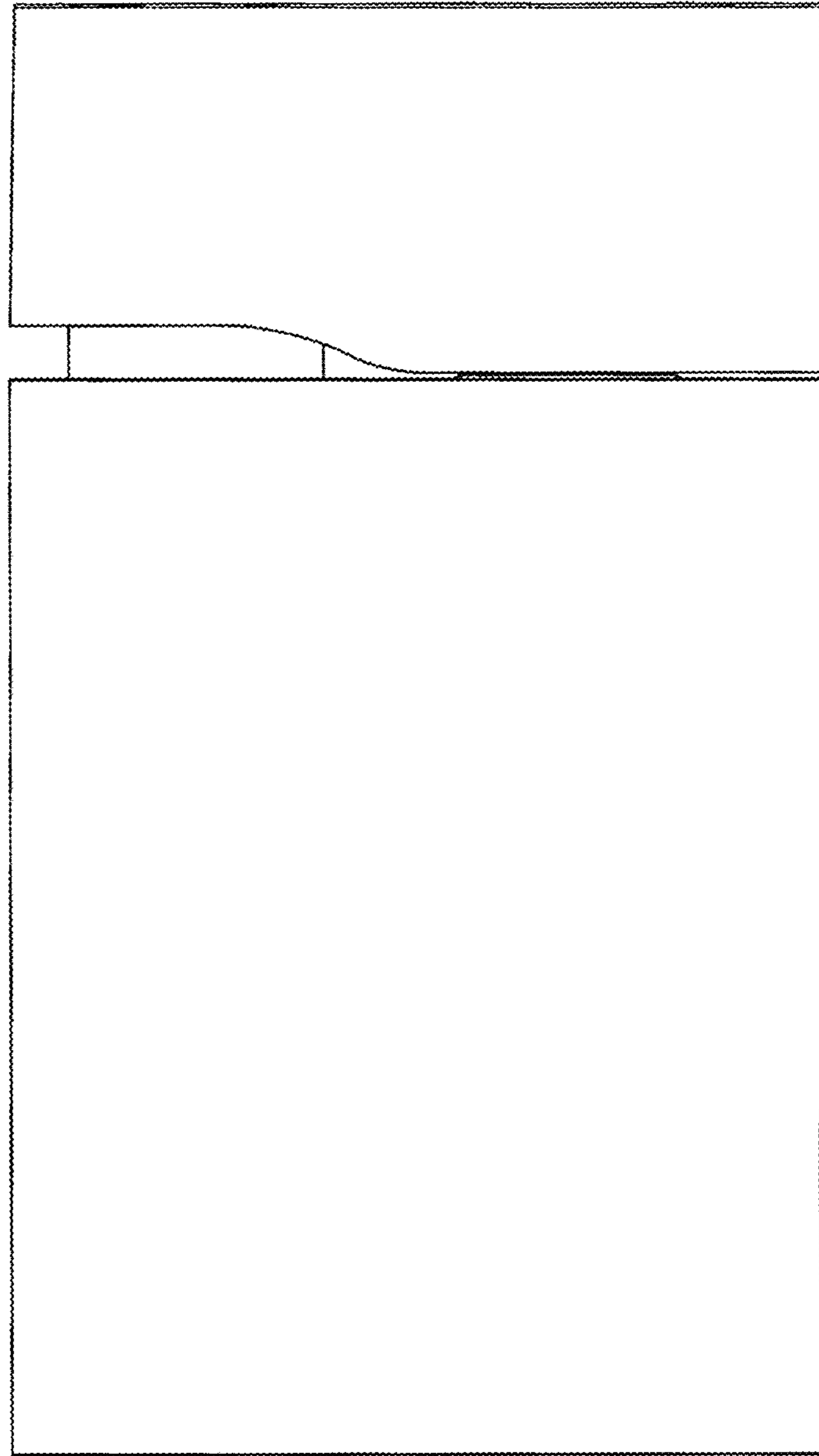

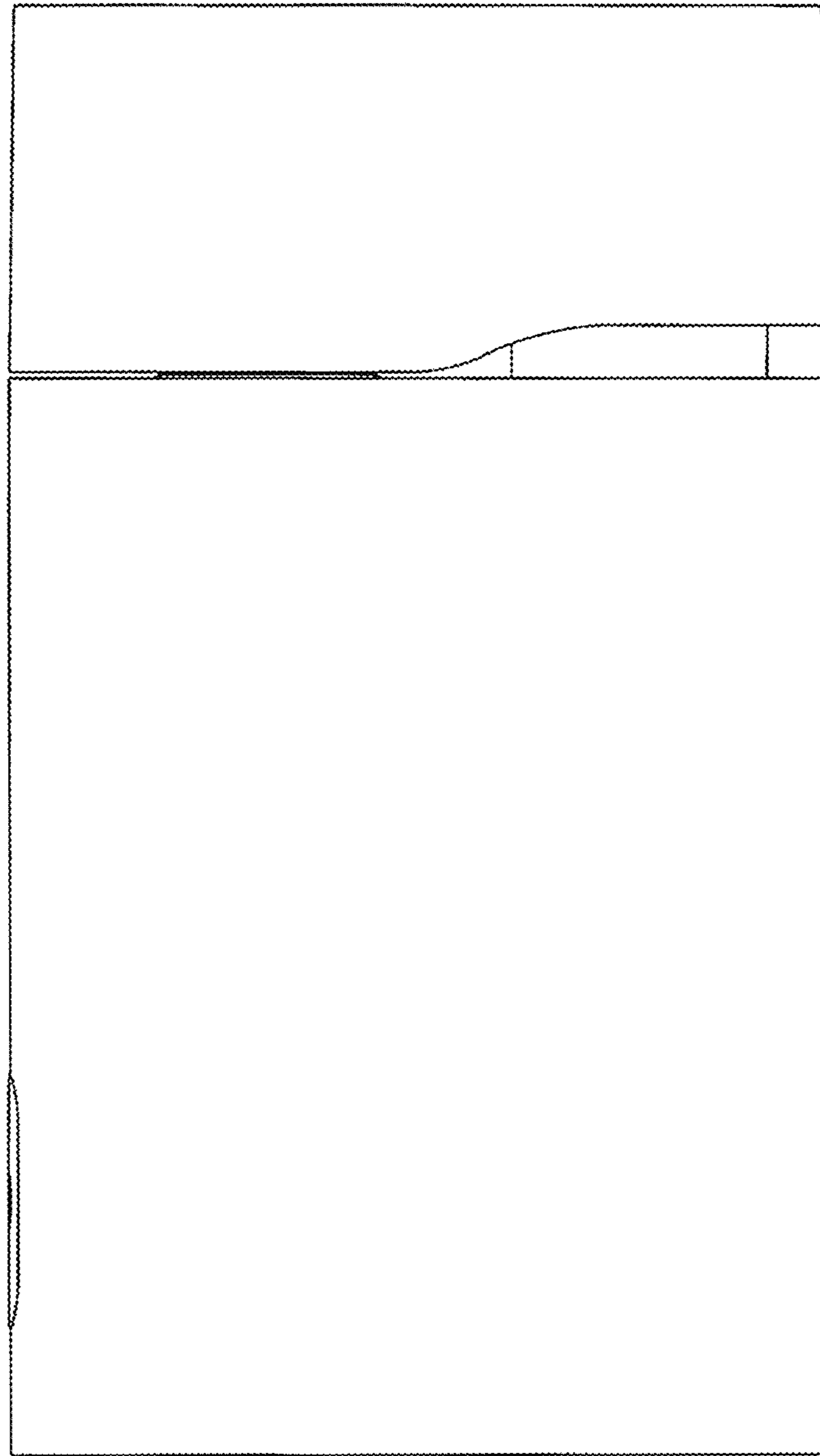

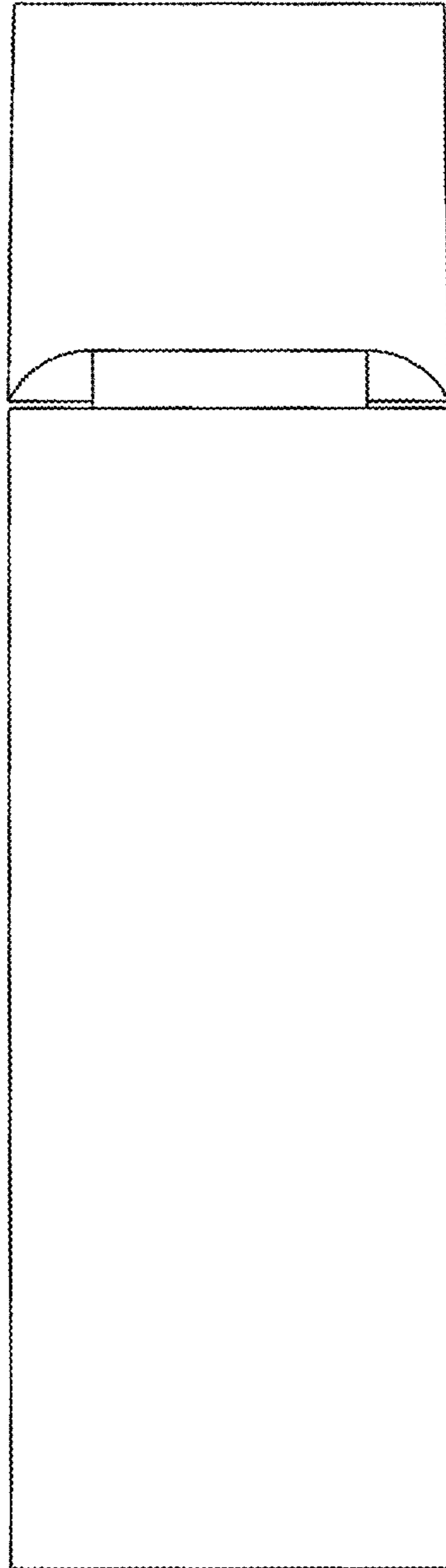

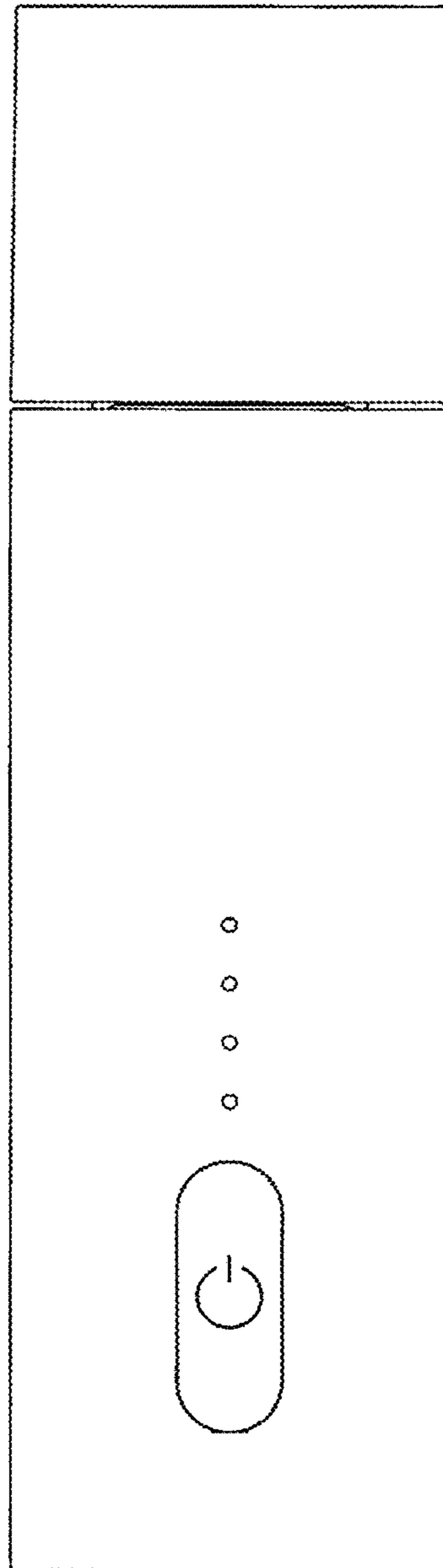

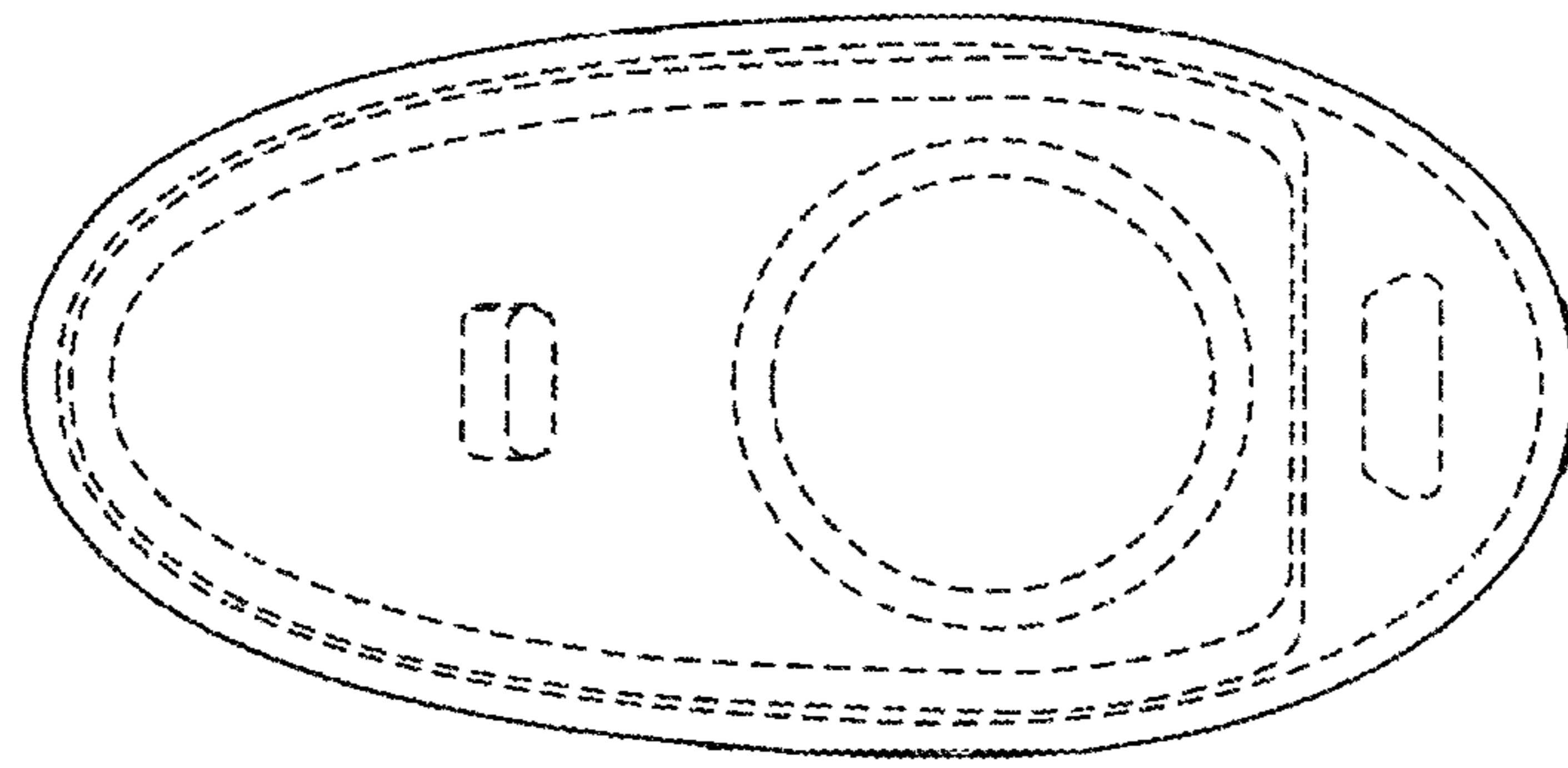

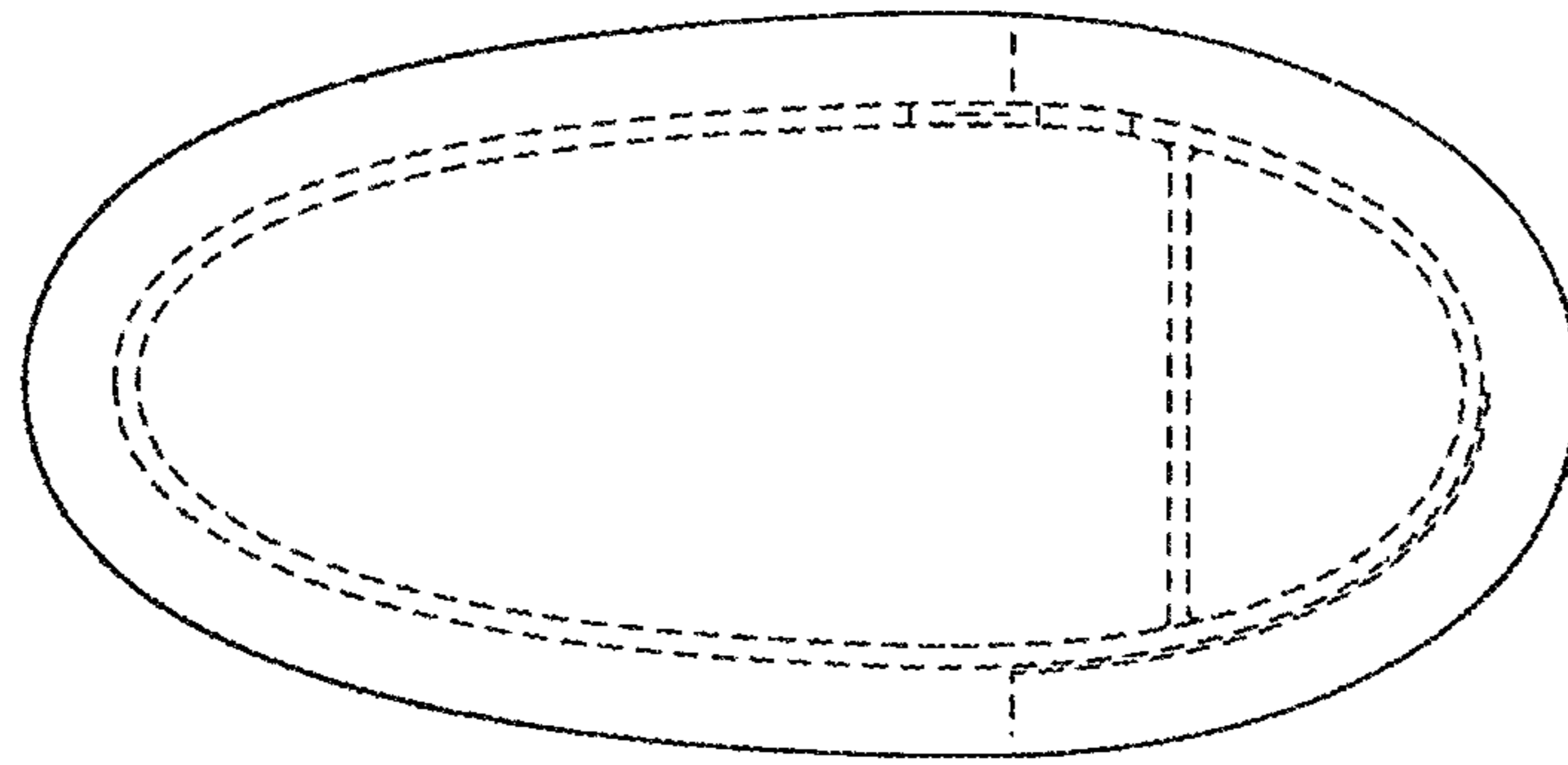
