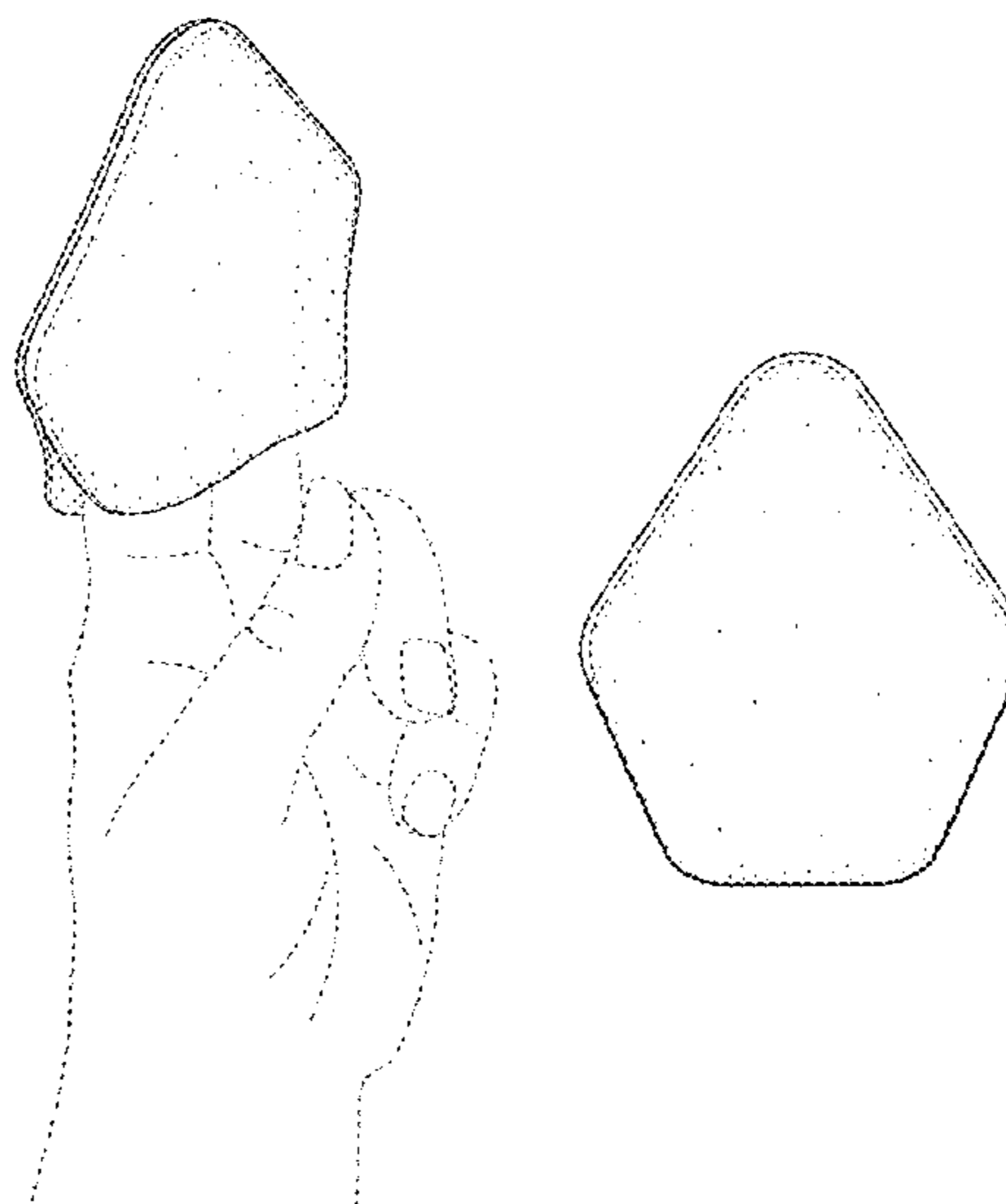
(57) **CLAIM**

The ornamental design for a multi-finger cosmetic applicator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a multi-finger cosmetic applicator showing the new design; FIG. 2 is a front elevation view of the multi-finger cosmetic applicator of FIG. 1, the back elevation view being a mirror image of the front elevation view; FIG. 3 is a right side view of the multi-finger cosmetic applicator of FIG. 1, the left side view being a mirror image of the right side view; FIG. 4 is a top view of the multi-finger cosmetic applicator of FIG. 1; and, FIG. 5 is a bottom view of the multi-finger cosmetic applicator of FIG. 1. The broken lines in the drawings illustrate unclaimed environment or unclaimed portions of the multi-finger cosmetic applicator and form no part of the claimed design.

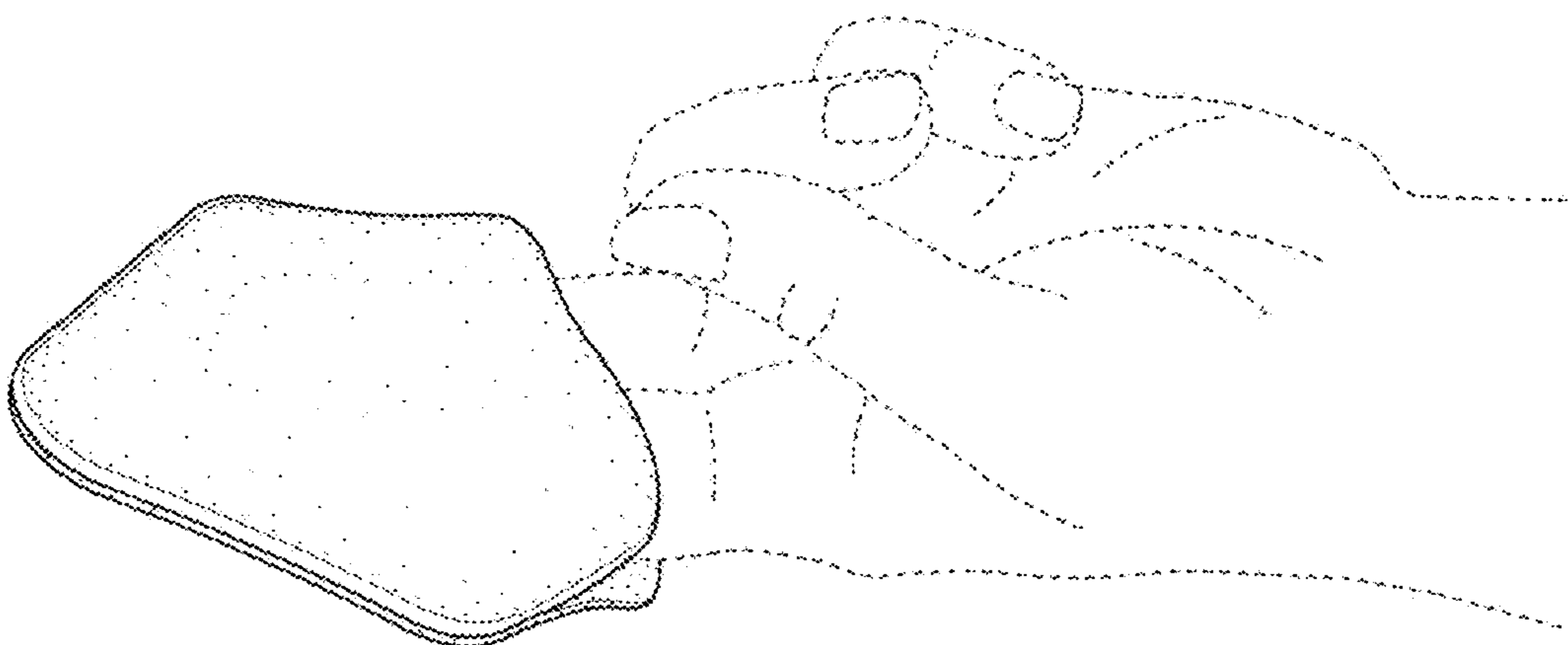

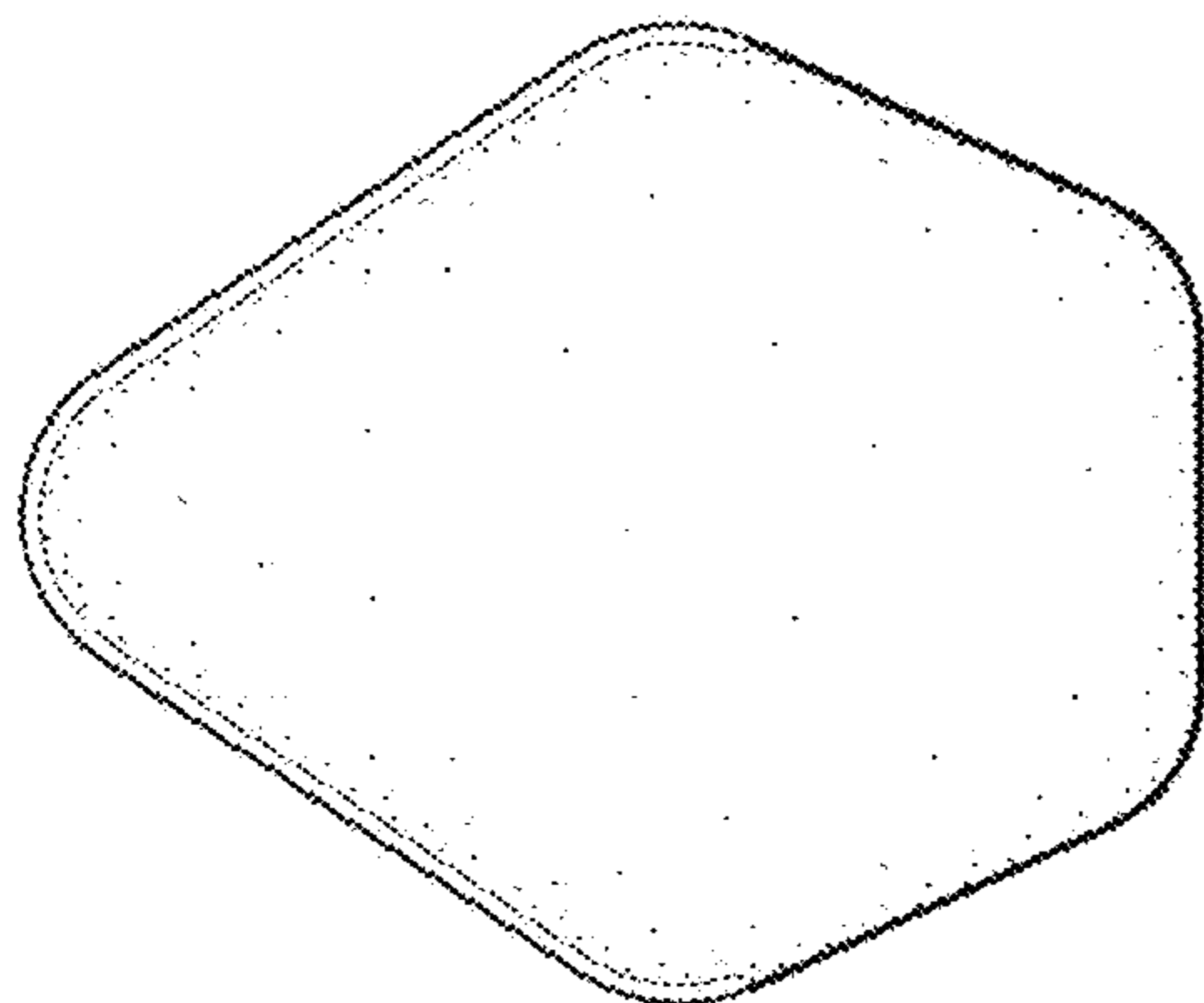

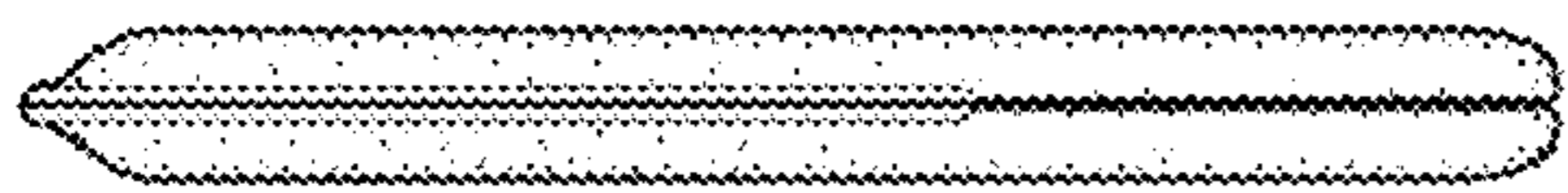

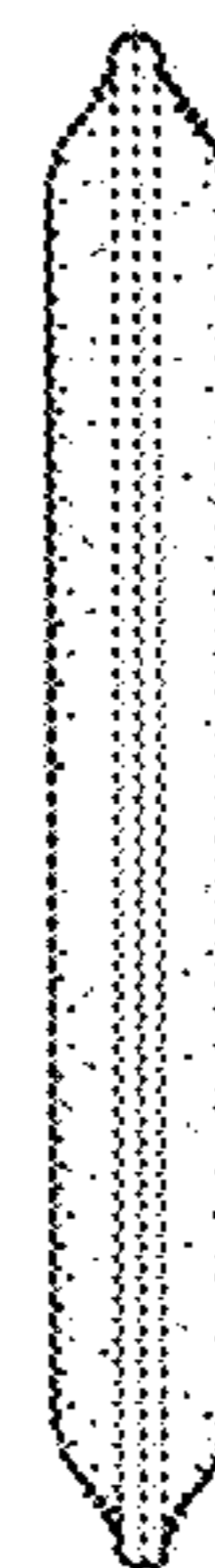

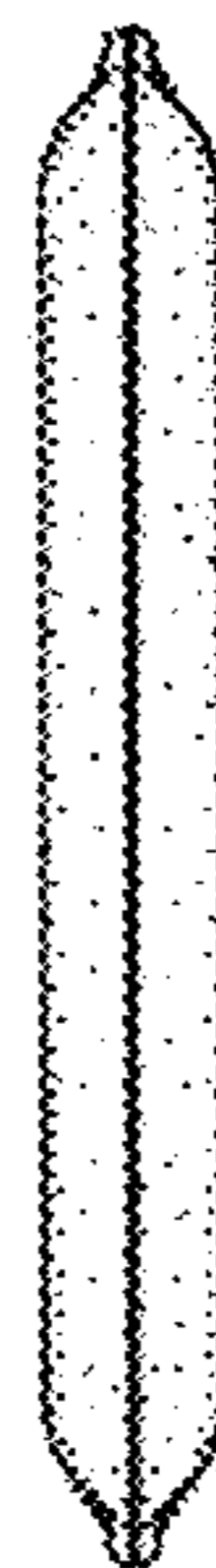
