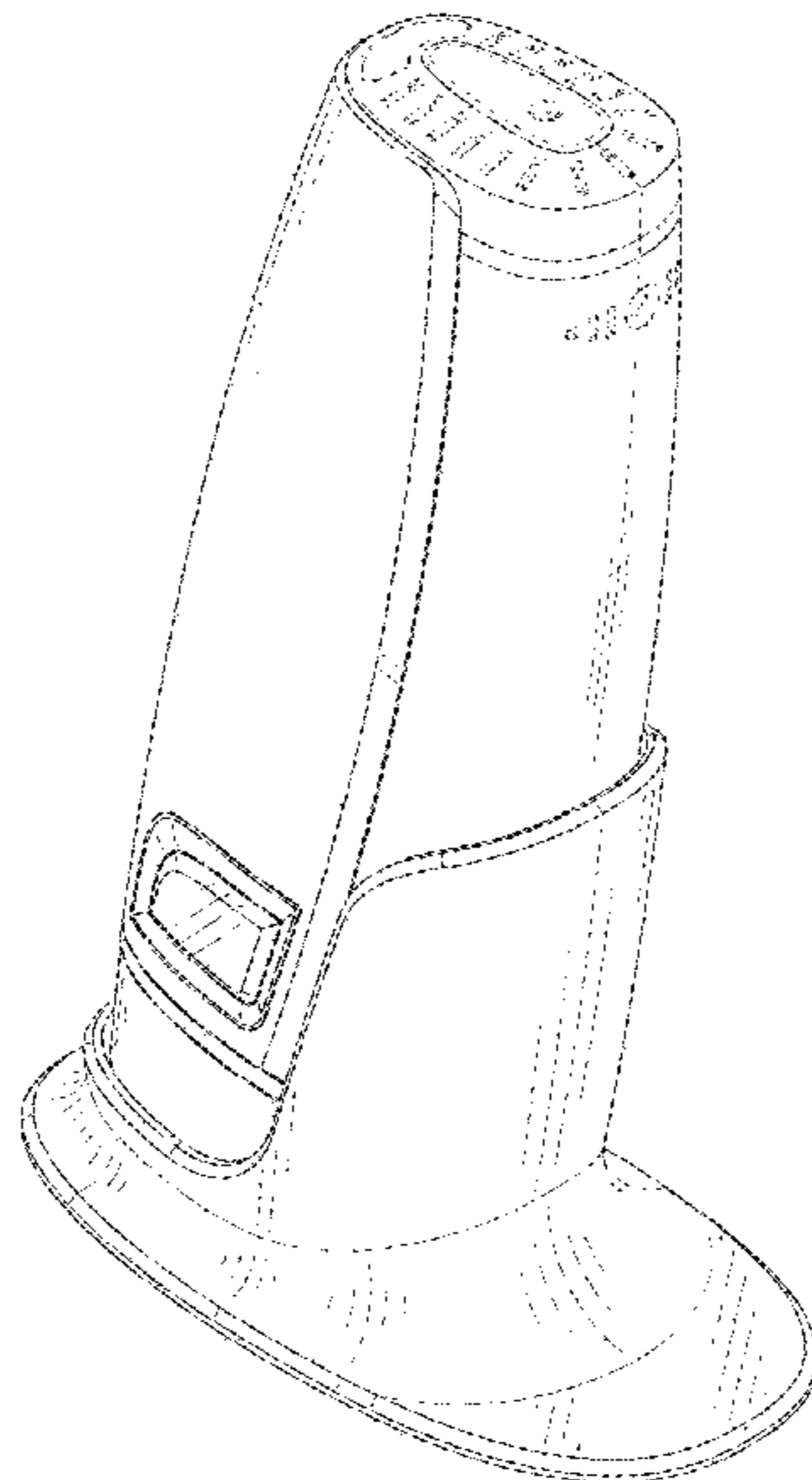
(57) **CLAIM**

I claim the ornamental design for a combined photon hair removal instrument and stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined photon hair removal instrument and stand showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is another perspective view thereof. The broken lines illustrate portions of the combined photon hair removal instrument and stand that form no part of the claimed design.

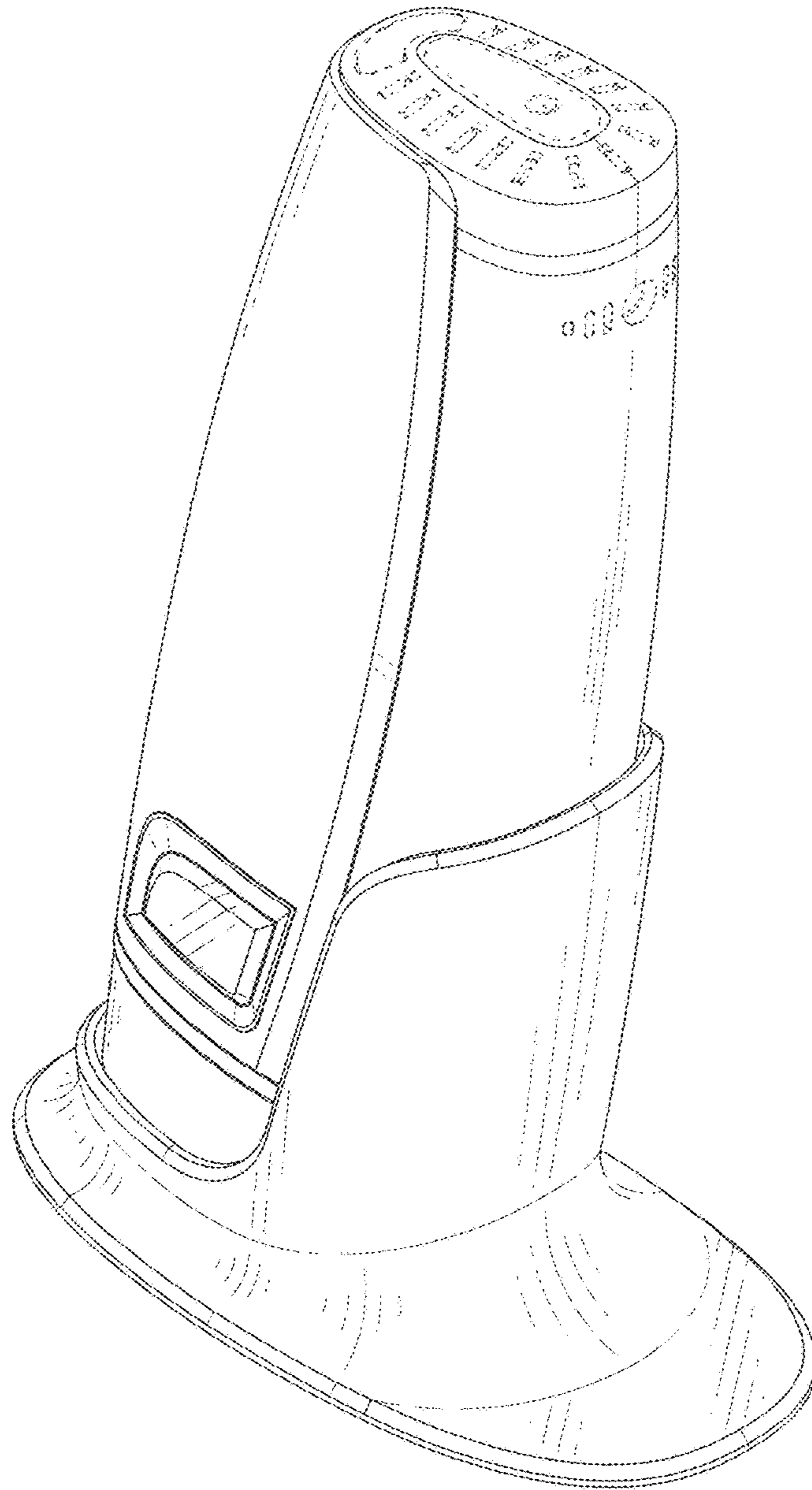

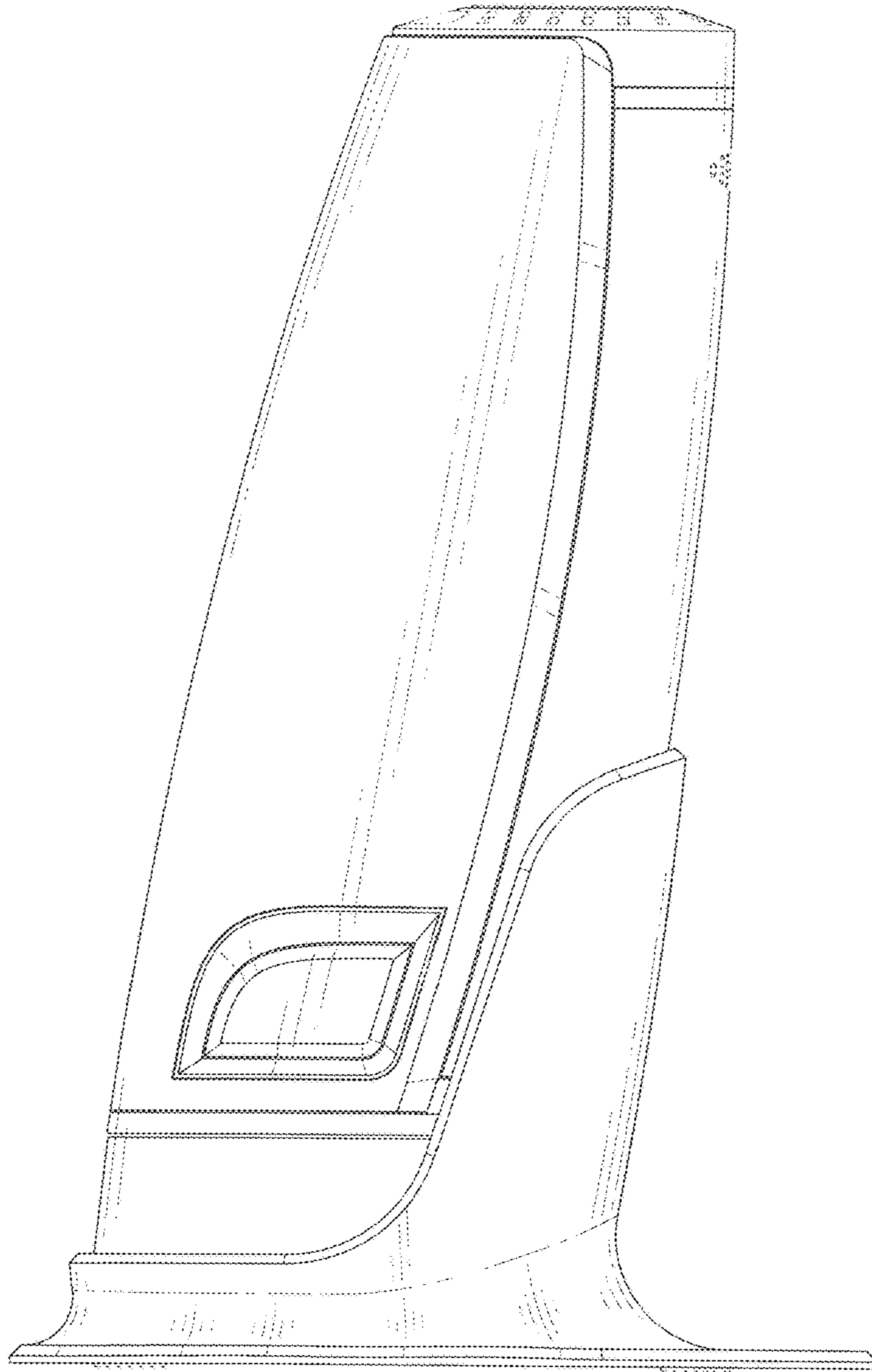

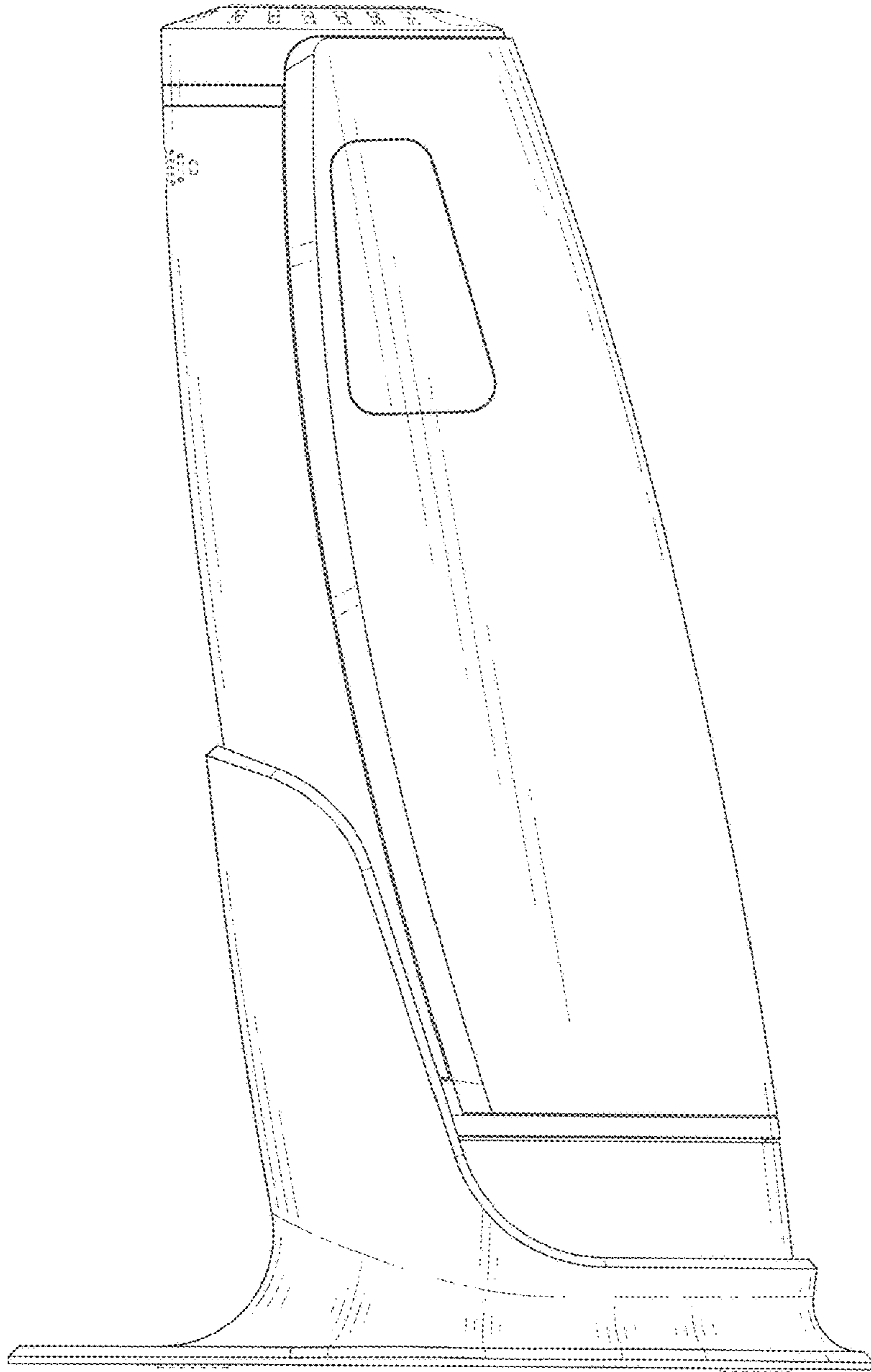

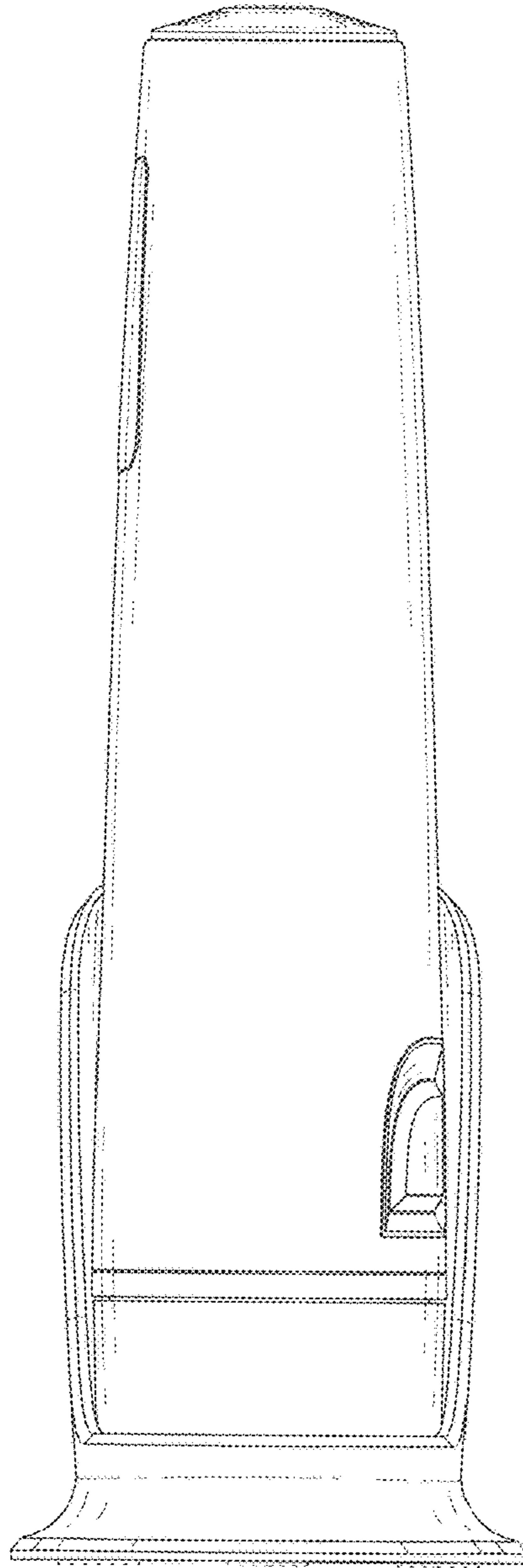

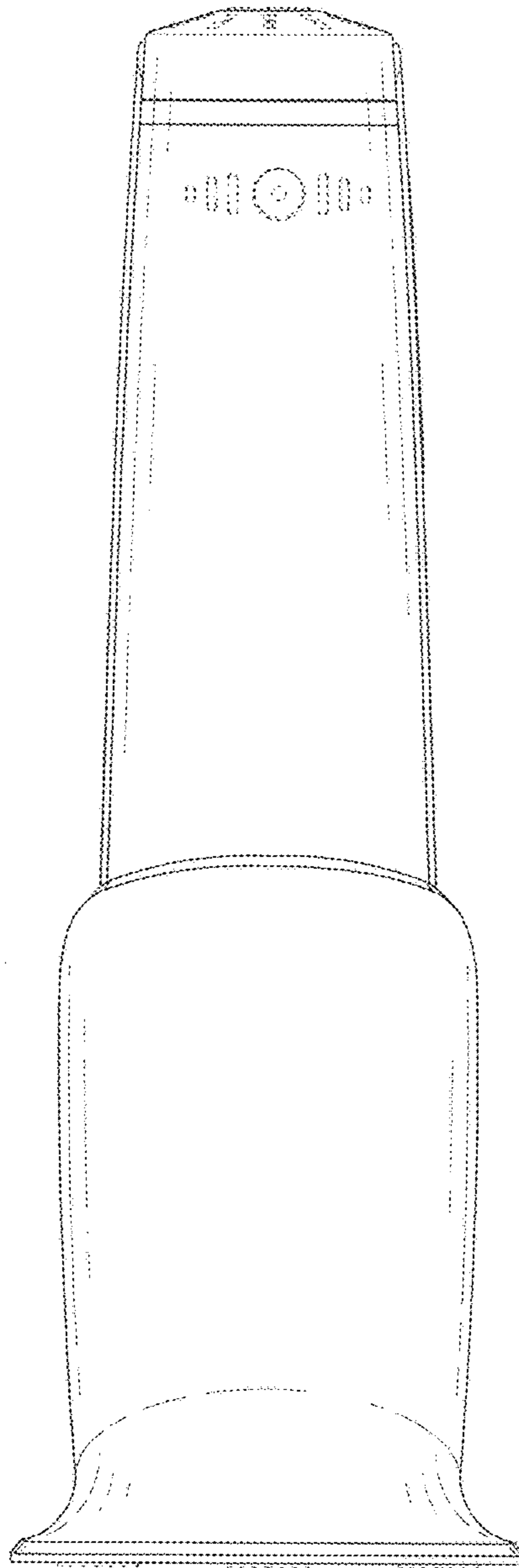

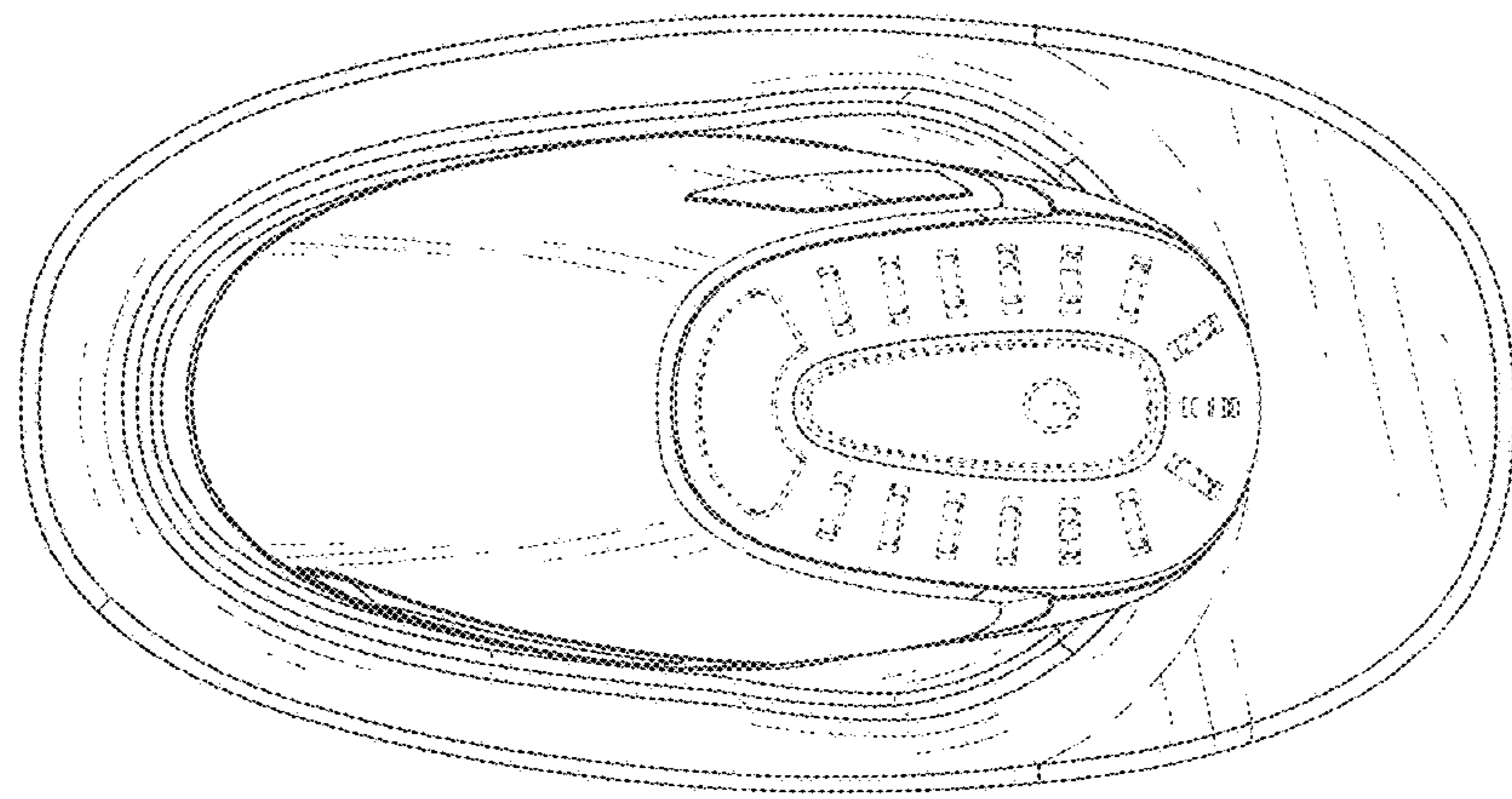

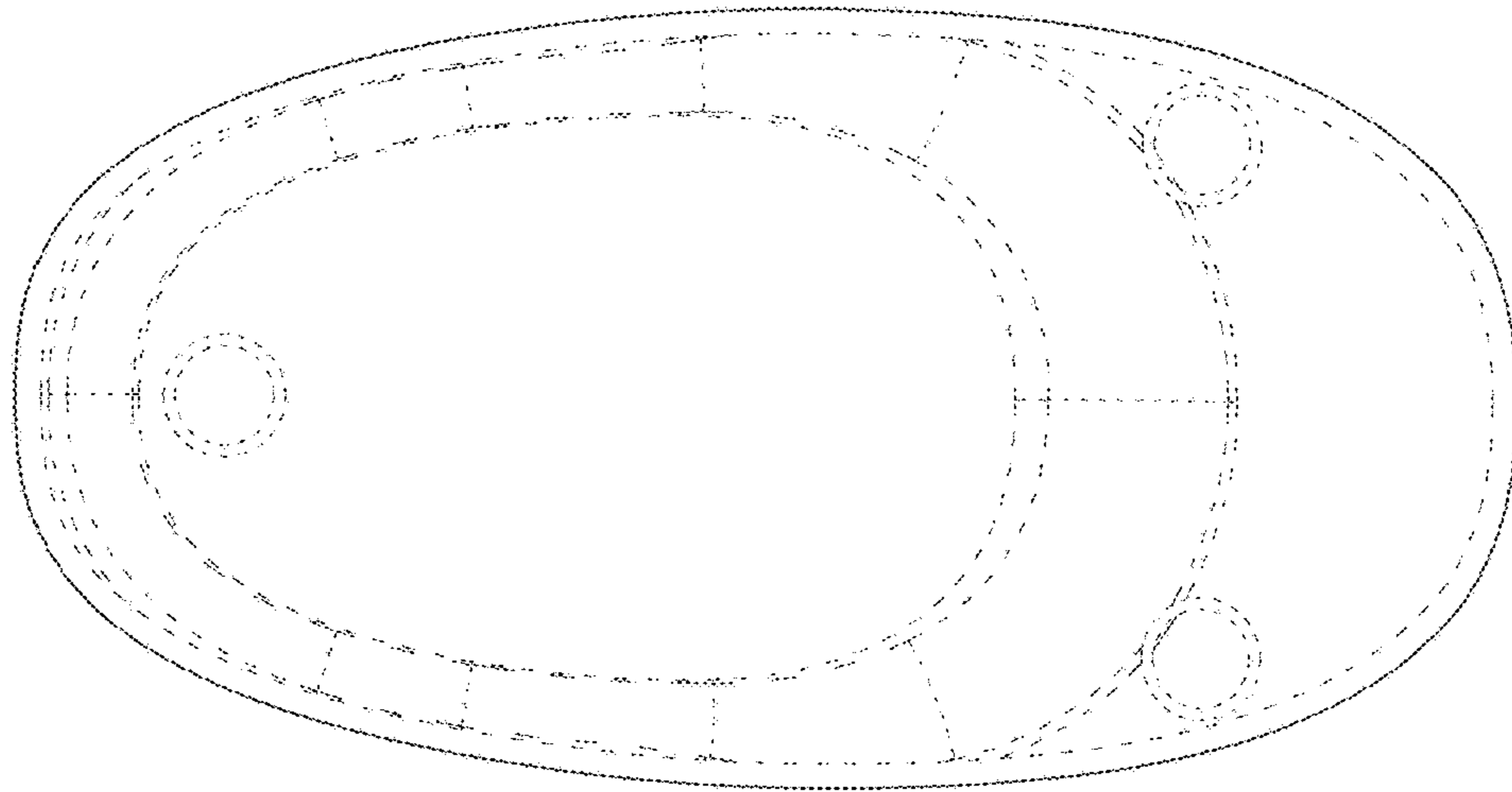

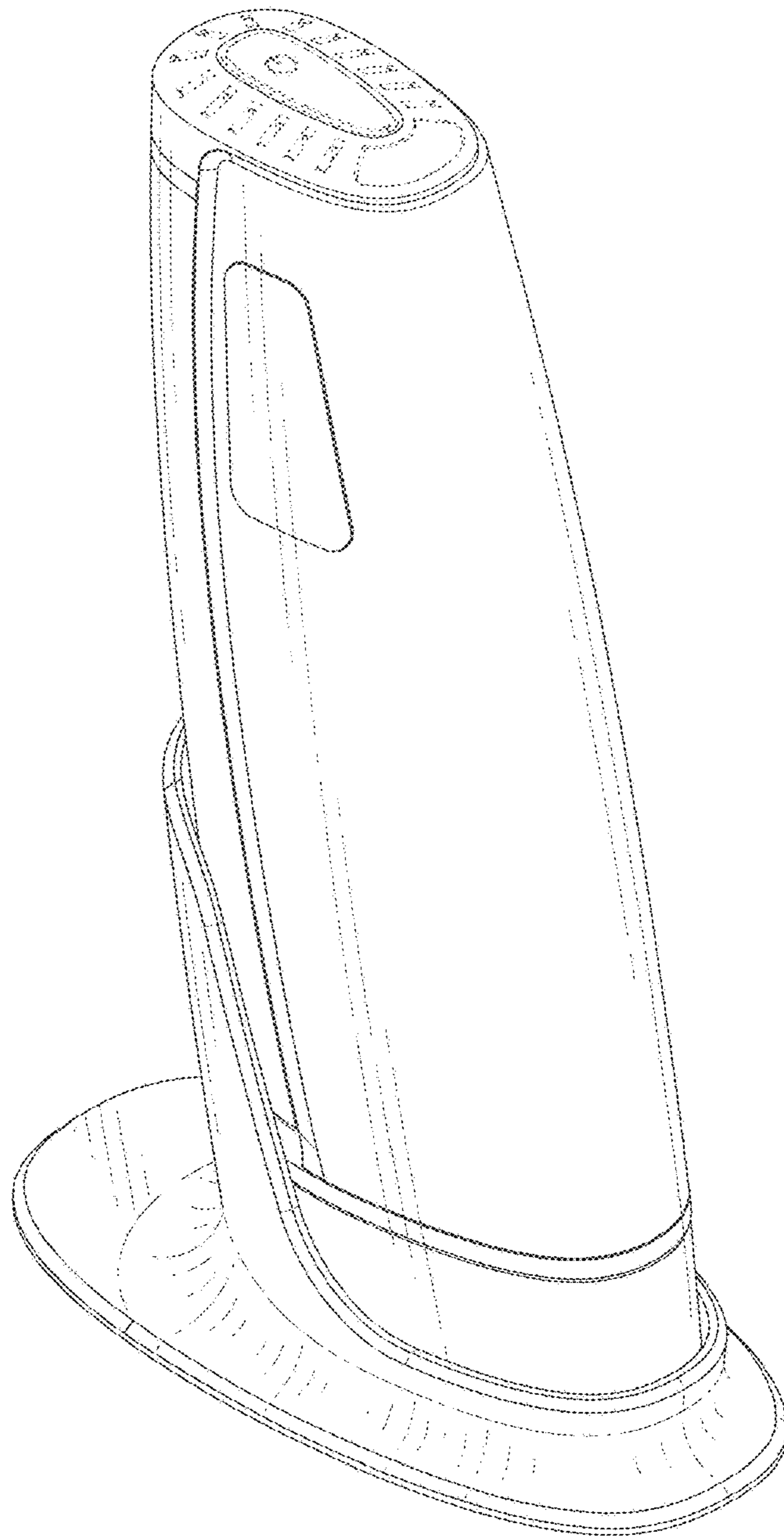
