The broken lines shown in the drawings depict portions of the pet toy that form no part of the claimed design.

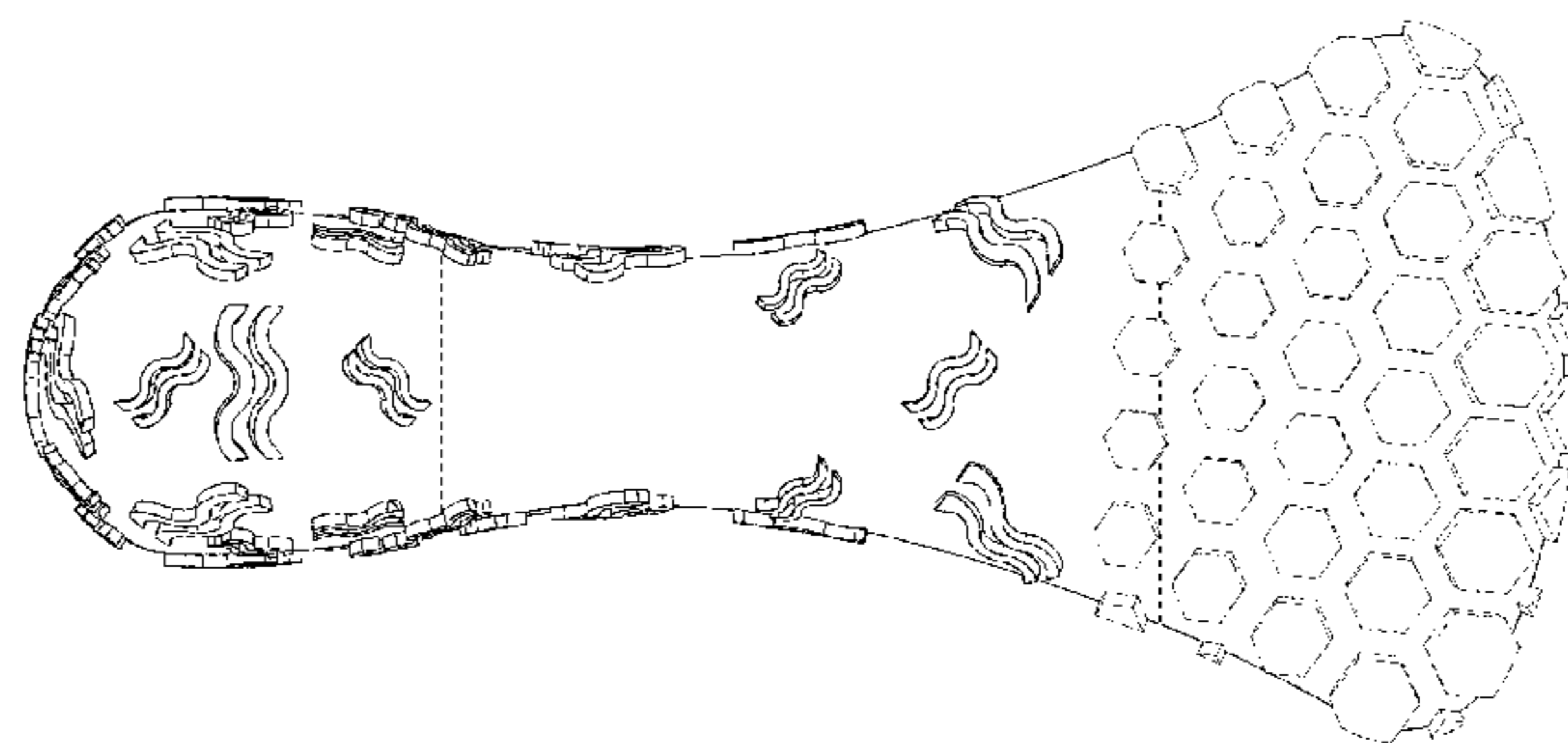
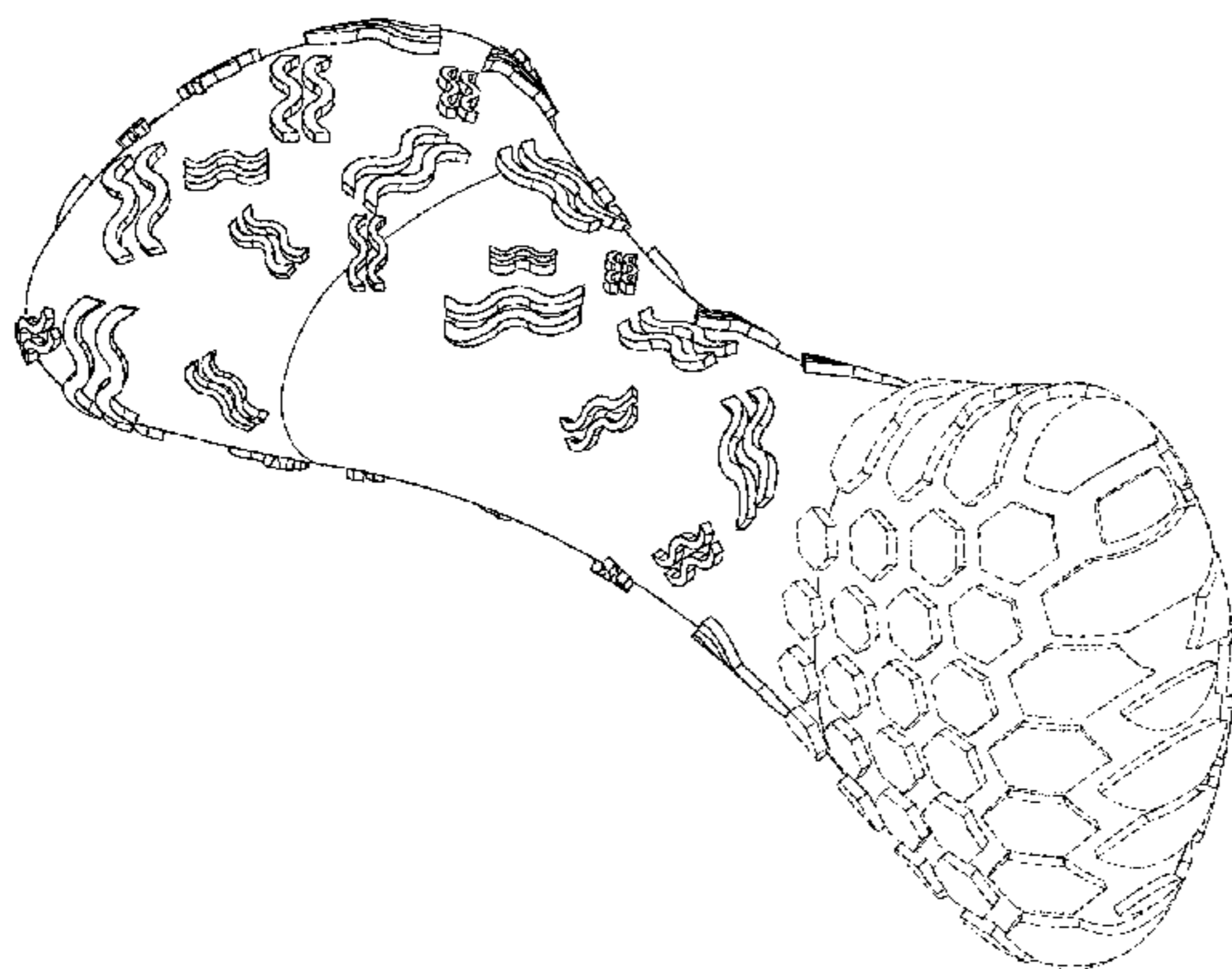

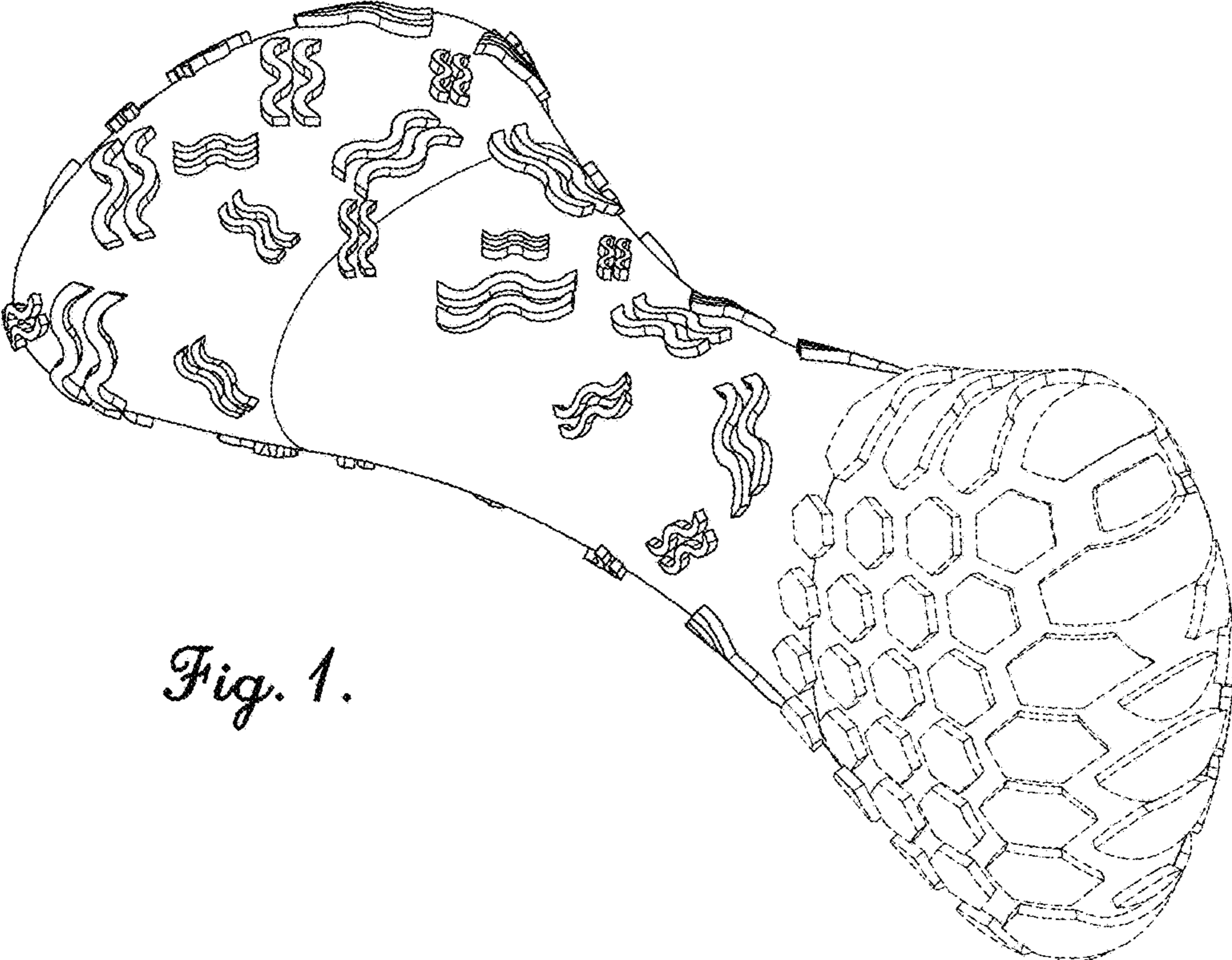

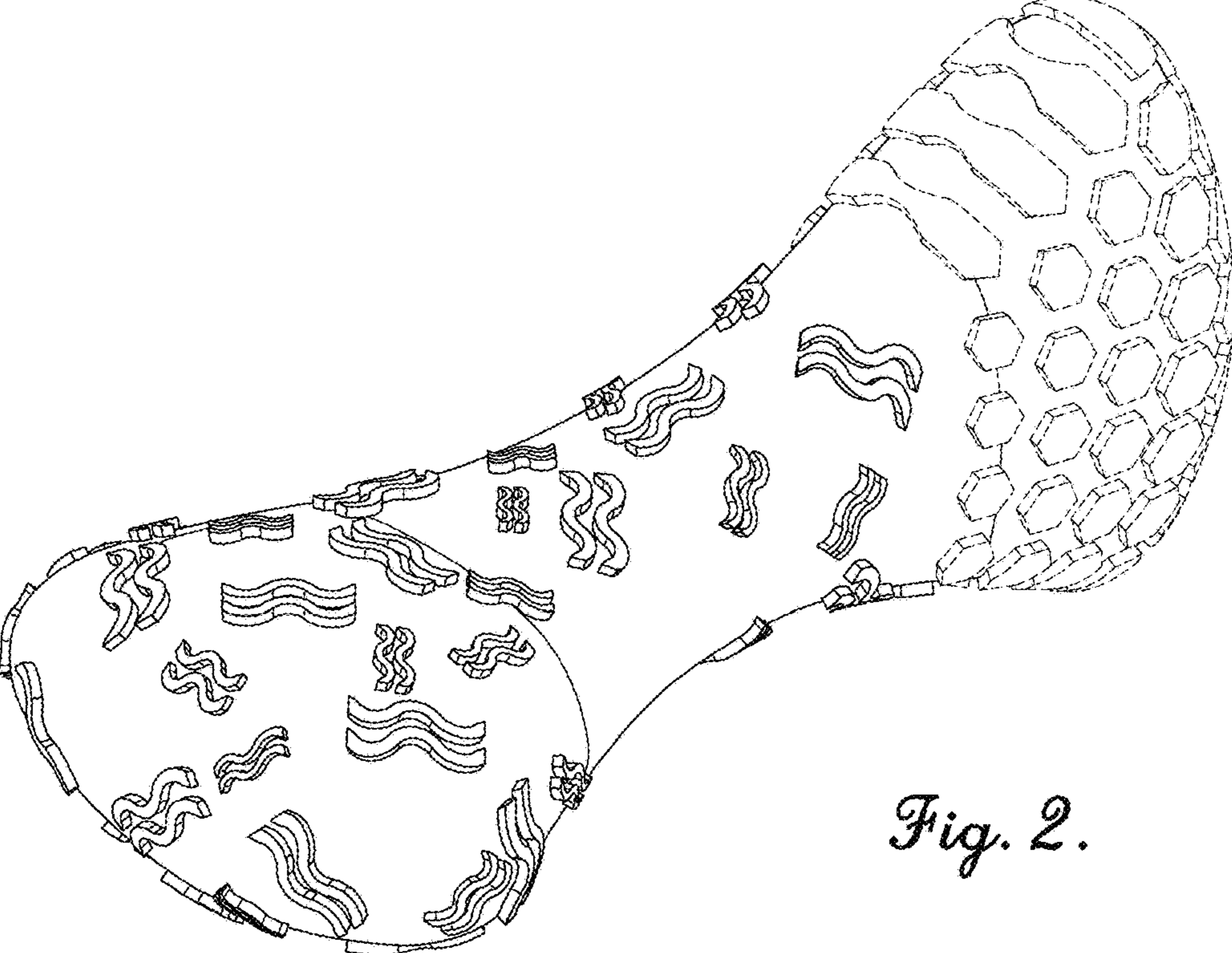

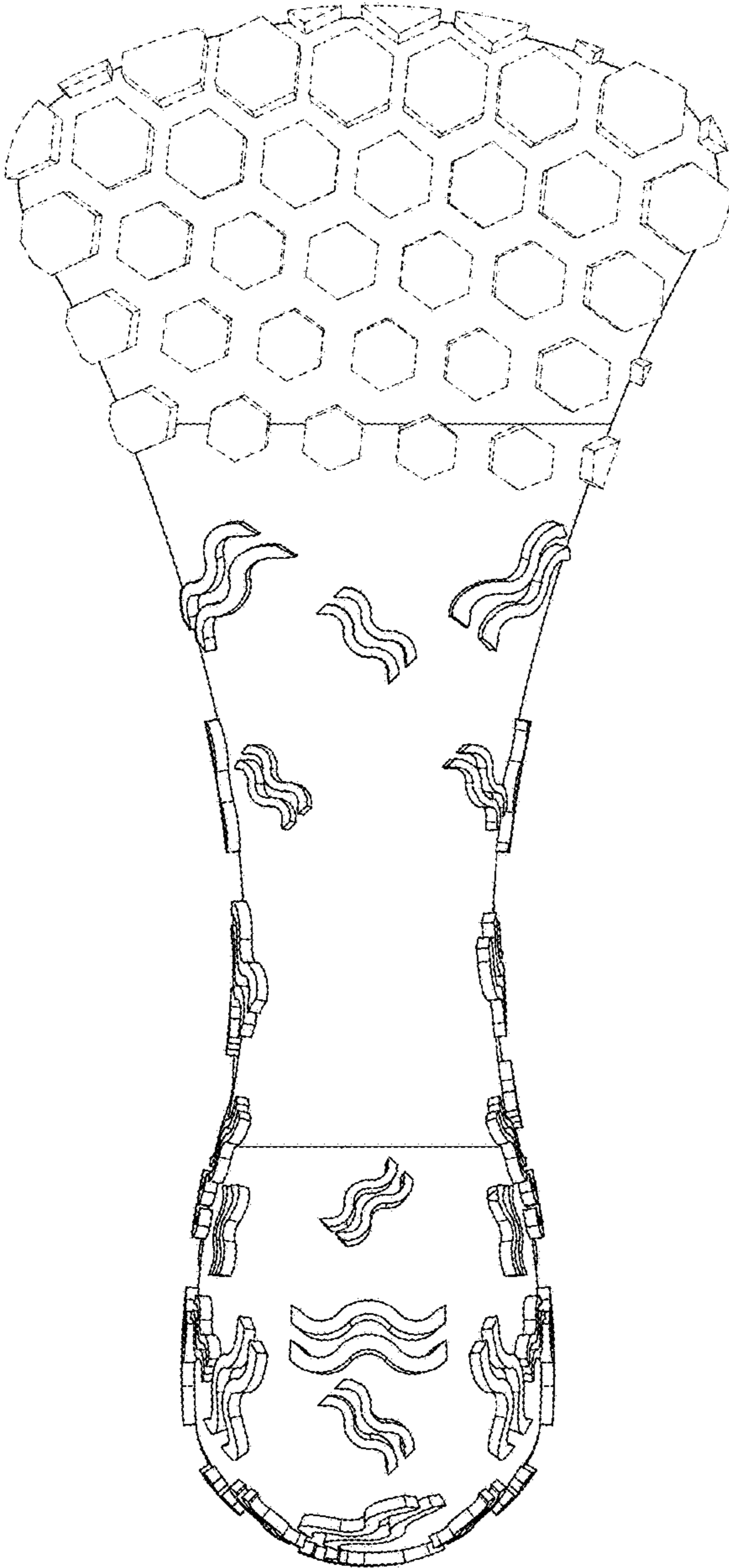

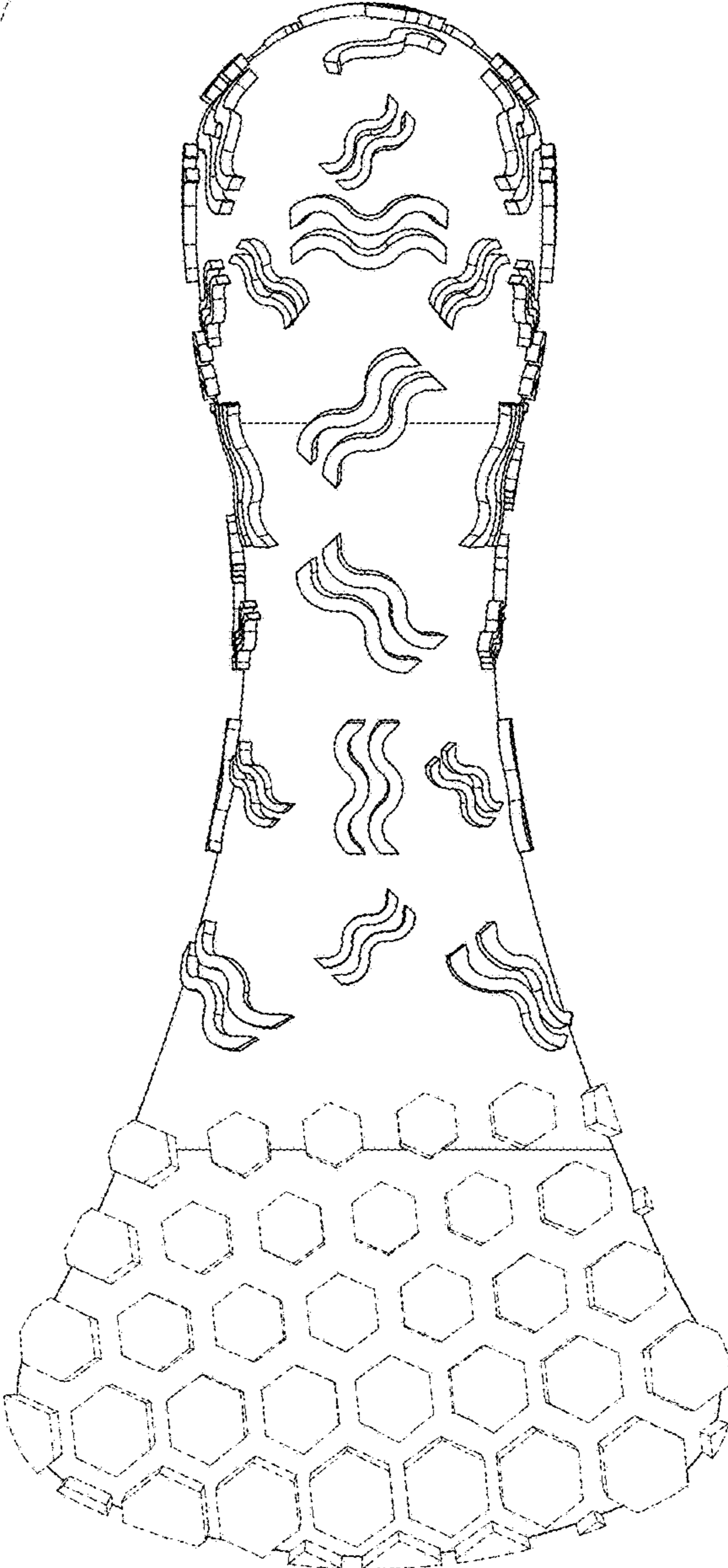

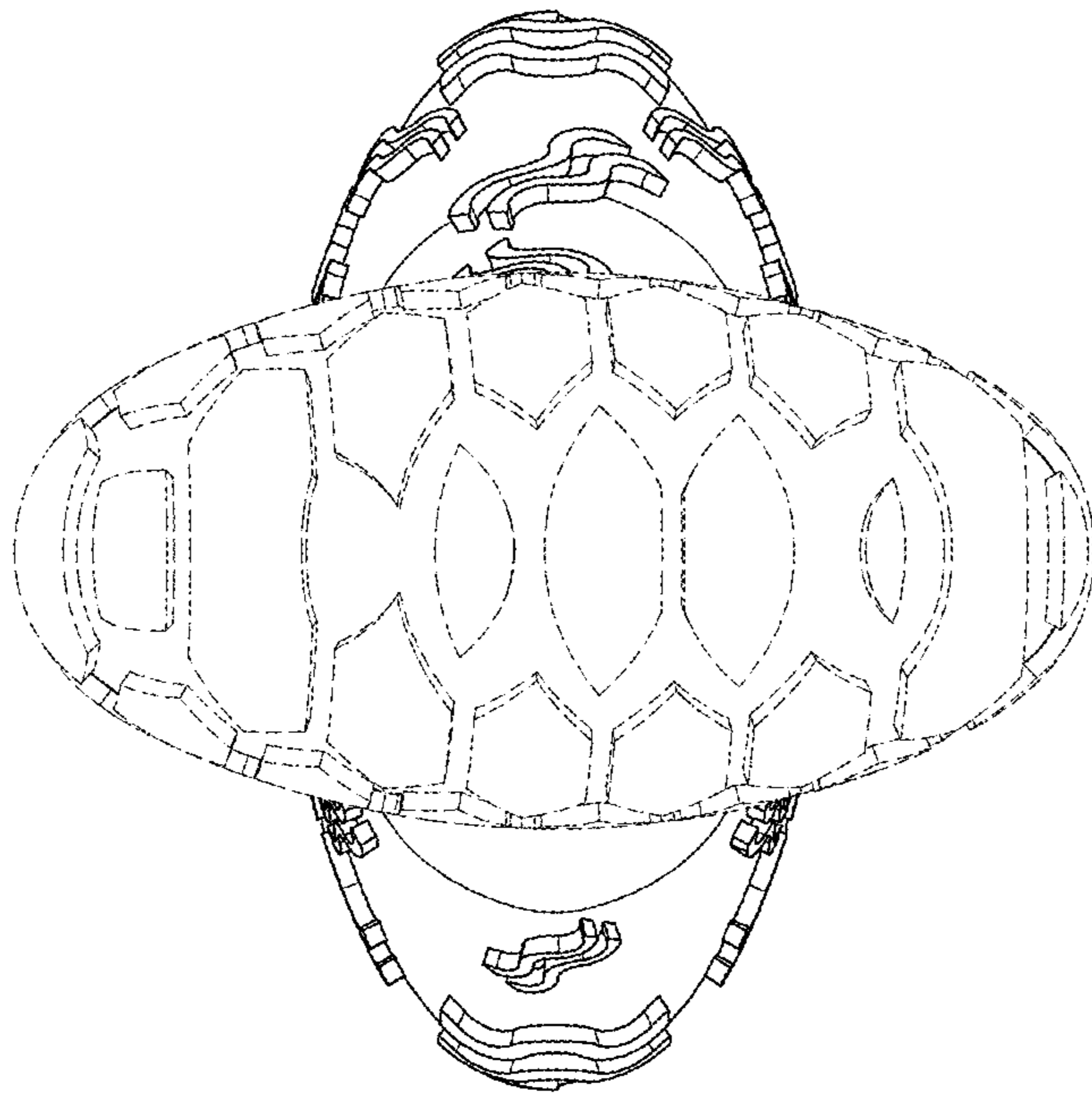

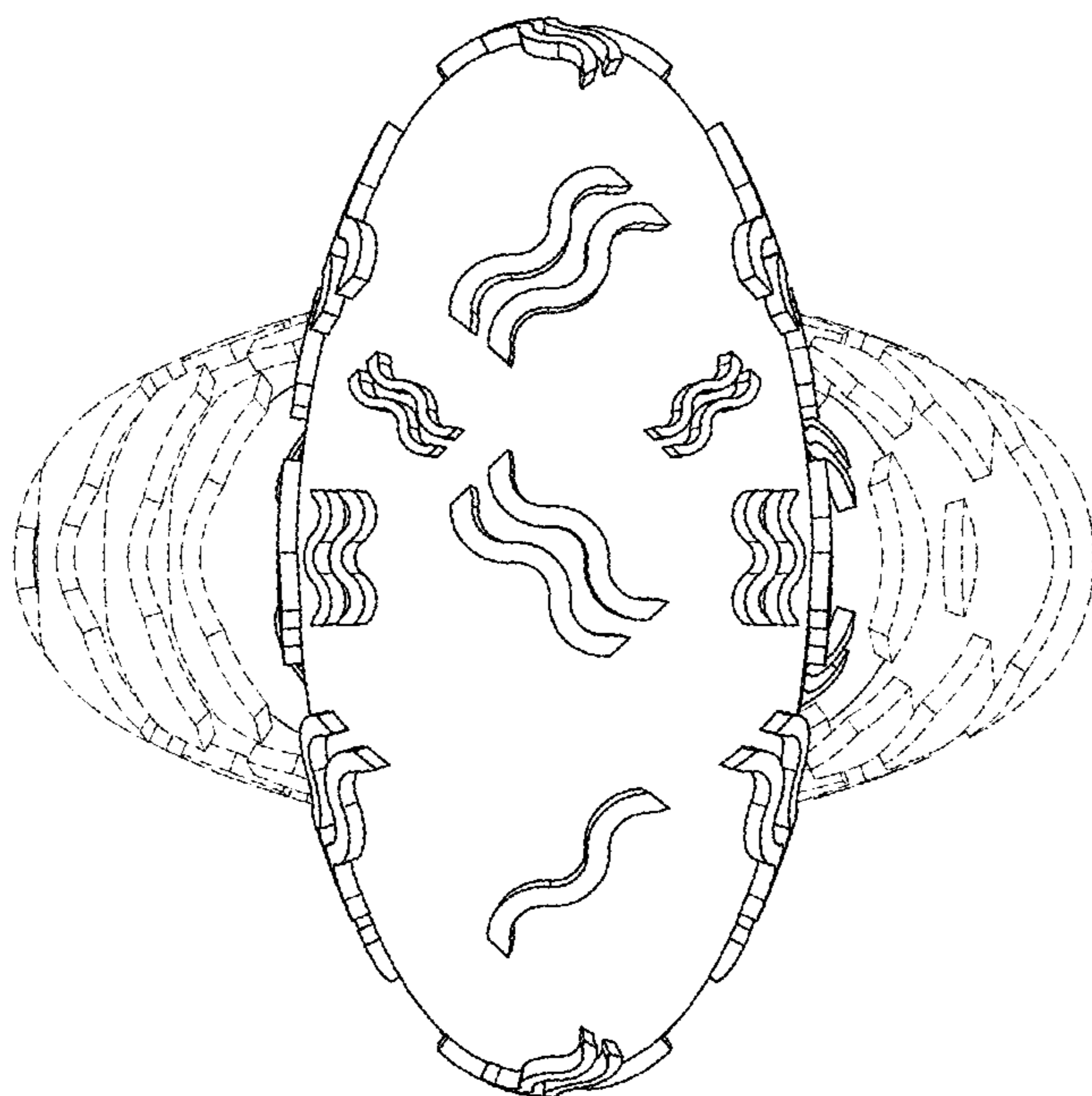

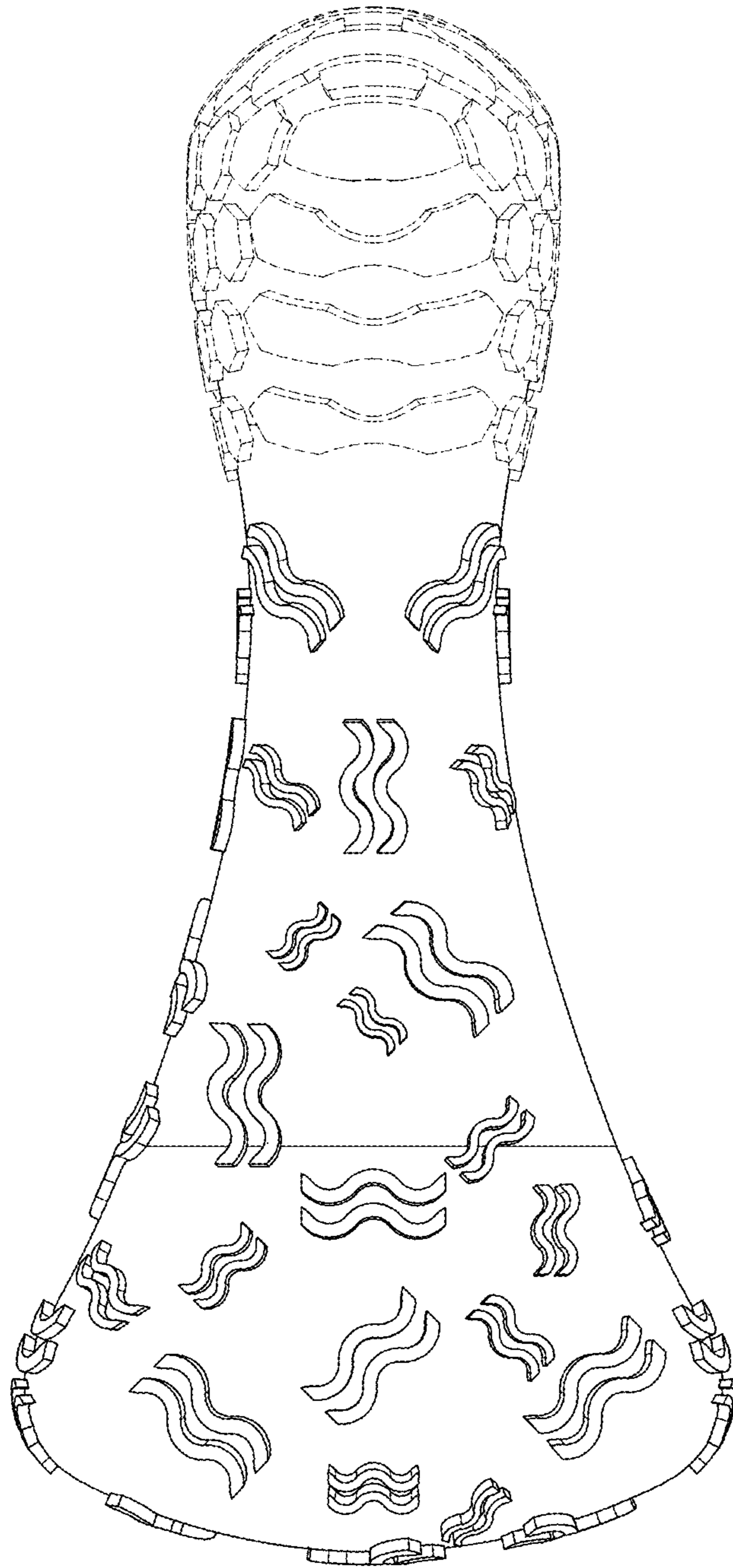

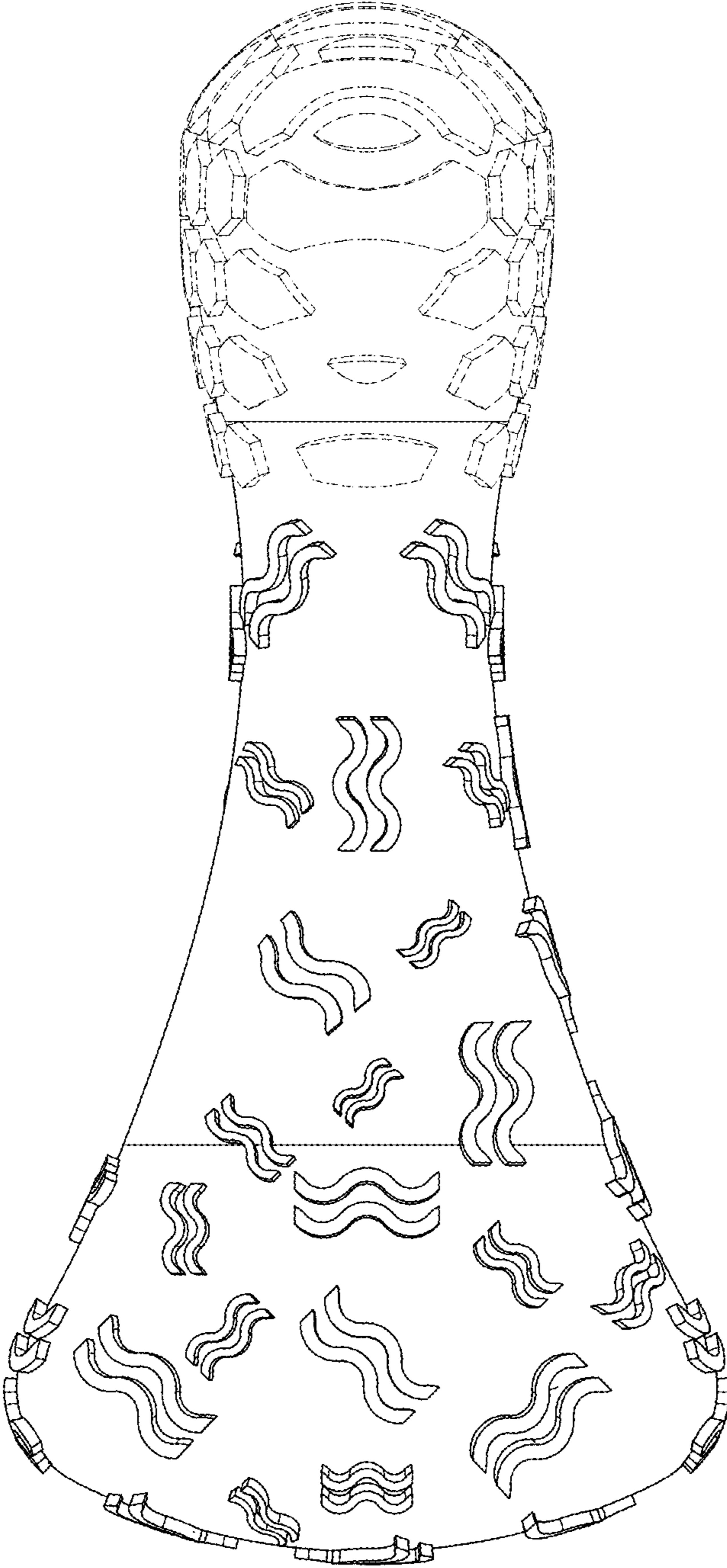
