(57) **CLAIM**

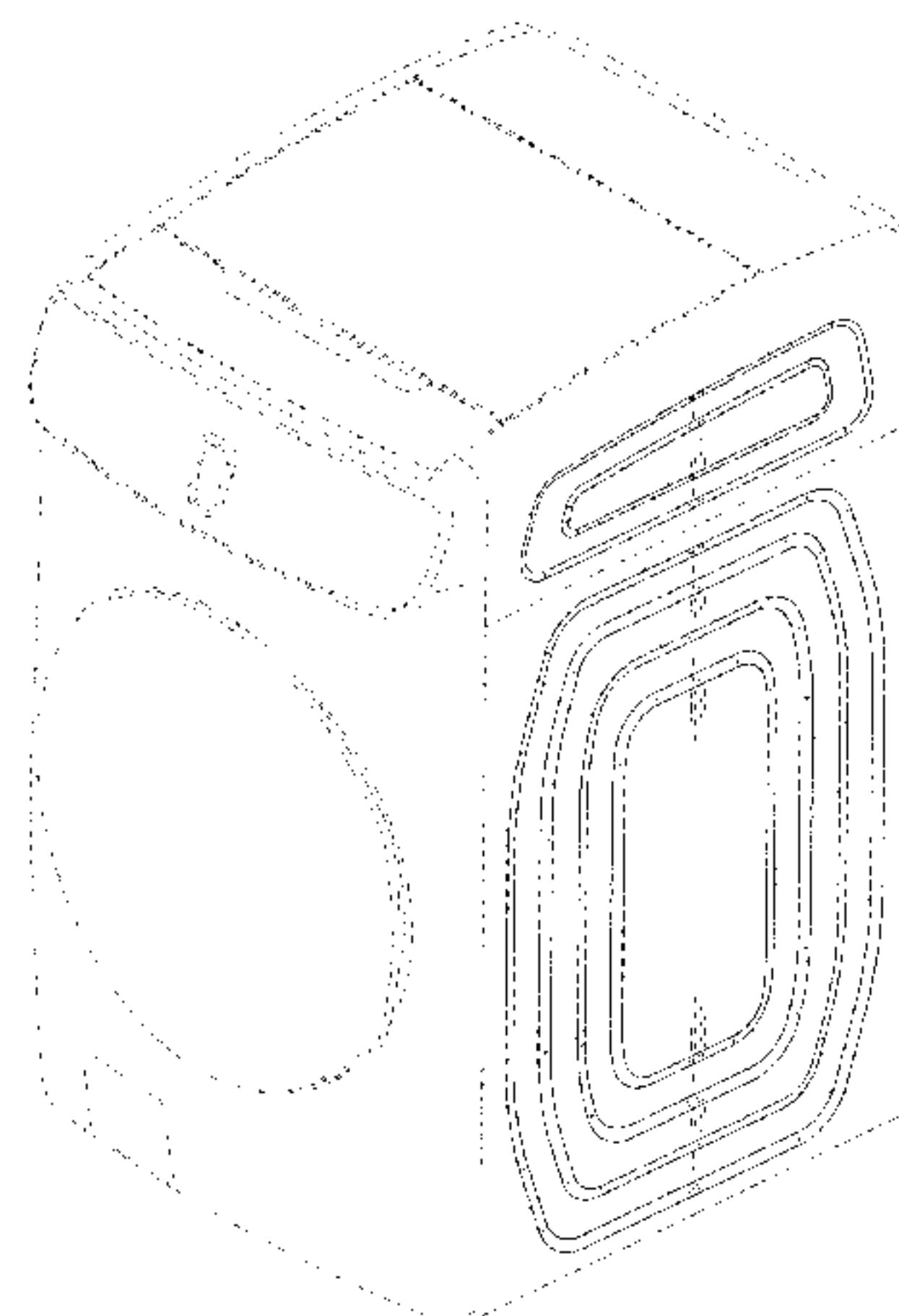
We claim the ornamental design for a washing machine, as shown and described.

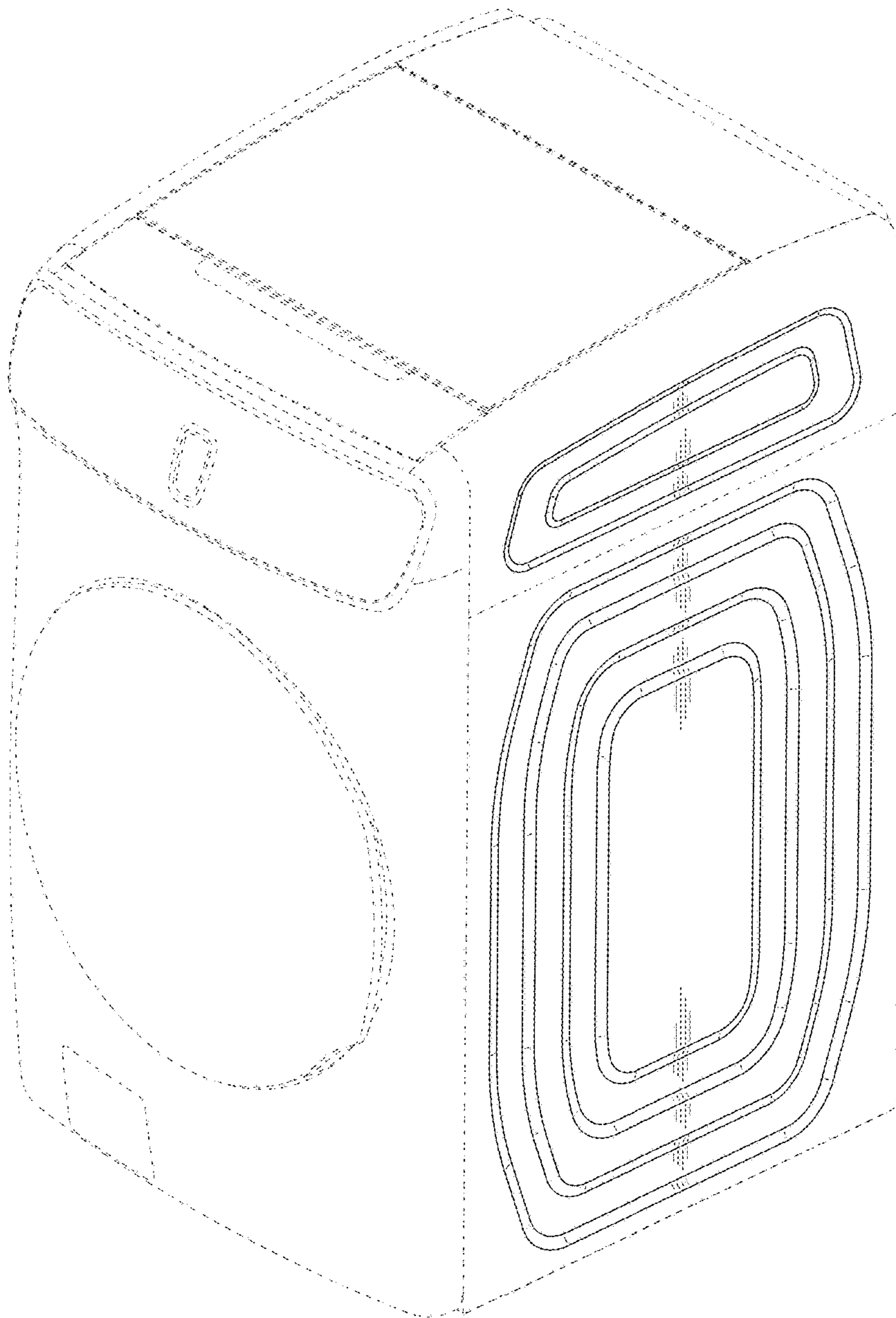

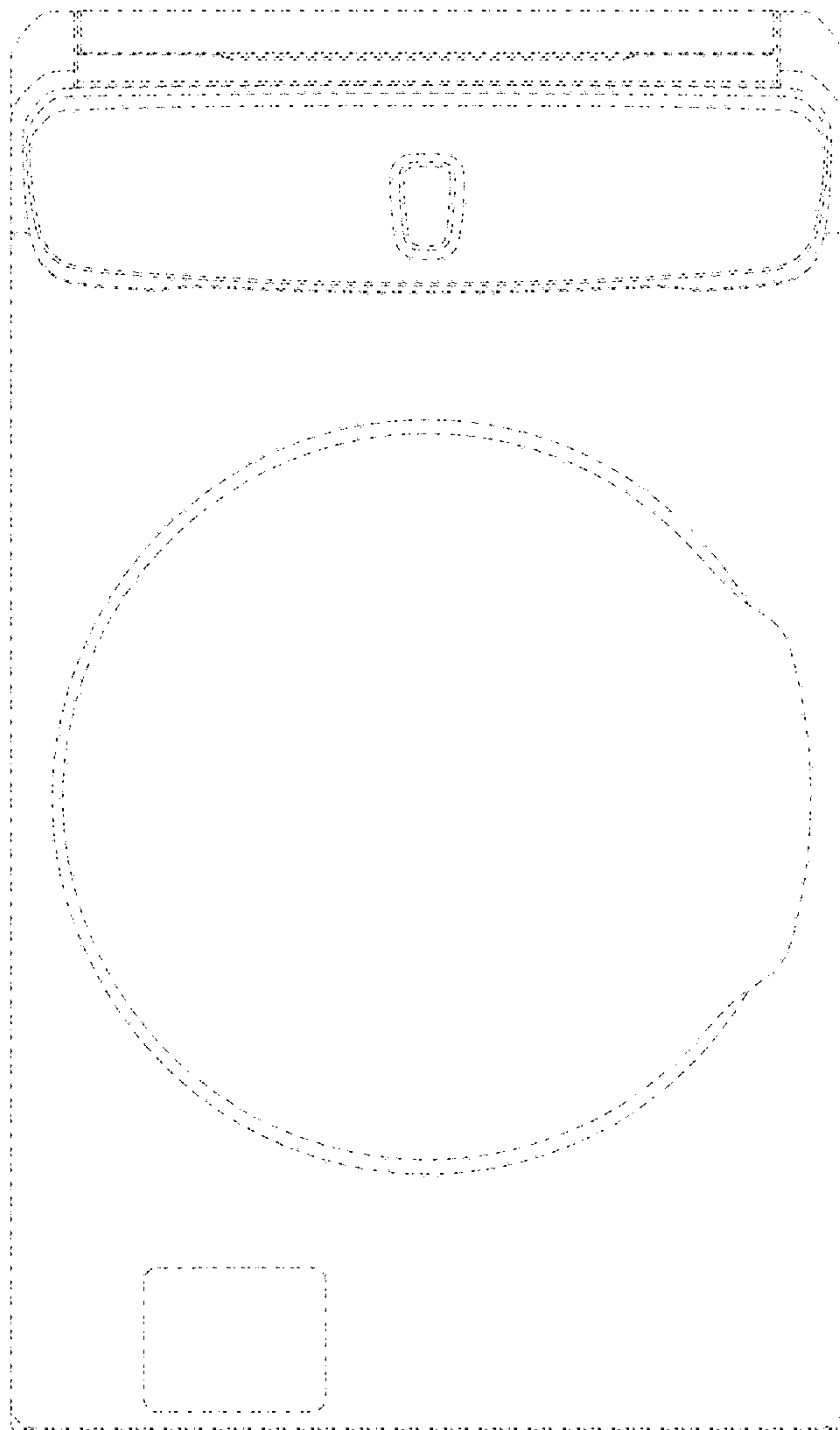

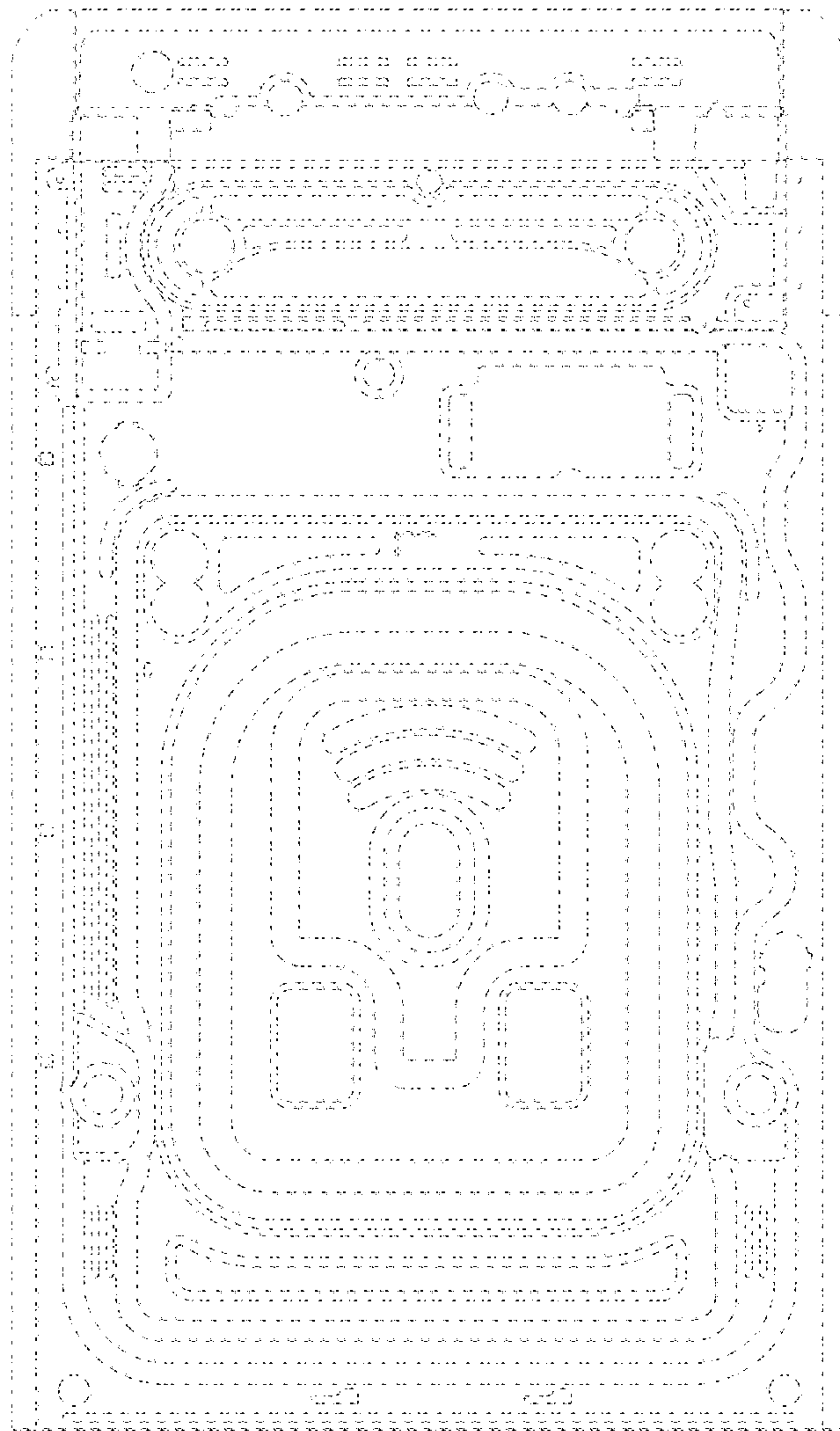

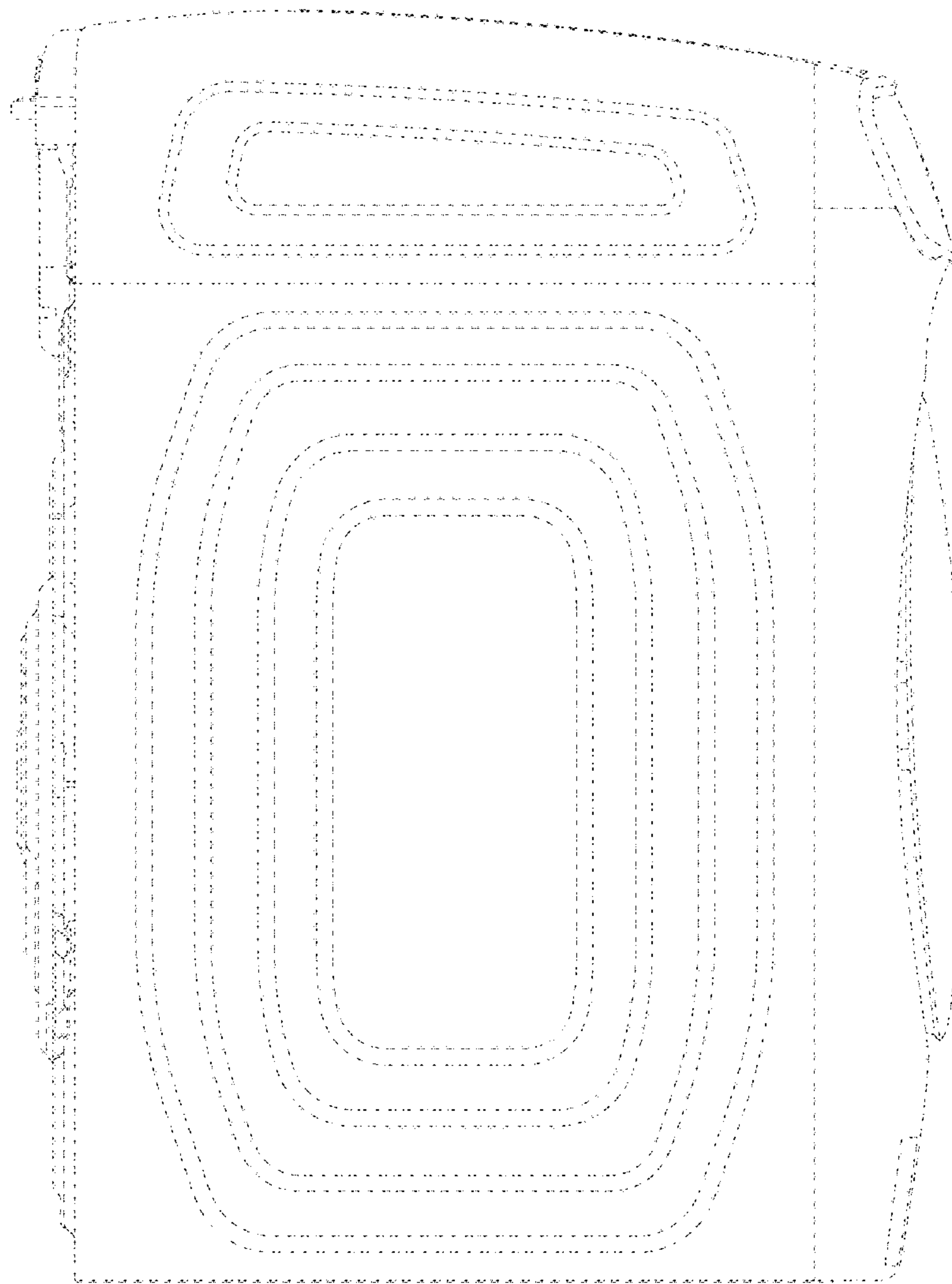

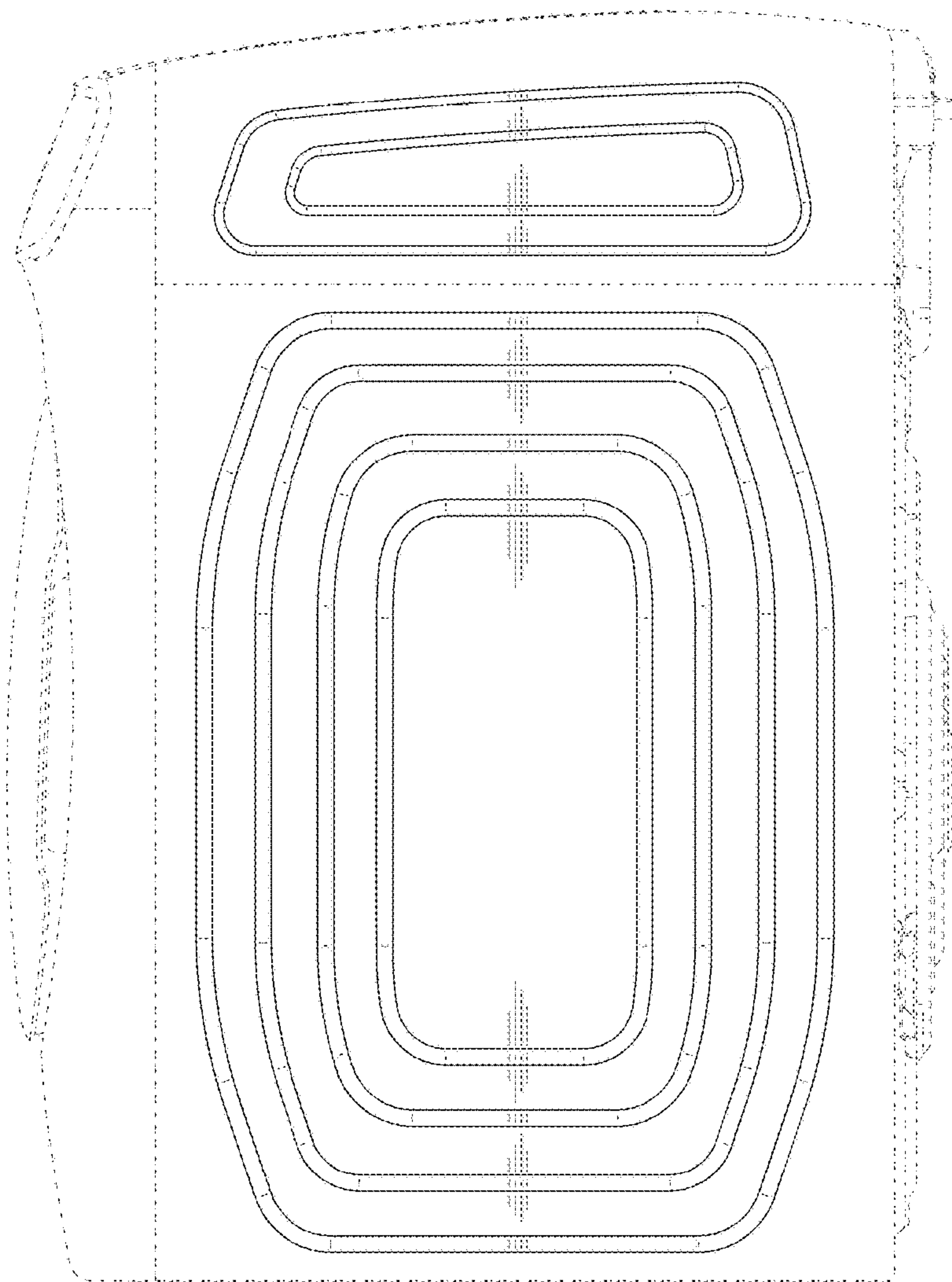

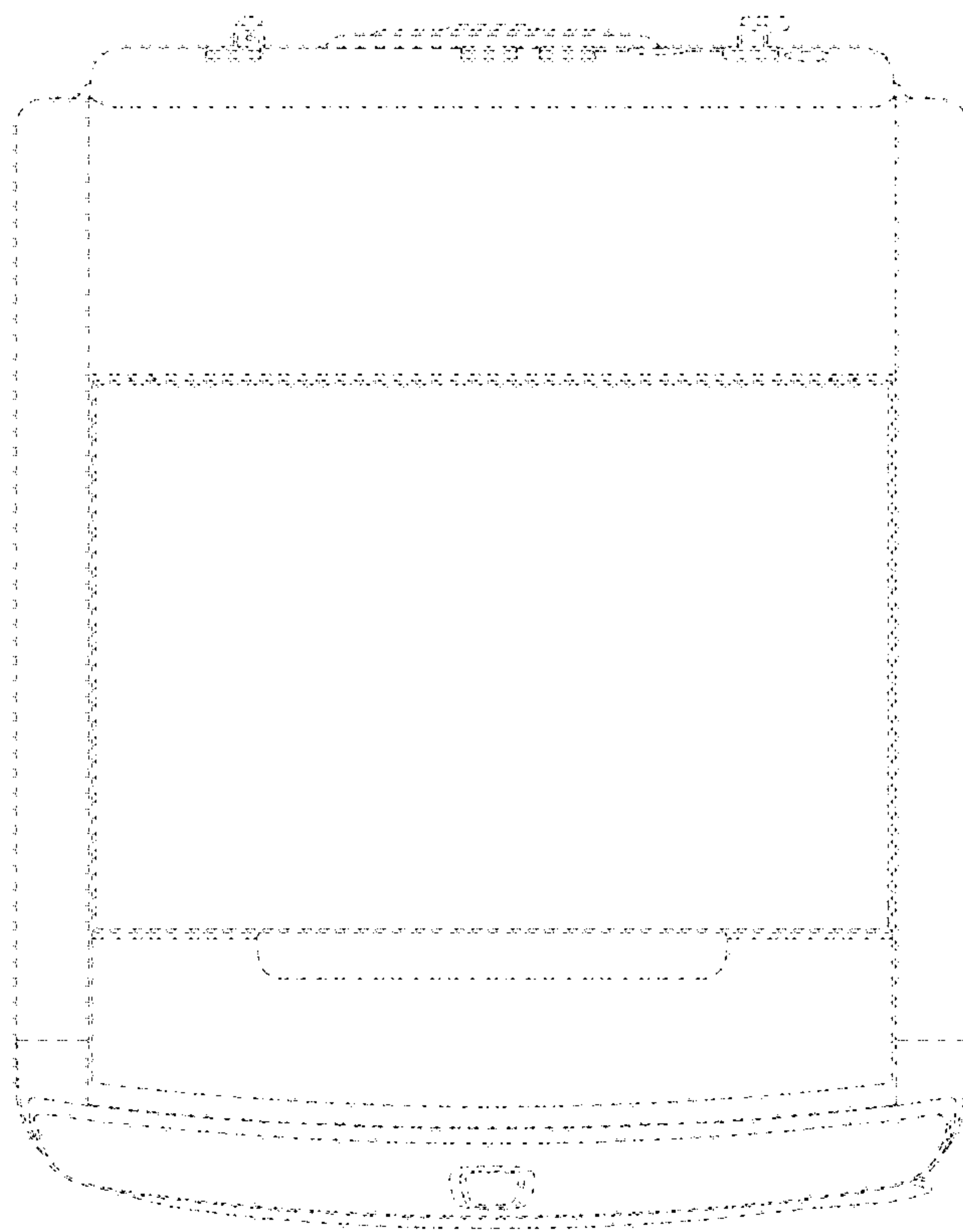
