The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is a side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
All of the broken lines on the bottom of the shoe in FIGS. 2 and 7 represent a portion of the article that does not form a part of the claim.
All of the broken lines not on the bottom of the shoe in FIGS. 1-6 represent stitching which forms a part of the claim.

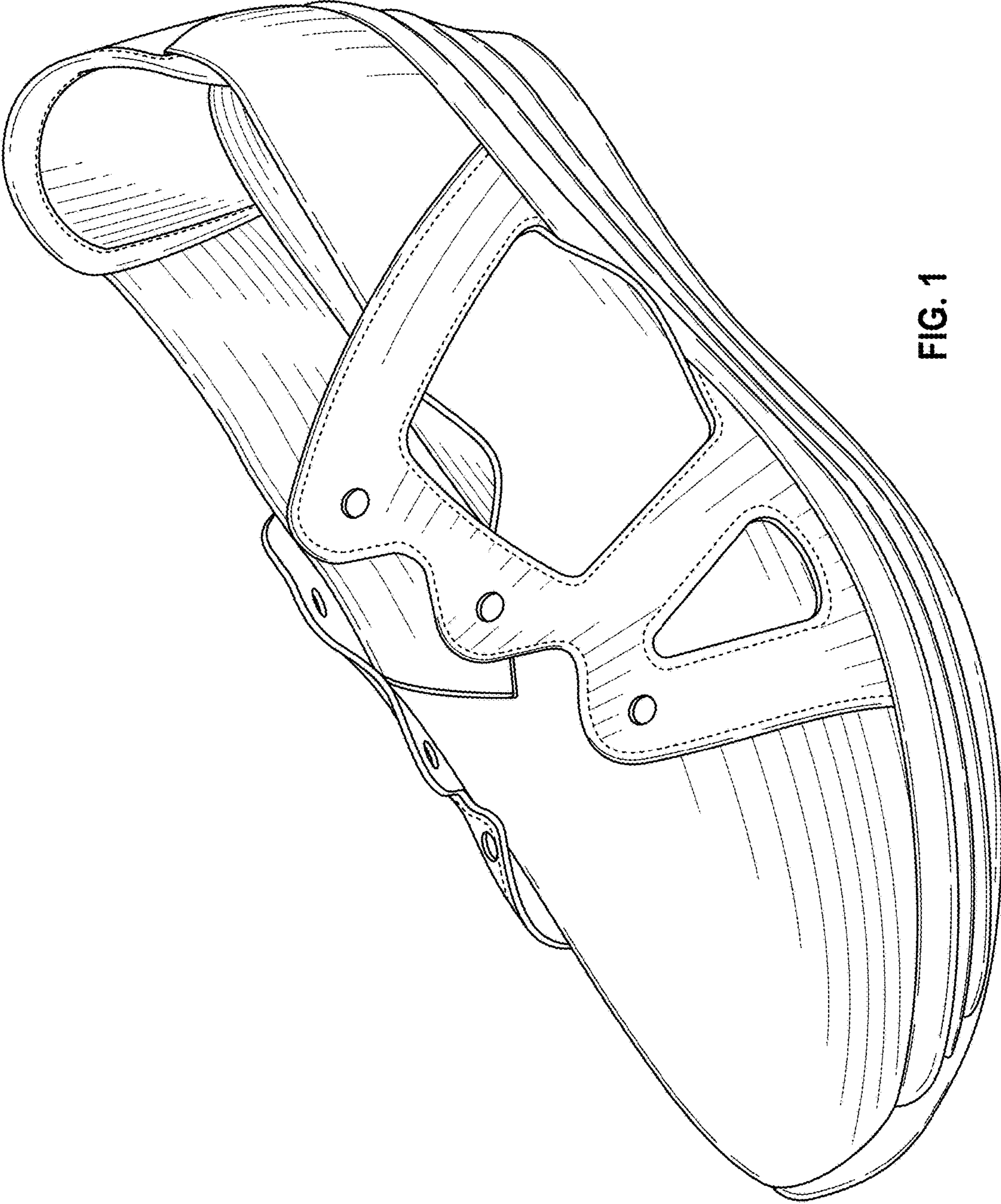

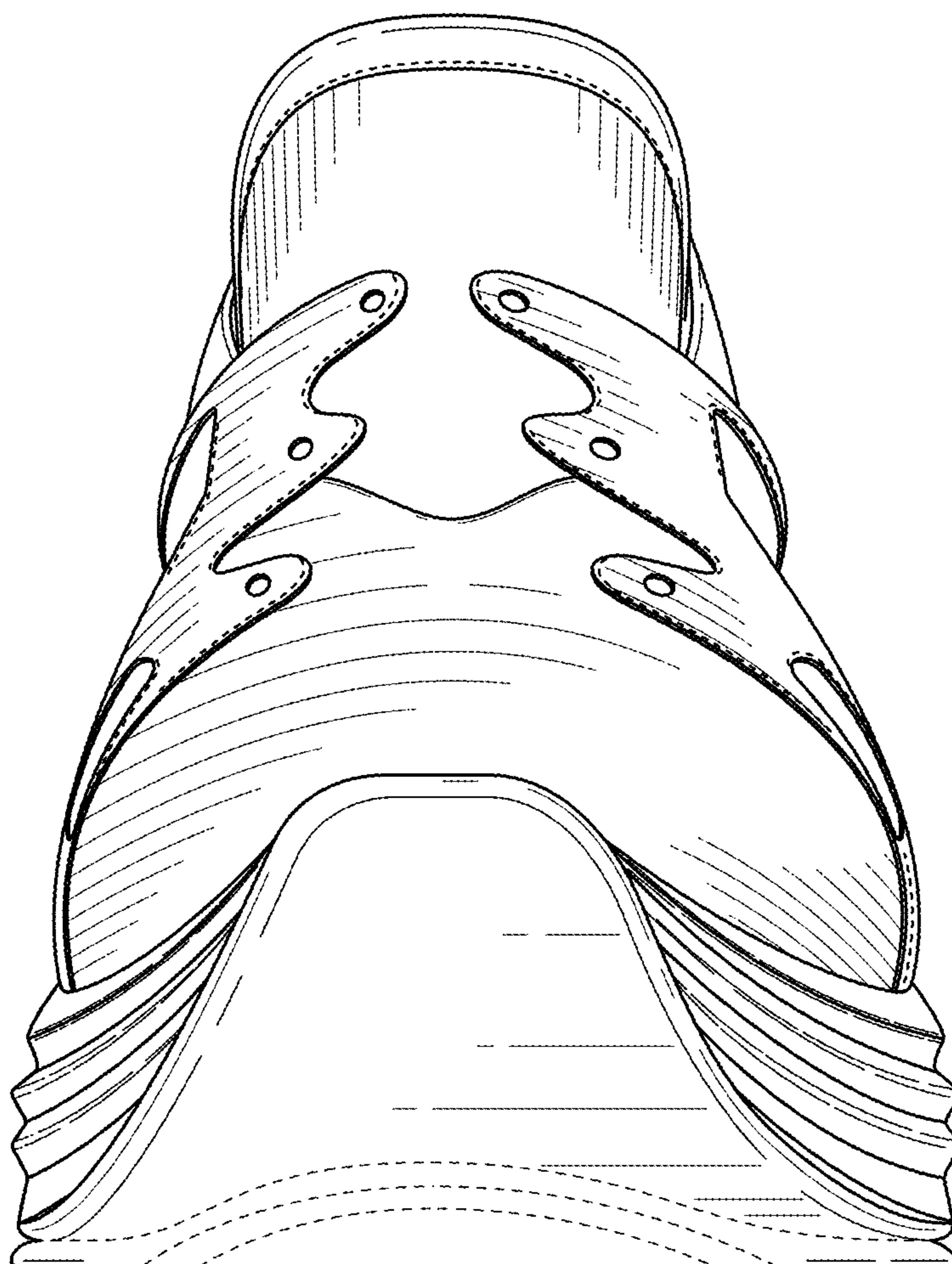

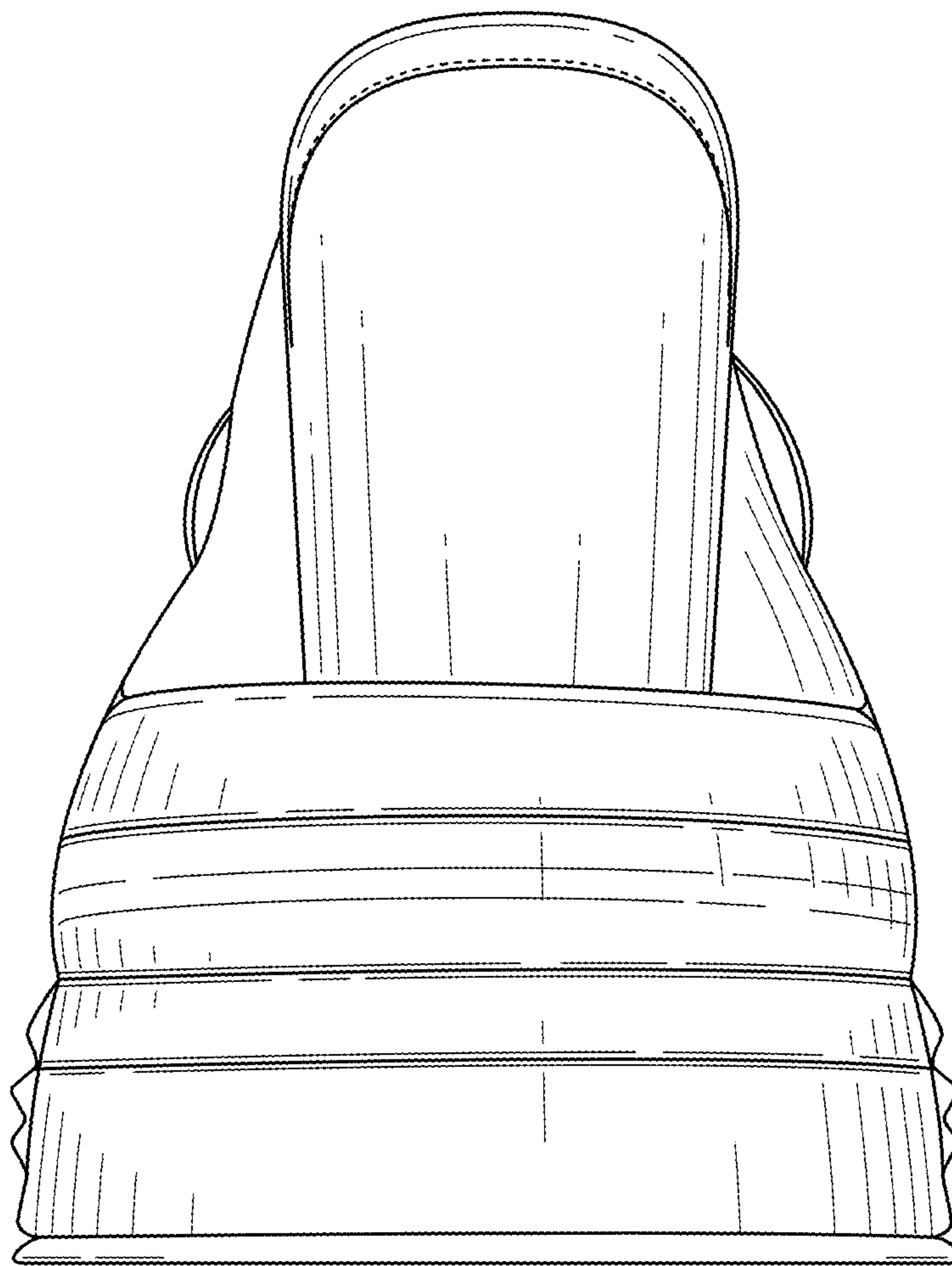

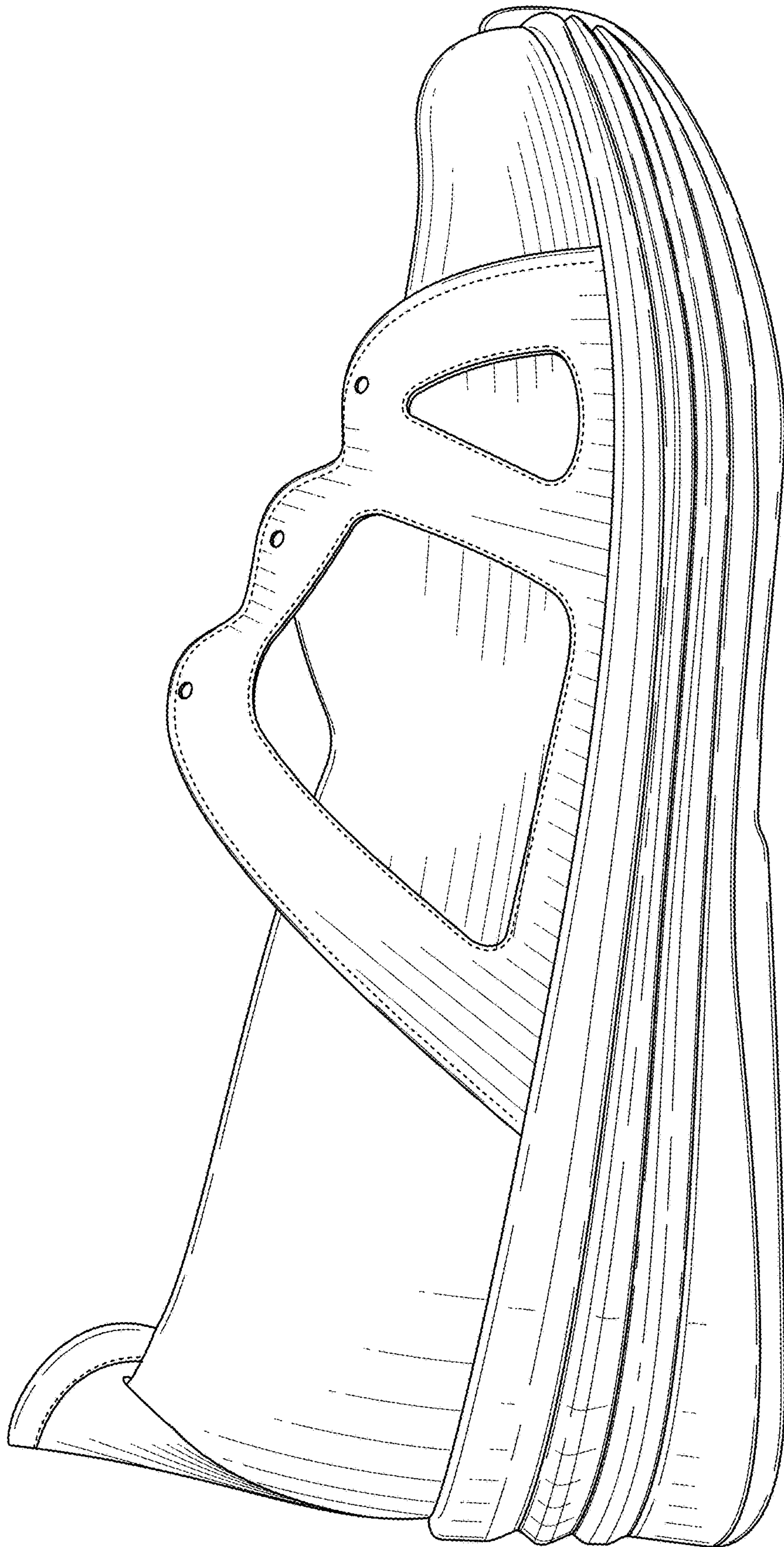

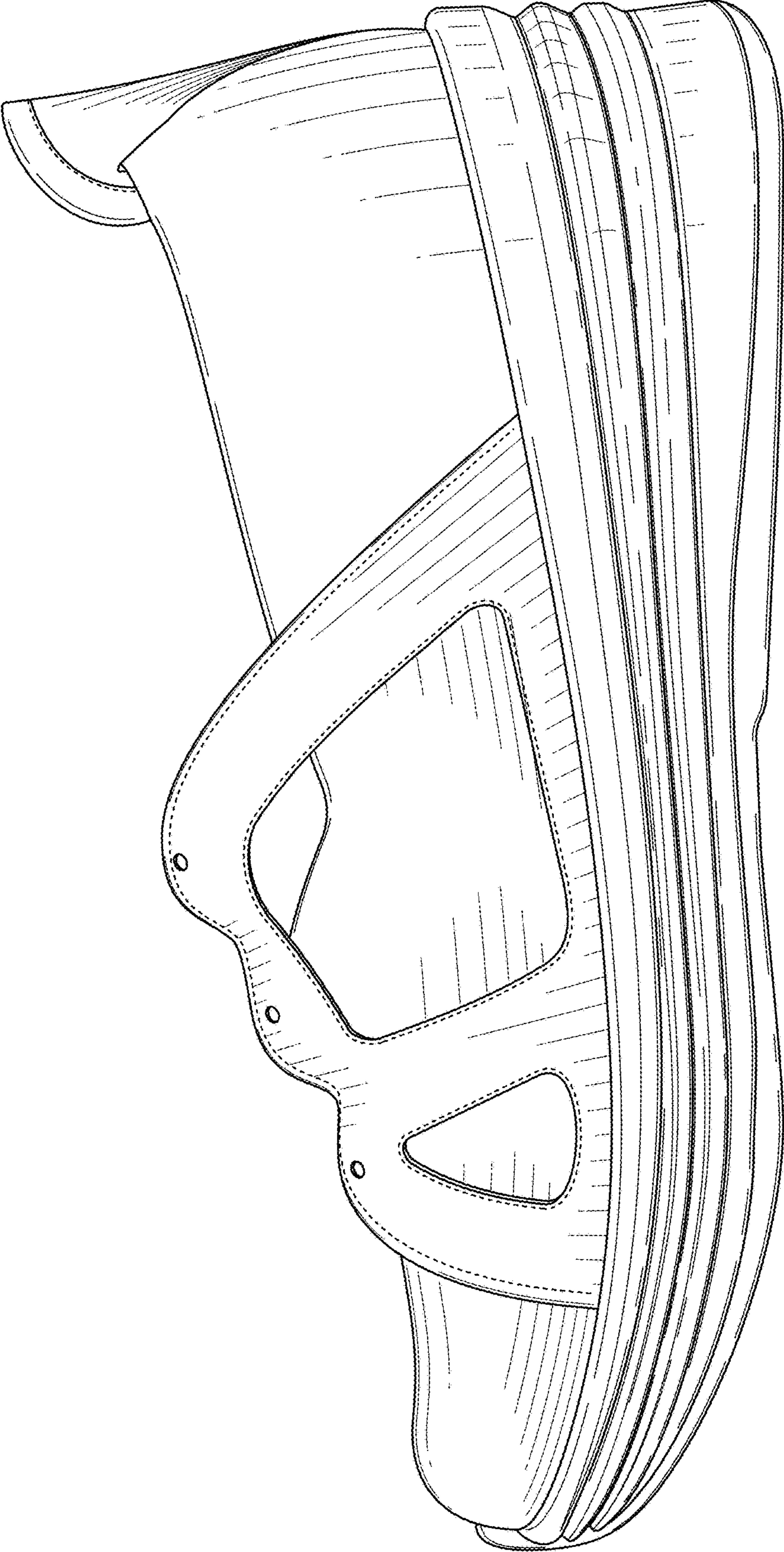

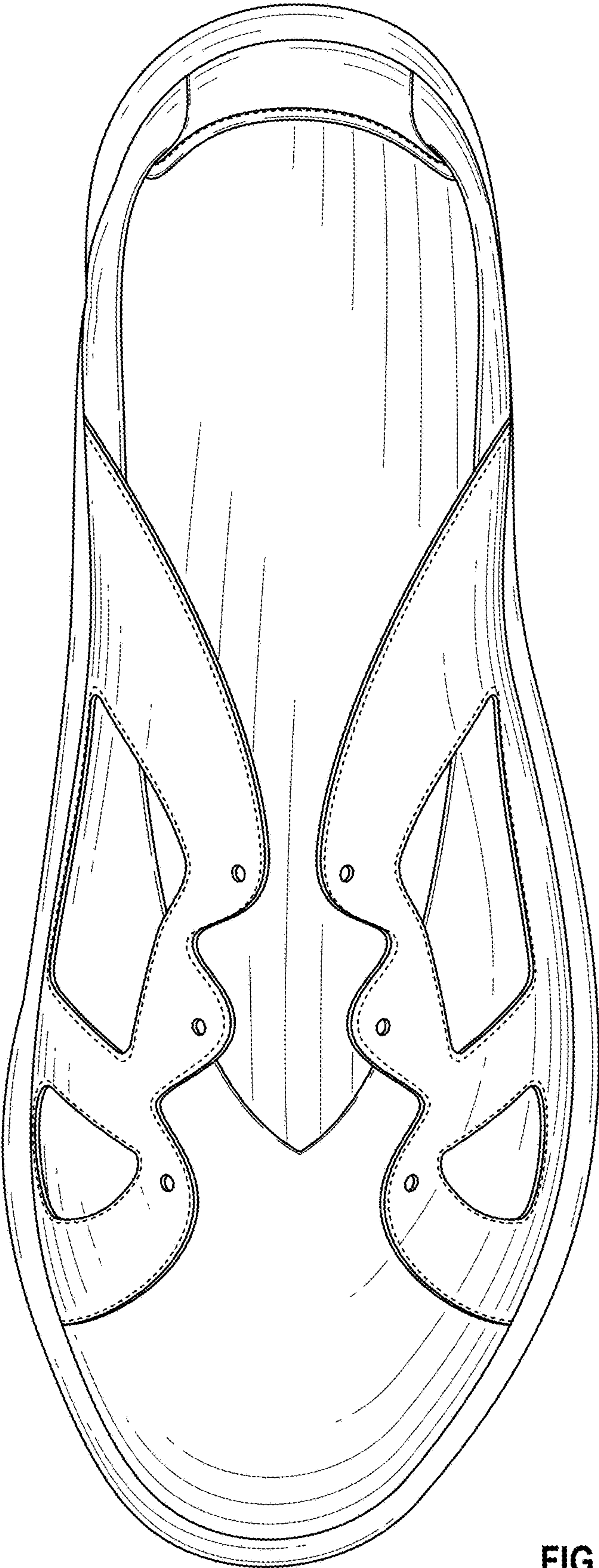

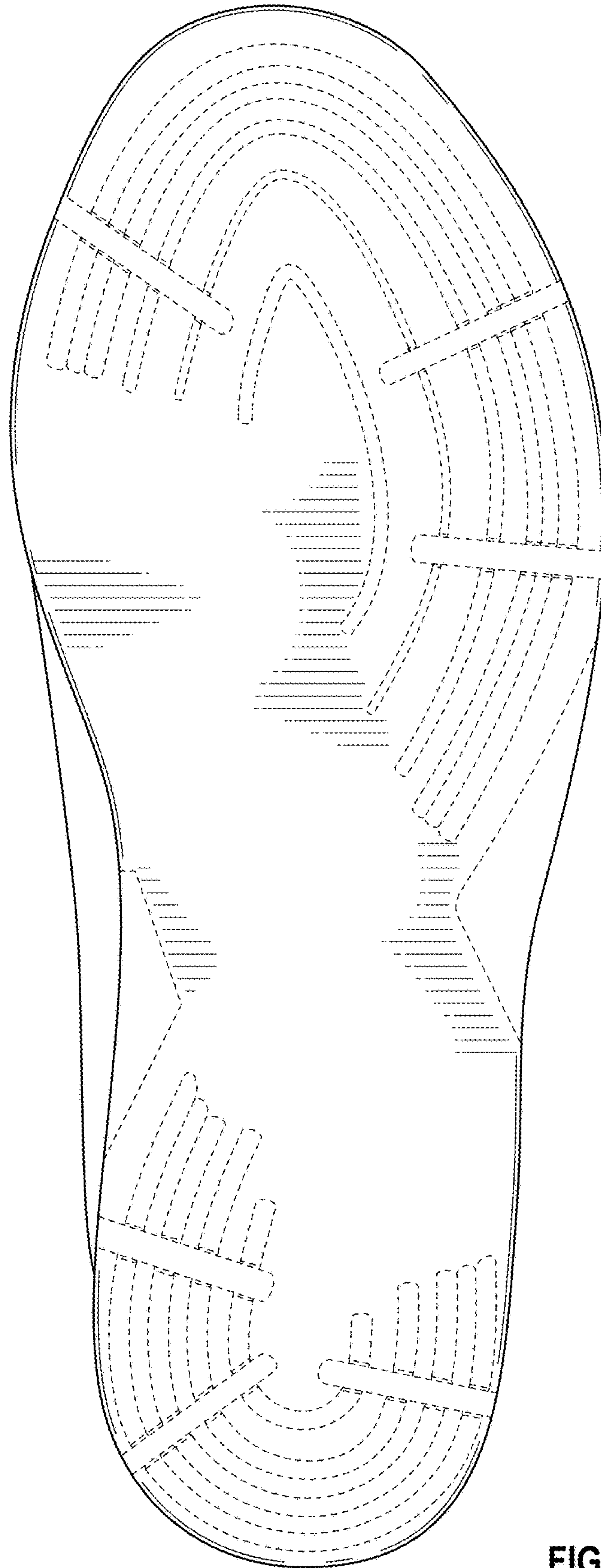
