I claim the ornamental design for a high heel base, as shown

FIG. 4 is a left-side elevation view of the claimed design.

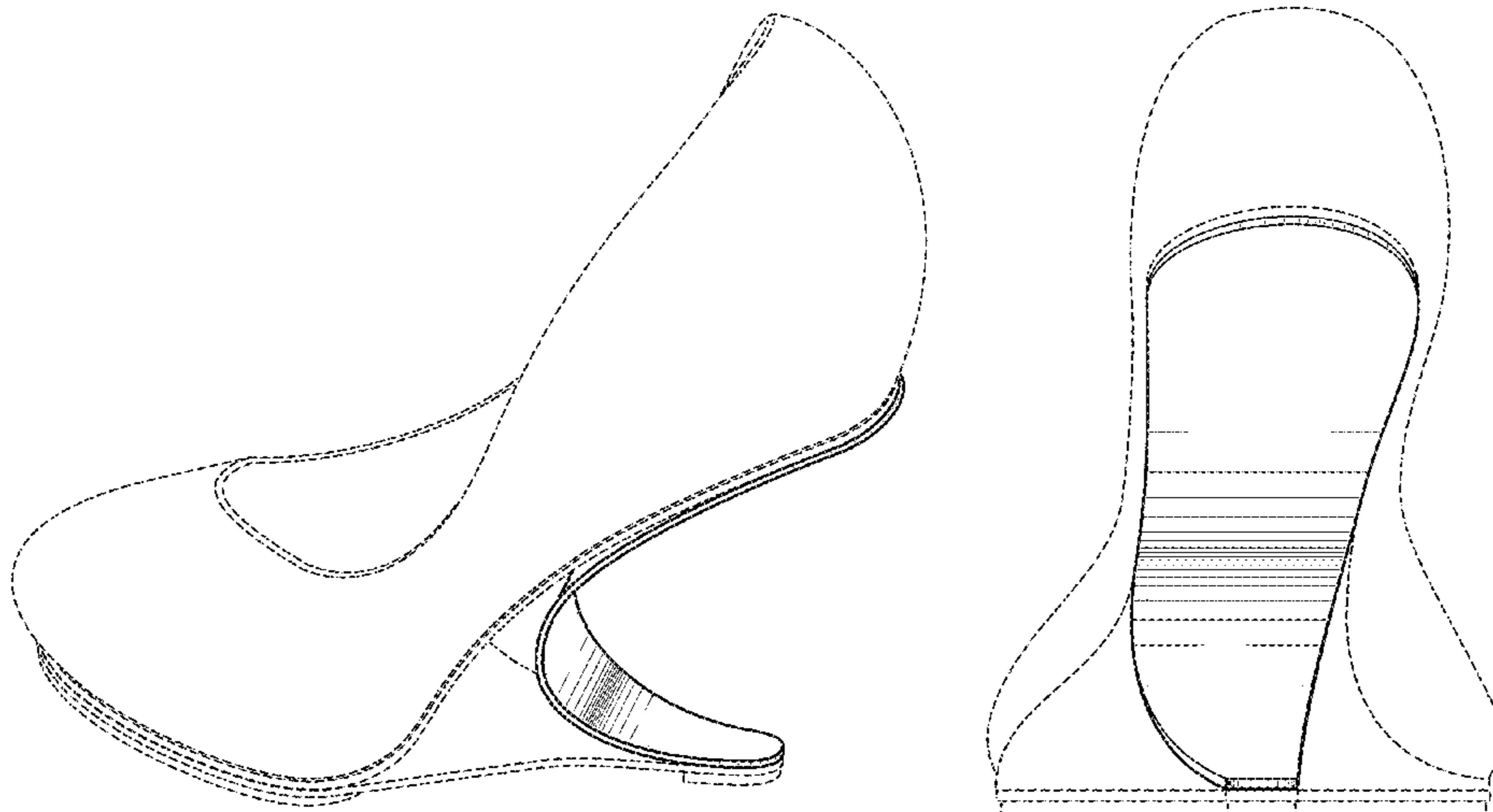
FIG. 5 is a right-side elevation view thereof.

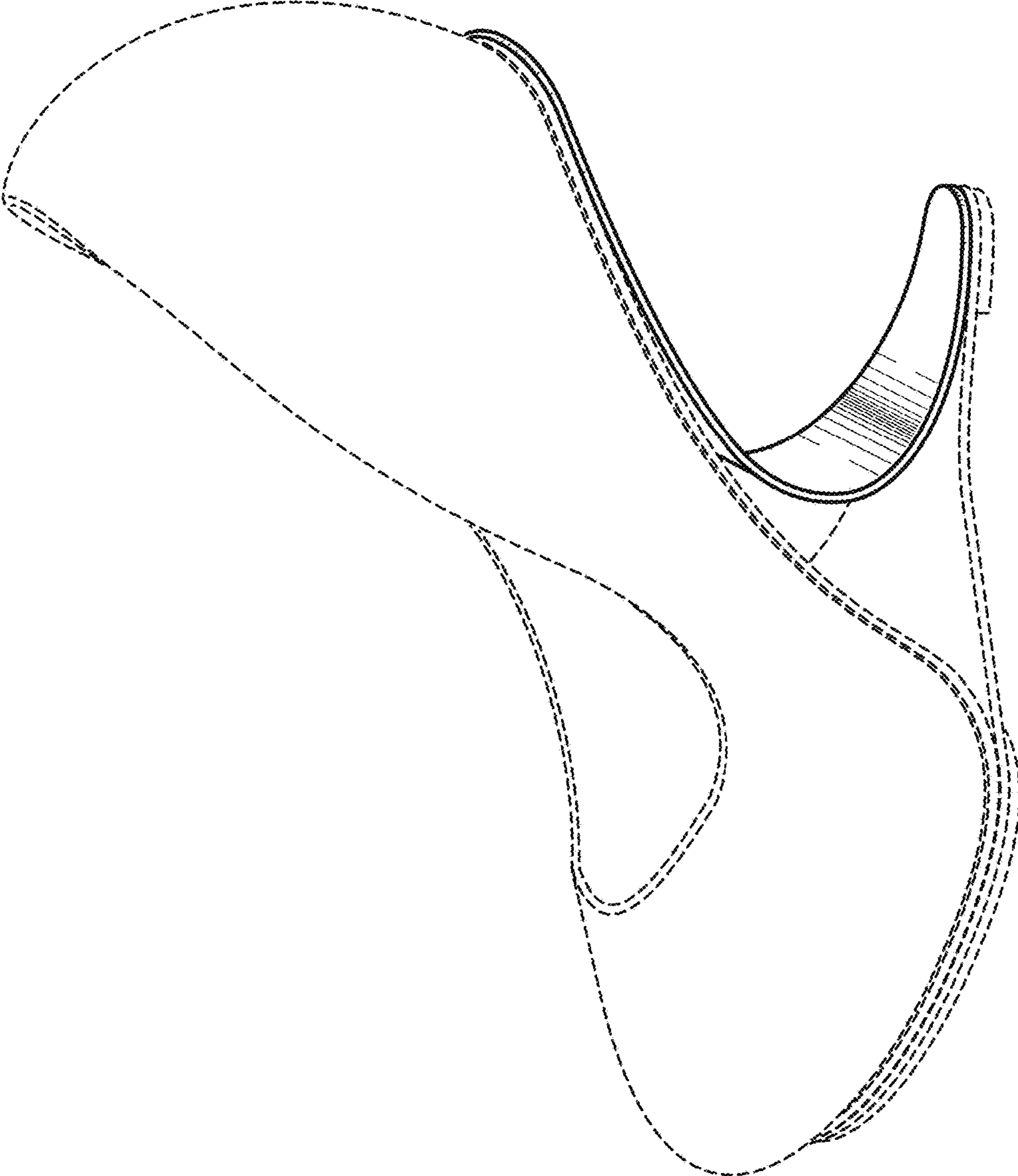

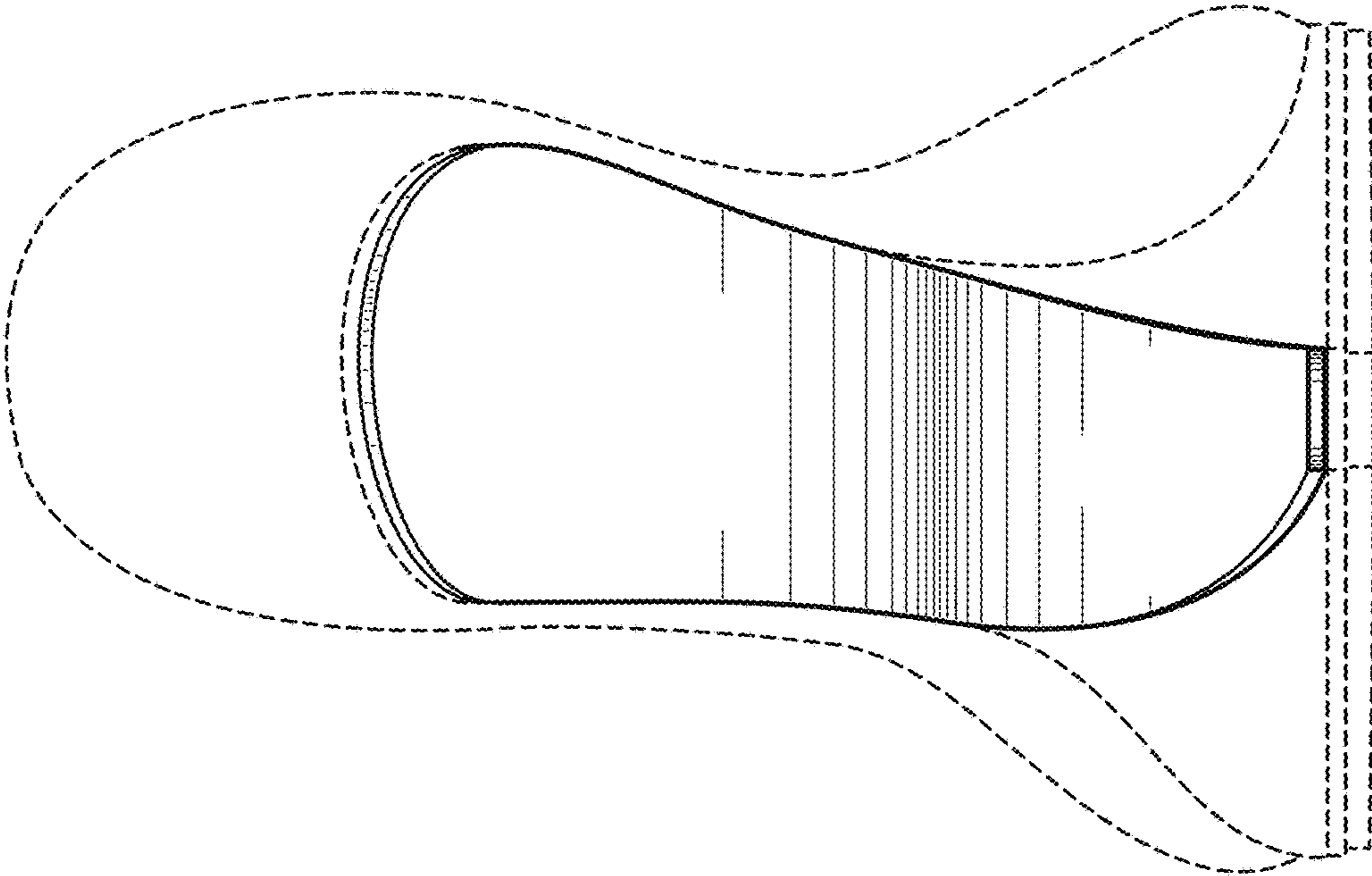

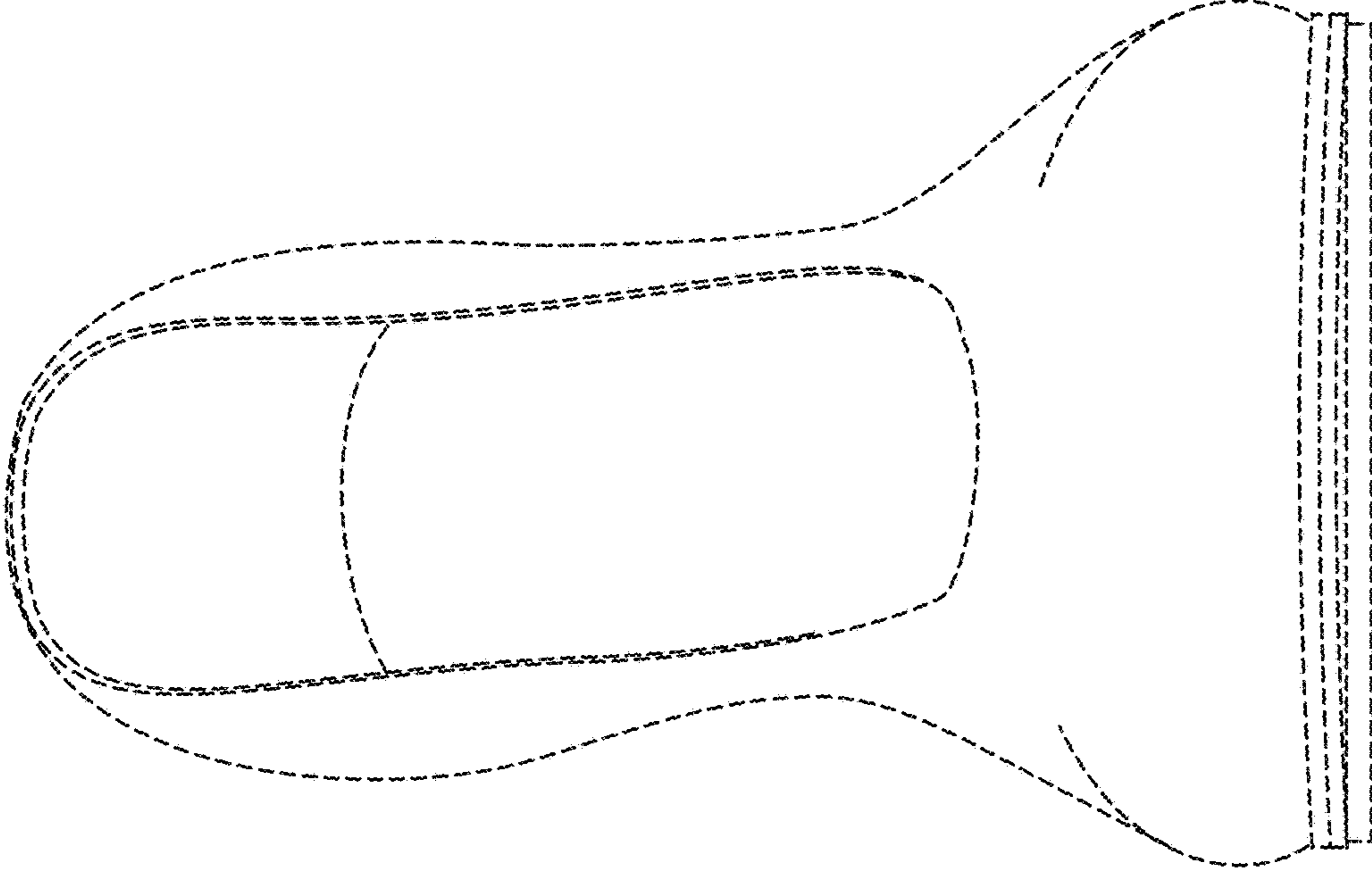

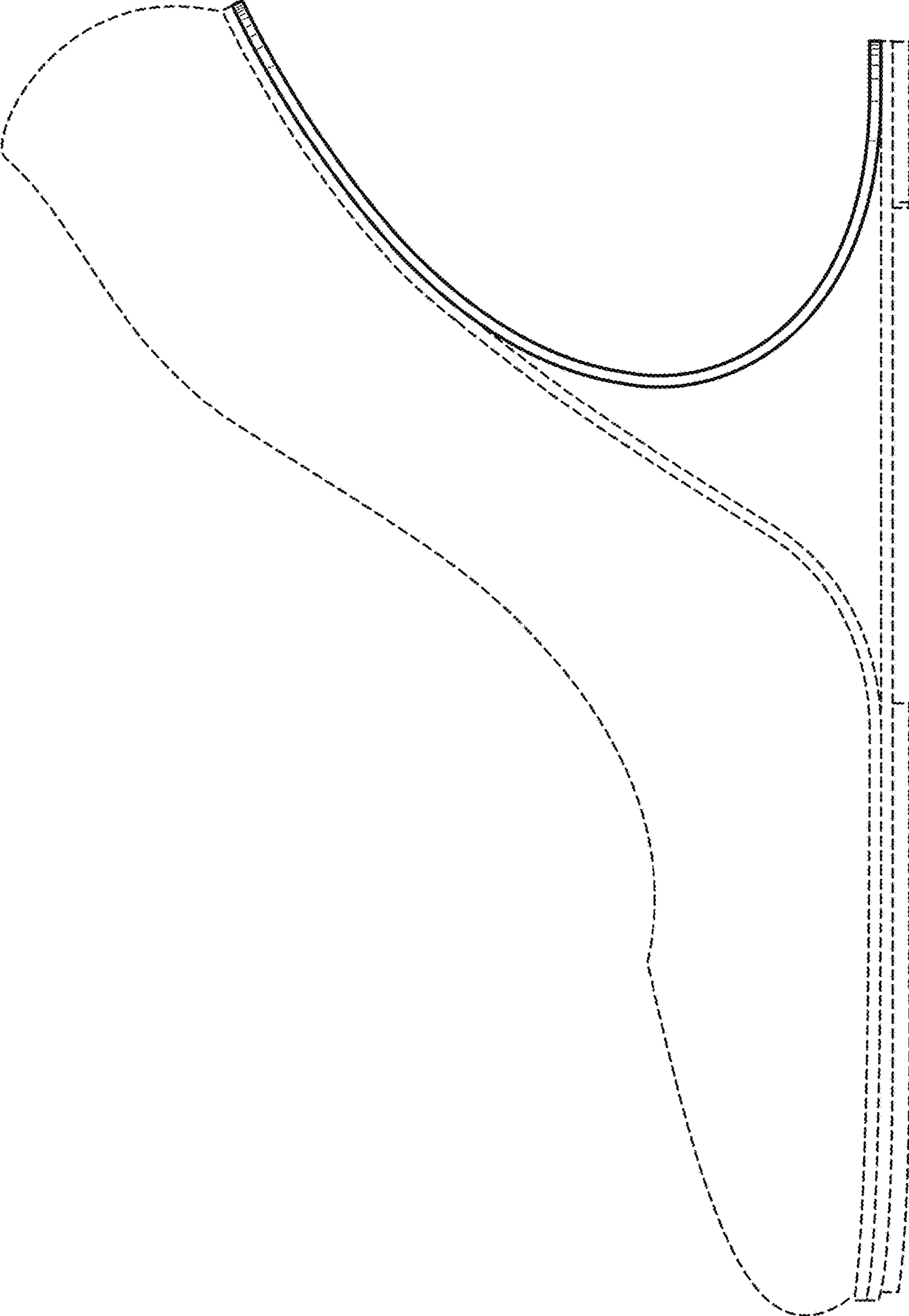

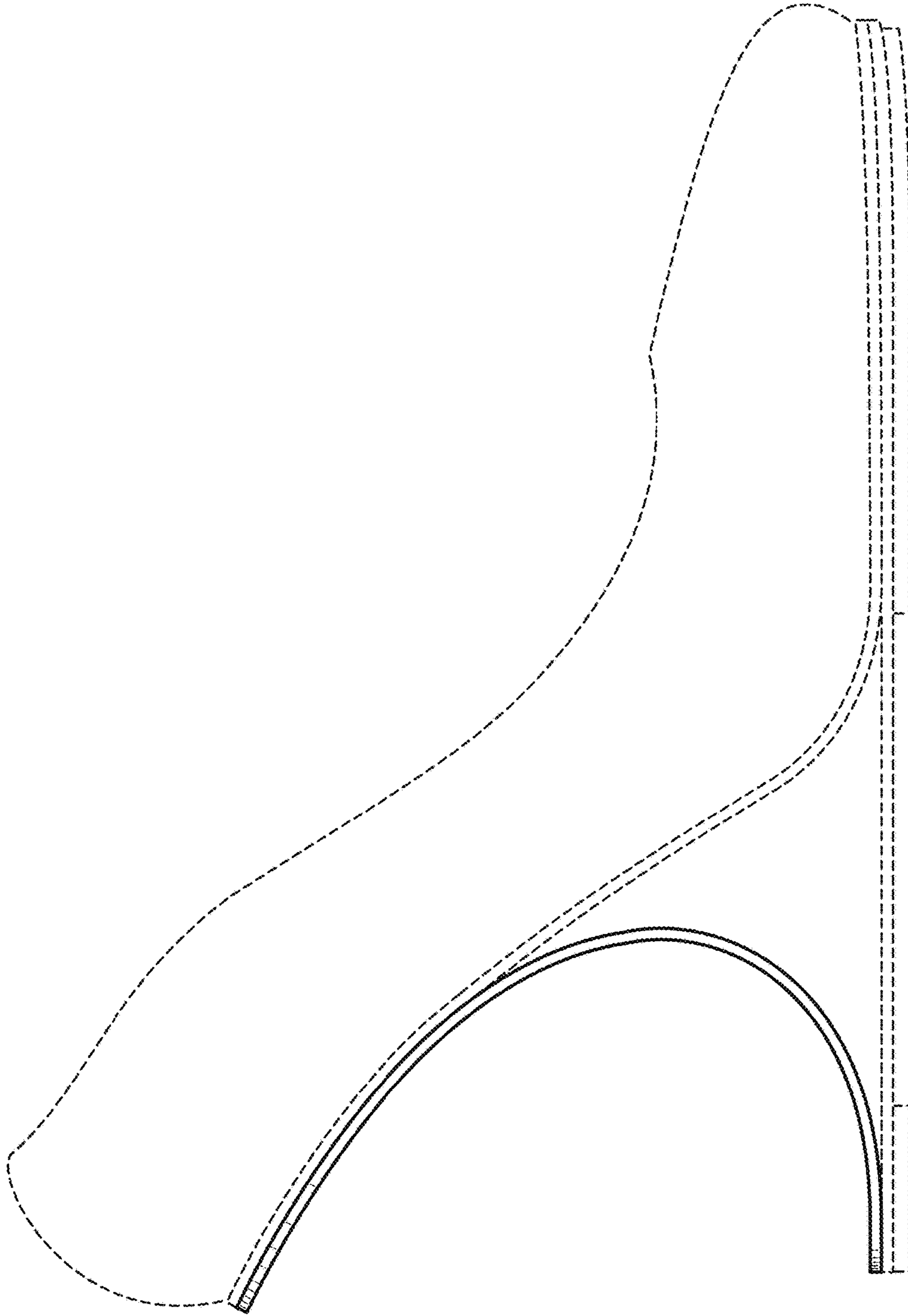

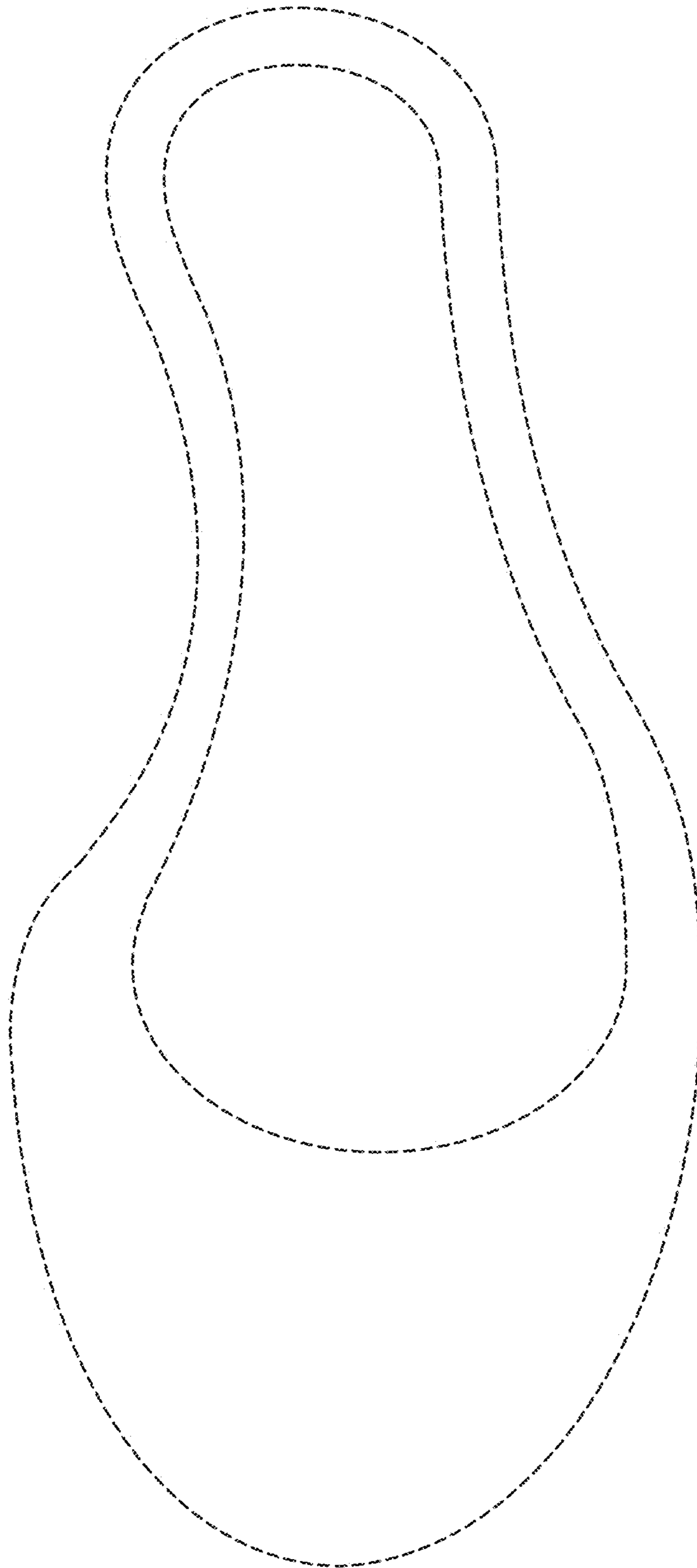

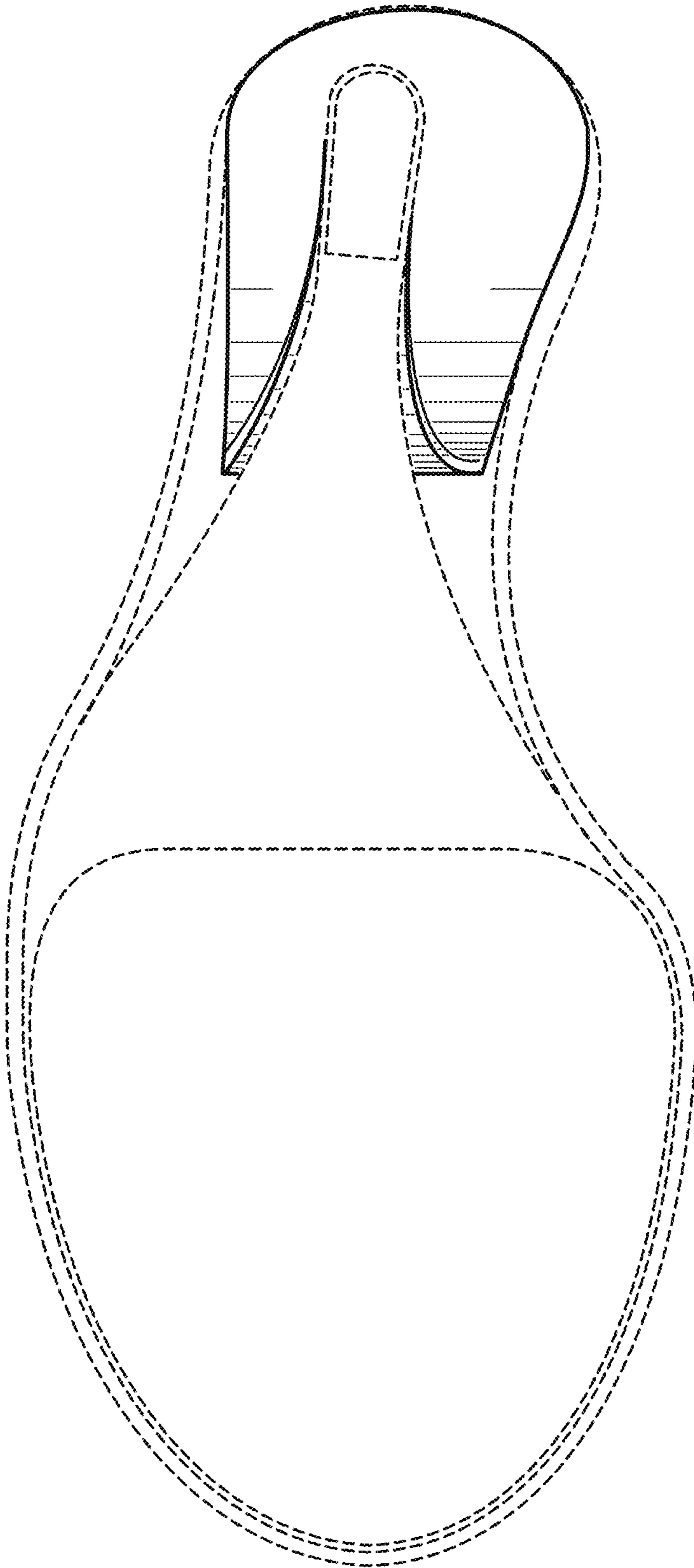
