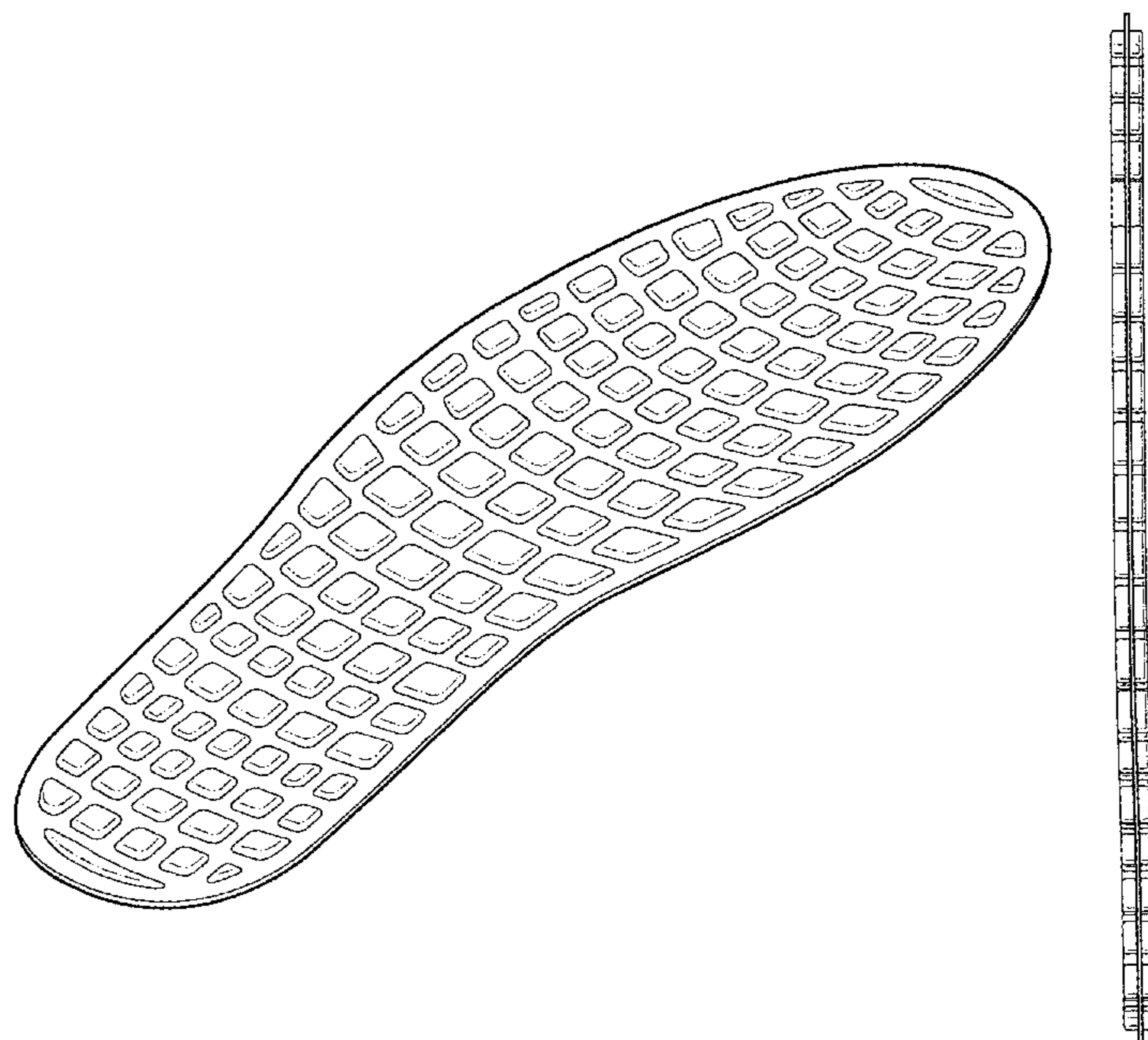
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric view of an insole showing my new design;

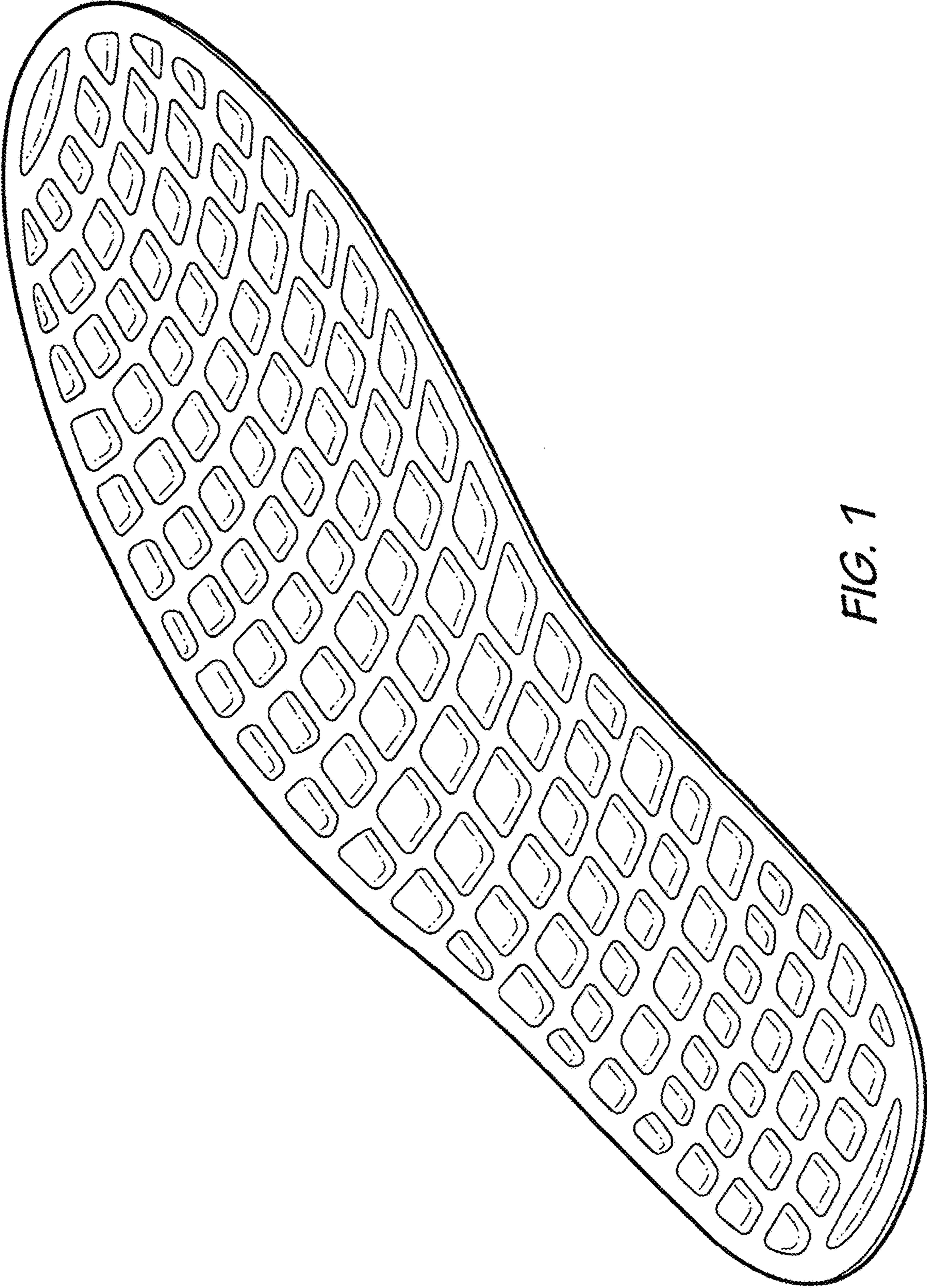

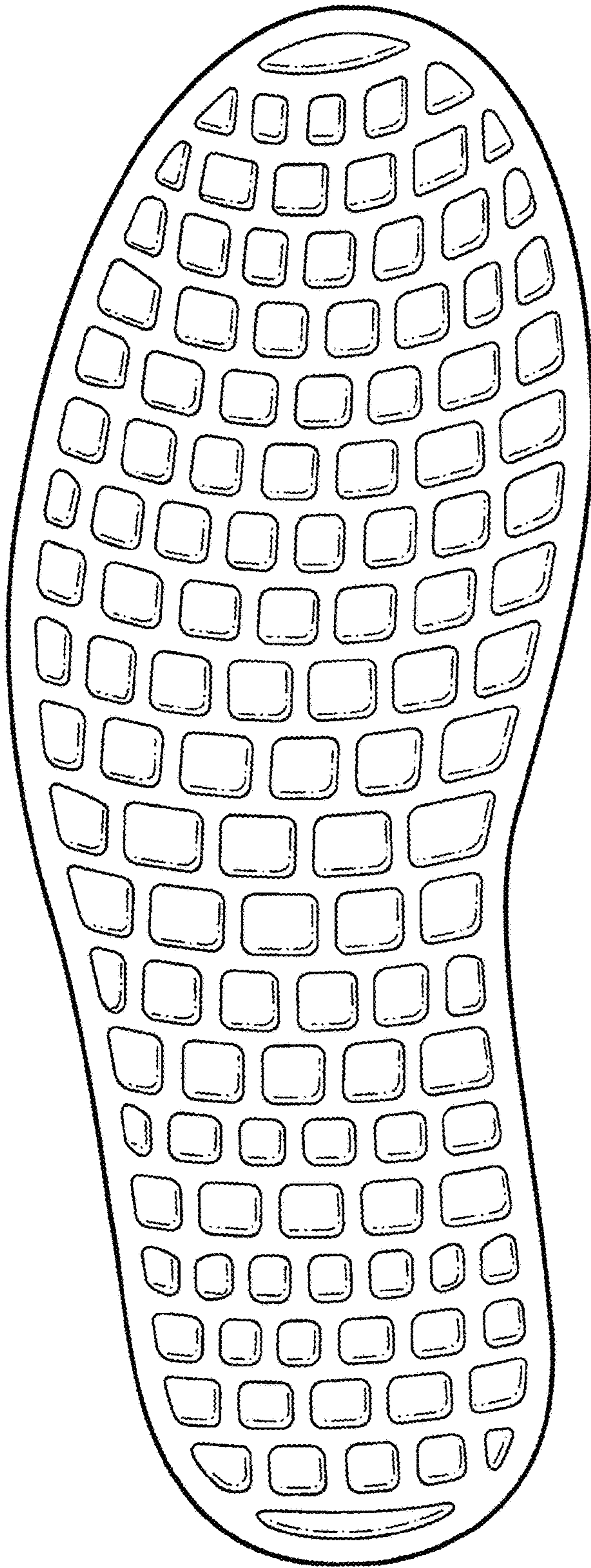

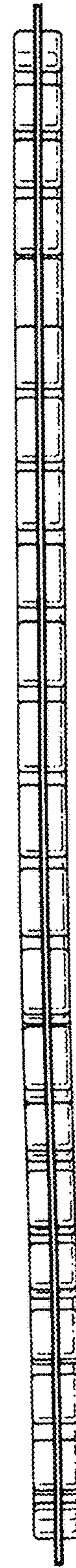
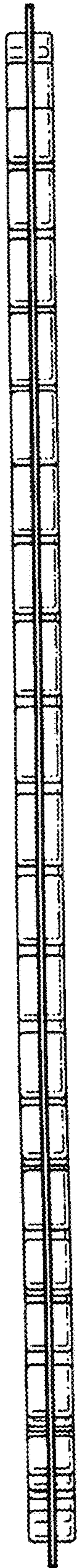
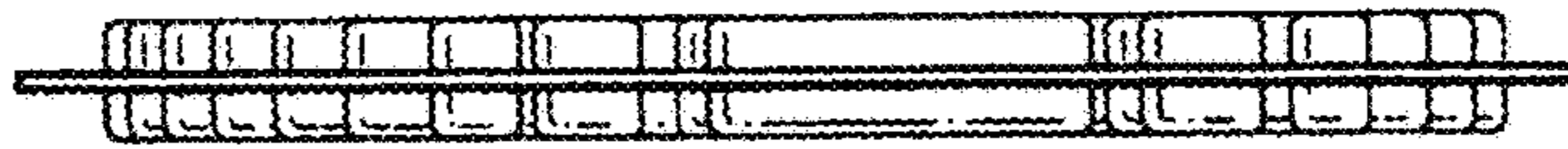


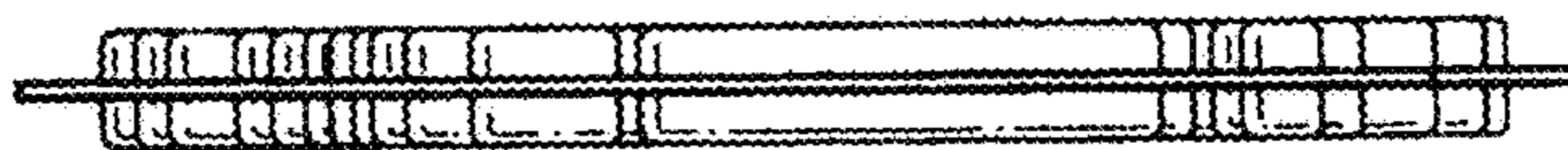
