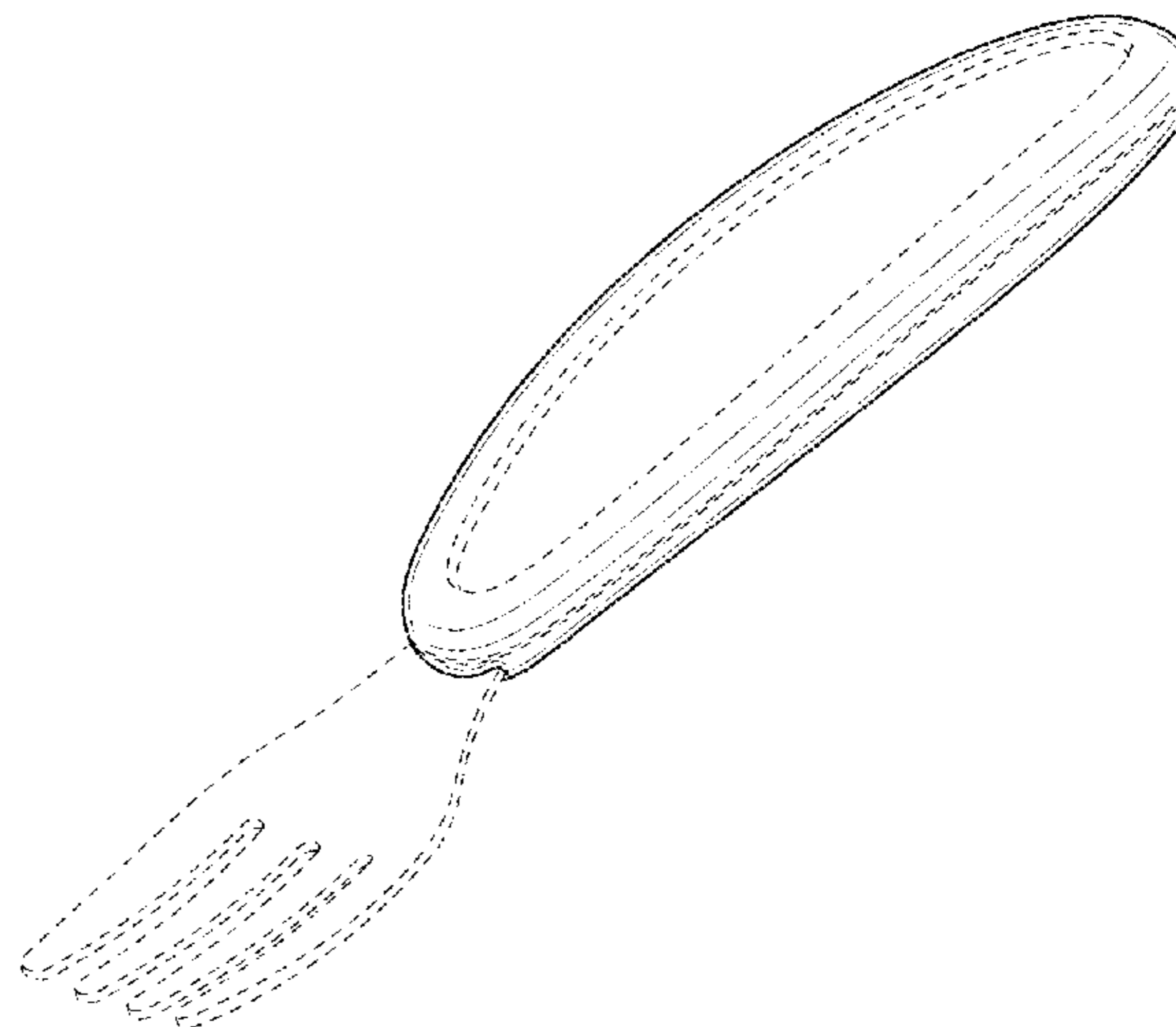
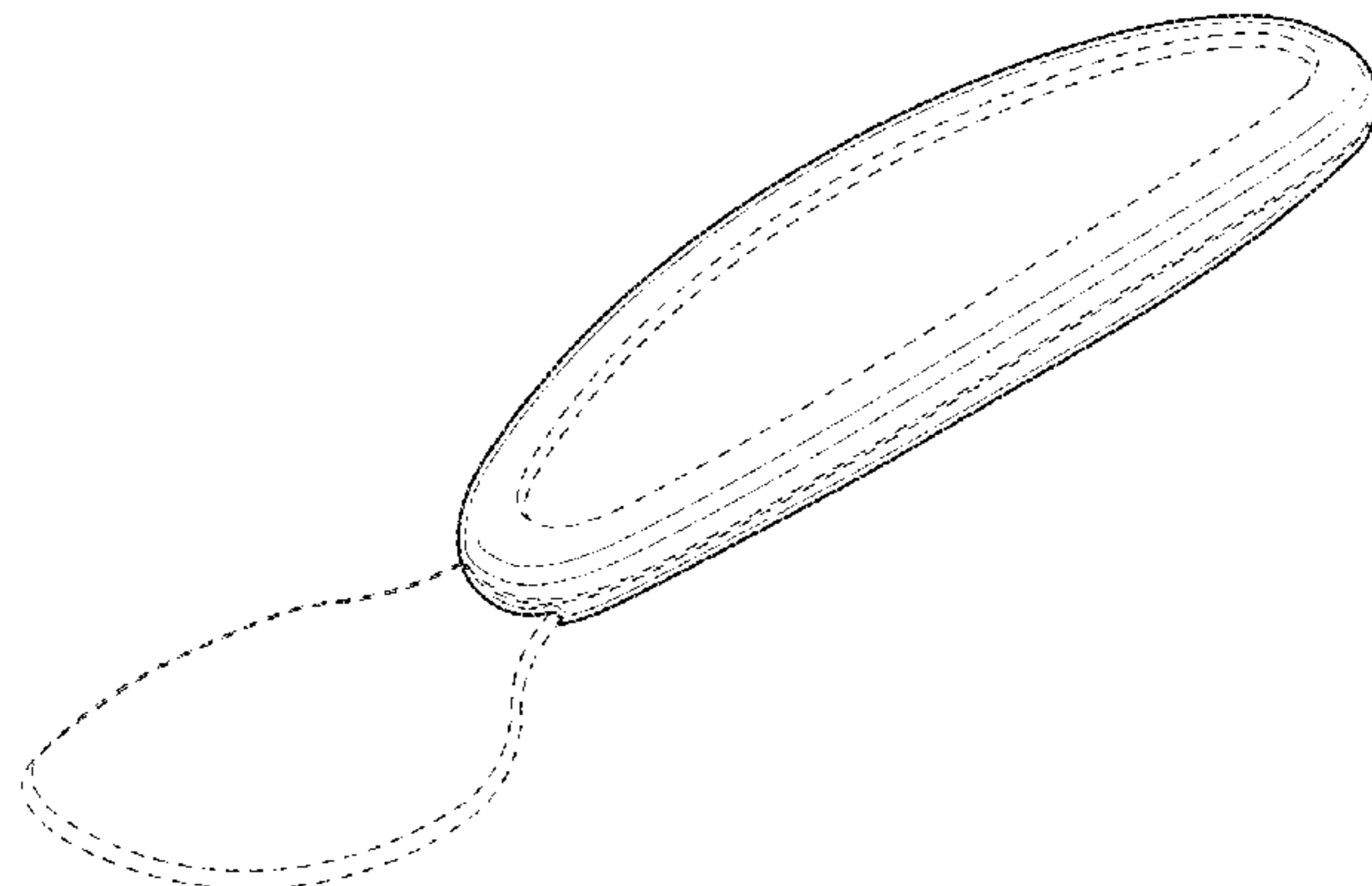
(57) **CLAIM**

I claim the ornamental design for a utensil, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a utensil showing my new design, generally in the shape of a spoon;

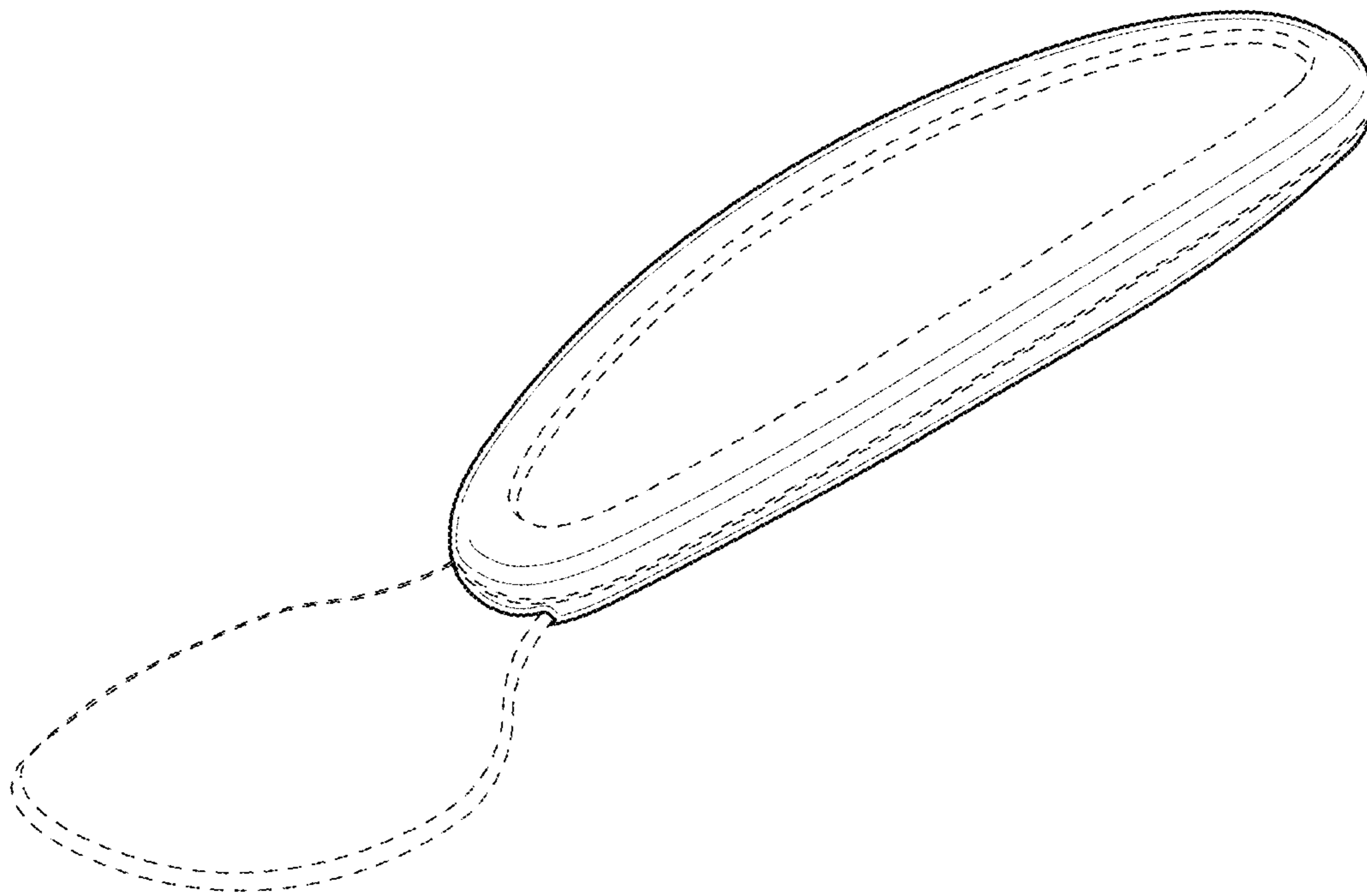

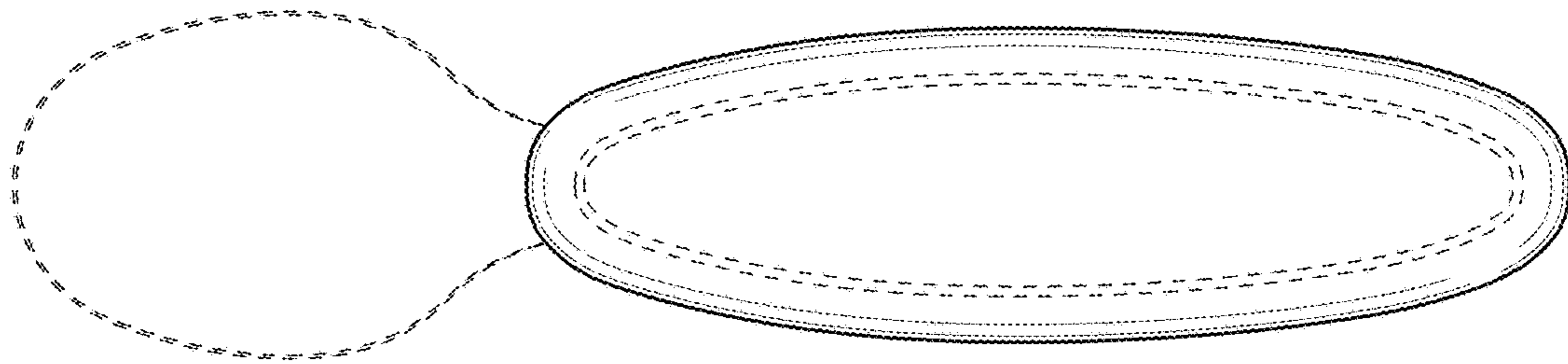

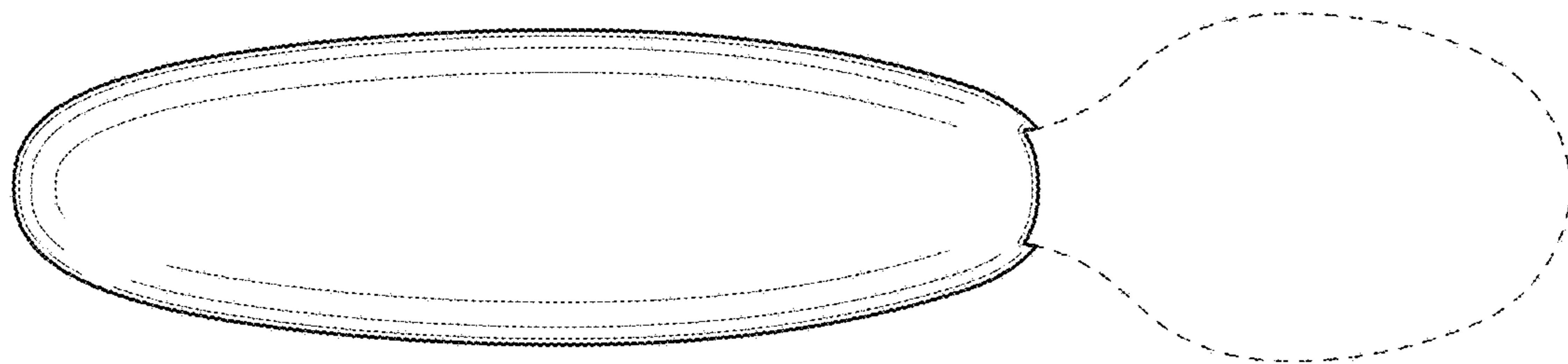

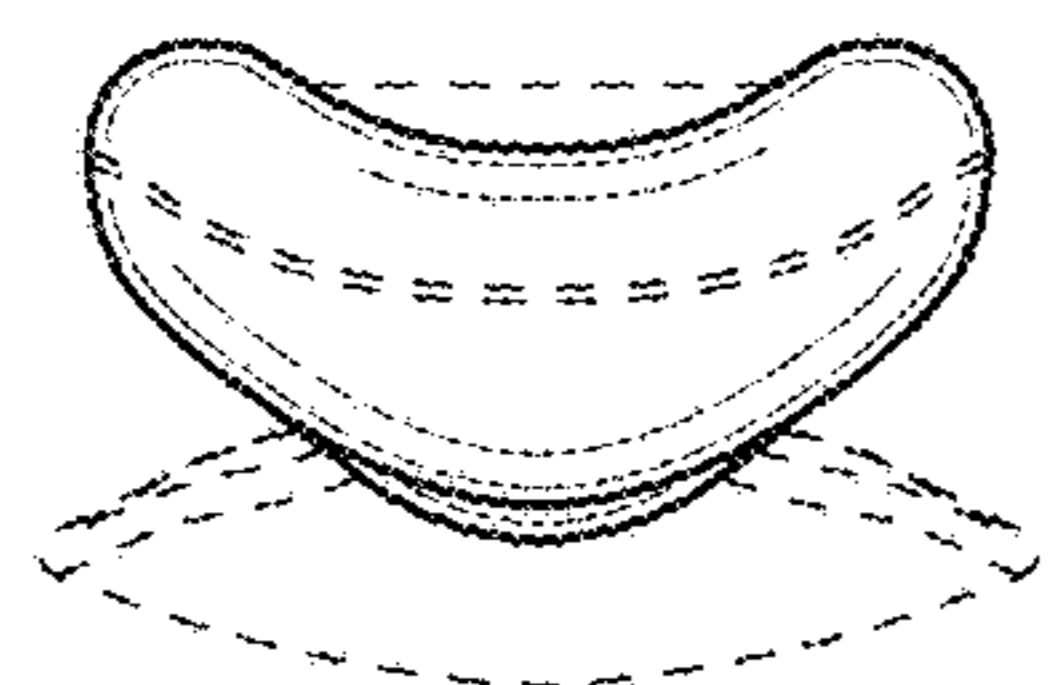

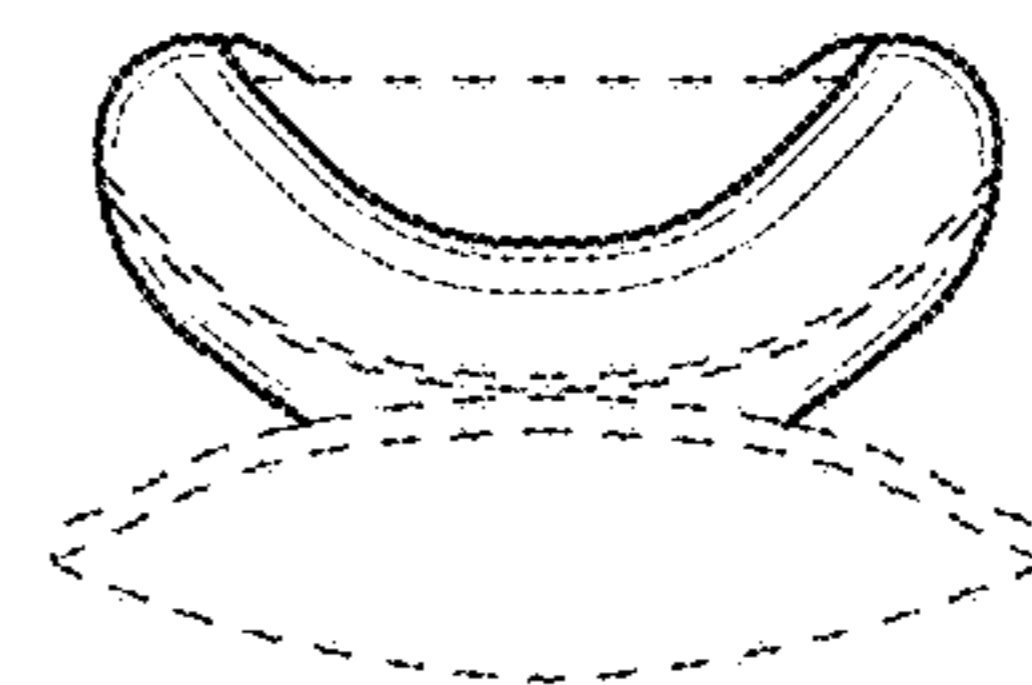

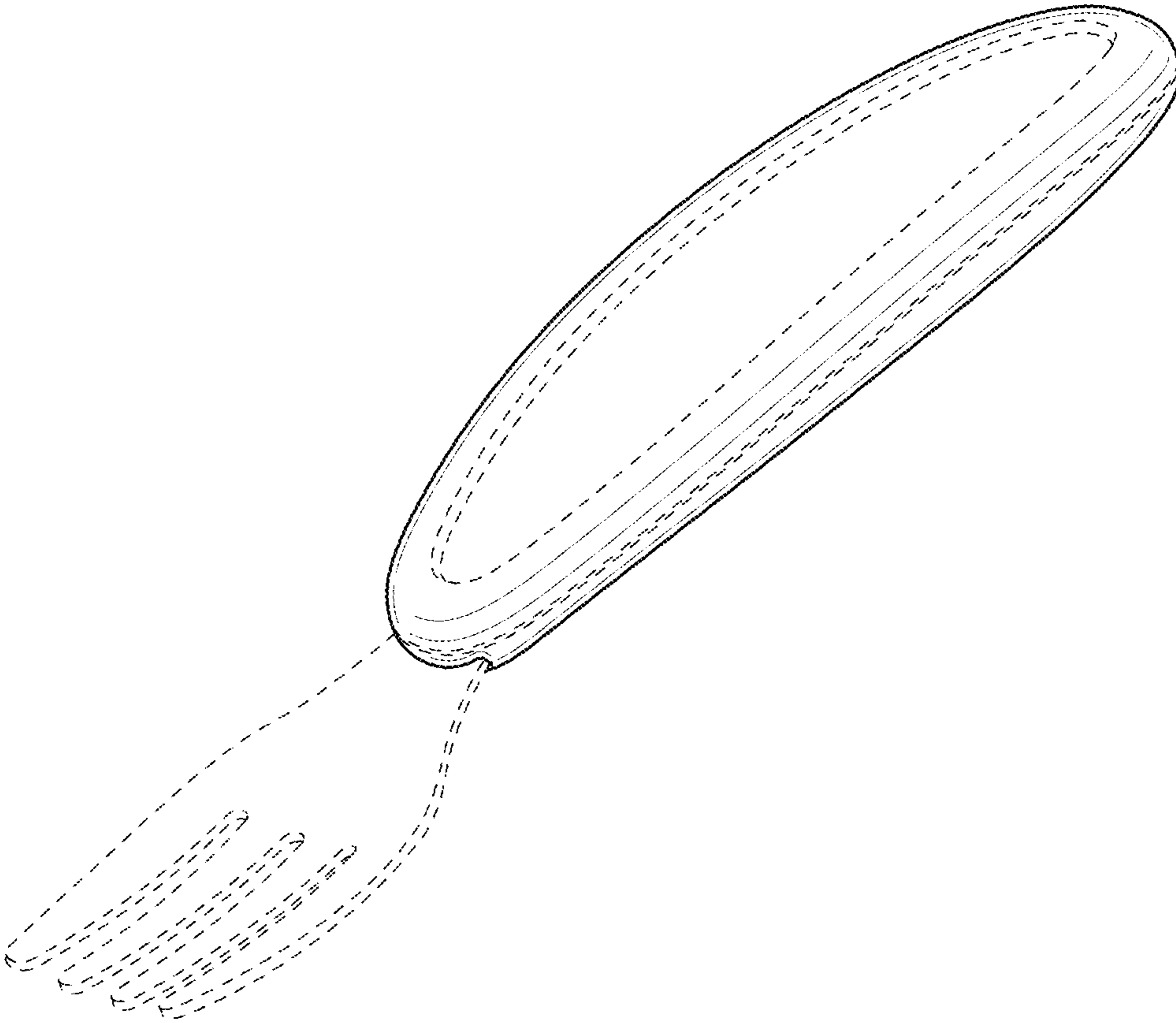

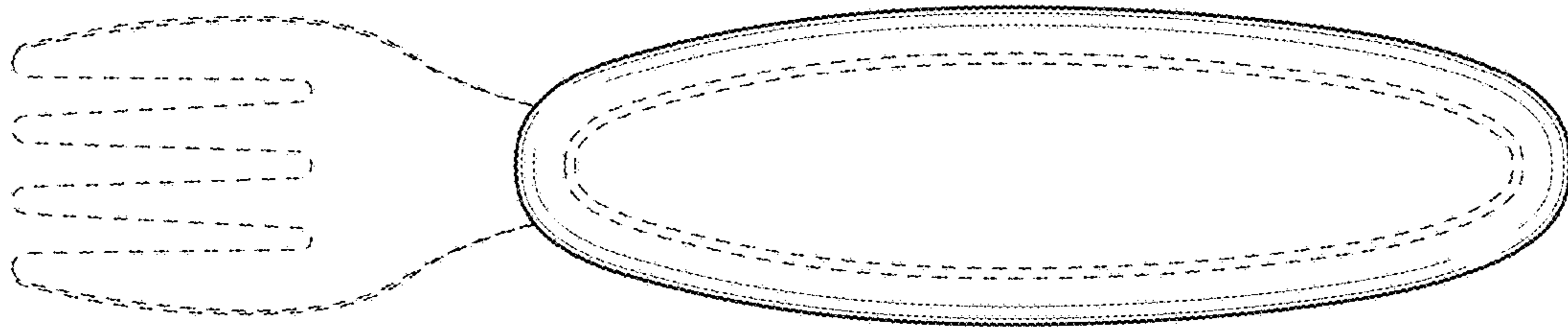

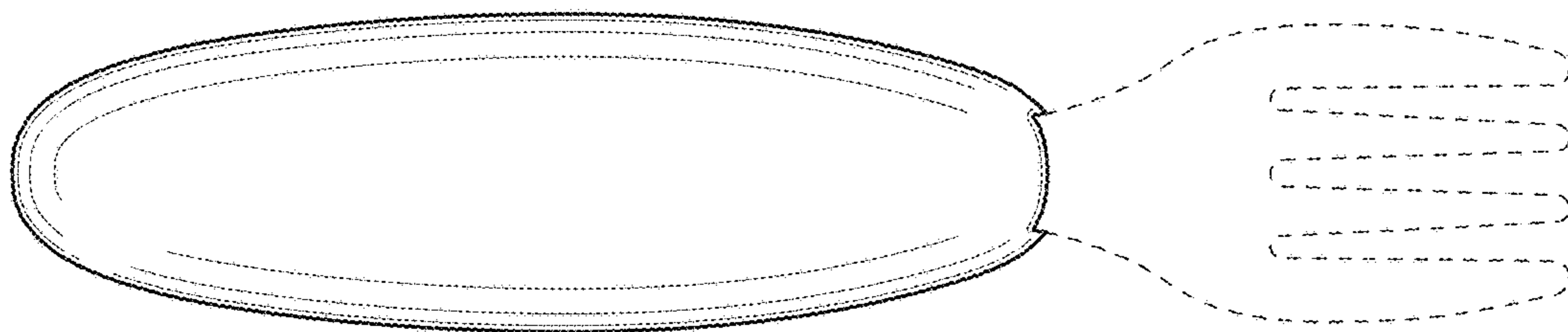

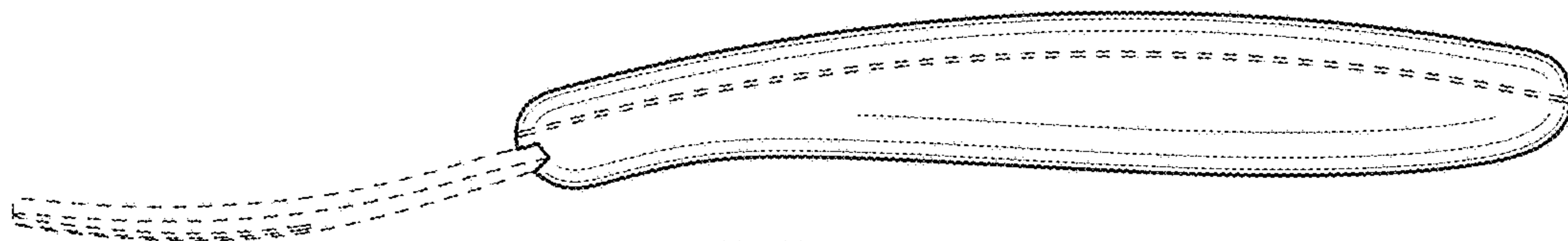

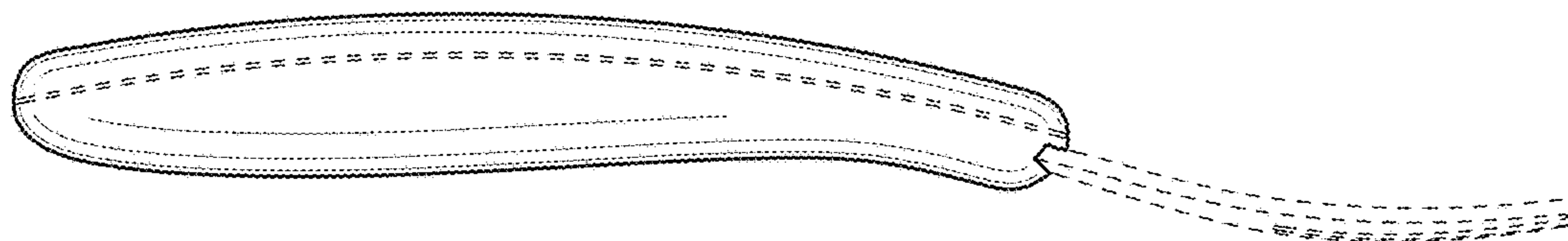

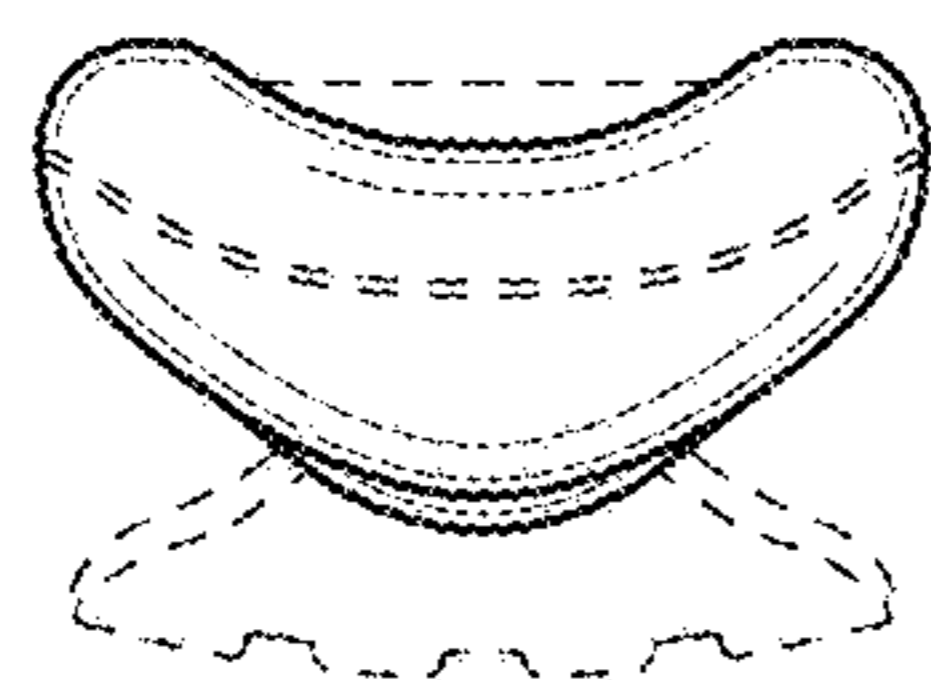

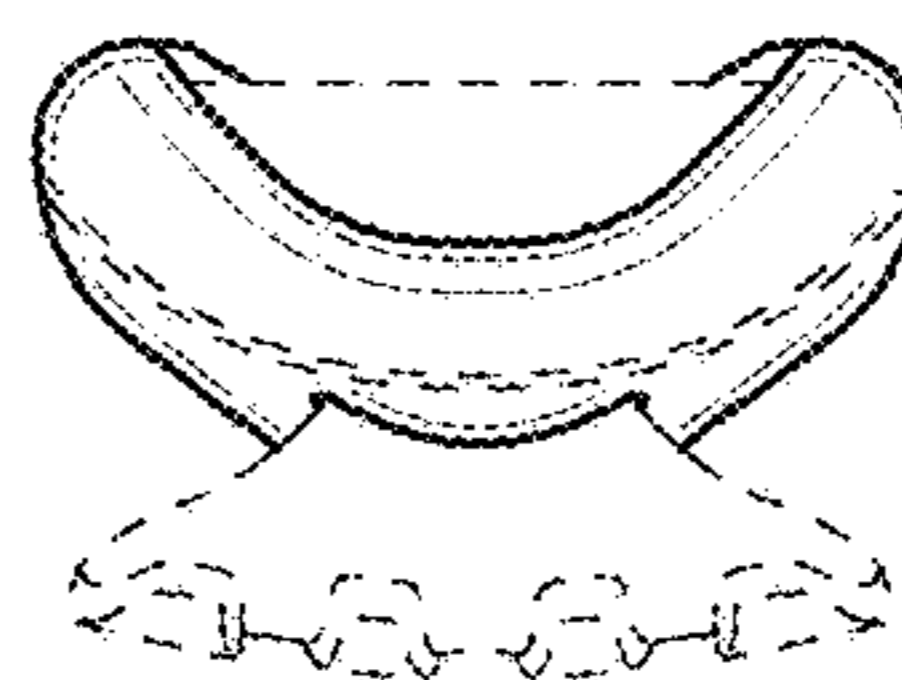
