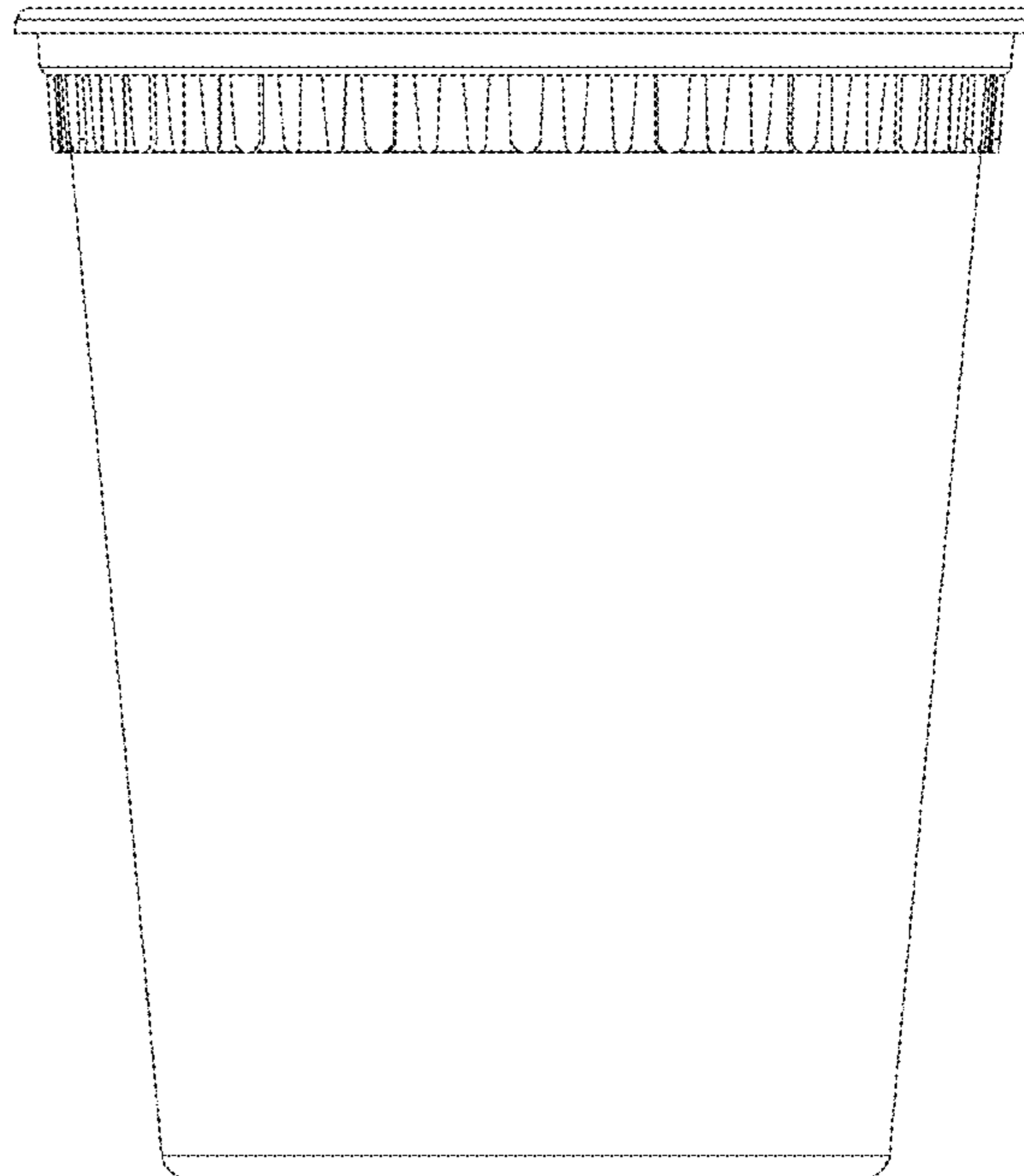
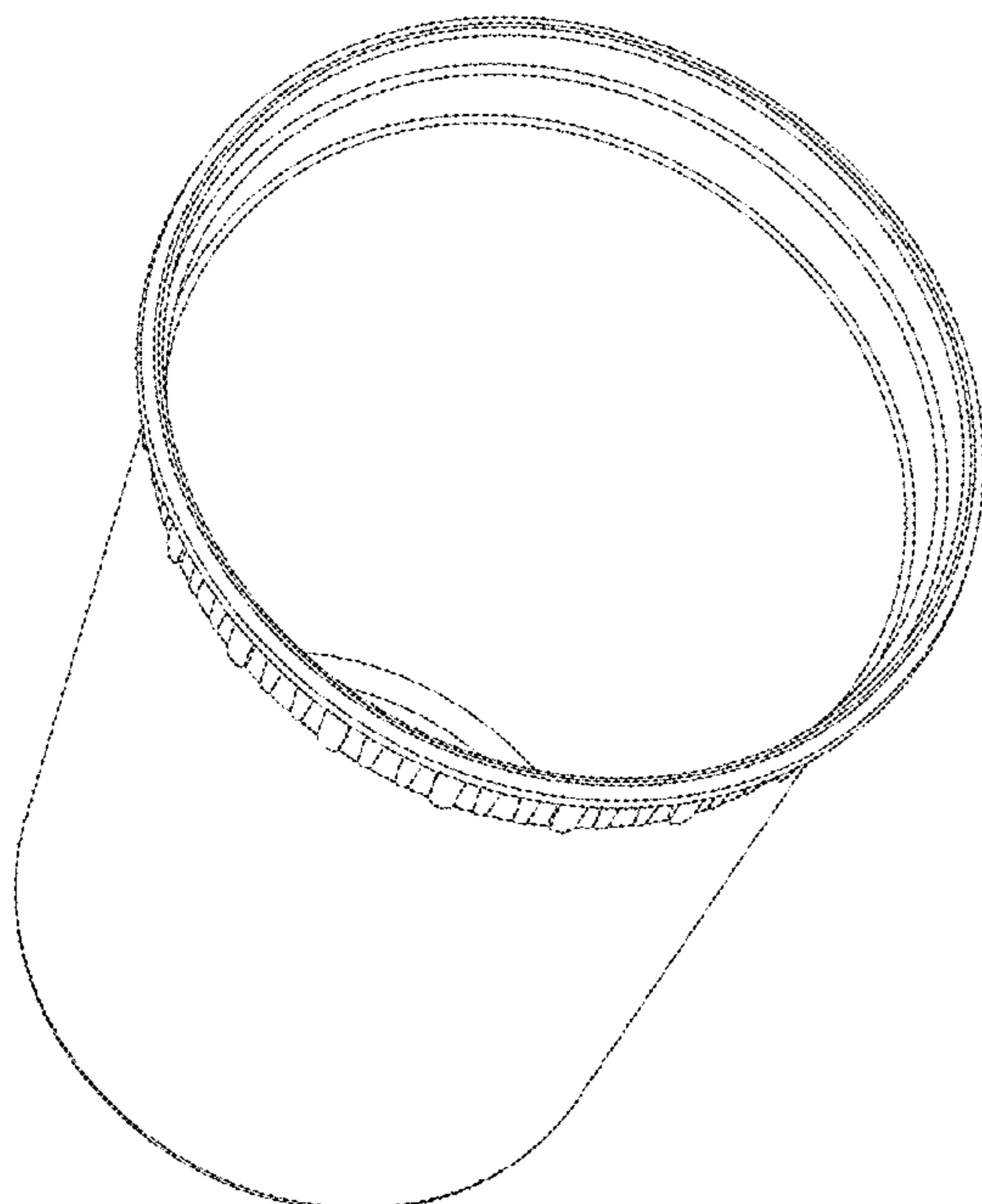
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left side, top perspective view of a container,
showing my new design;

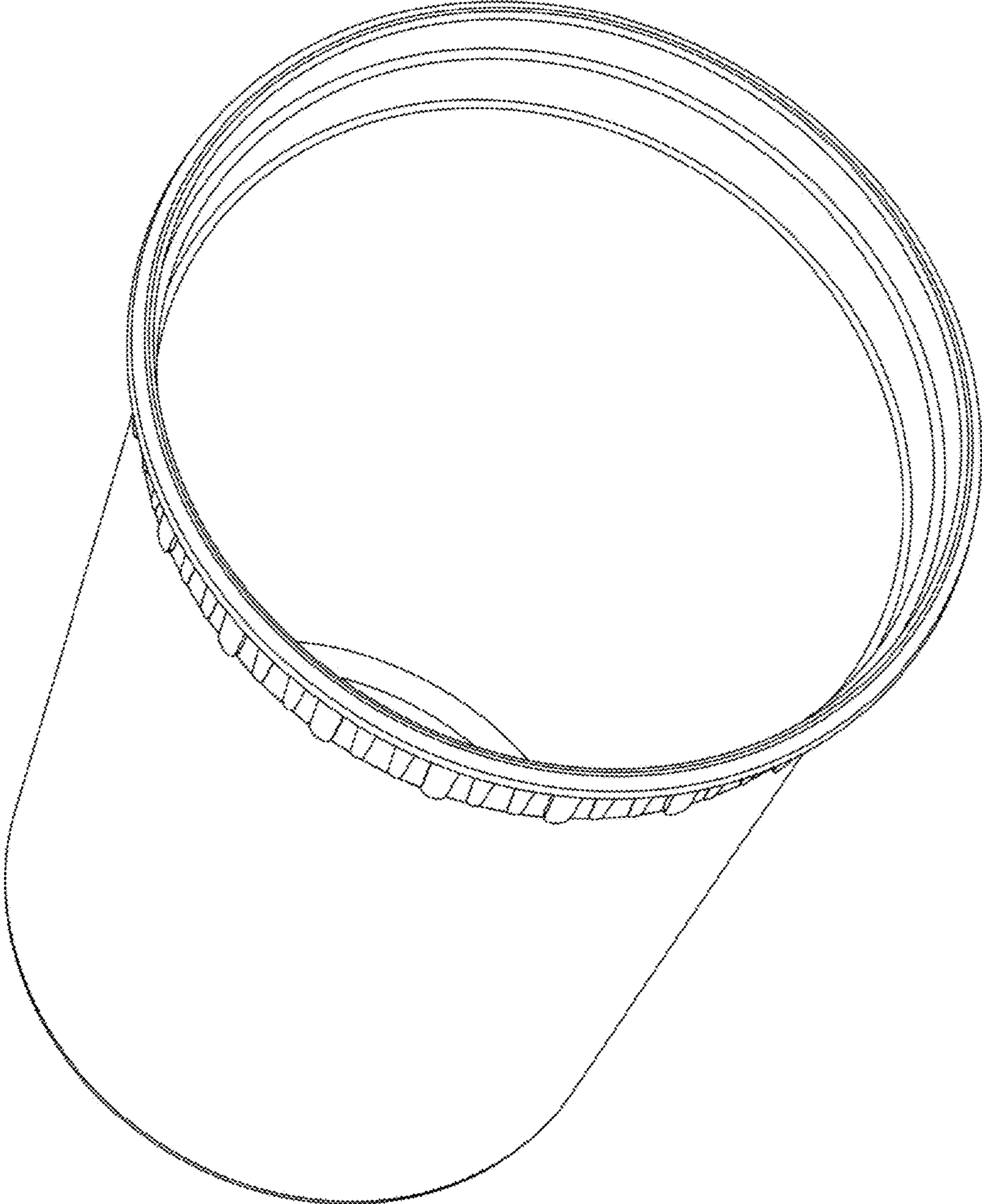

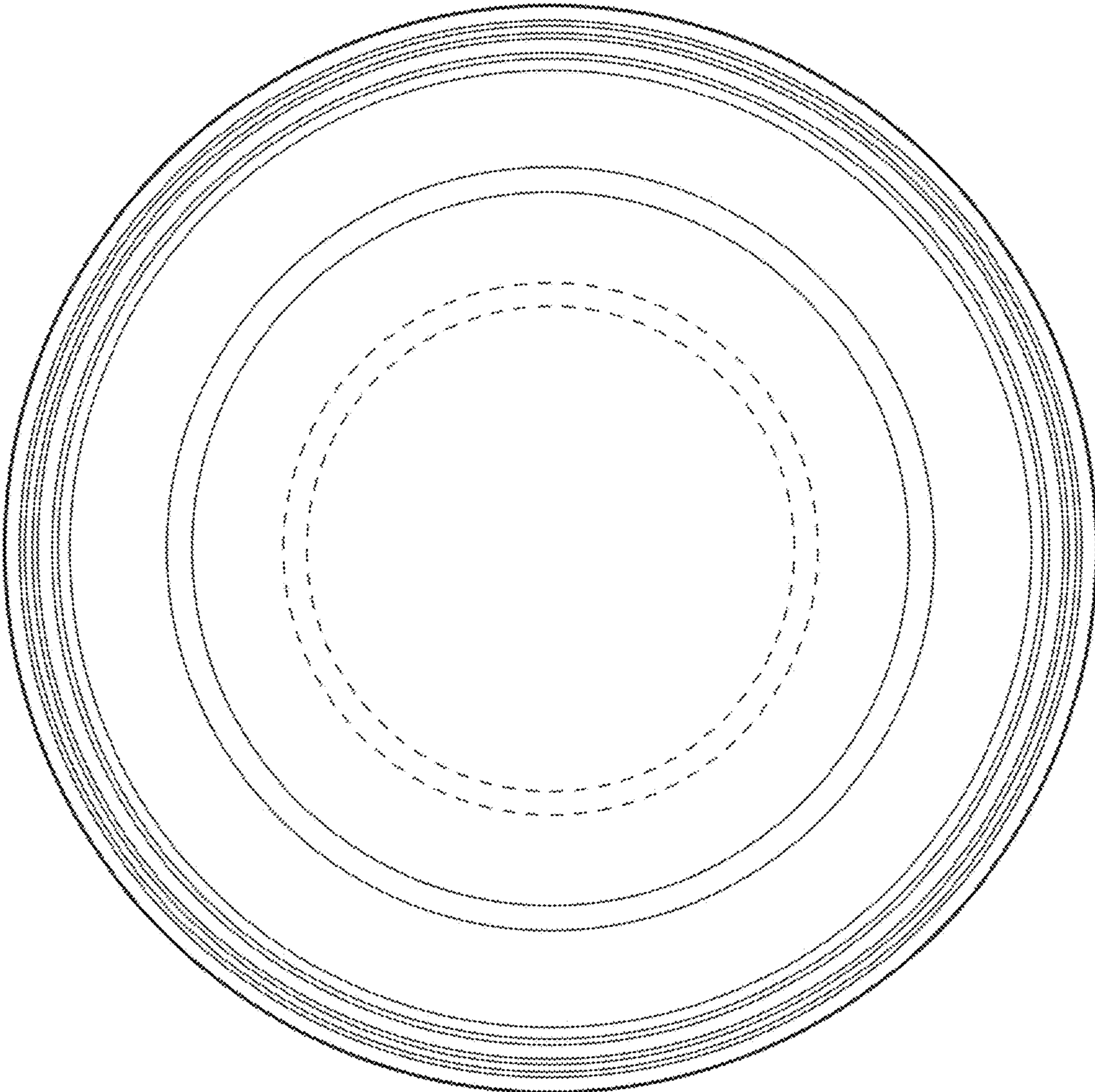

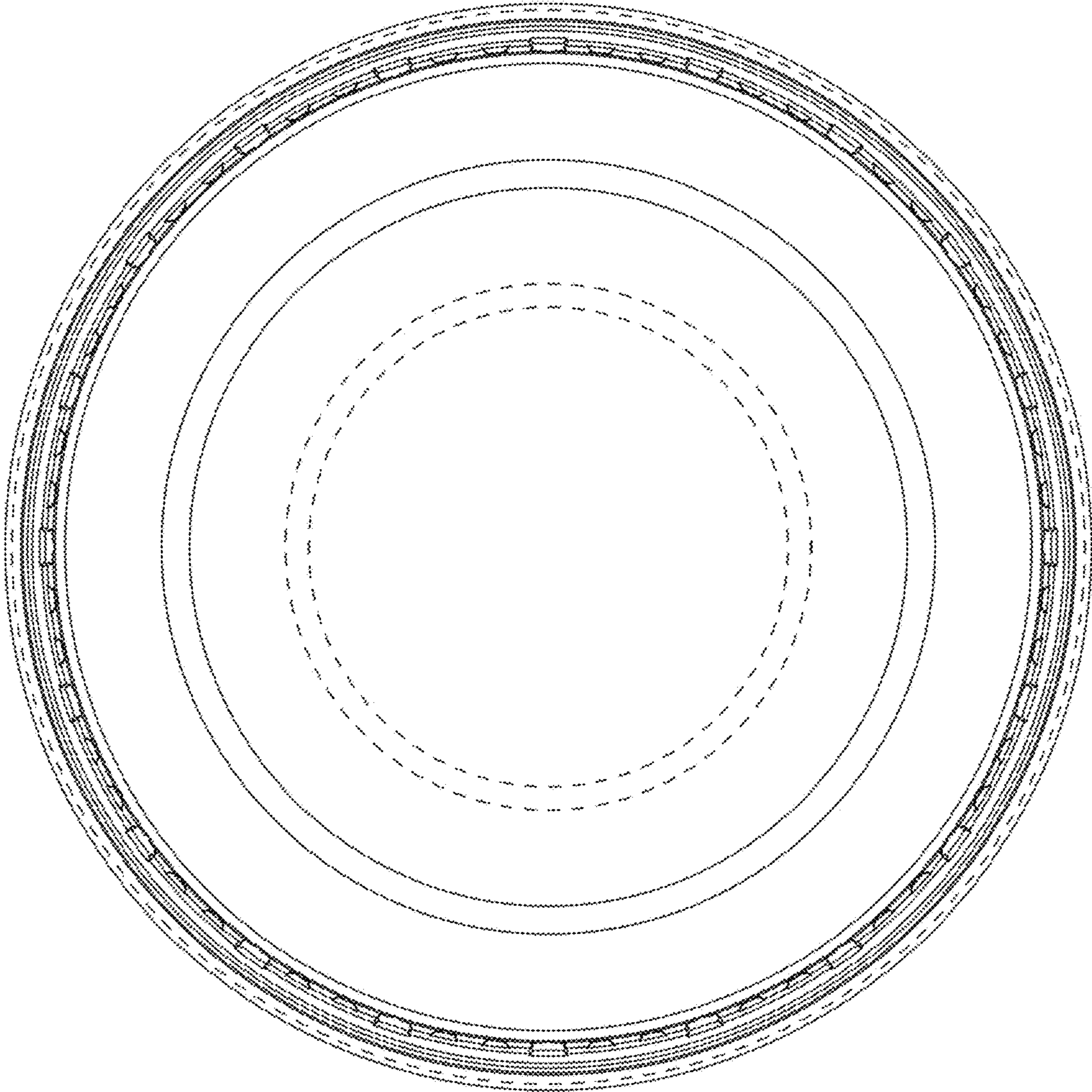

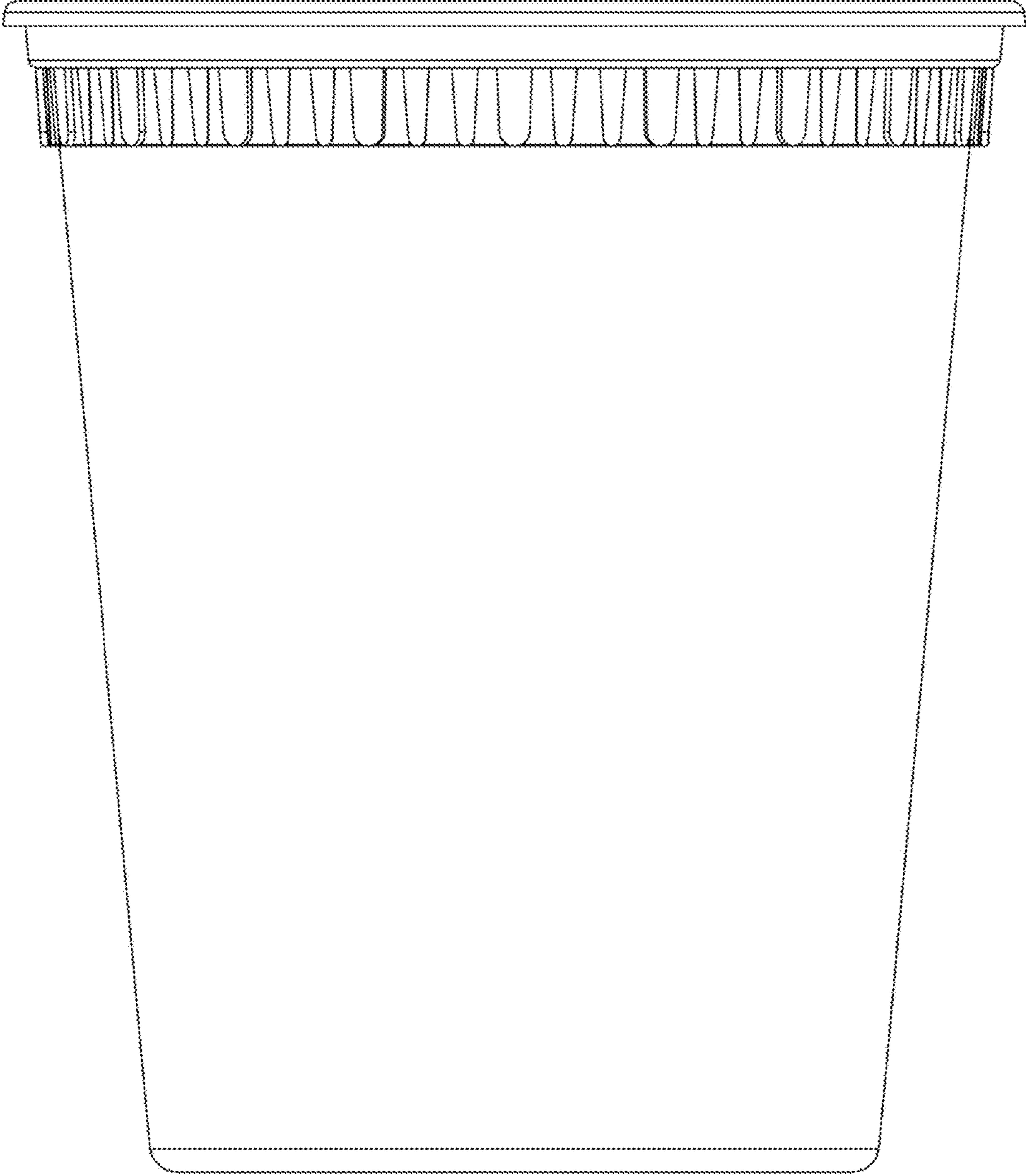
