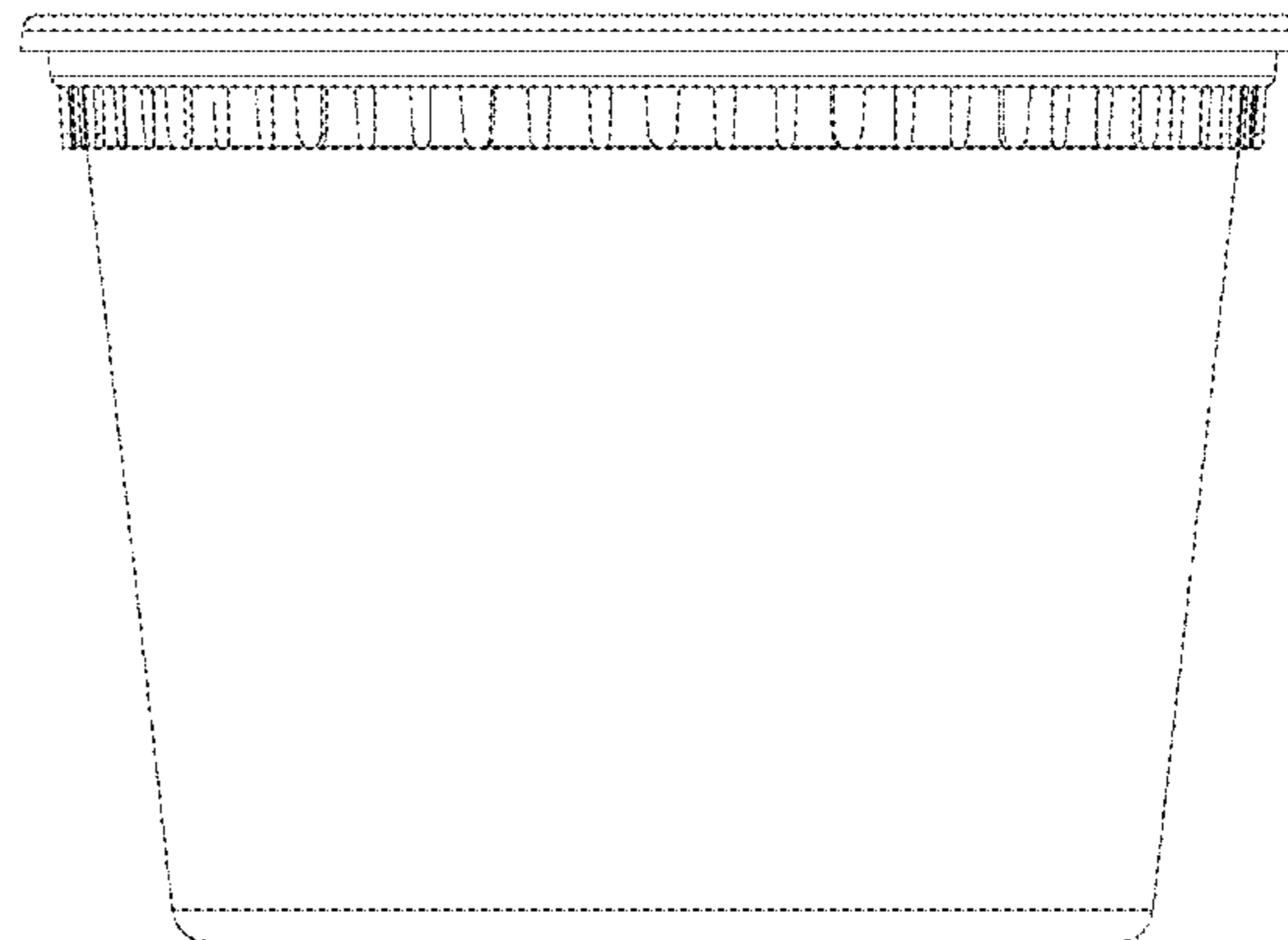
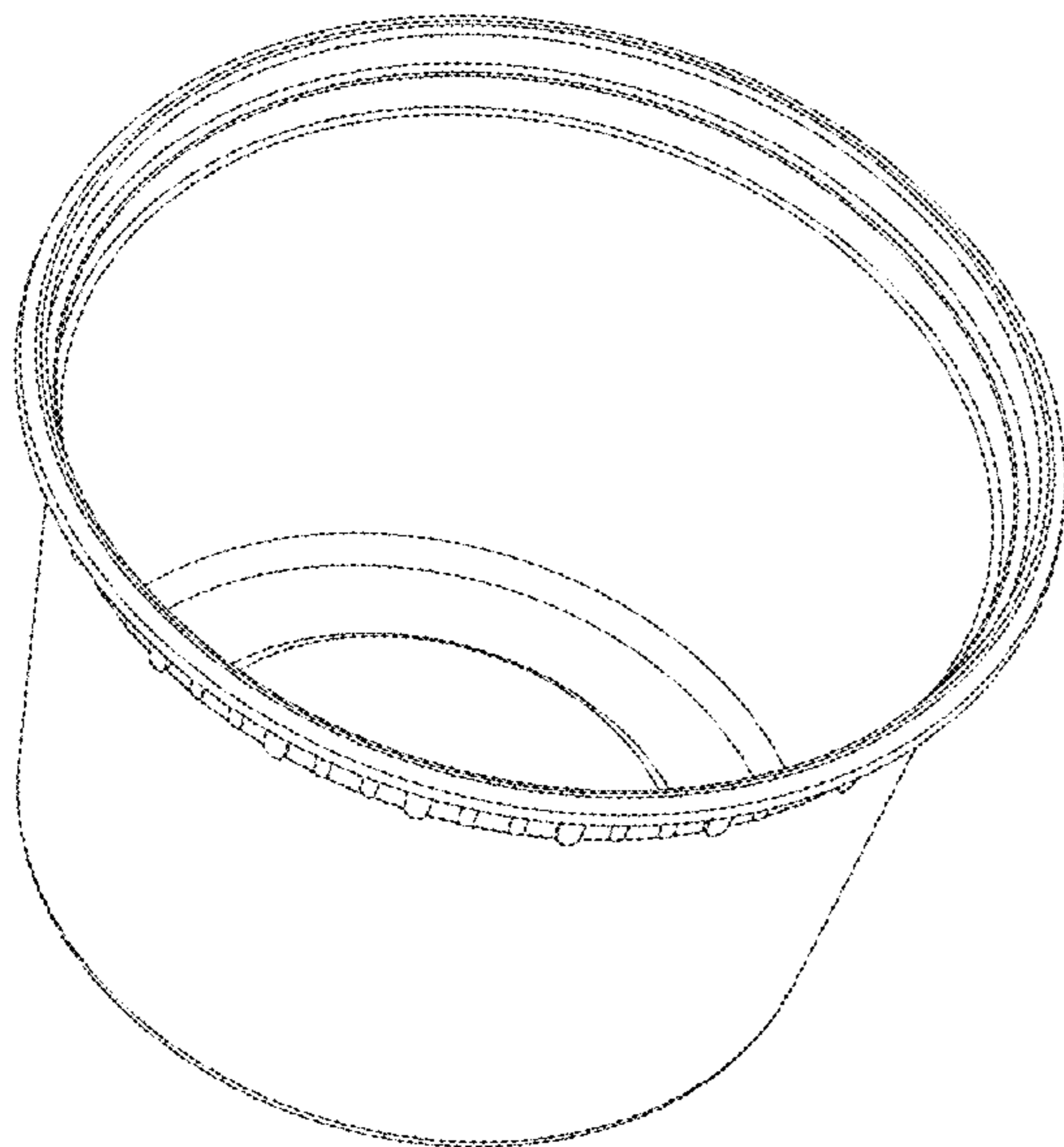
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left side, top perspective view of a container, showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof; and,
FIG. 4 is a left side view thereof, the right side, front, and rear views being mirror images thereof.

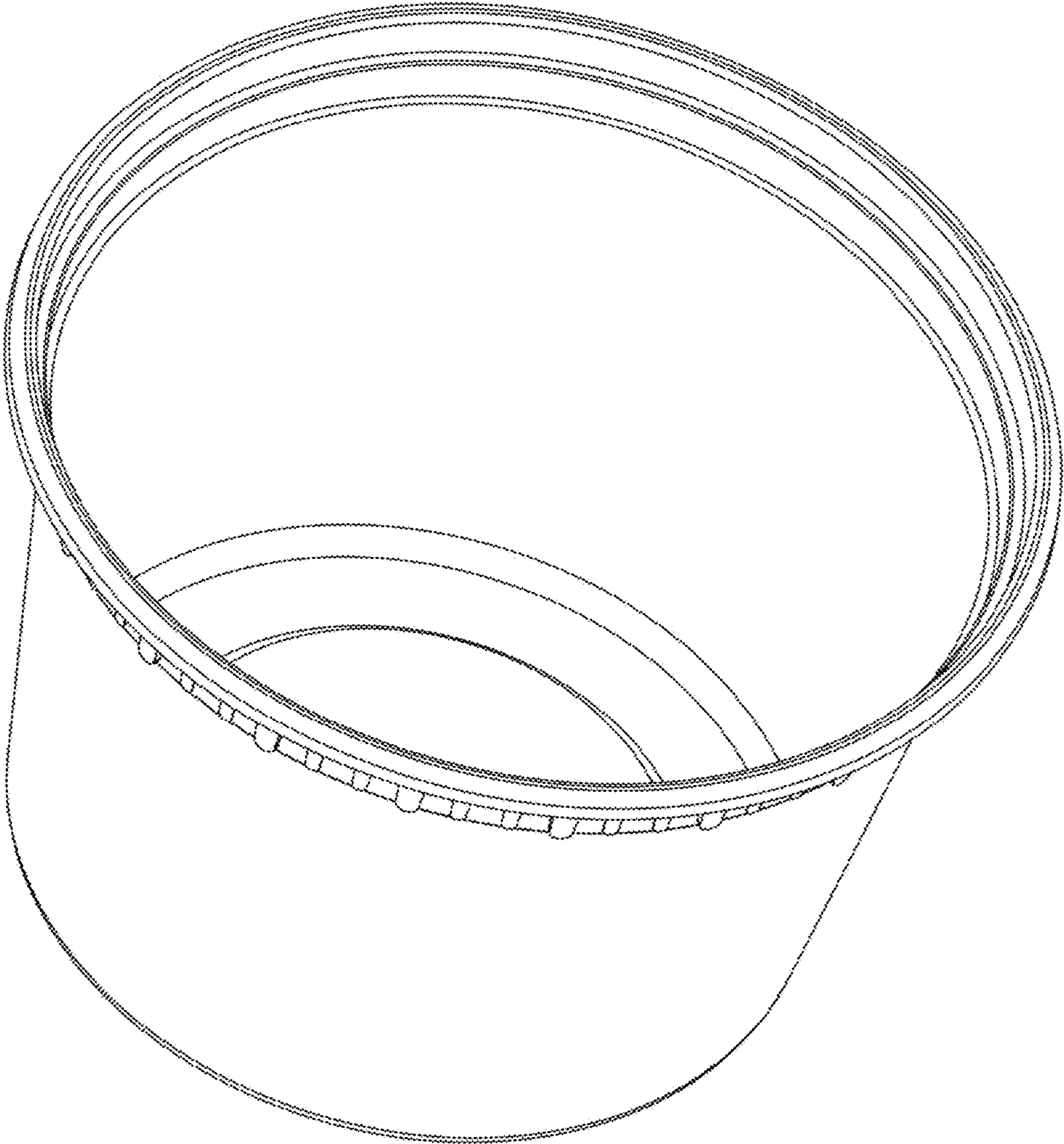

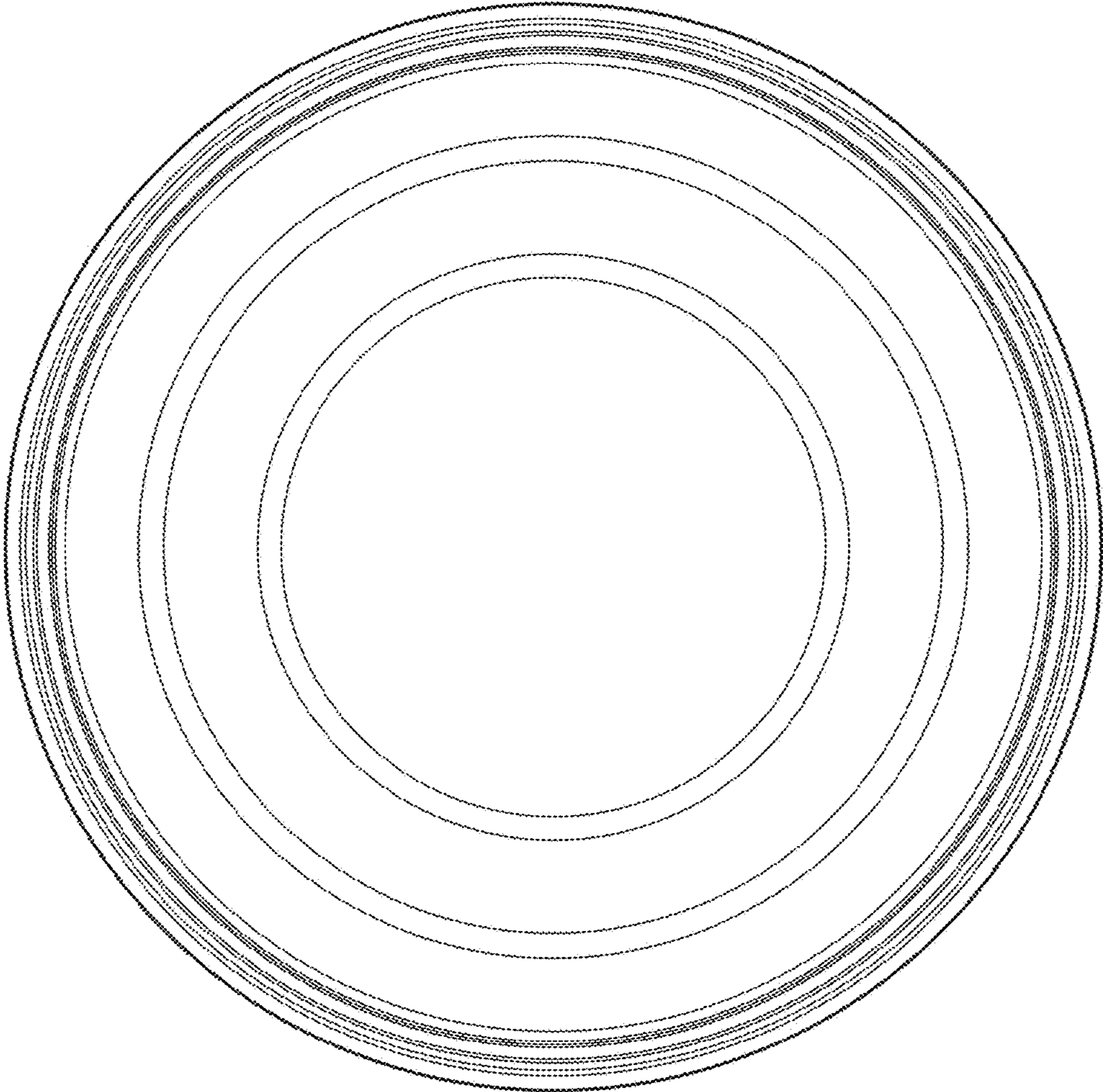

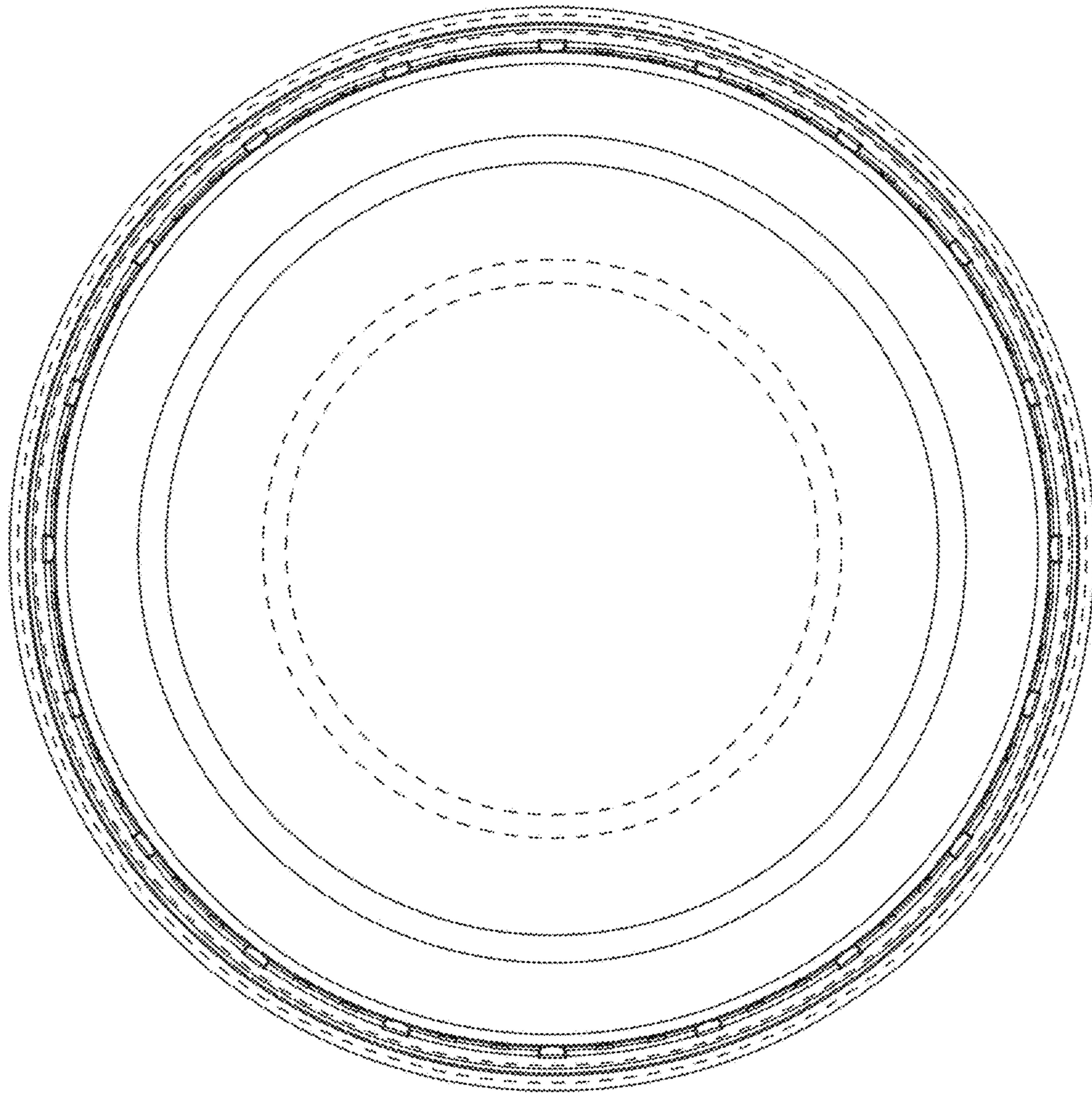

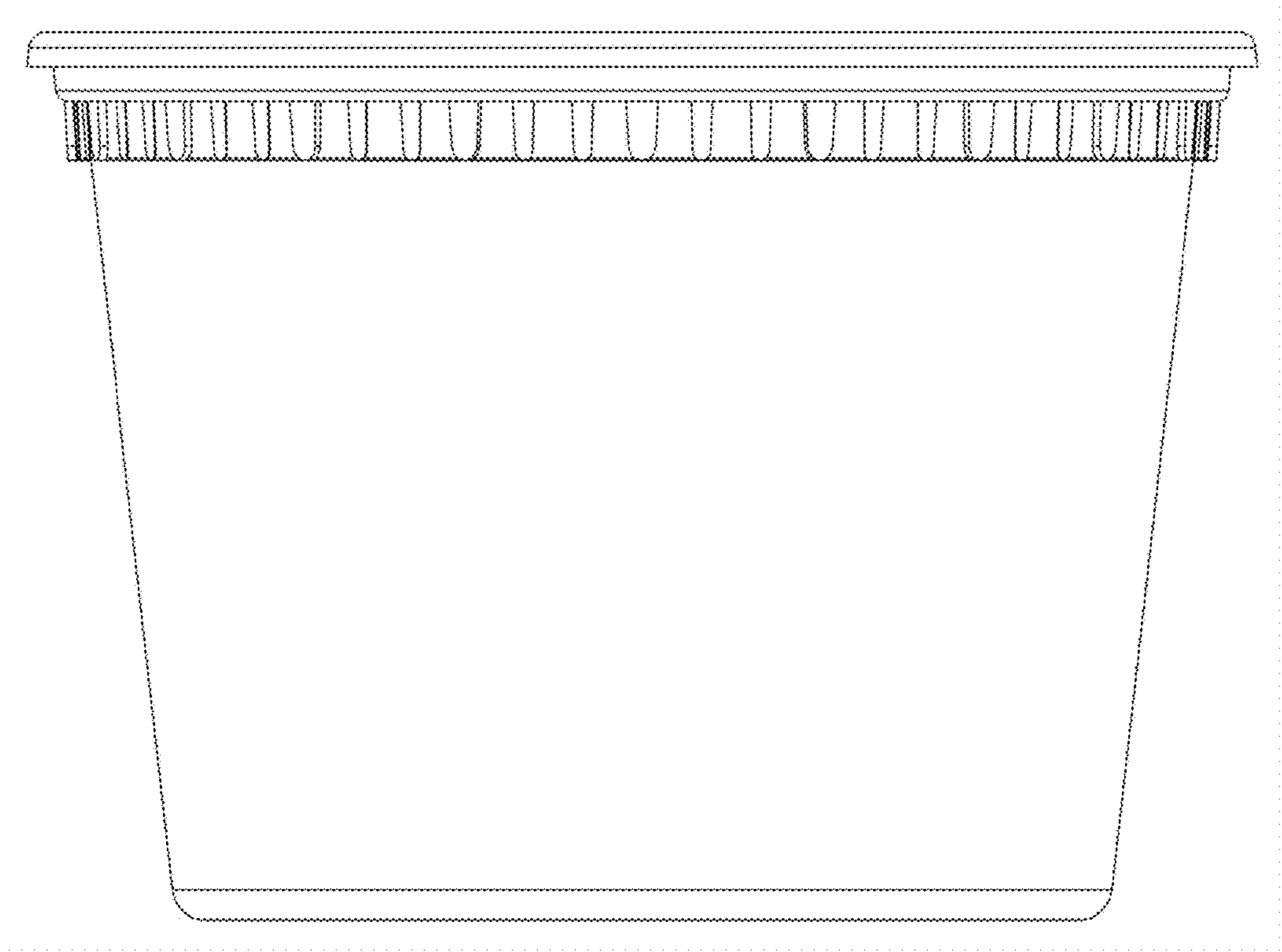
