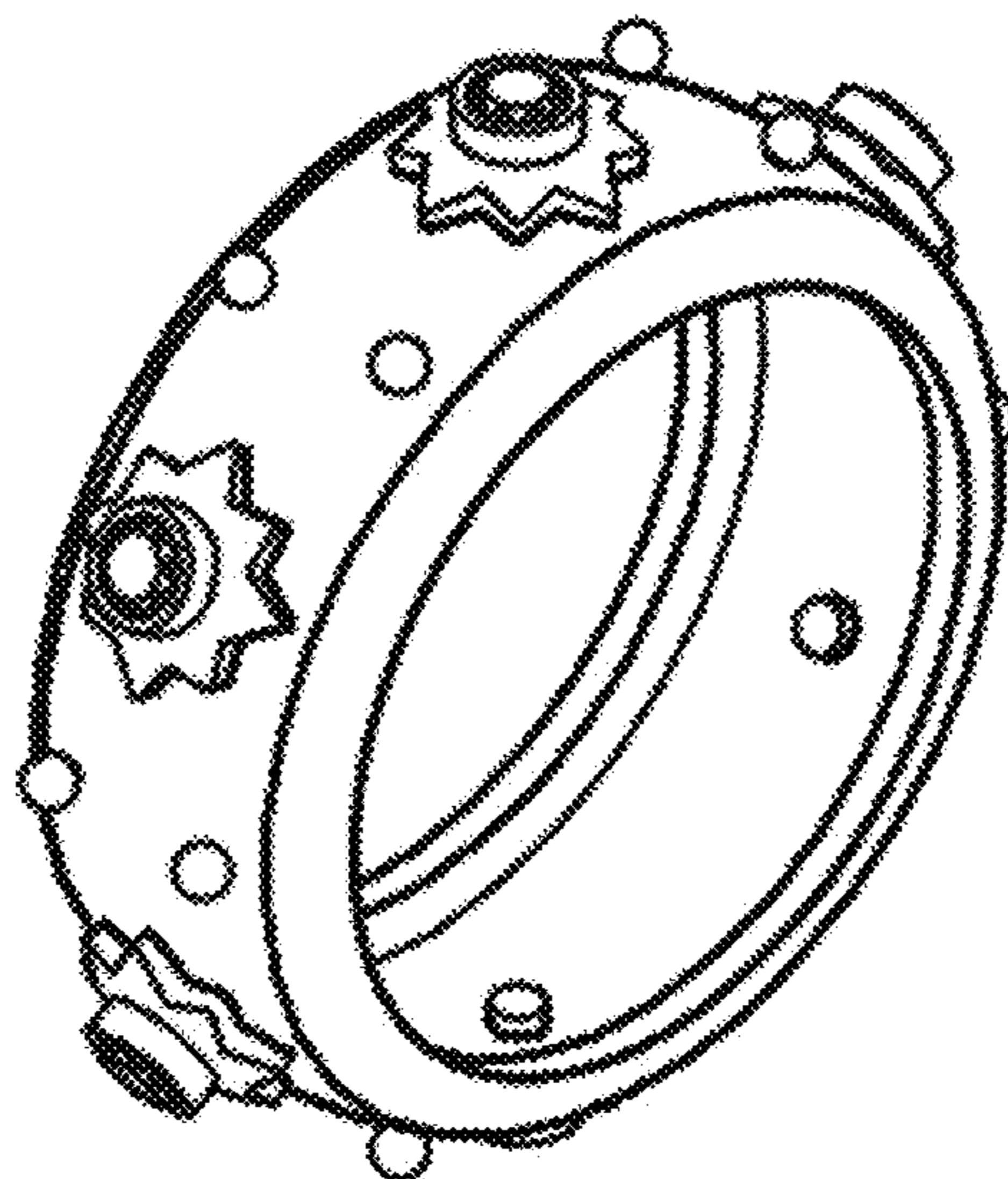

The ornamental design for a finger ring, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a finger ring, showing my new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top view, the bottom view being a mirror image thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a rear view thereof; and,
FIG. 8 is a top enlarged view of one of the jeweled elements of the finger ring, the others being the same.

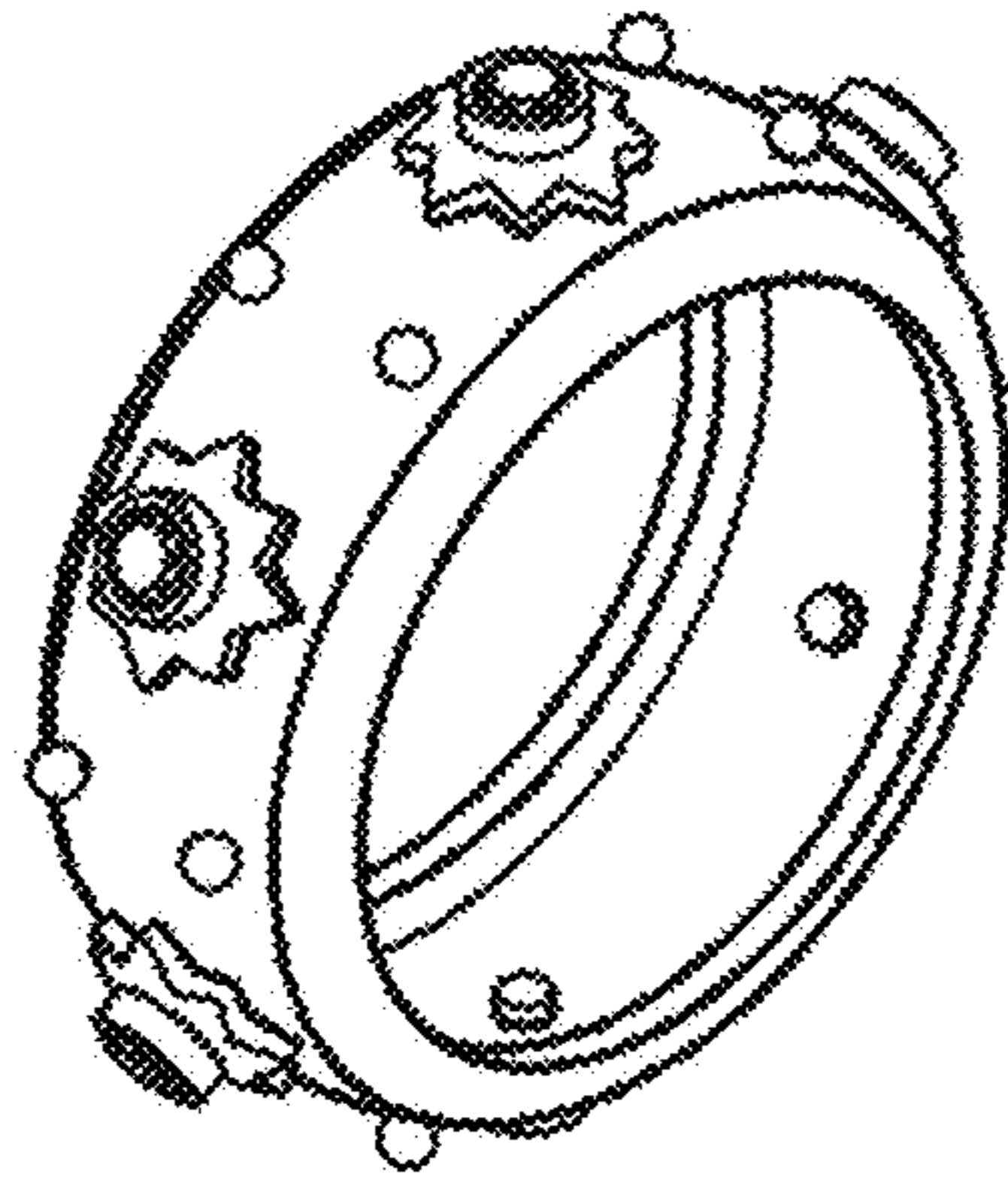

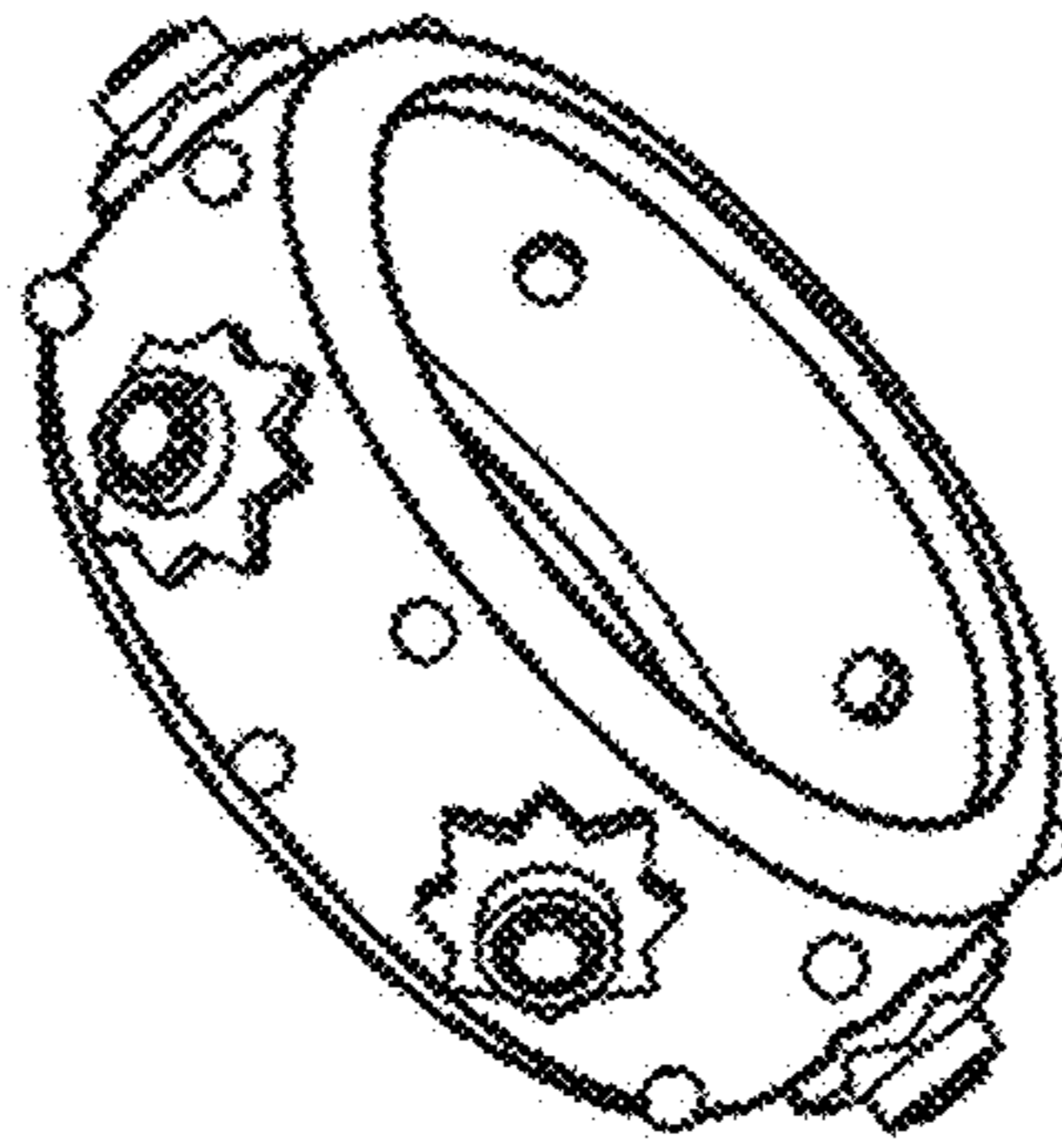

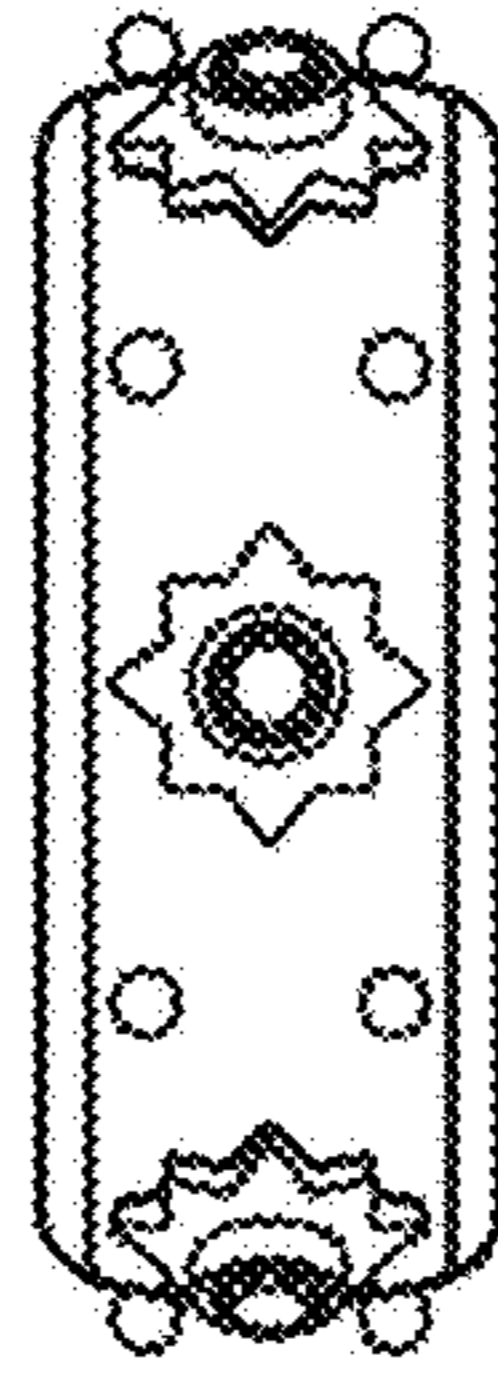

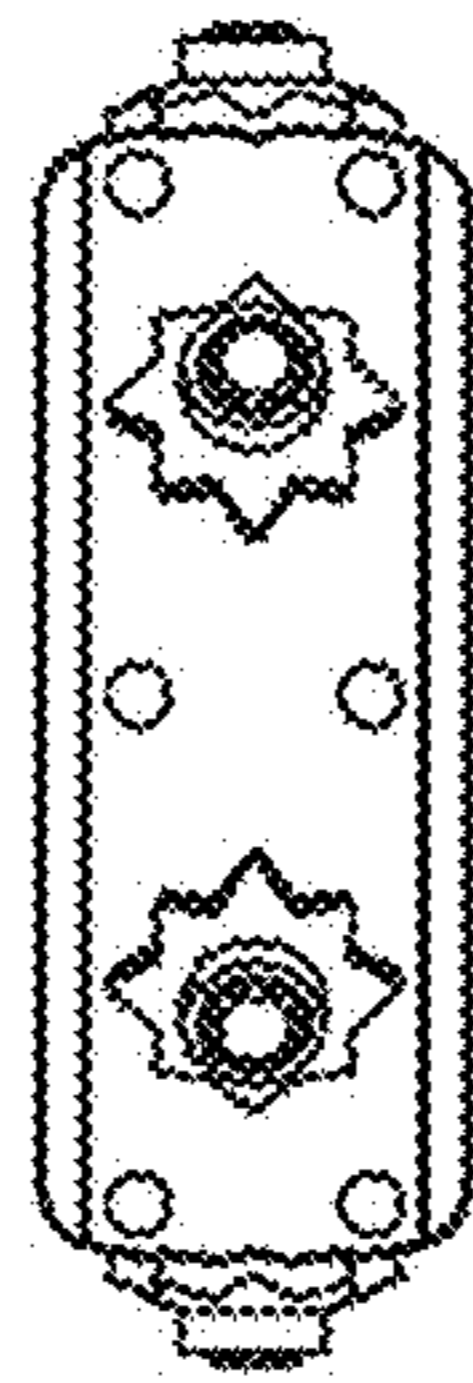

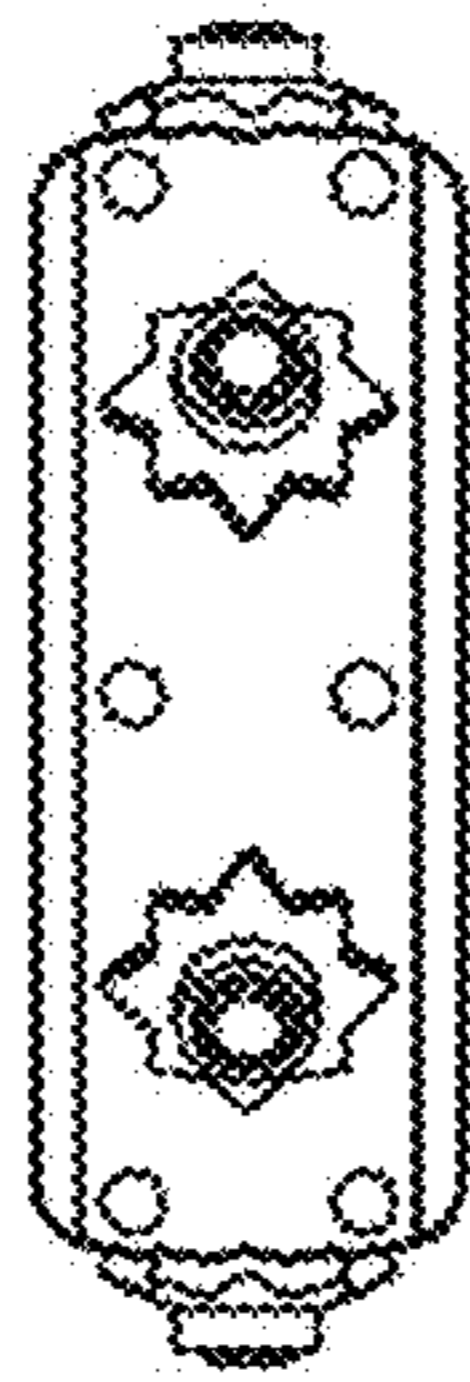

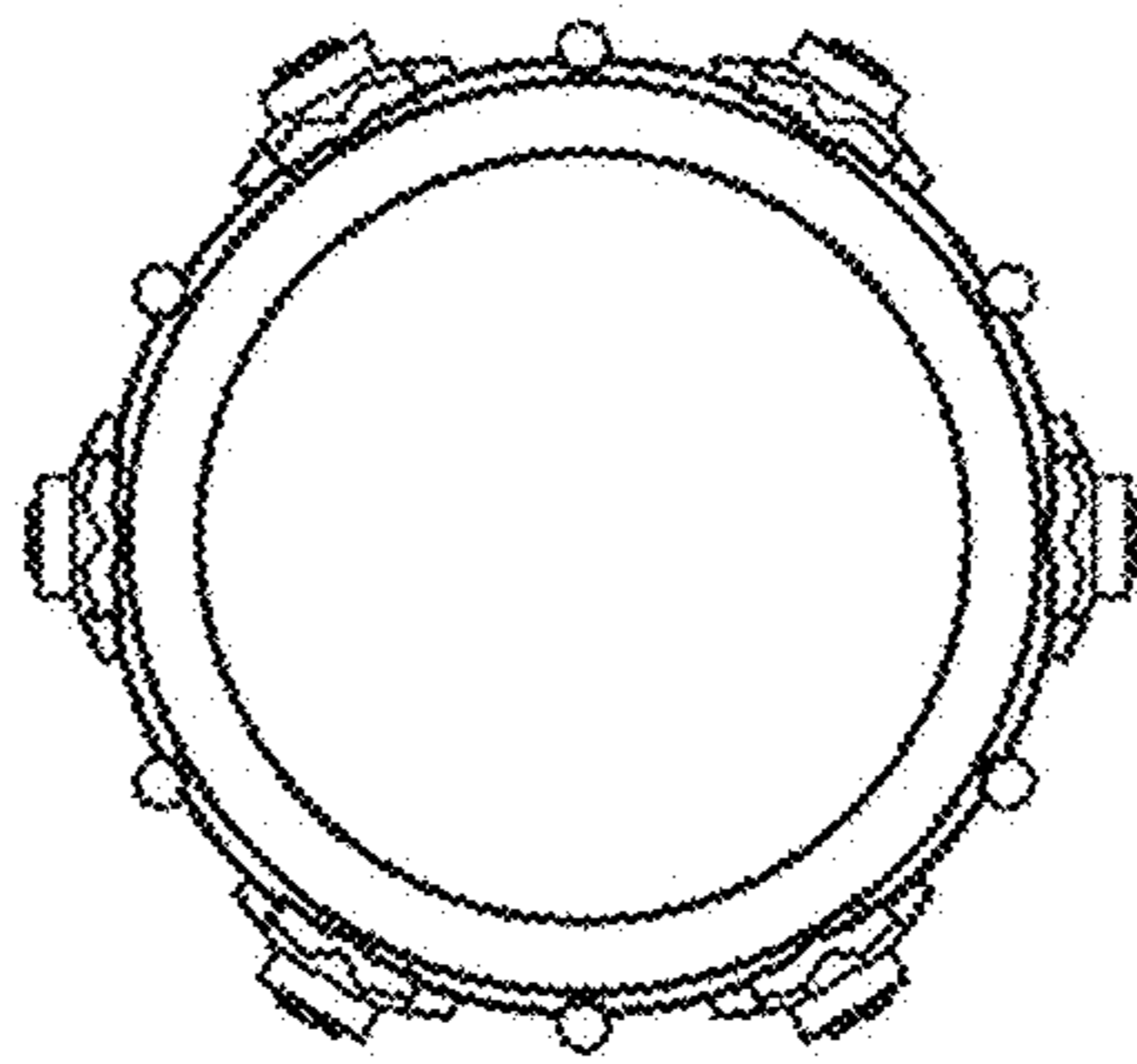

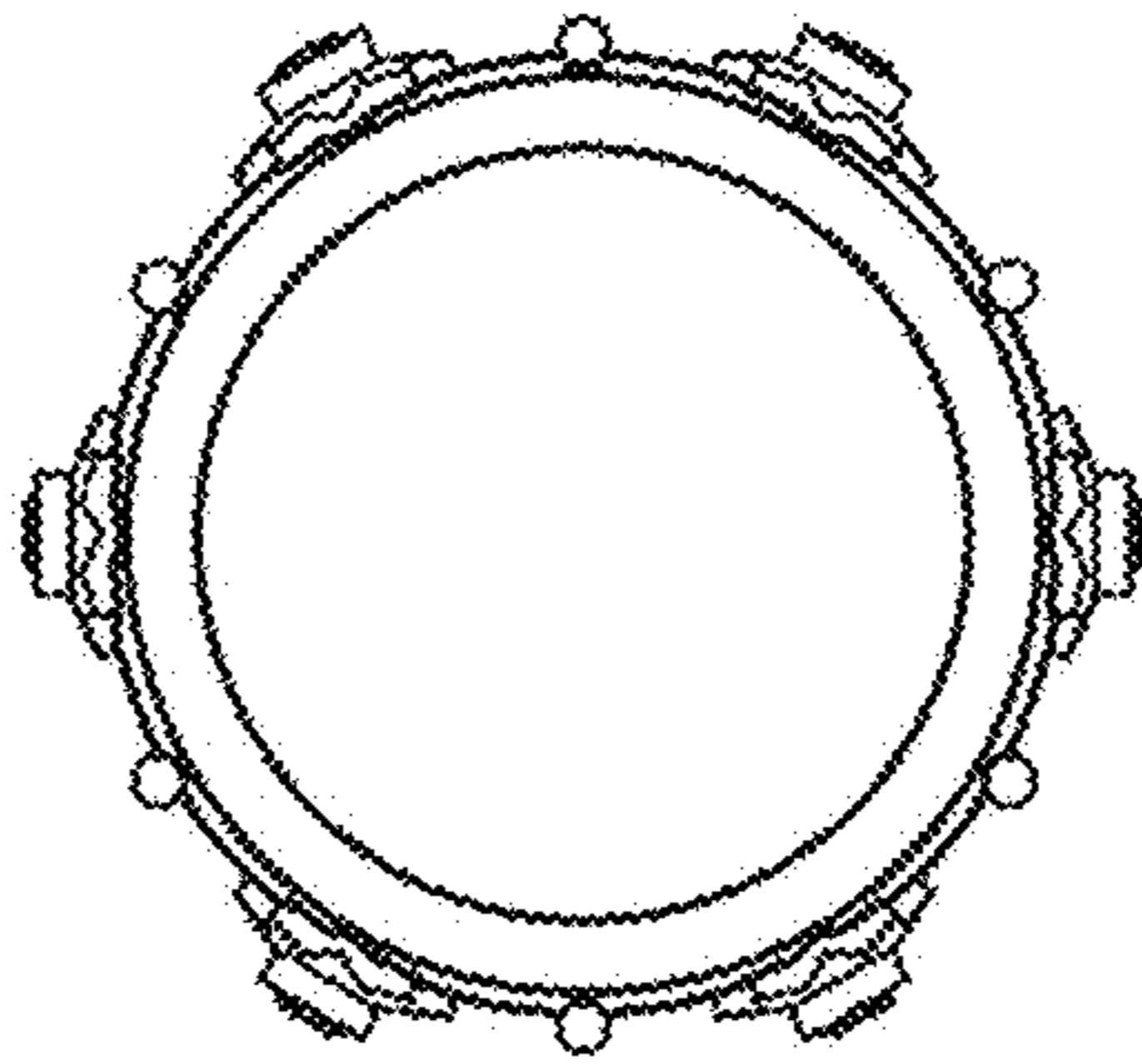

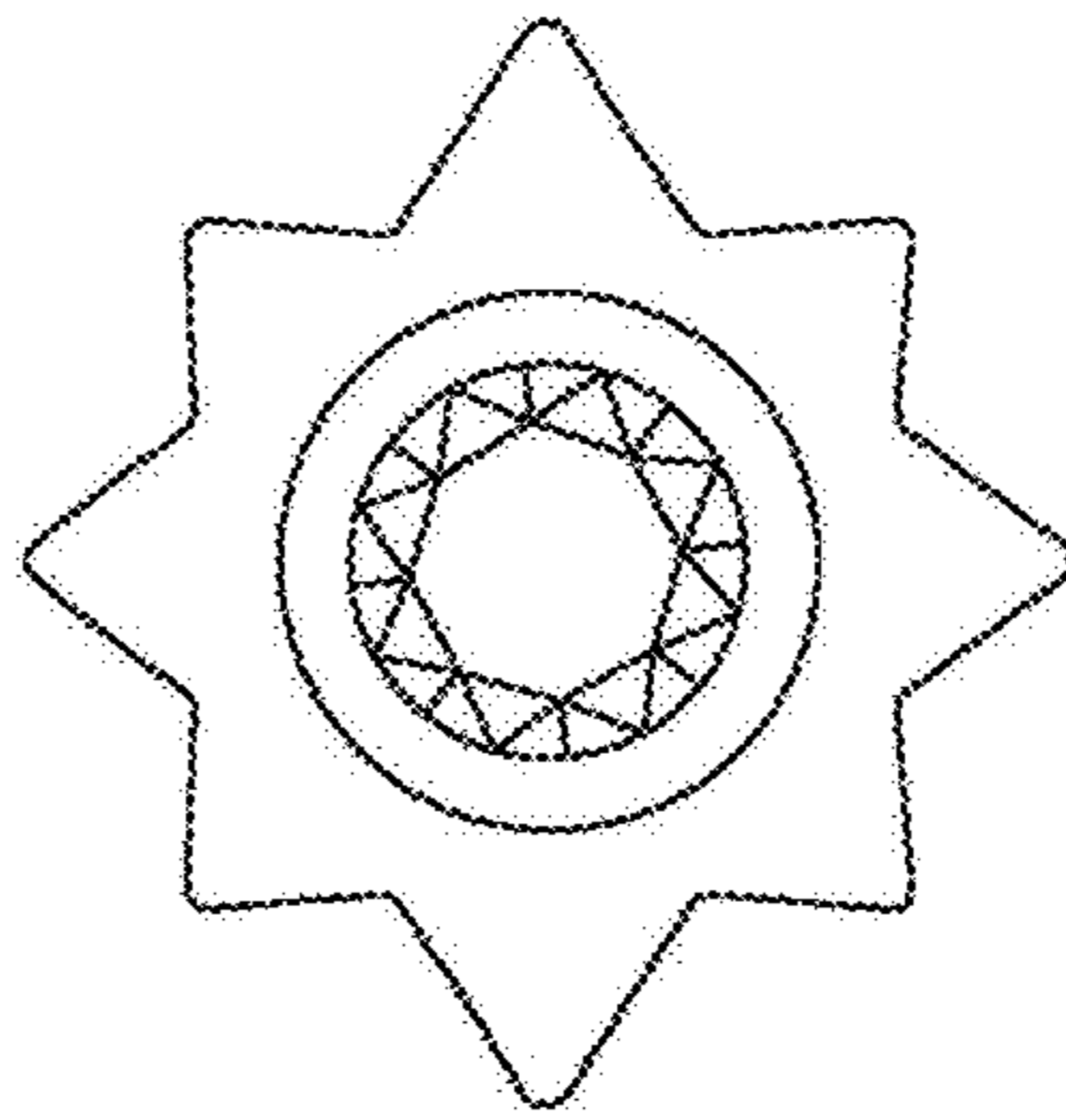
