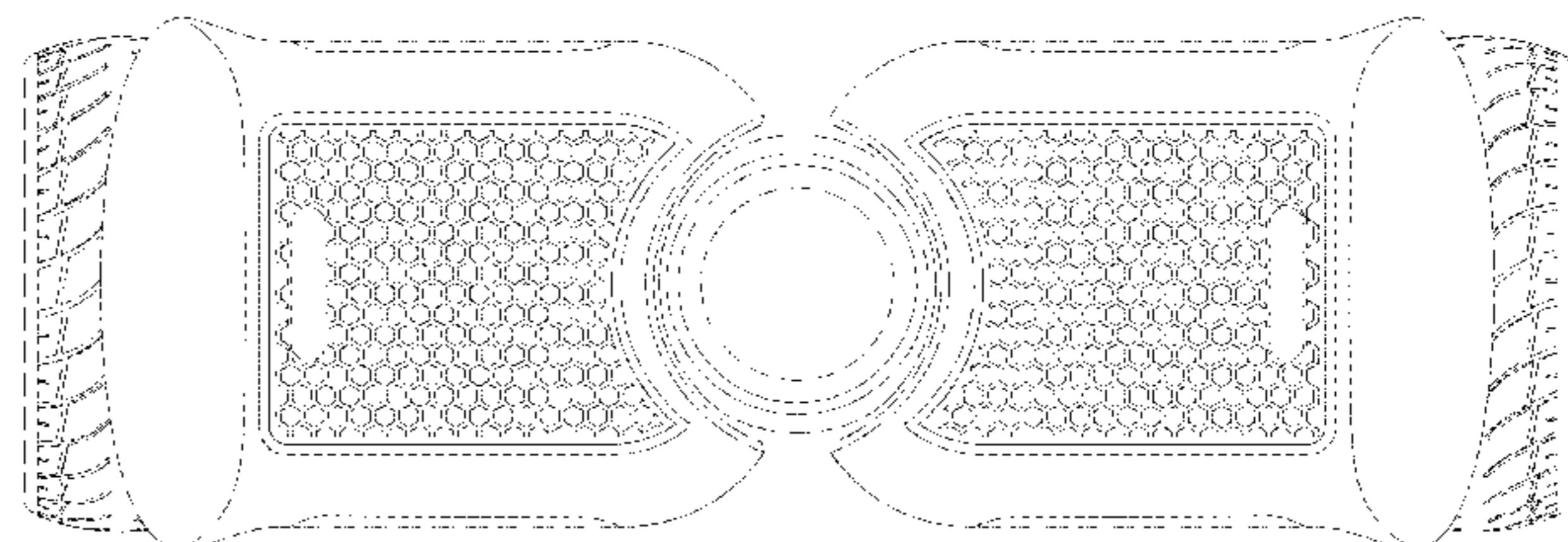
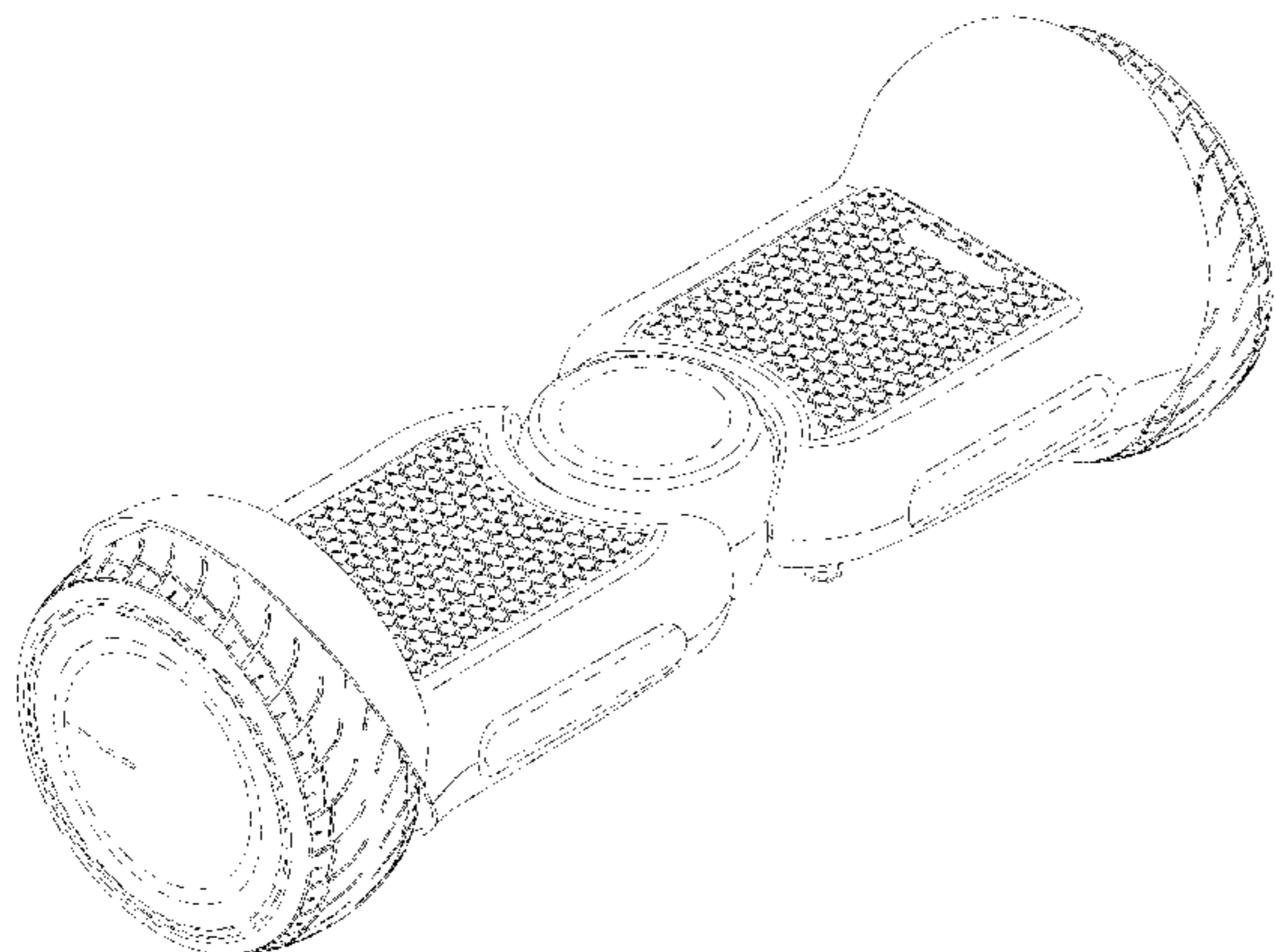
(57) **CLAIM**

The ornamental design for an electric self-balancing vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and left side perspective view of an electric self-balancing vehicle showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a front elevational view thereof. In the drawings, the broken lines are included to show portions of the electric self-balancing vehicle that form no part of the claimed design.

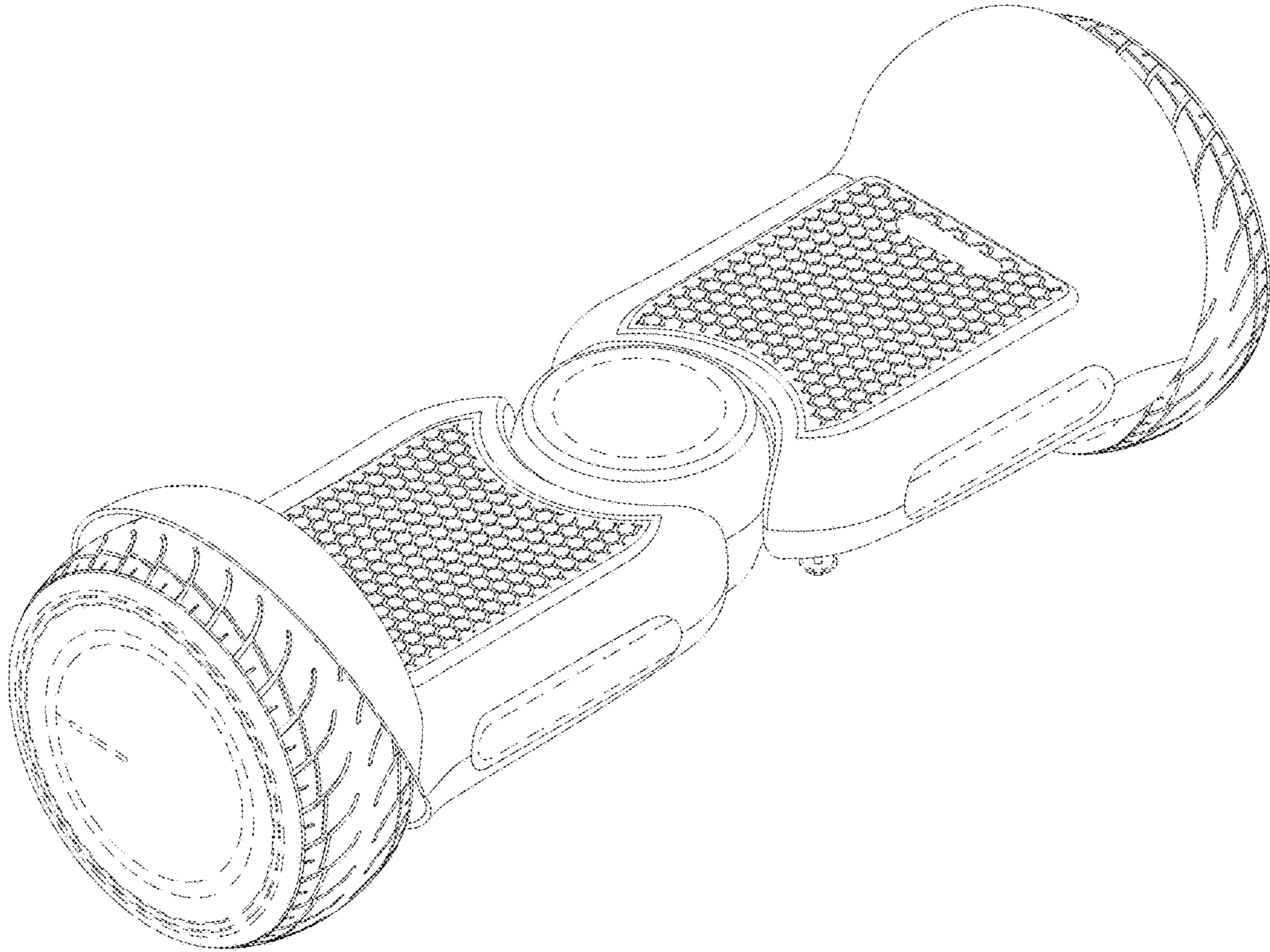

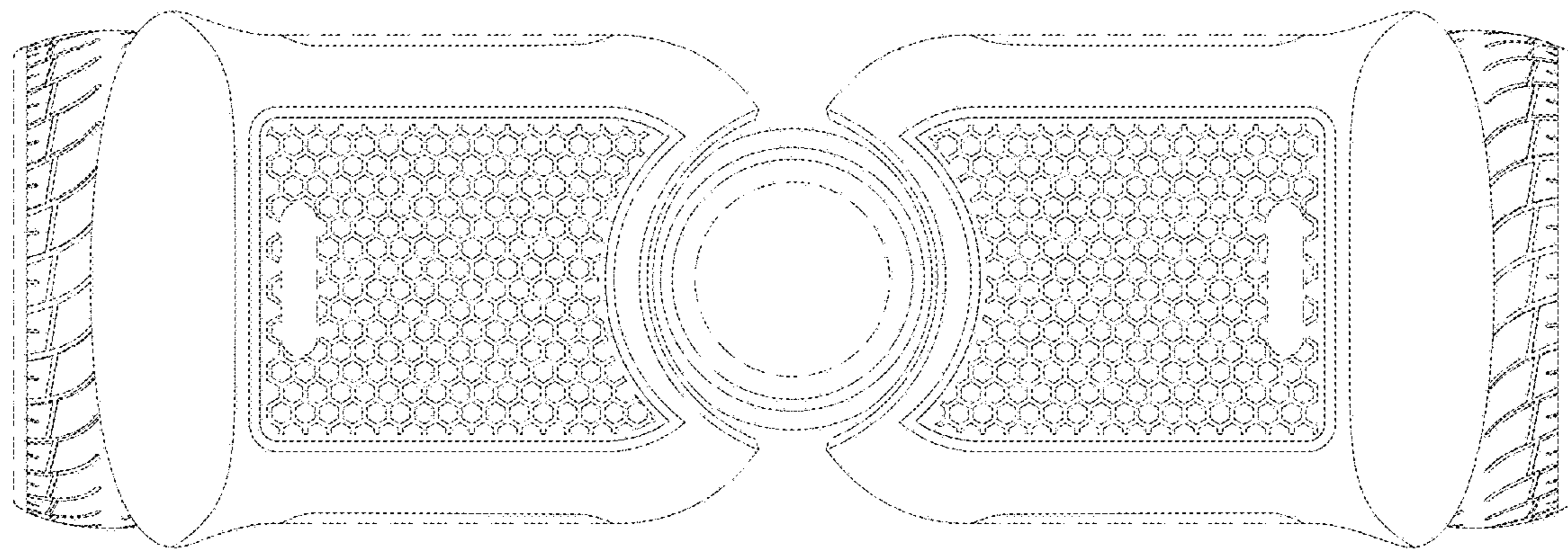

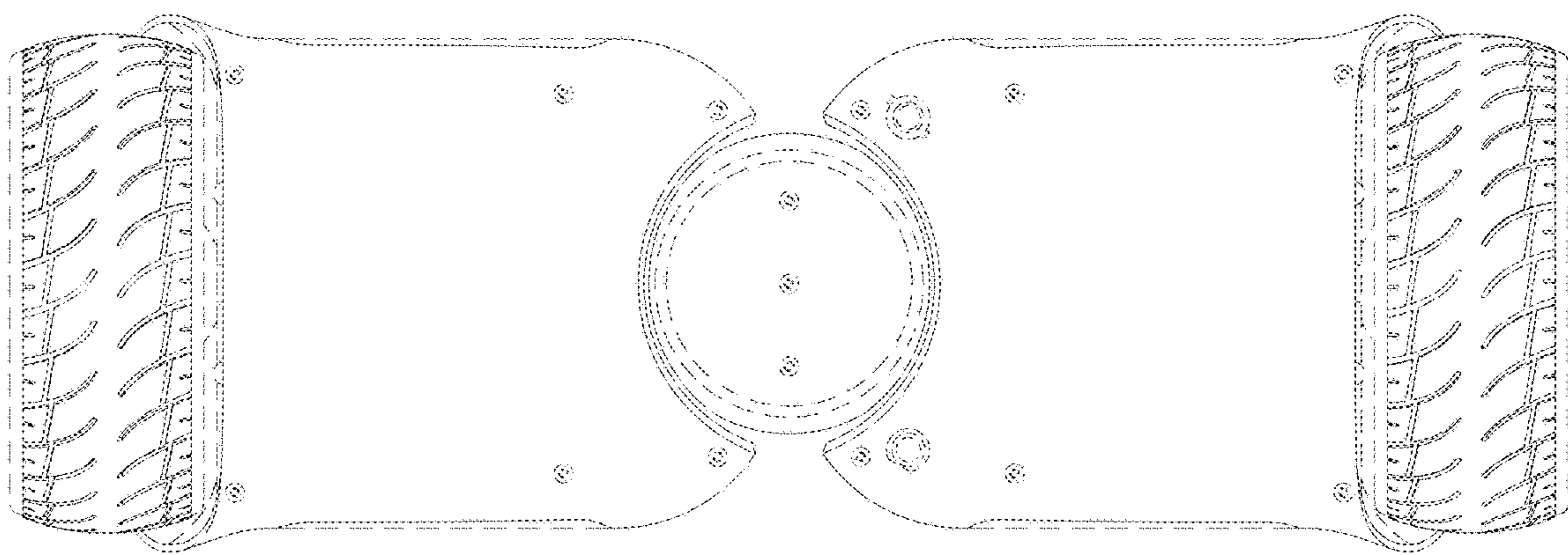

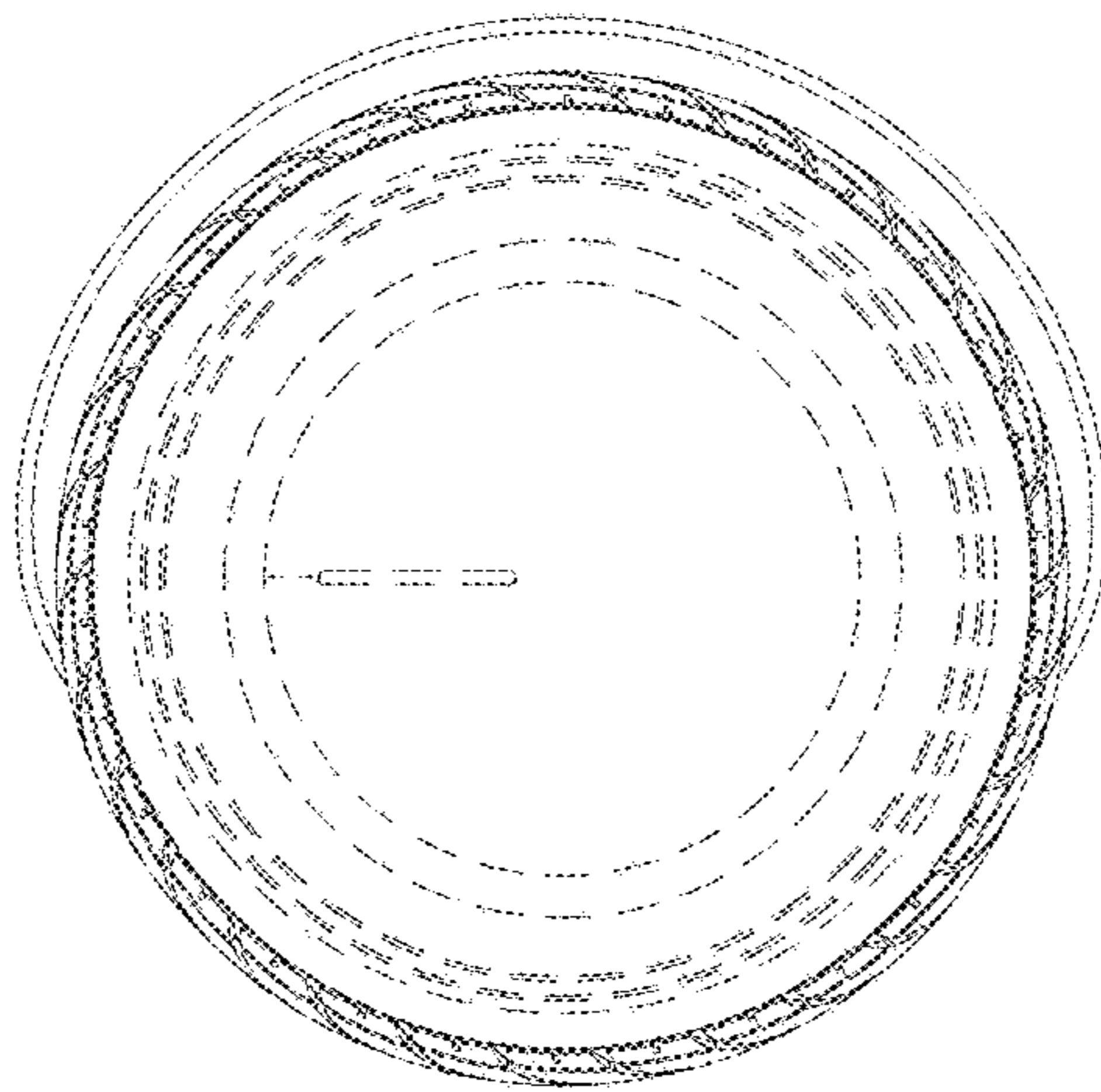

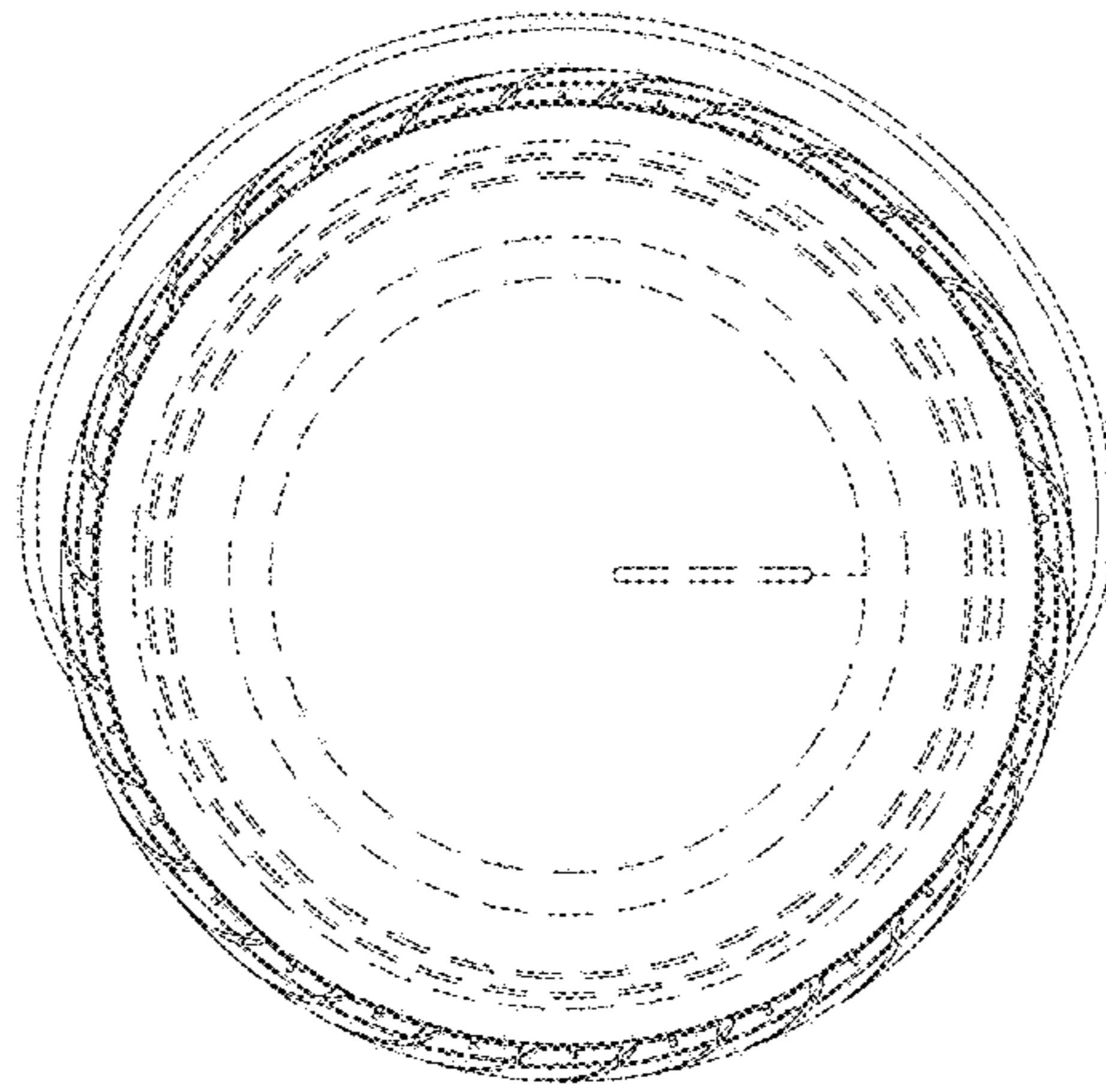

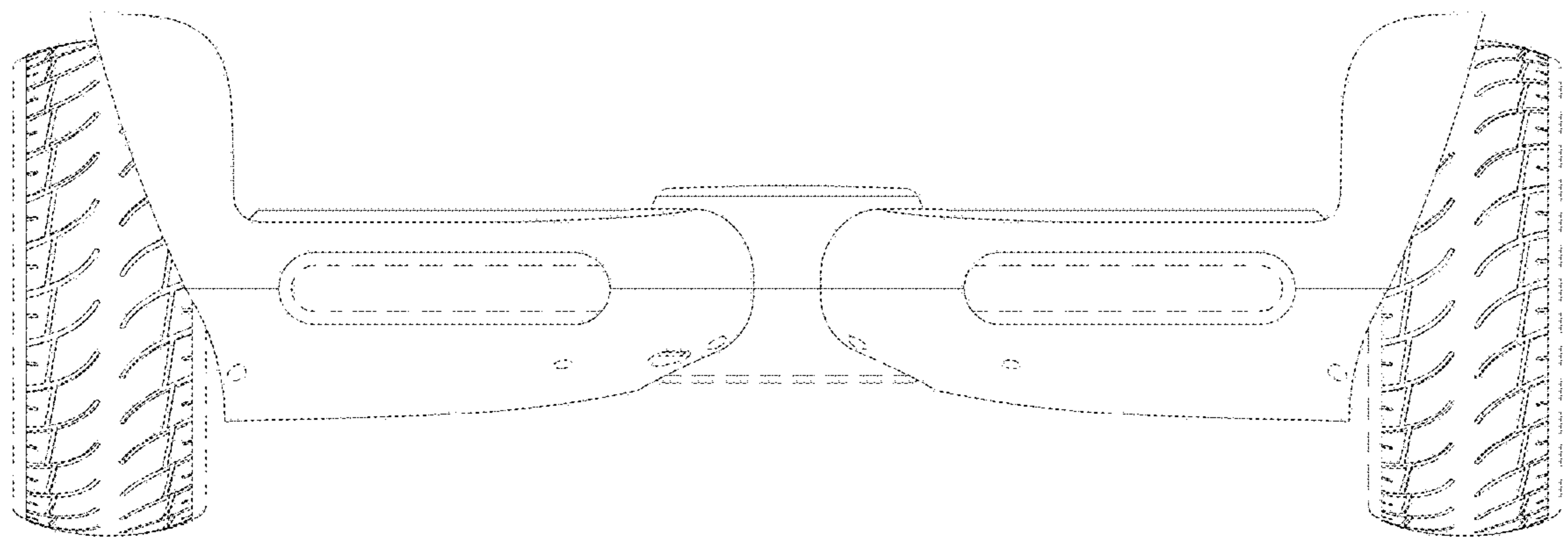

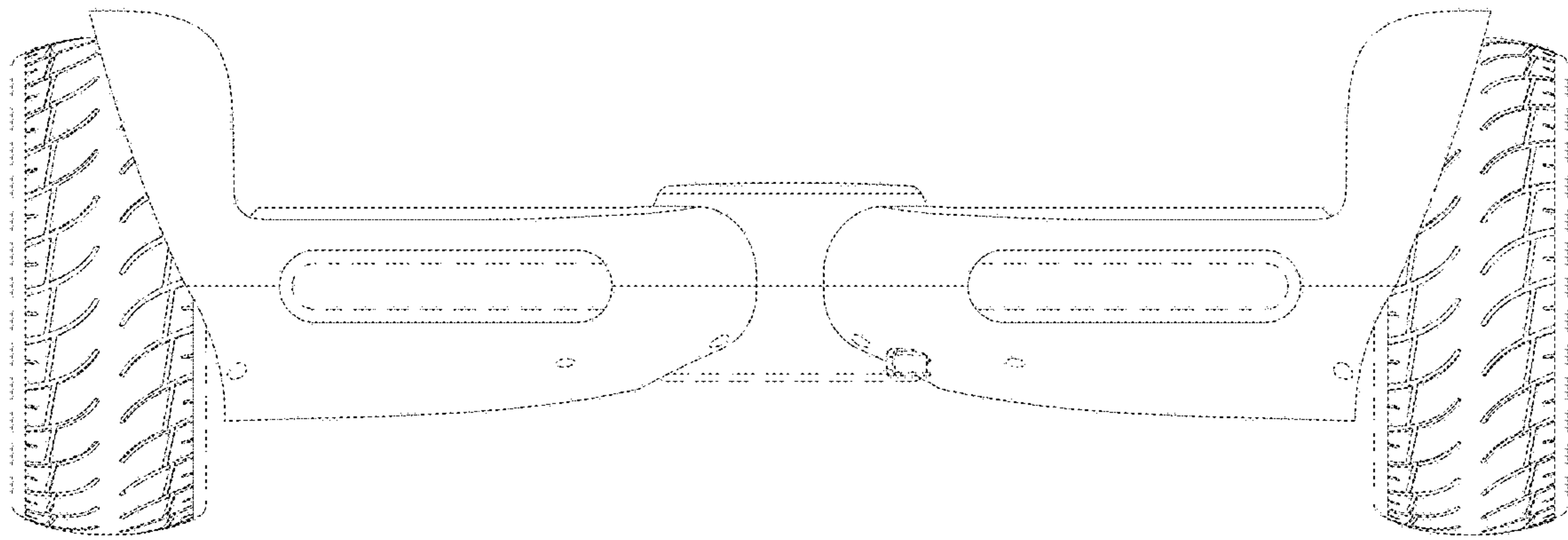
