DESCRIPTION

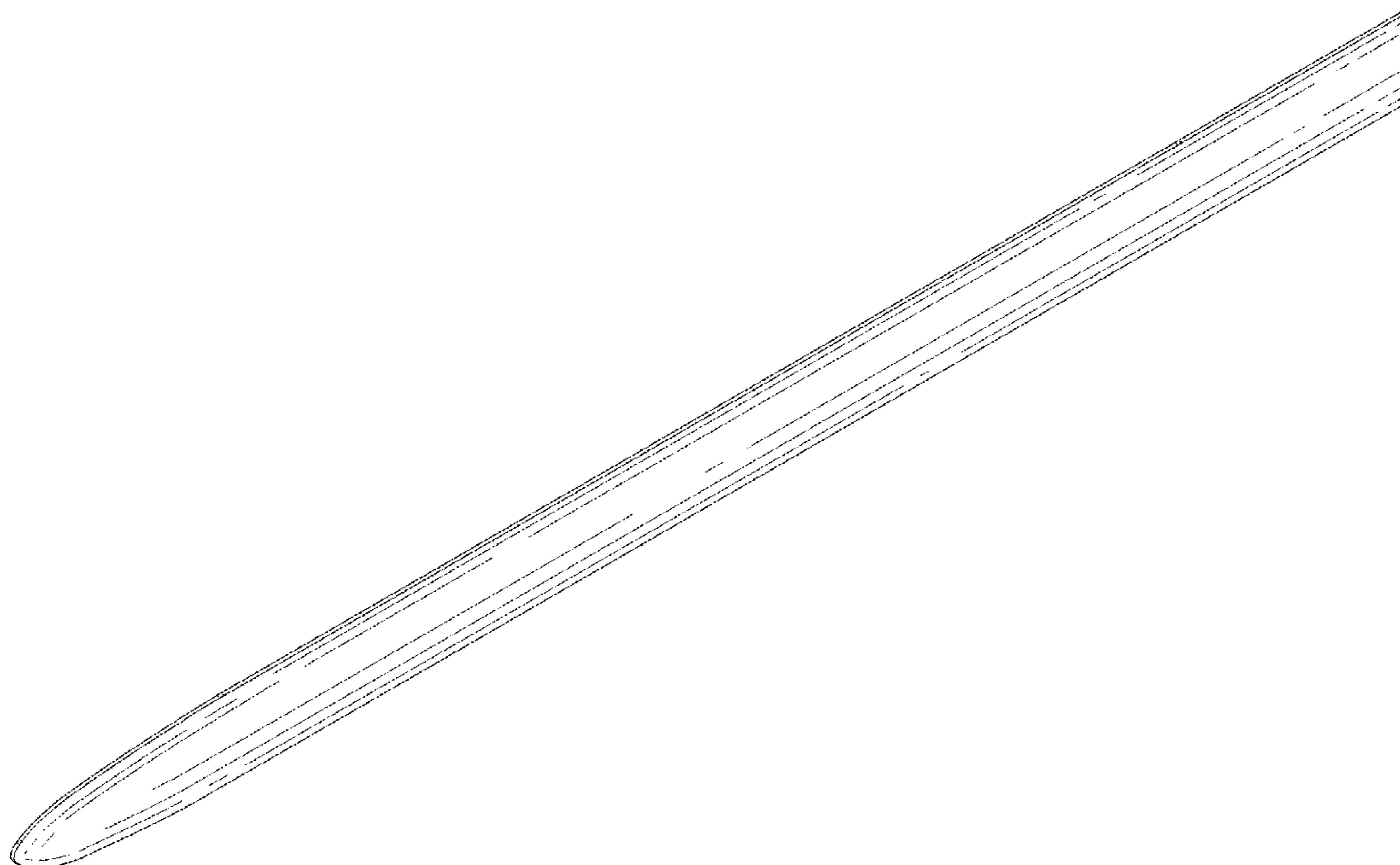
FIG. 1 is a front perspective view of an automobile door bumper showing my new design;

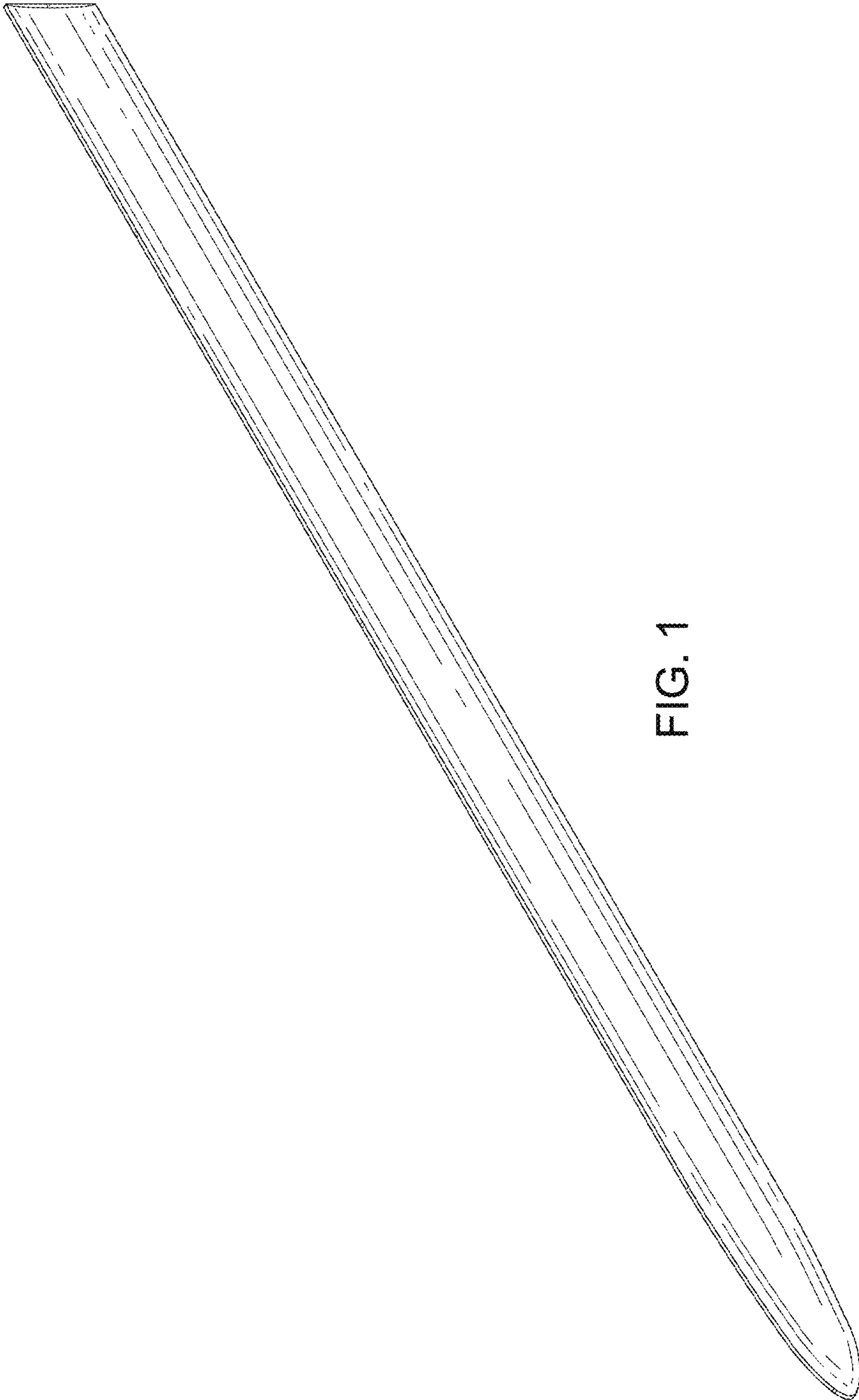

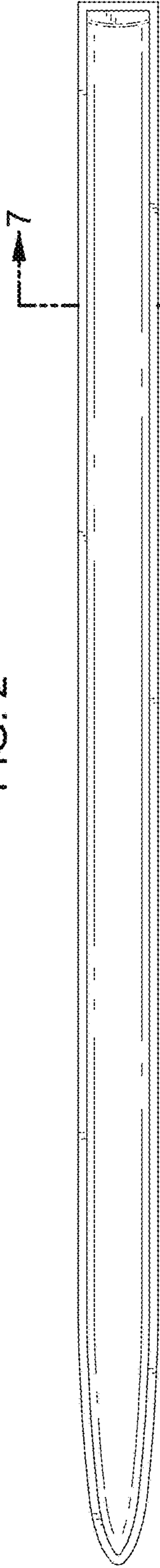

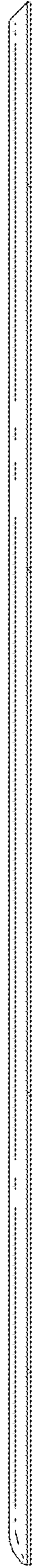

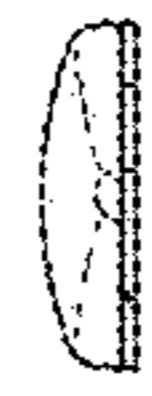

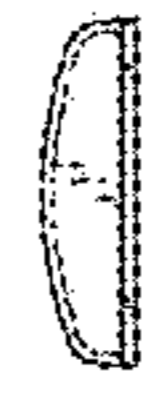

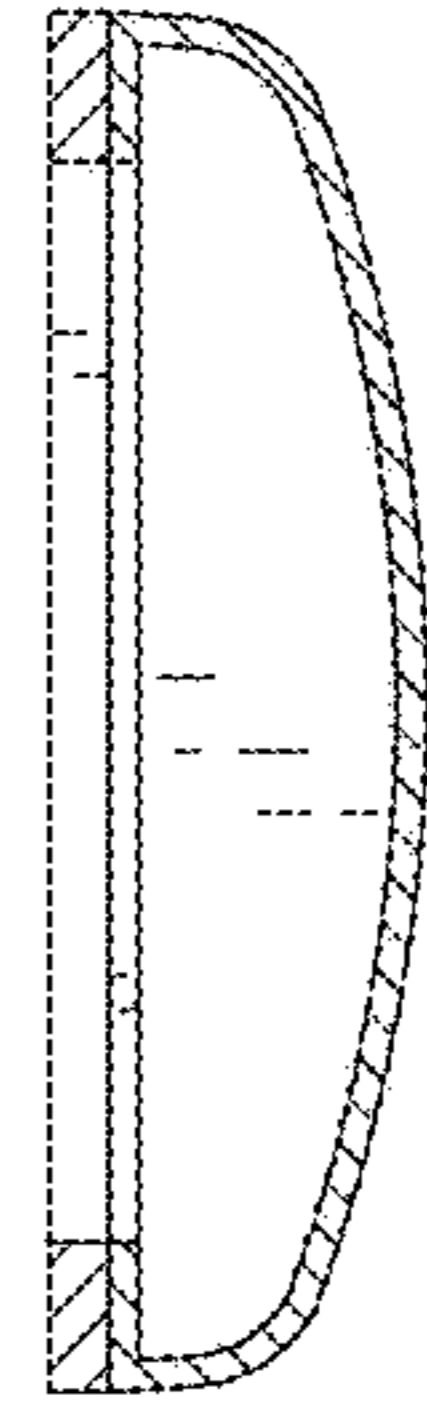

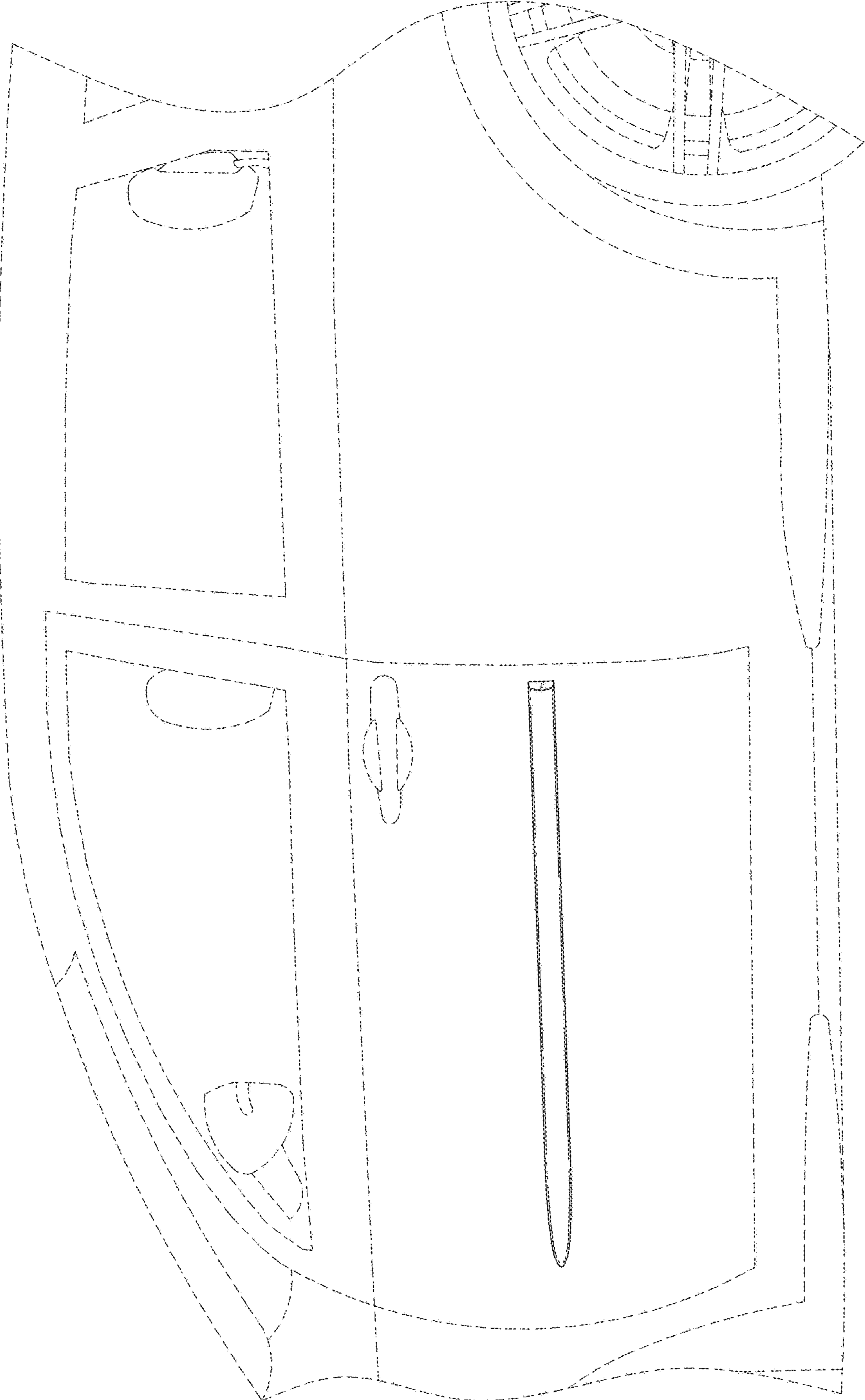
