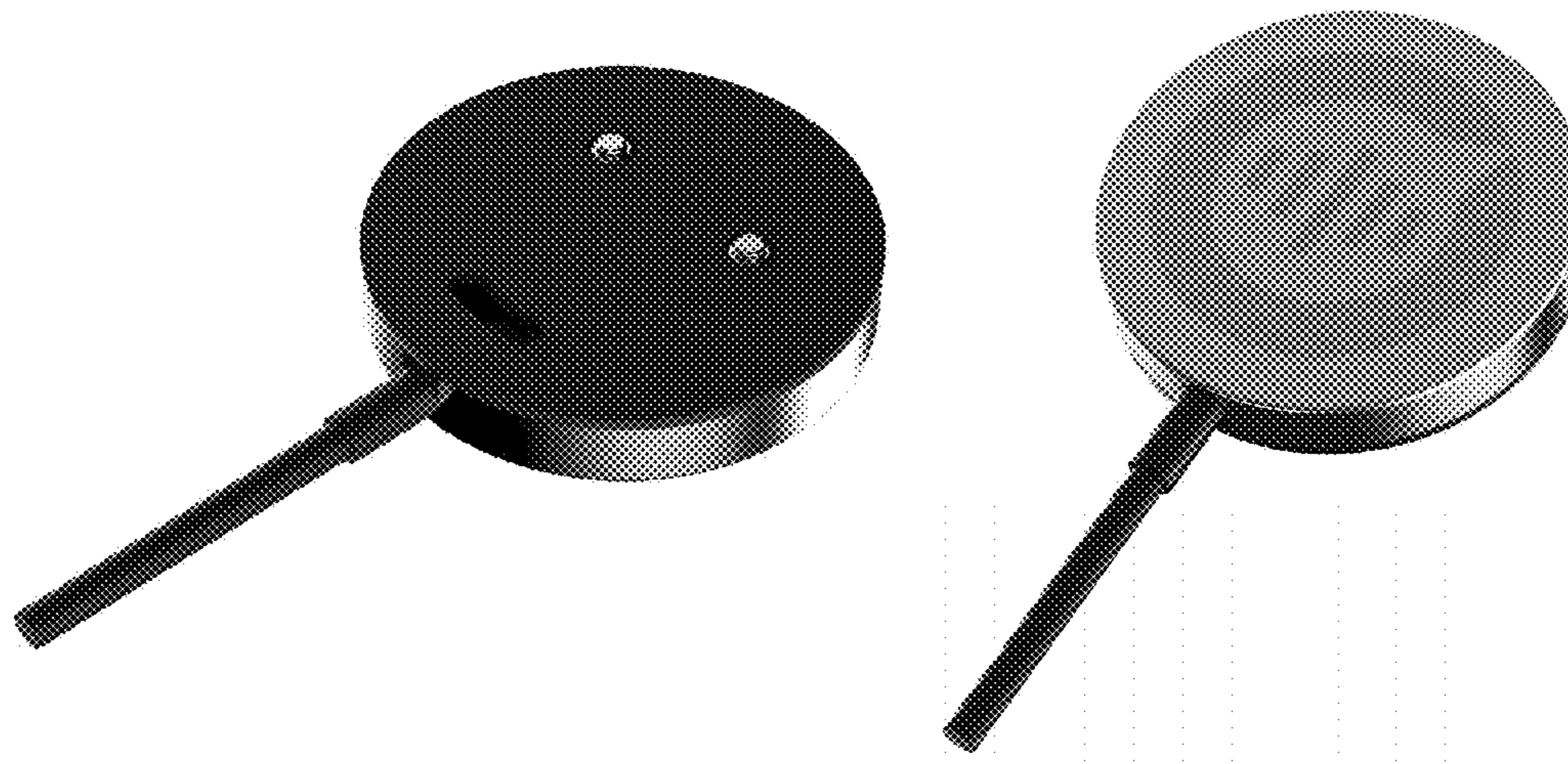
The ornamental design for a charging dock, as shown and described.

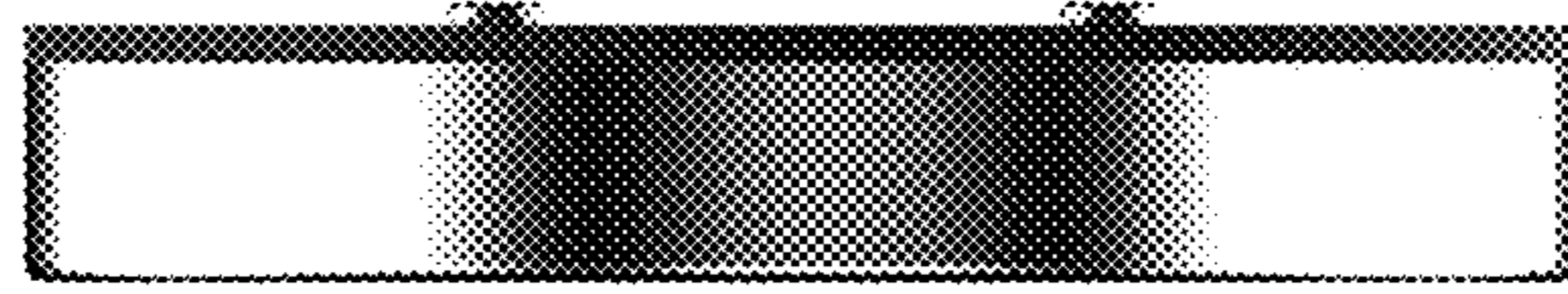

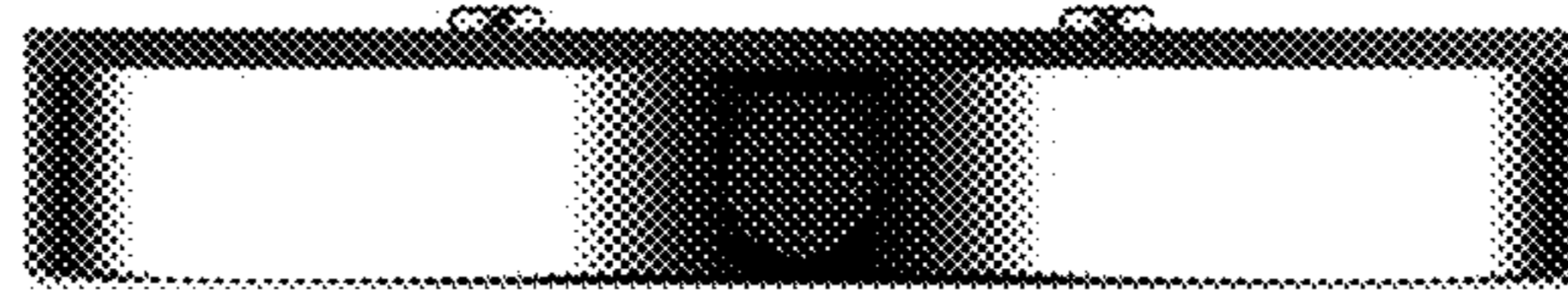

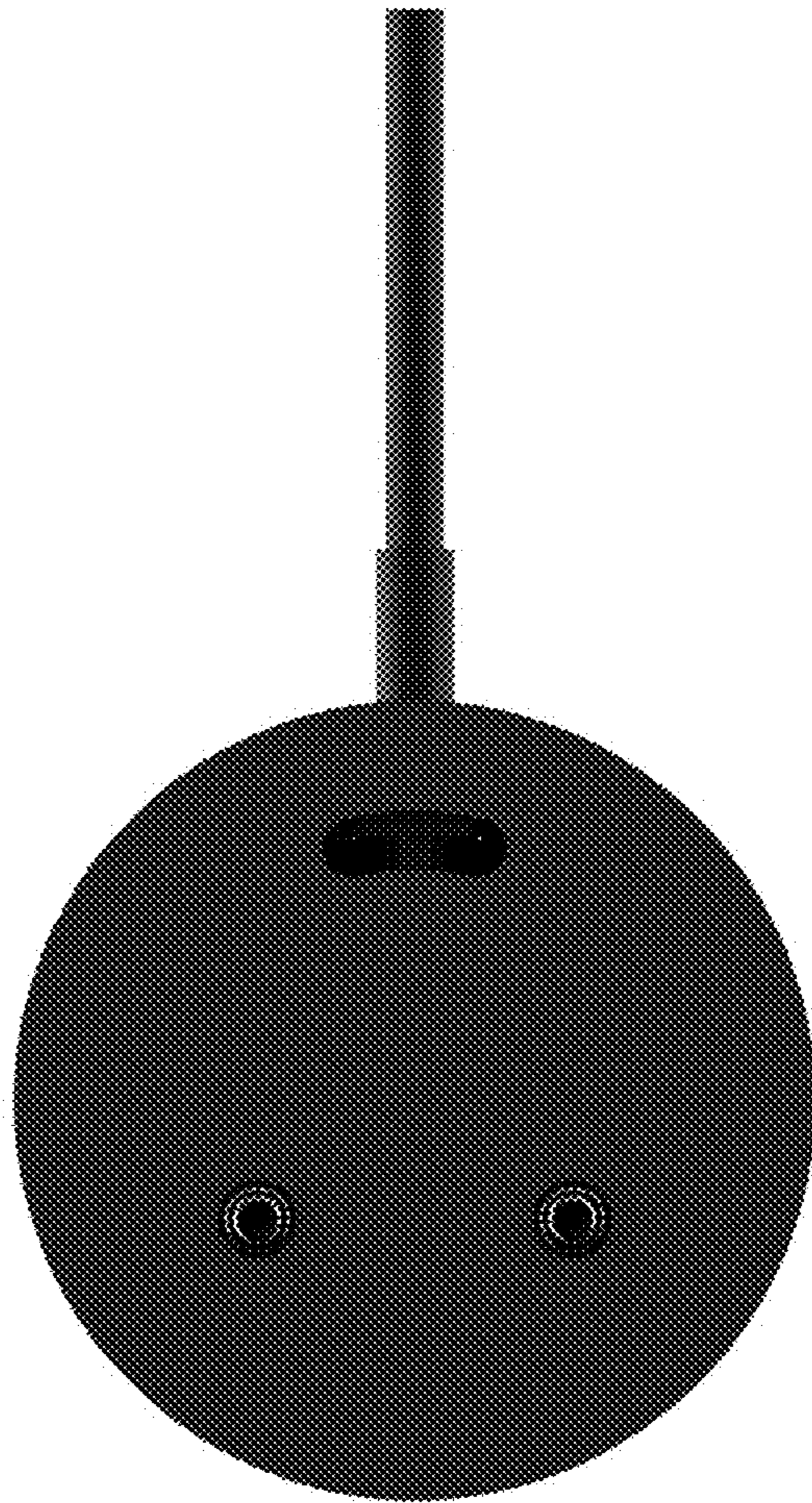

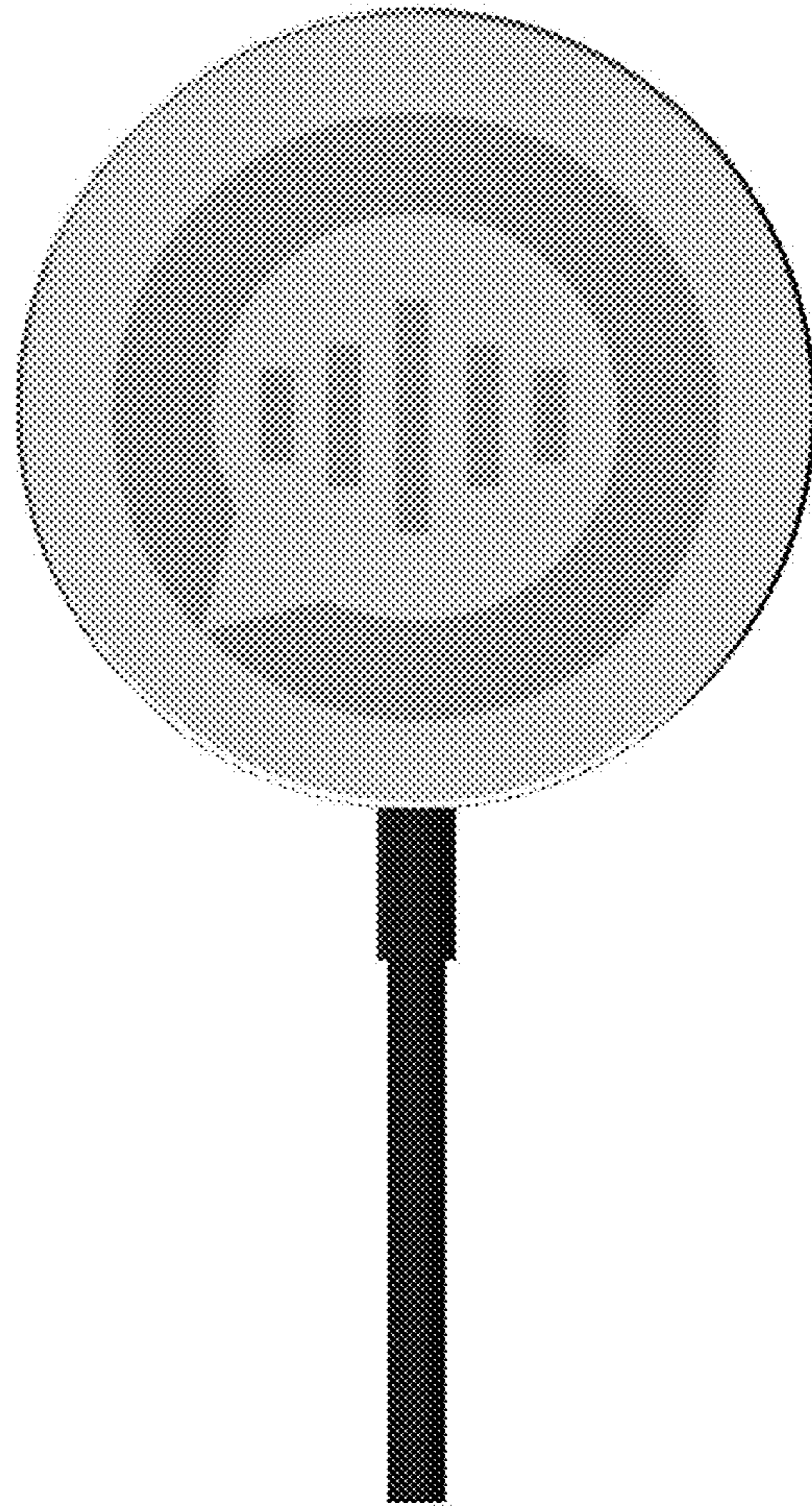

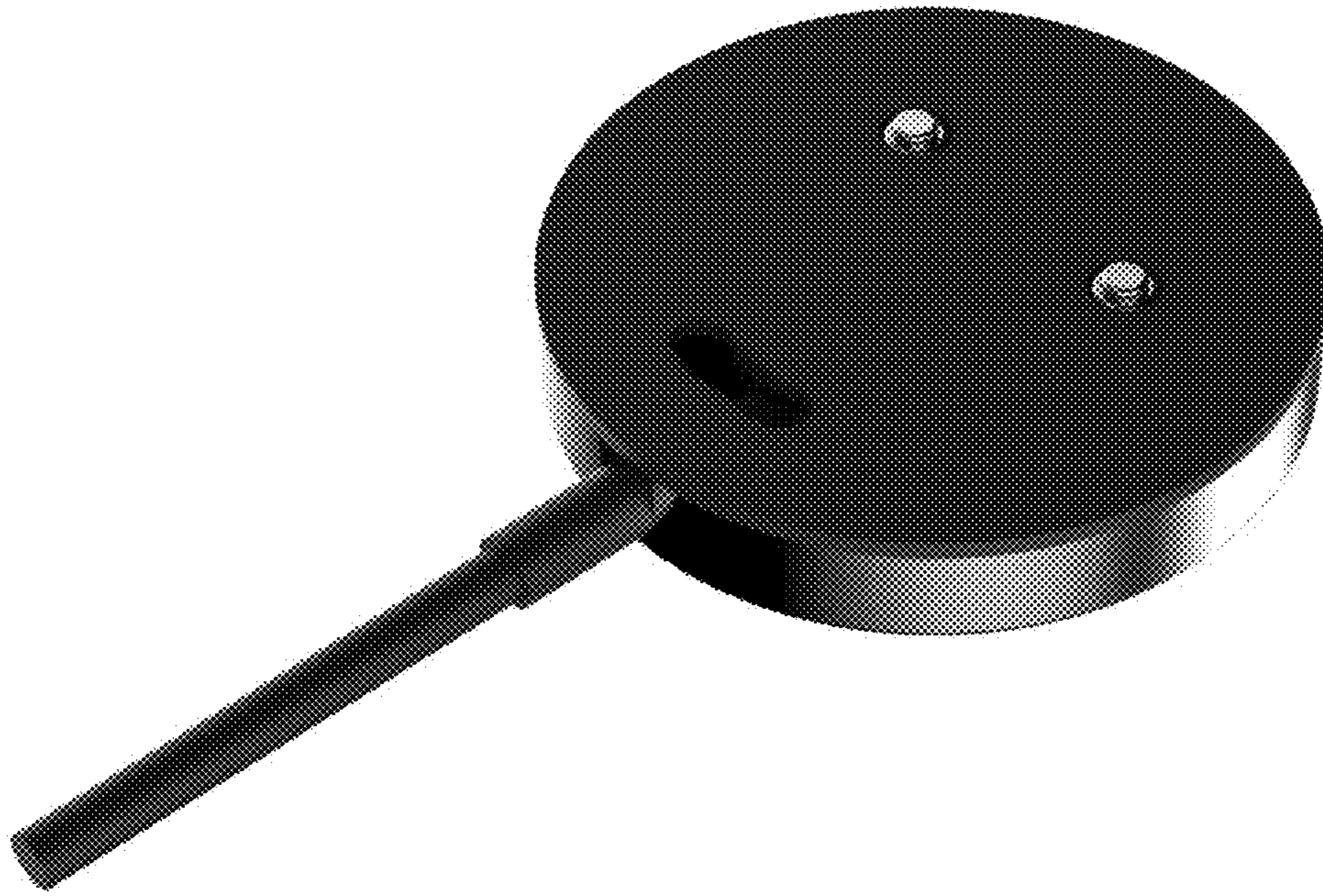
