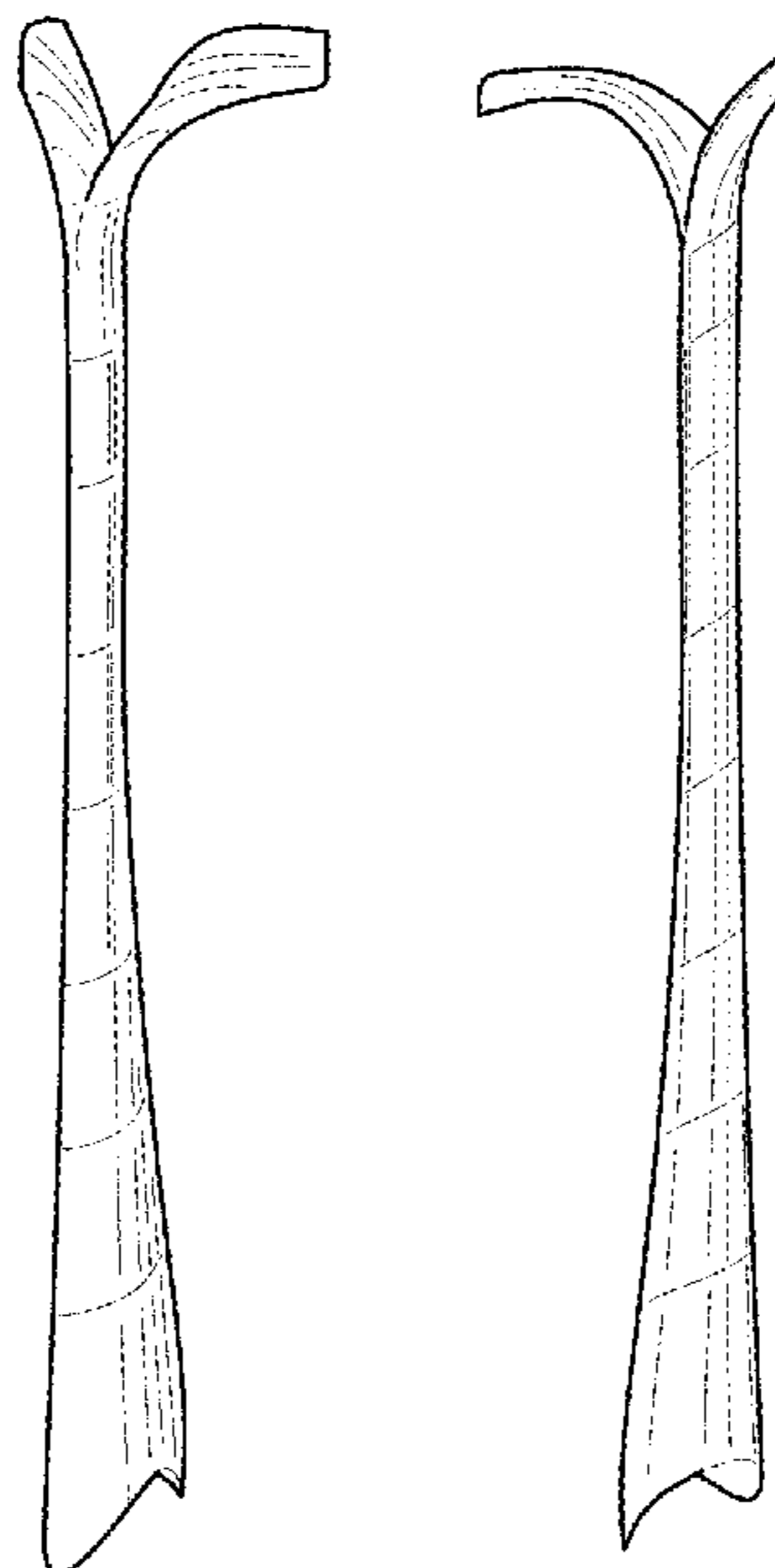
(57) **CLAIM**

The ornamental design for a fluid turbine mixing rotor blade, as shown and described.

**DESCRIPTION**

FIG. 1 is a front right side perspective view of a fluid turbine mixing rotor blade, showing my new design;

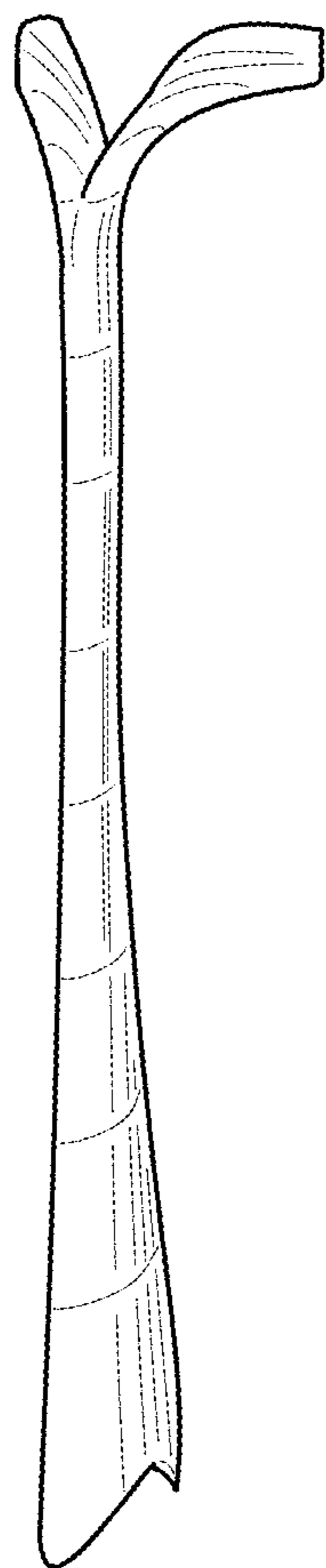

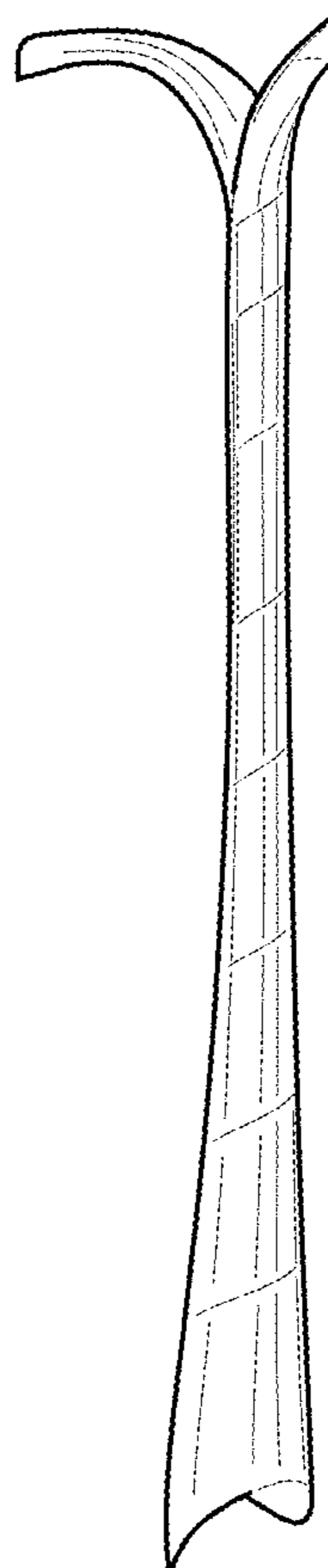

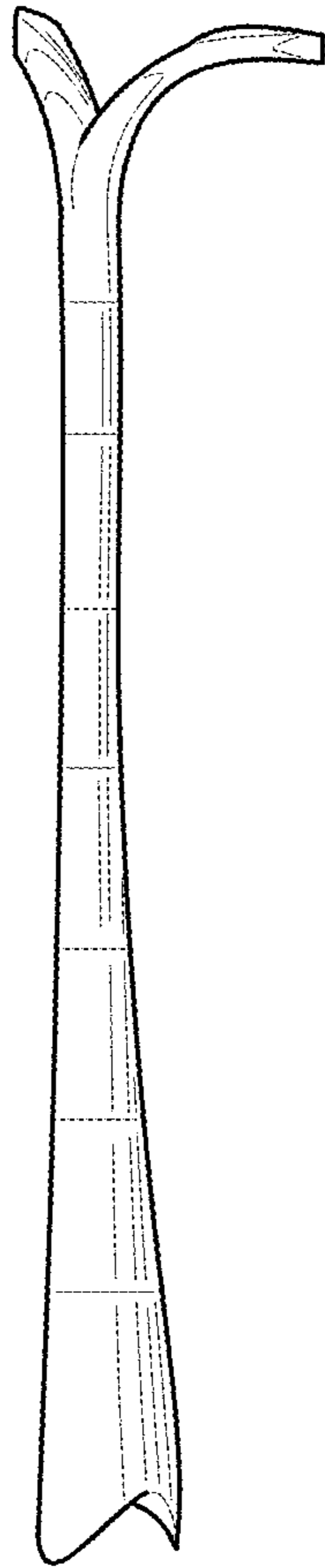

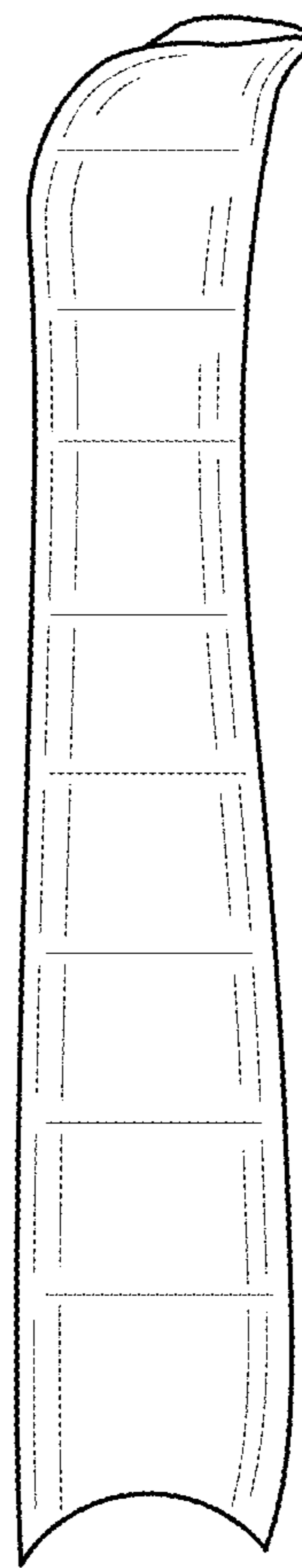

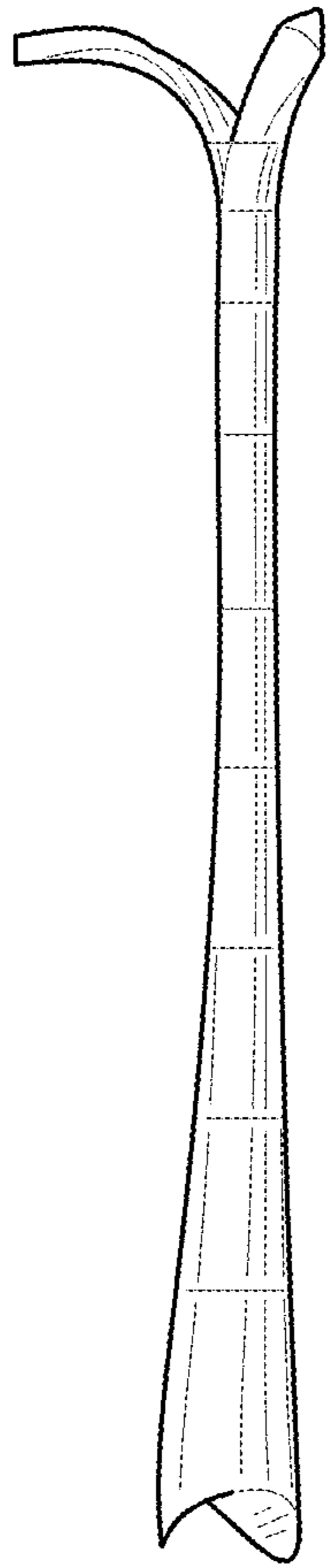

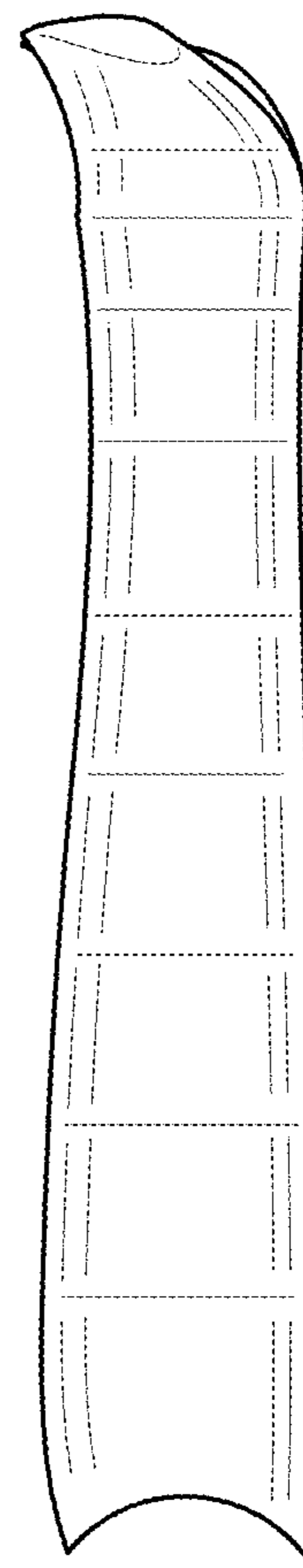

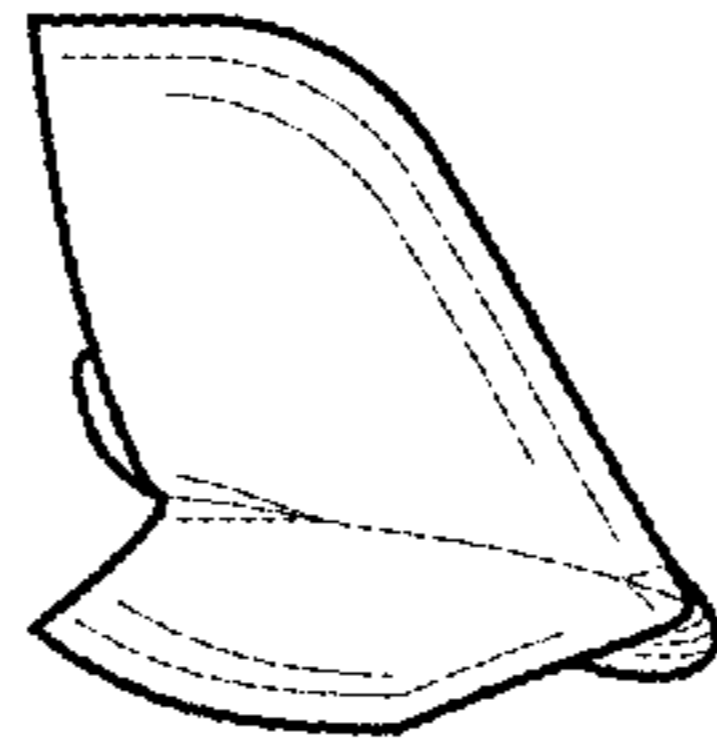

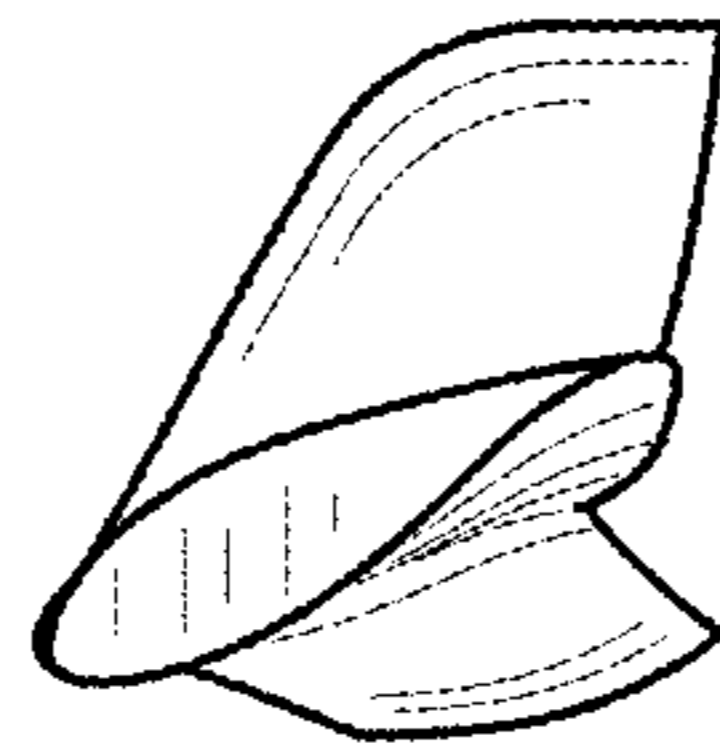
