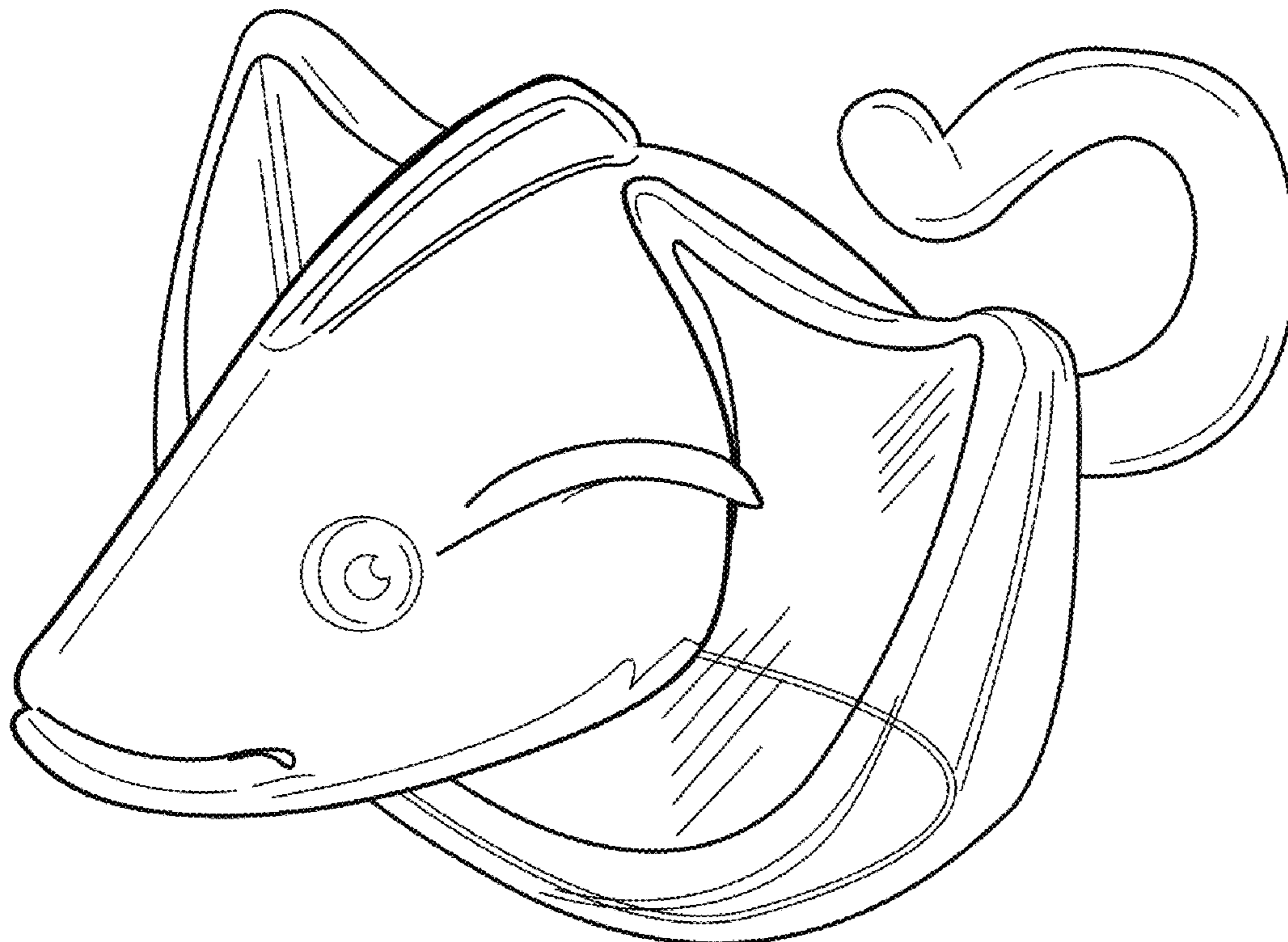
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a fish hook protector;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a bottom view thereof;
 FIG. 4 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a bottom isometric view thereof;
 FIG. 7 is a front isometric view thereof; and,
 FIG. 8 is a bottom isometric view thereof, showing my design in use.

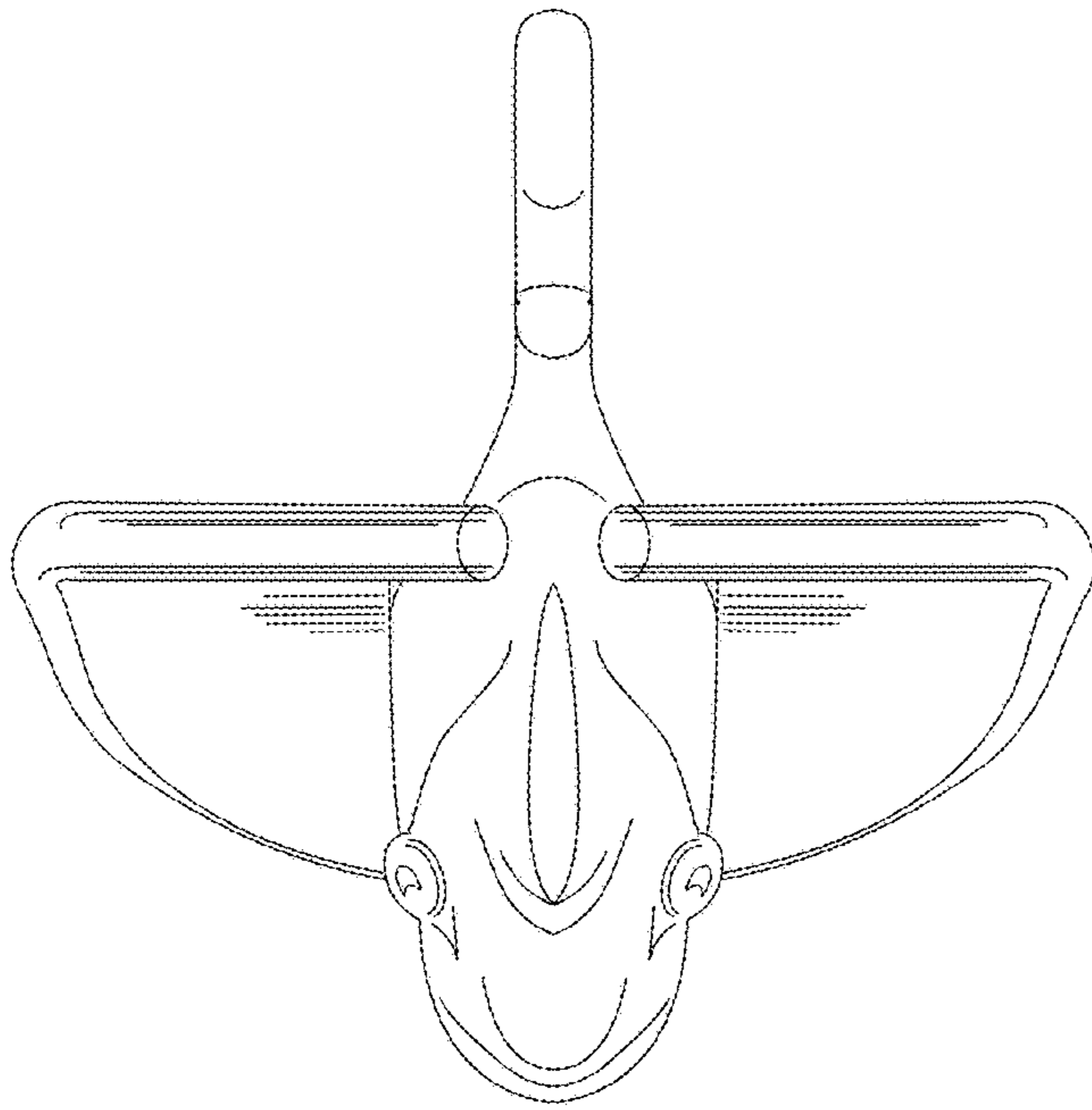

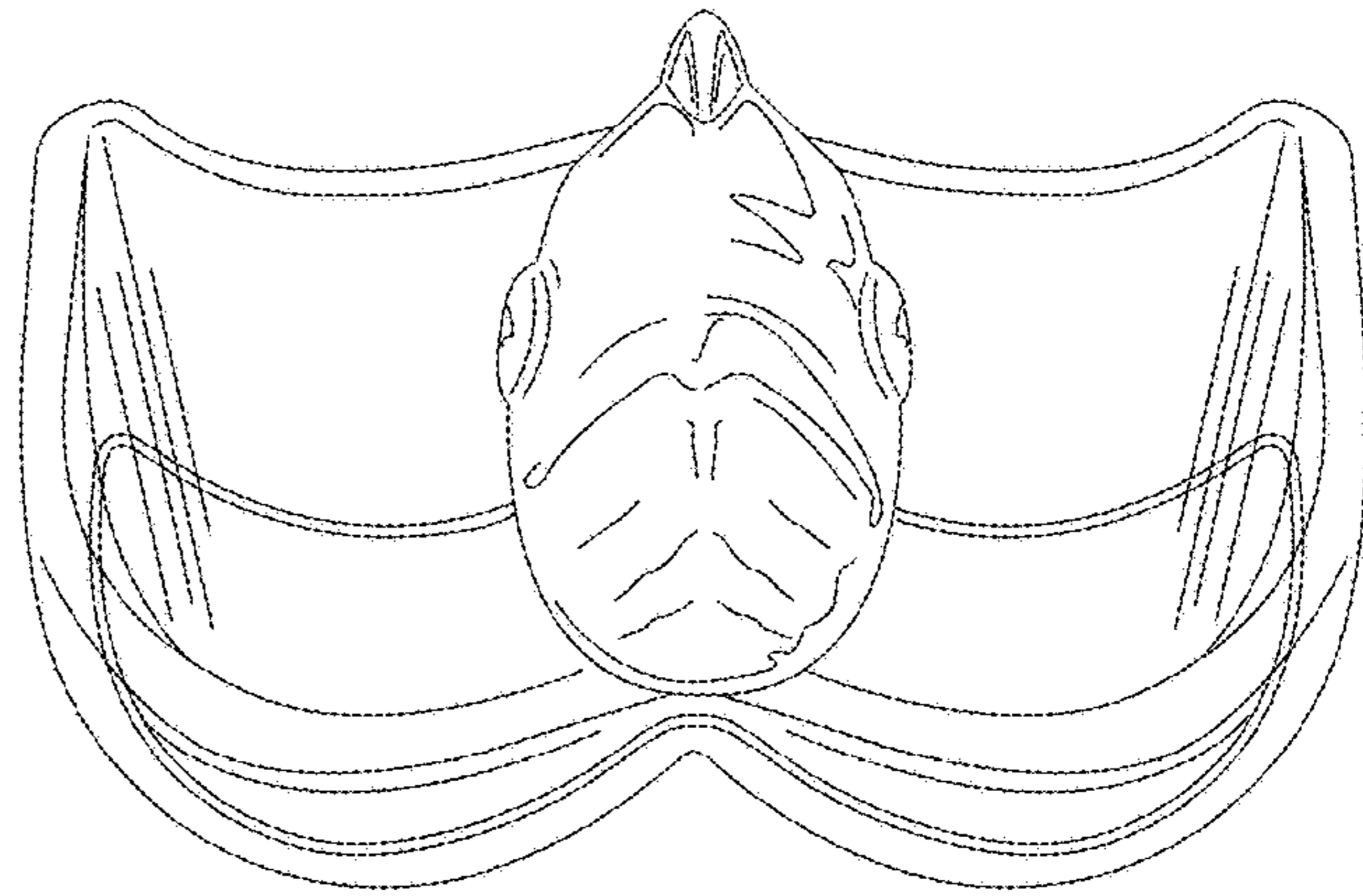

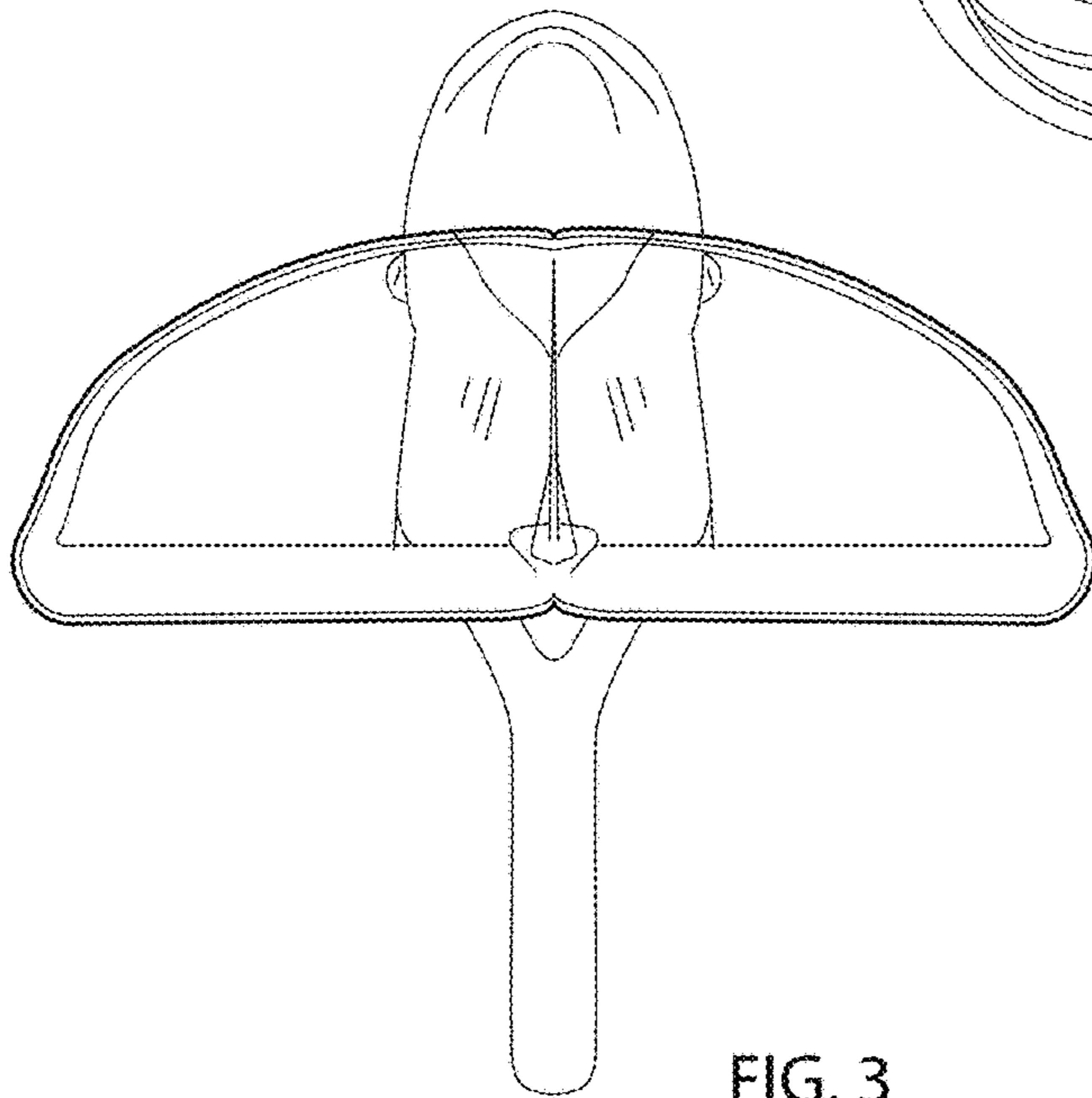

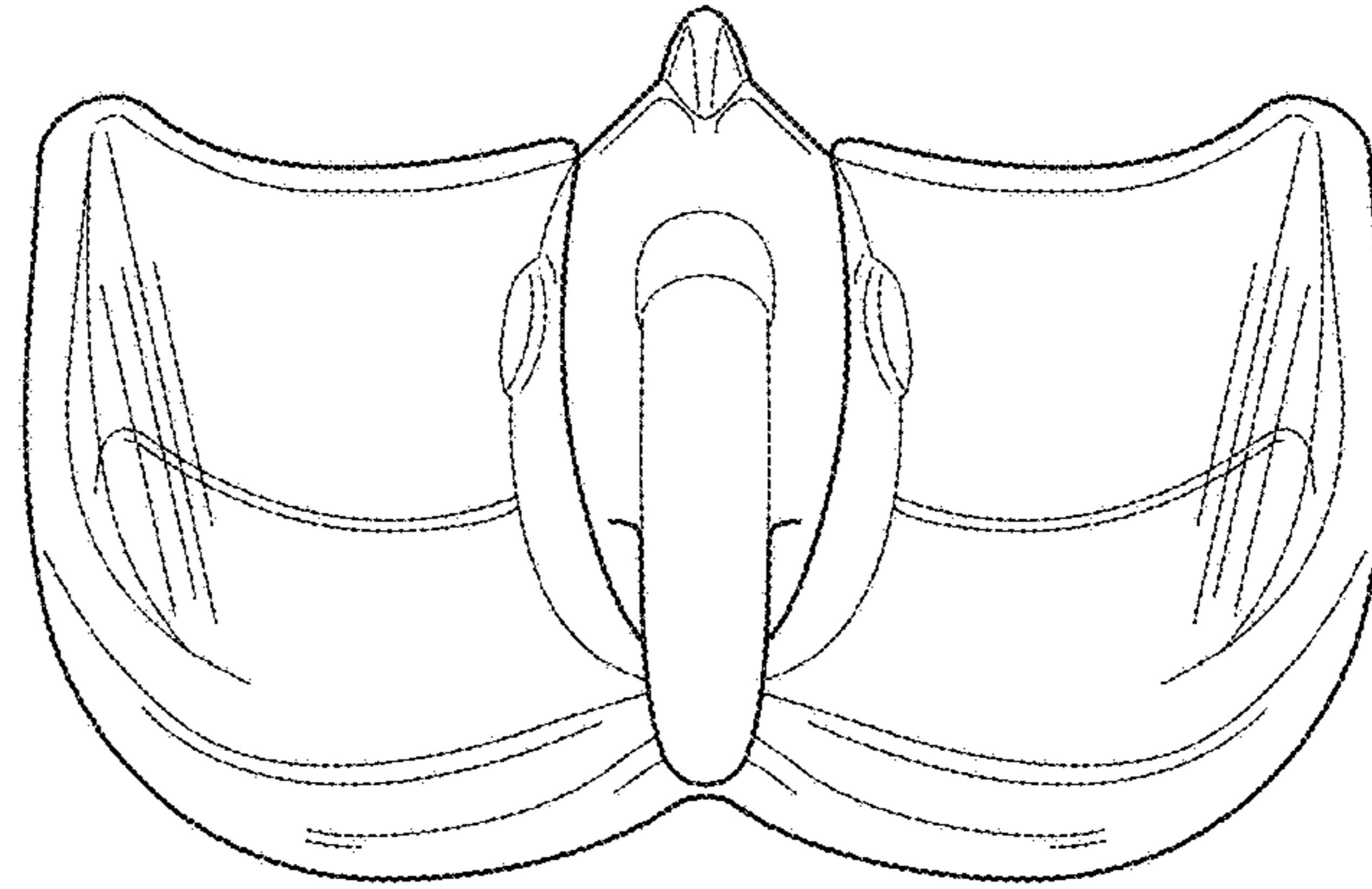

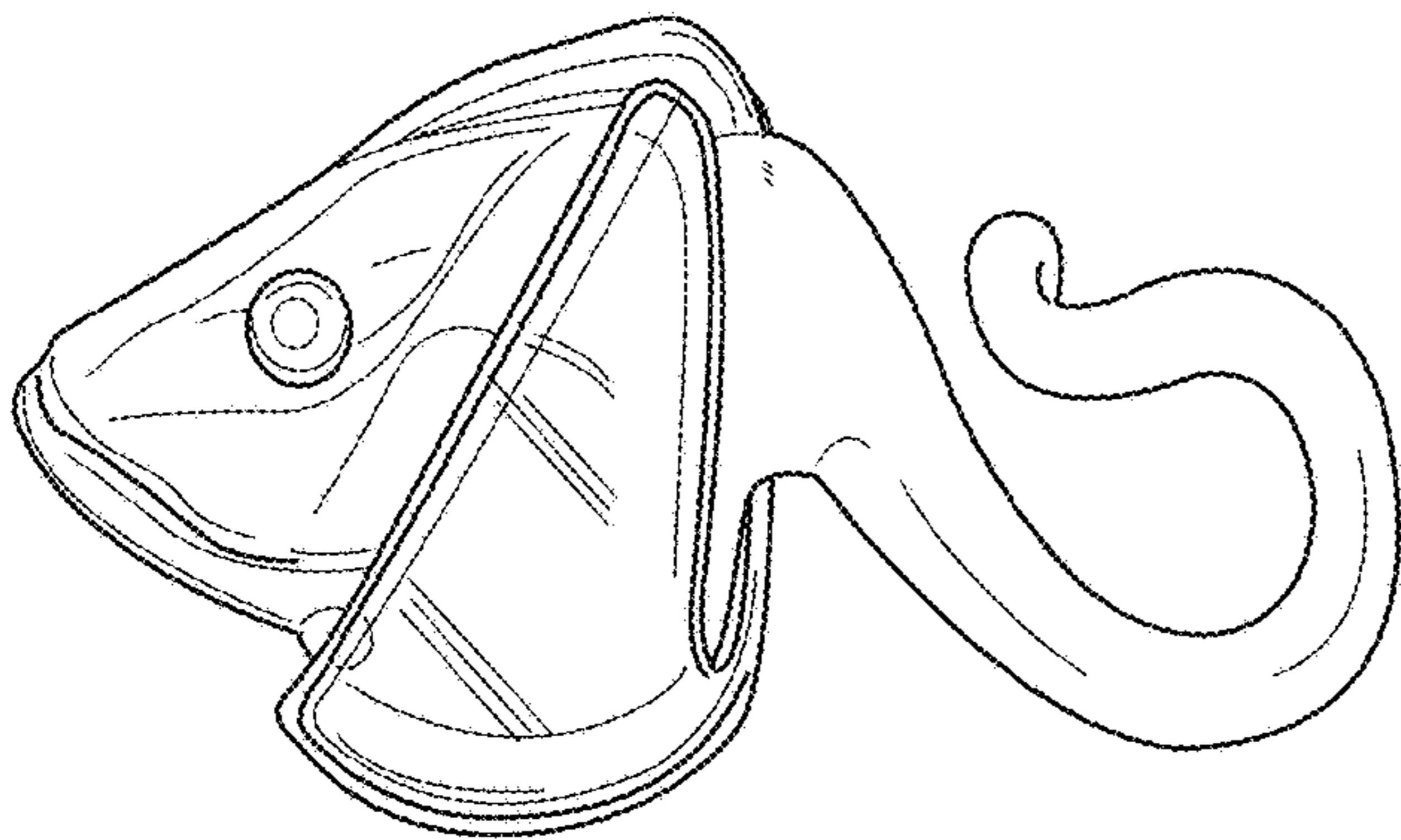

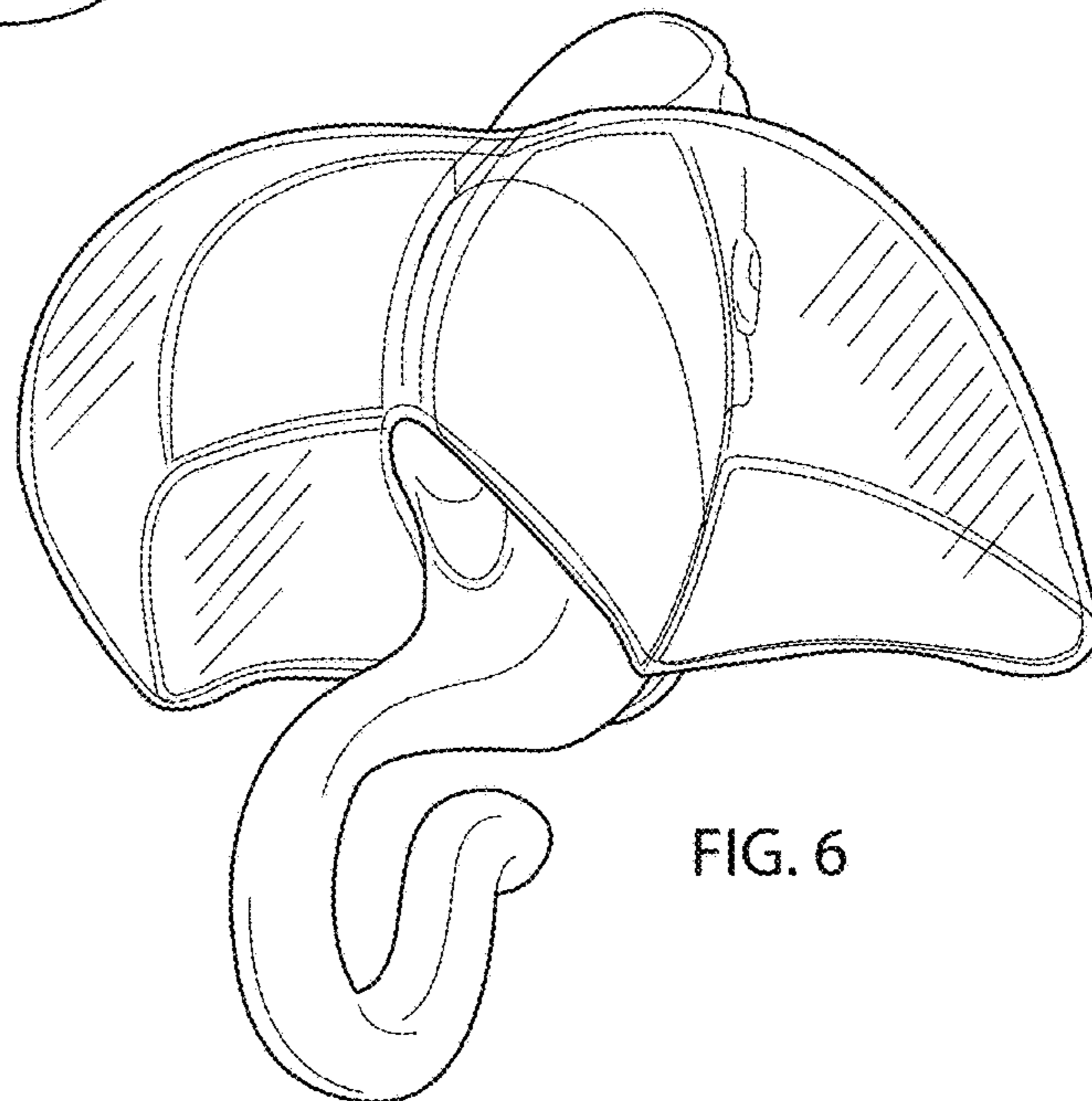

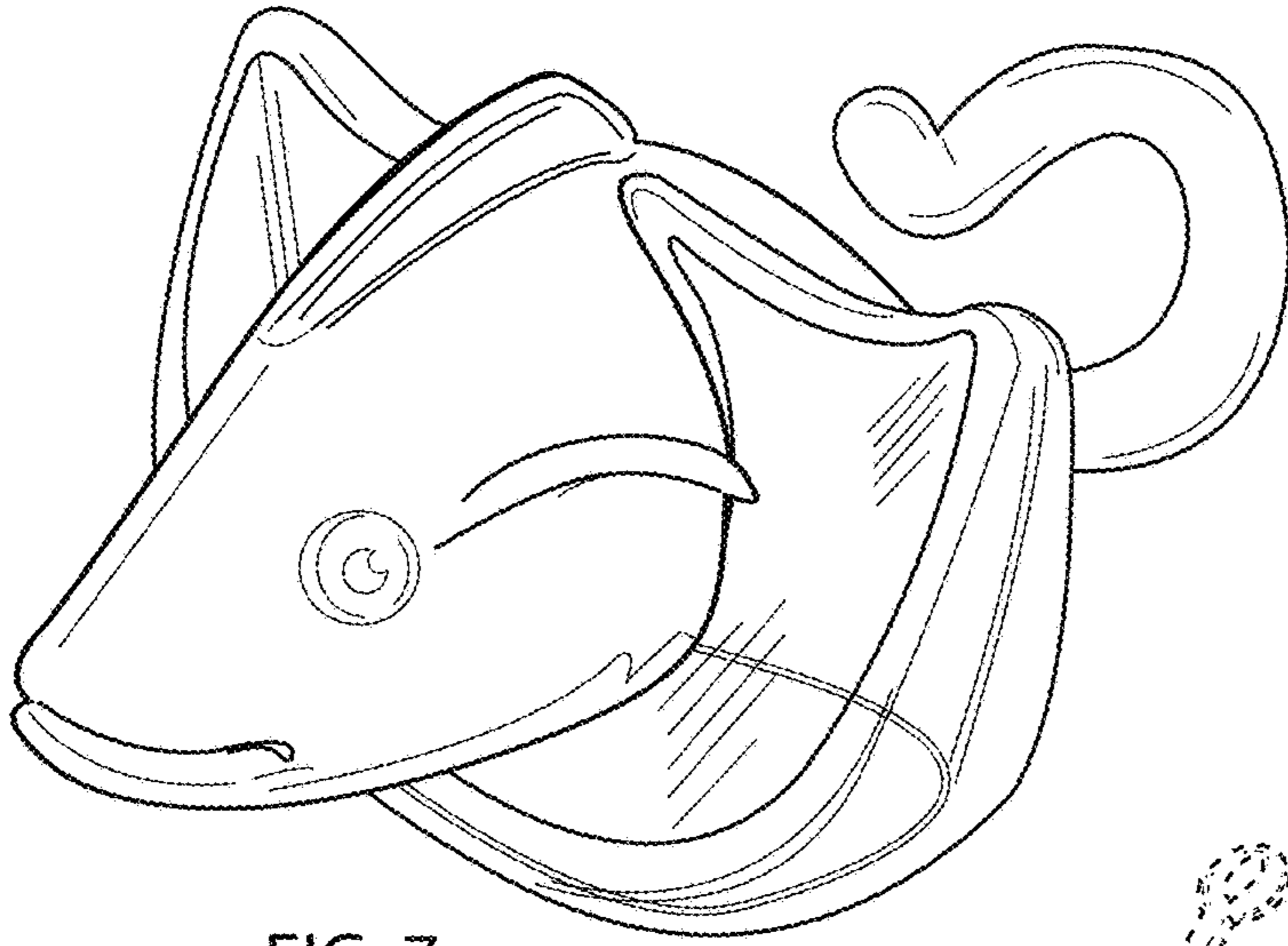

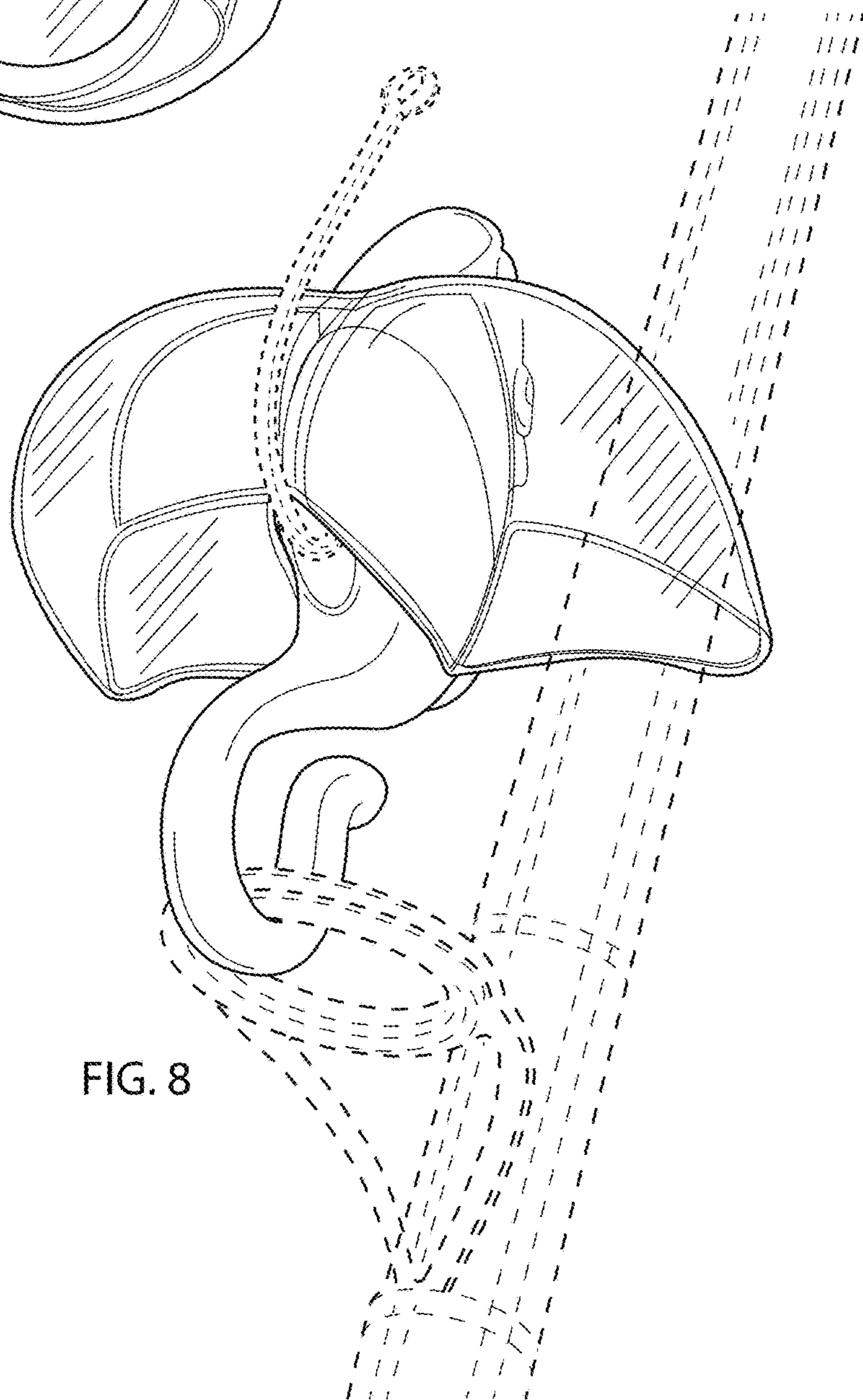
