(57) **CLAIM**

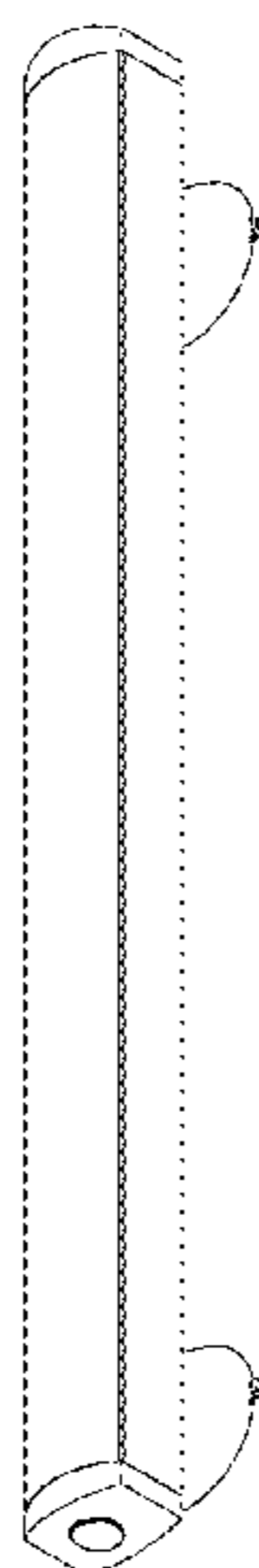
The ornamental design for a makeup light bar, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and right-side perspective view of a makeup light bar embodying my new design;

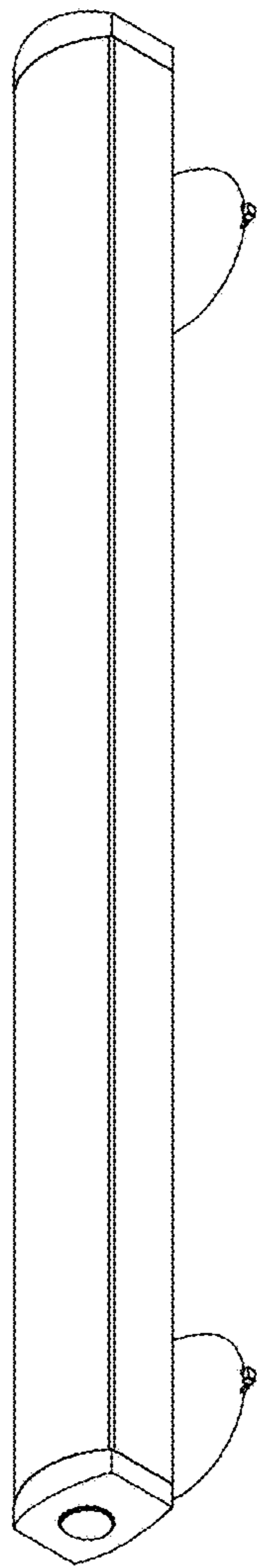

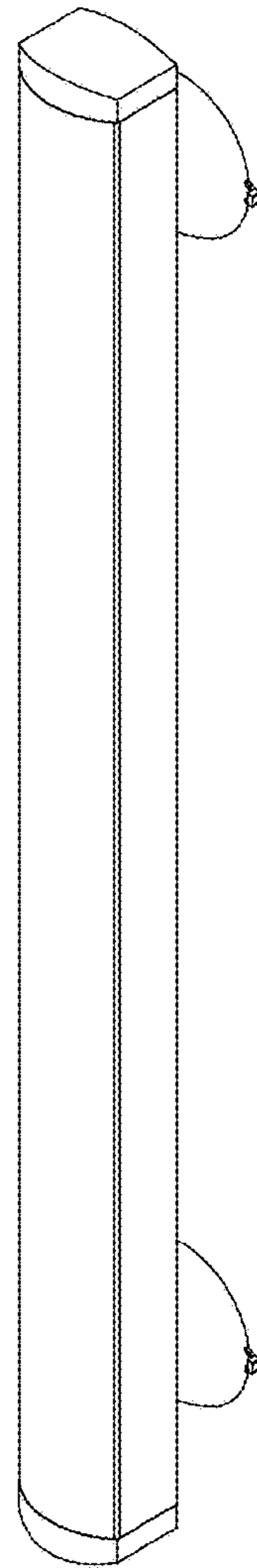

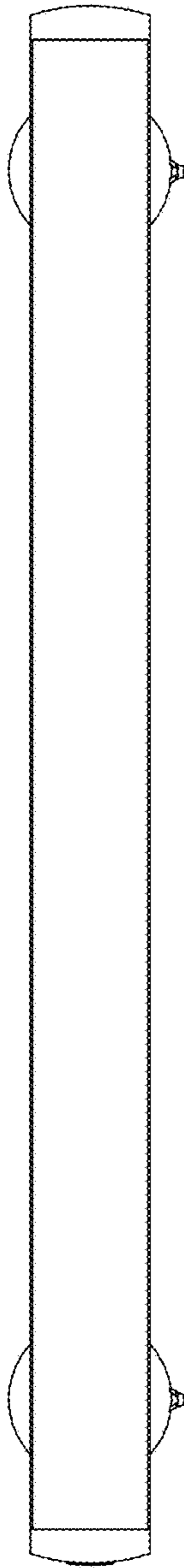

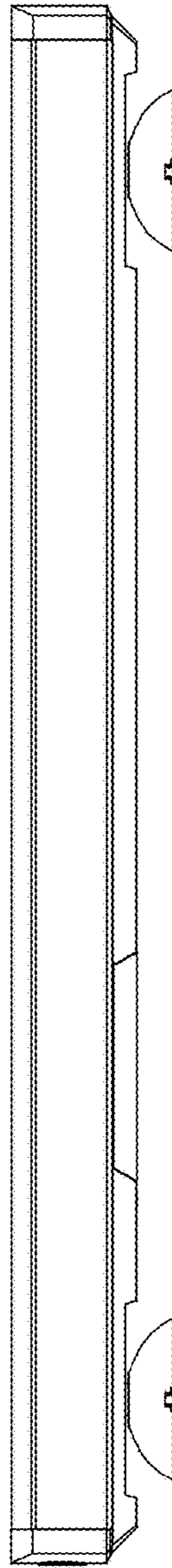

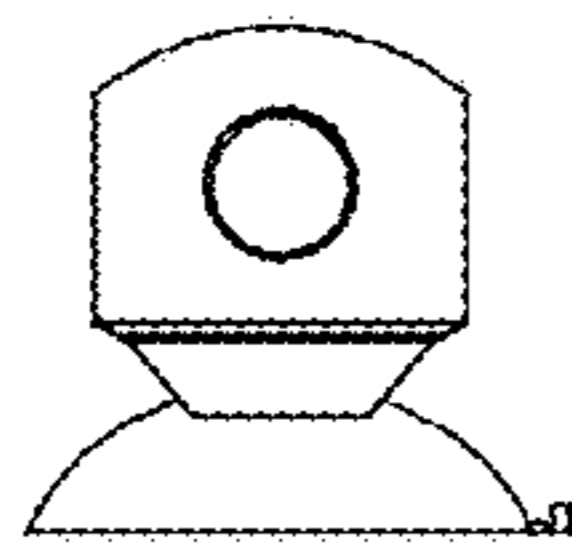

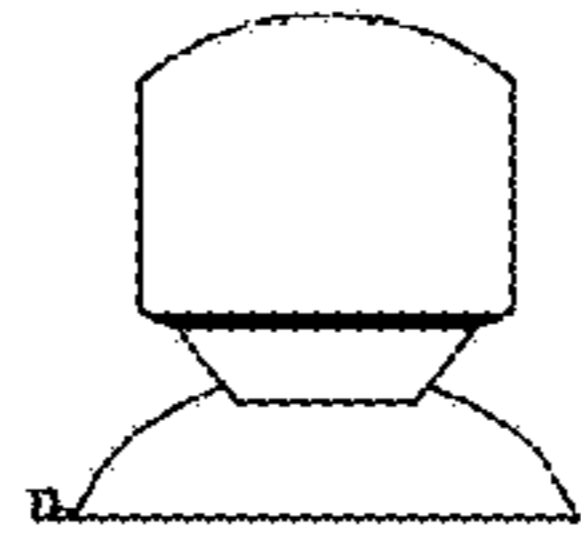

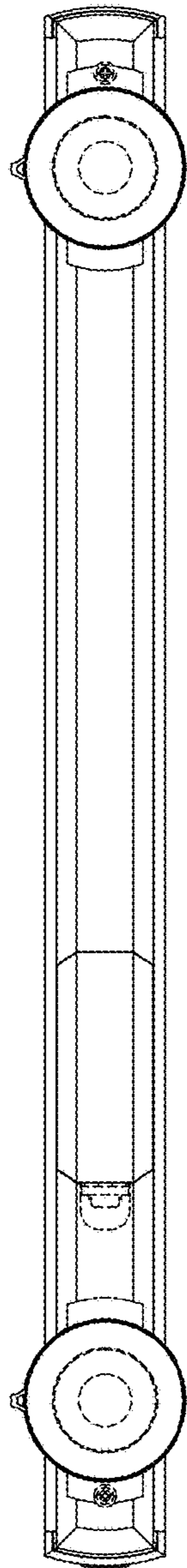
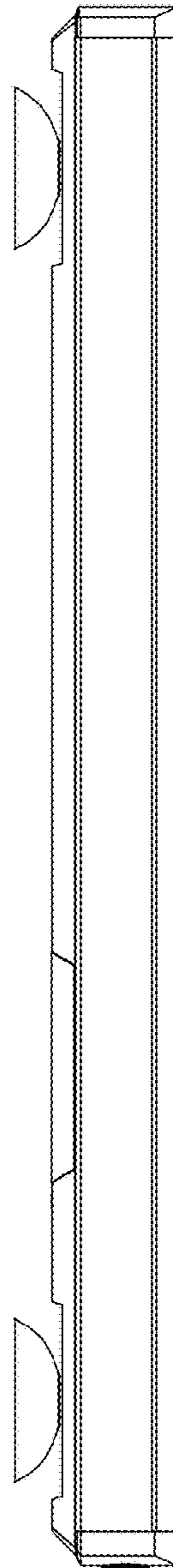

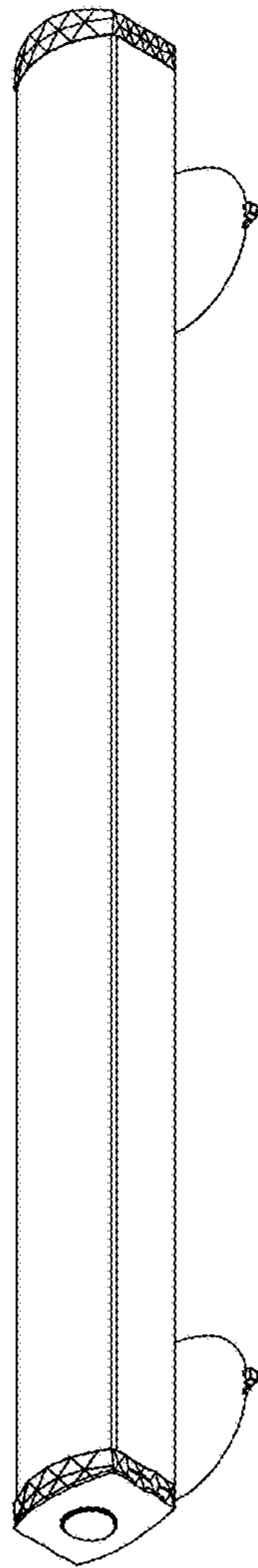

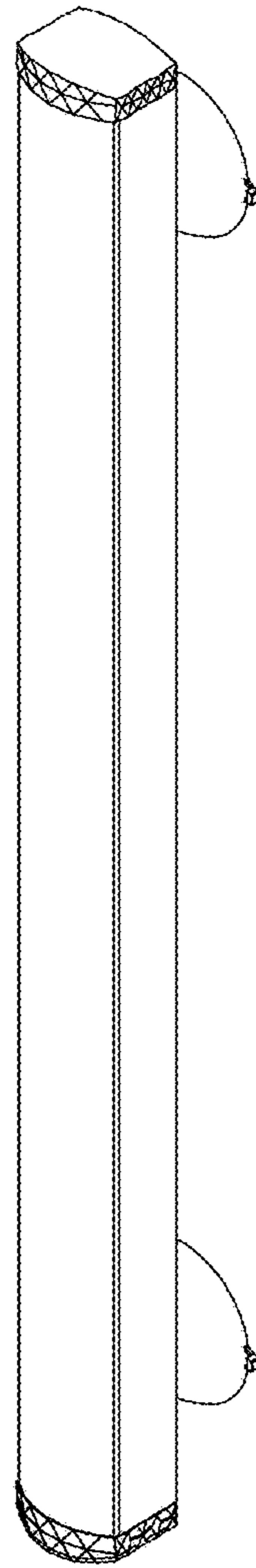

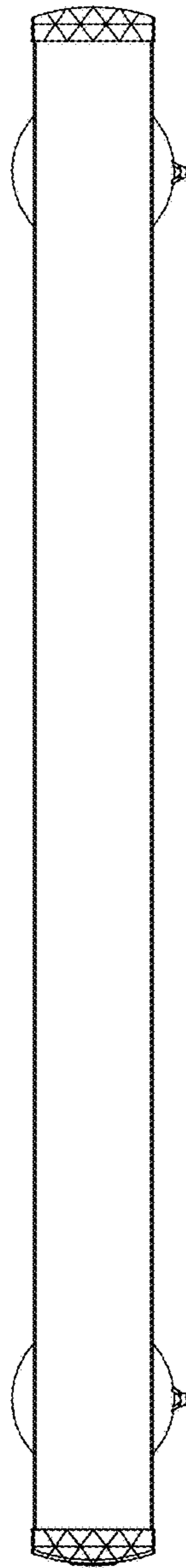

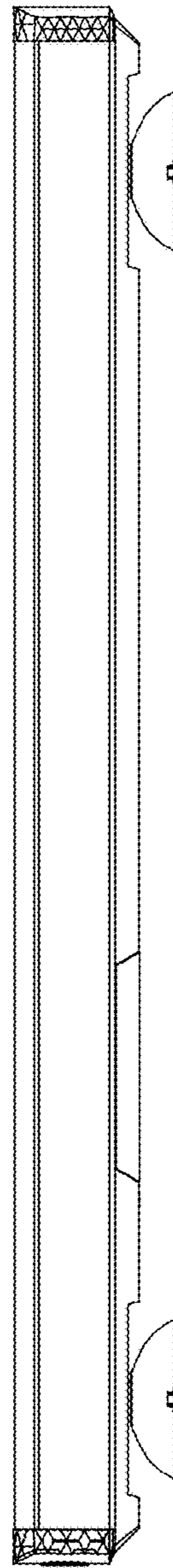

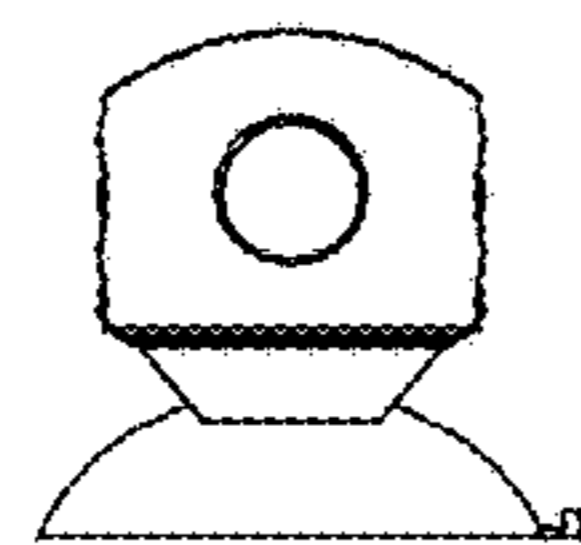

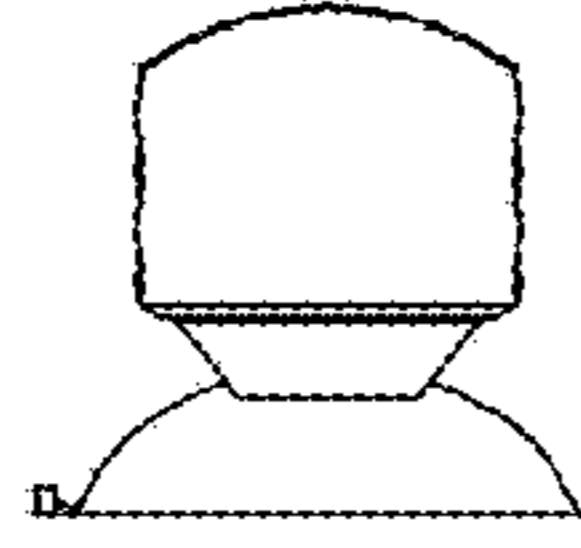

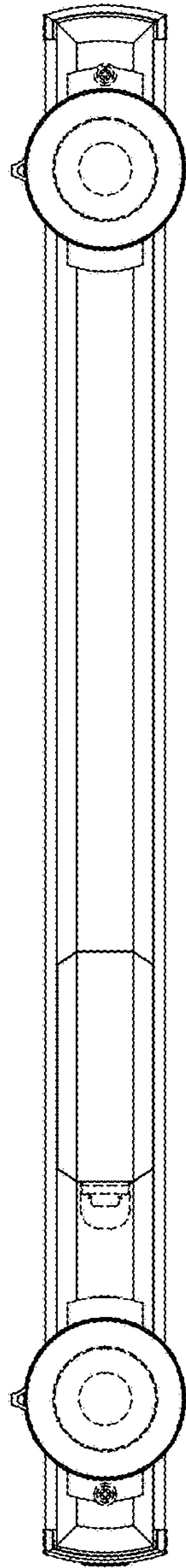
