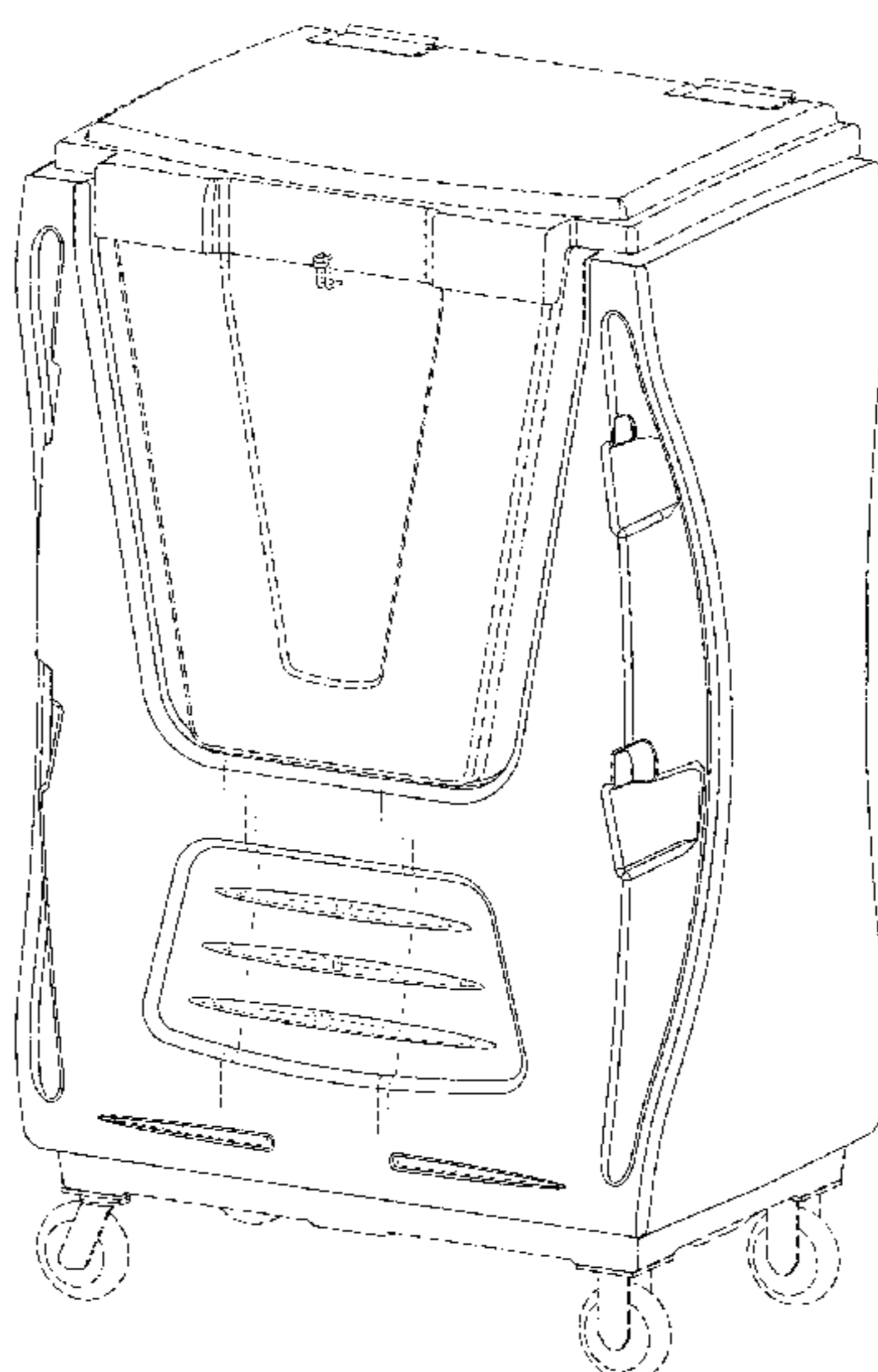
(57) **CLAIM**

The ornamental design for a linen truck, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a linen truck showing our new design;
FIG. 2 is a front view of the linen truck of FIG. 1;
FIG. 3 is a back view of the linen truck of FIG. 1;
FIG. 4 is a top view of the linen truck of FIG. 1;
FIG. 5 is a bottom view of the linen truck of FIG. 1; and,
FIG. 6 is a right side view of the linen truck of FIG. 1, the left side being a mirror image thereof.
The broken lines in the figures represent portions of the linen truck that form no part of the claimed design.

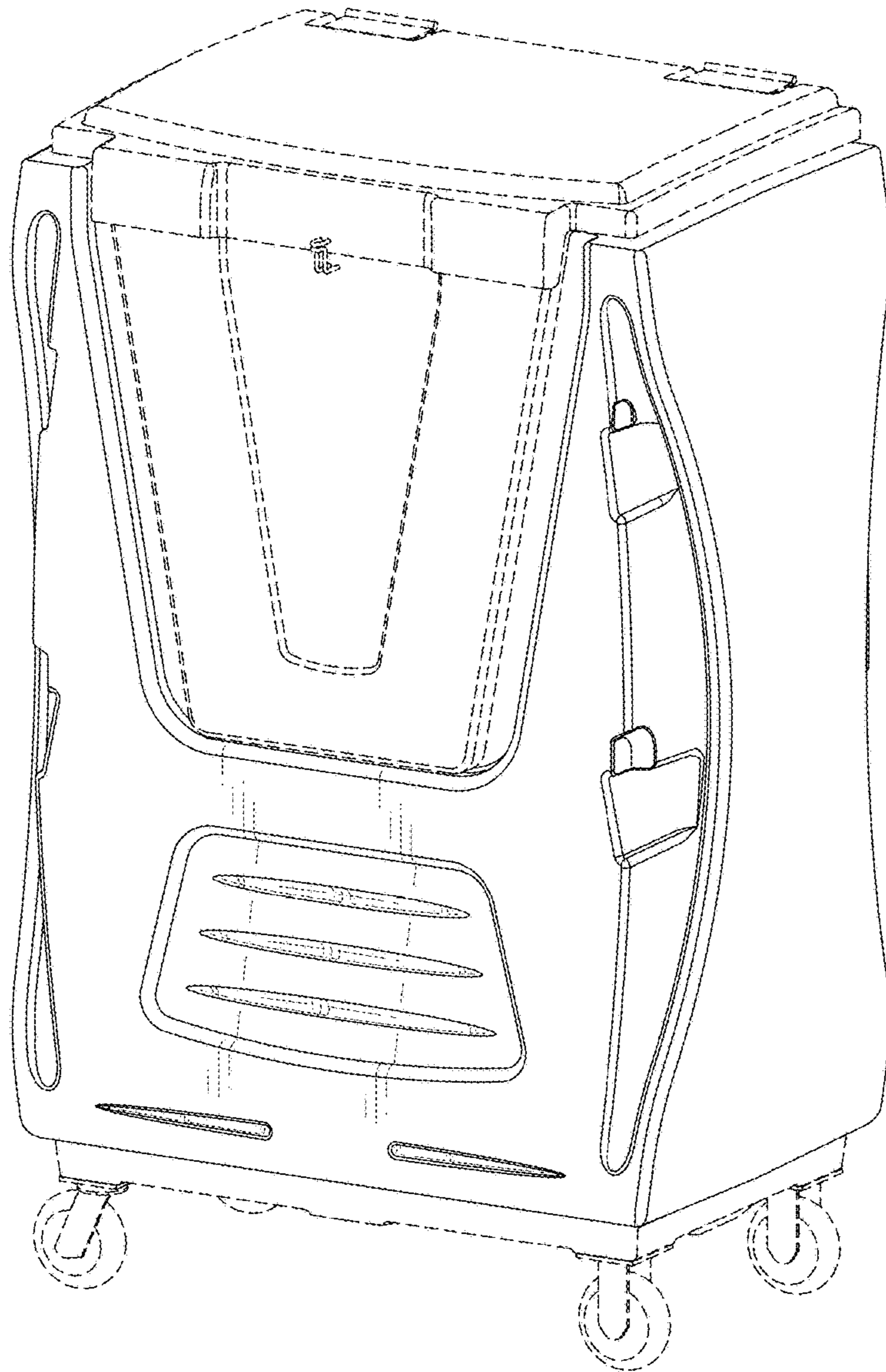

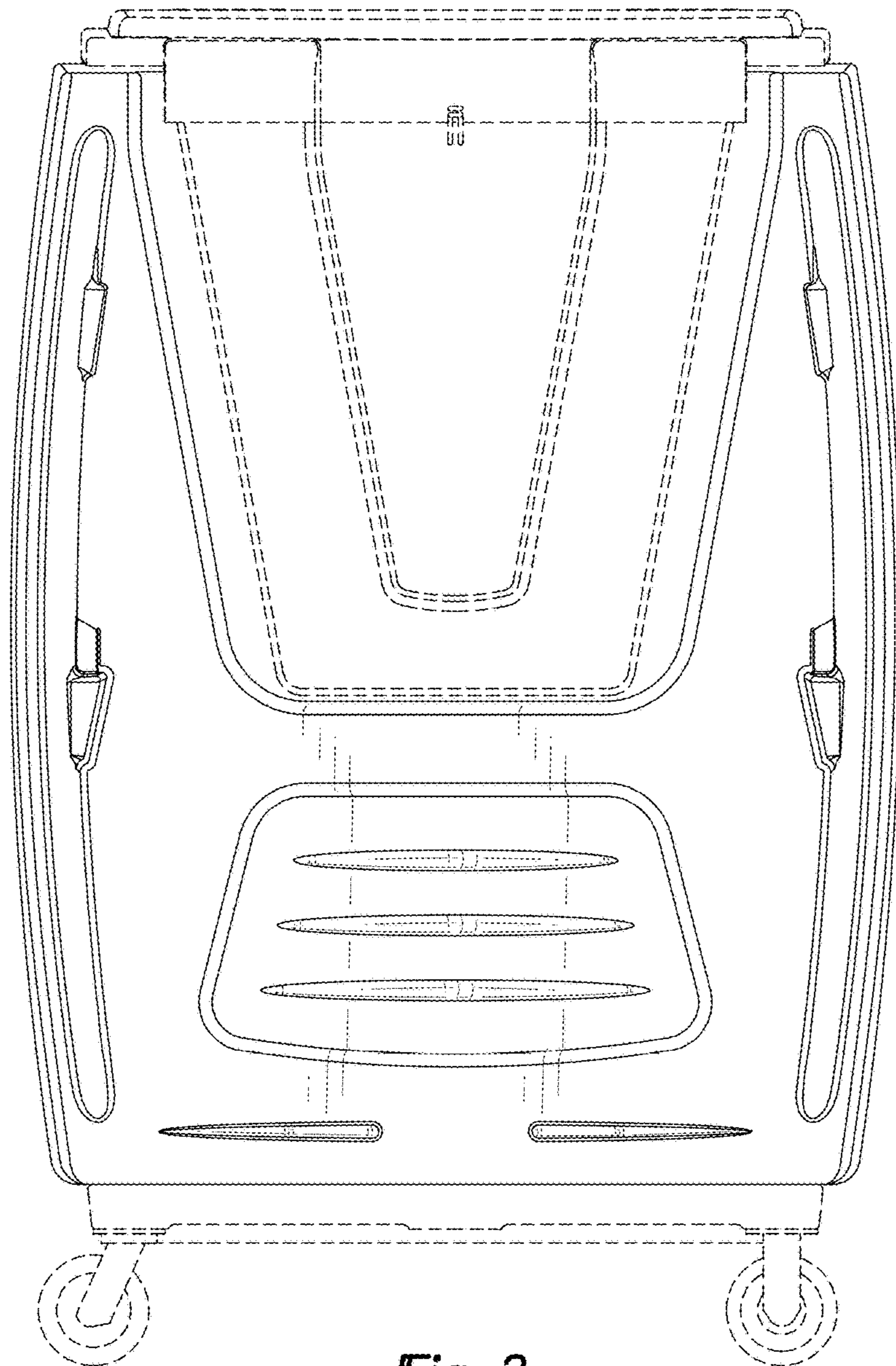

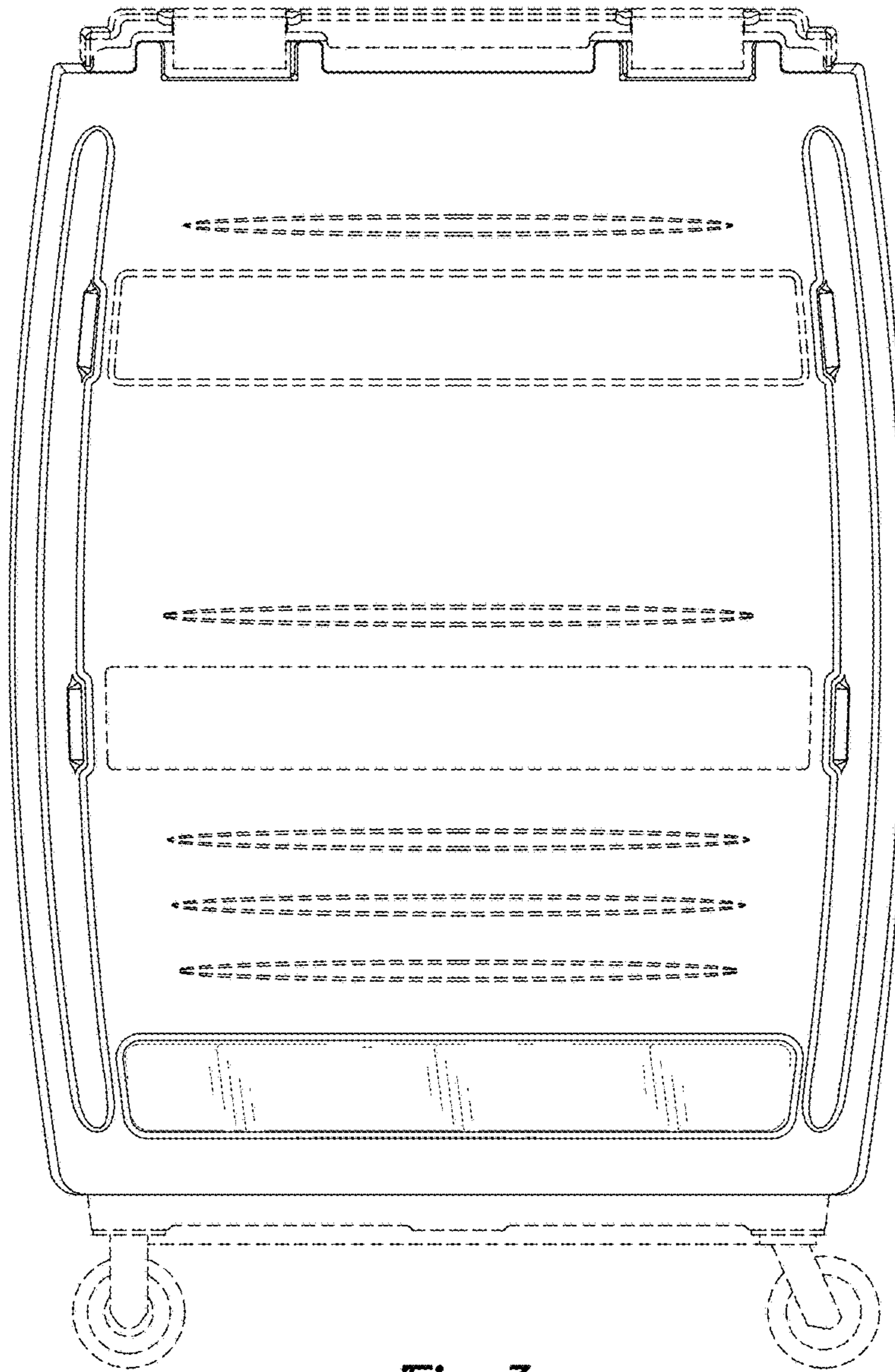

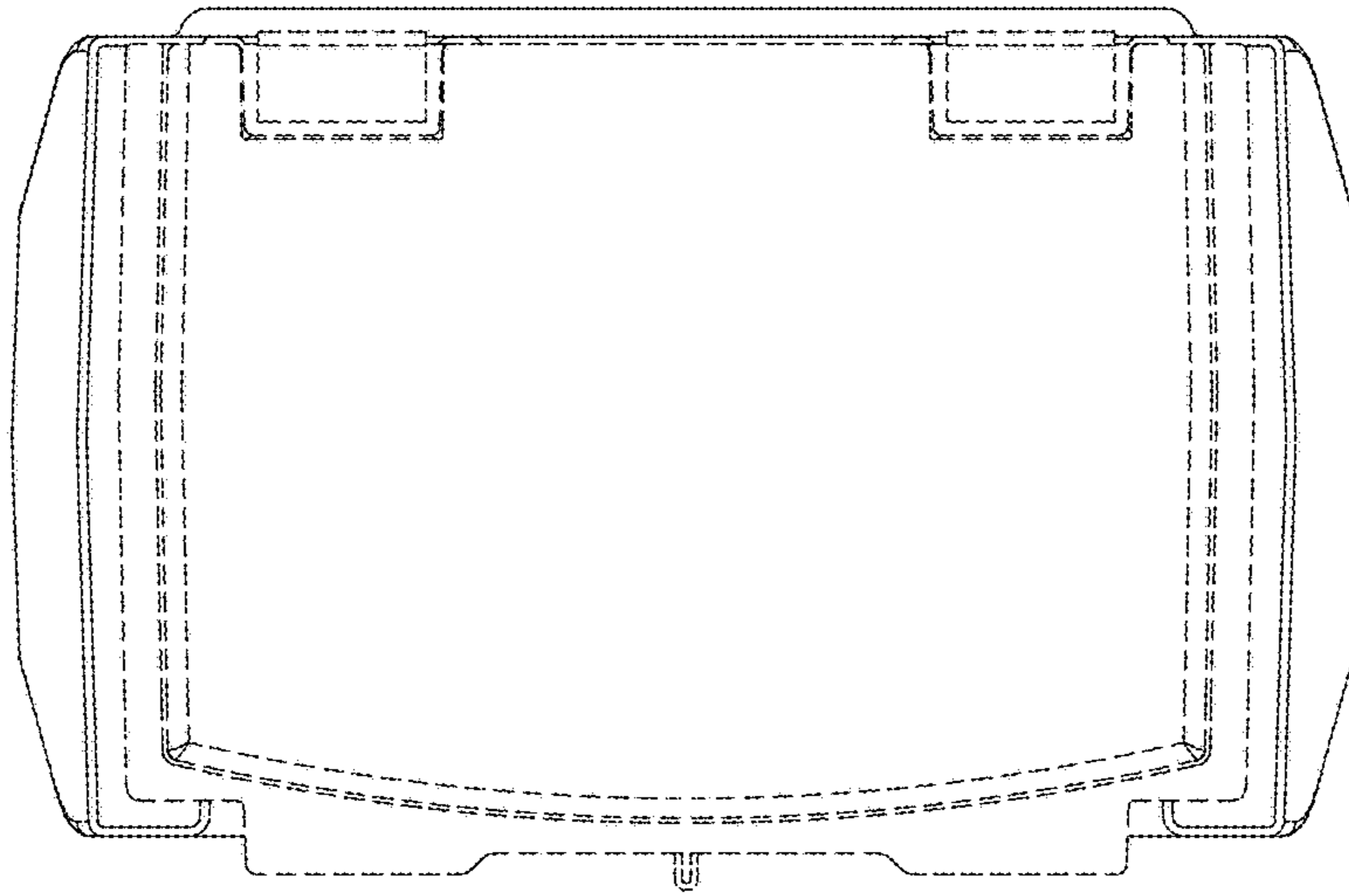

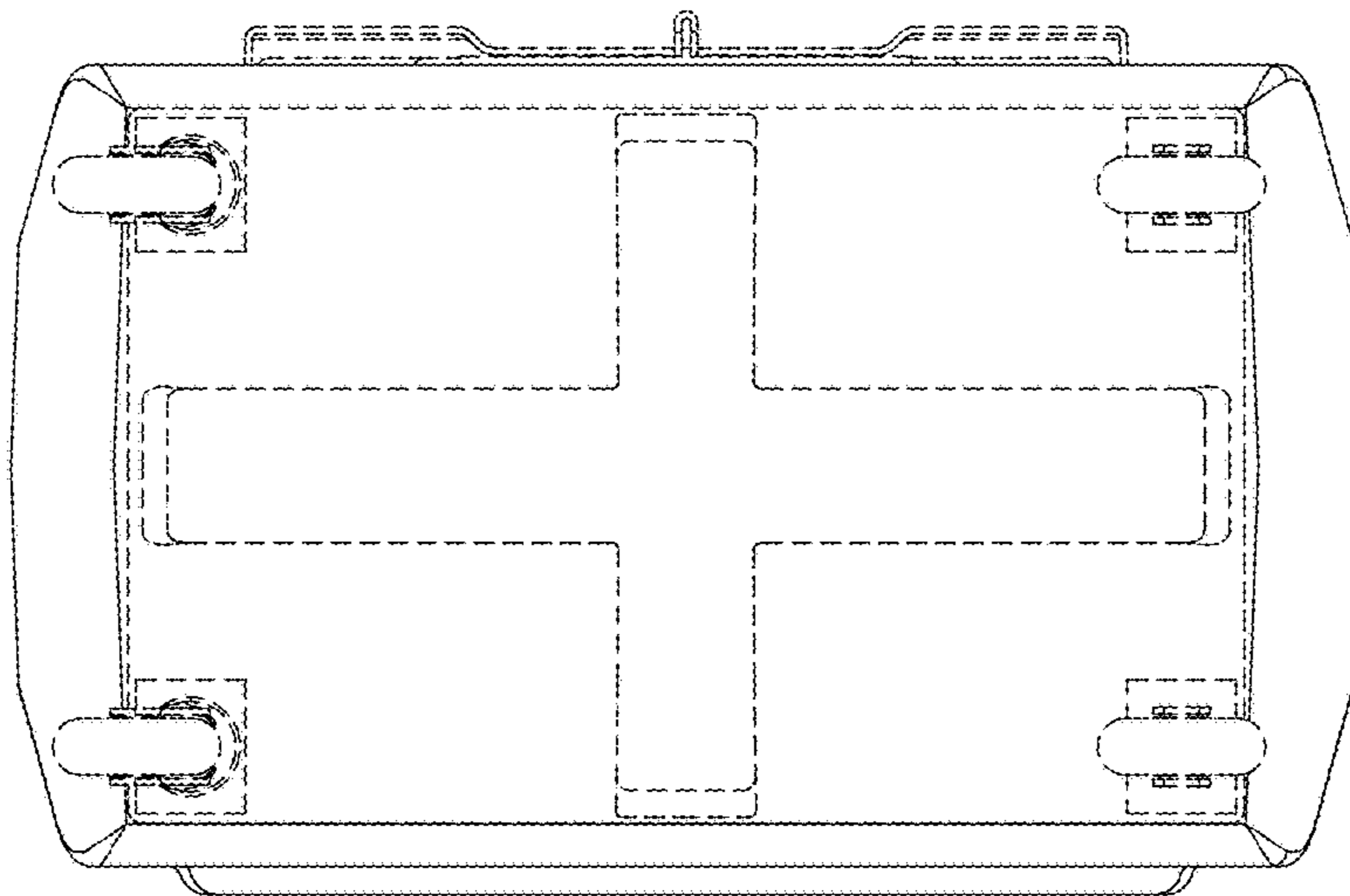

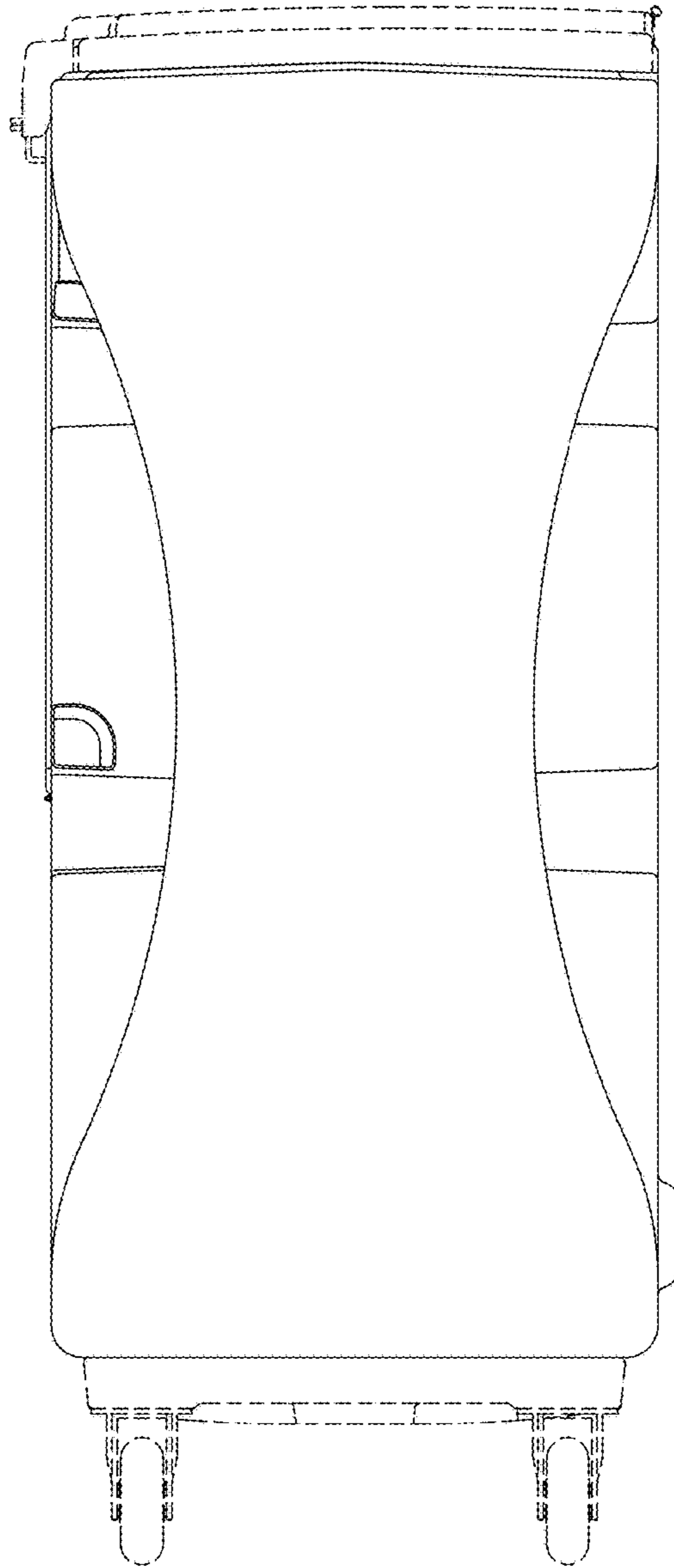
