(57) **CLAIM**

We claim the ornamental design for a cracker, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cracker comprising the present invention.

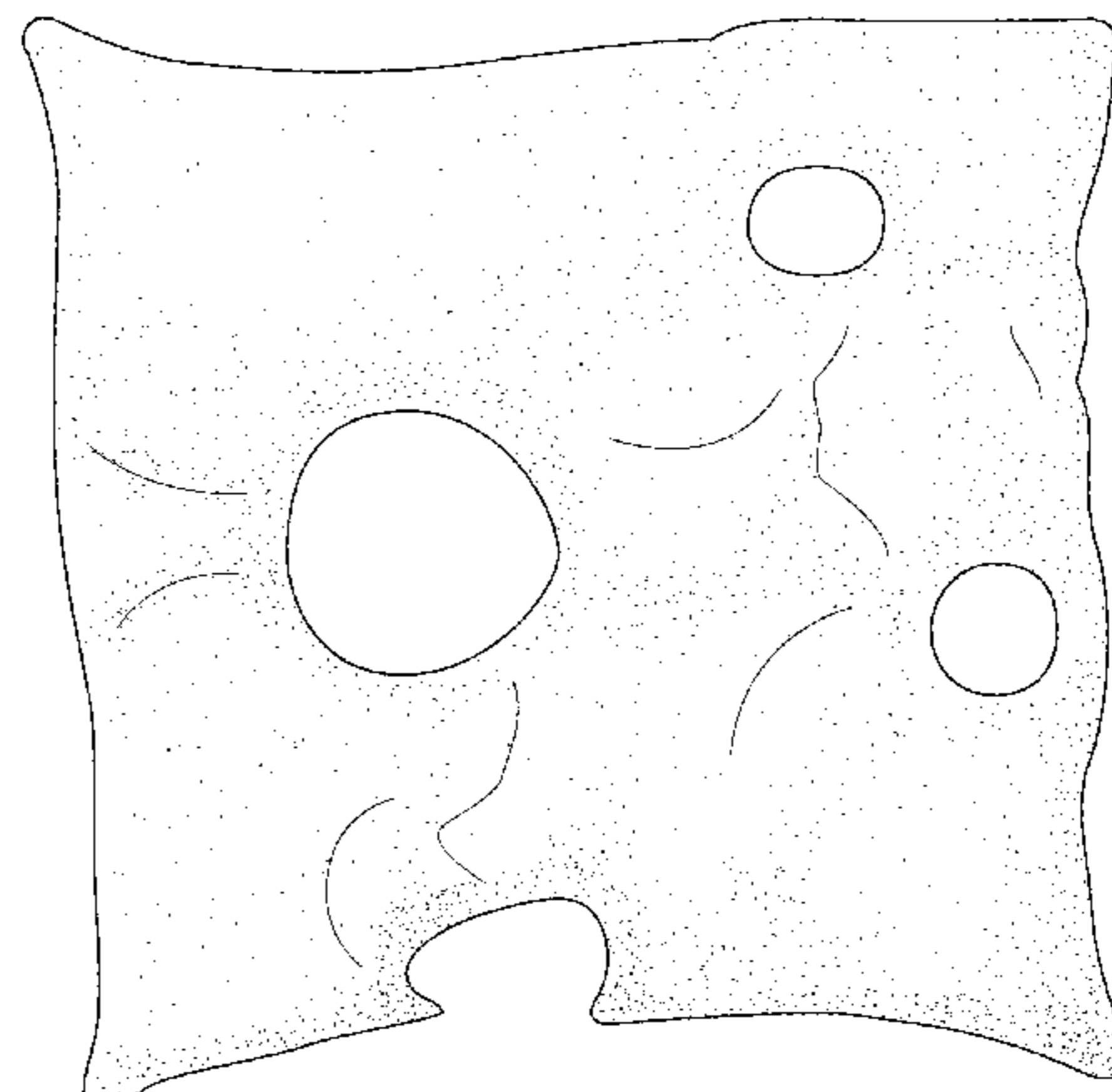
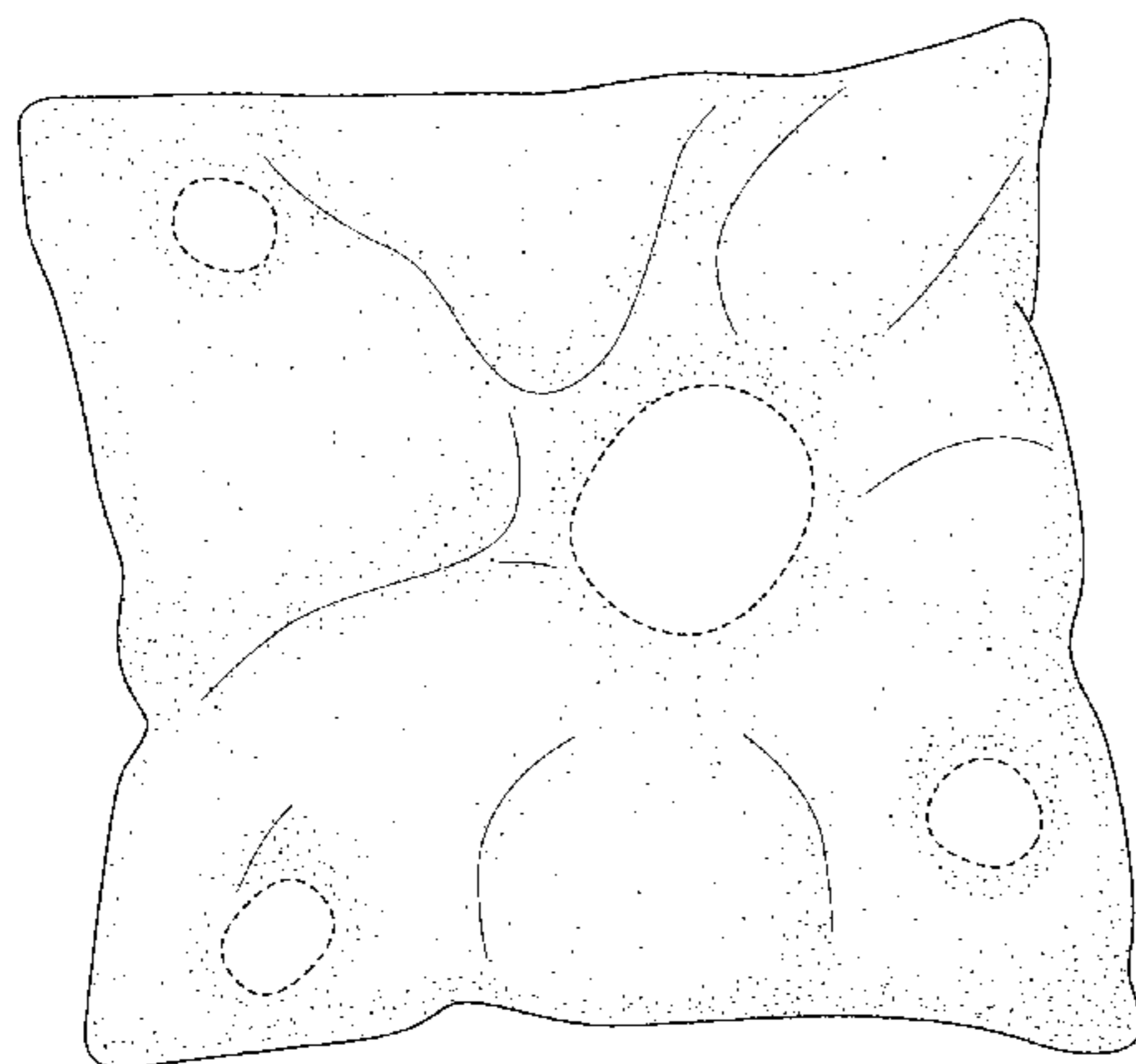


FIG. 19 is a right elevational view of the cracker shown in FIGS. 15, 16, 17, and 18.

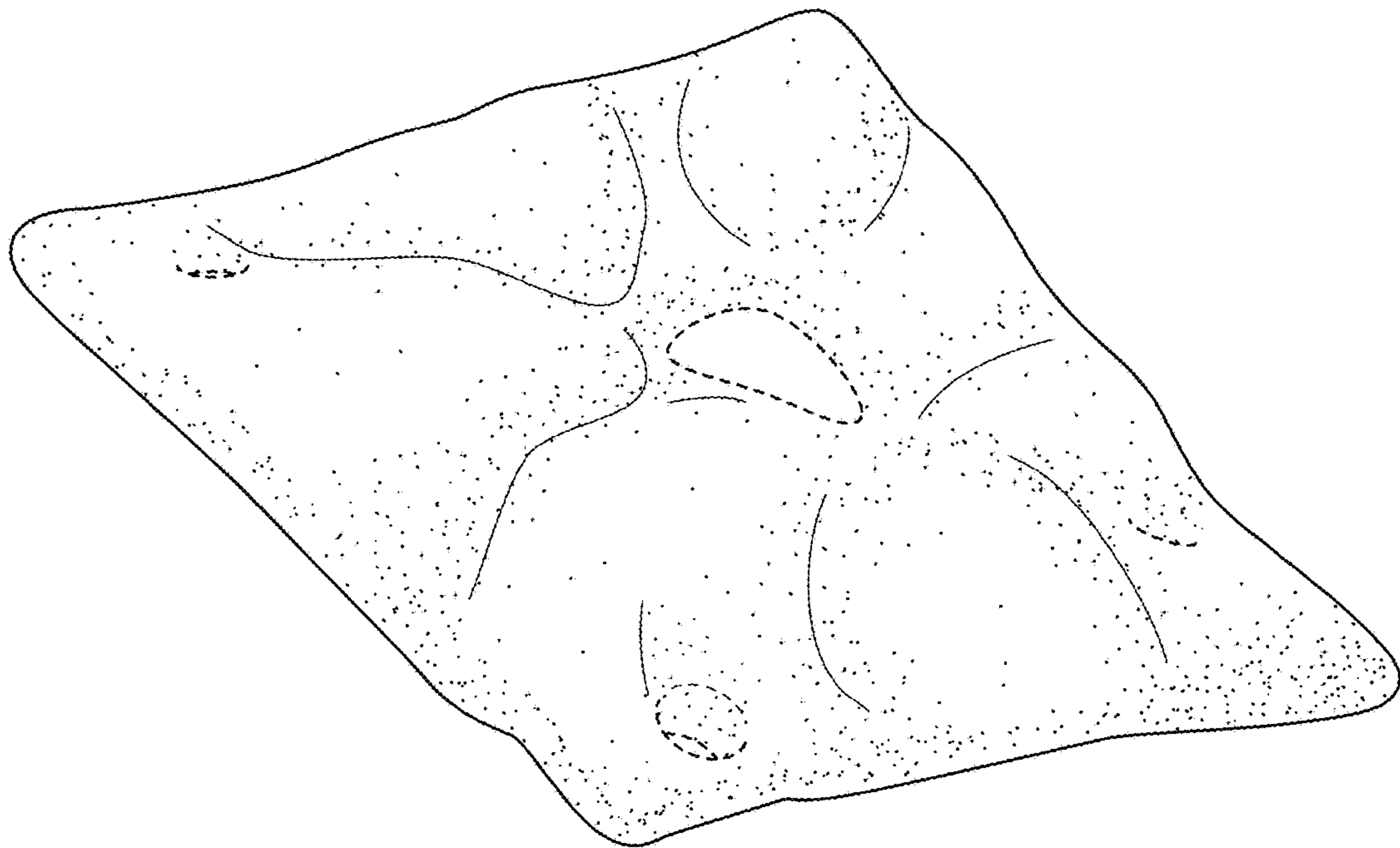

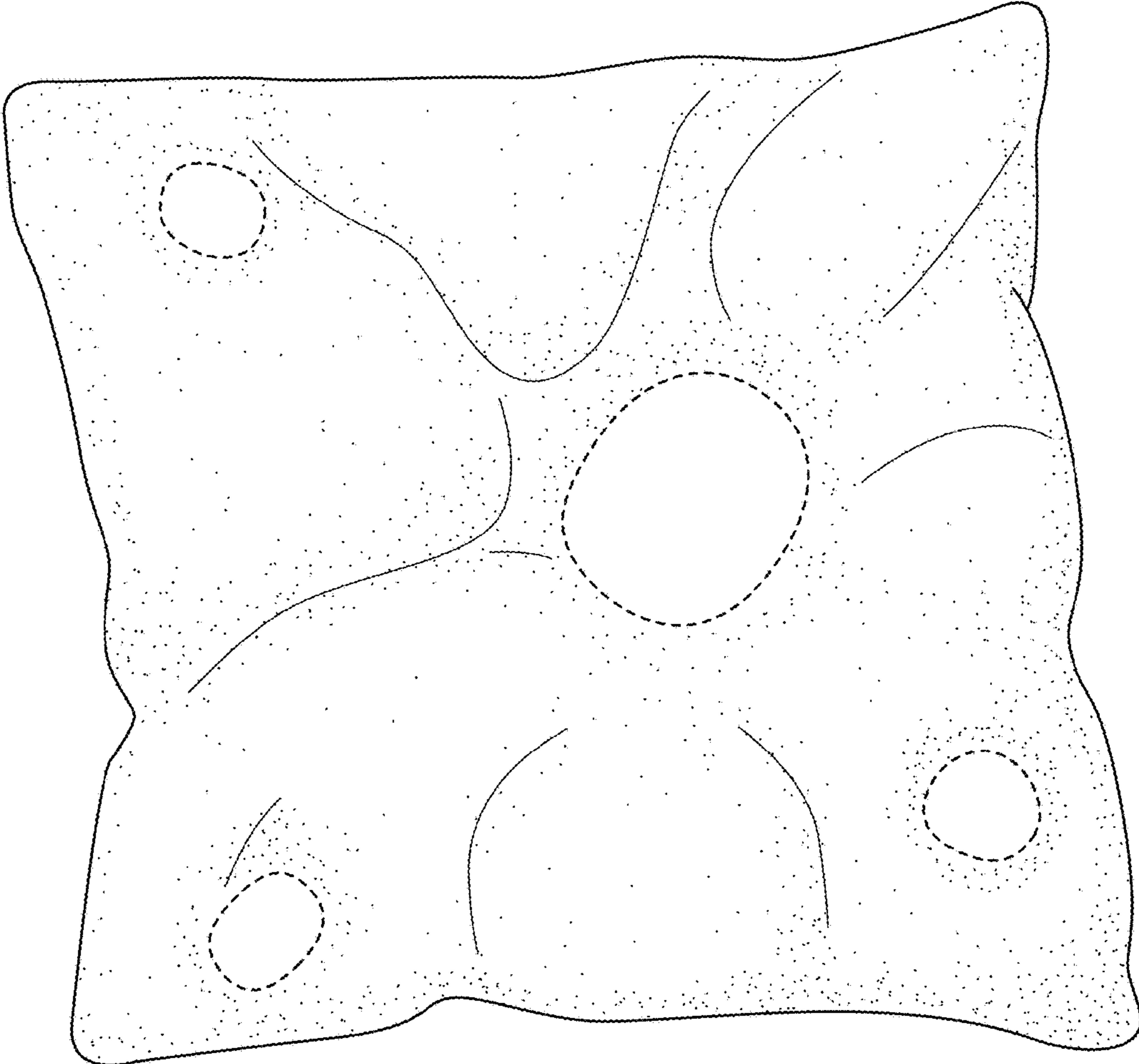

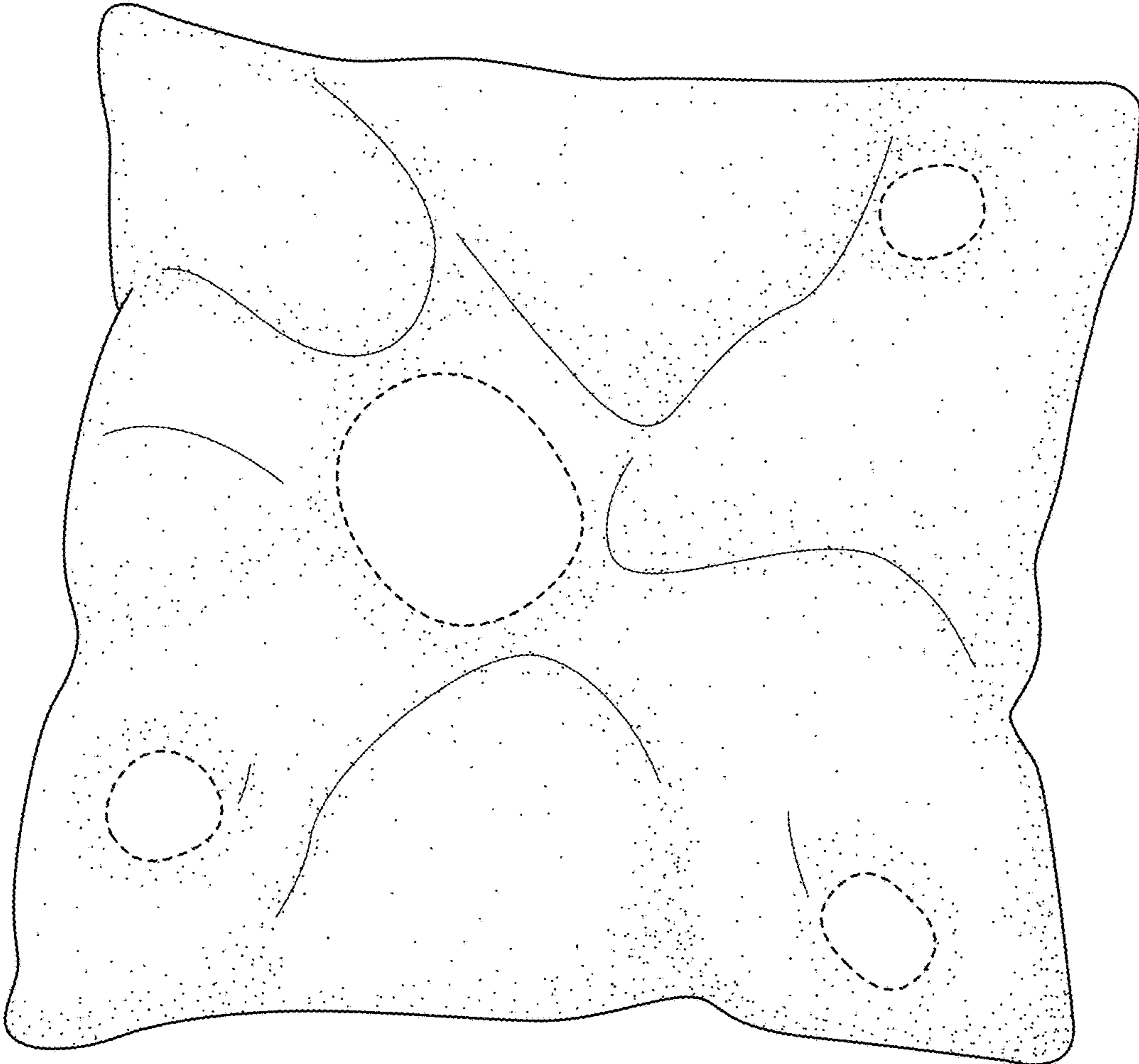

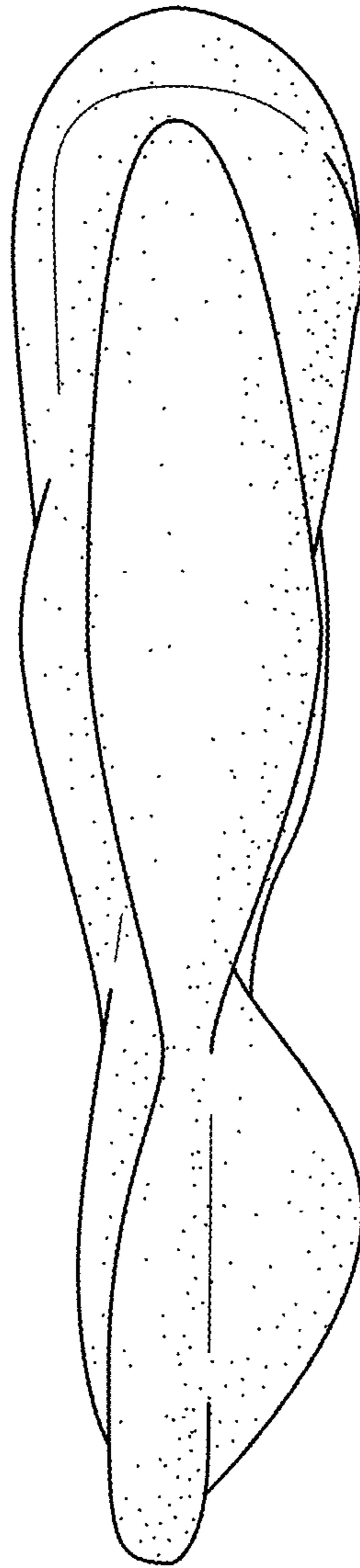

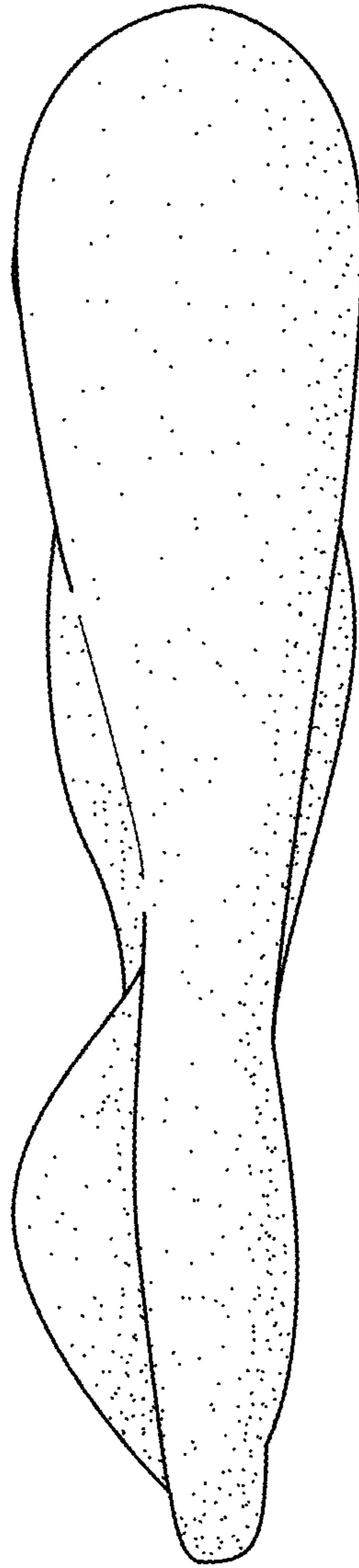

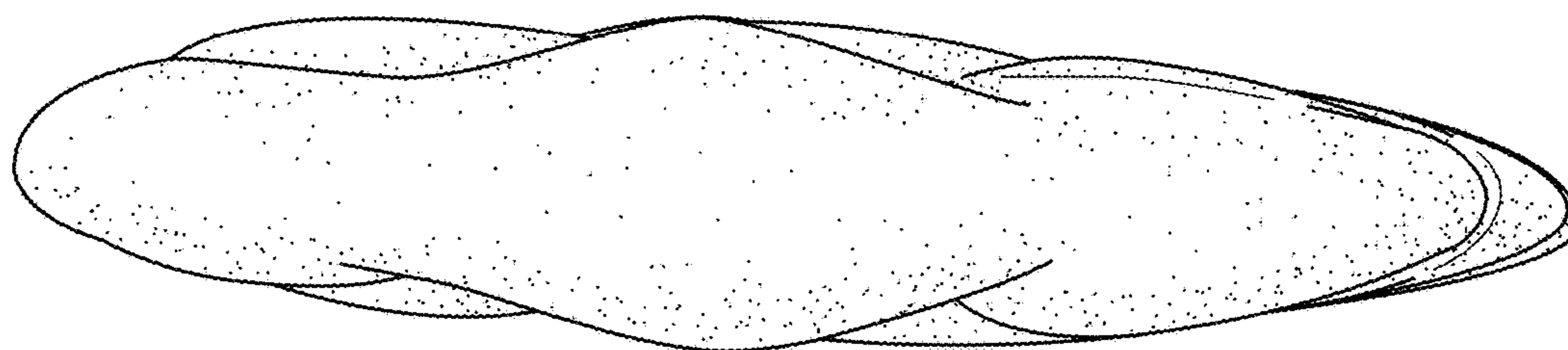

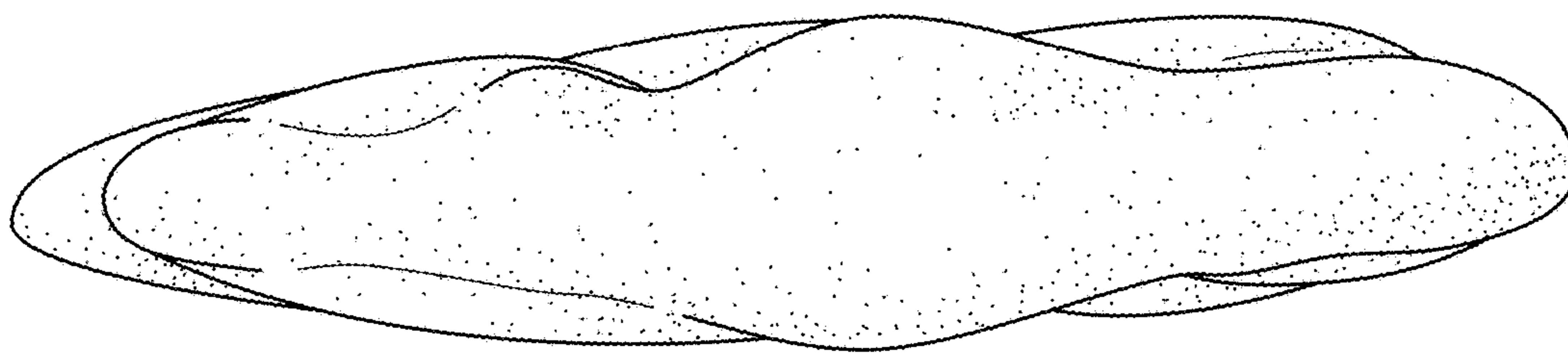

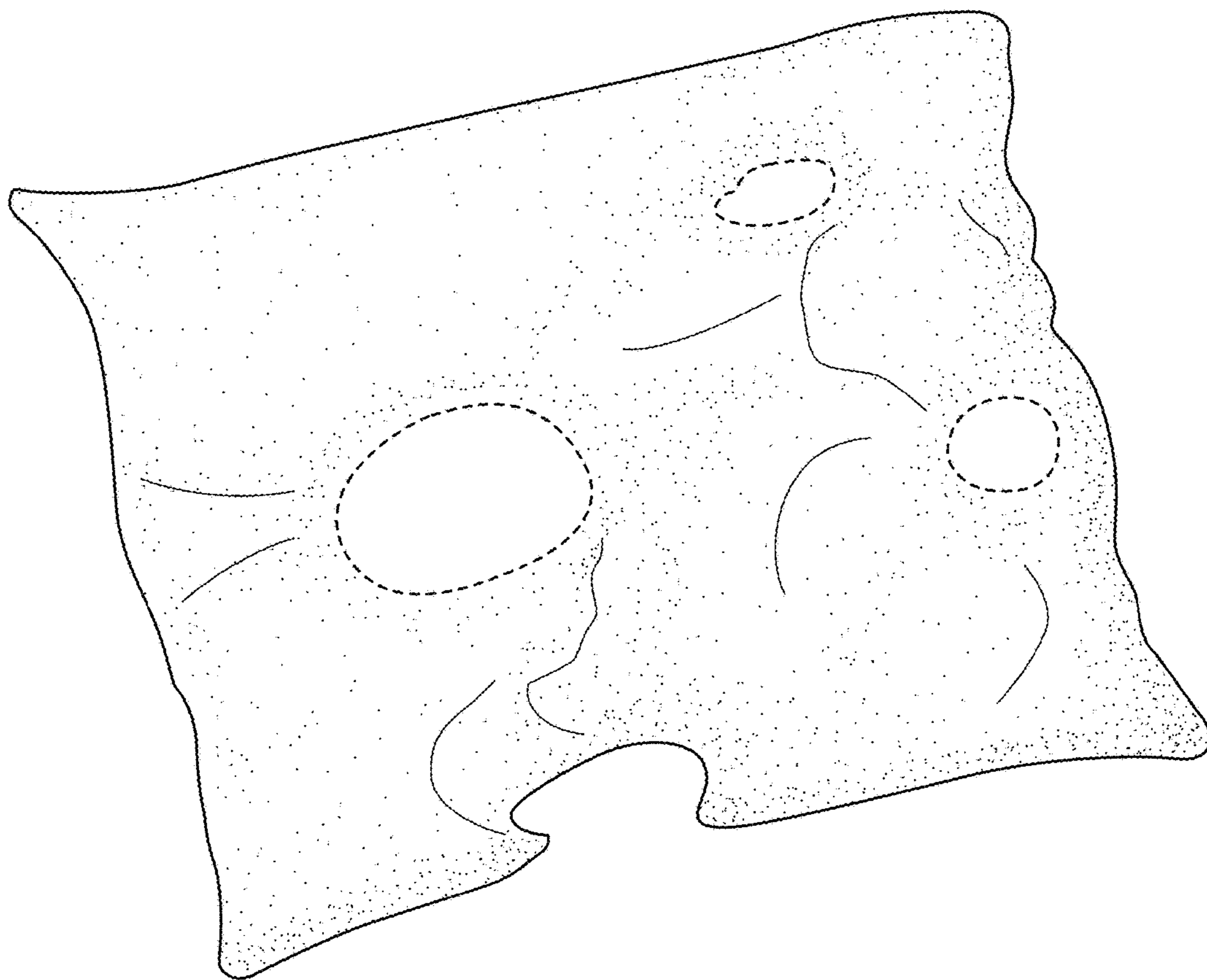

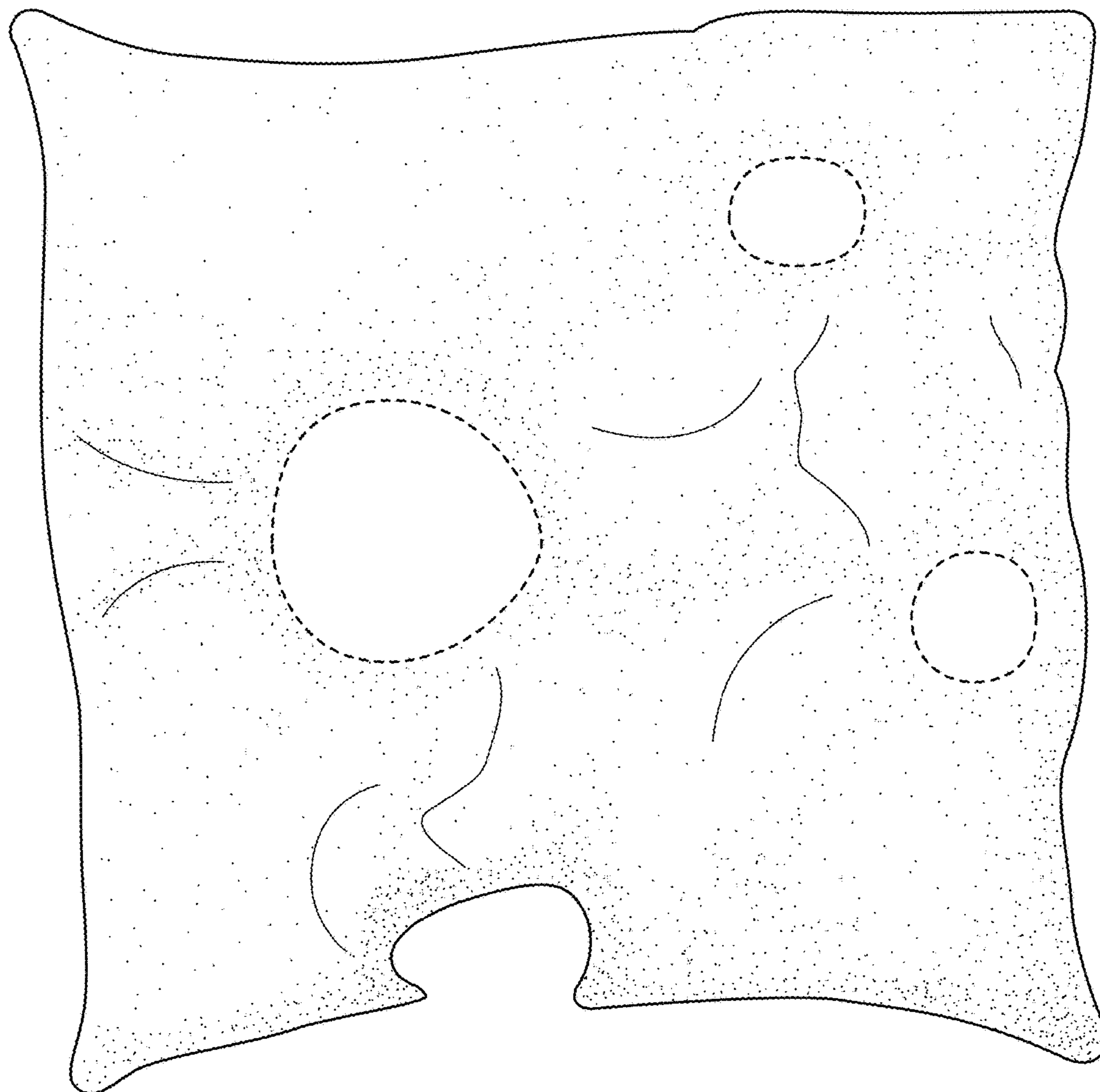

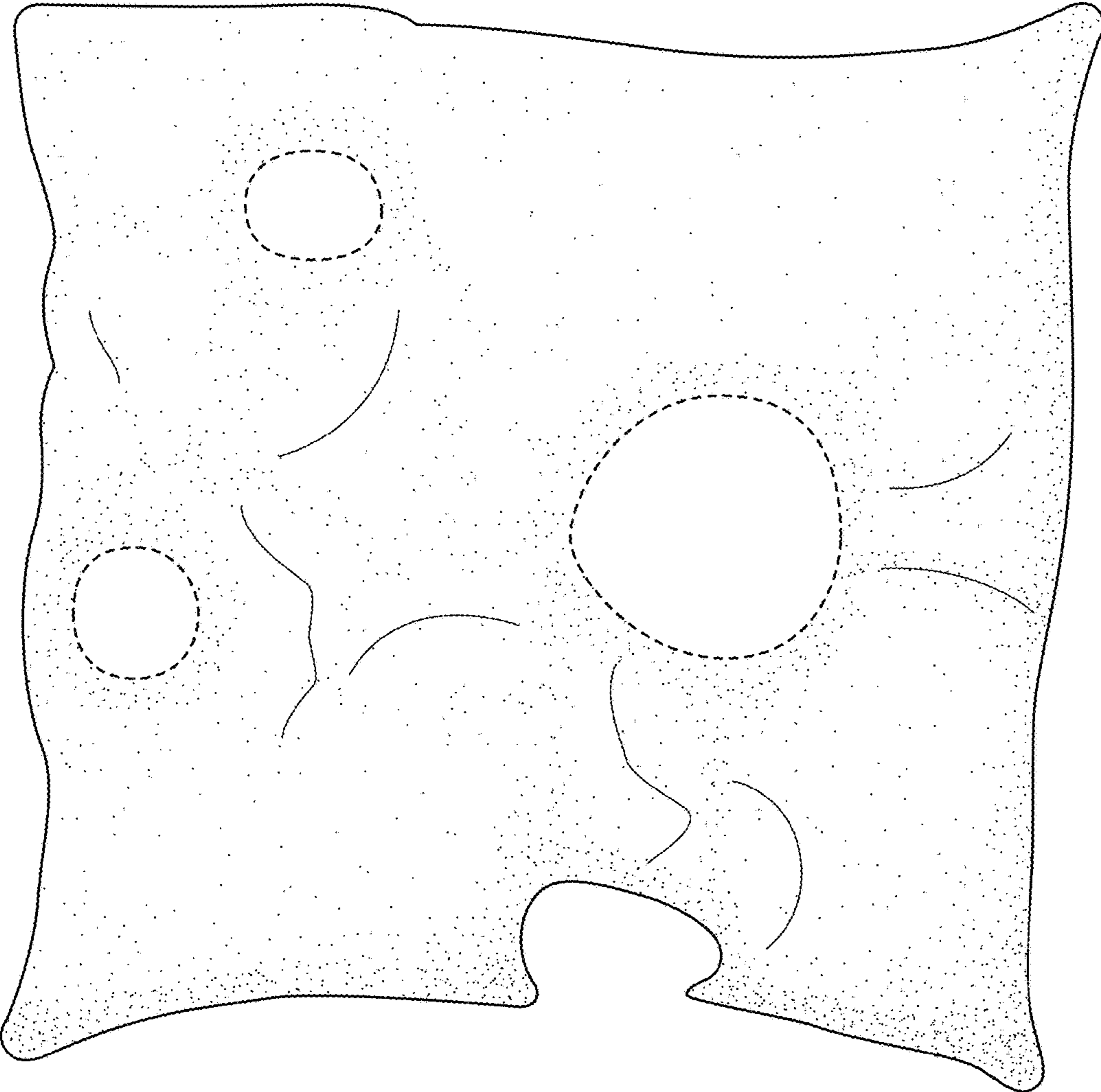

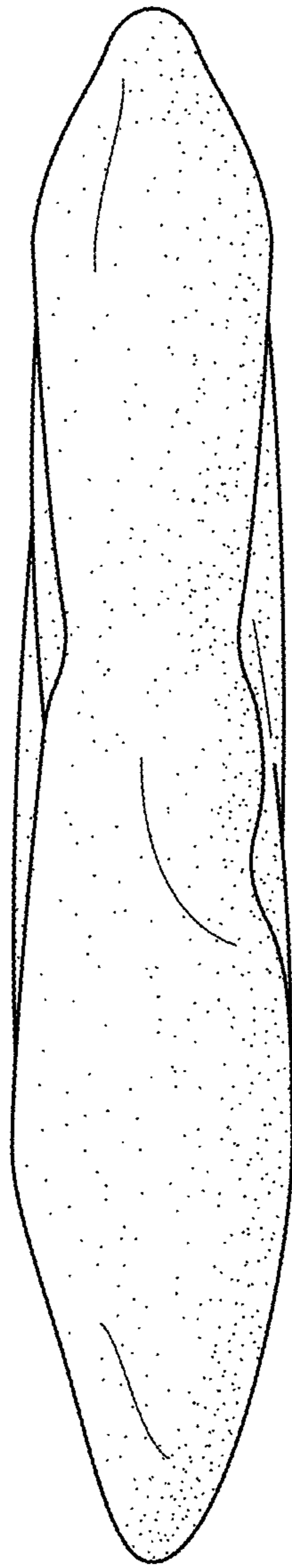

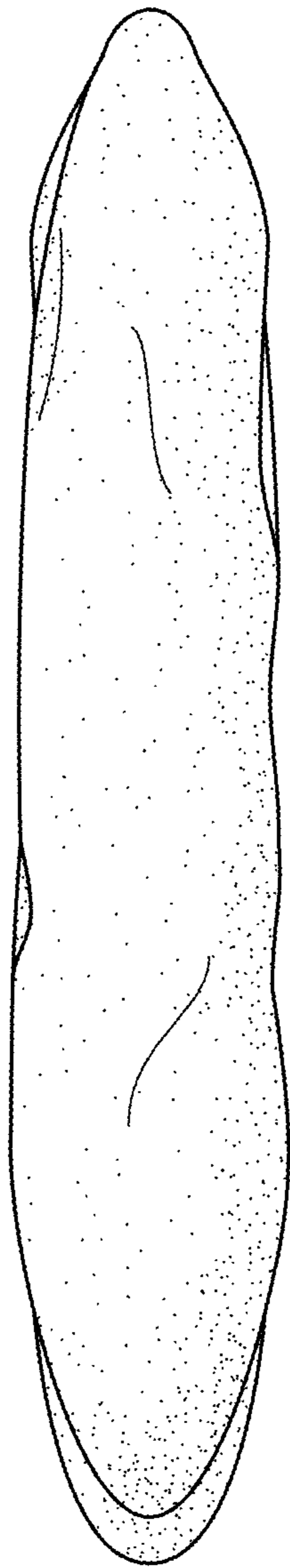

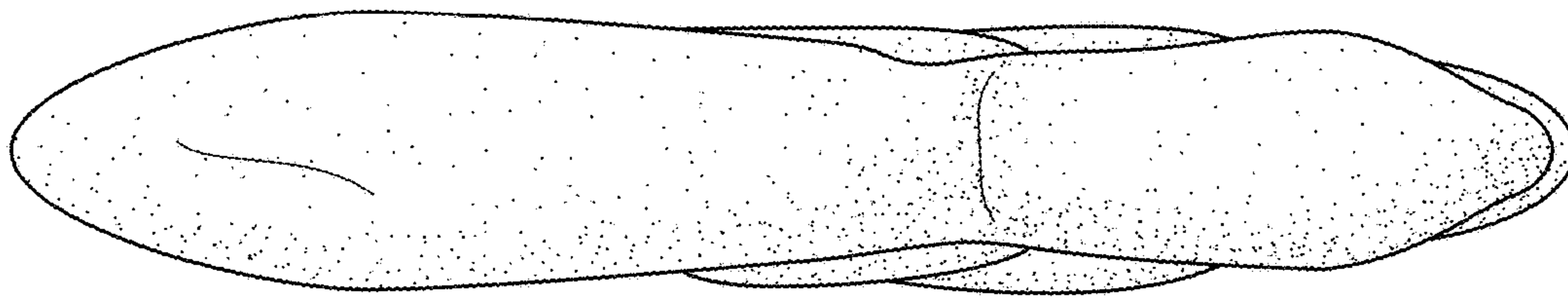

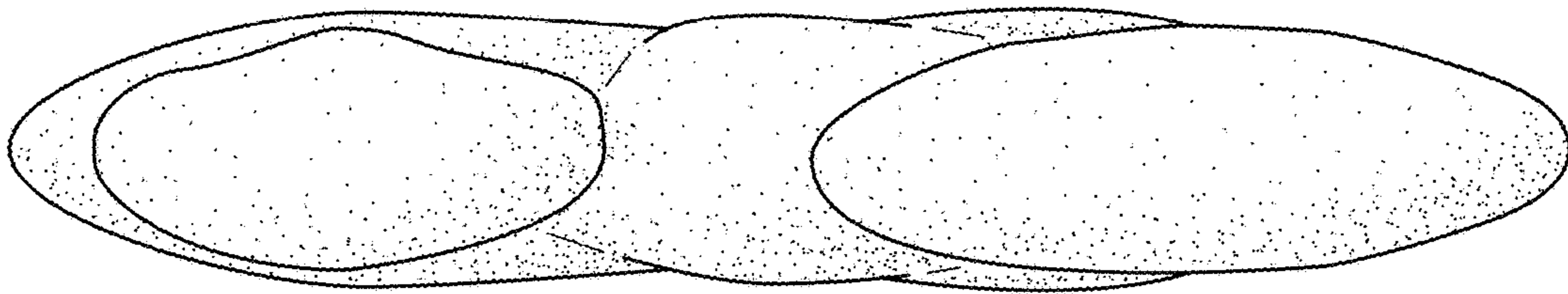

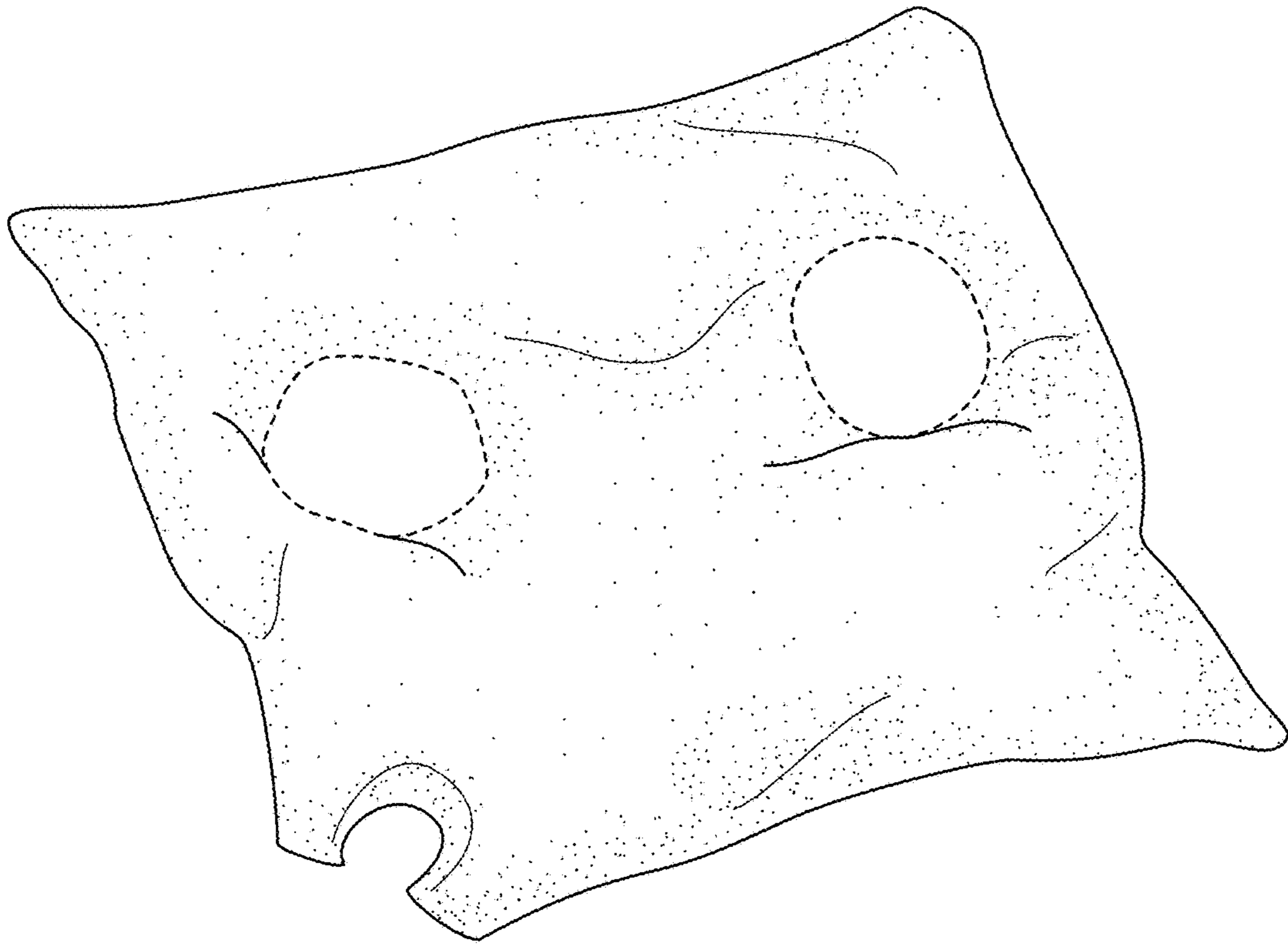

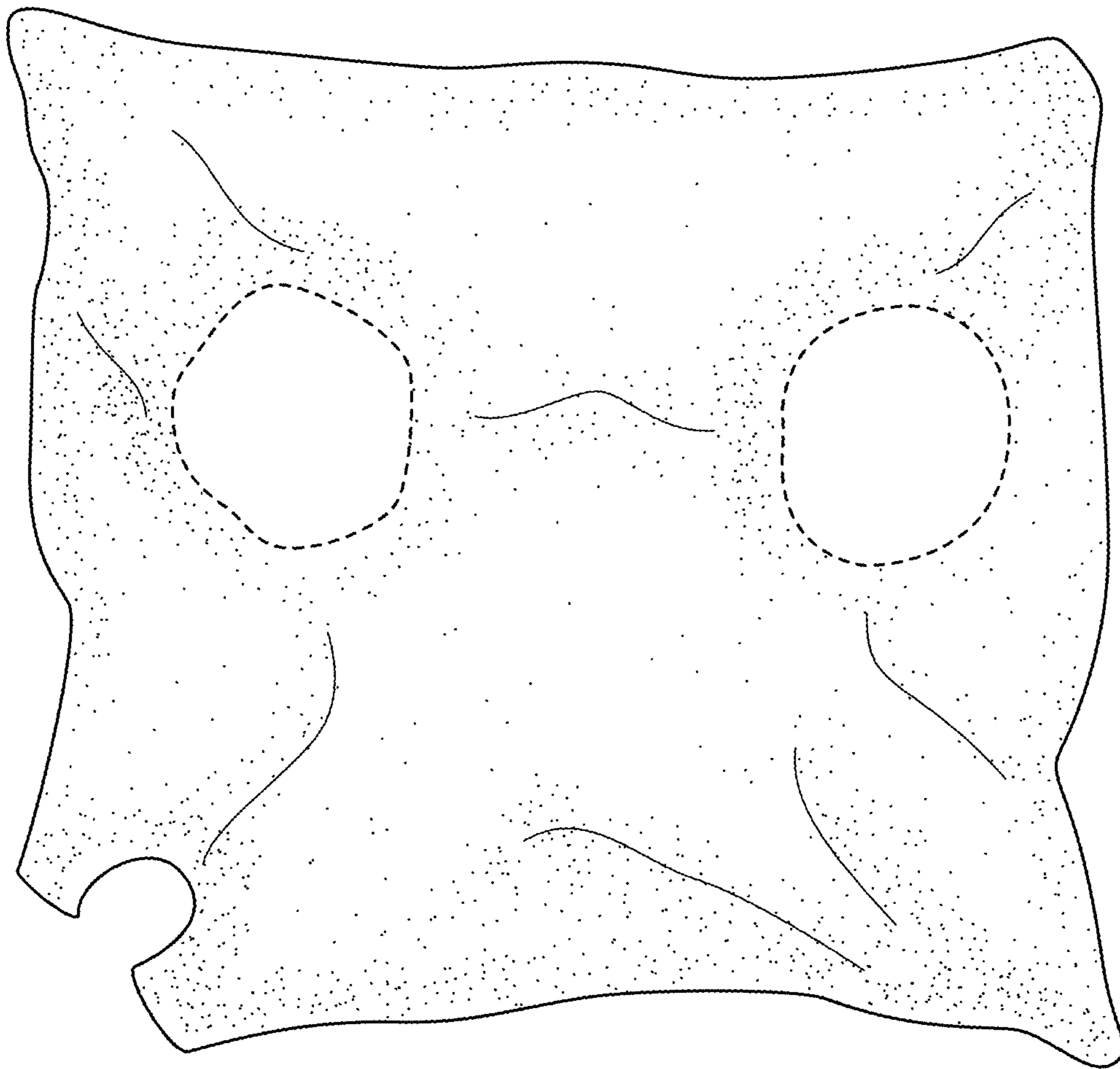

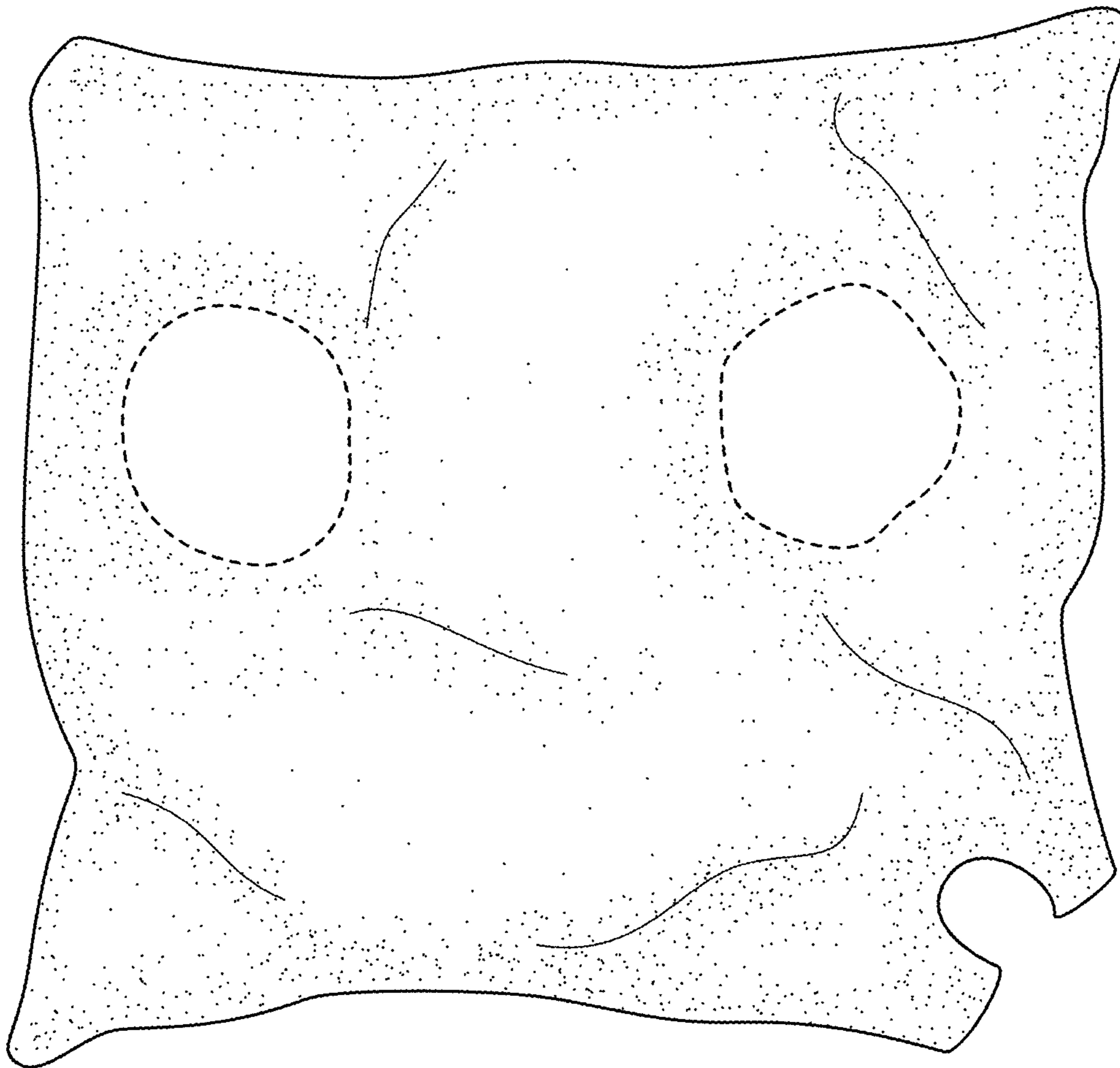

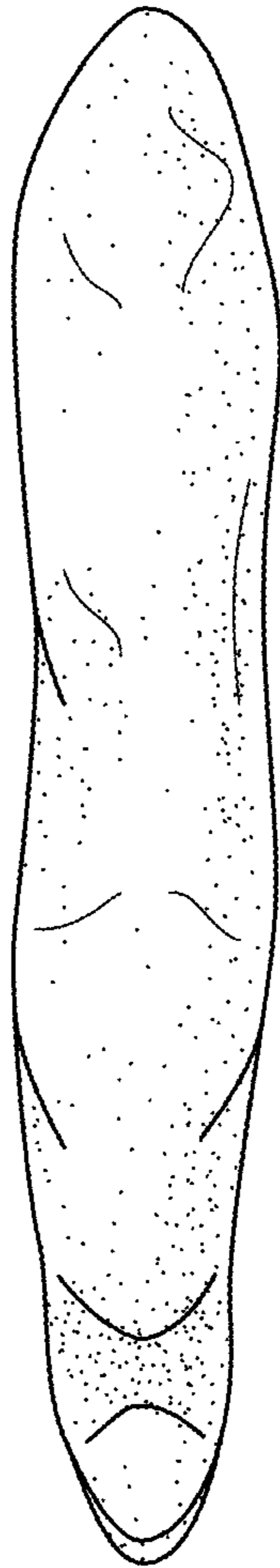

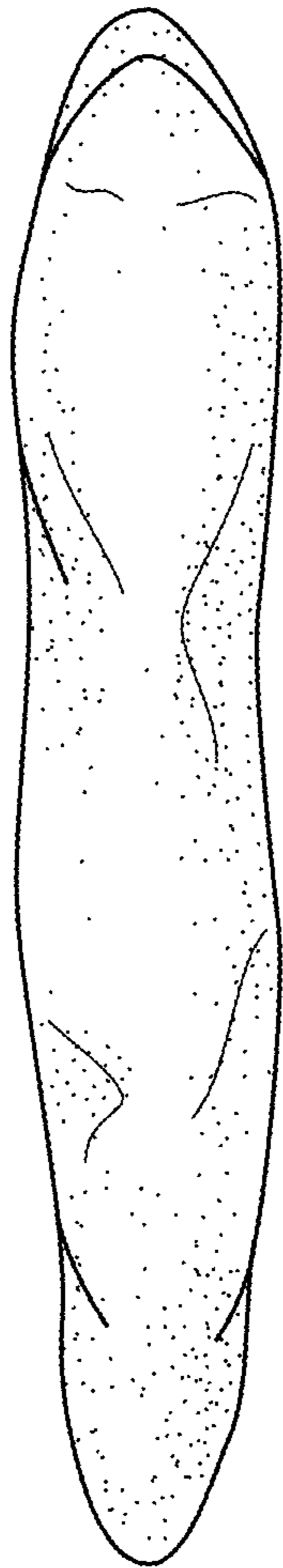

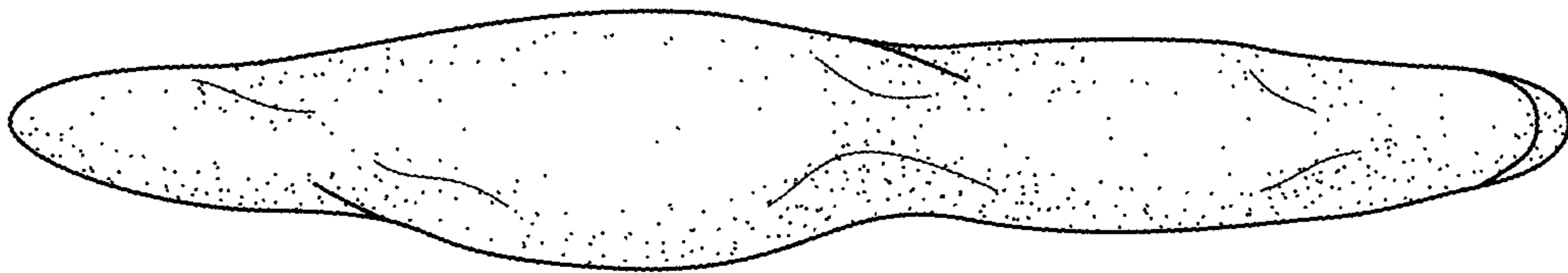

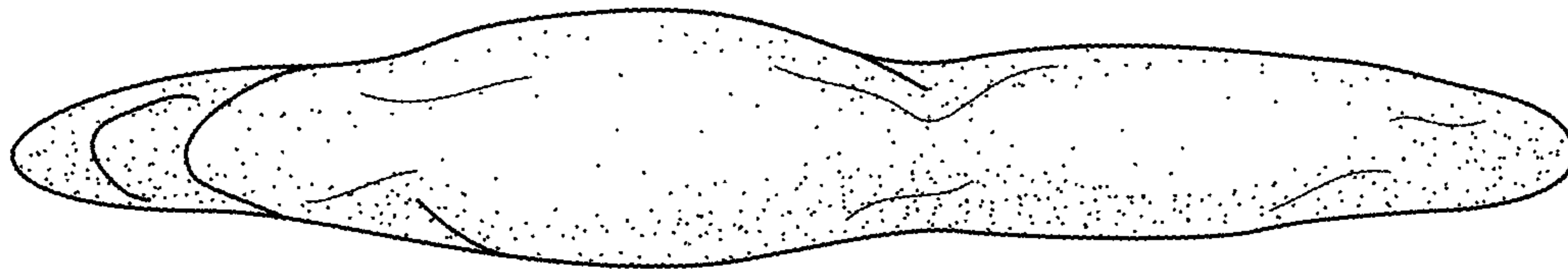

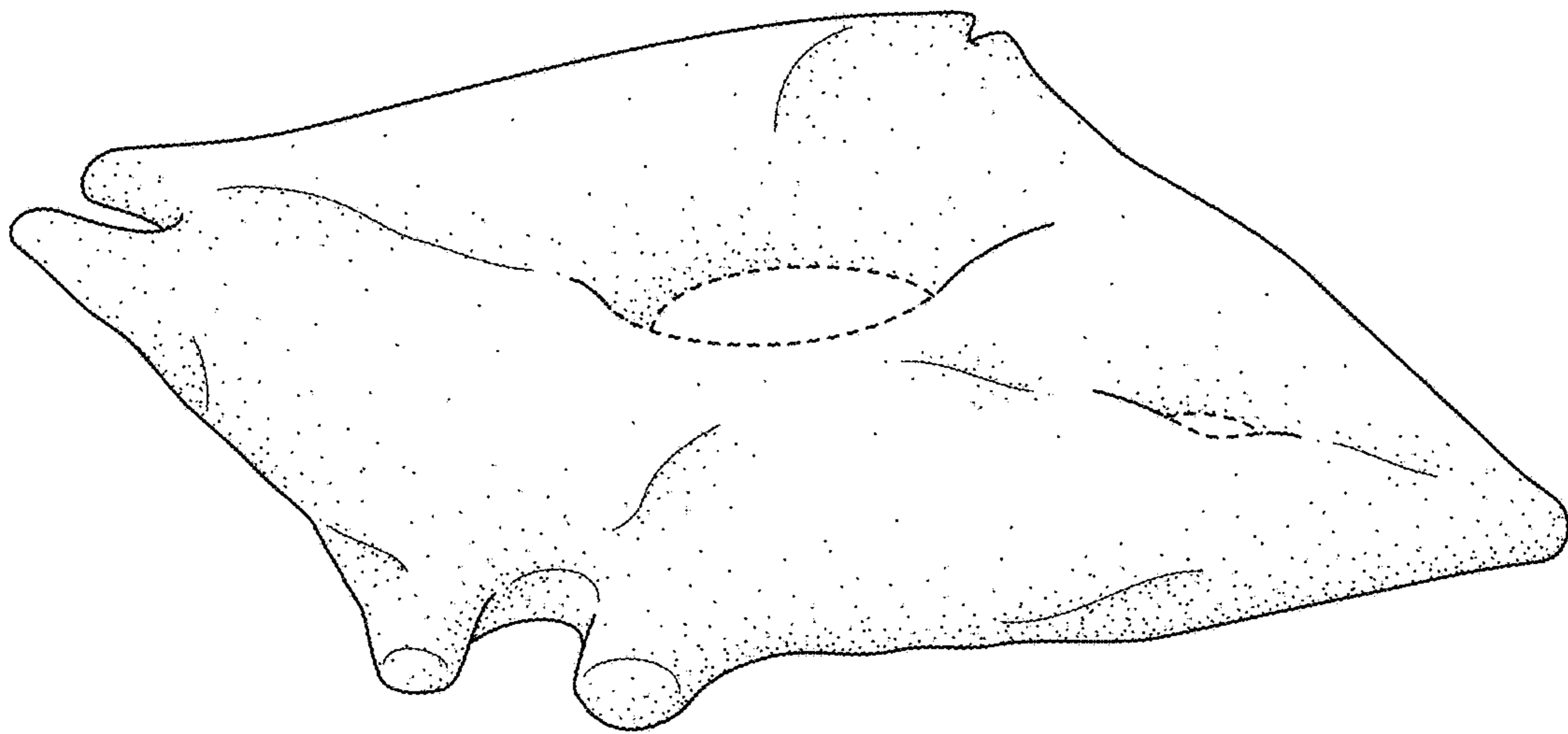

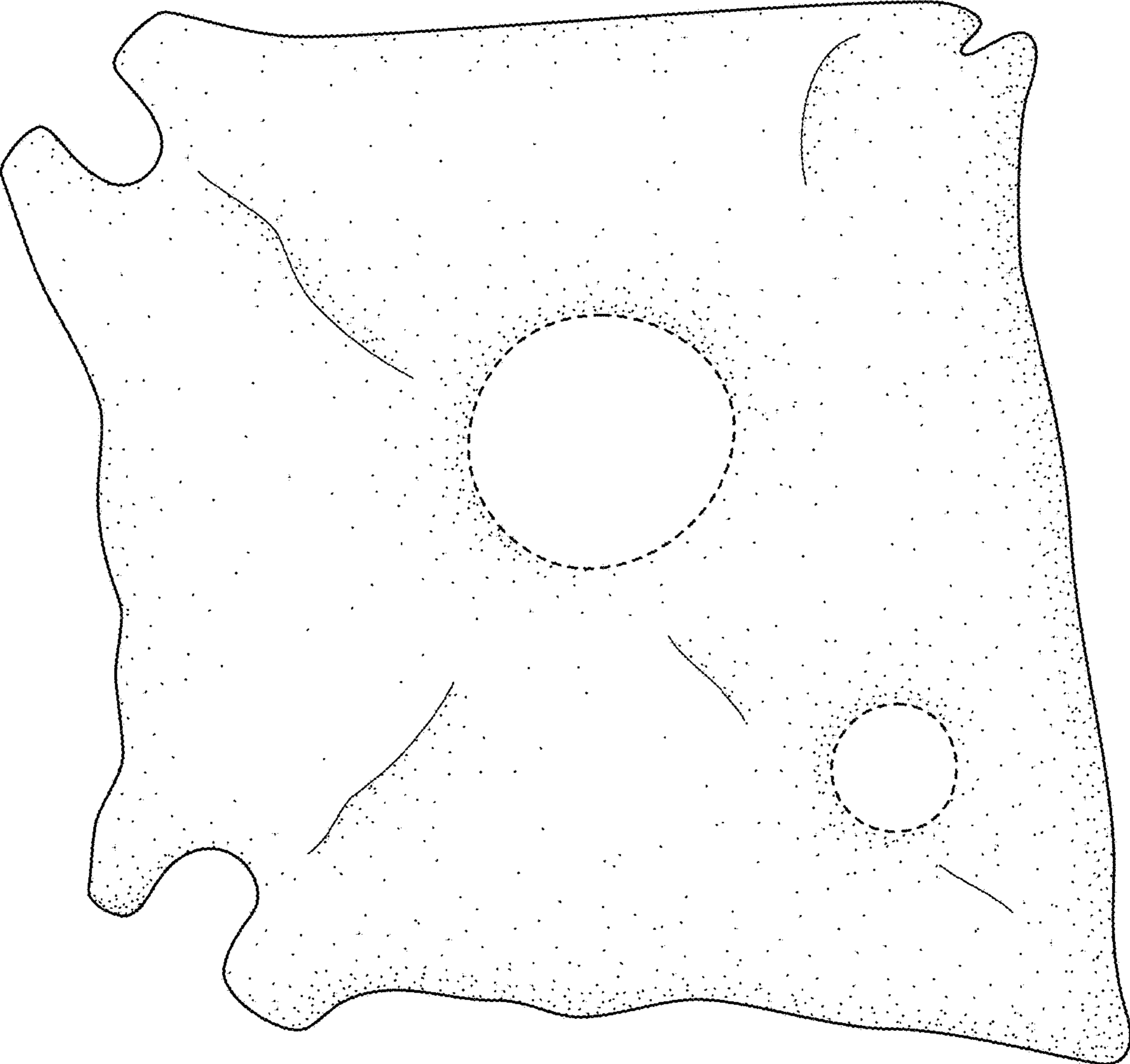

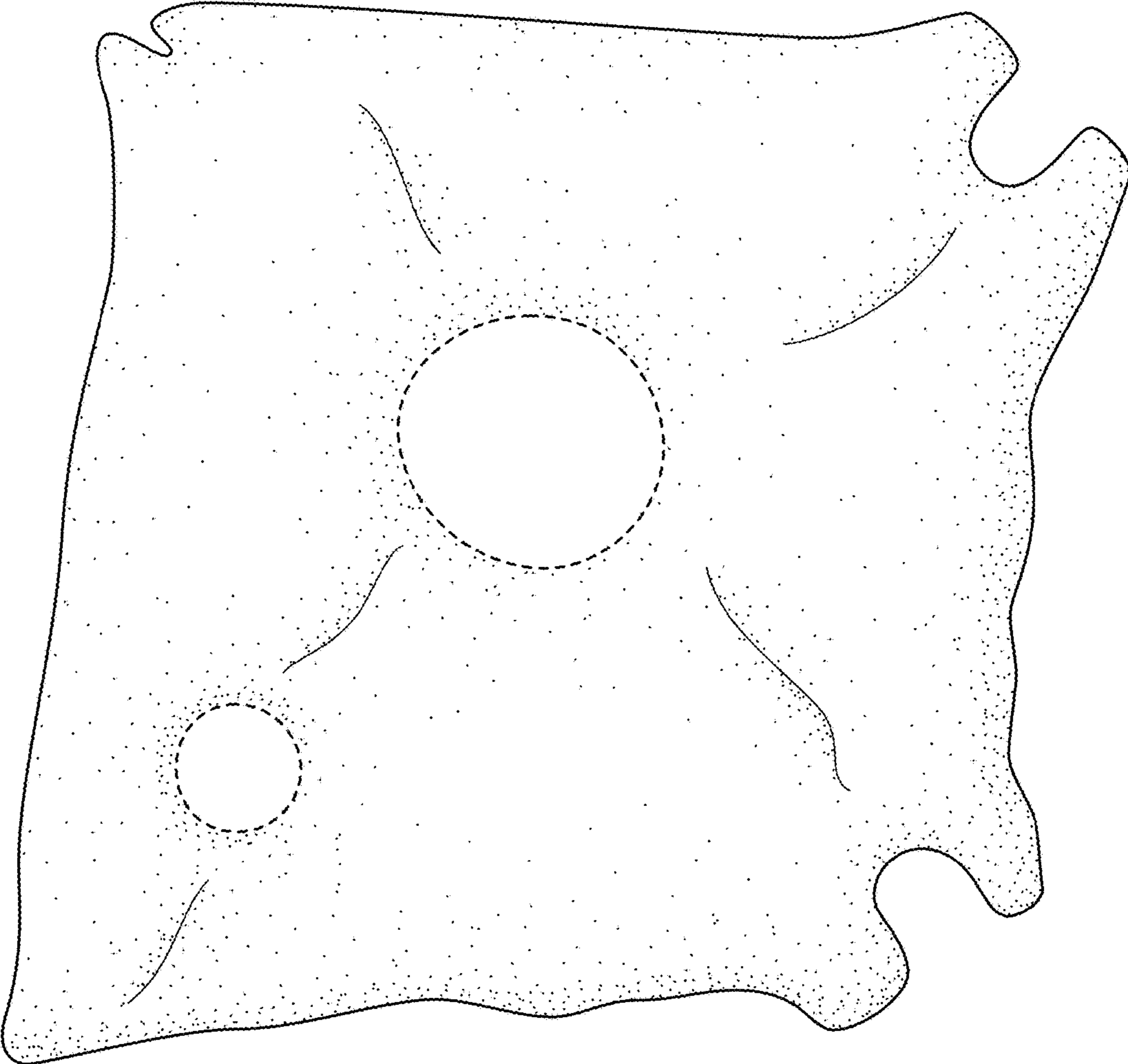

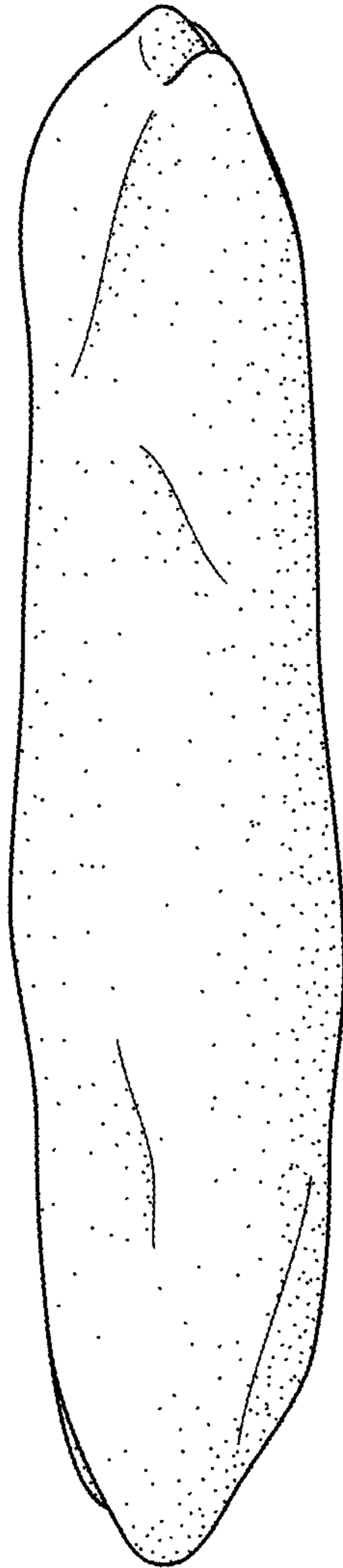

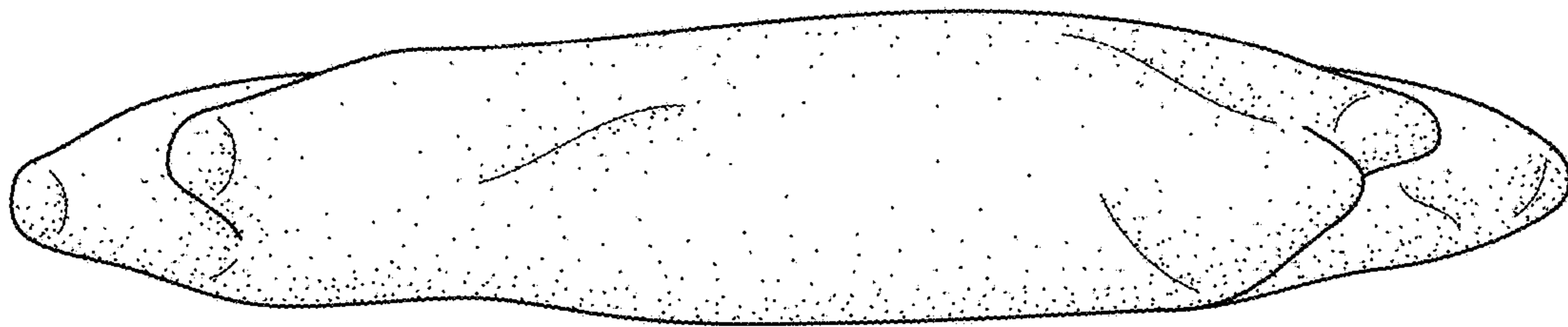

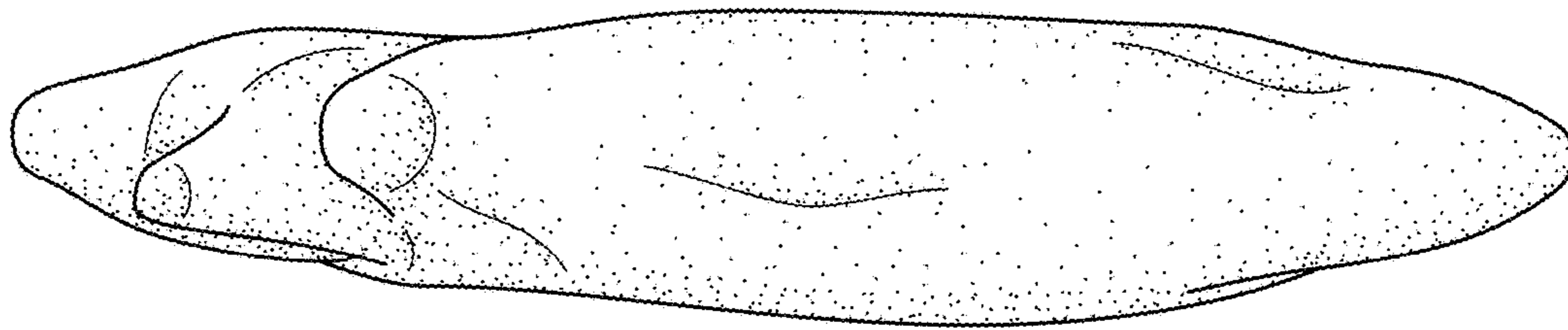

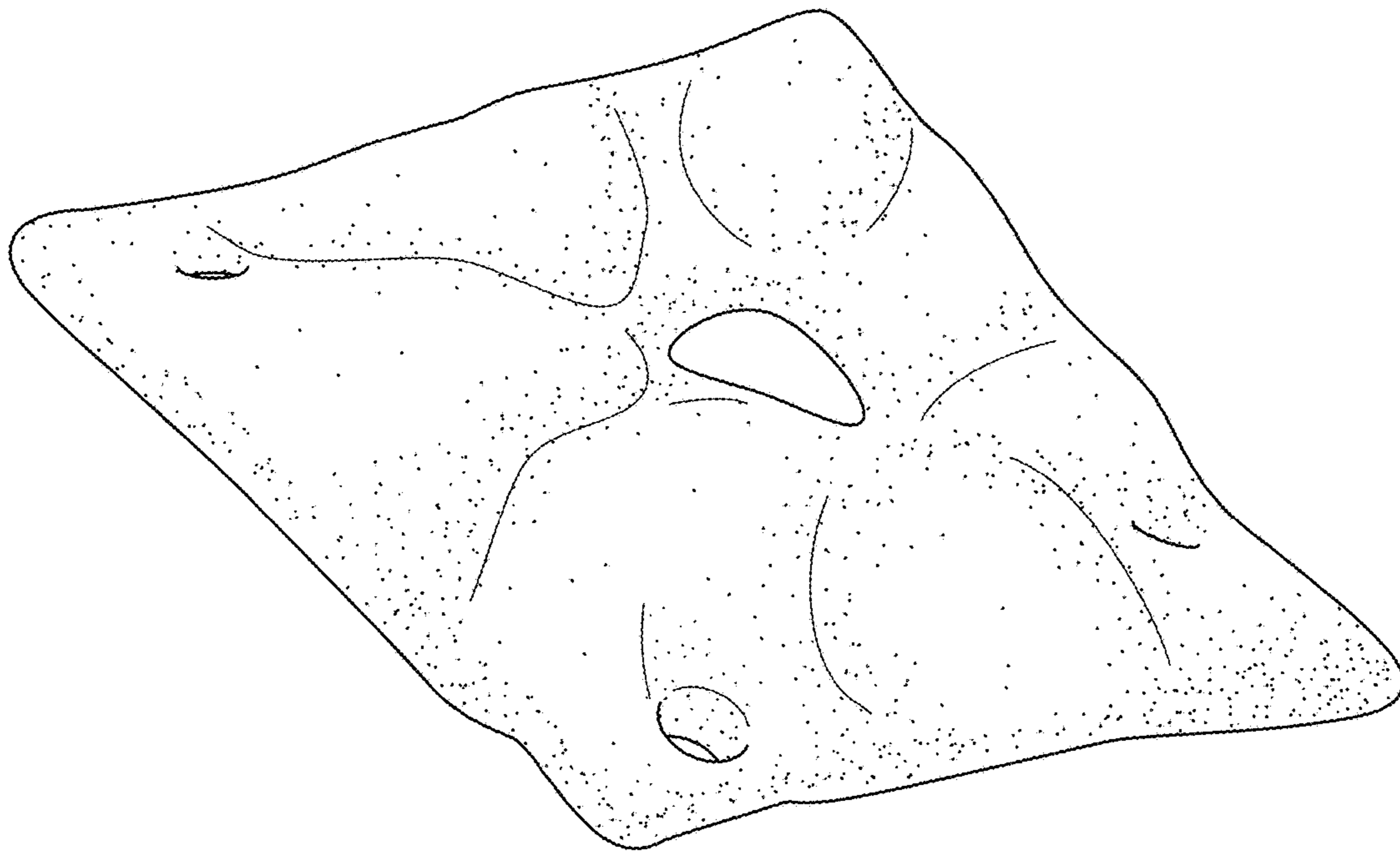

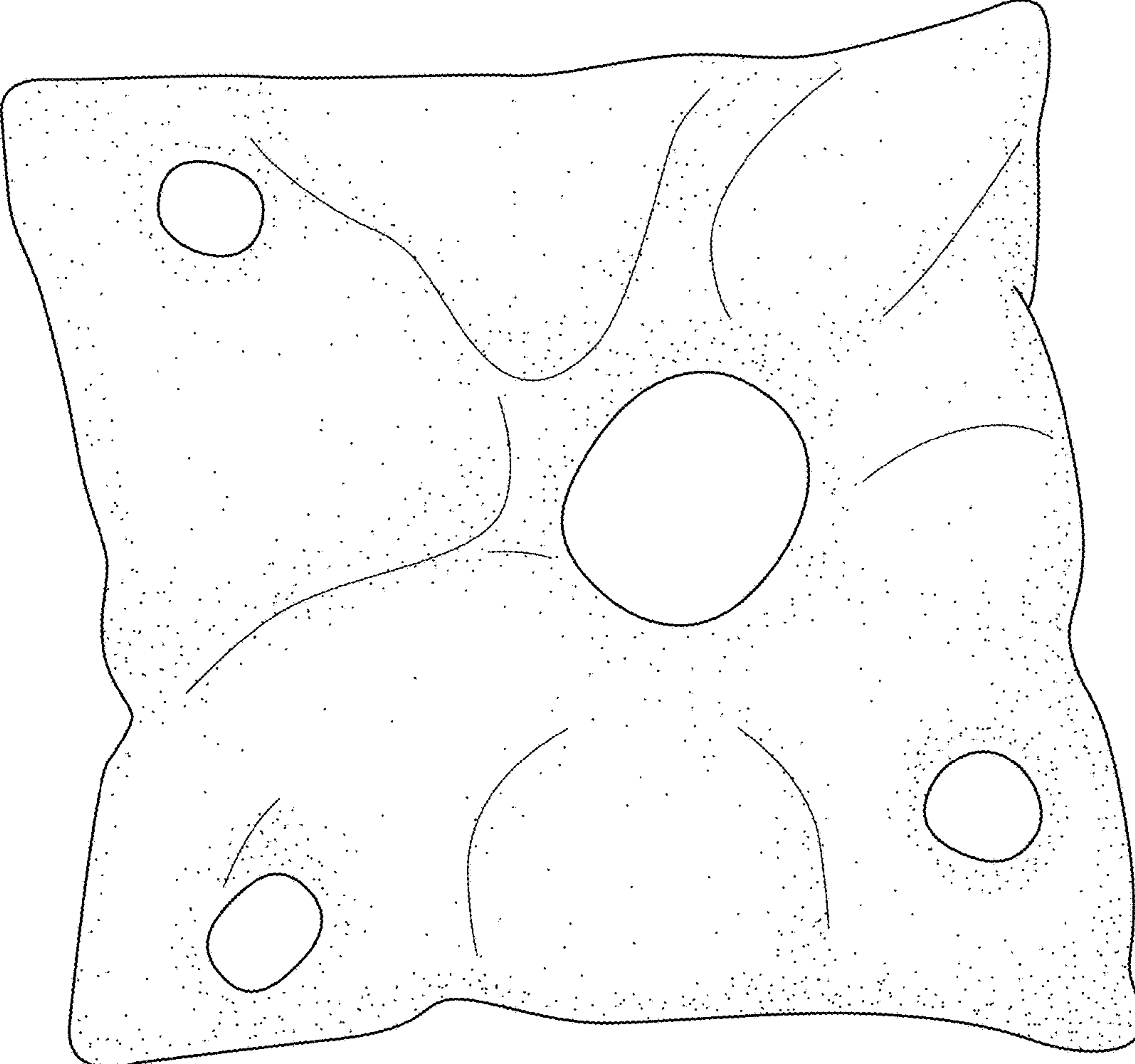

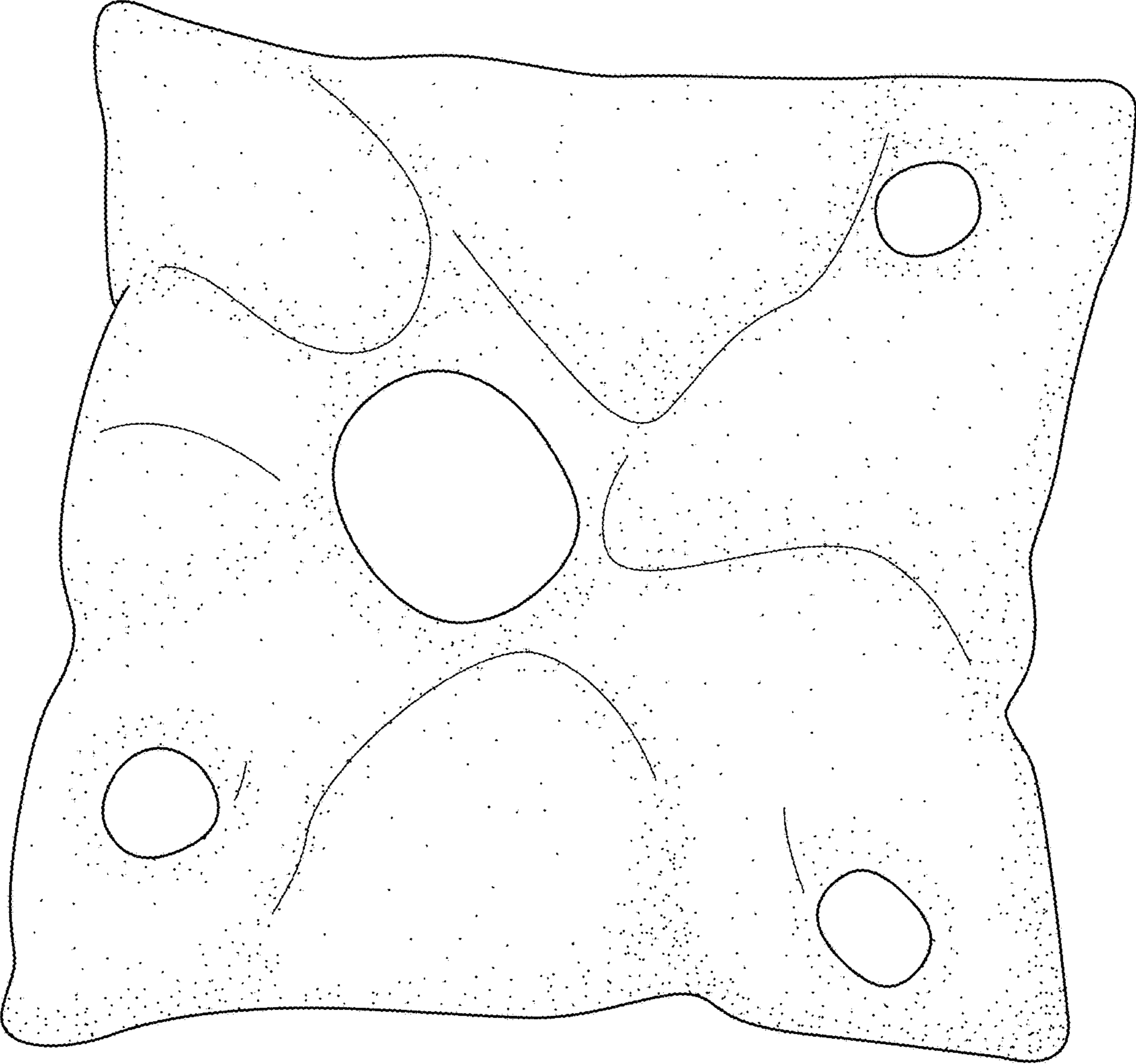

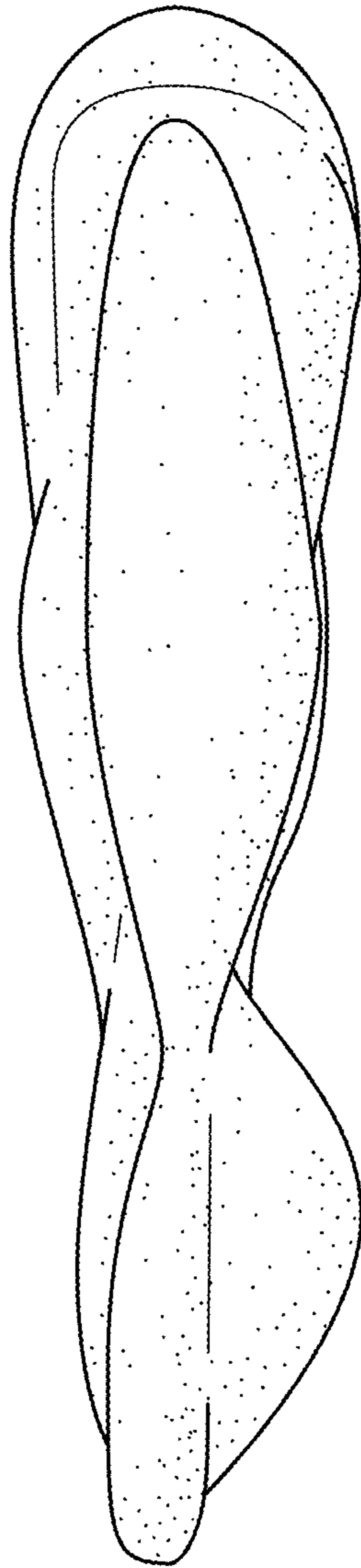

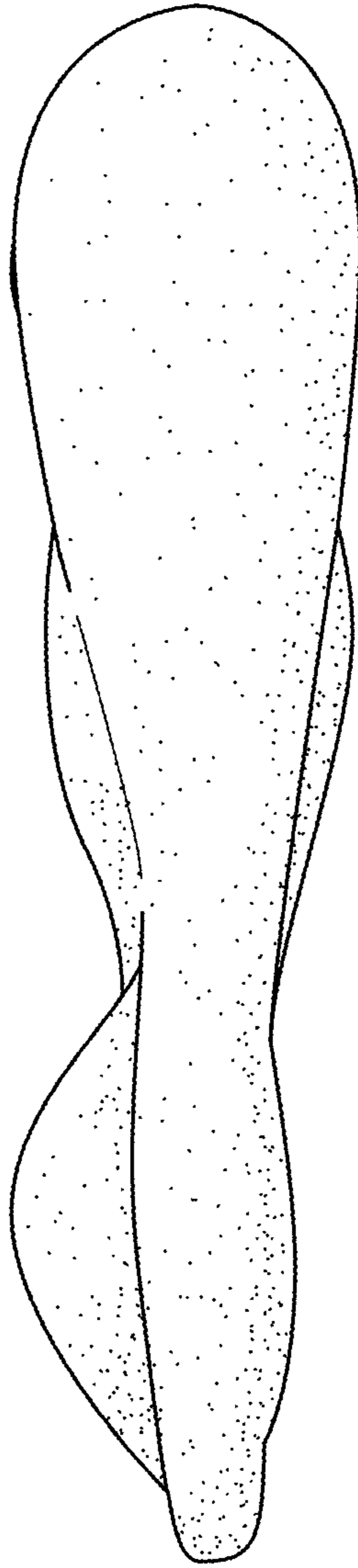

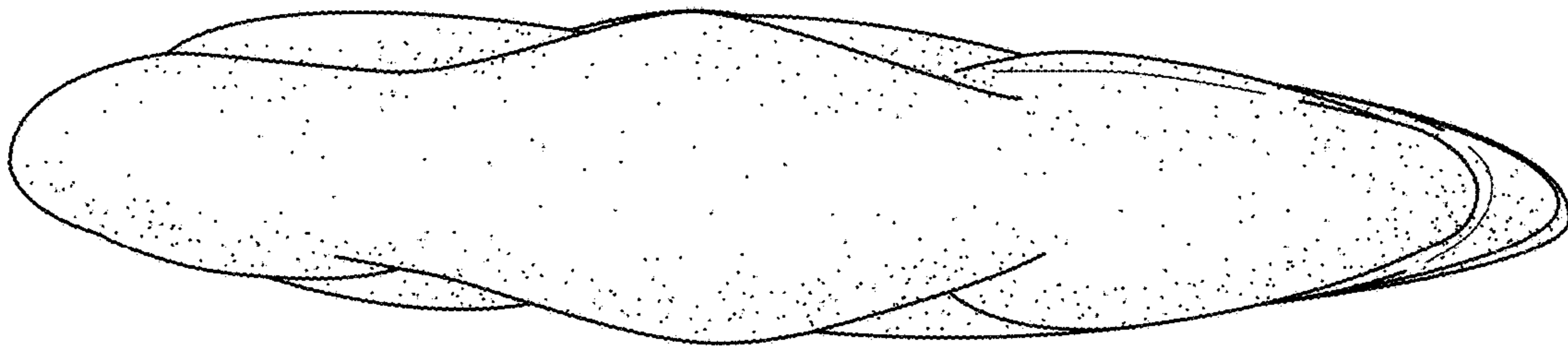

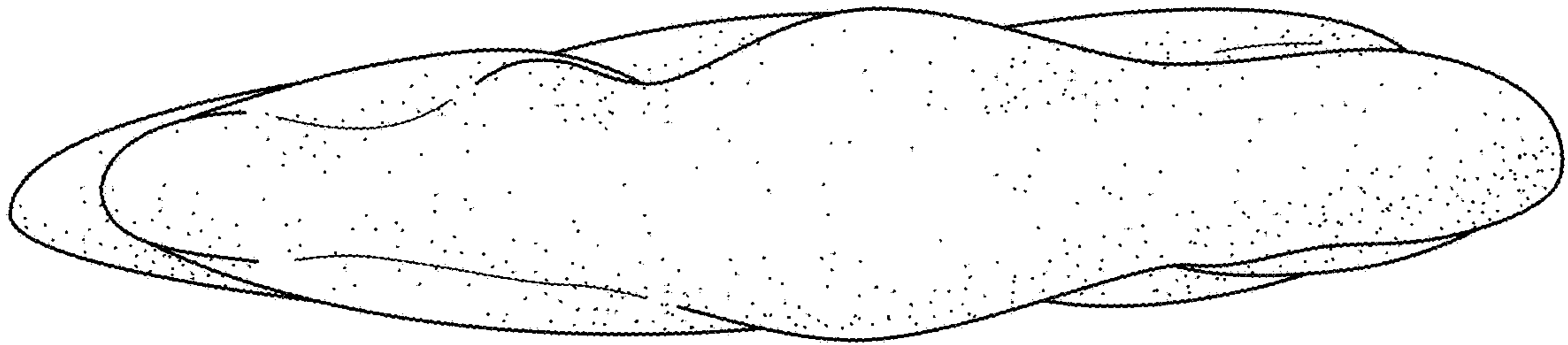

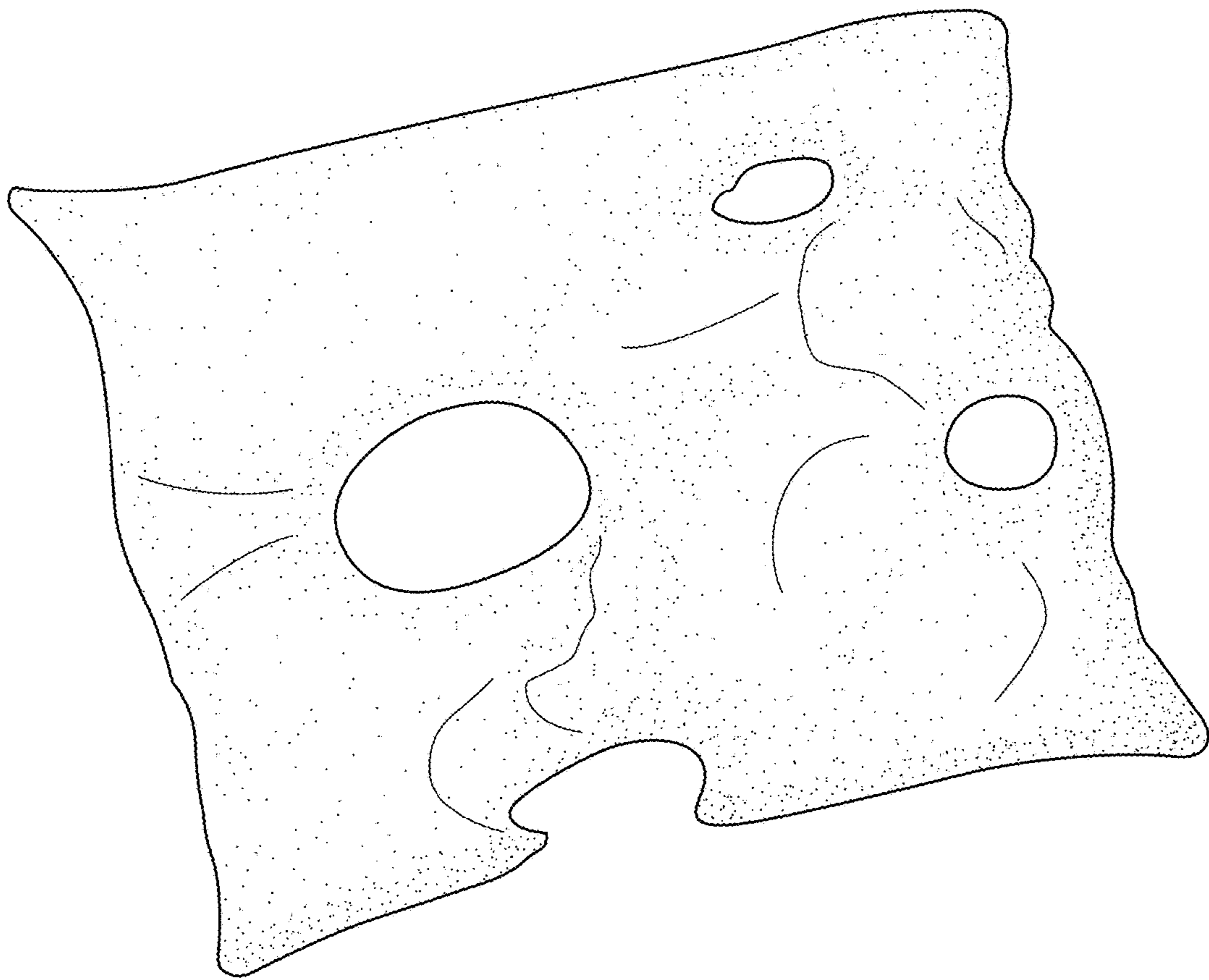

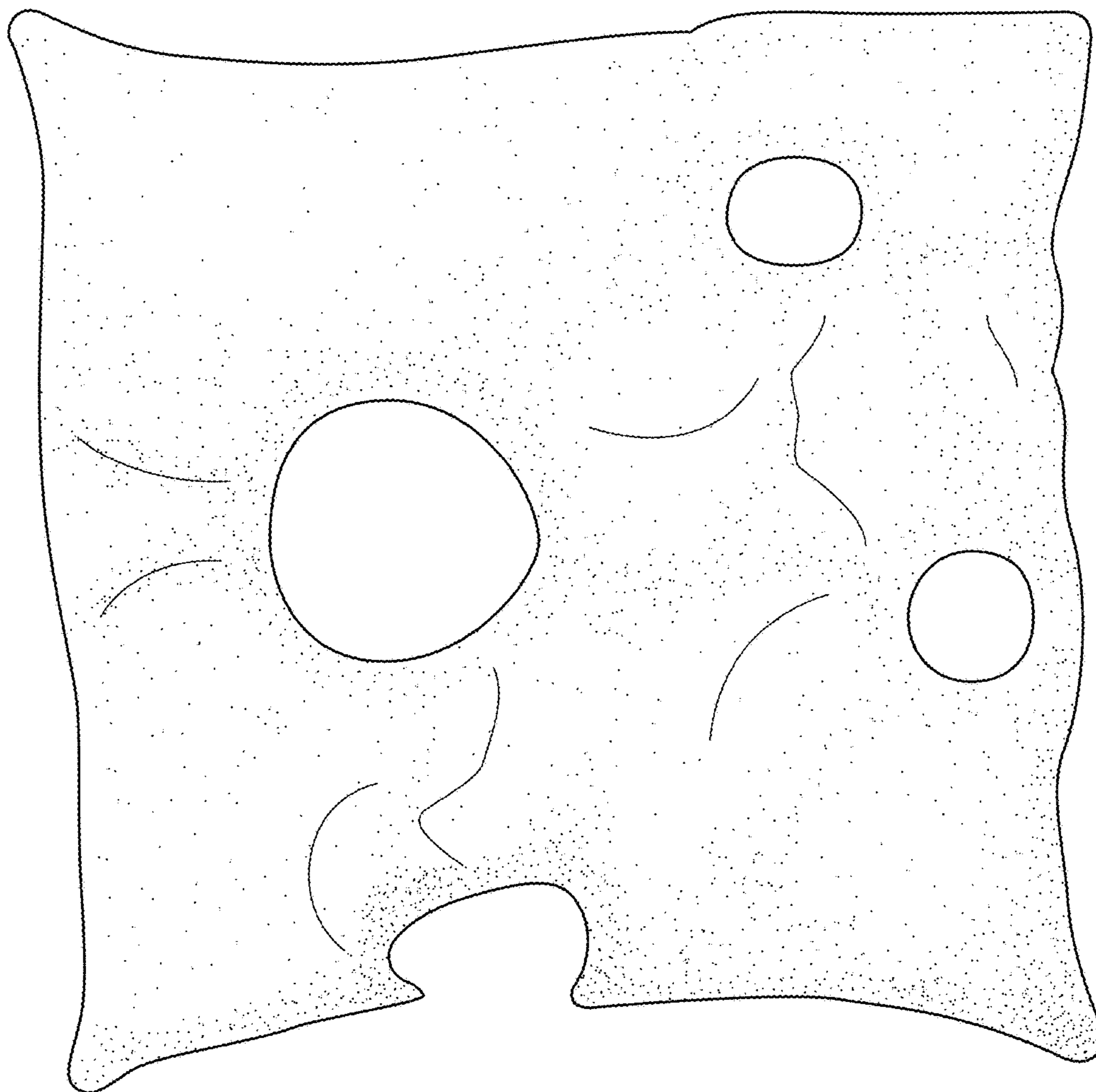

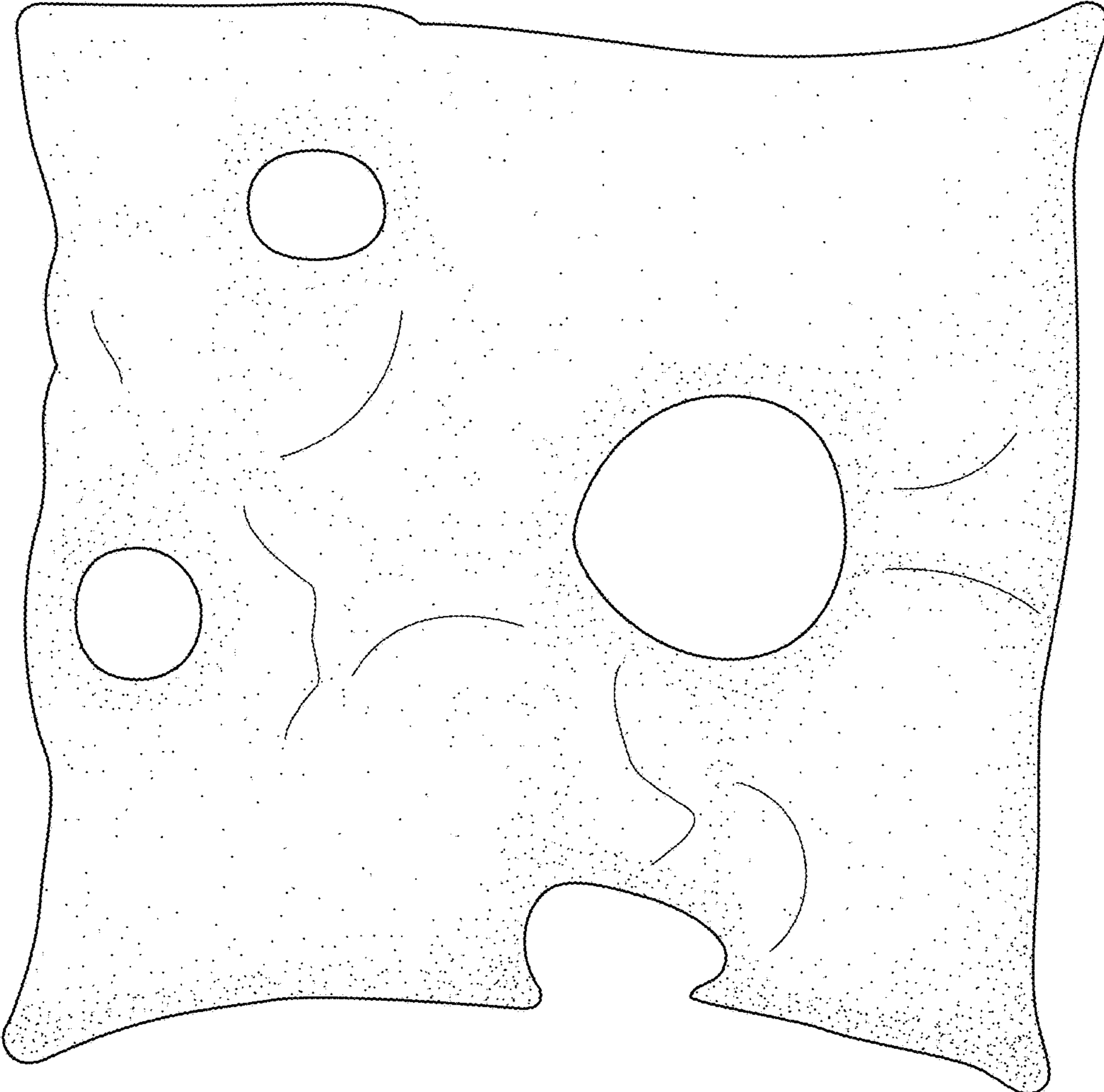

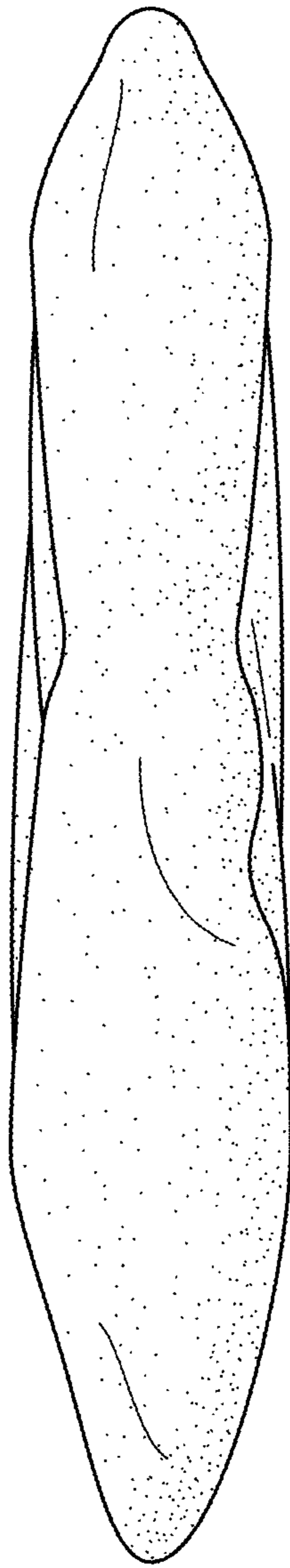

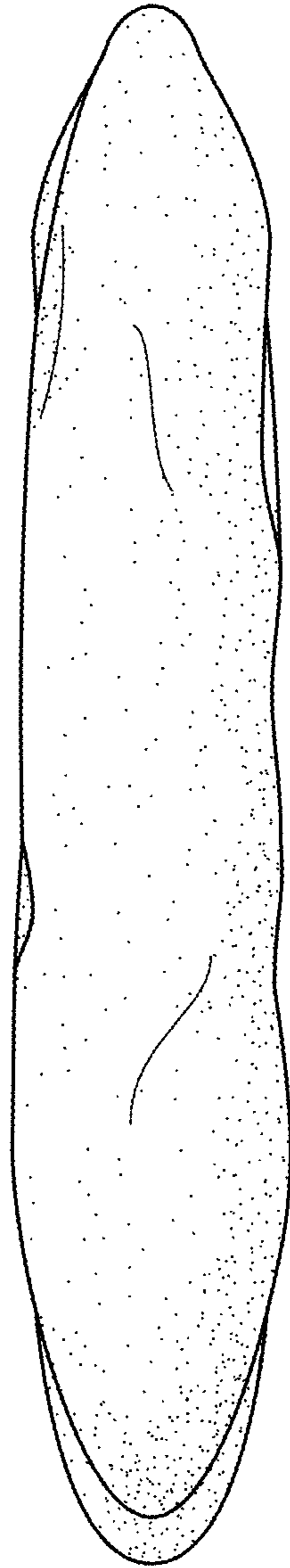

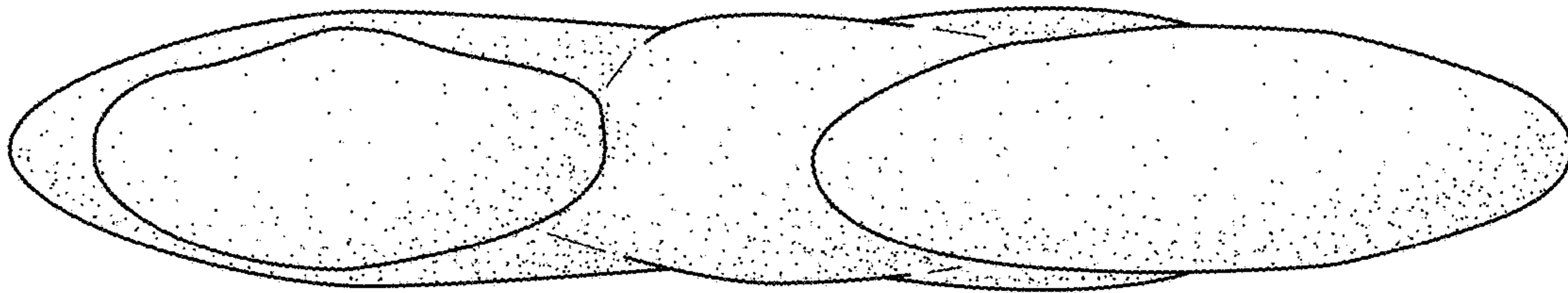

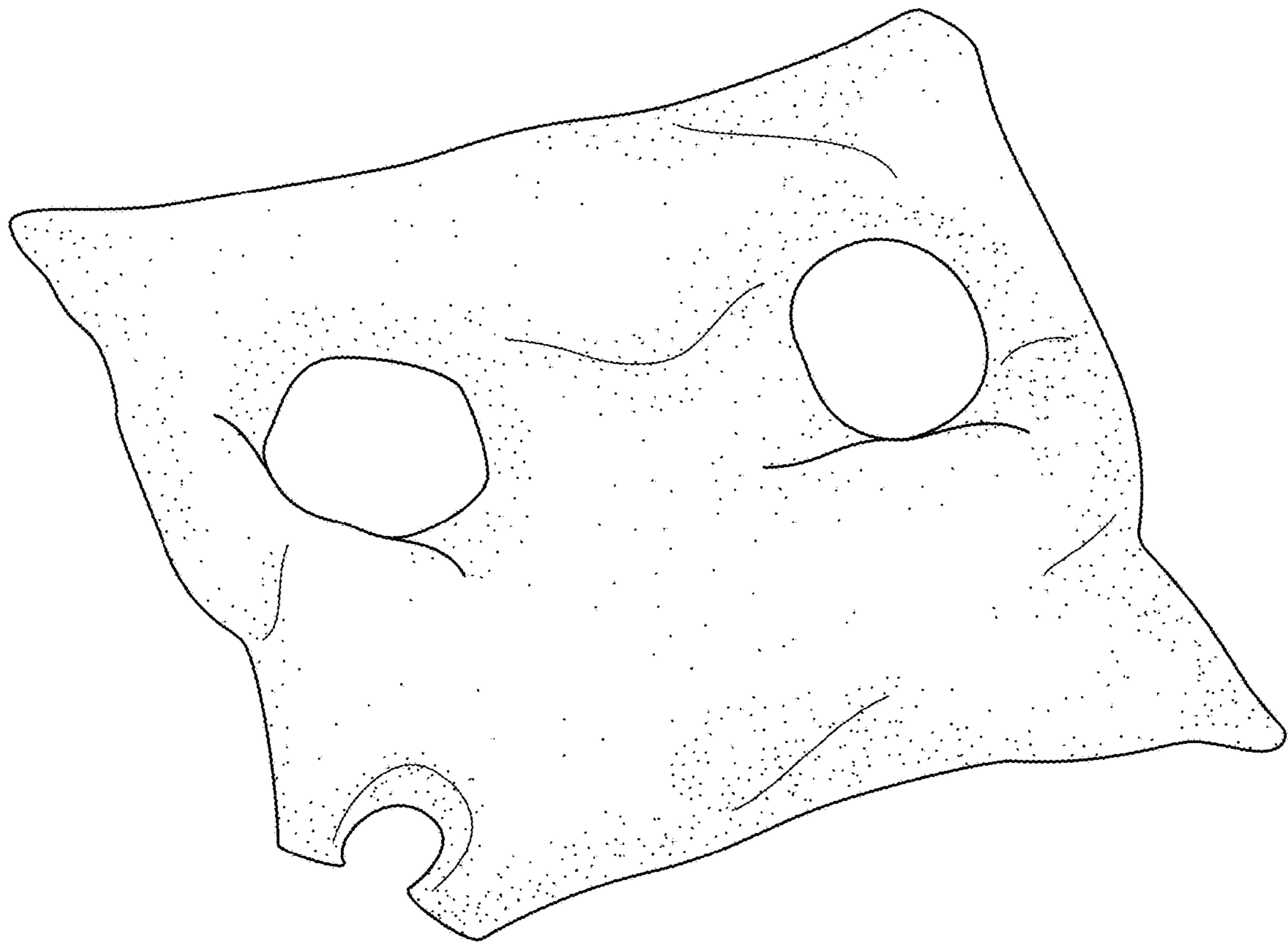

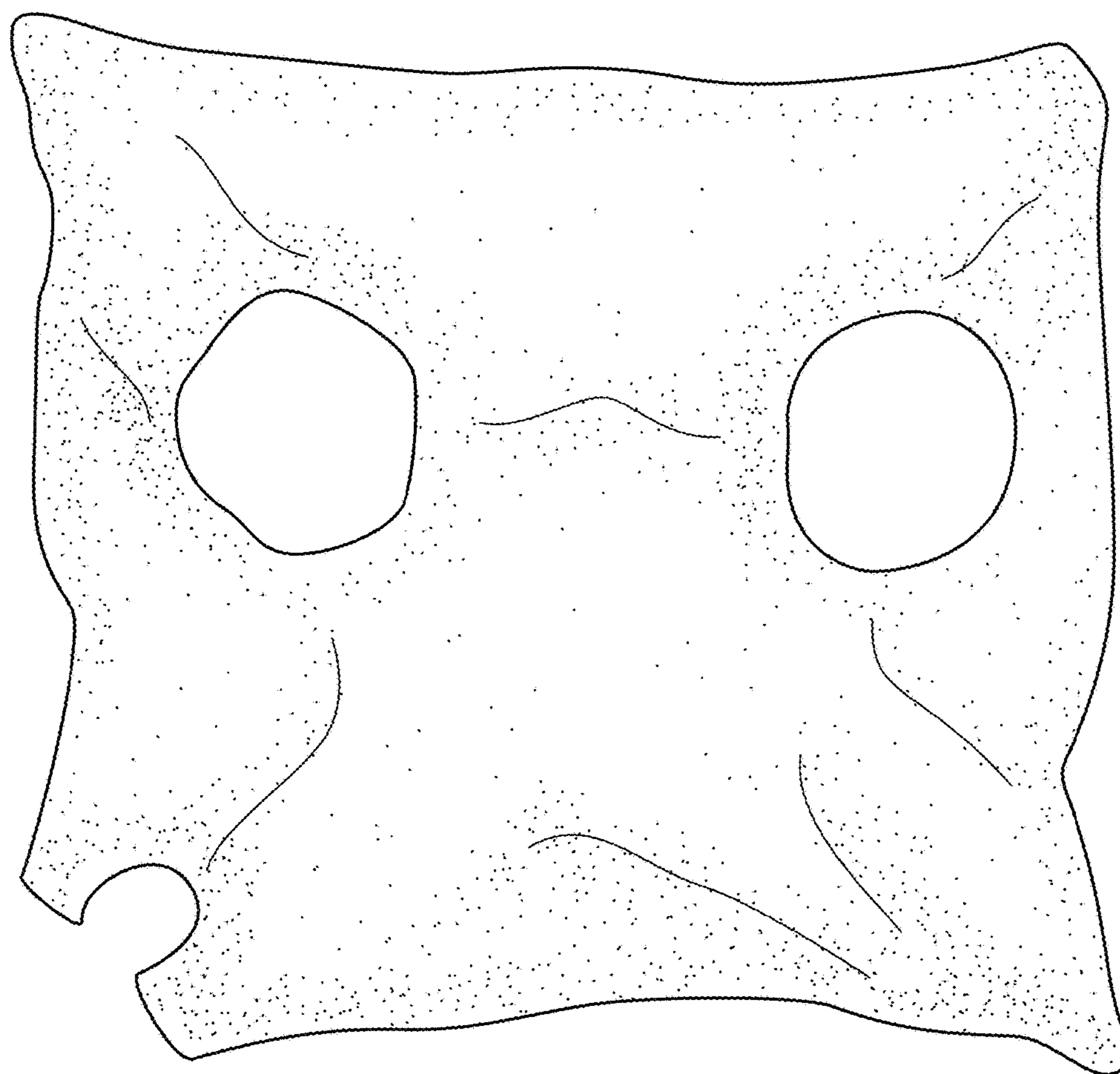

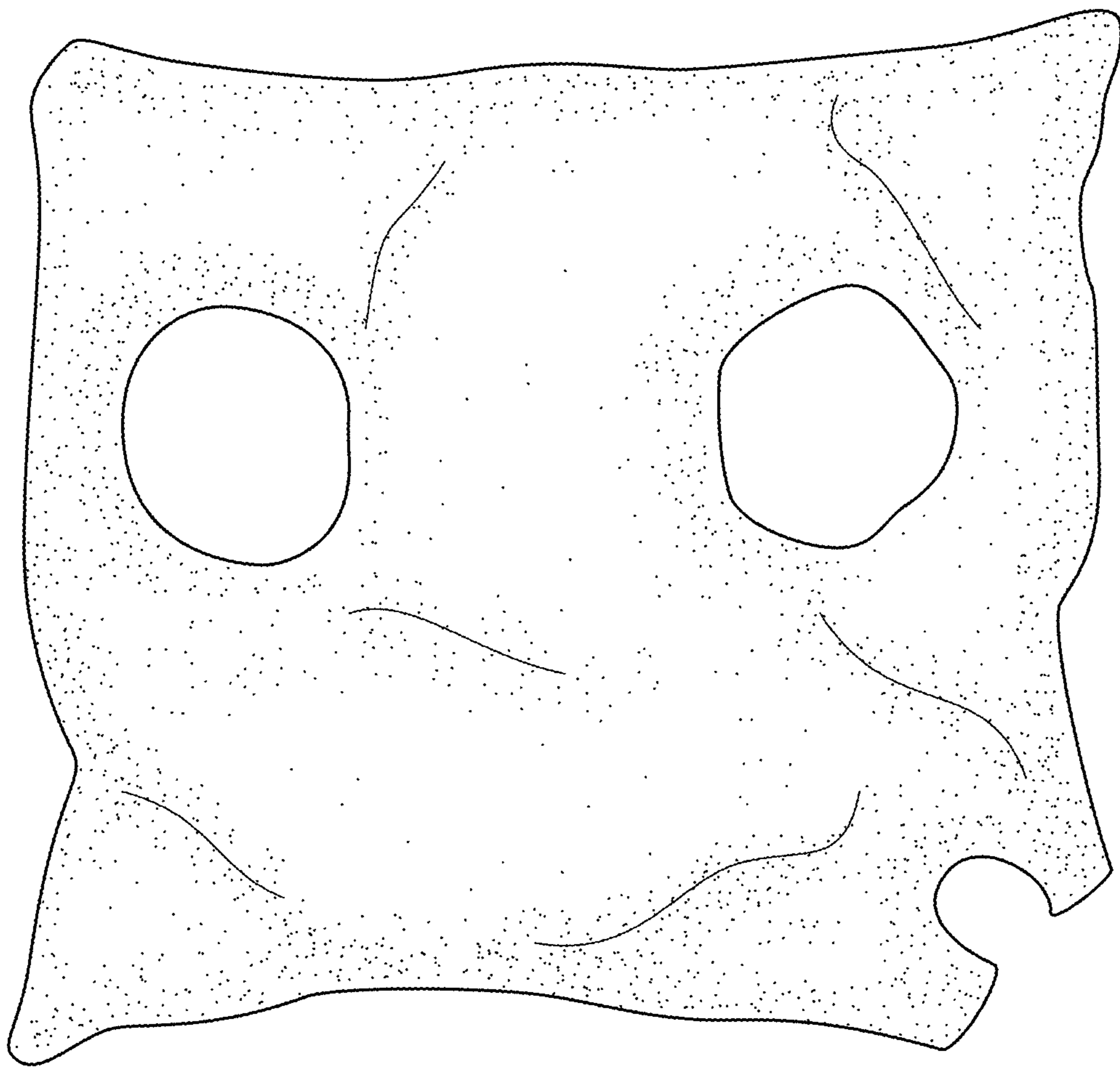

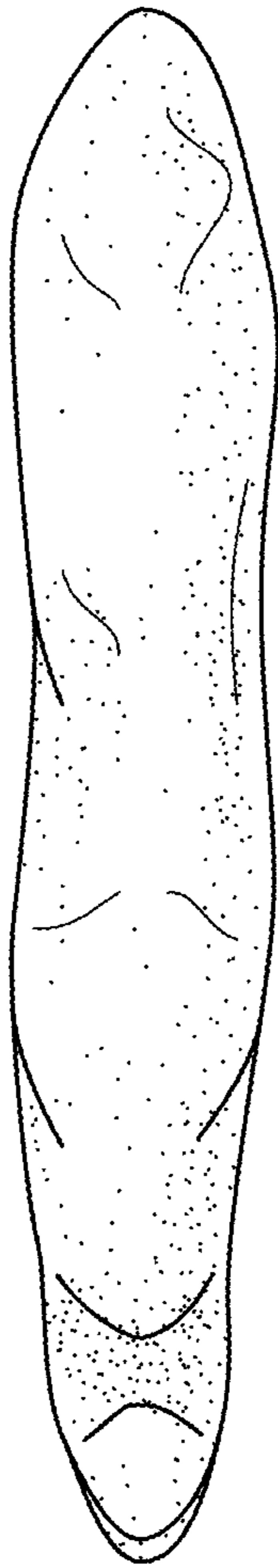

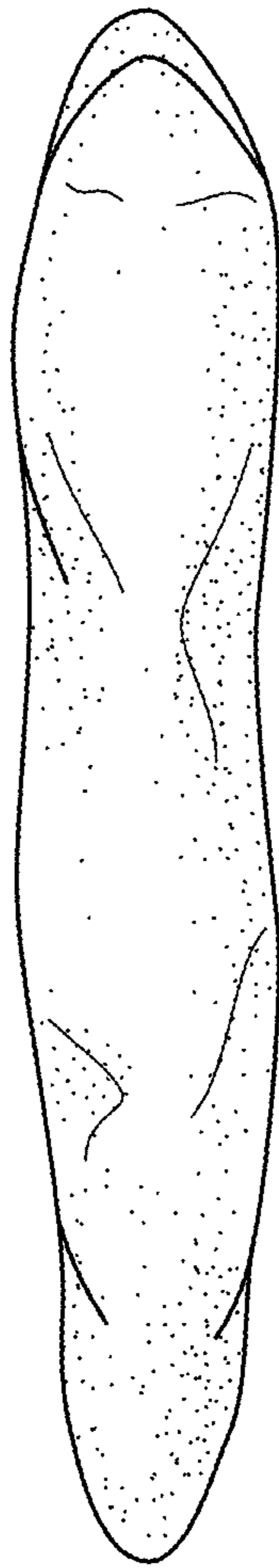

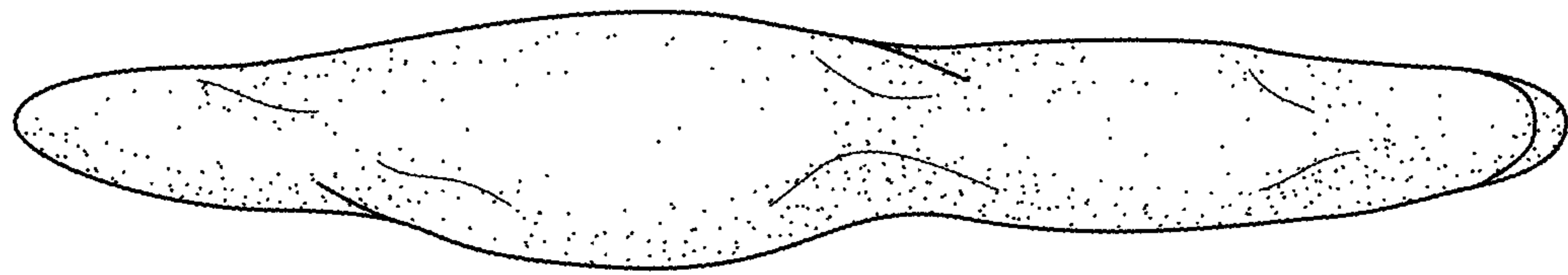

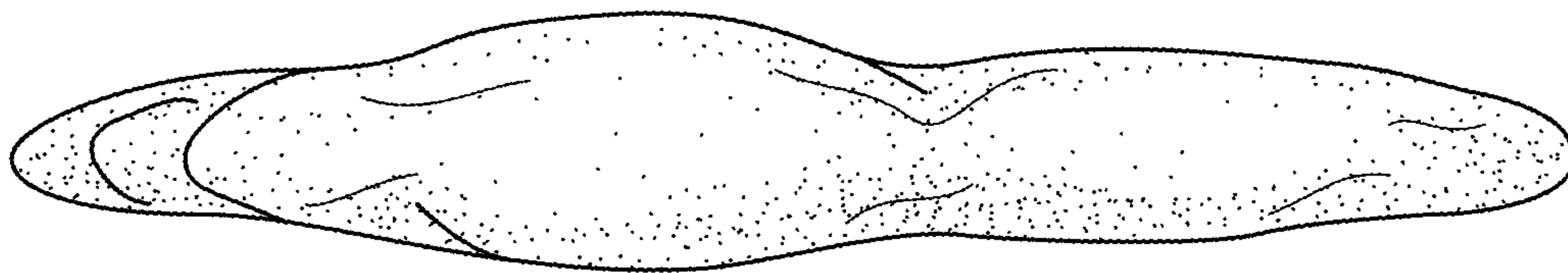

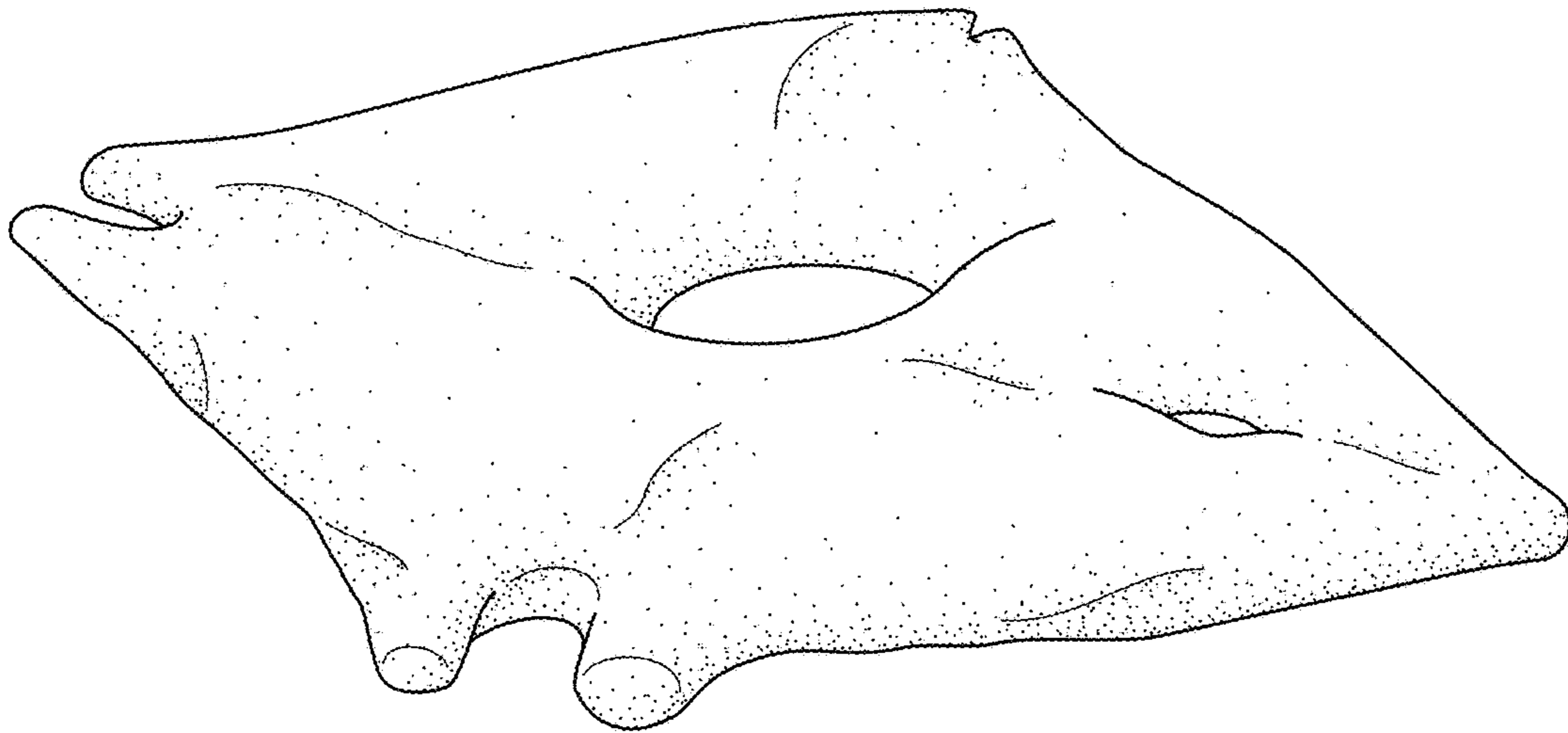

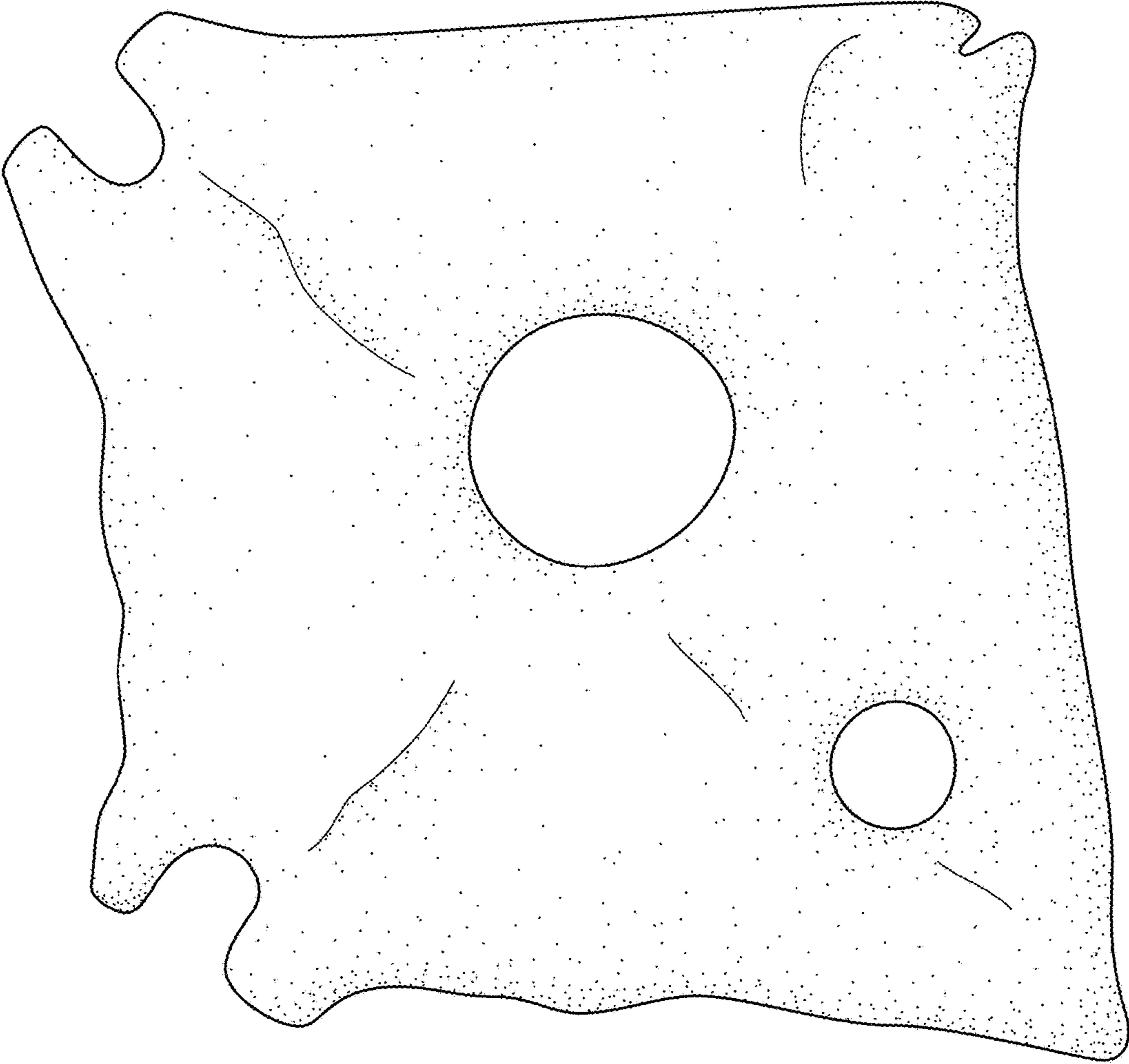

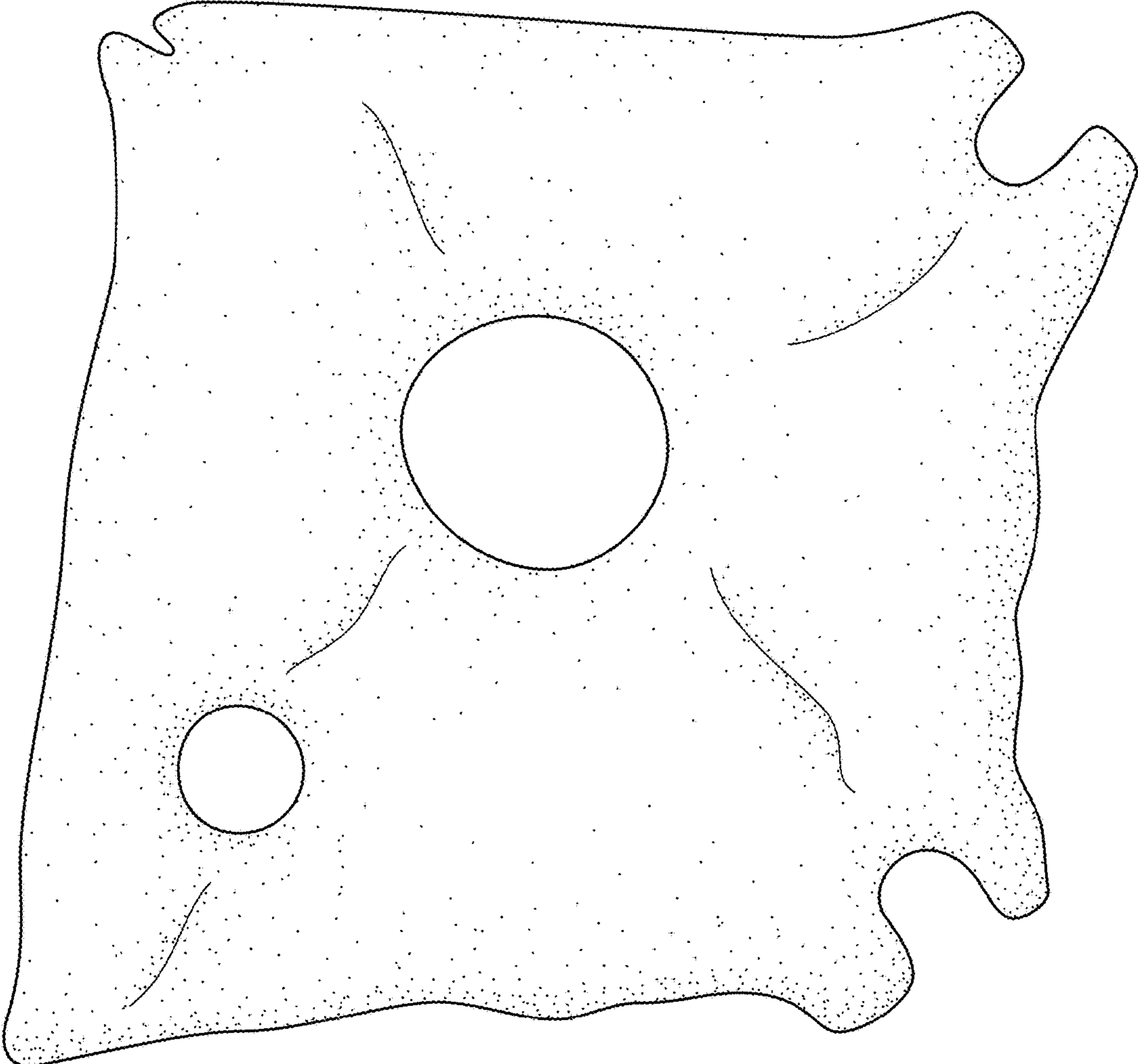

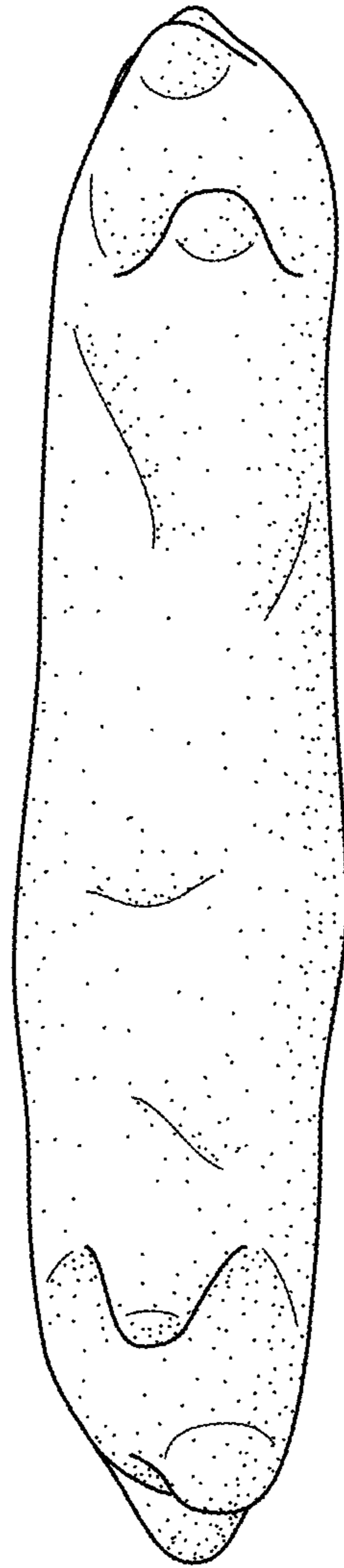

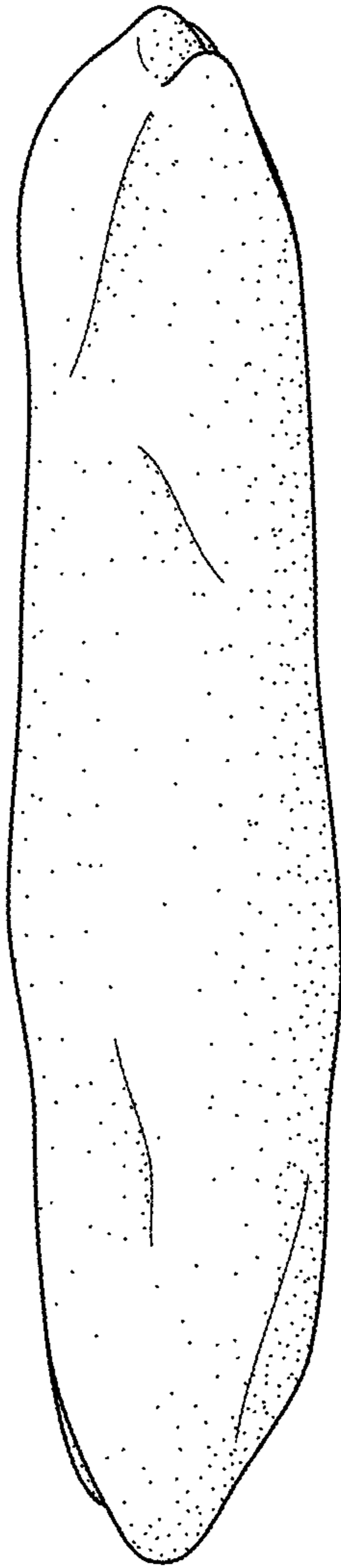

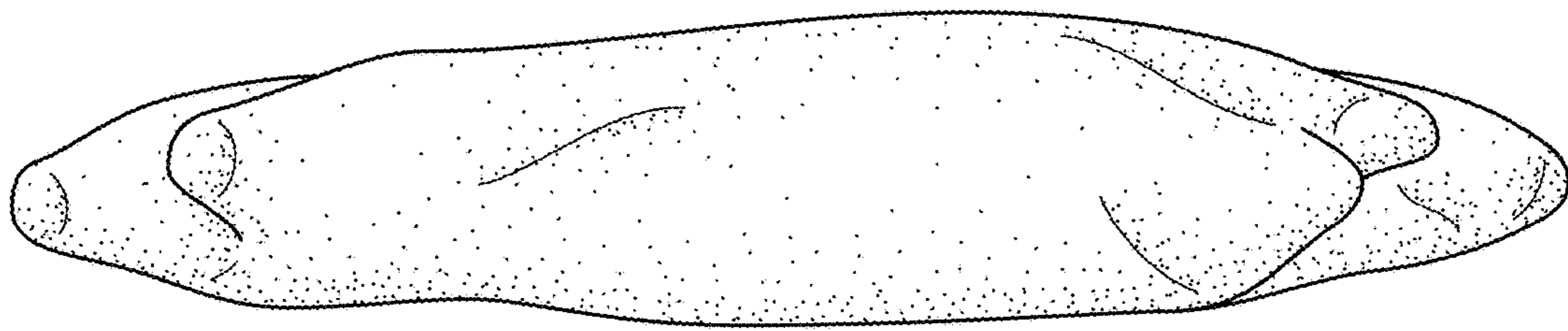

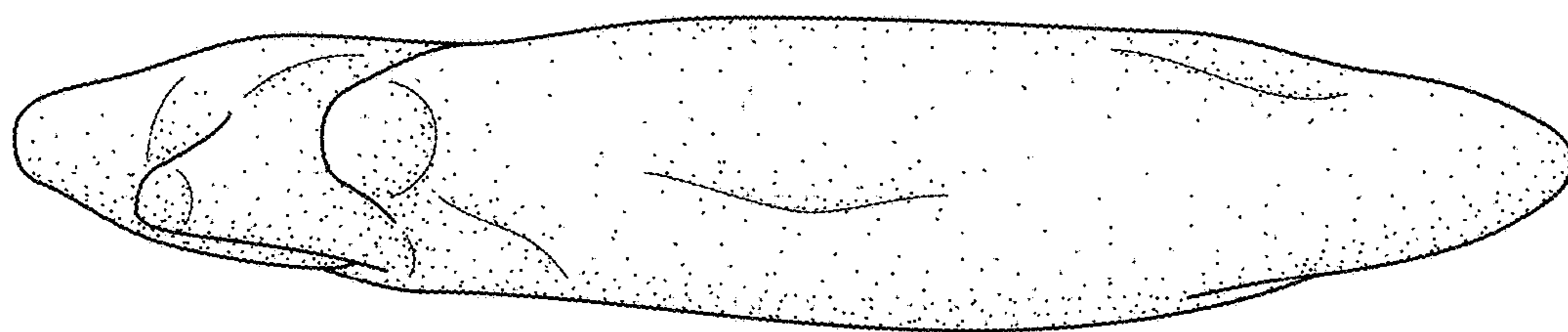
