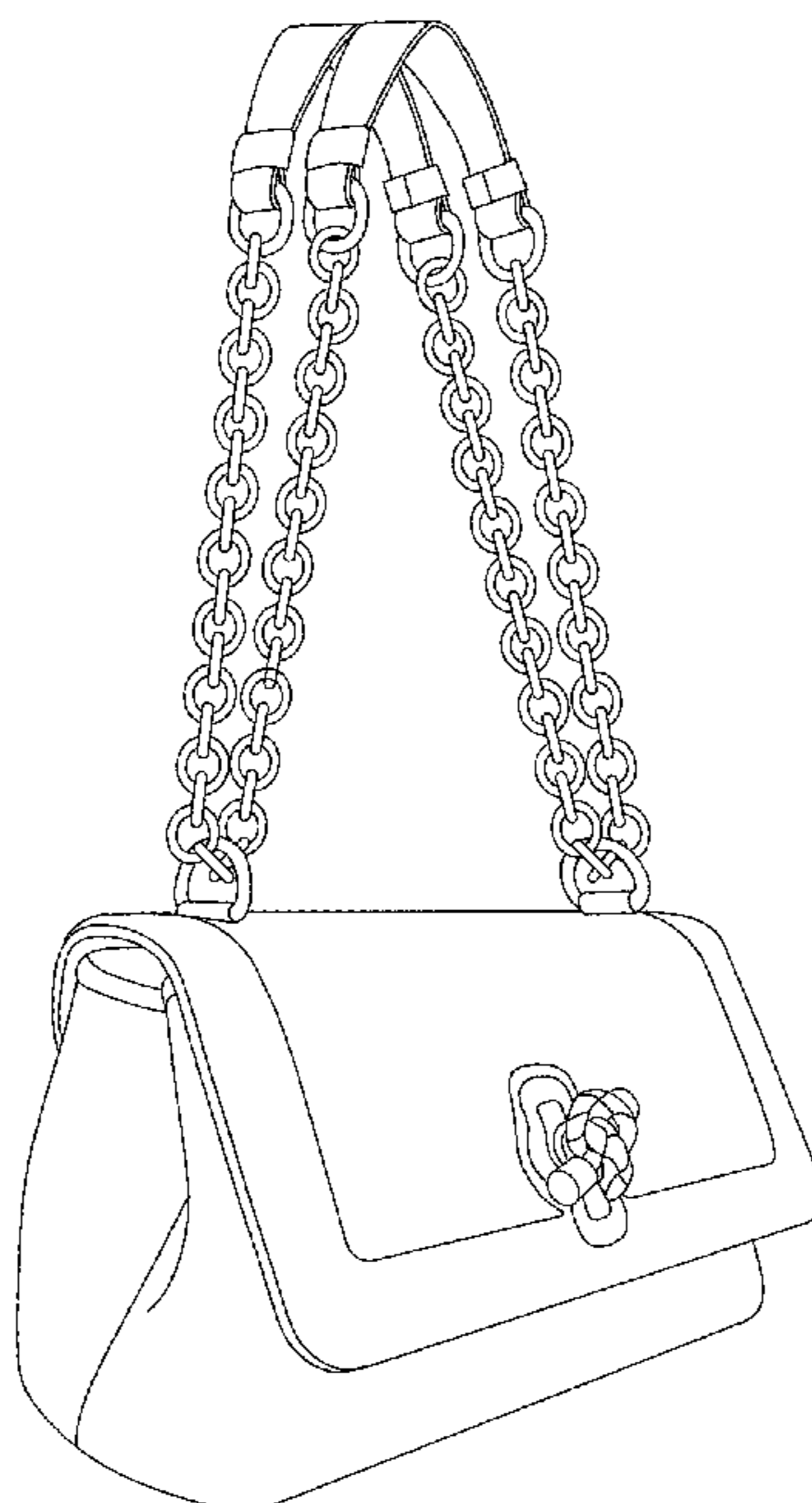

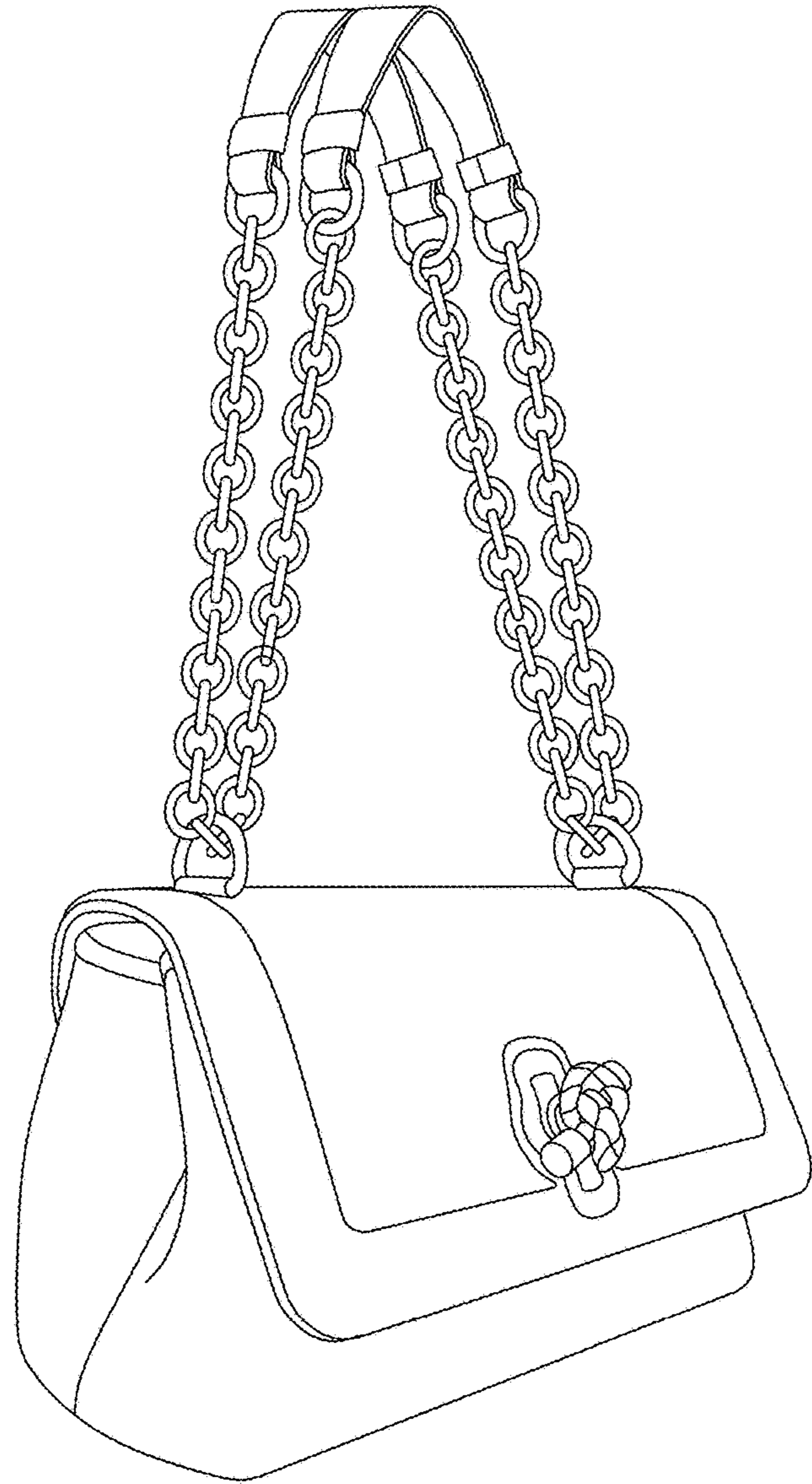
DESCRIPTION

- 15.7** is a bottom view thereof.

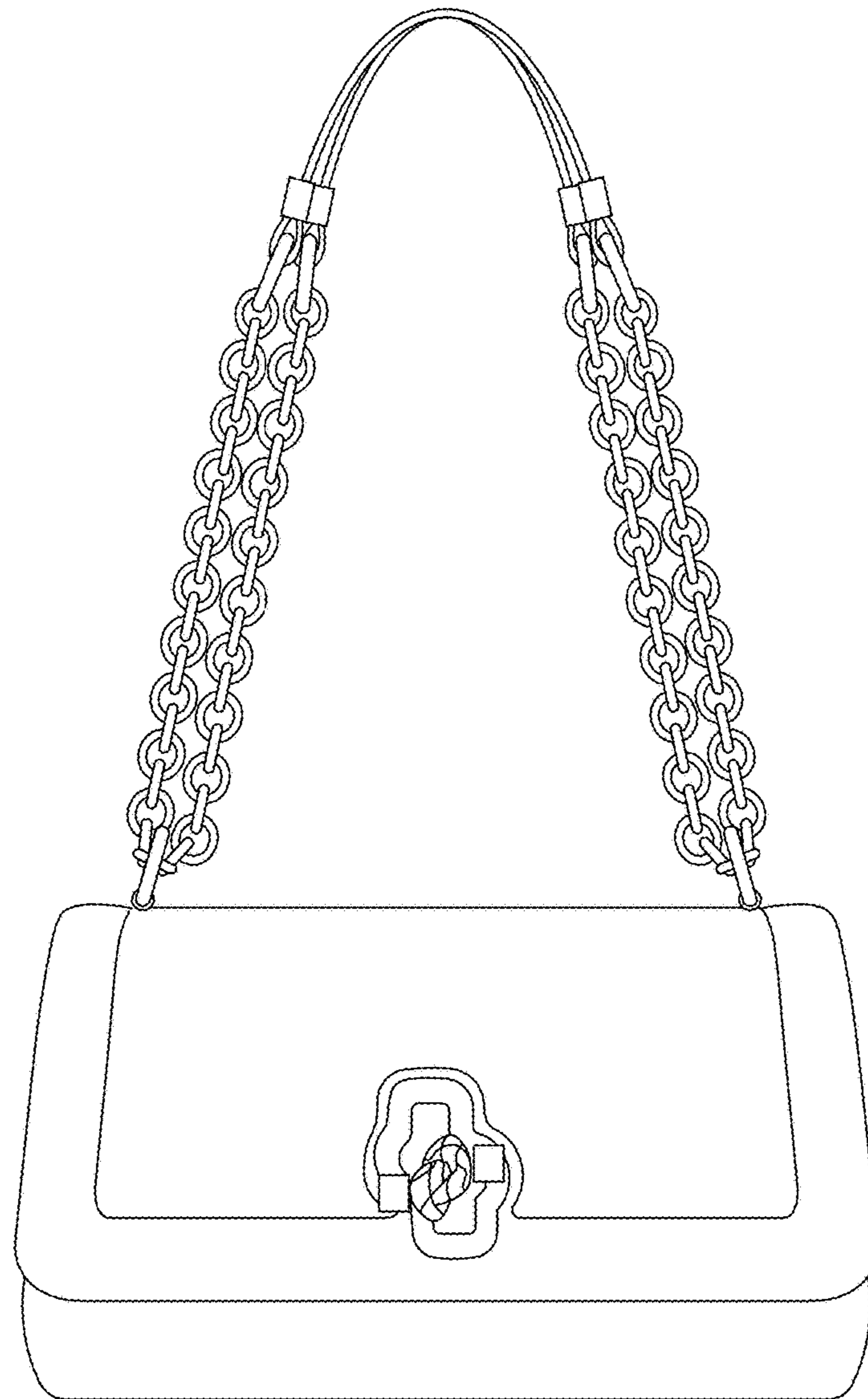

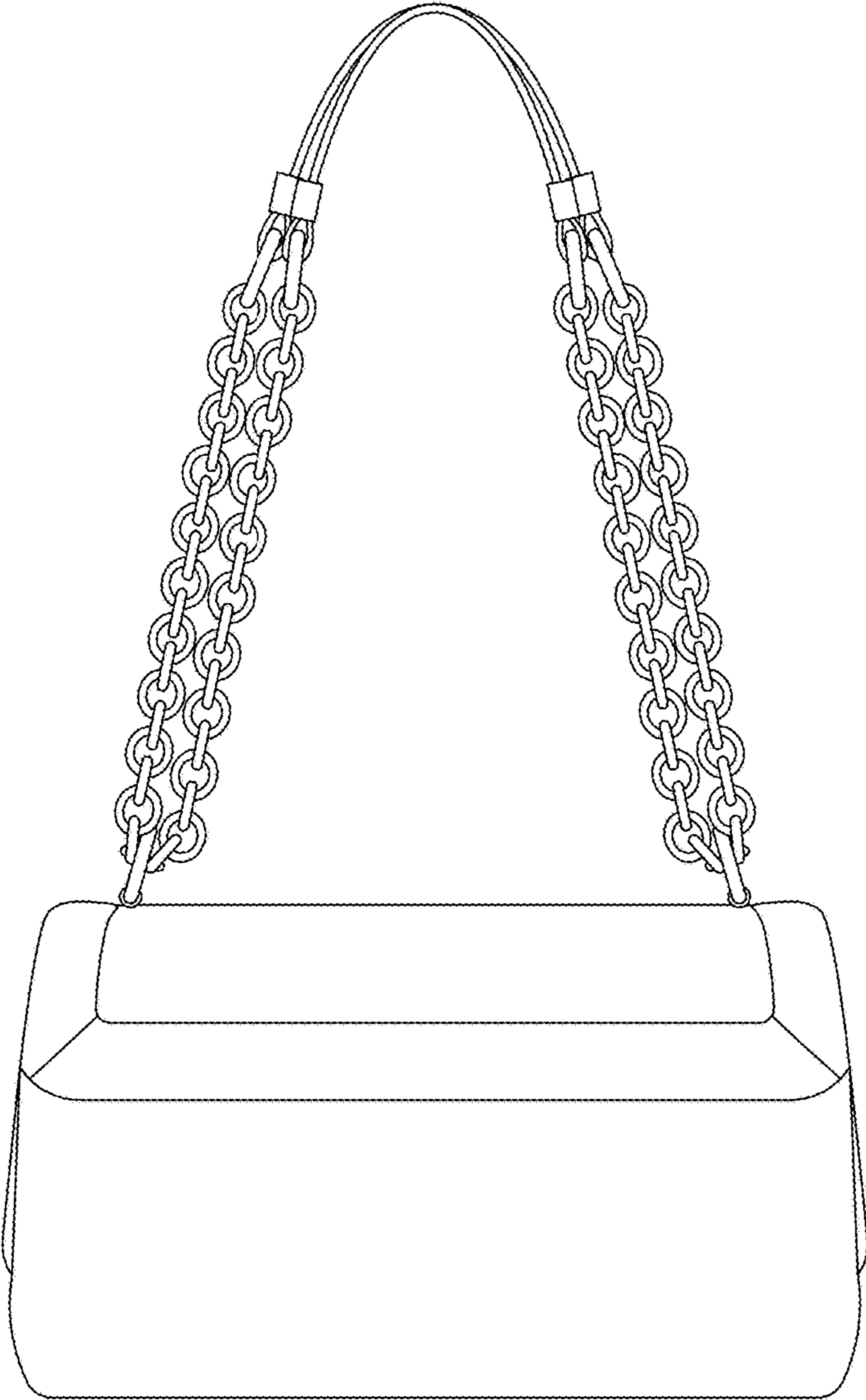




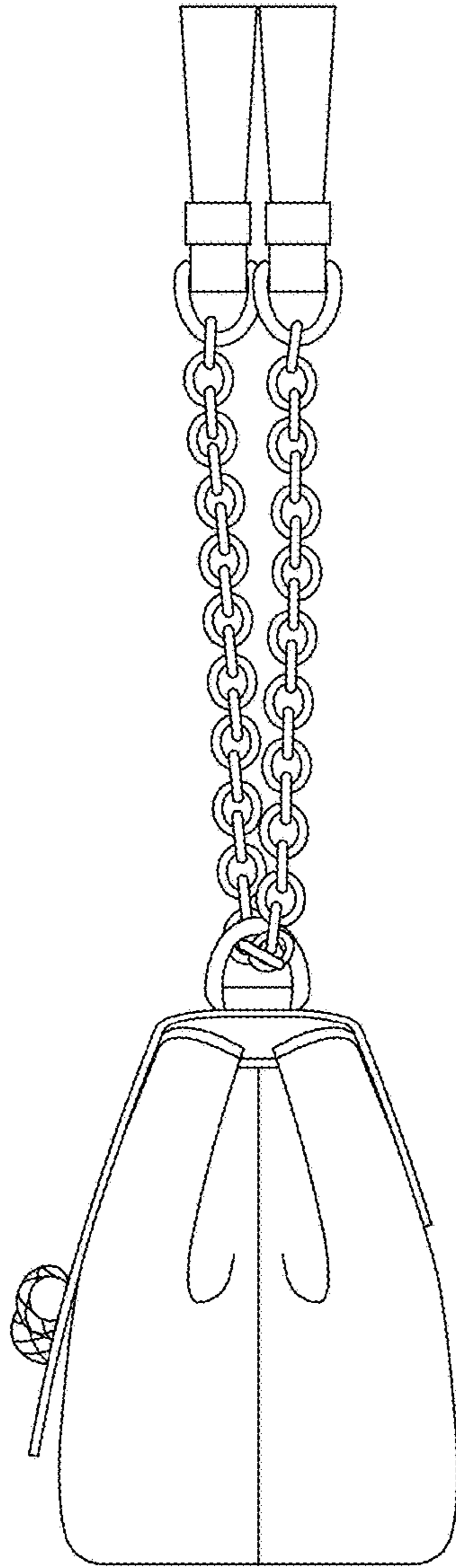

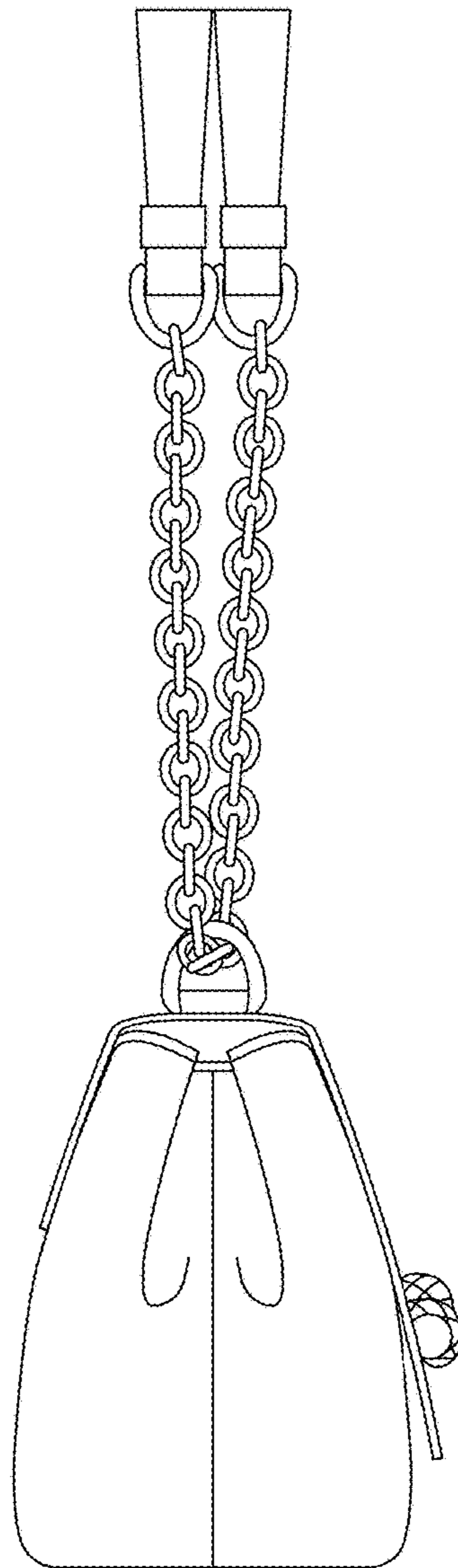
