(57) **CLAIM**

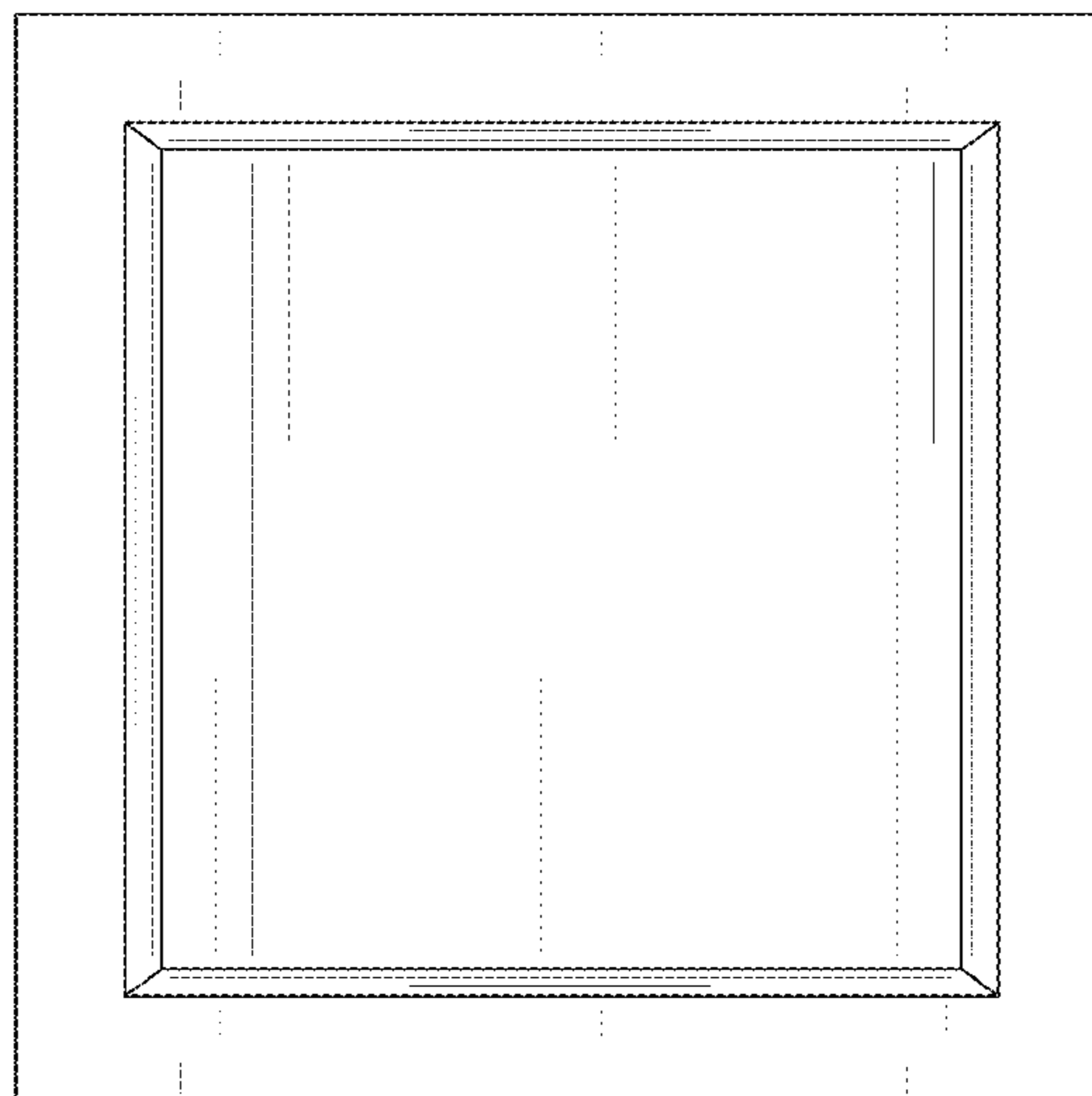
The ornamental design for a stand, as shown and described.

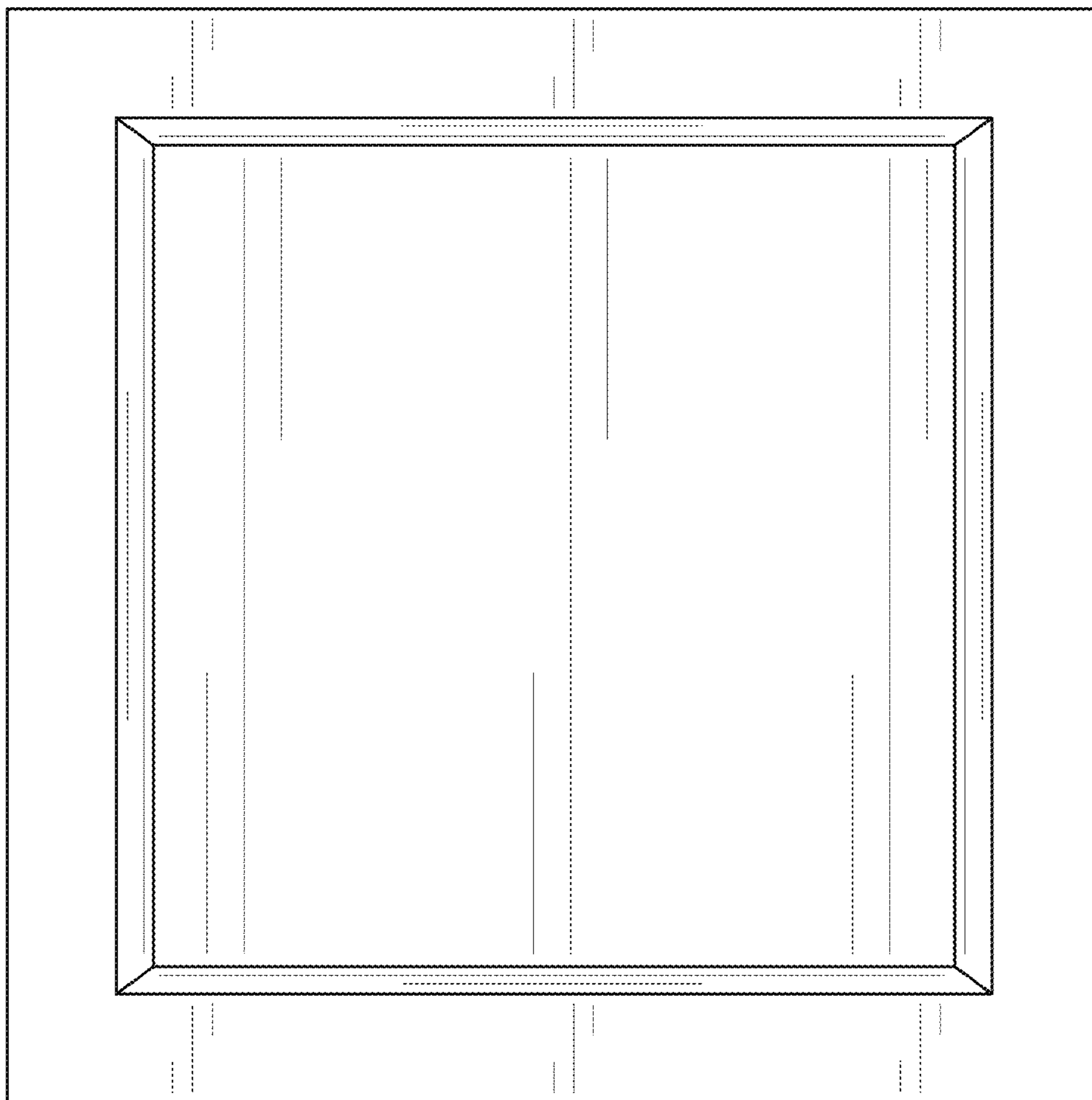

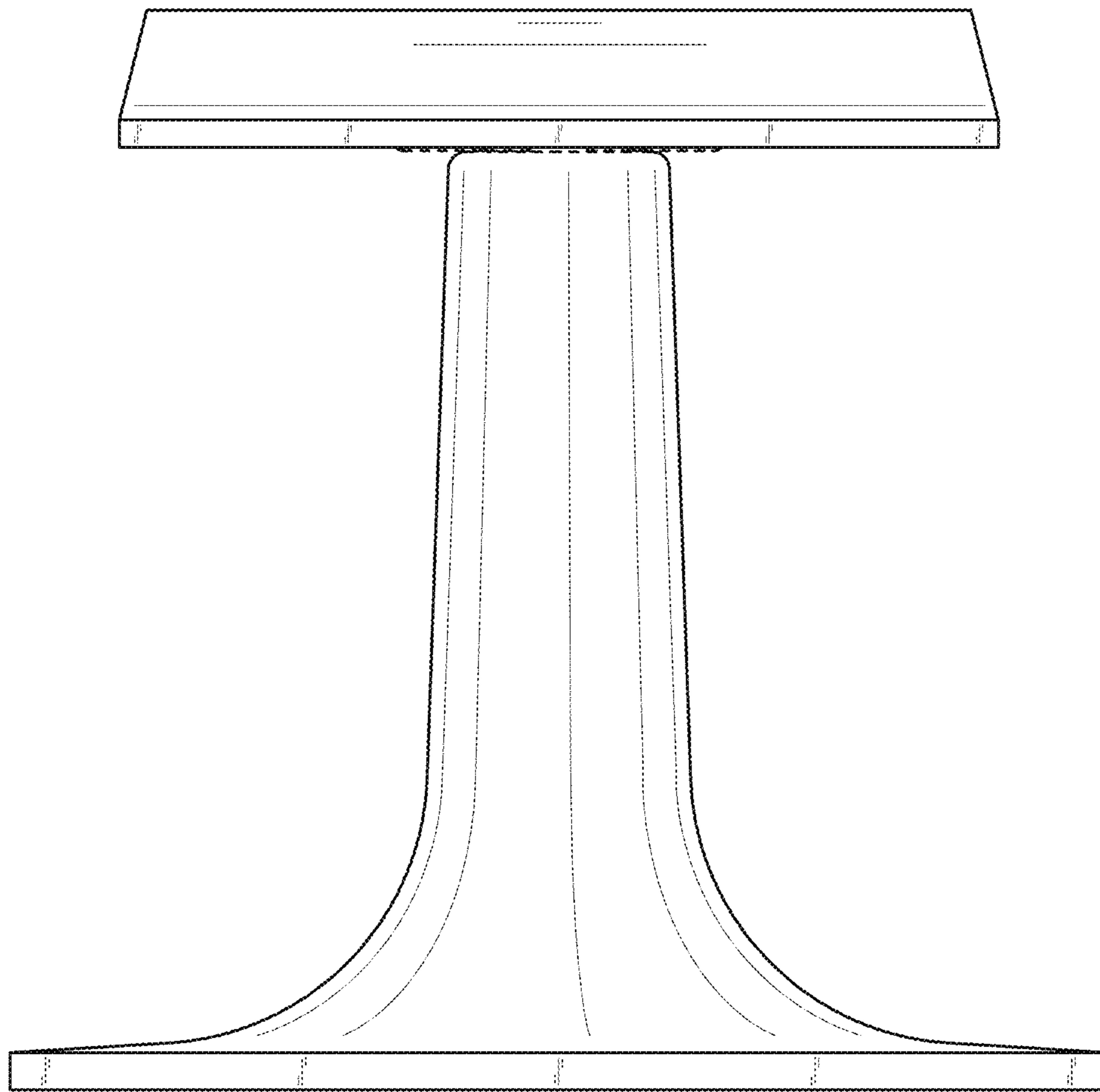
