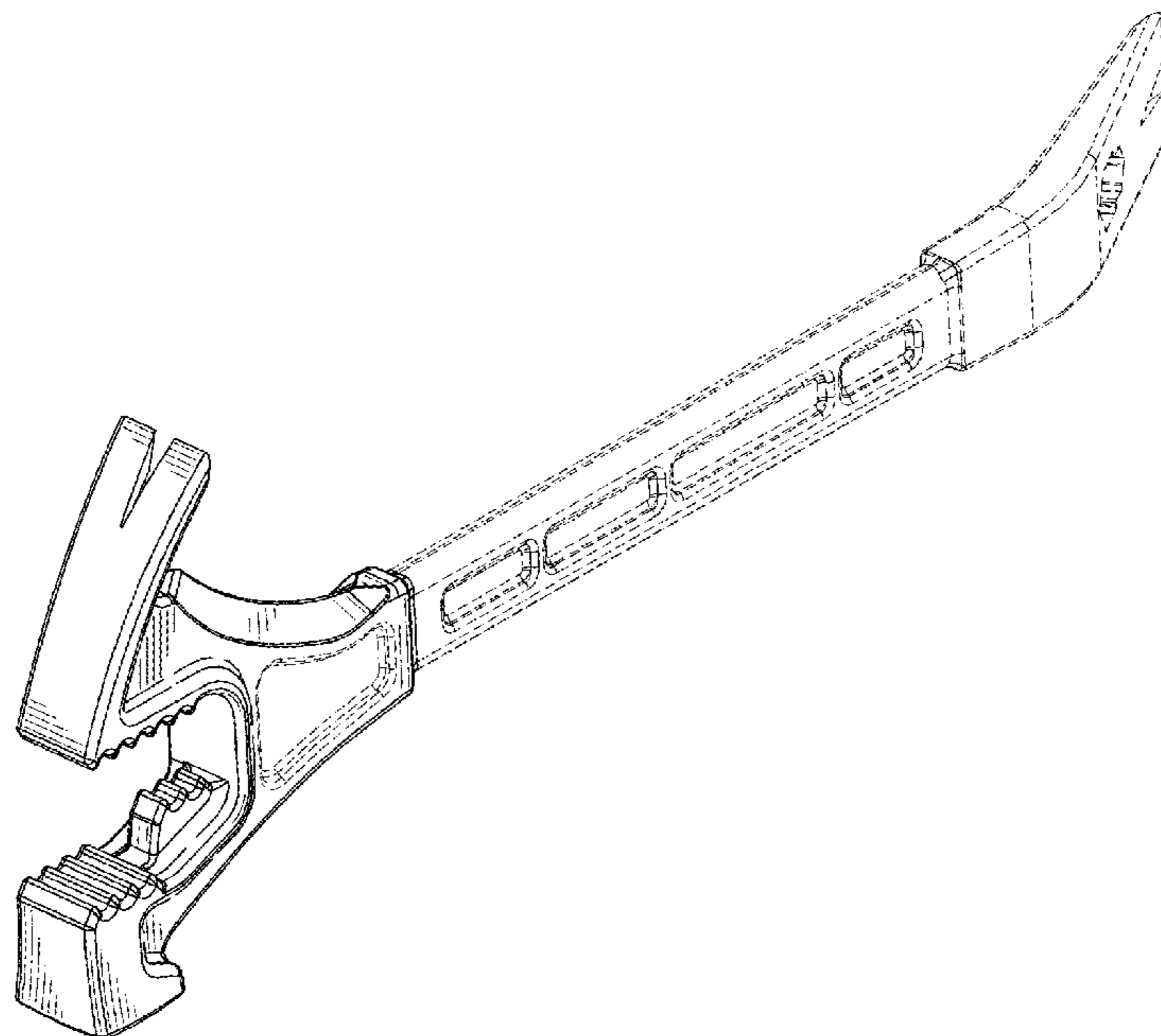
(57) **CLAIM**

I claim the ornamental design for a wrecking tool, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of the wrecking tool according to my new design;
FIG. 2 is a bottom, rear perspective view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a front elevation view thereof; and,
FIG. 8 is a rear elevation view thereof.

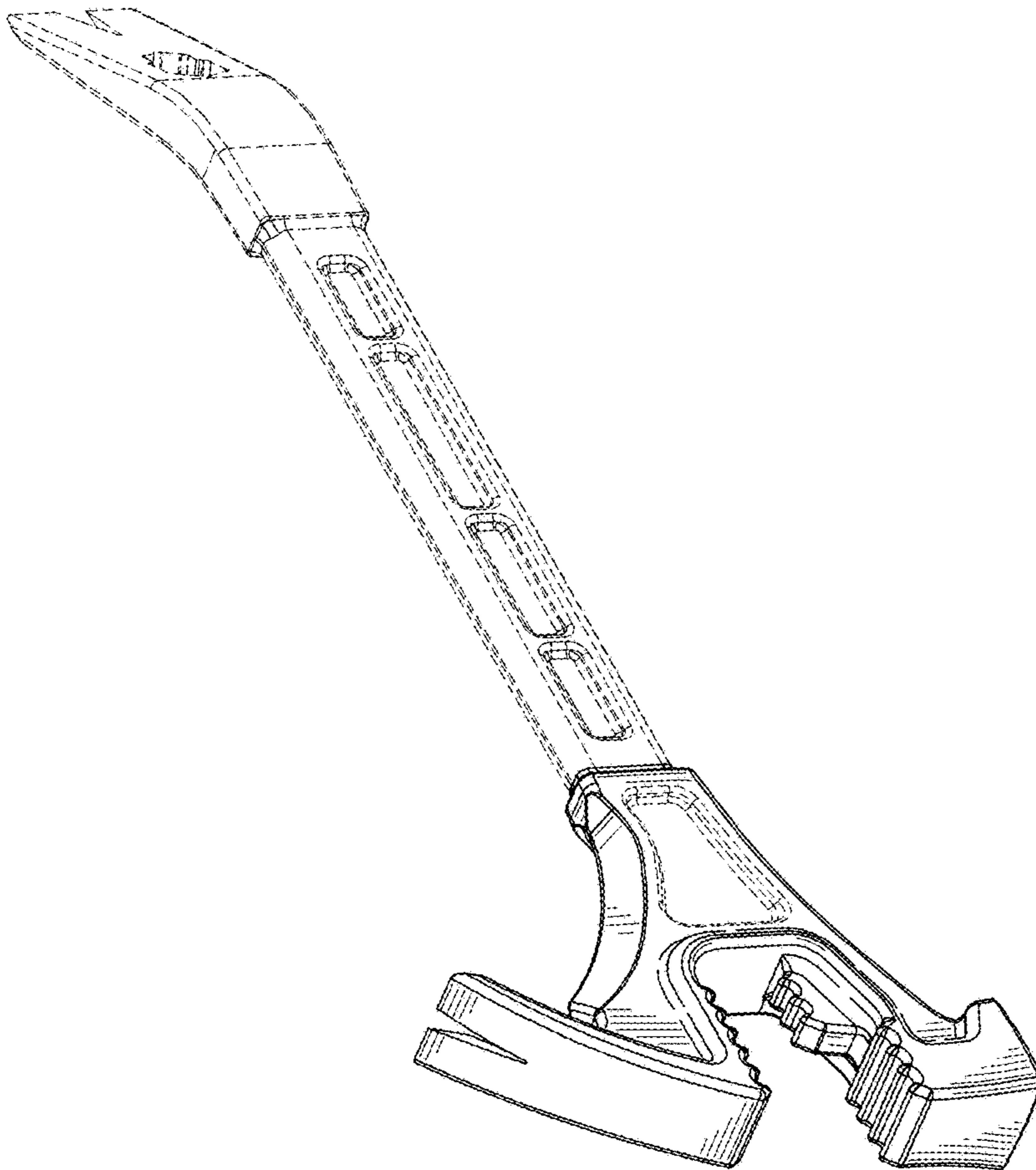

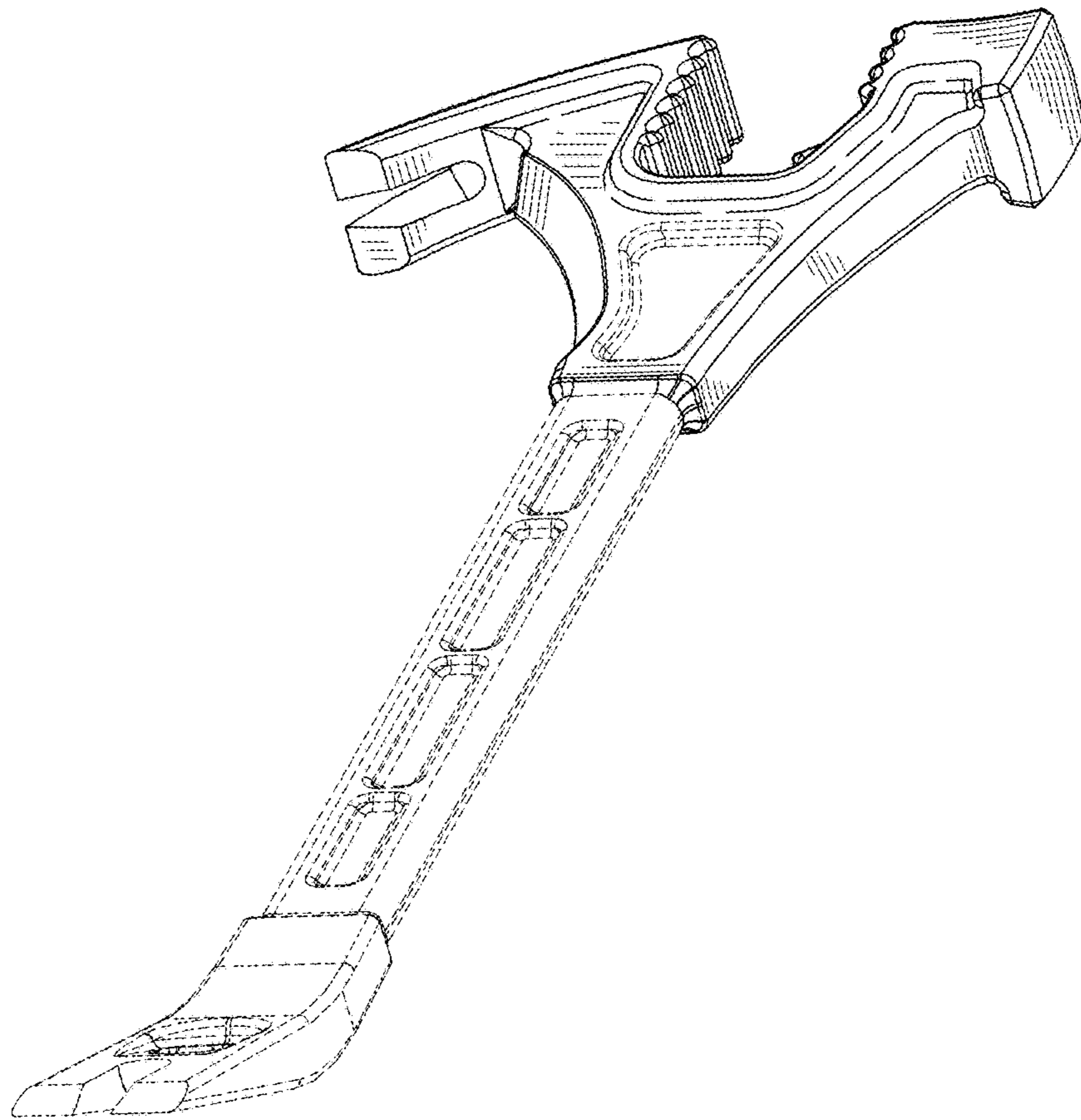

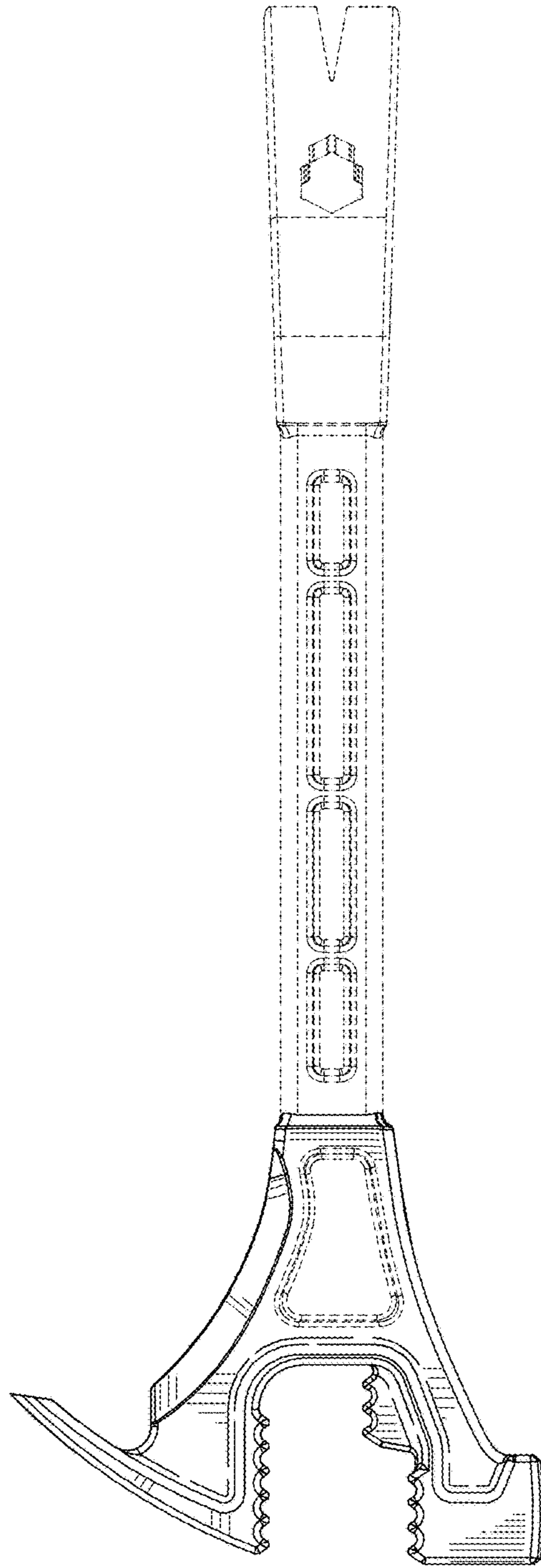

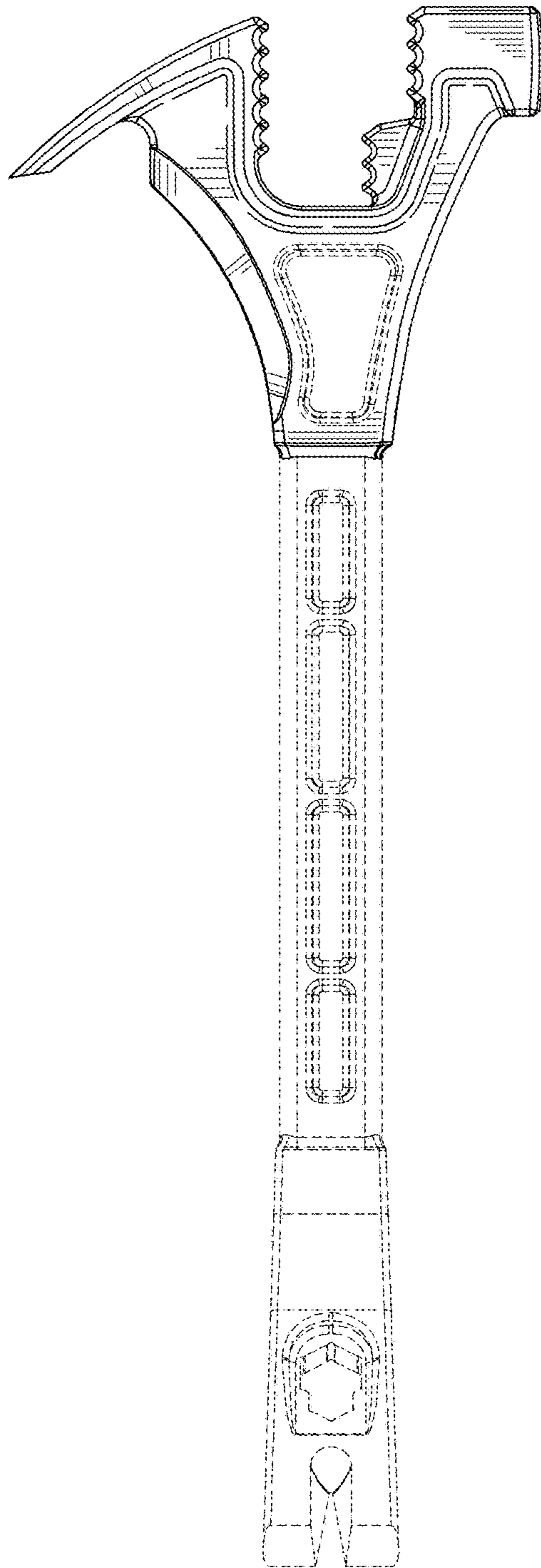

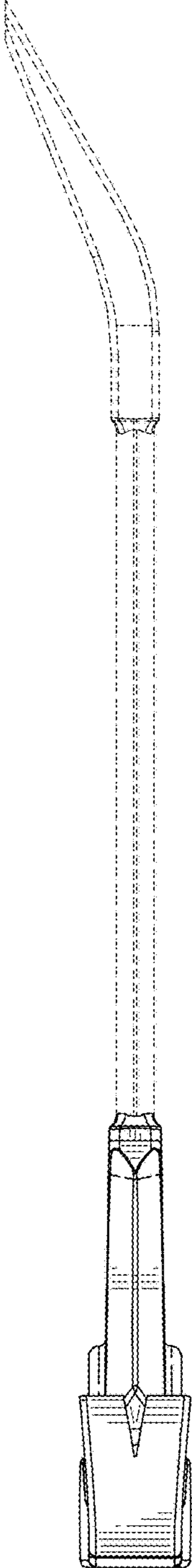

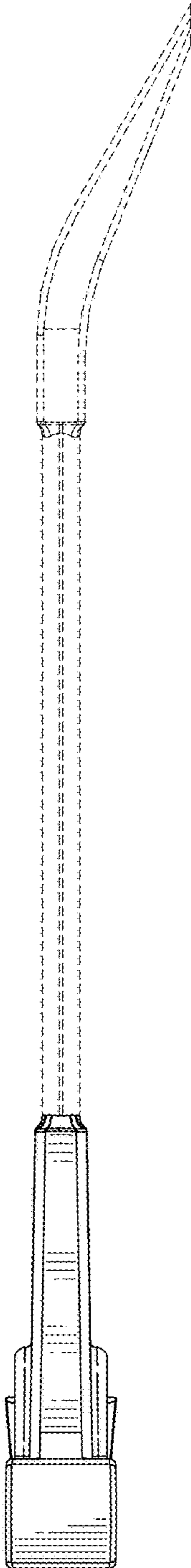

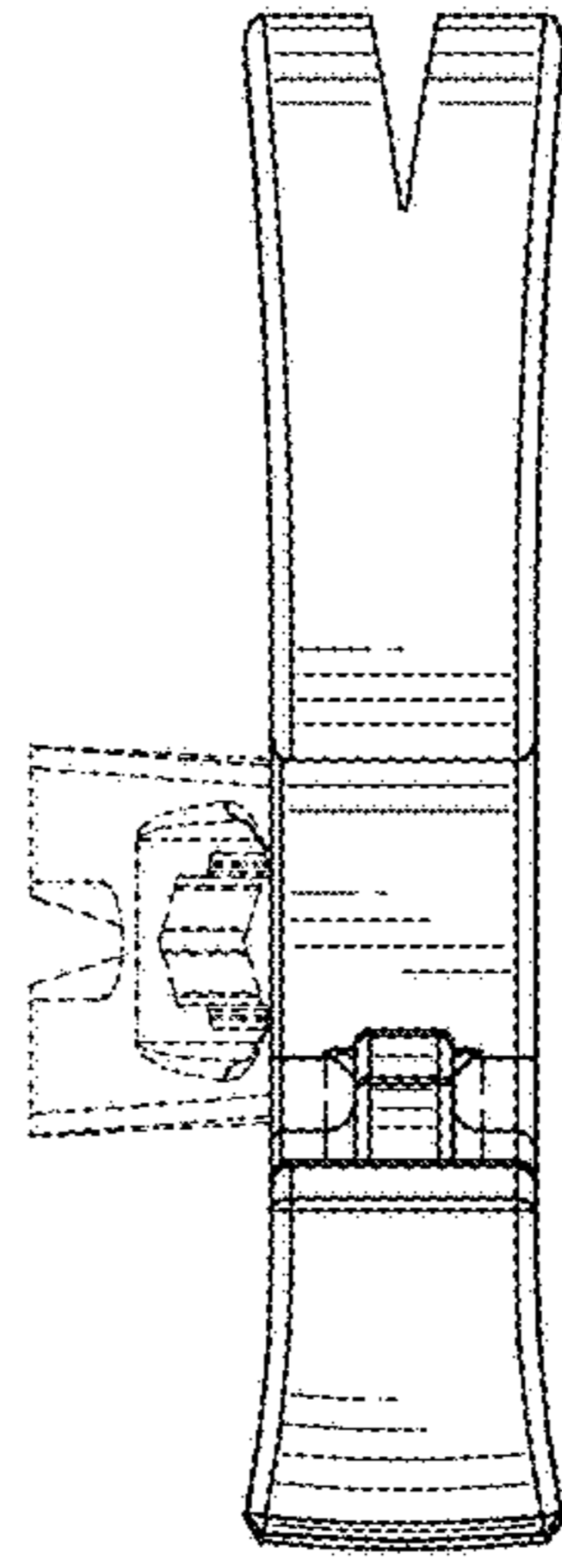

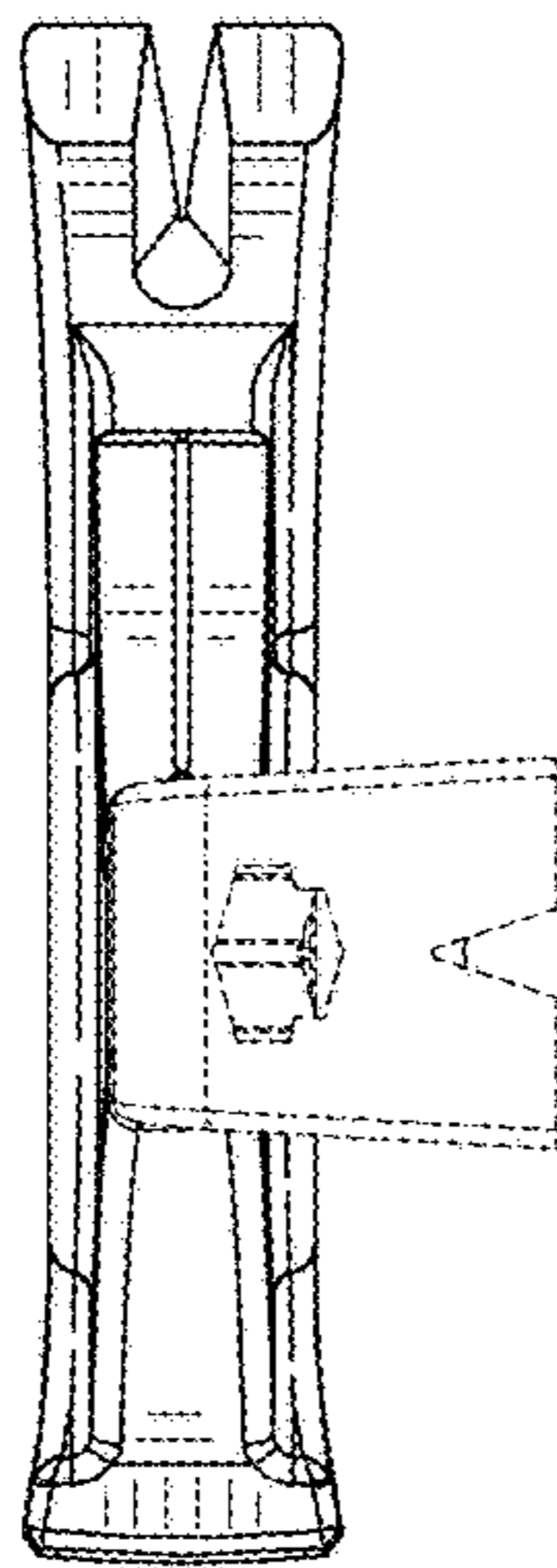
