The ornamental design for a package for data medium, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the package for data medium showing our new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear view thereof;

FIG. 5 is a front perspective view thereof.

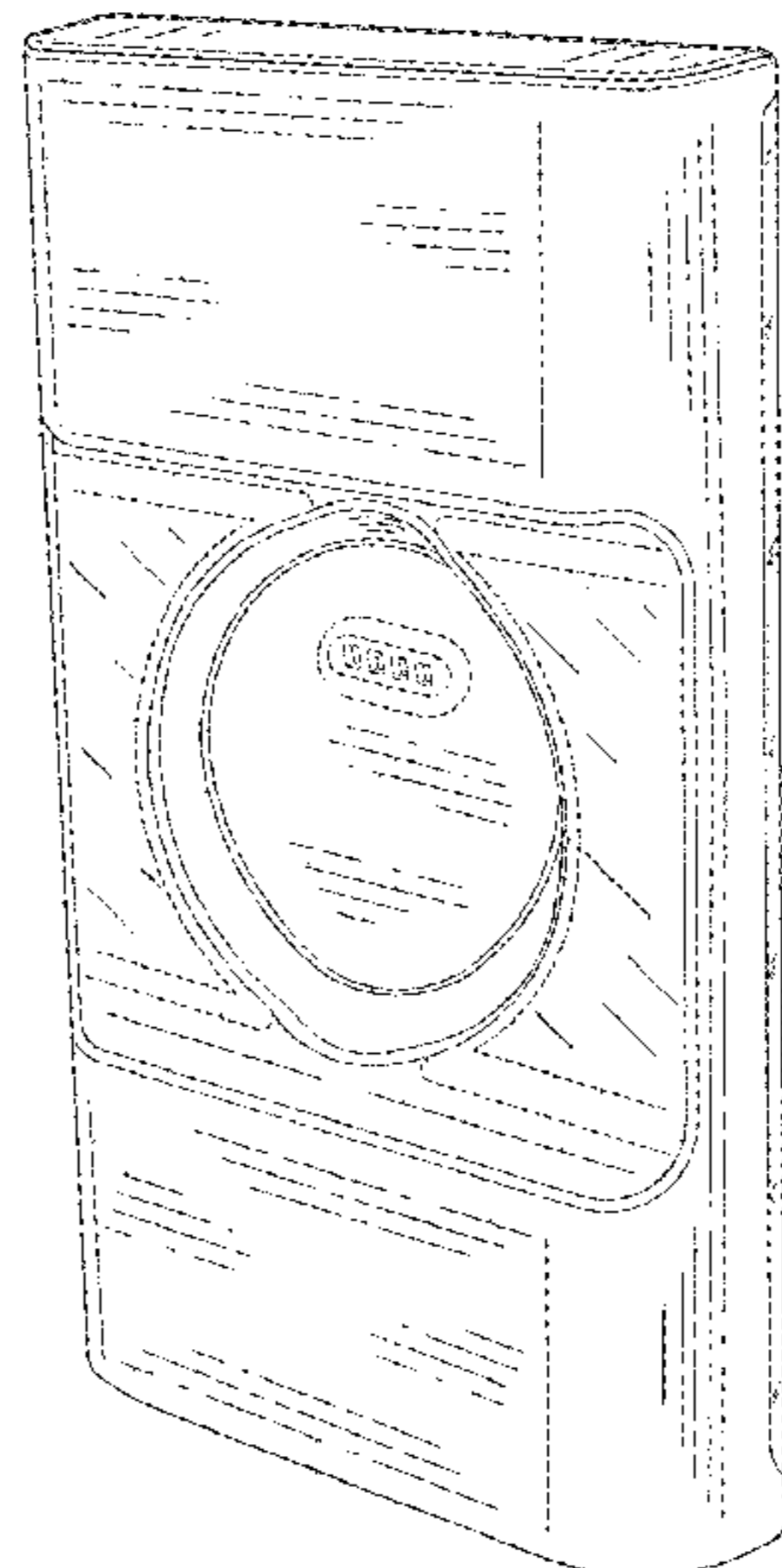

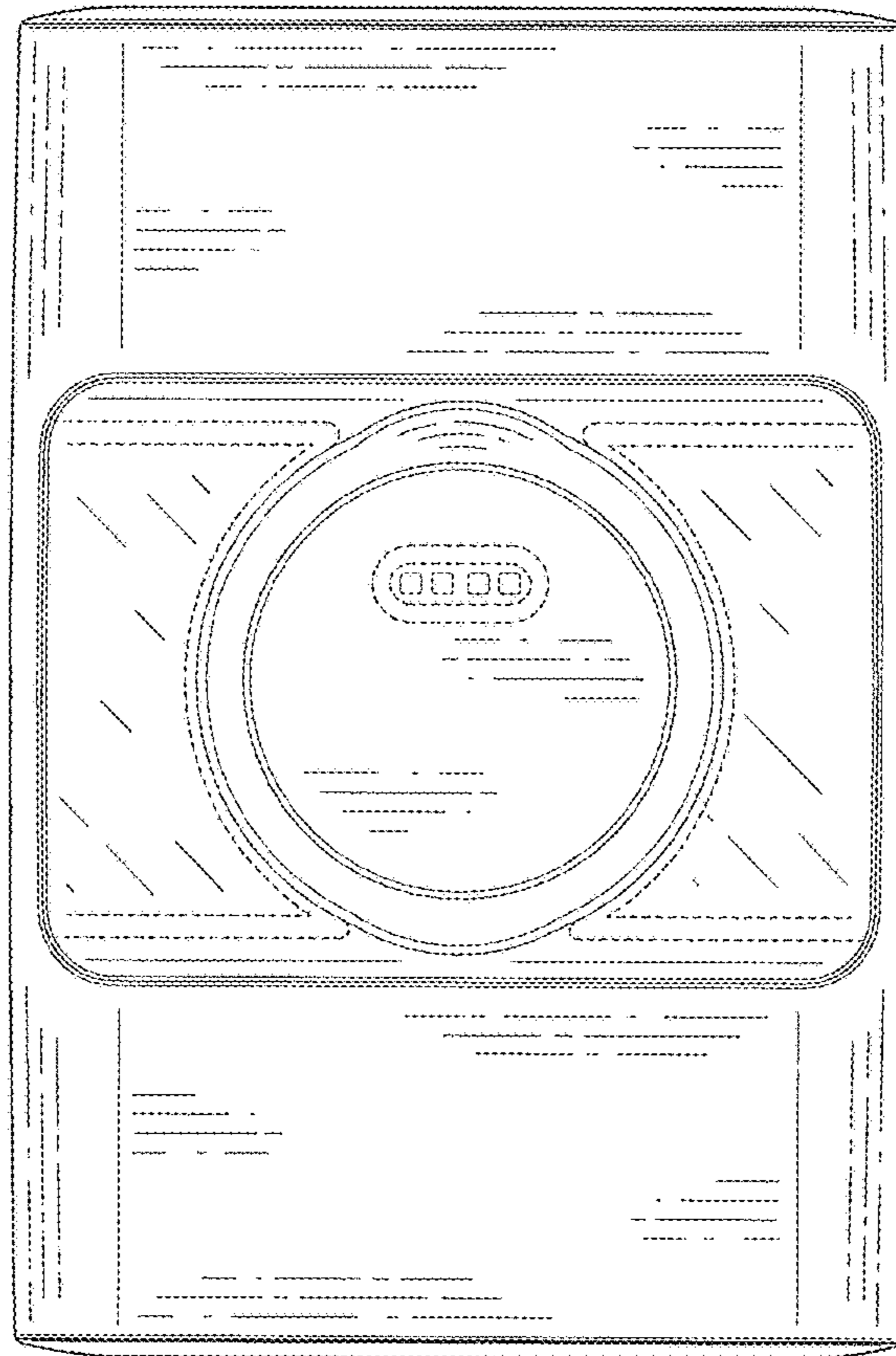

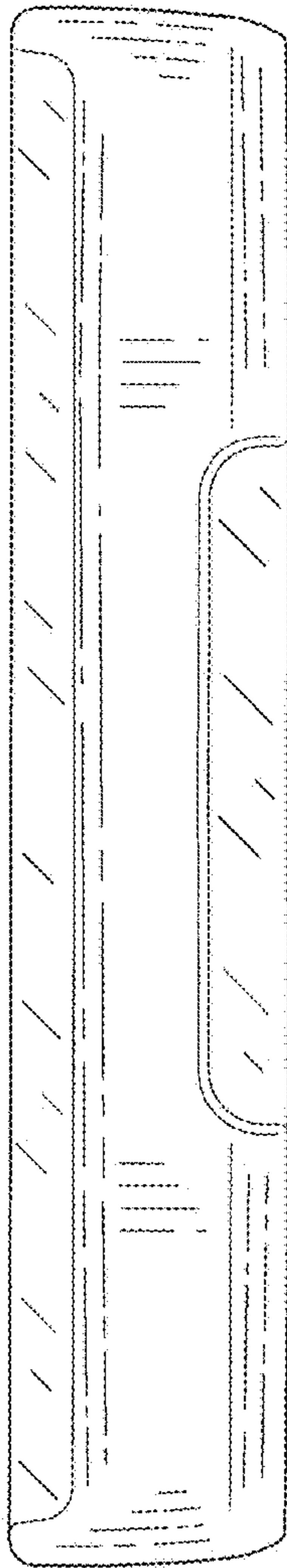

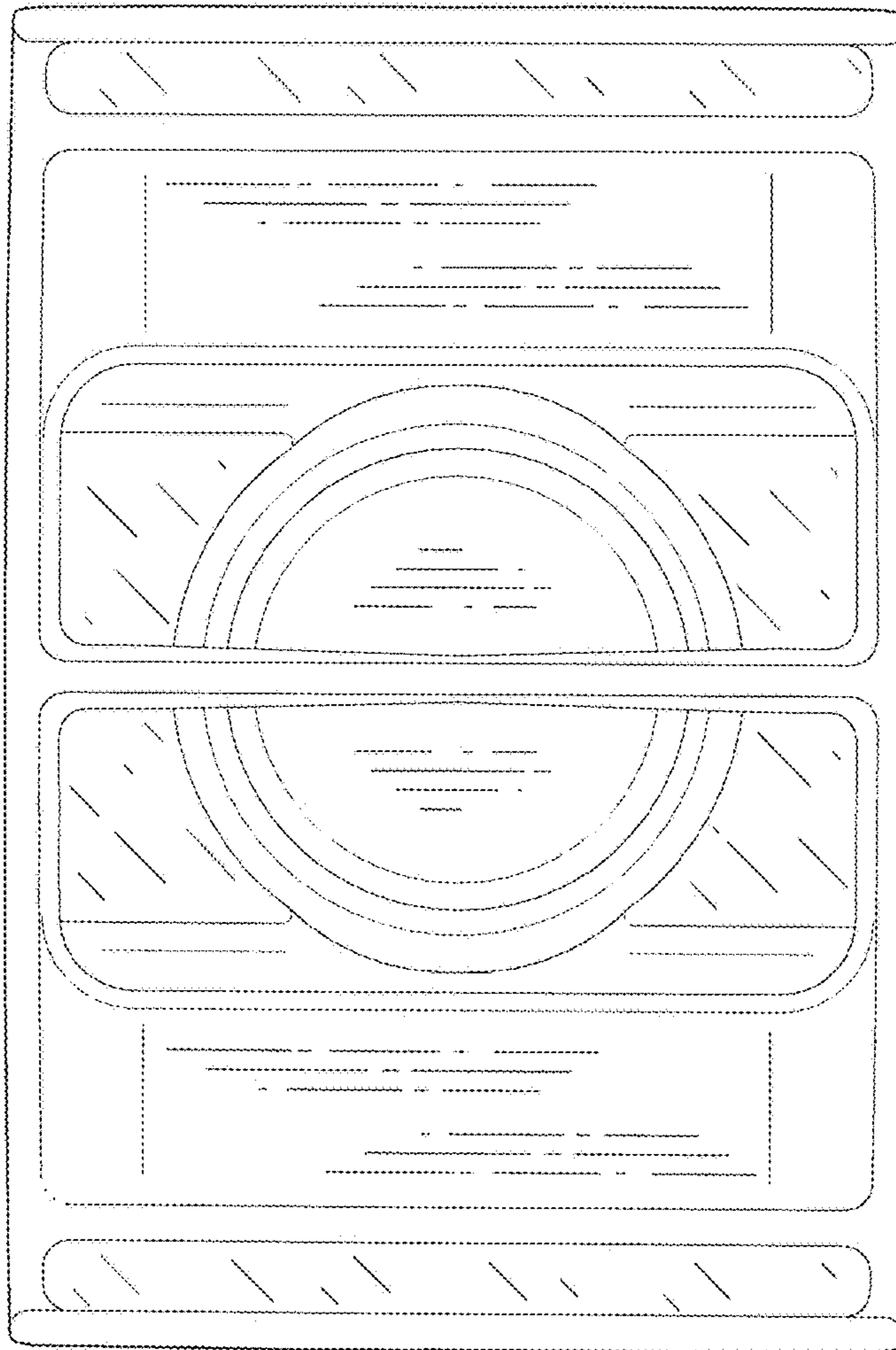

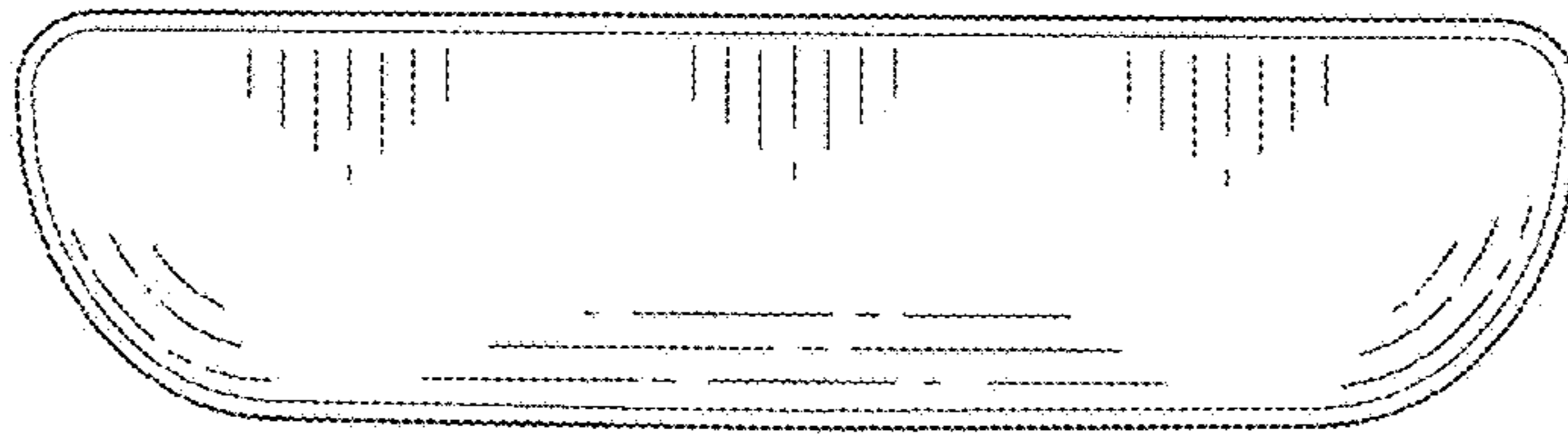
