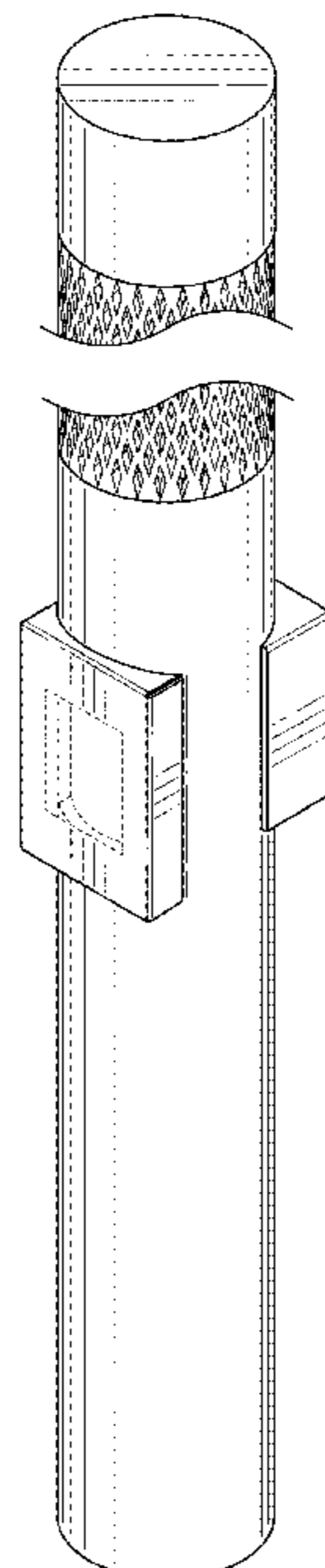

**DESCRIPTION**

FIG. 1 is a front isometric view of a housing for electrical or cabling wires, showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof; and,  
FIG. 6 is a top plan view thereof.  
The housing for electrical or cabling wires is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

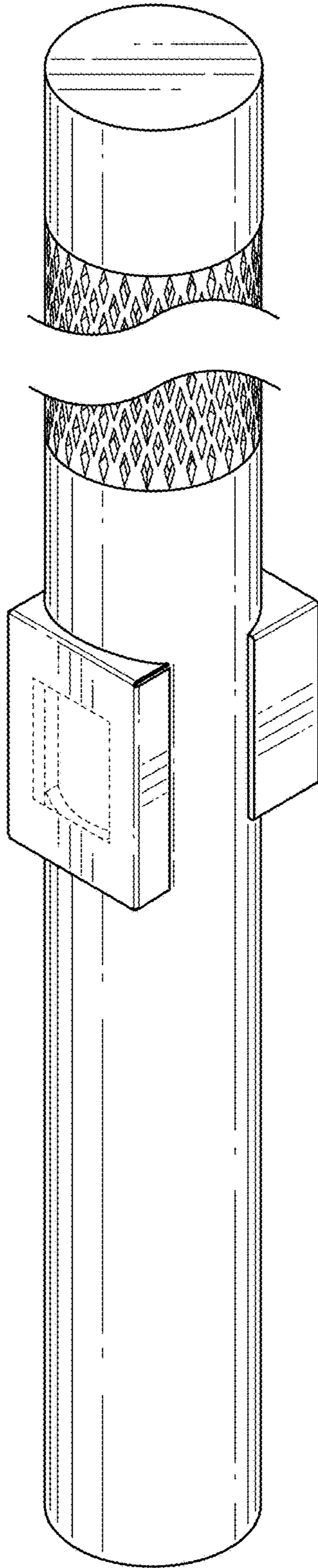

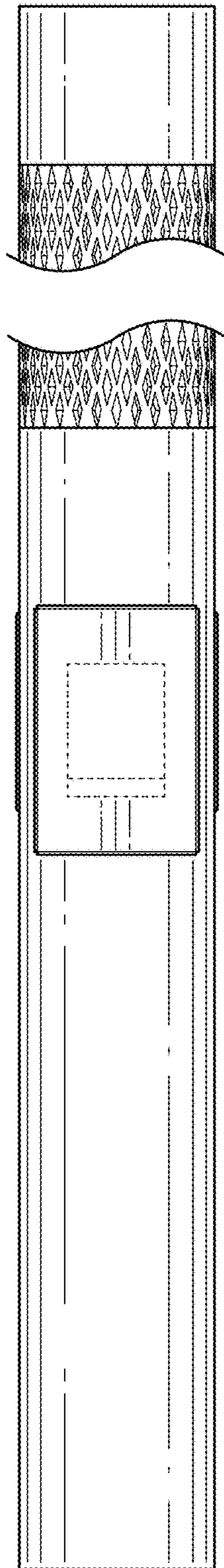

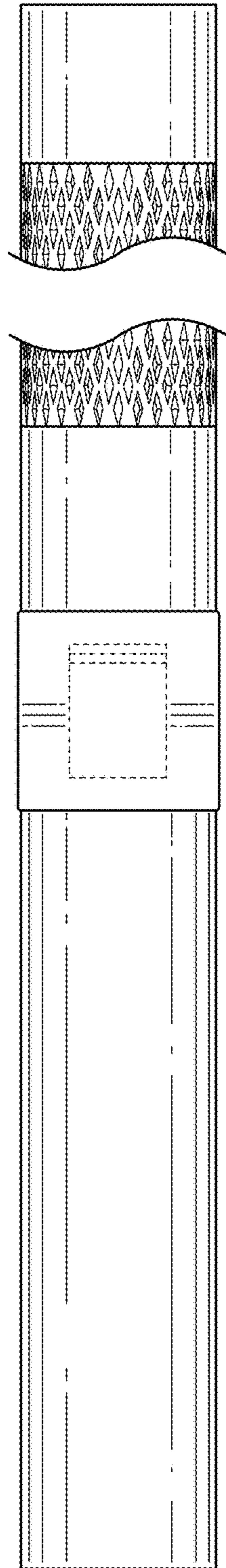

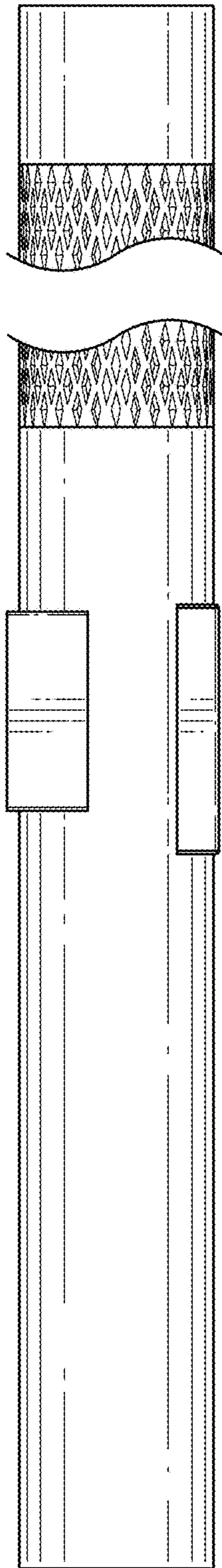

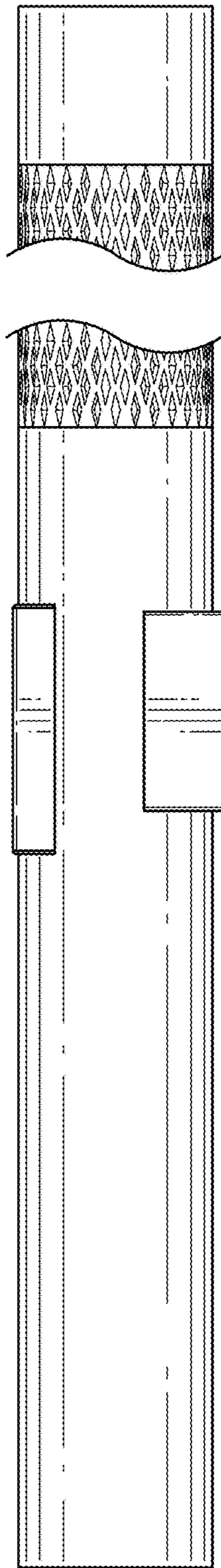

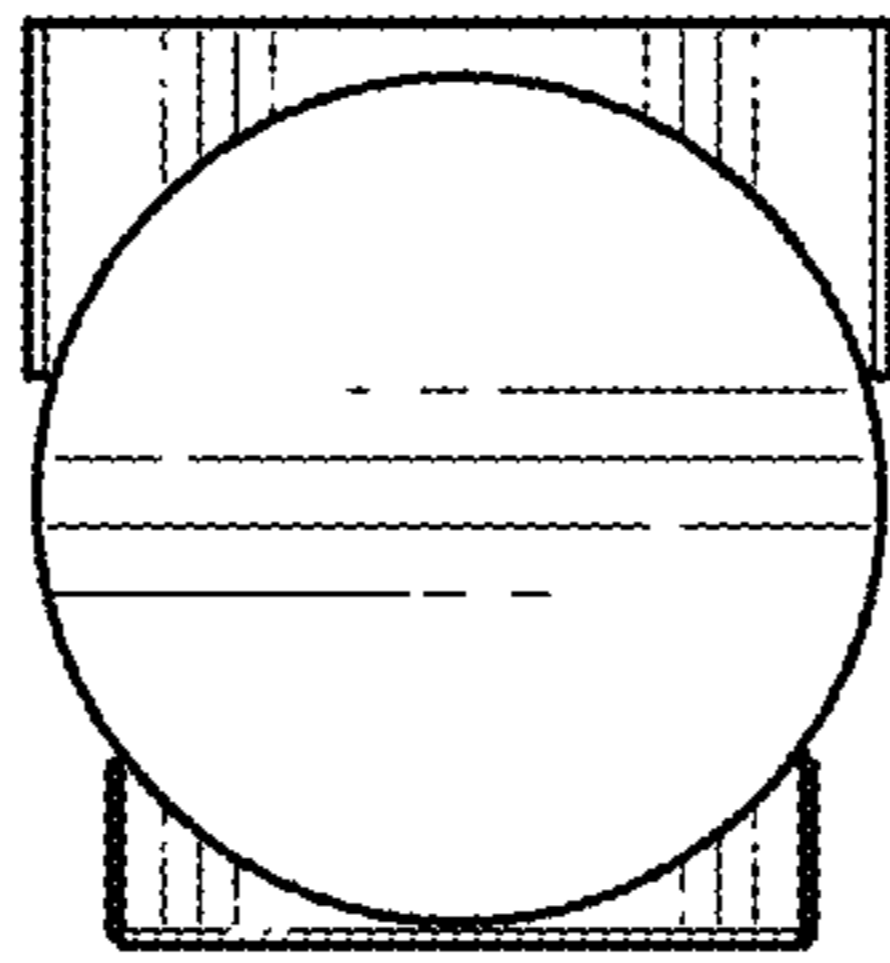
