FIG. 15 is a right side elevation view thereof;

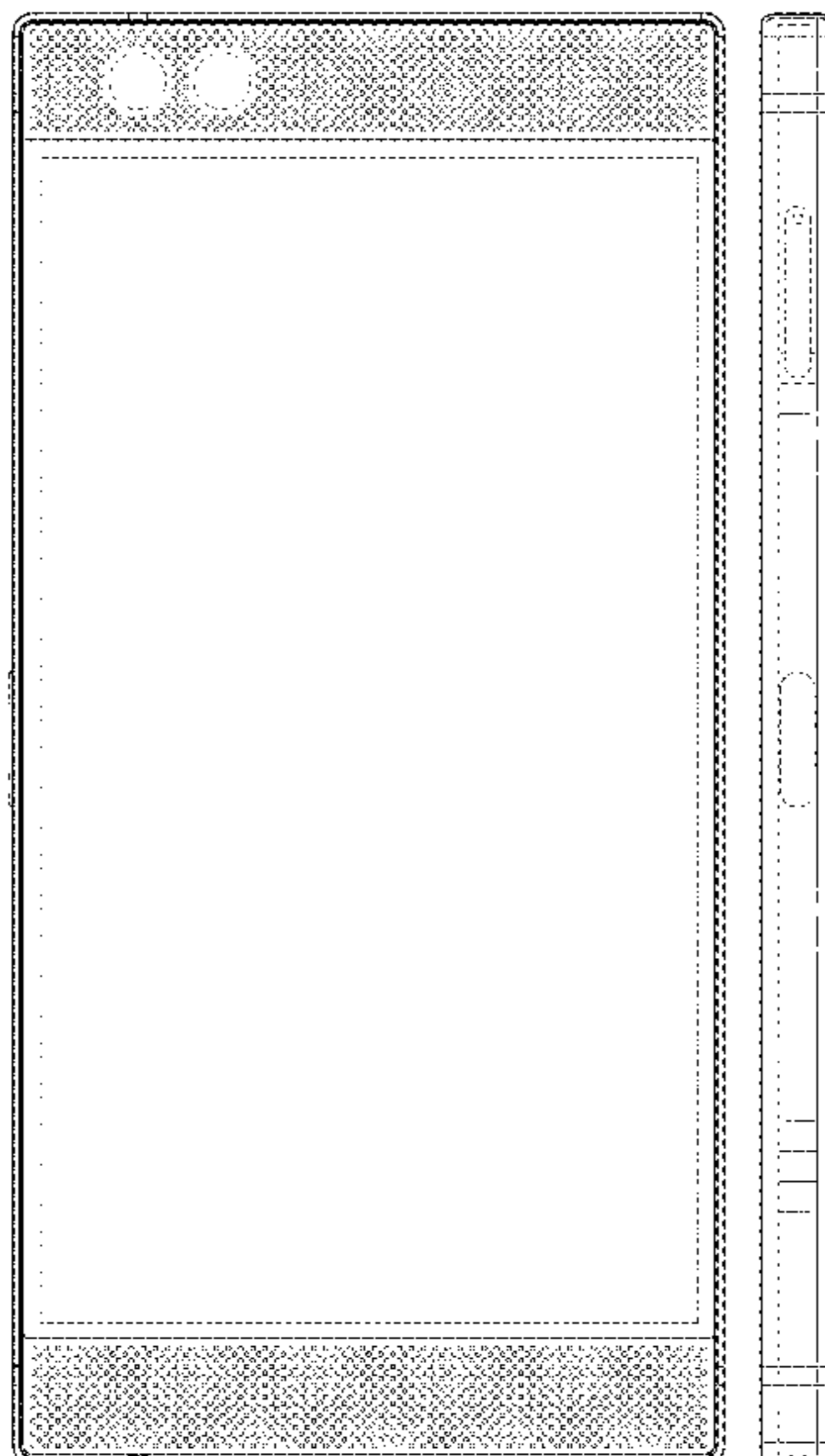
FIG. 16 is a rear elevation view thereof; and,

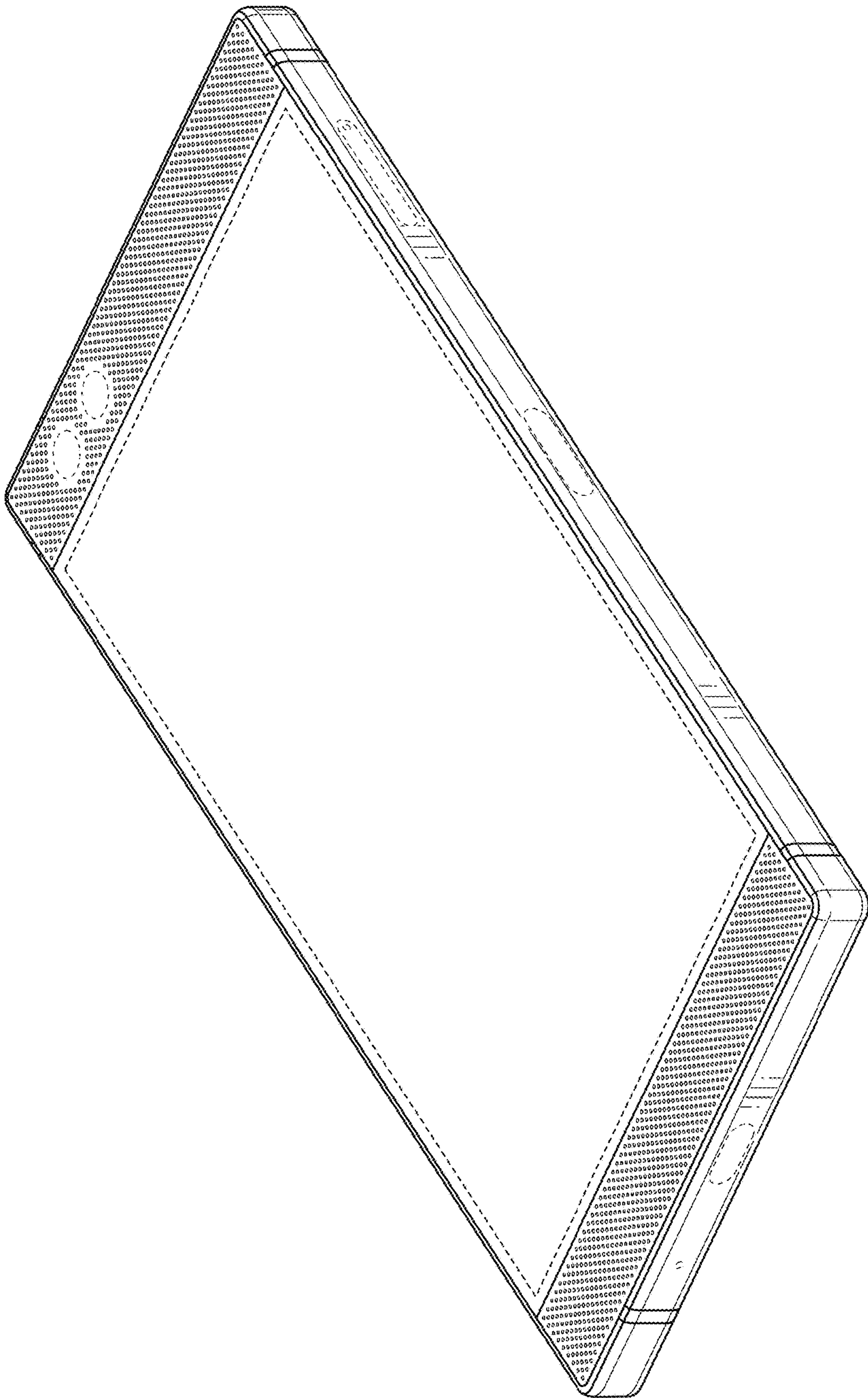

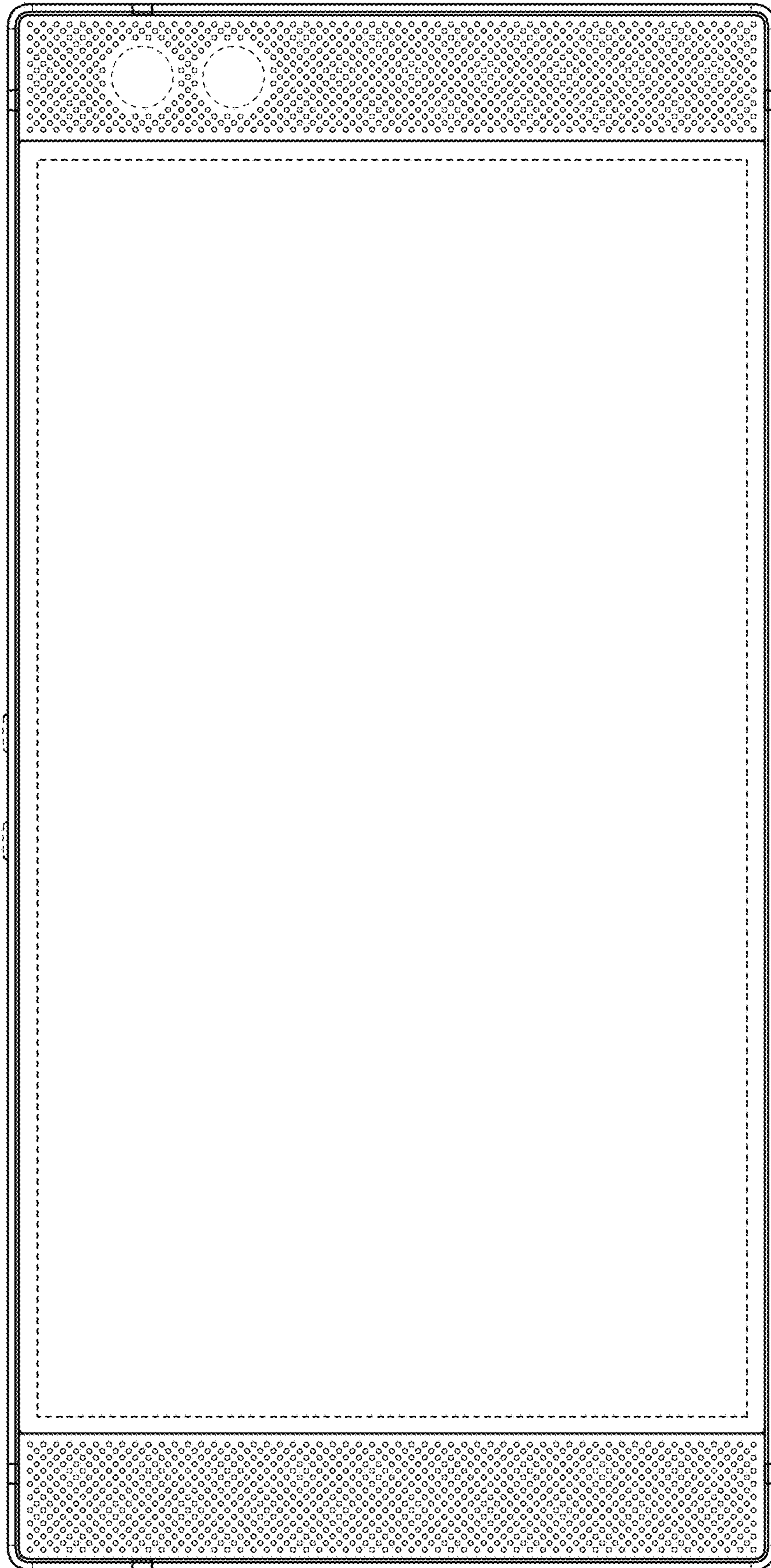

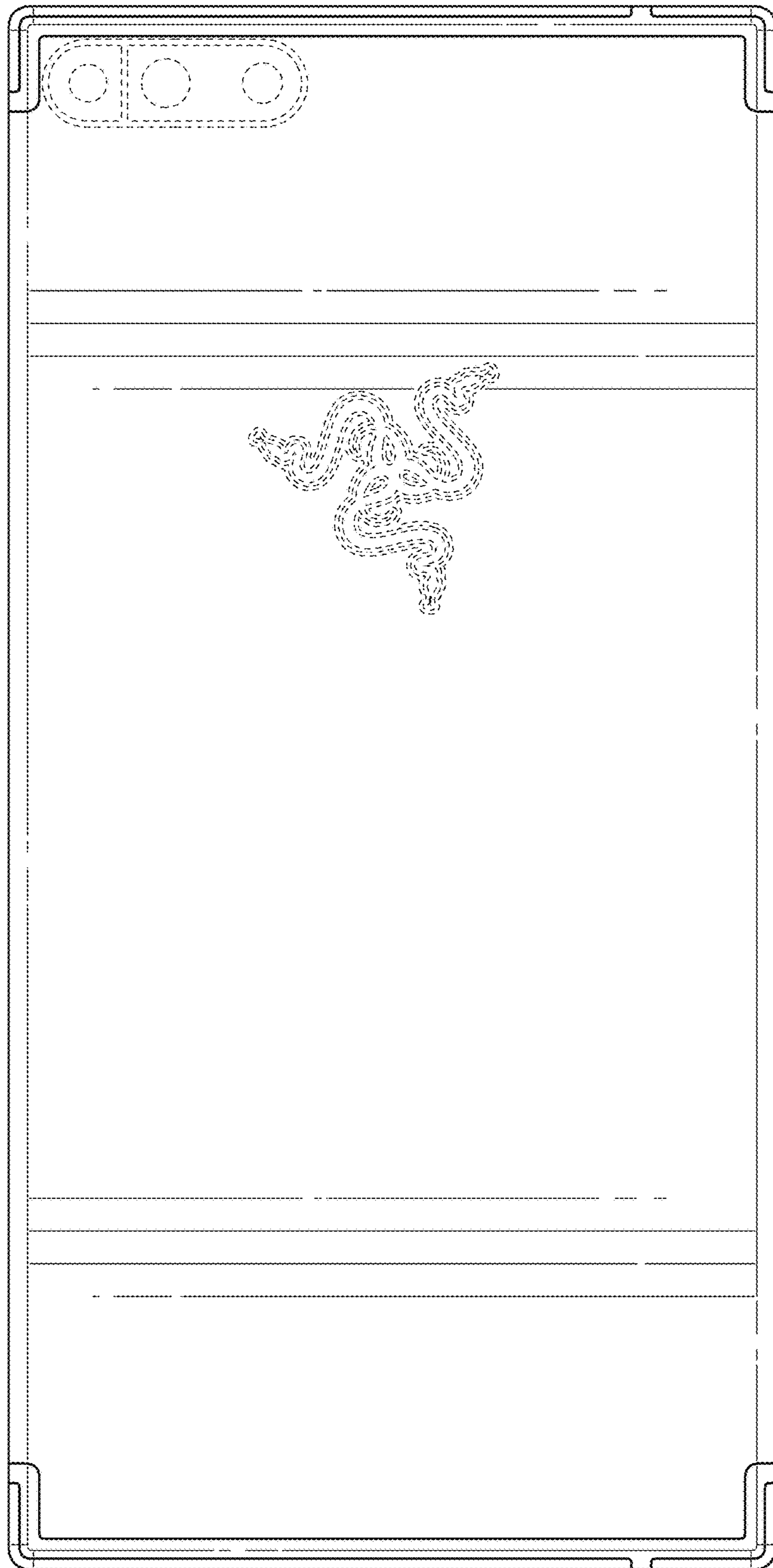

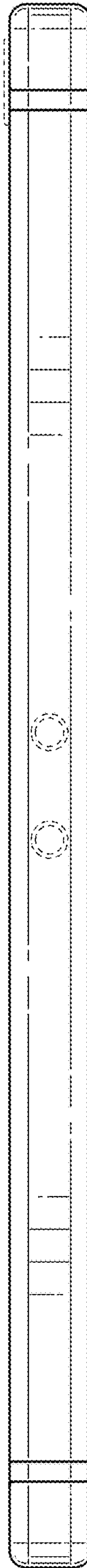

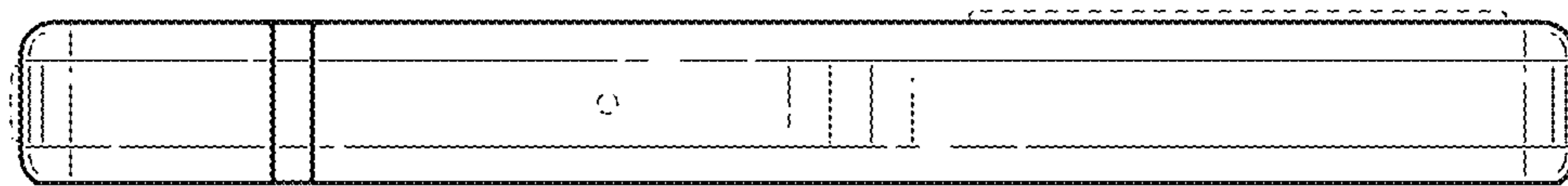

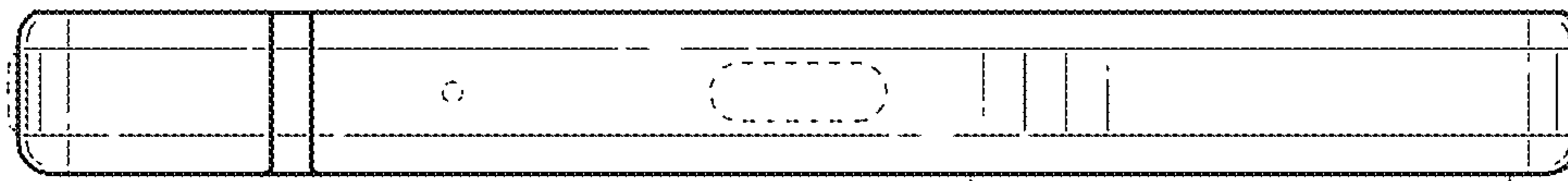

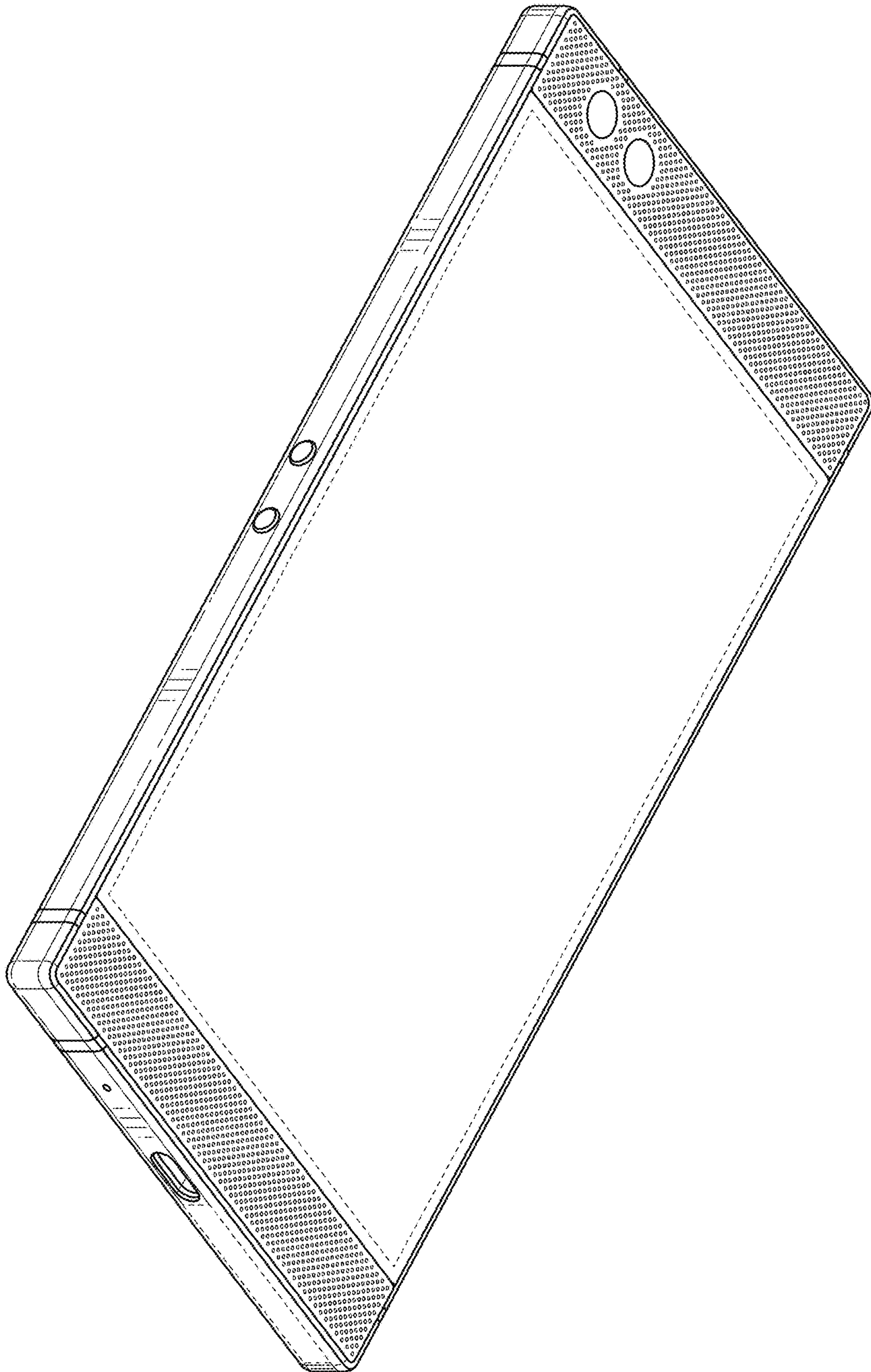

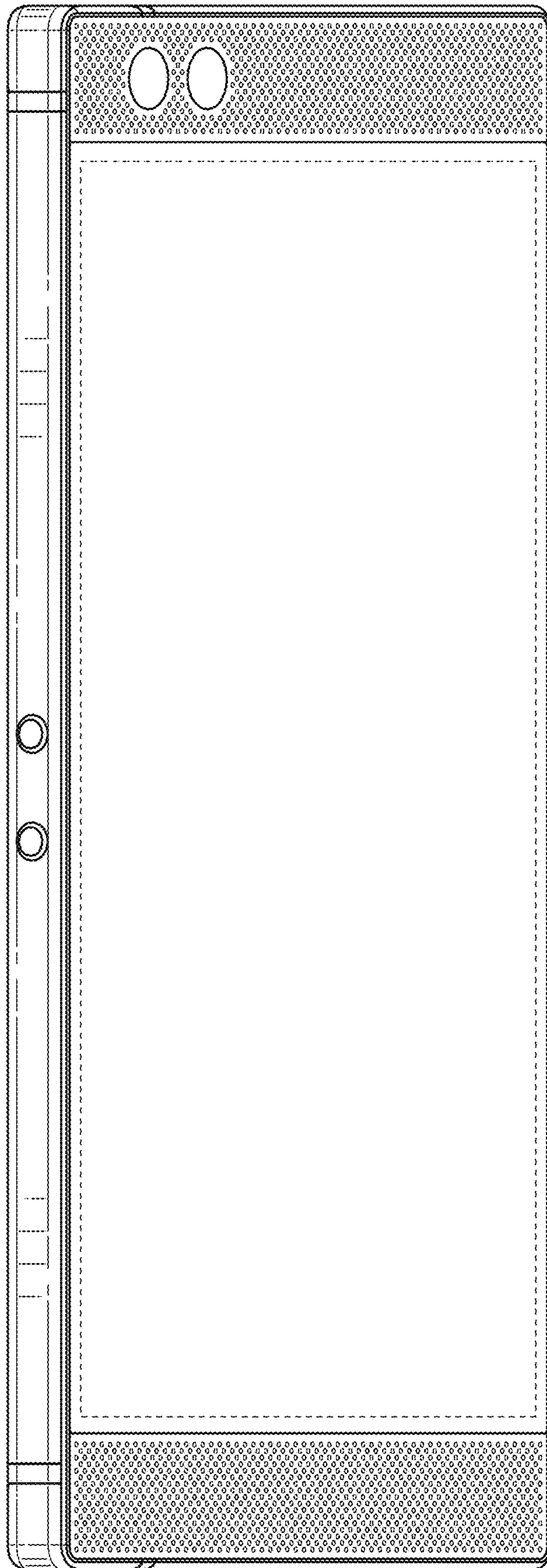

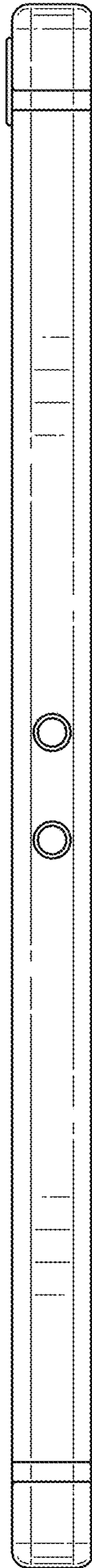

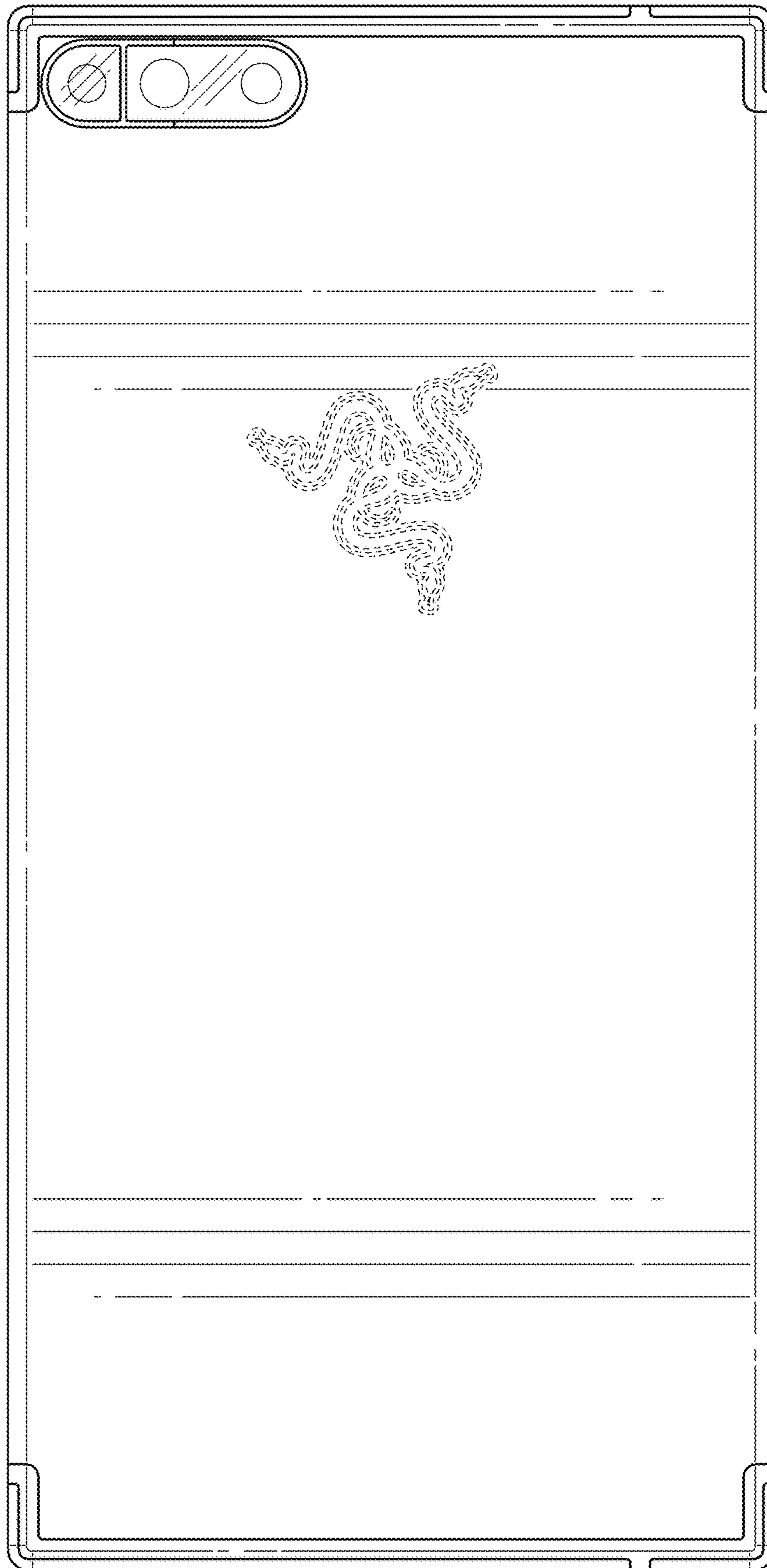

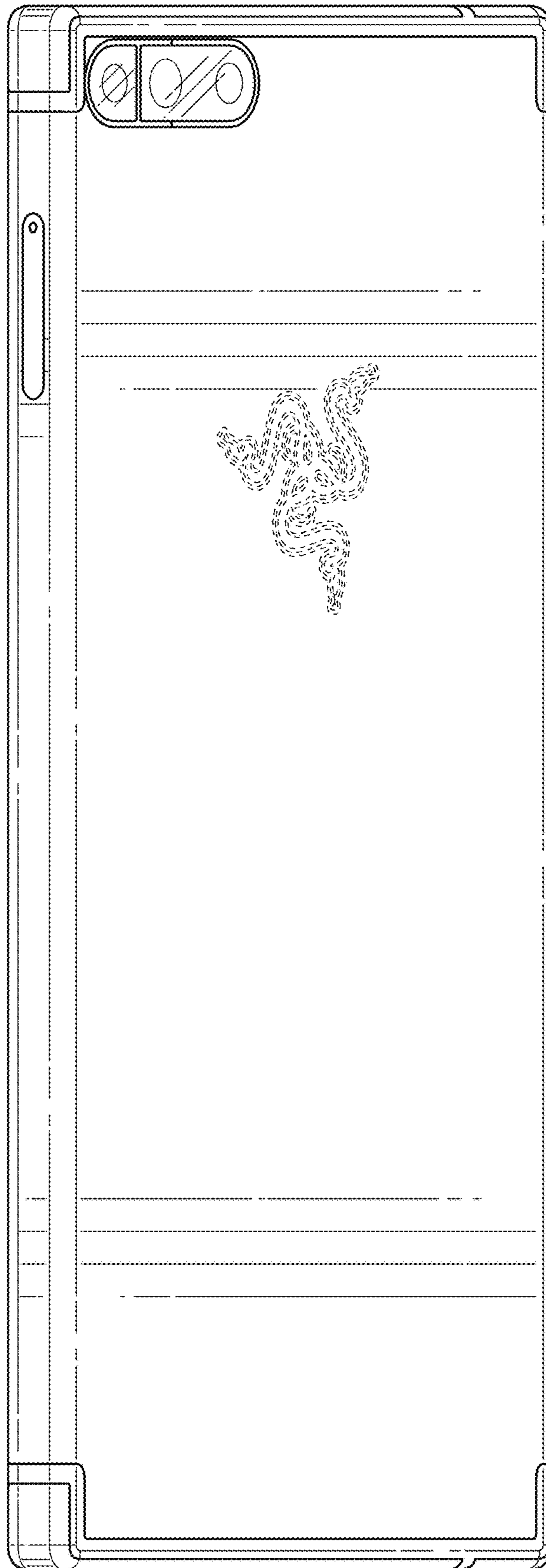

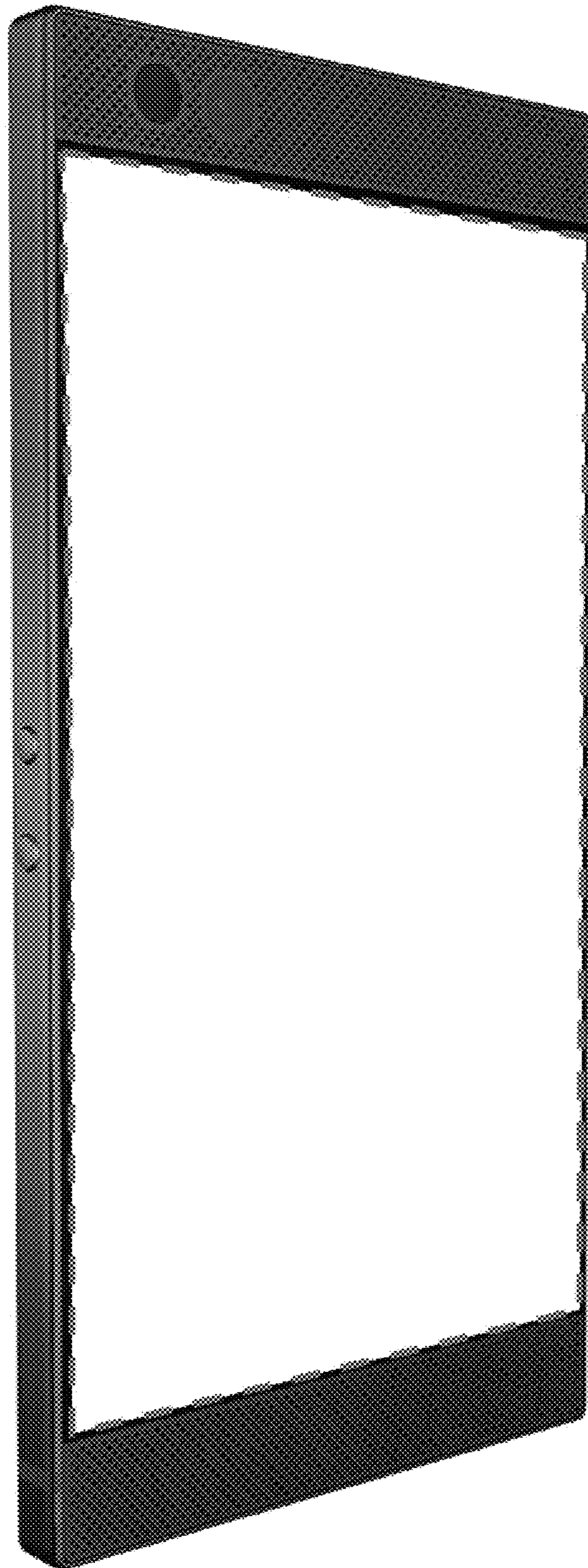

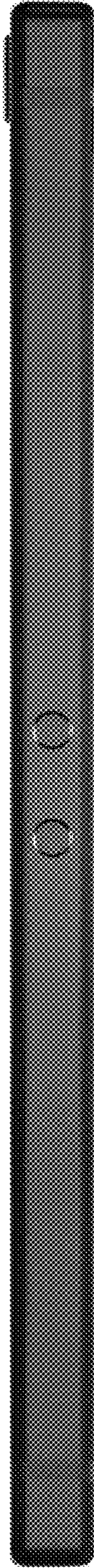

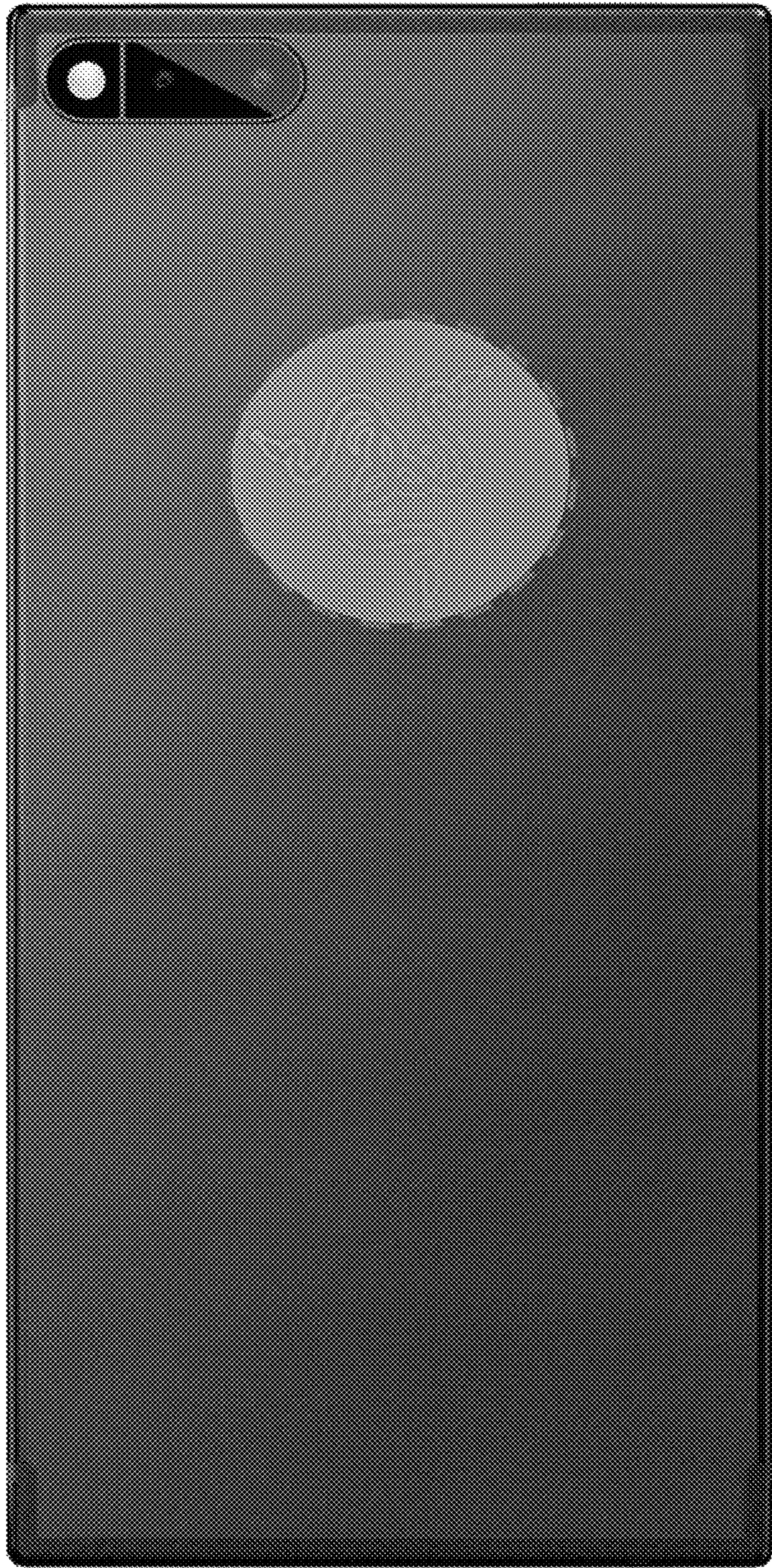

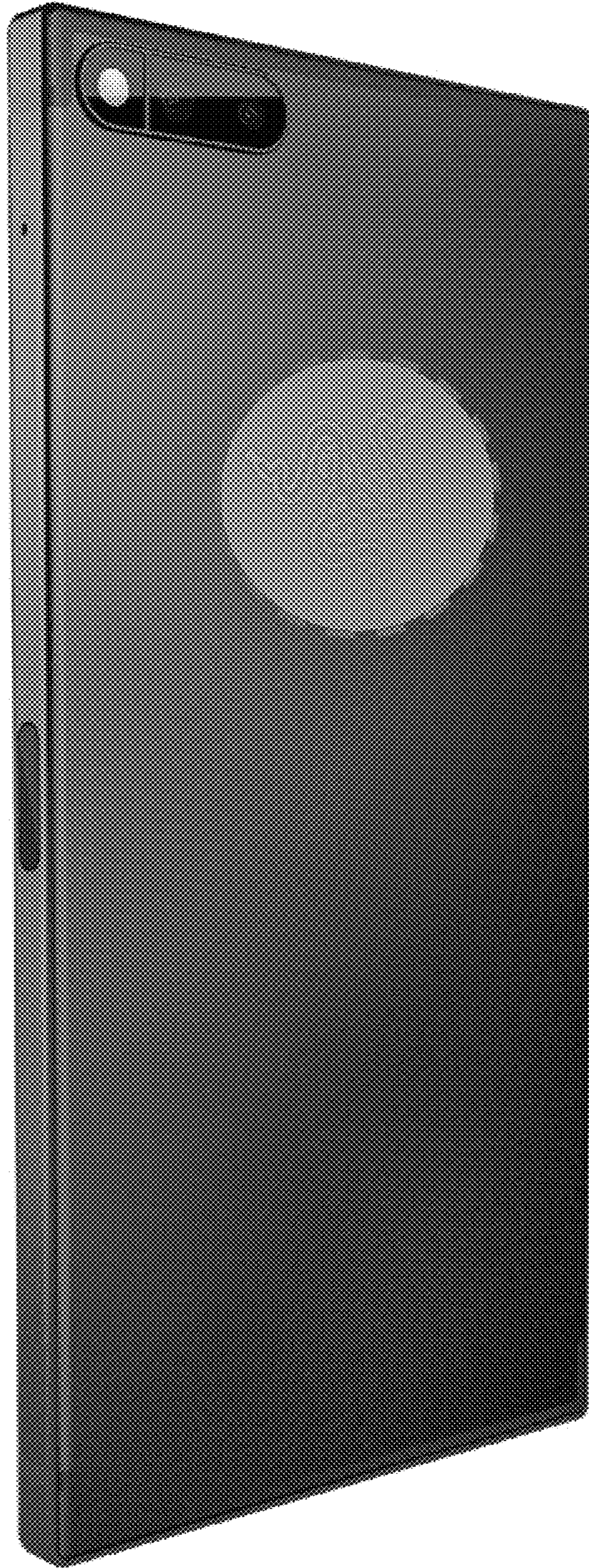
