(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

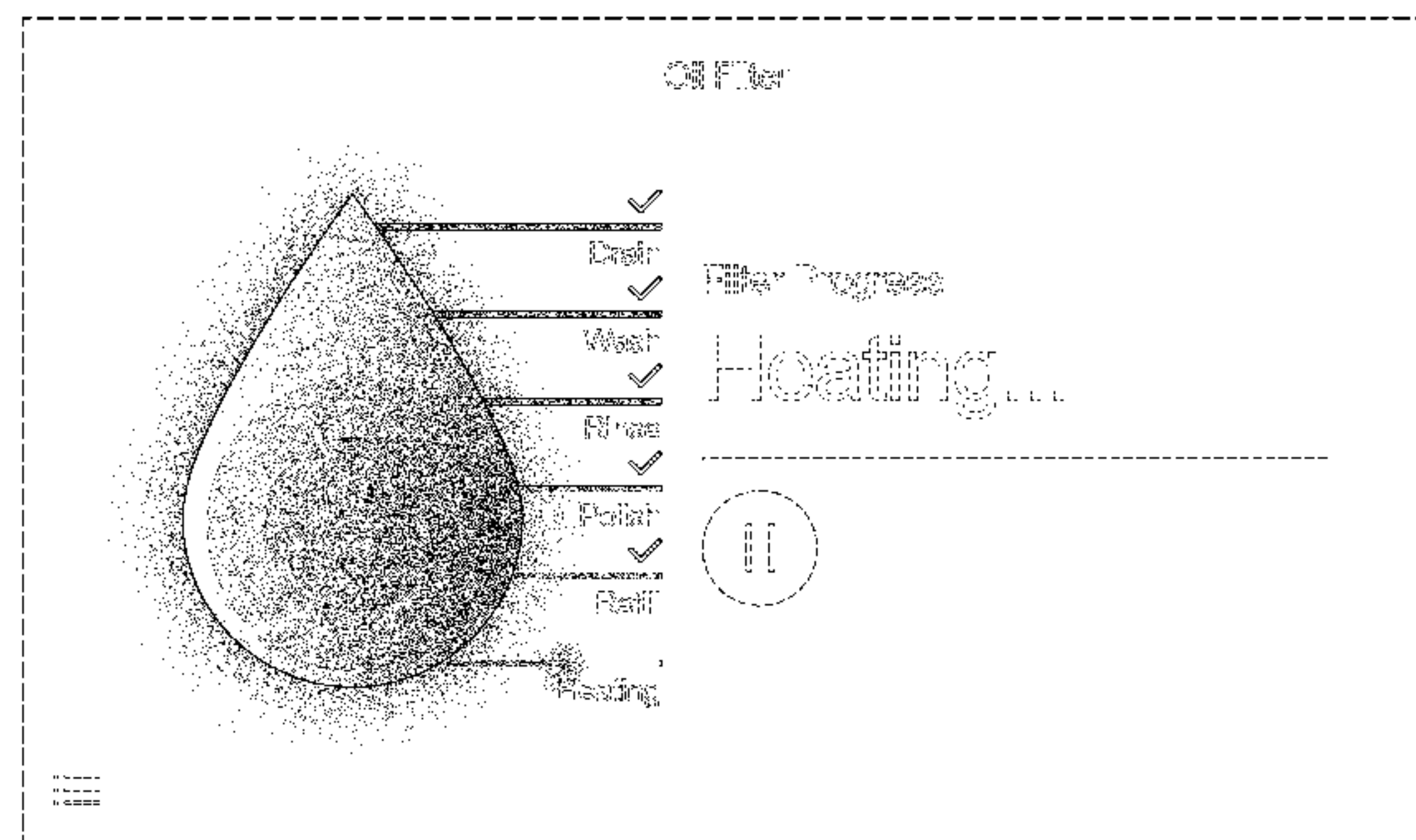
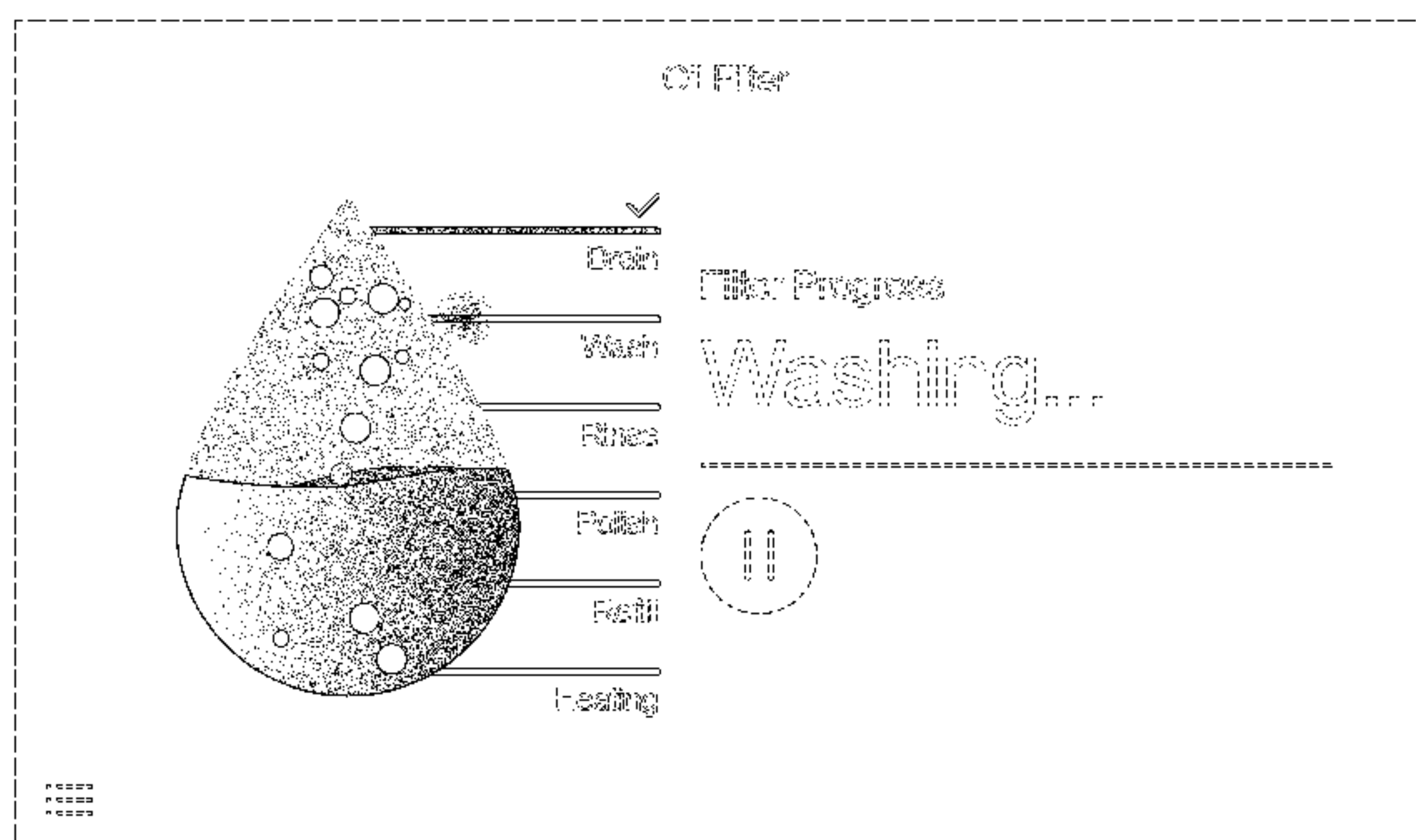


FIG. 16 is a front view of the display screen or portion thereof showing the sixteenth image of the sequence of FIG. 1;

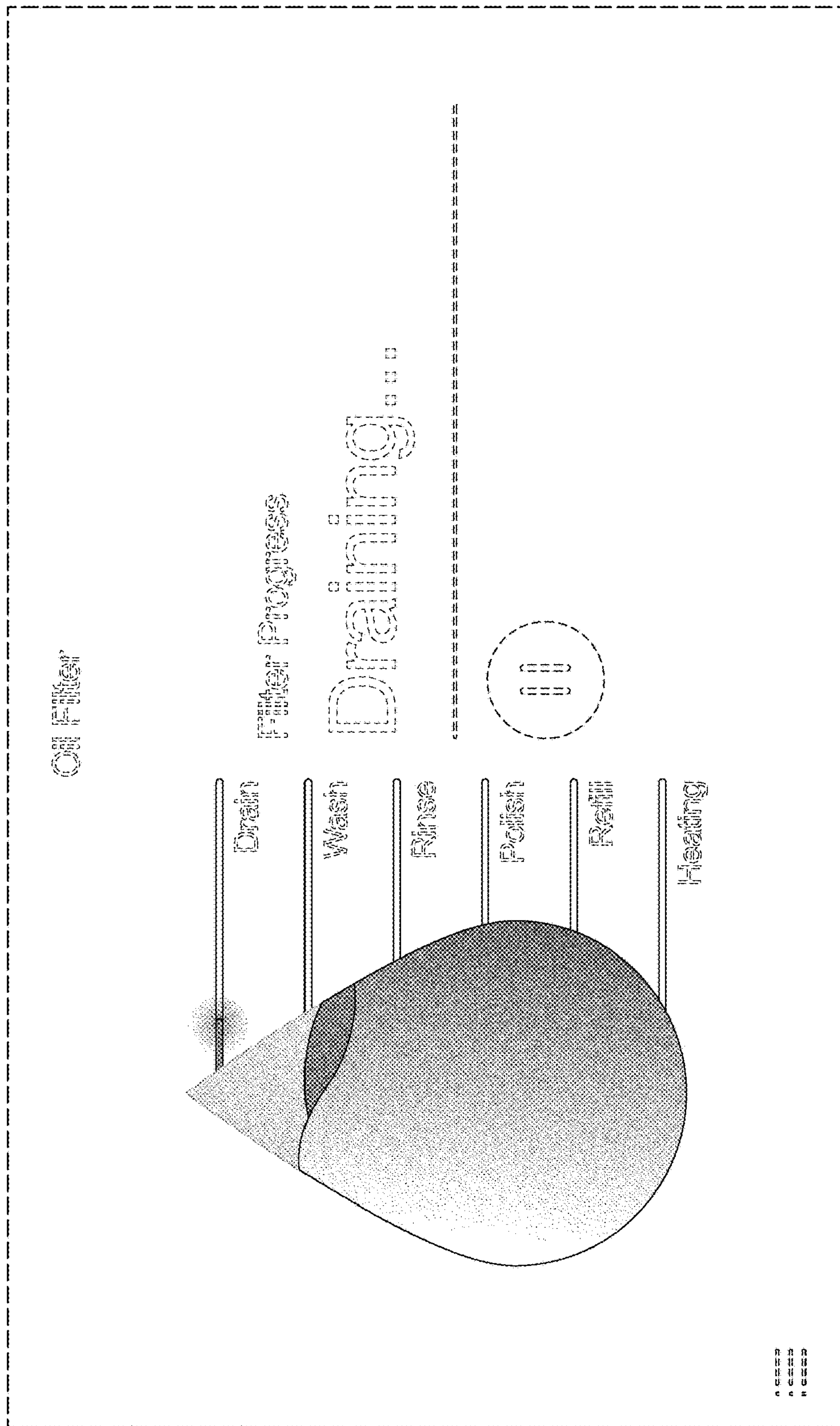

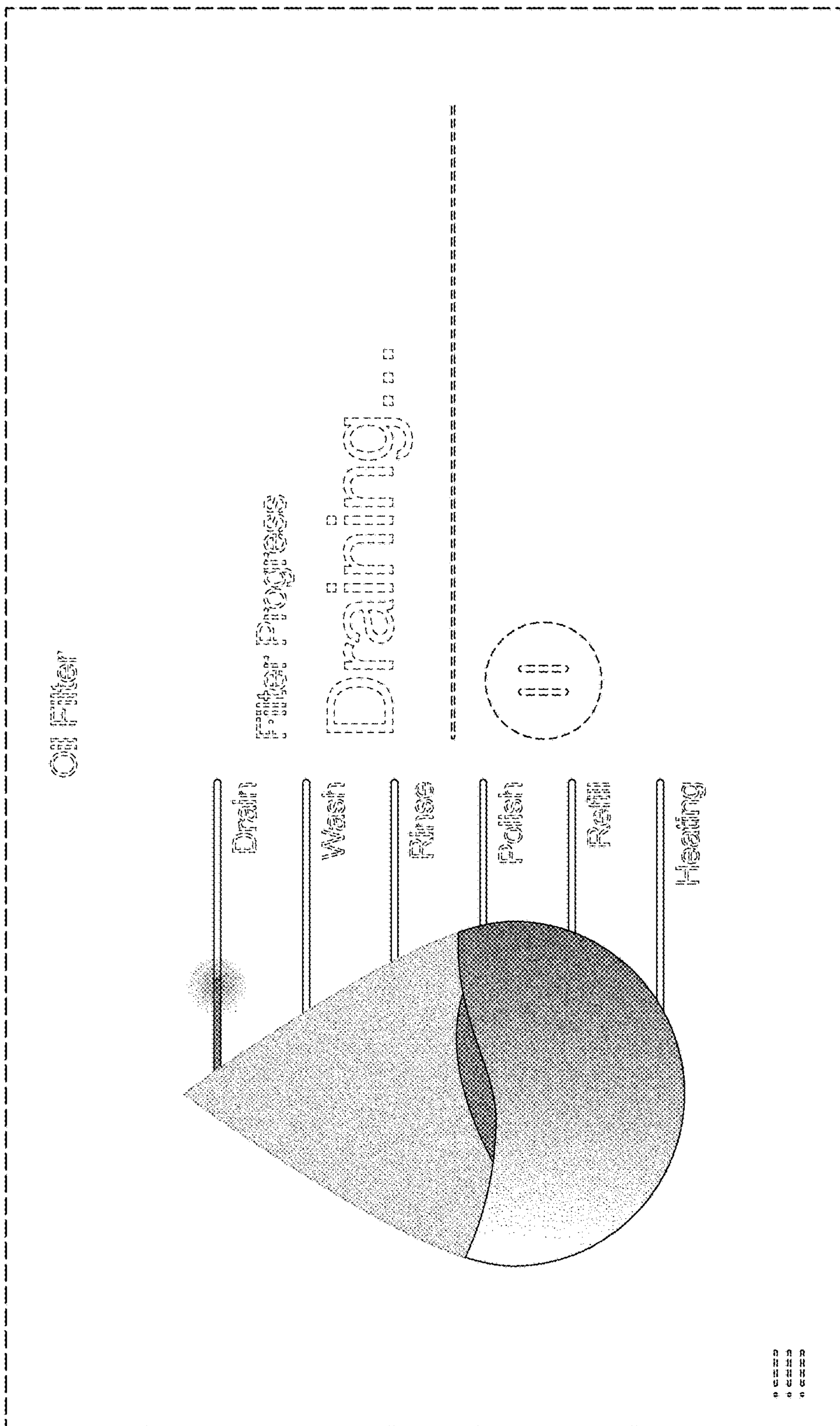

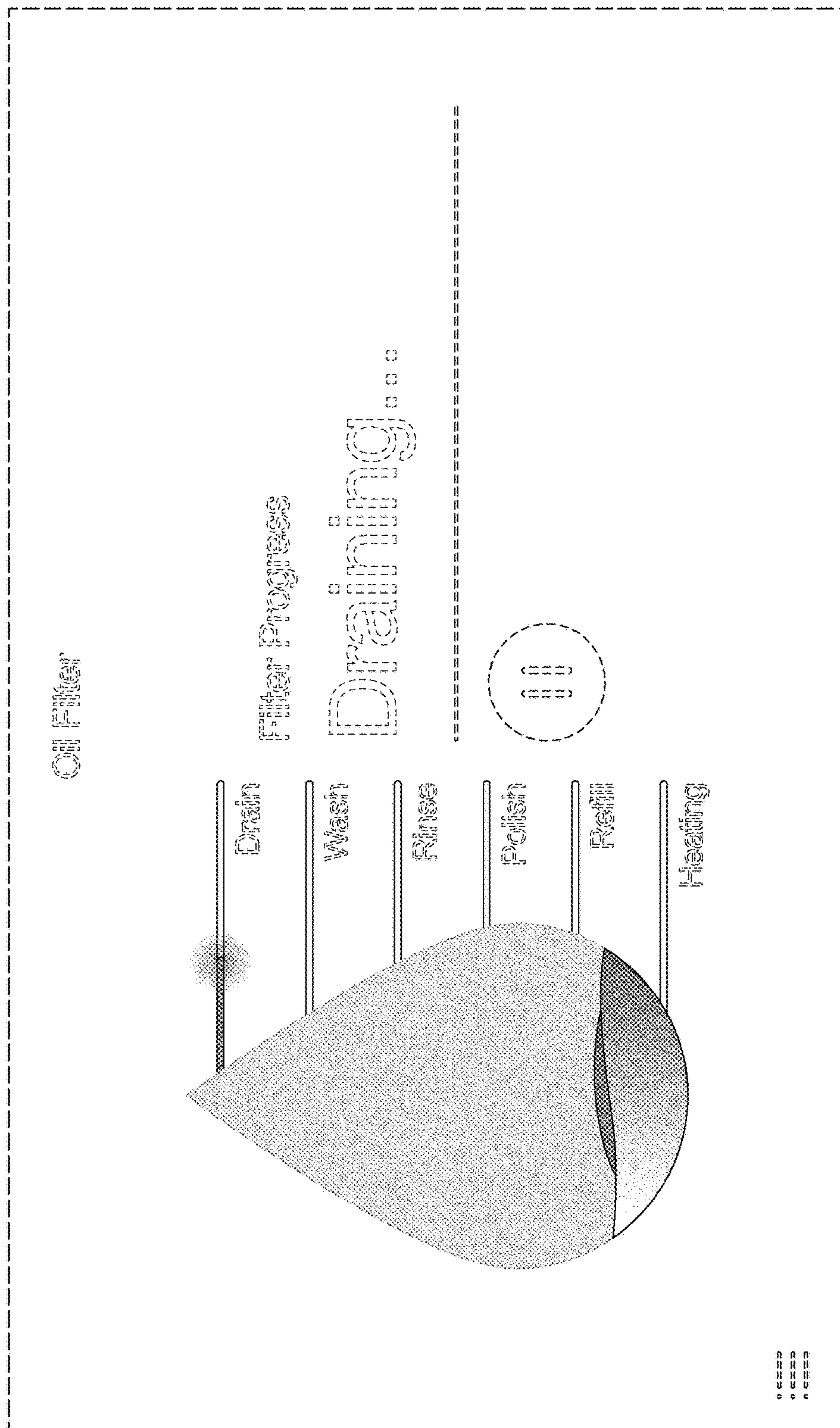

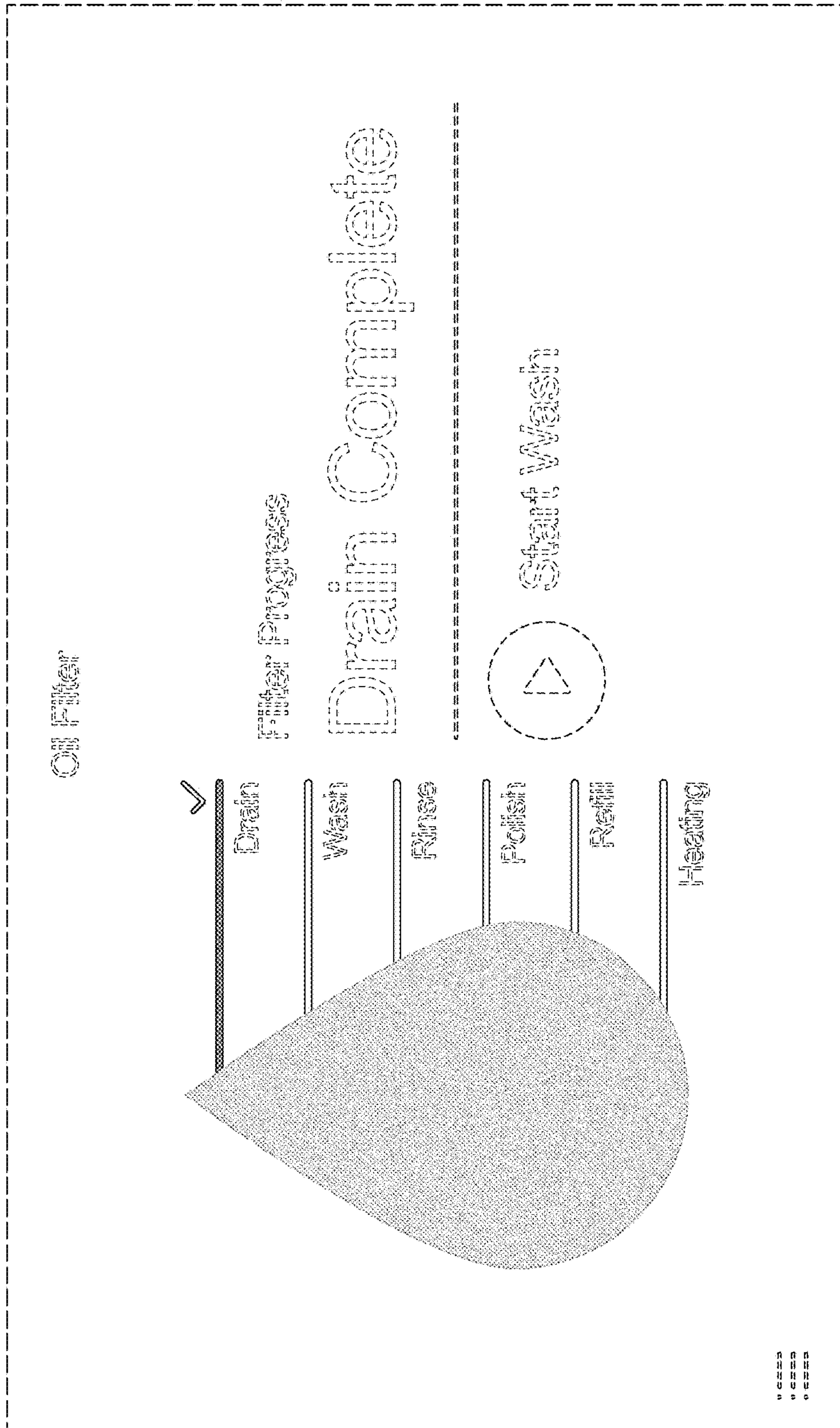

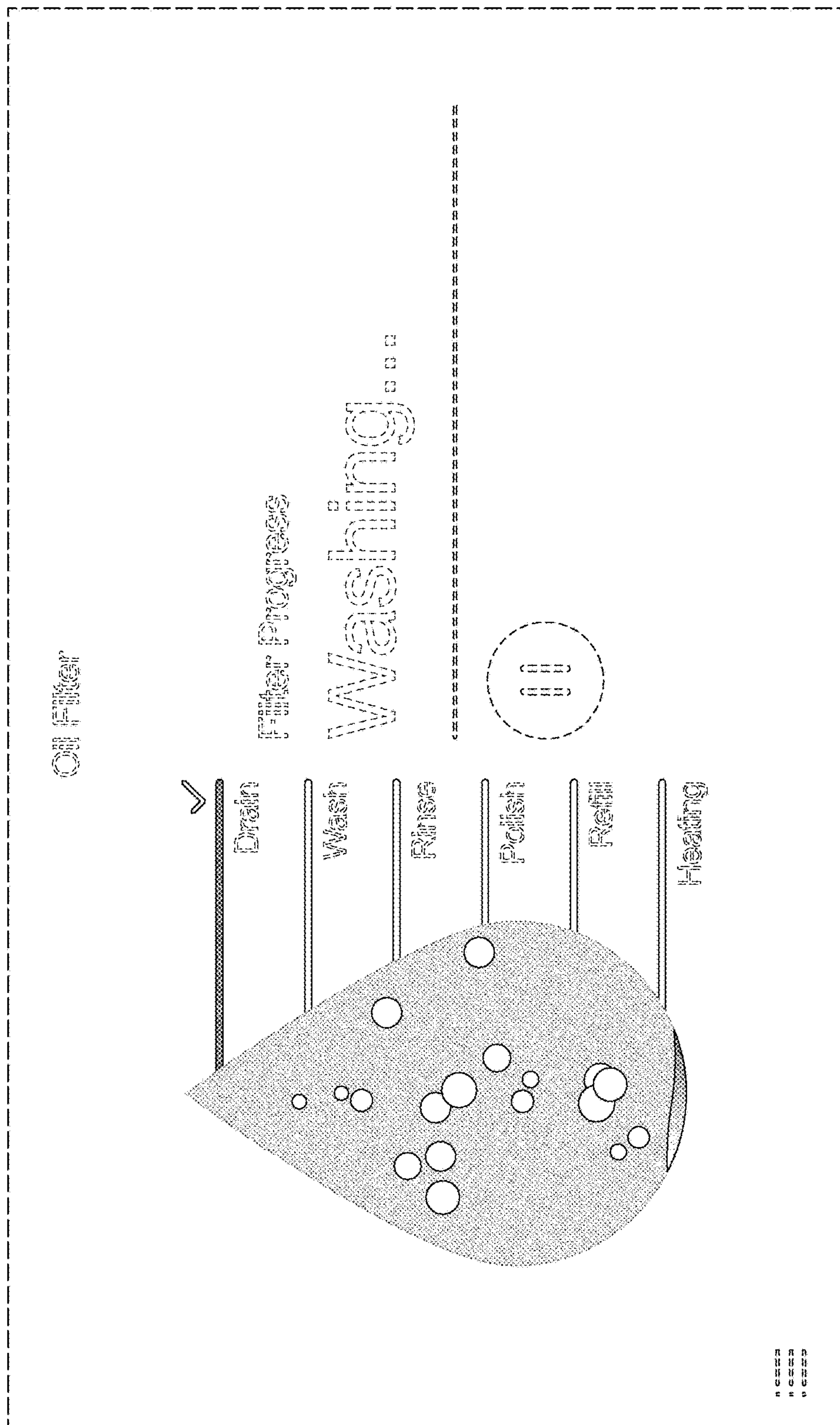

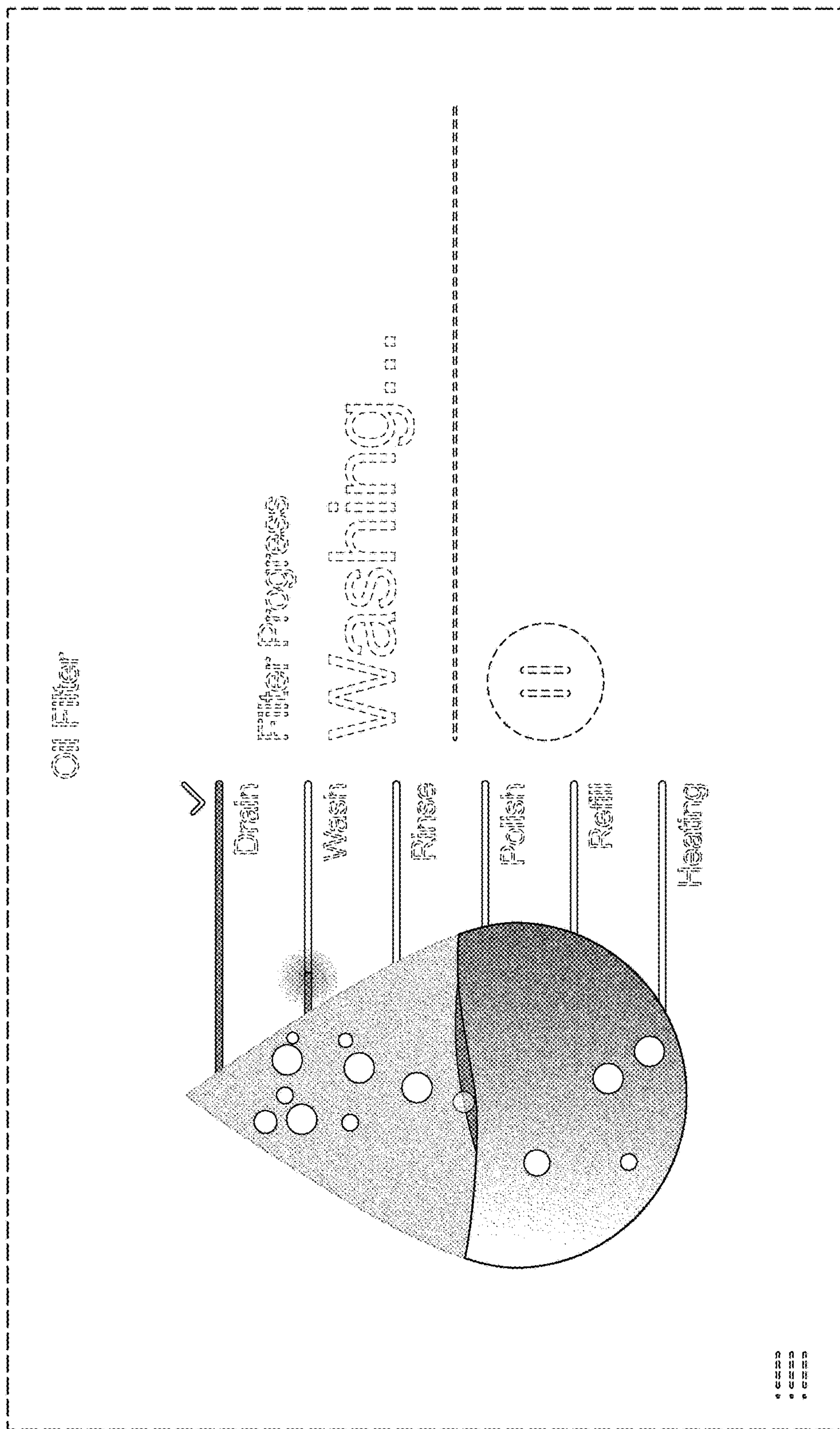

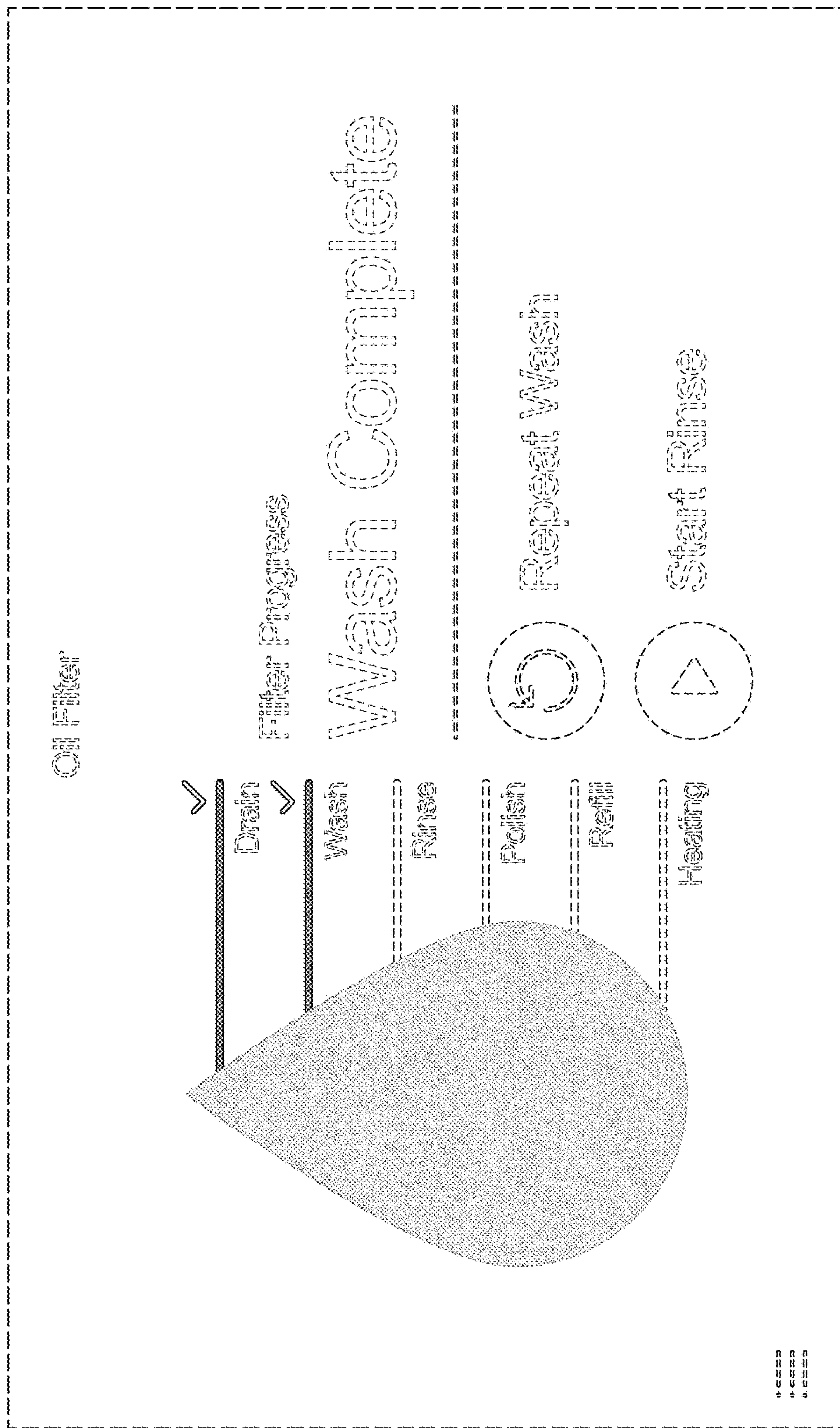

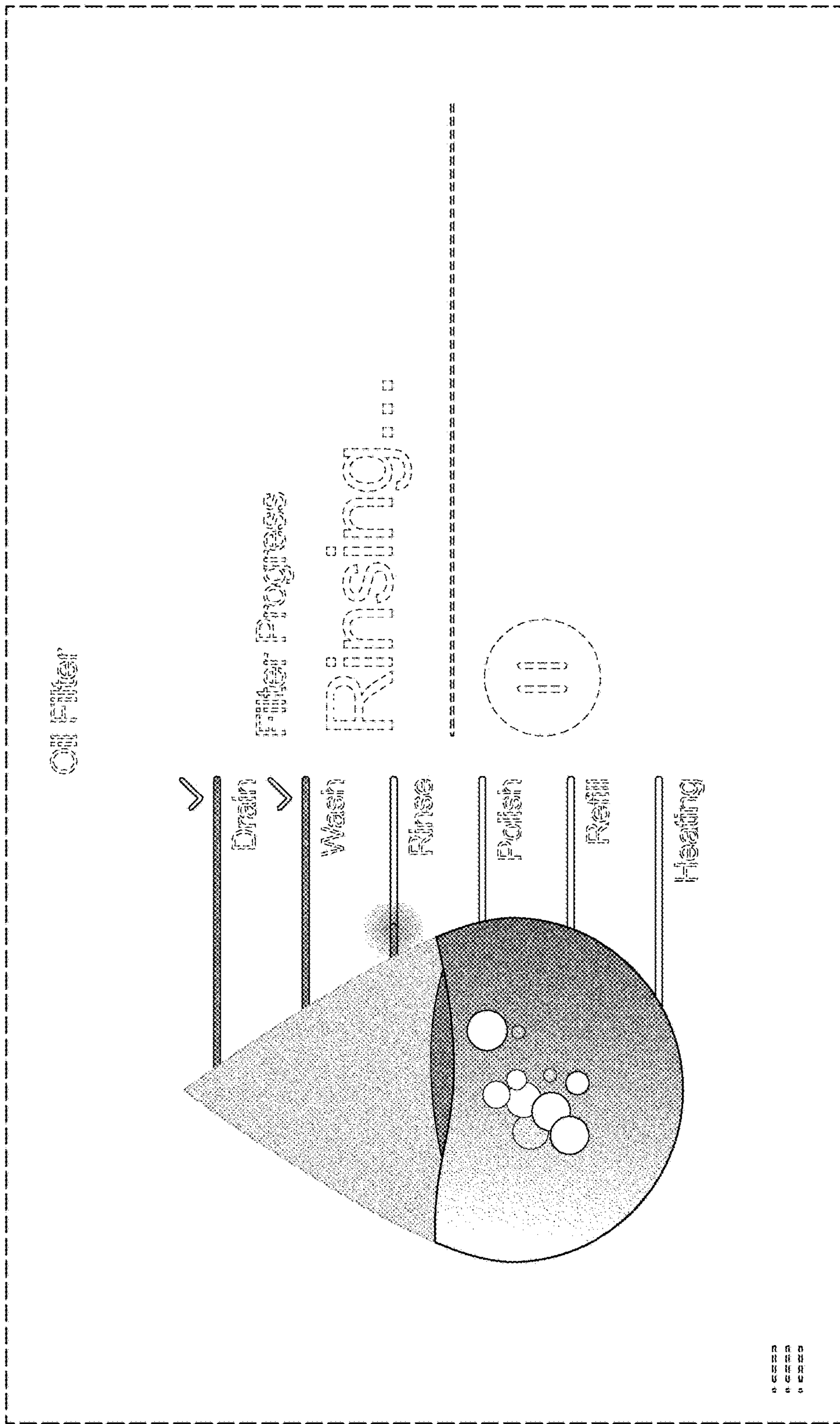

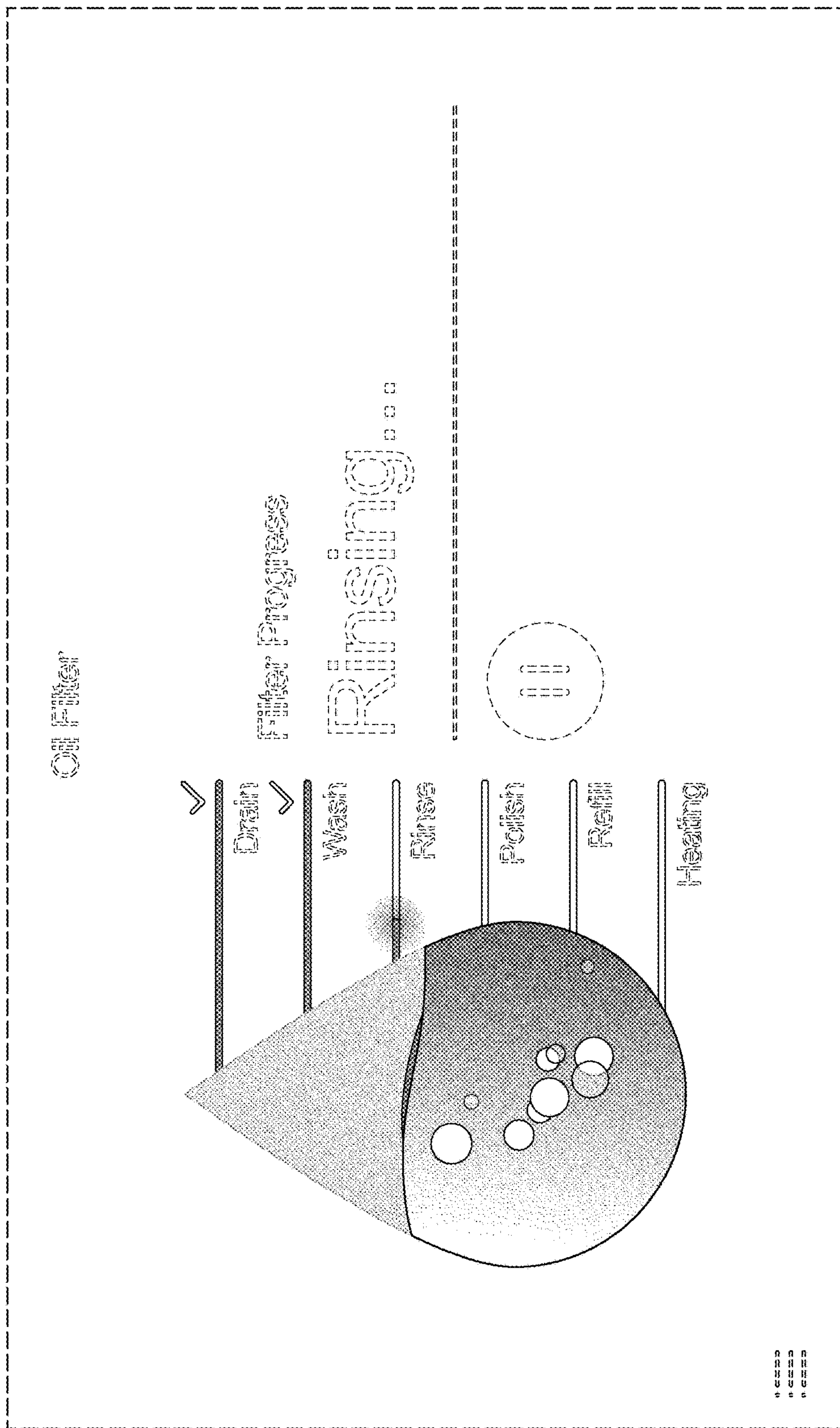

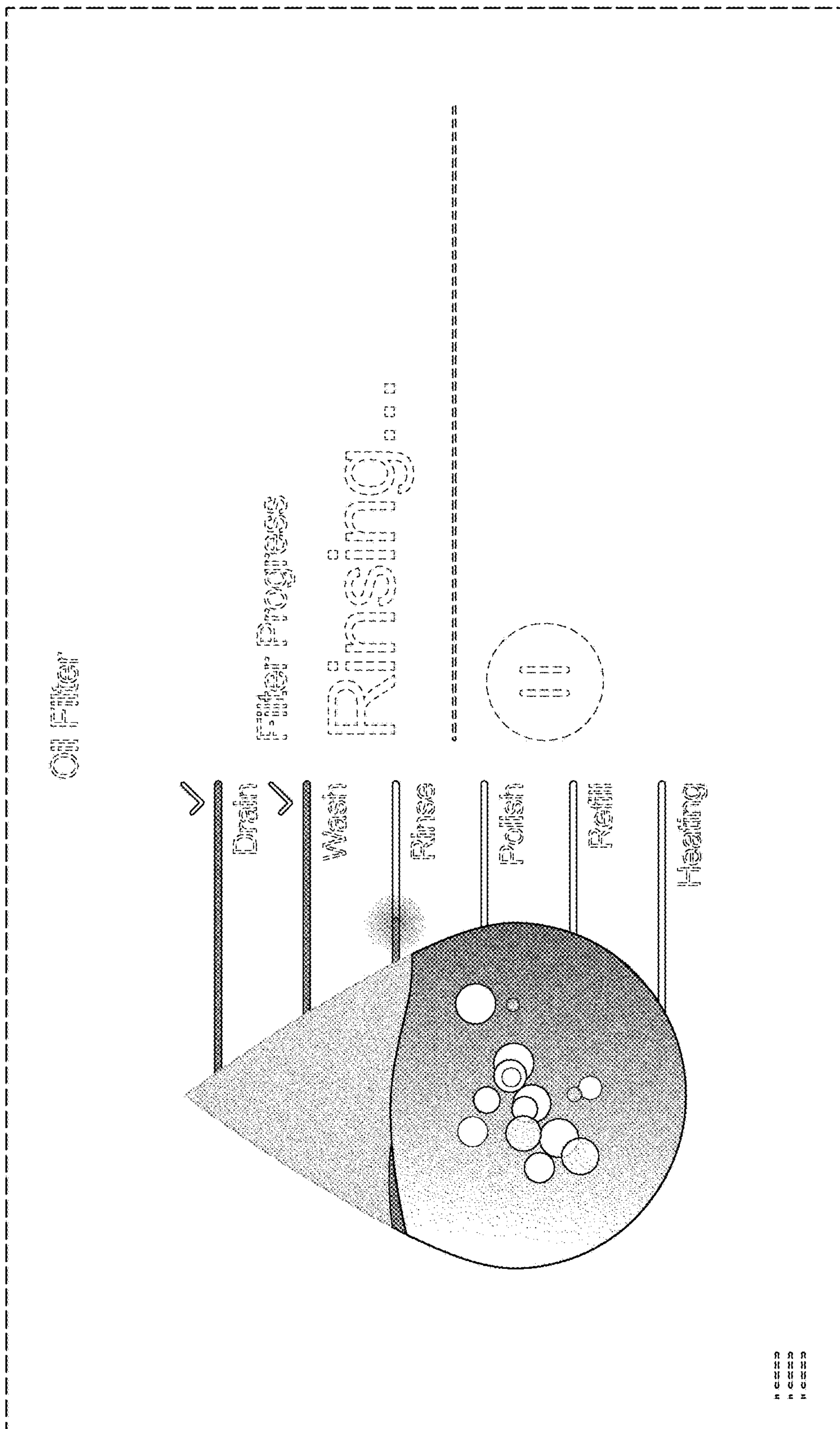

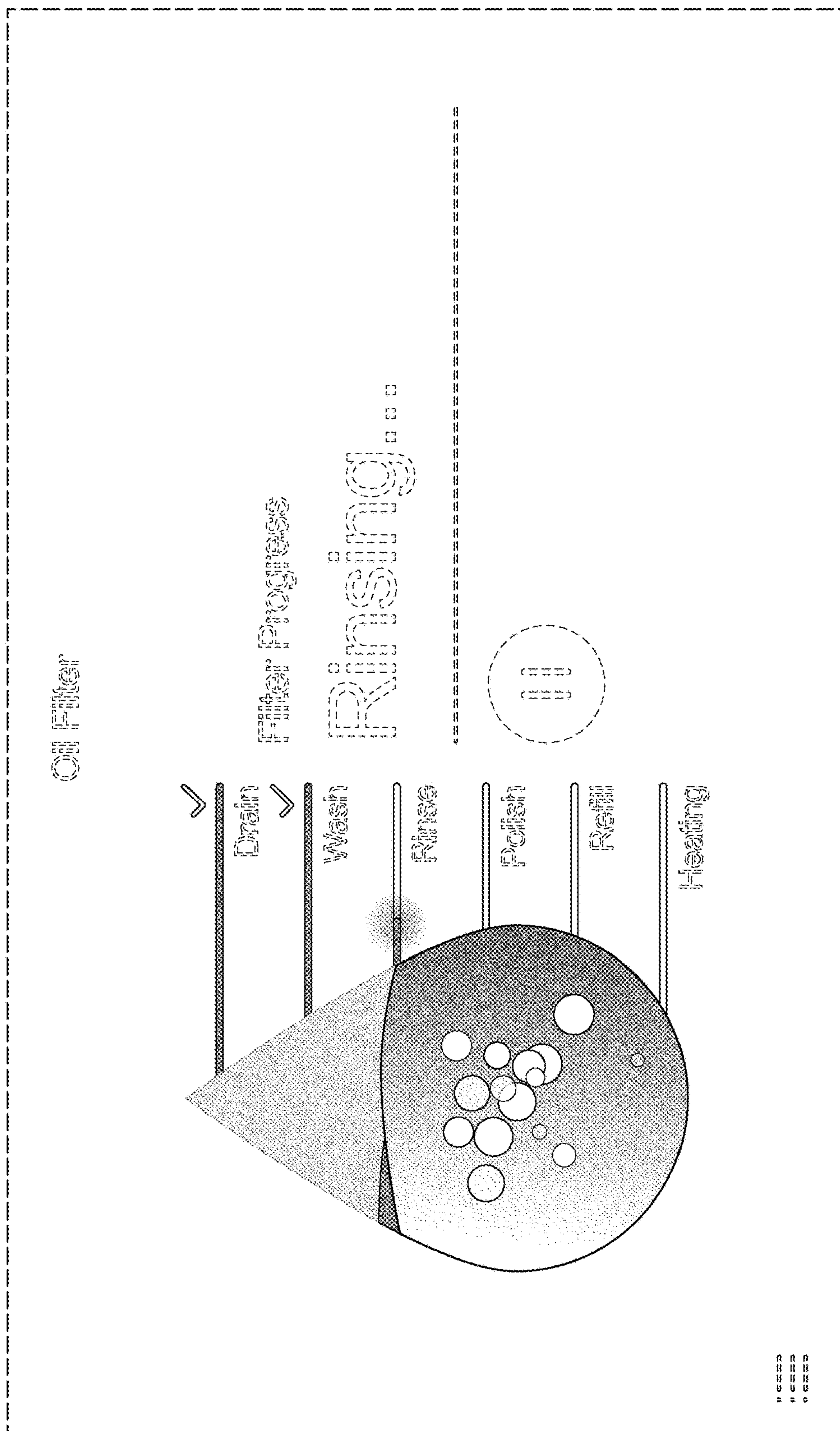

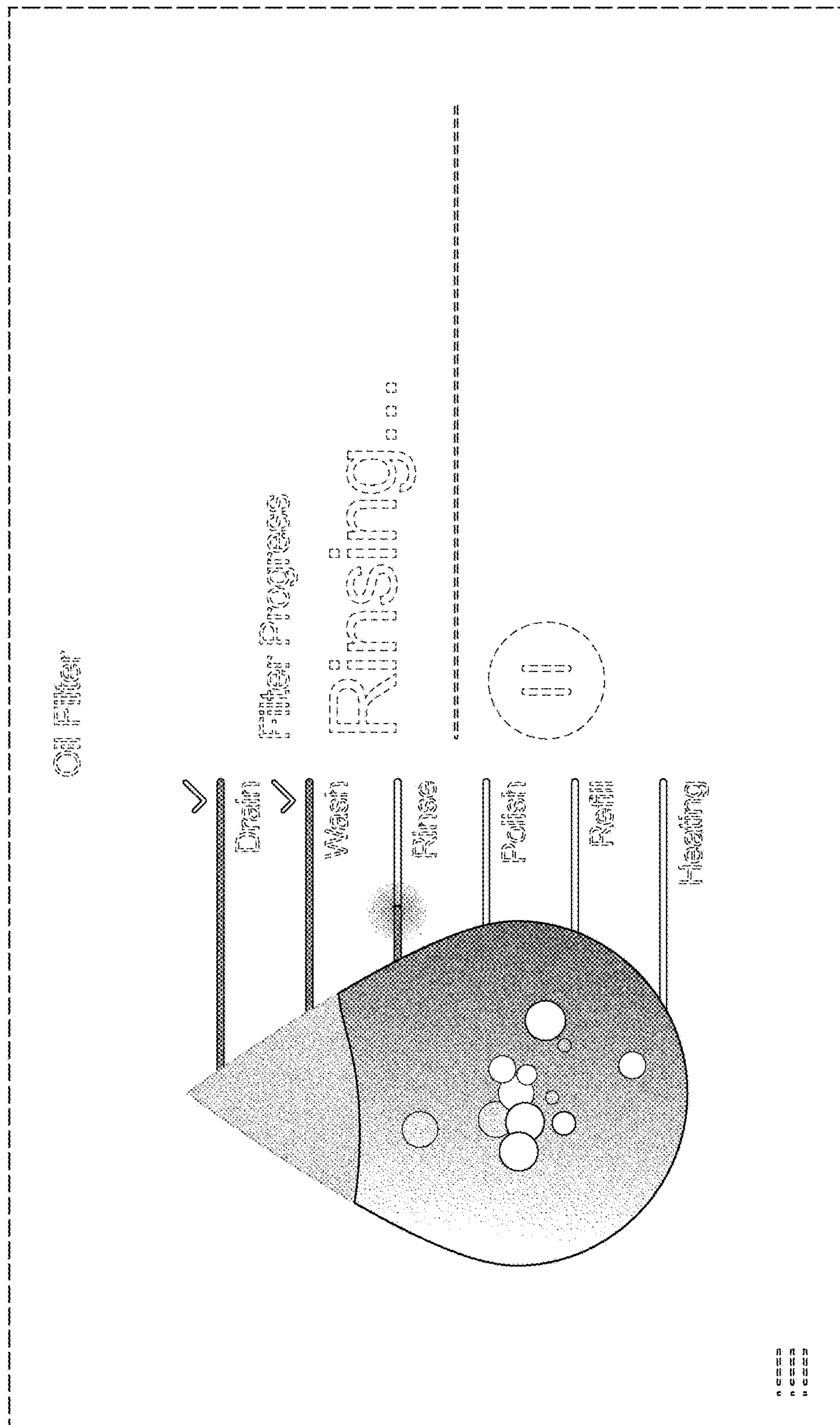

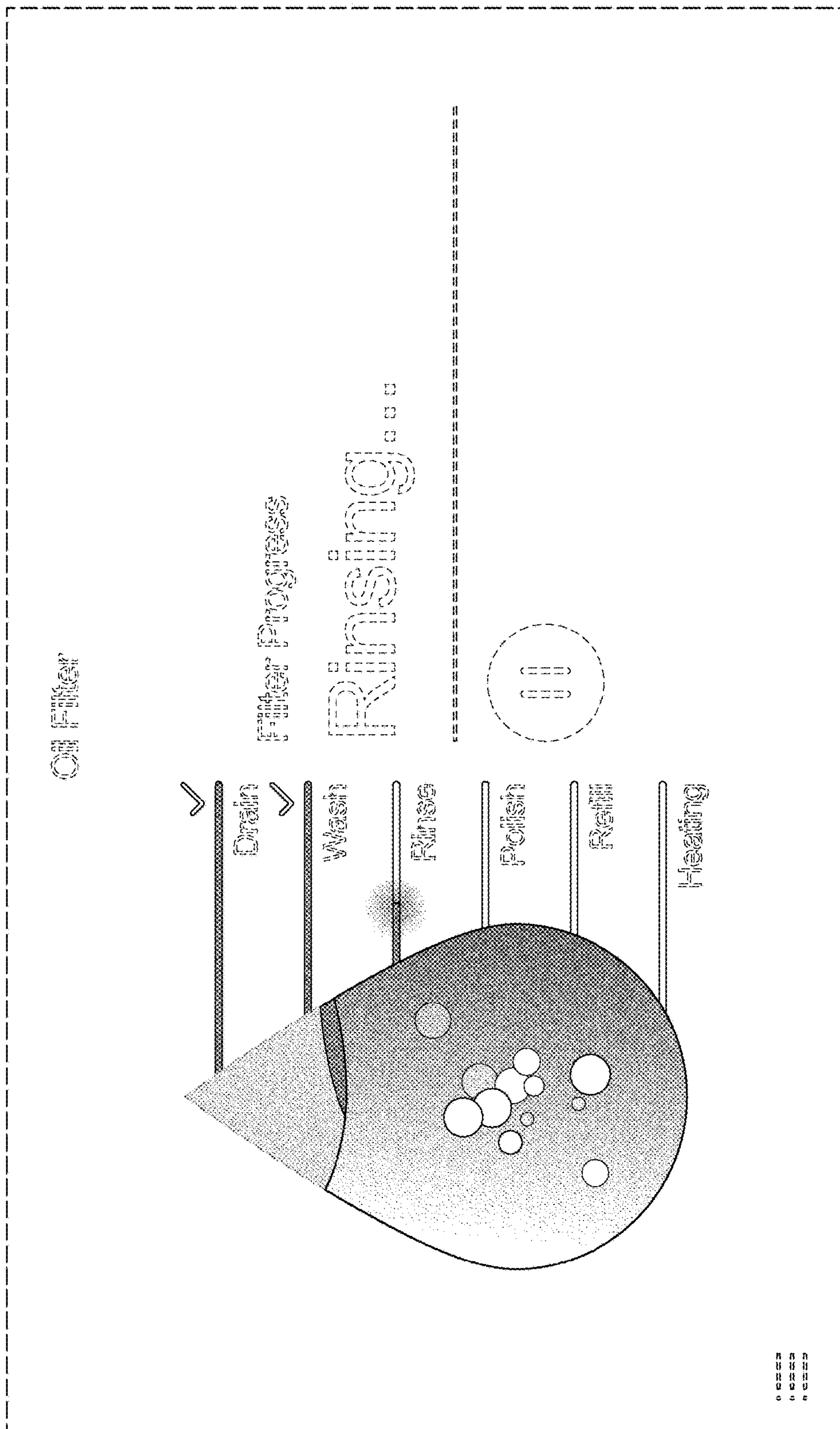

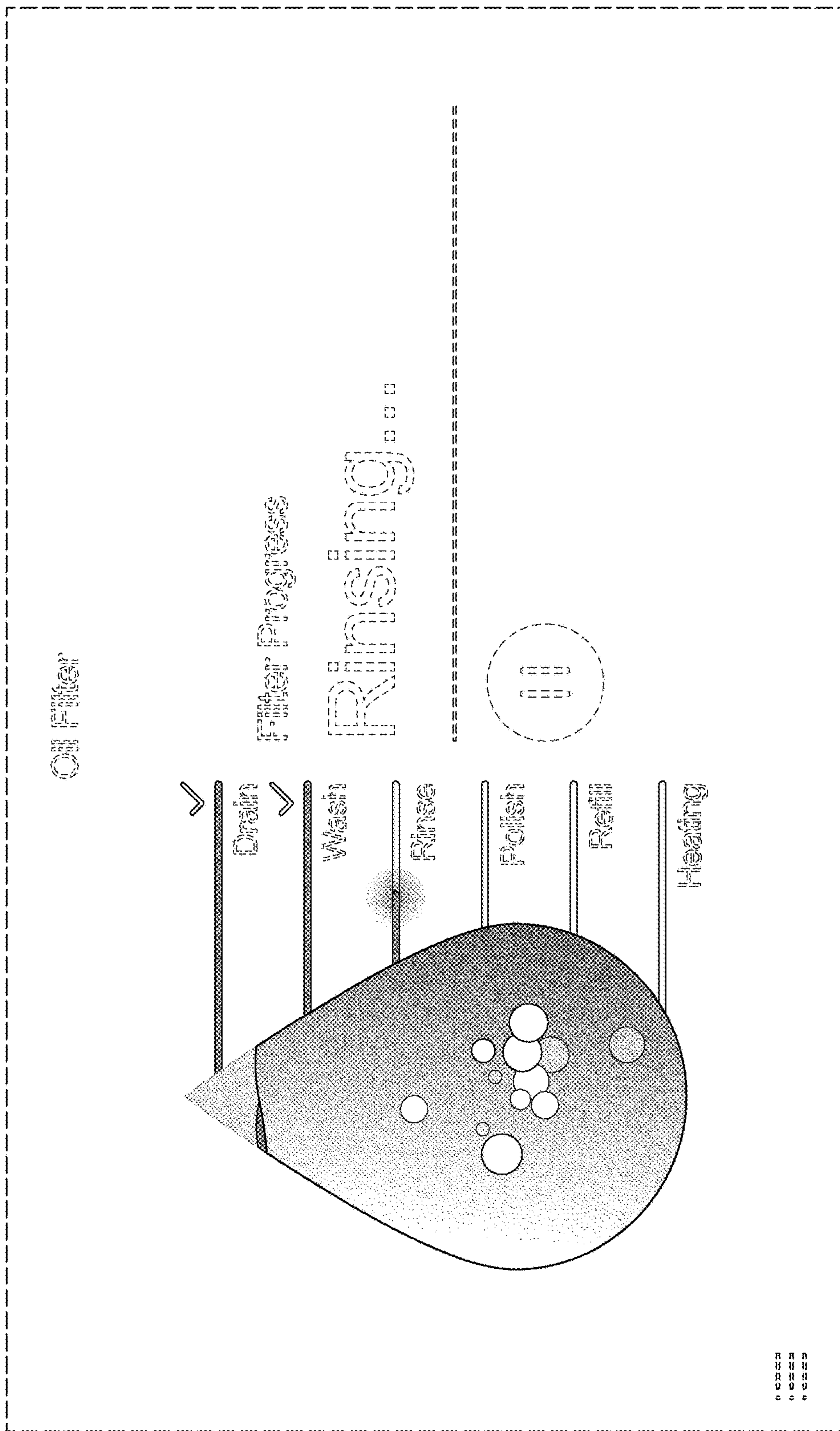

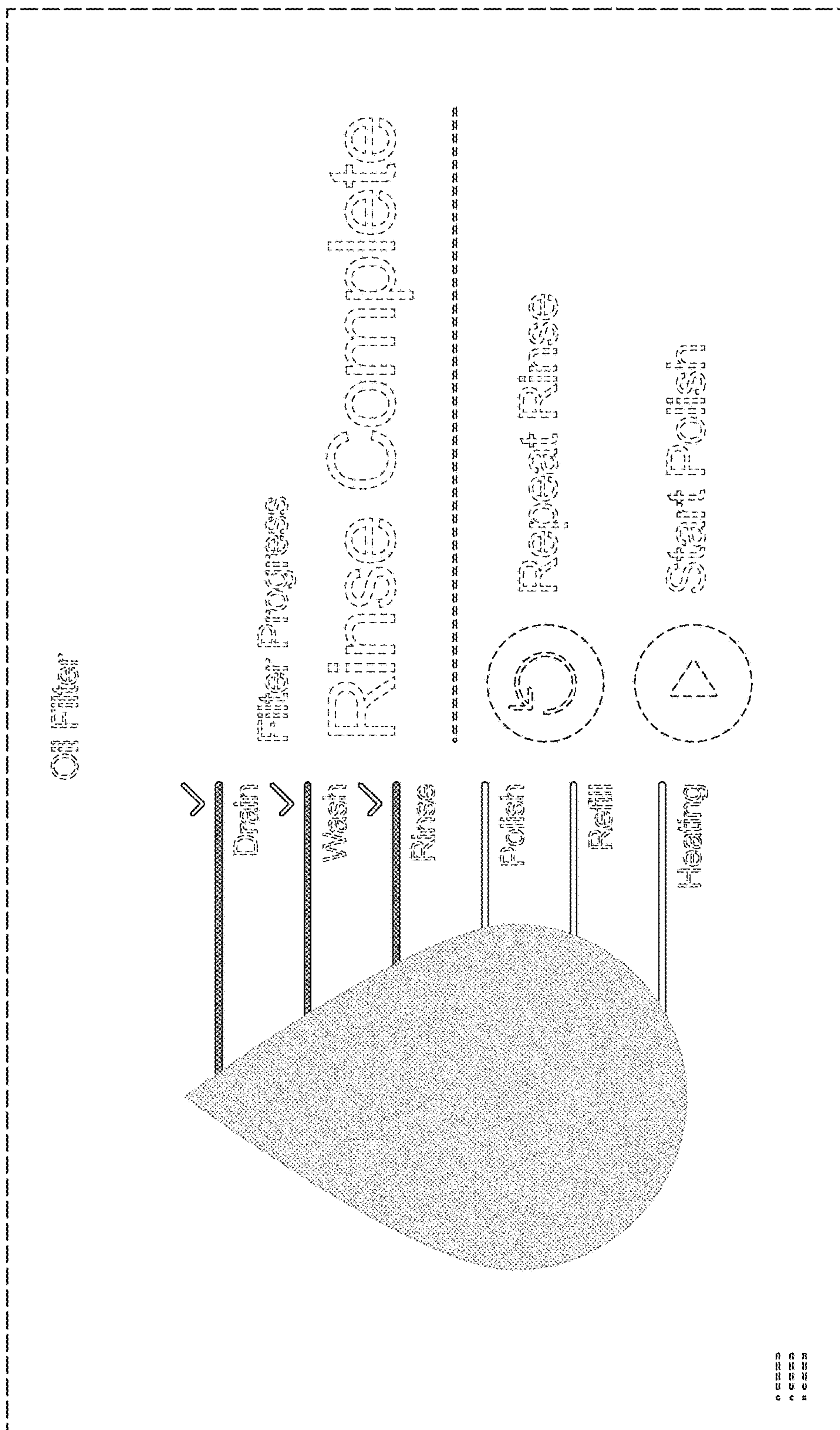

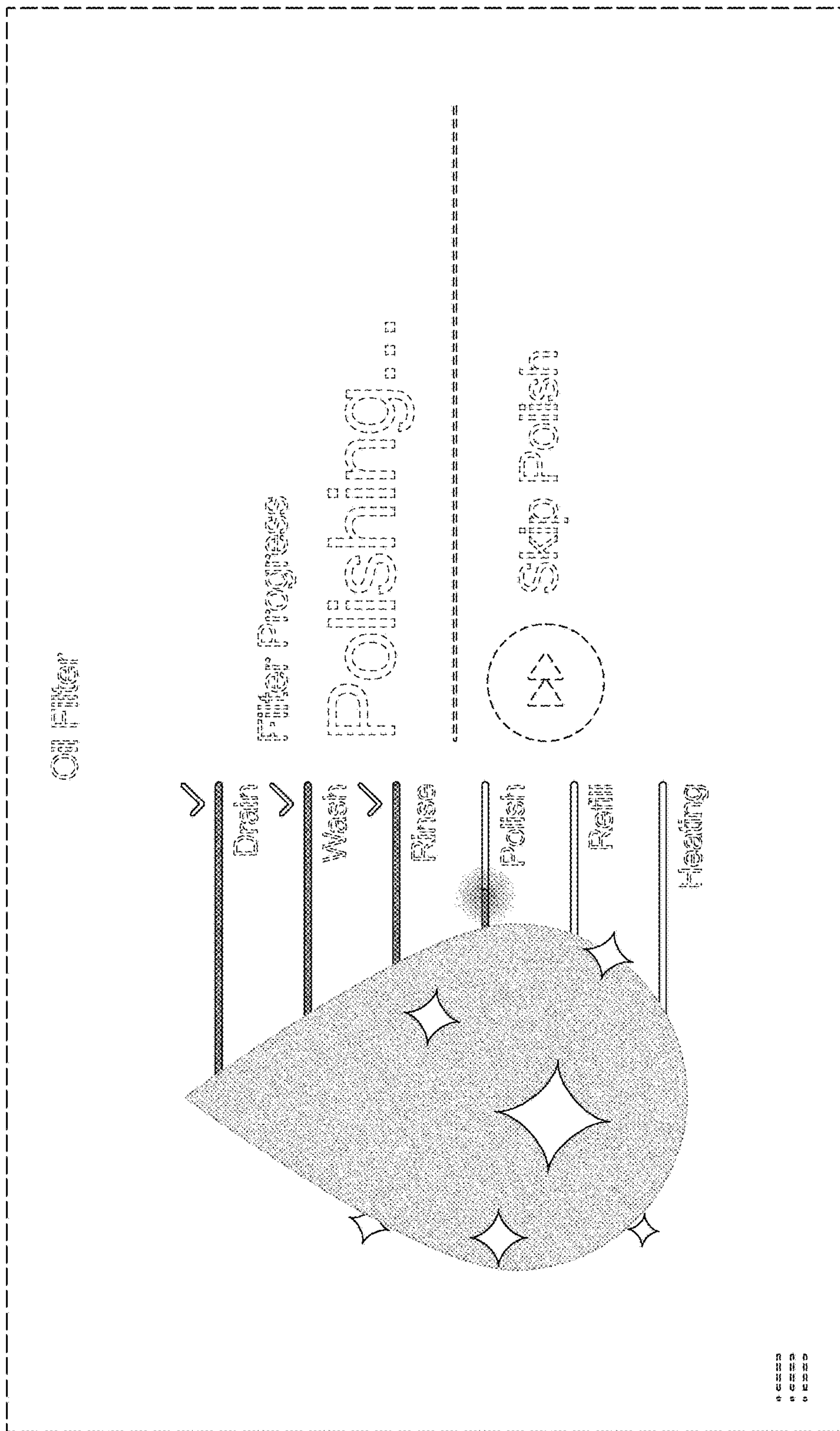

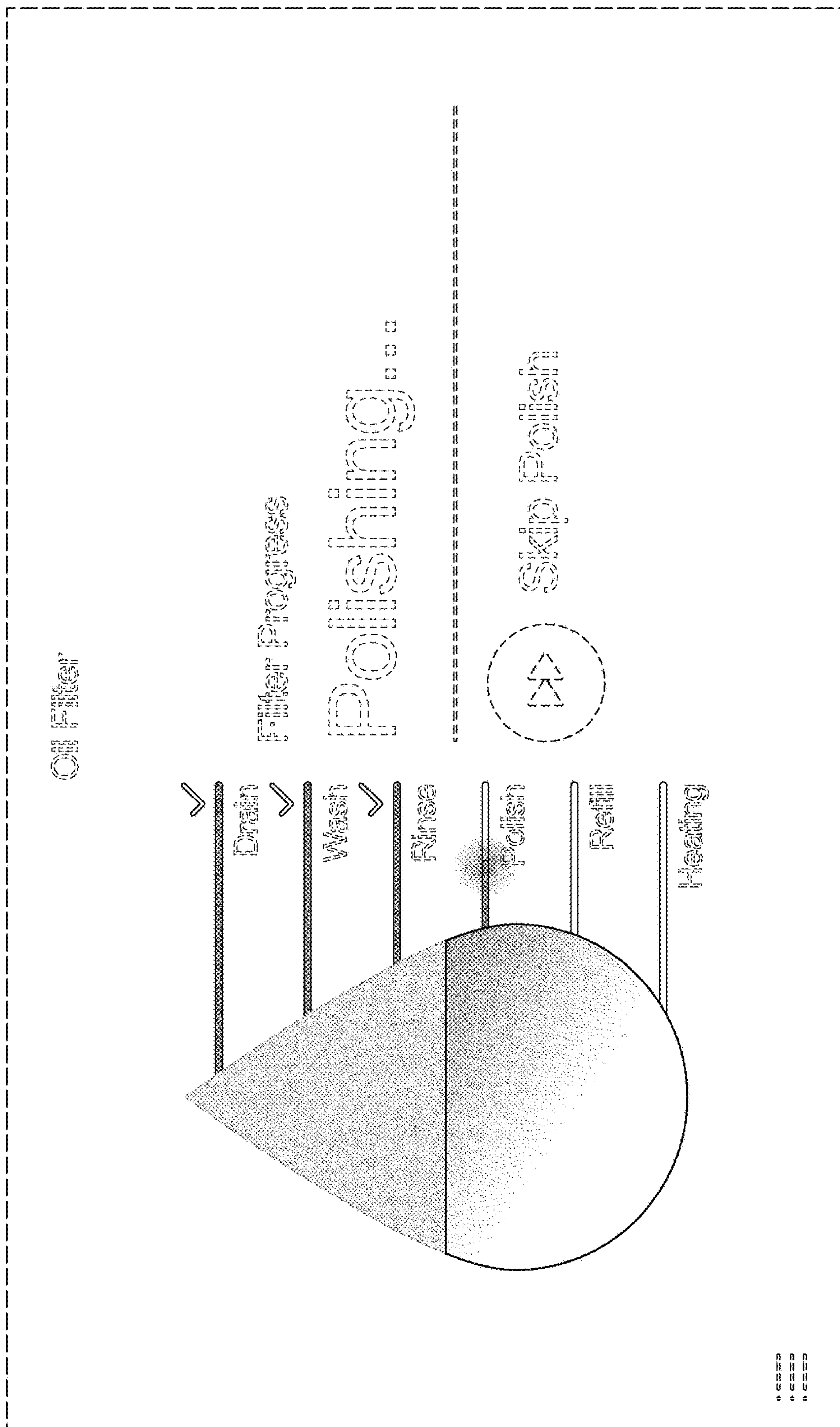

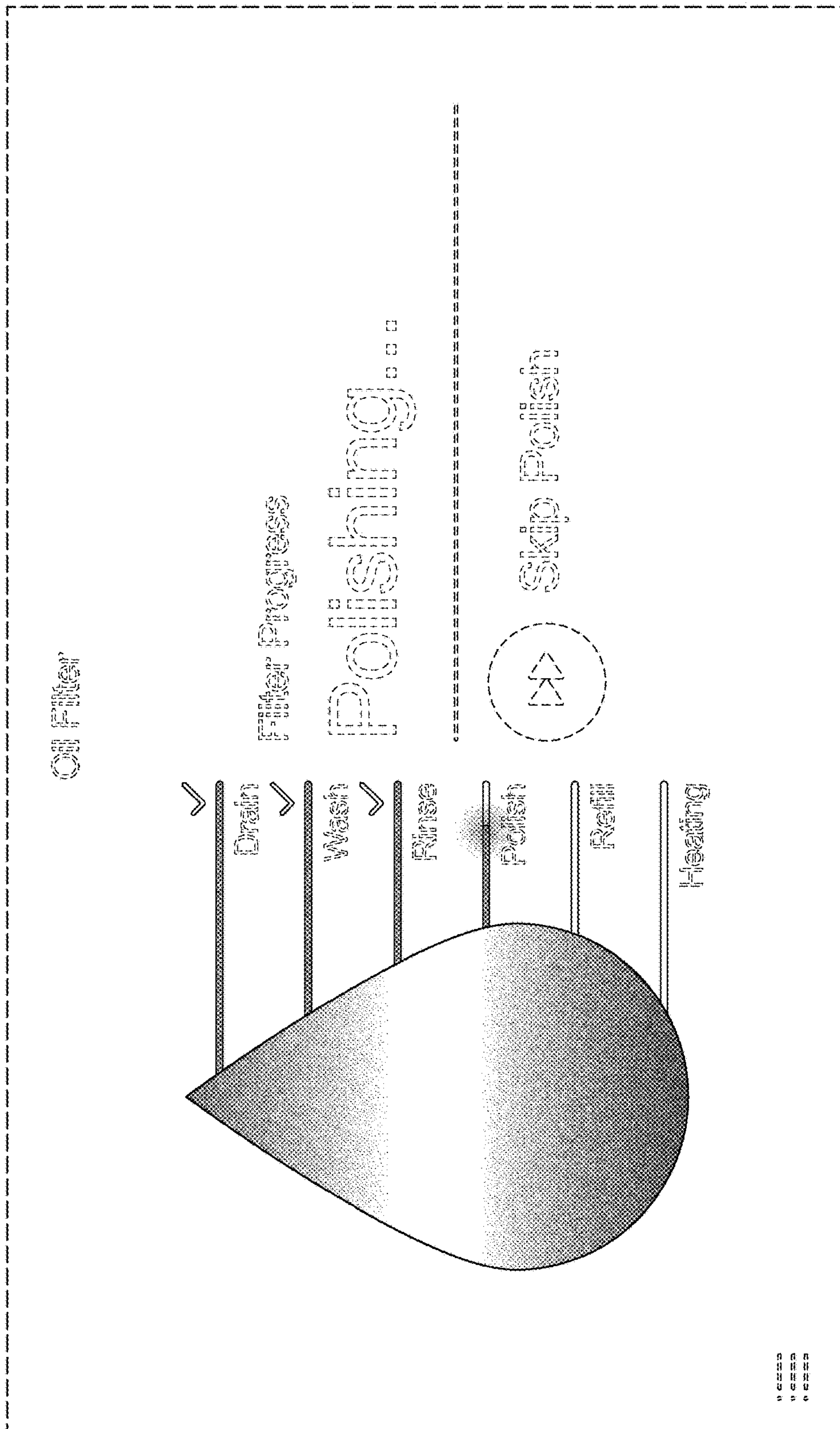

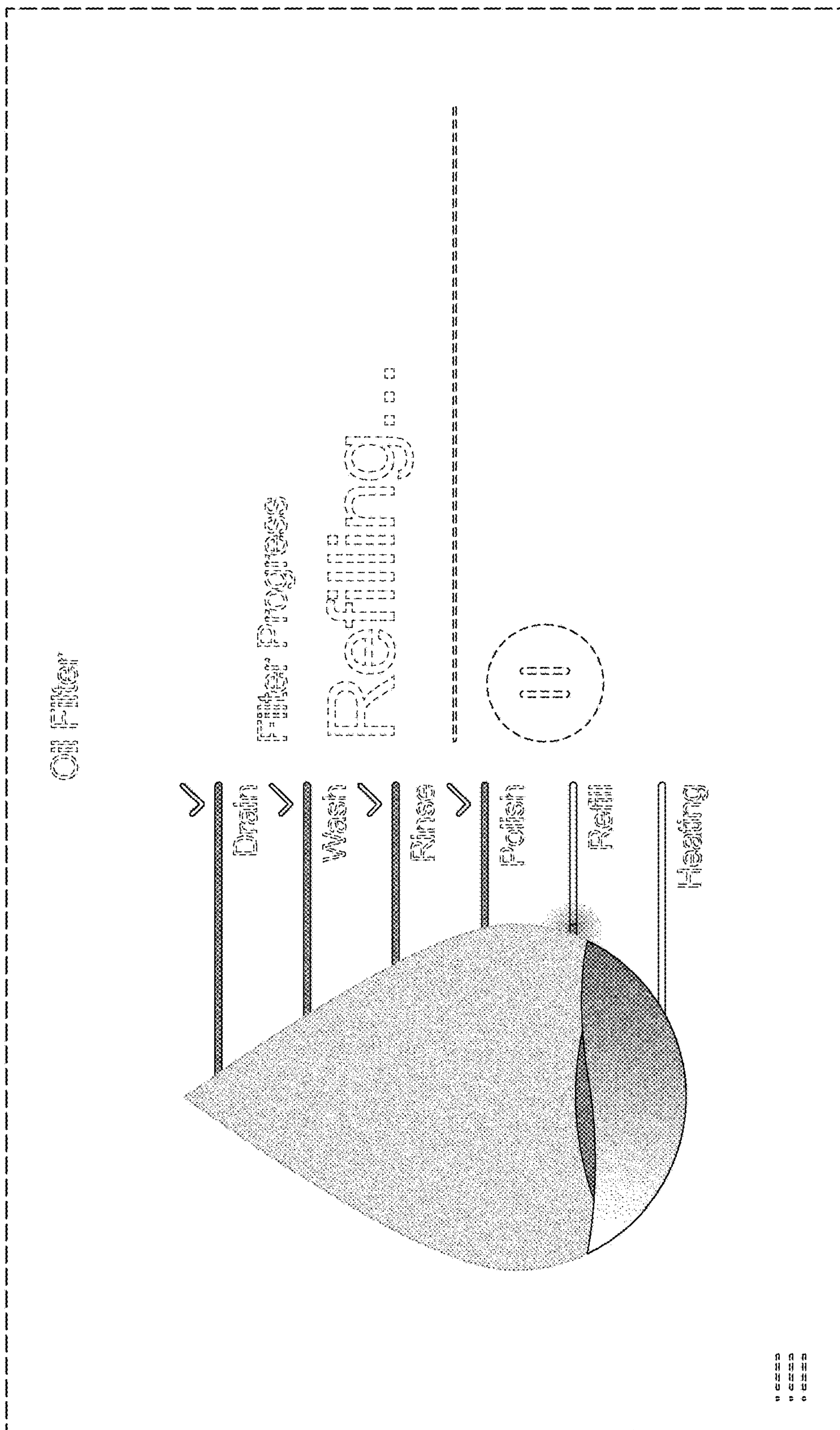

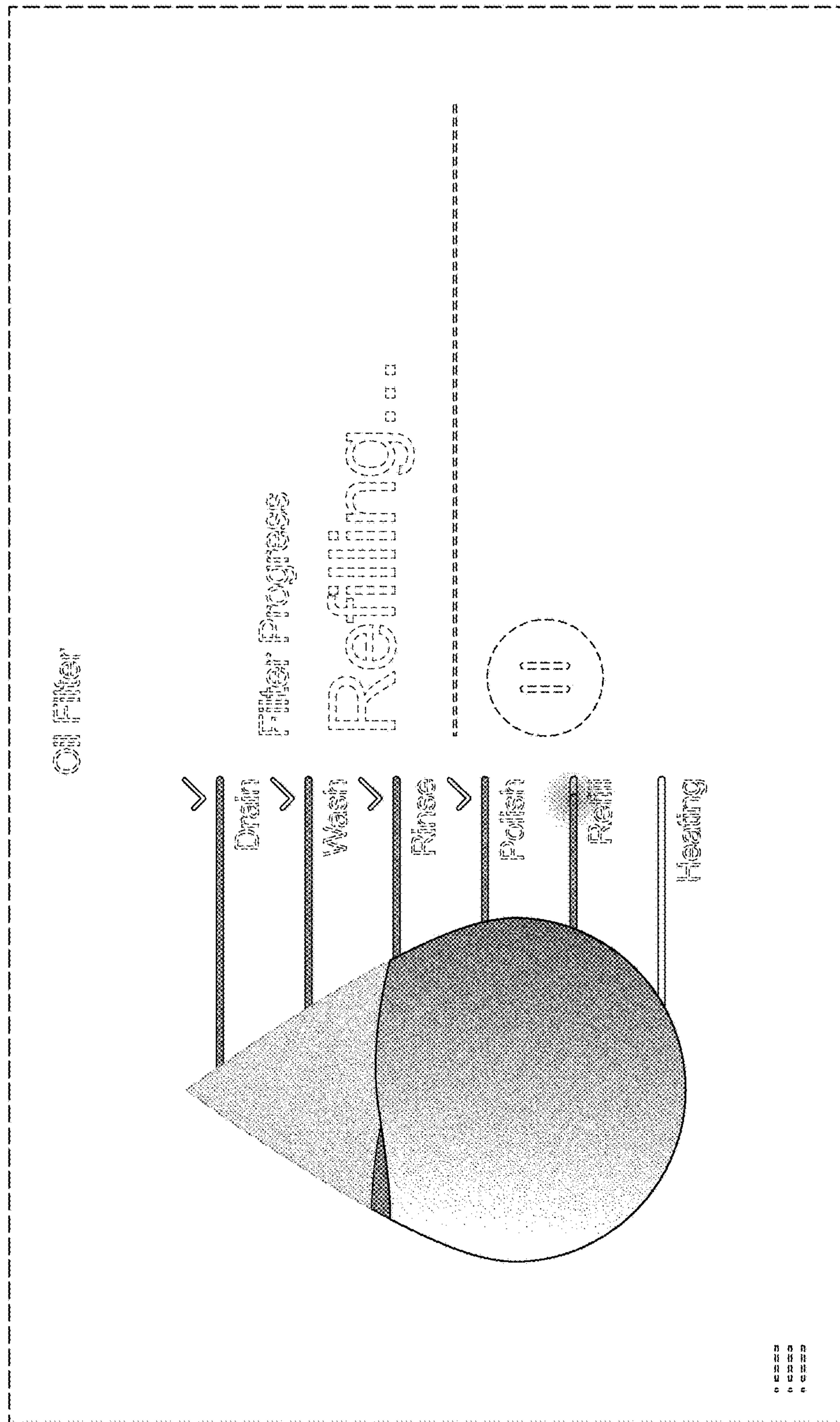

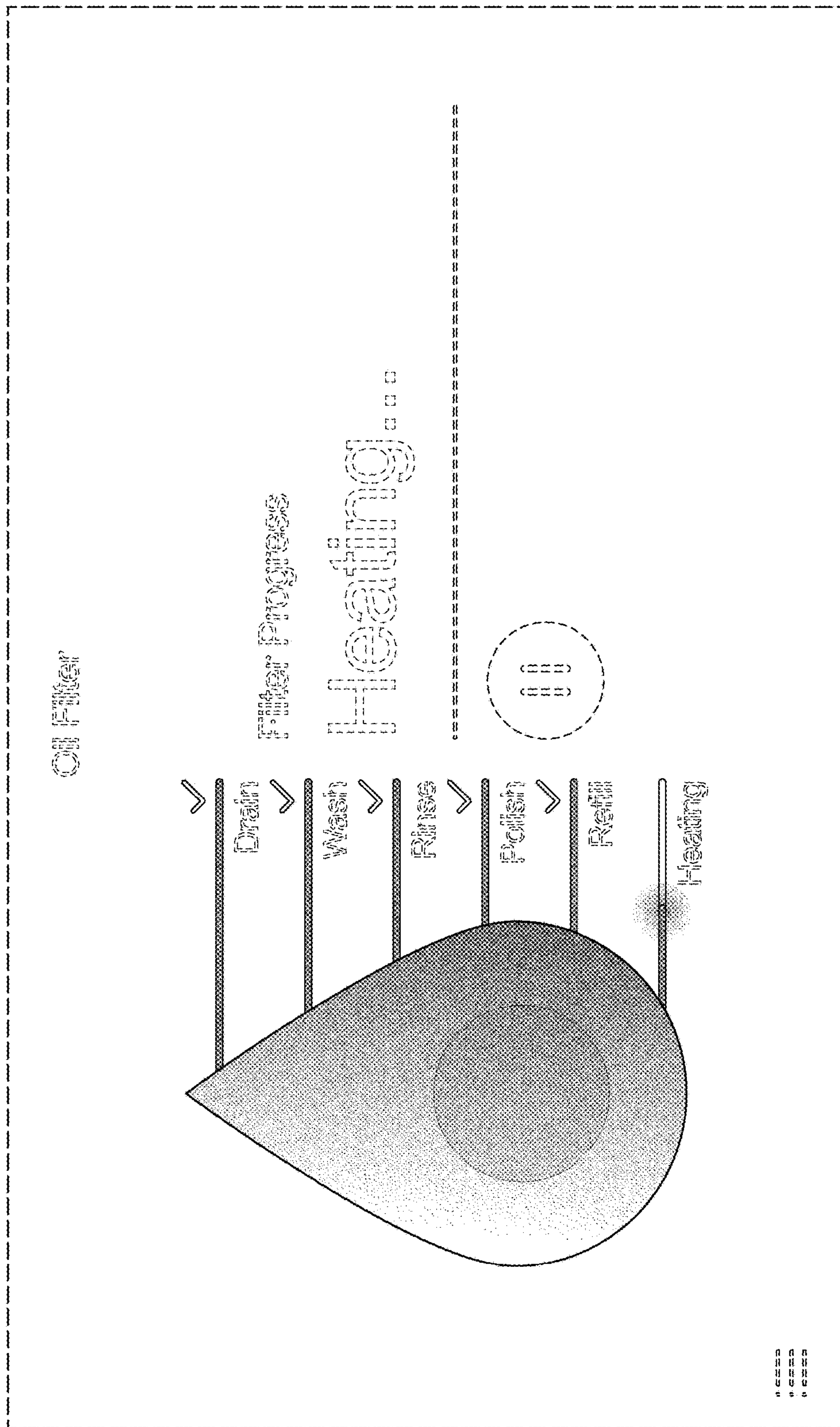

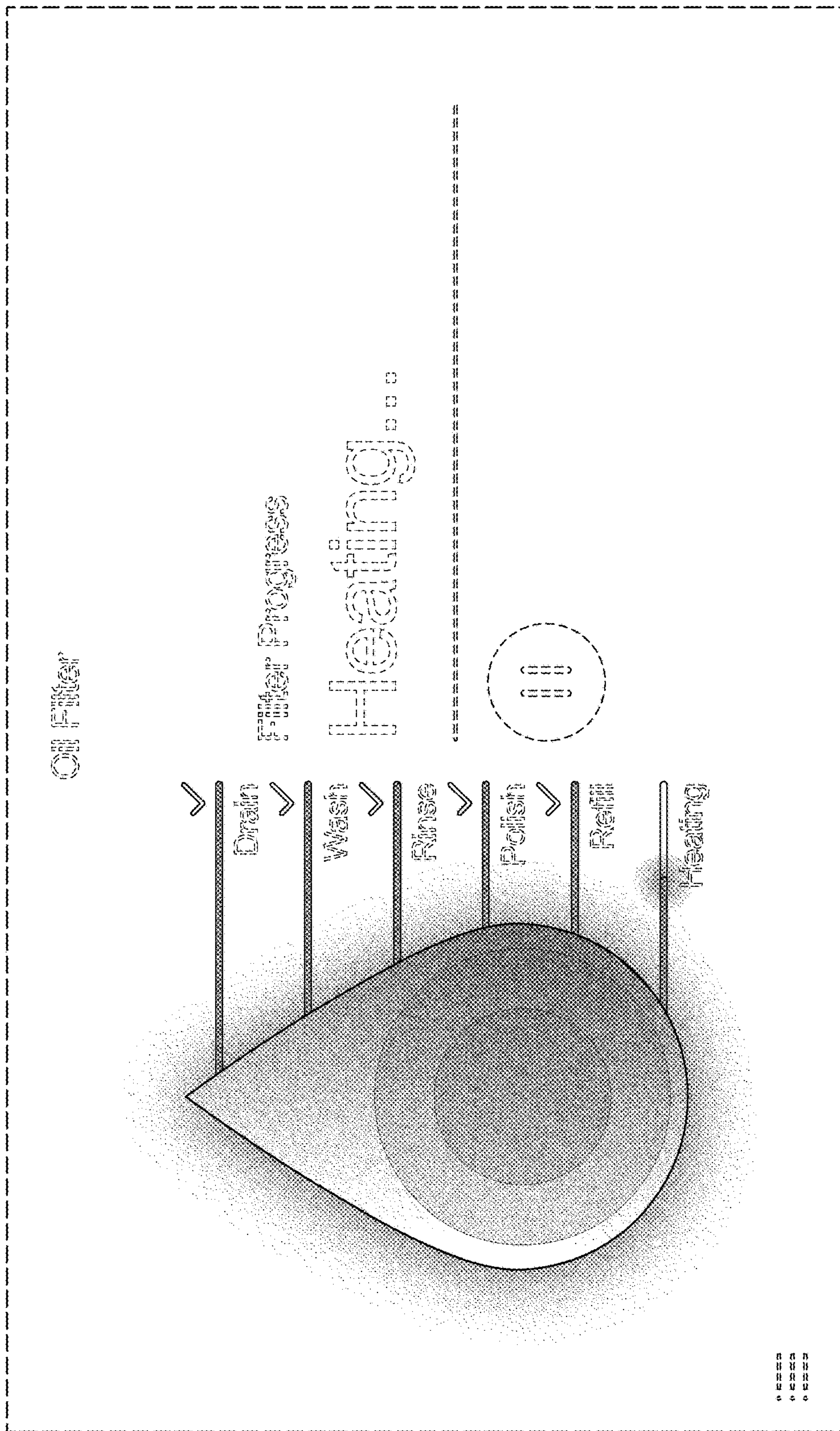

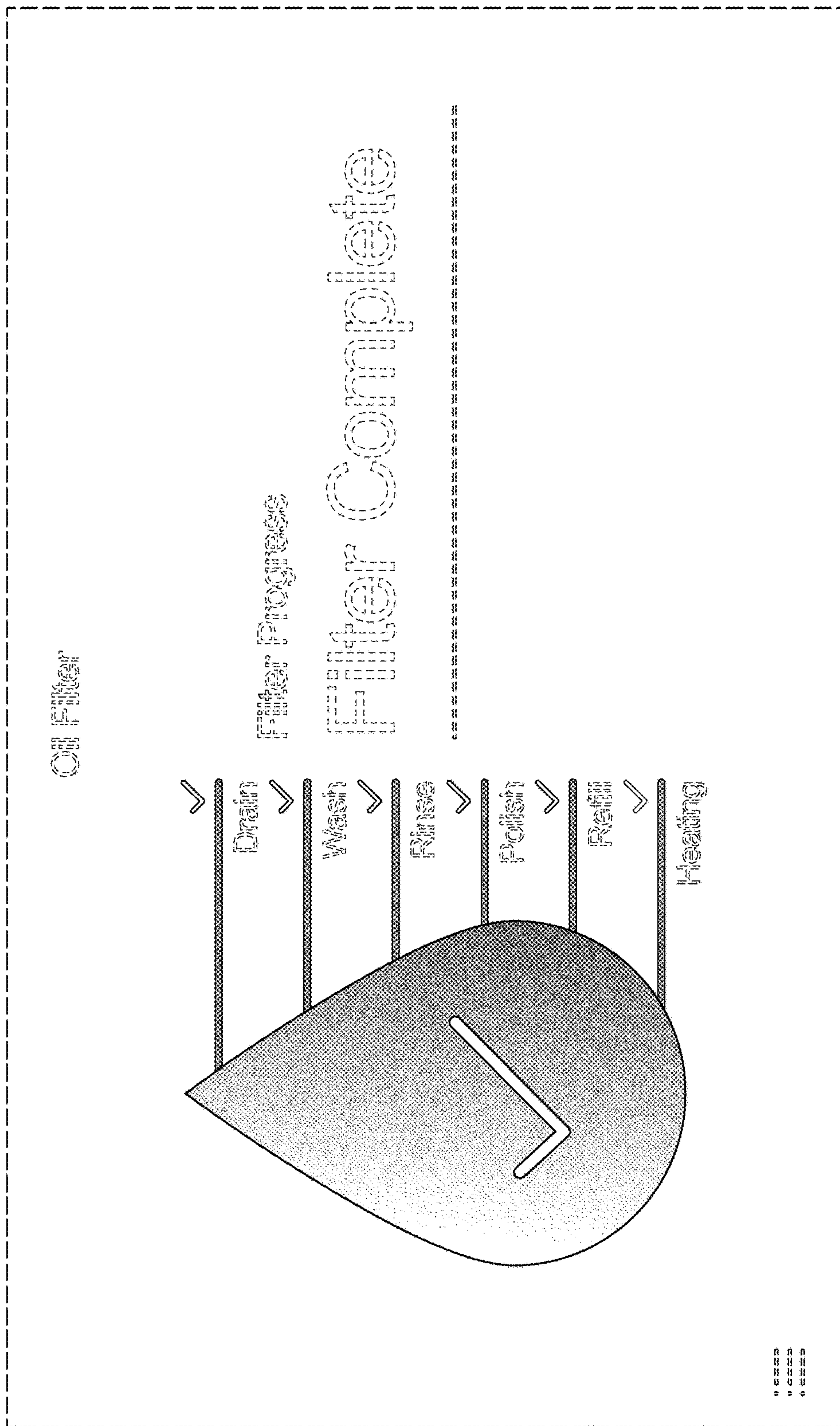
