FIG. 6 is a top plan view.

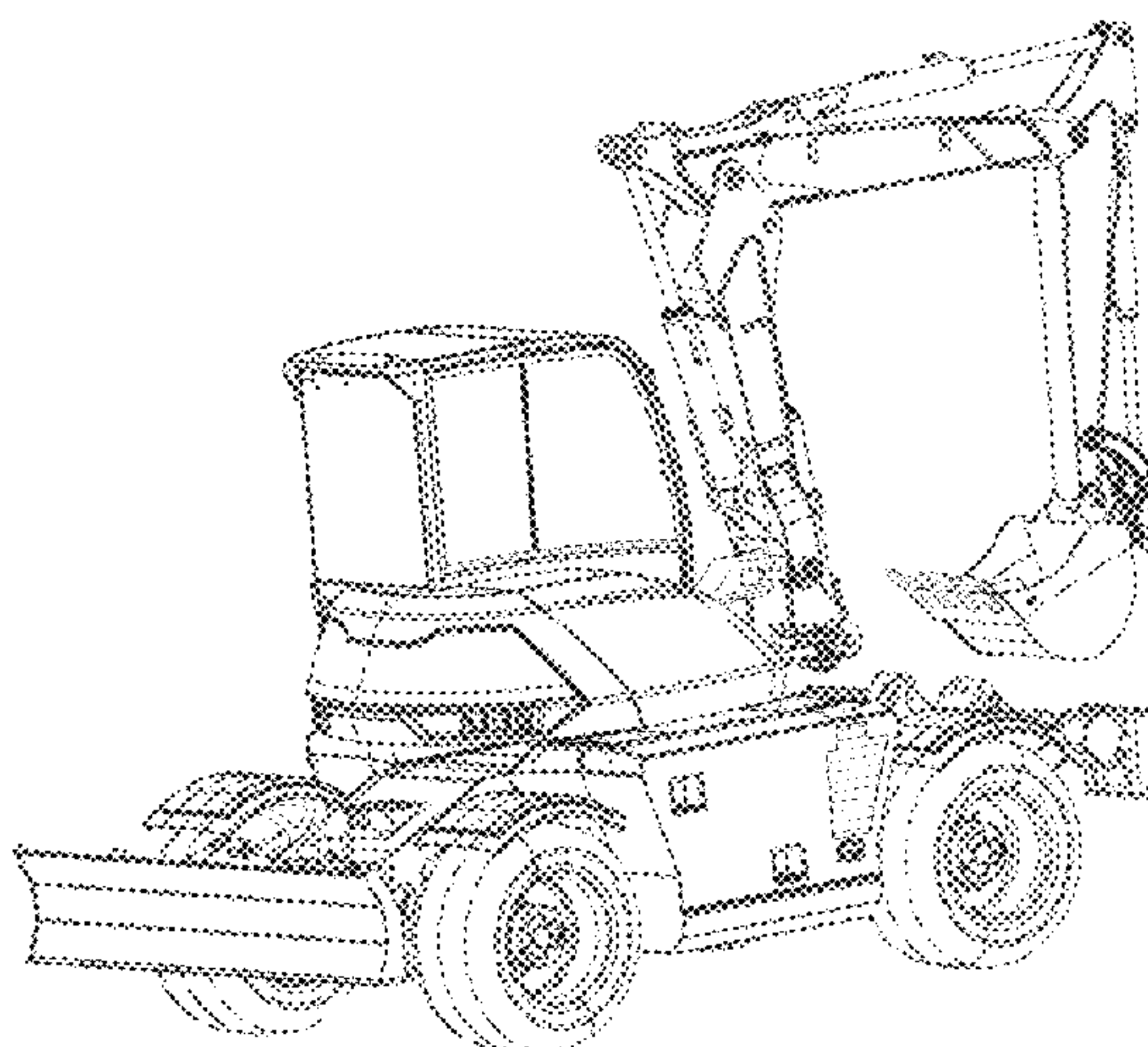
FIG. 7 is a front, right-side, and top view.

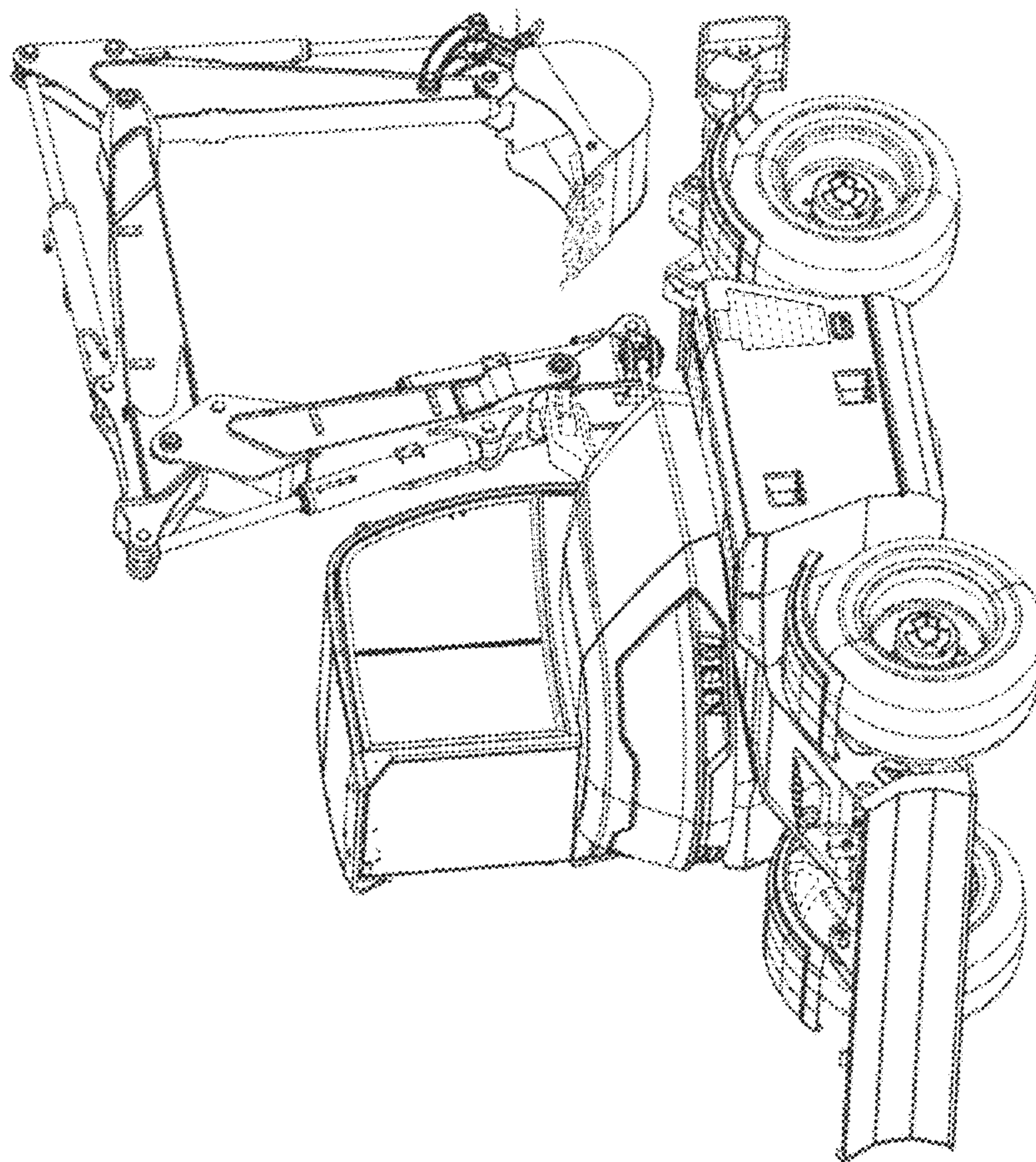

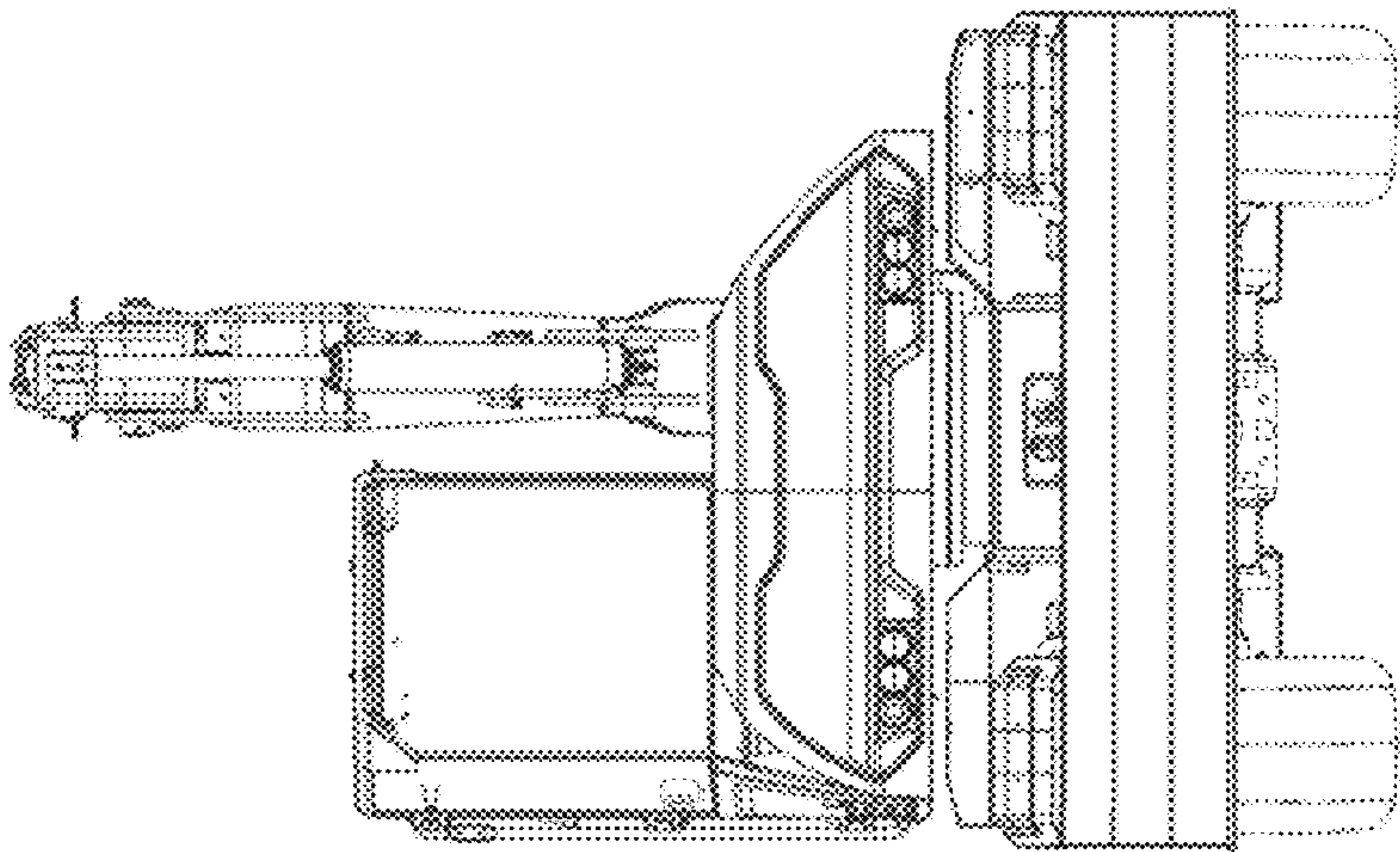

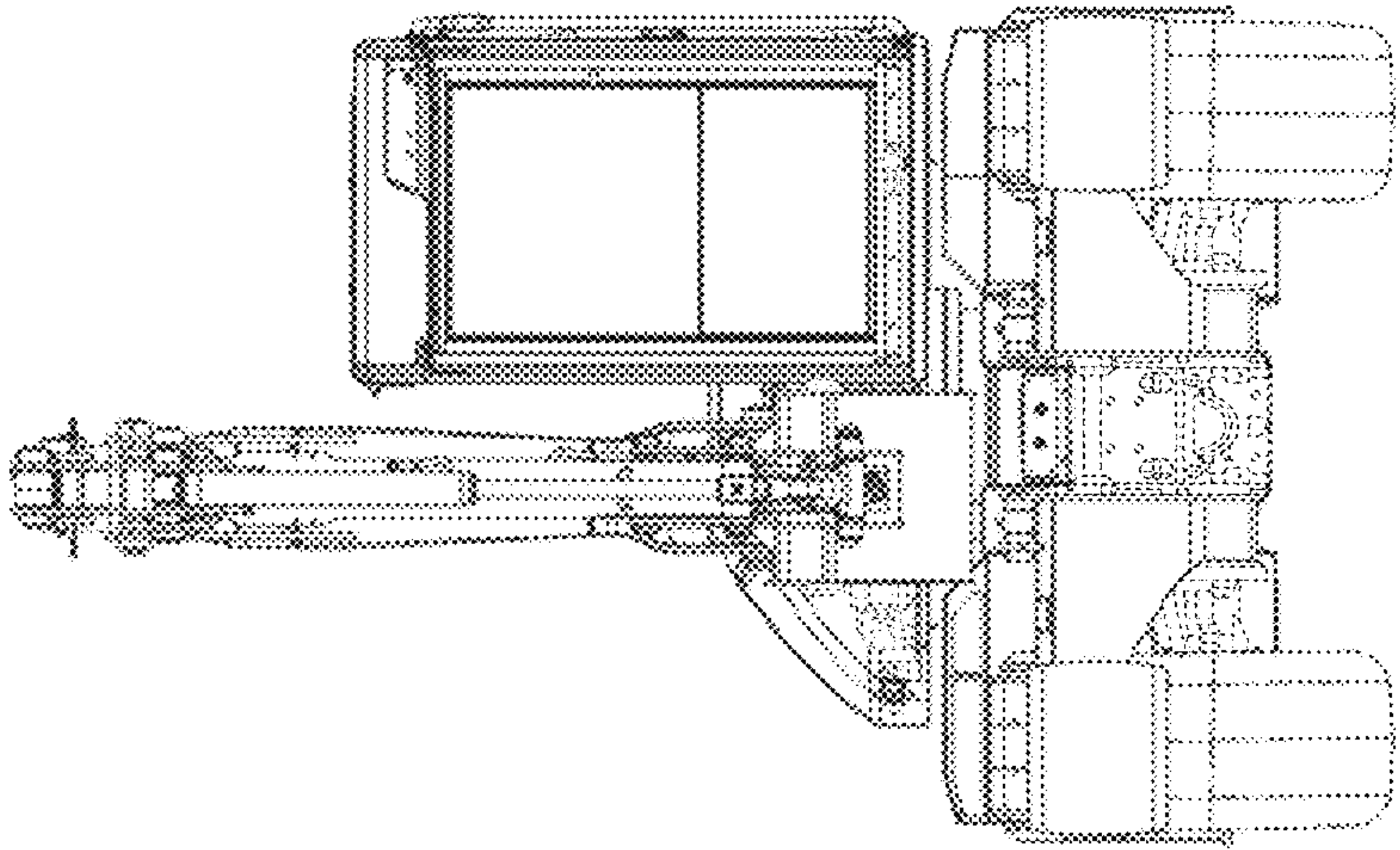

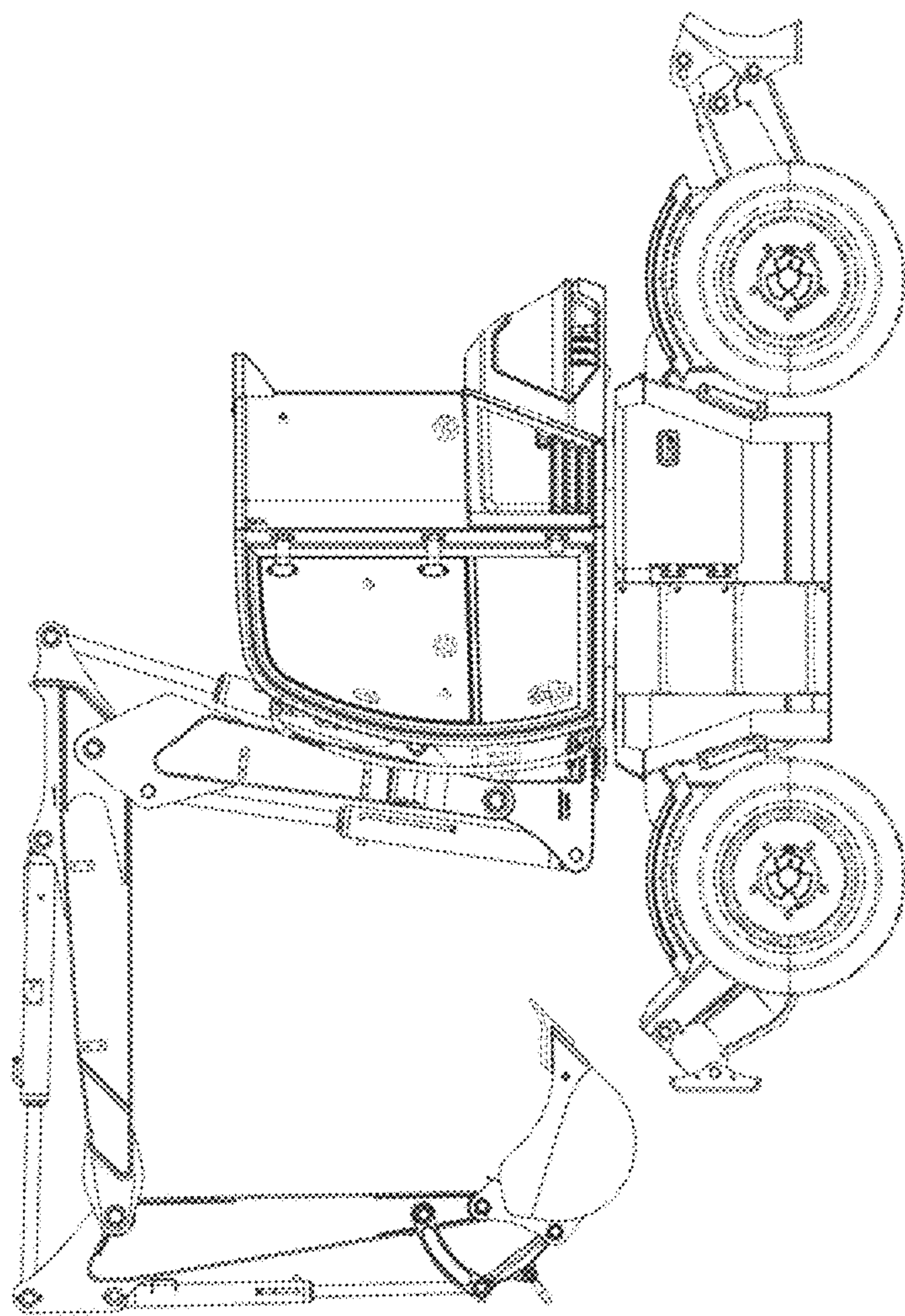

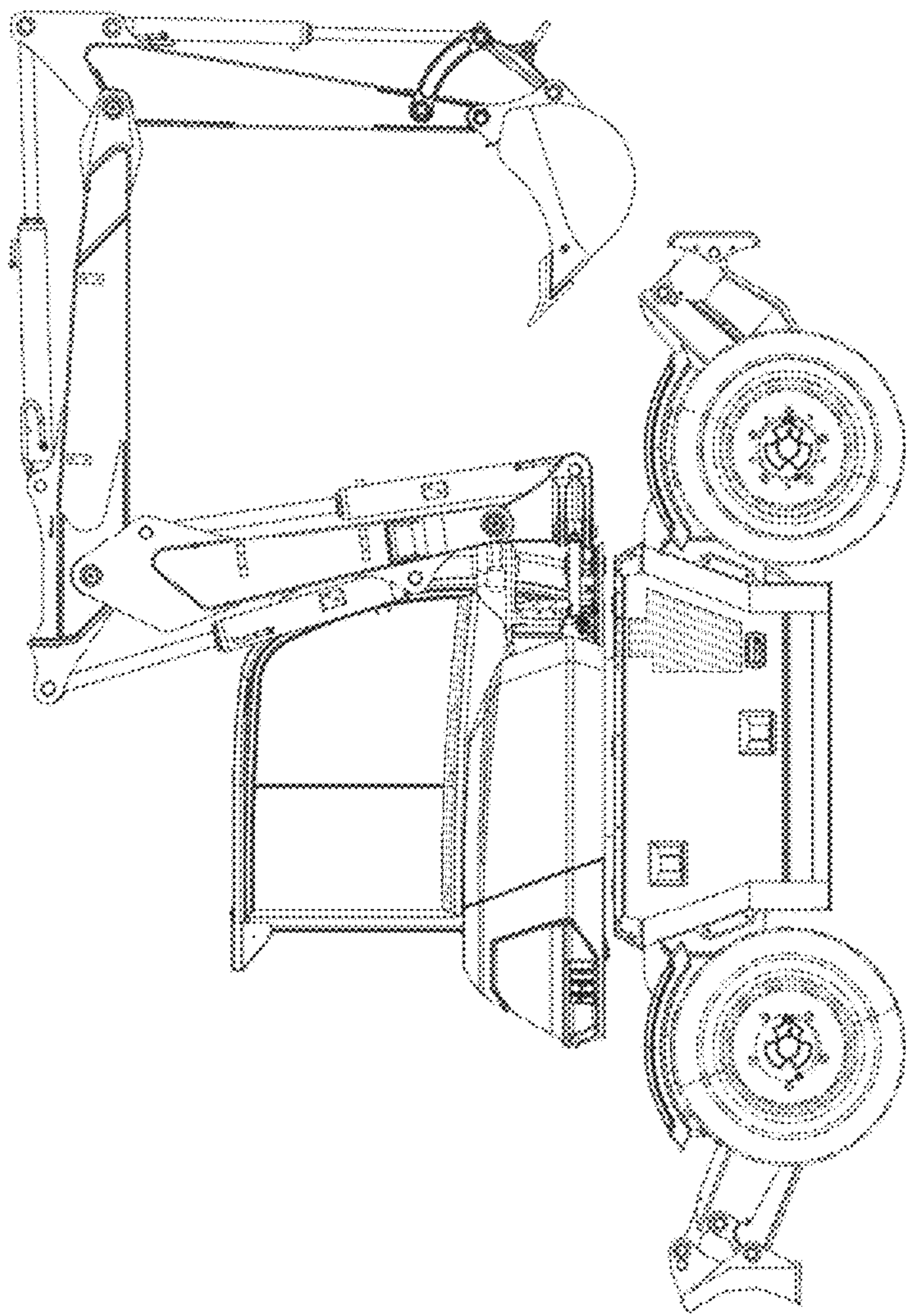

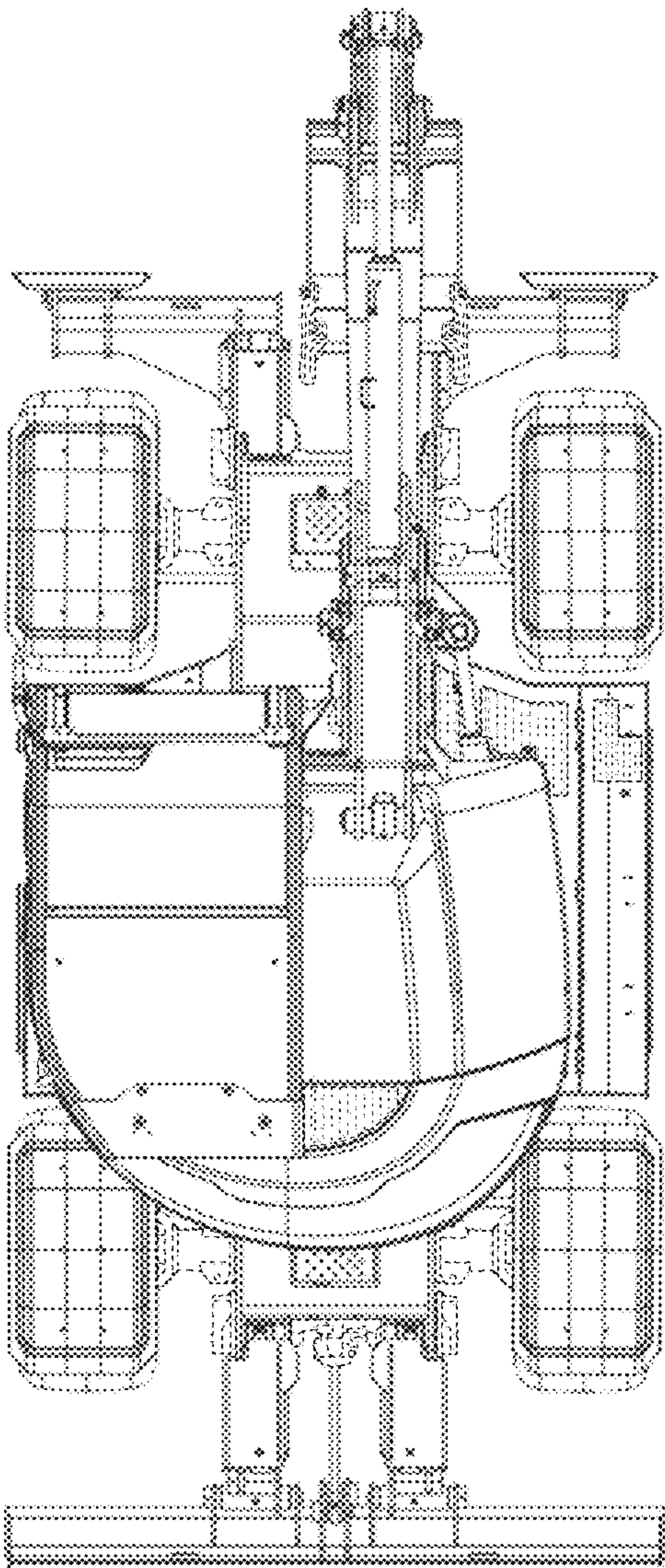

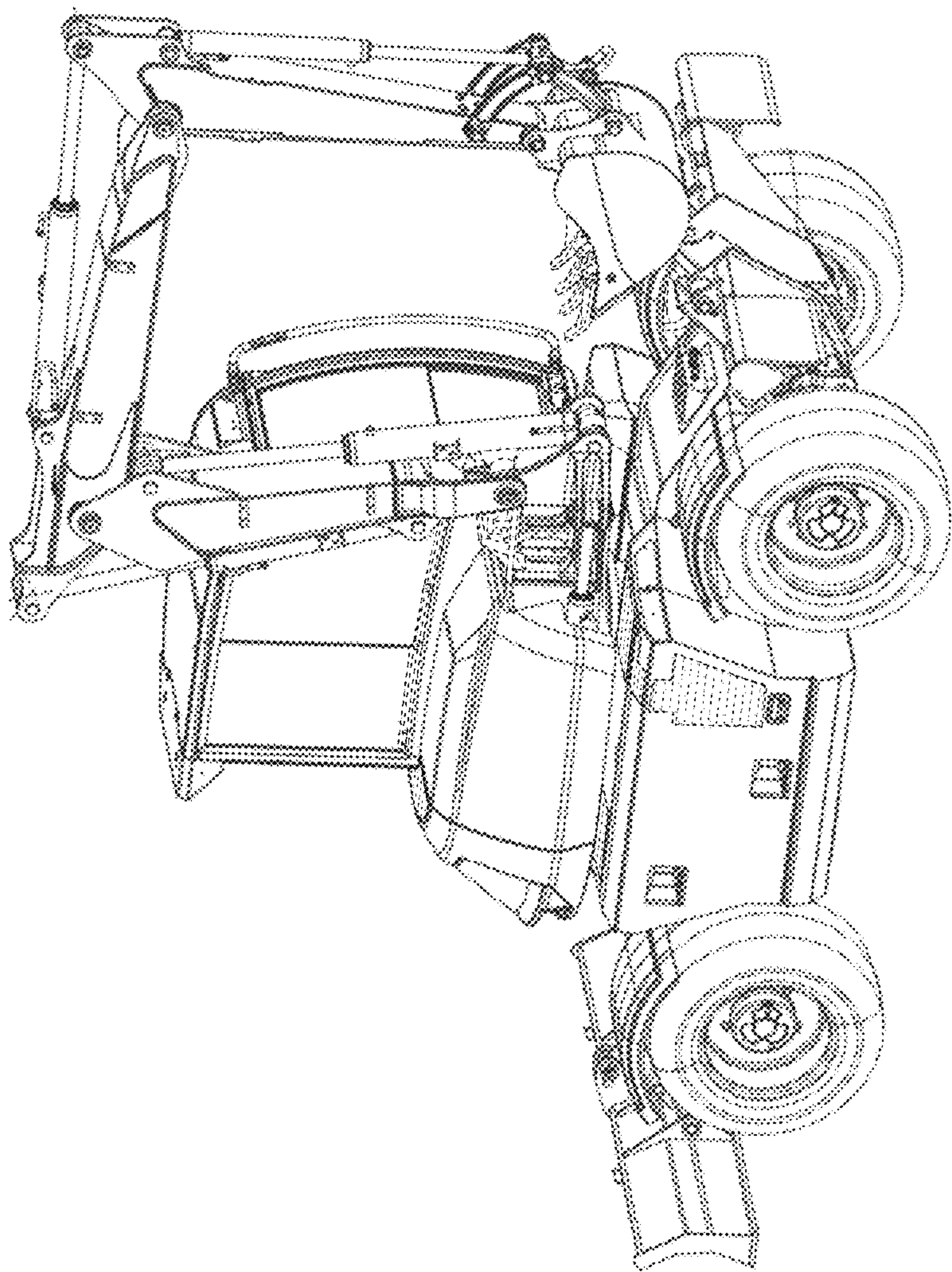

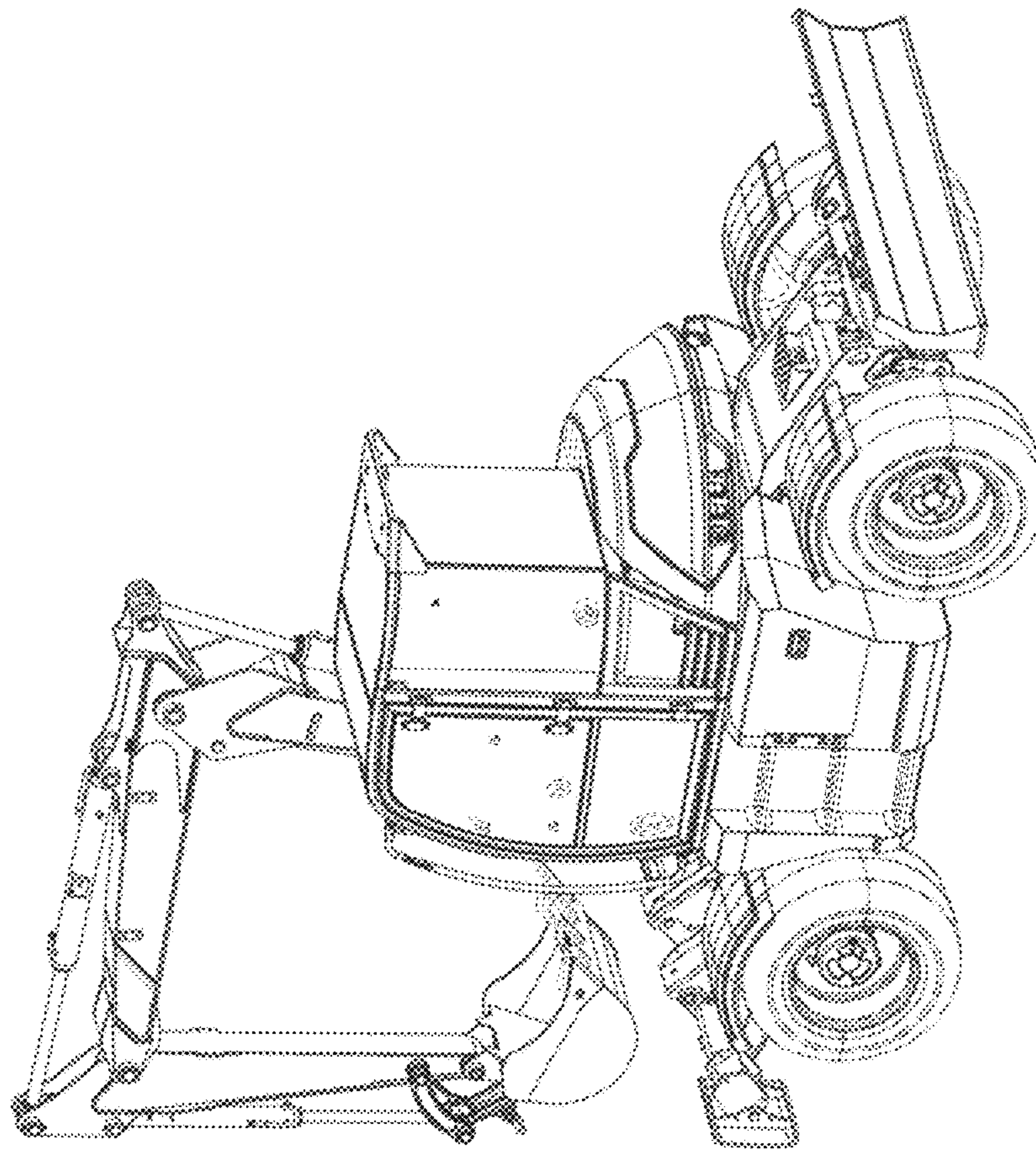

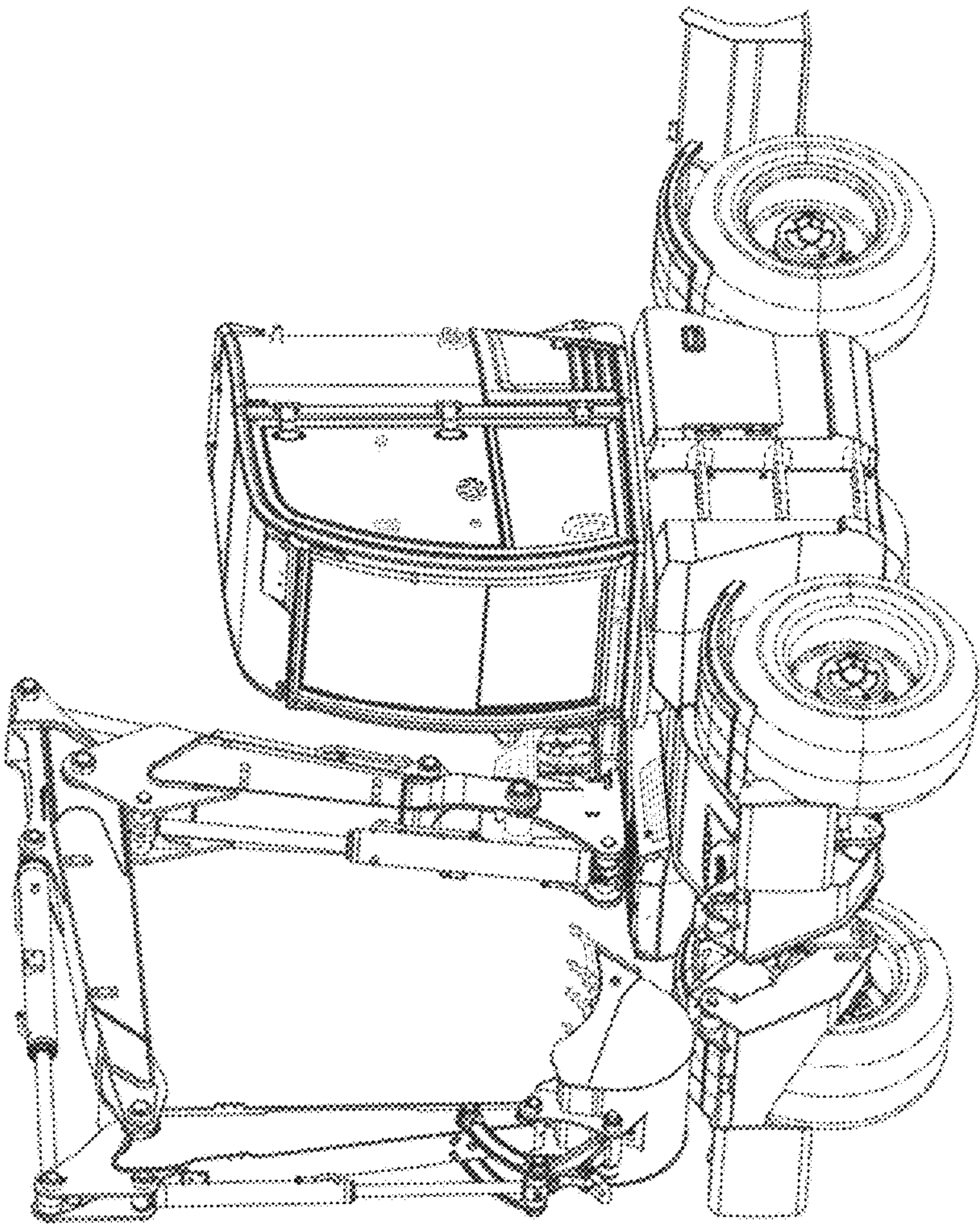
