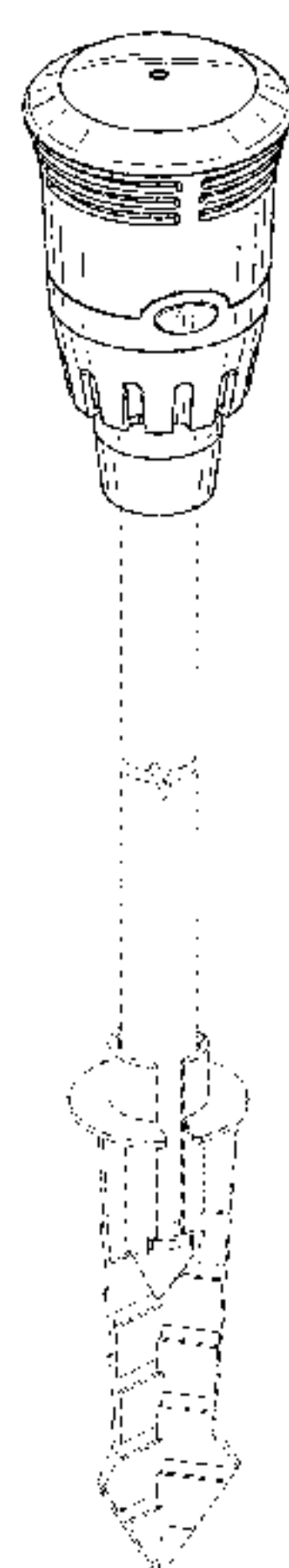

(57) **CLAIM**

We claim the design for an insect repellent fixture, as shown and described.

FIG. 1 is a first perspective view of a first embodiment of an insect repellent fixture;
FIG. 2 is a second perspective view of the insect repellent fixture of FIG. 1;
FIG. 3 is a front view of the insect repellent fixture of FIG. 1;
FIG. 4 is a left side view of the insect repellent fixture of FIG. 1;
FIG. 5 is a rear view of the insect repellent fixture of FIG. 1;
FIG. 6 is a right side view of the insect repellent fixture of FIG. 1;
FIG. 7 is a top view of the insect repellent fixture of FIG. 1;
FIG. 8 is a bottom view of the insect repellent fixture of FIG. 1;
FIG. 9 is a first perspective view of a second embodiment of an insect repellent fixture;
FIG. 10 is a second perspective view of the insect repellent fixture of FIG. 9;

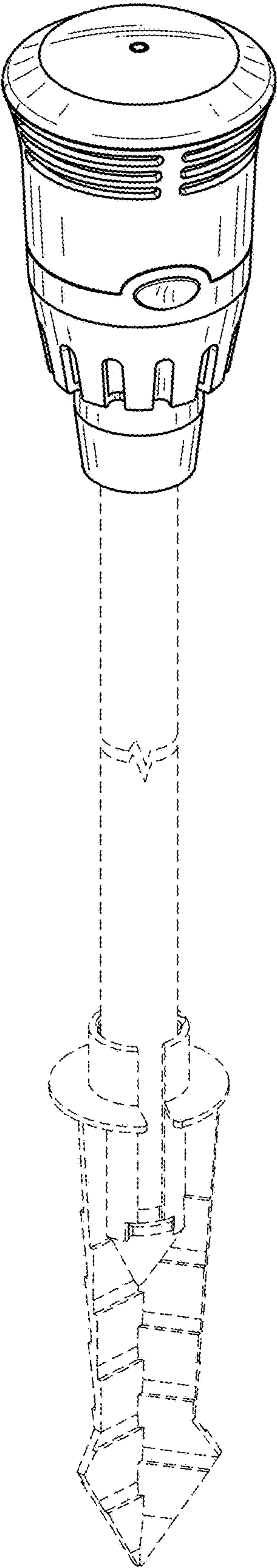

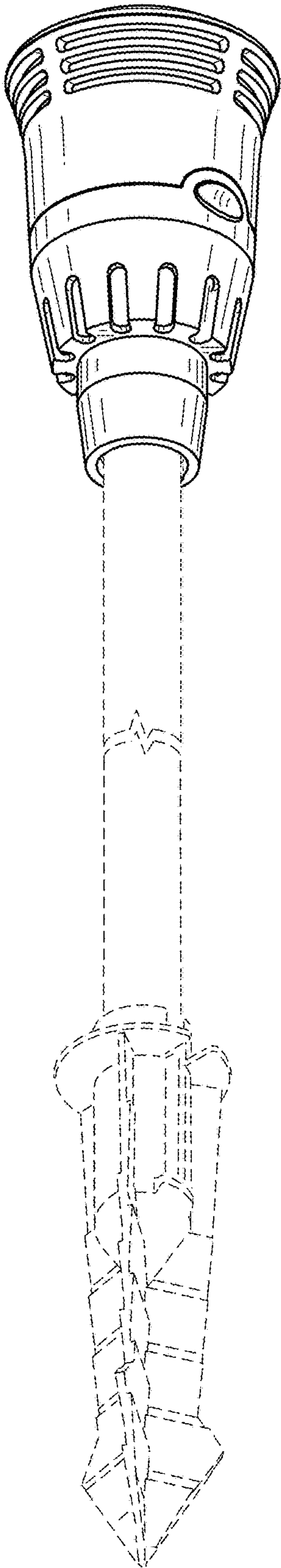

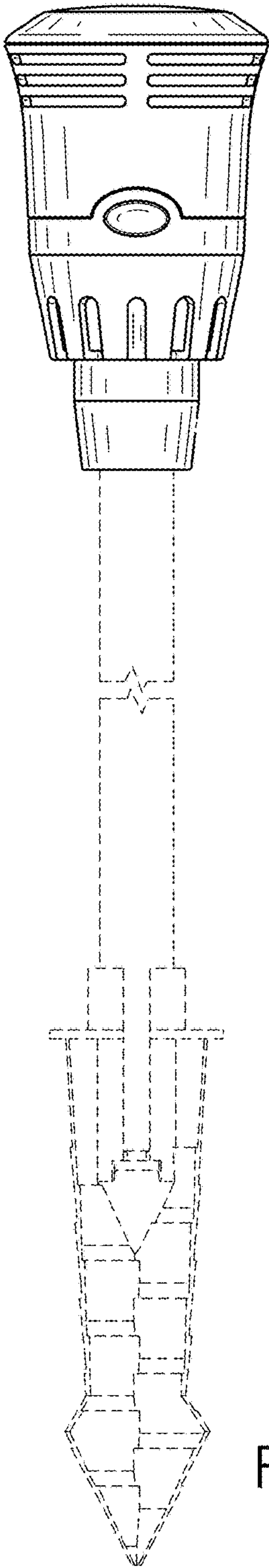

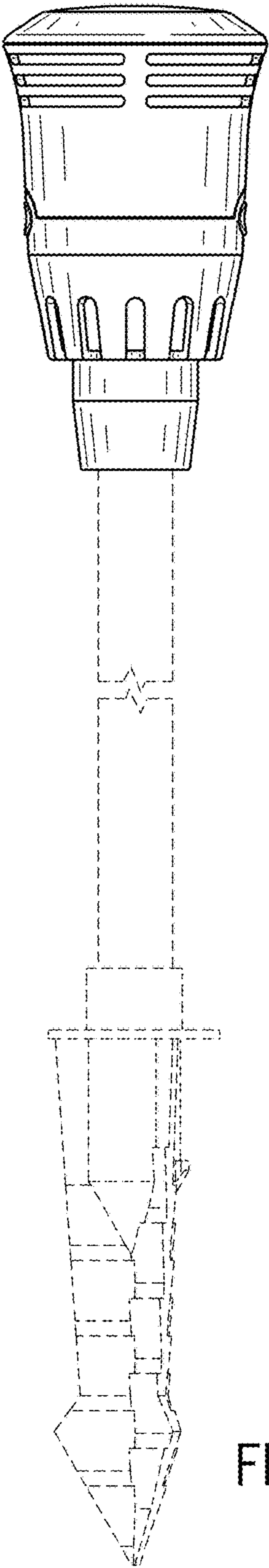

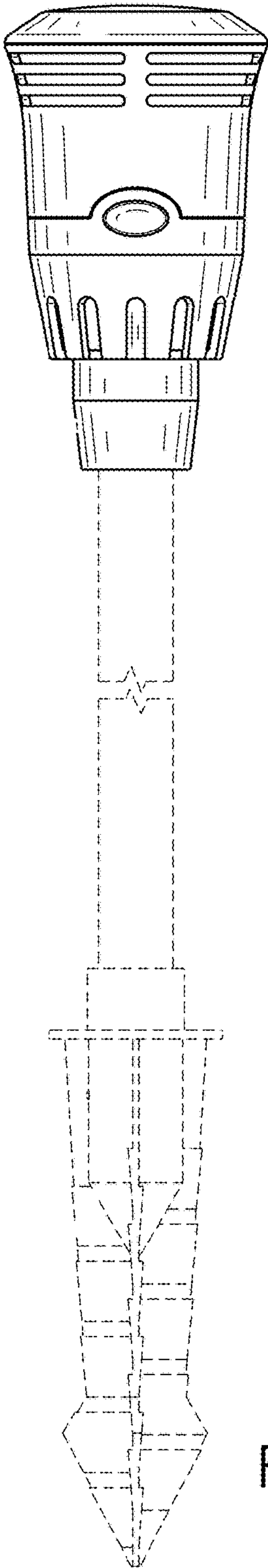

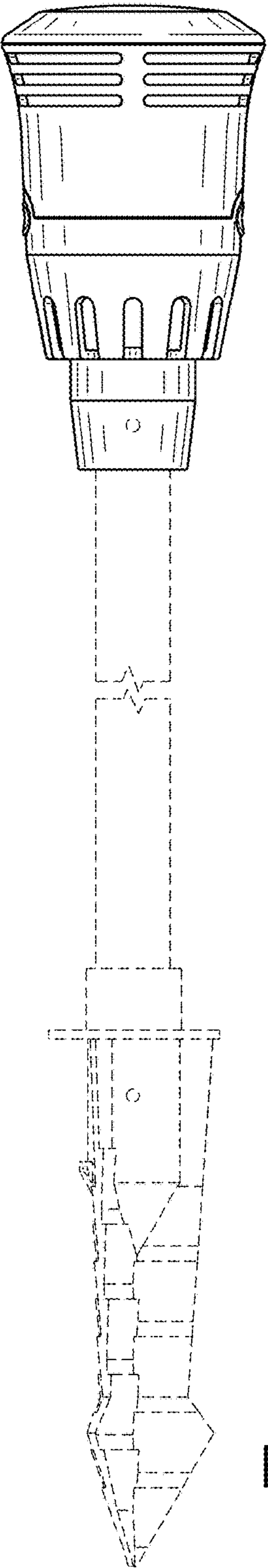

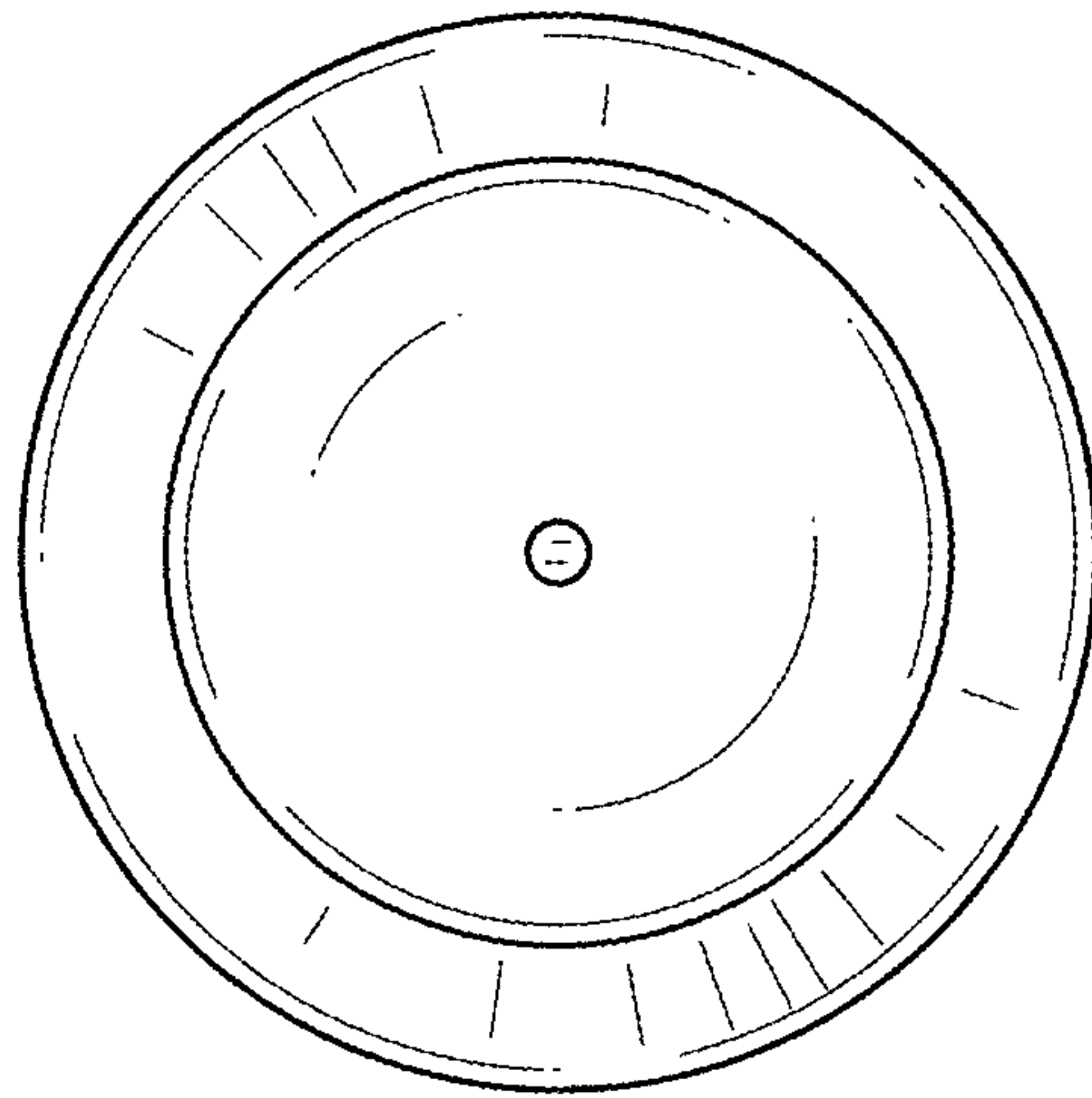

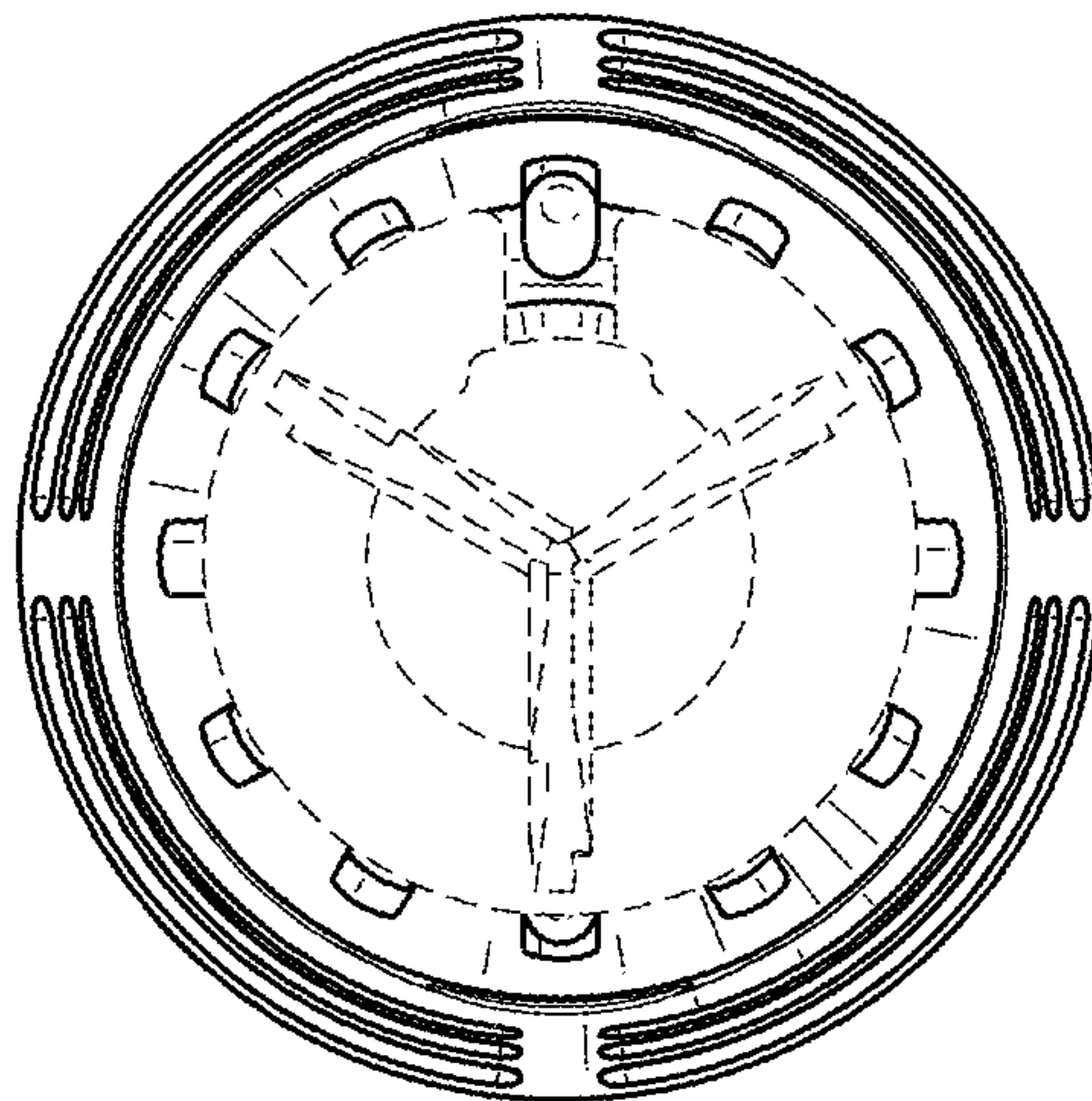

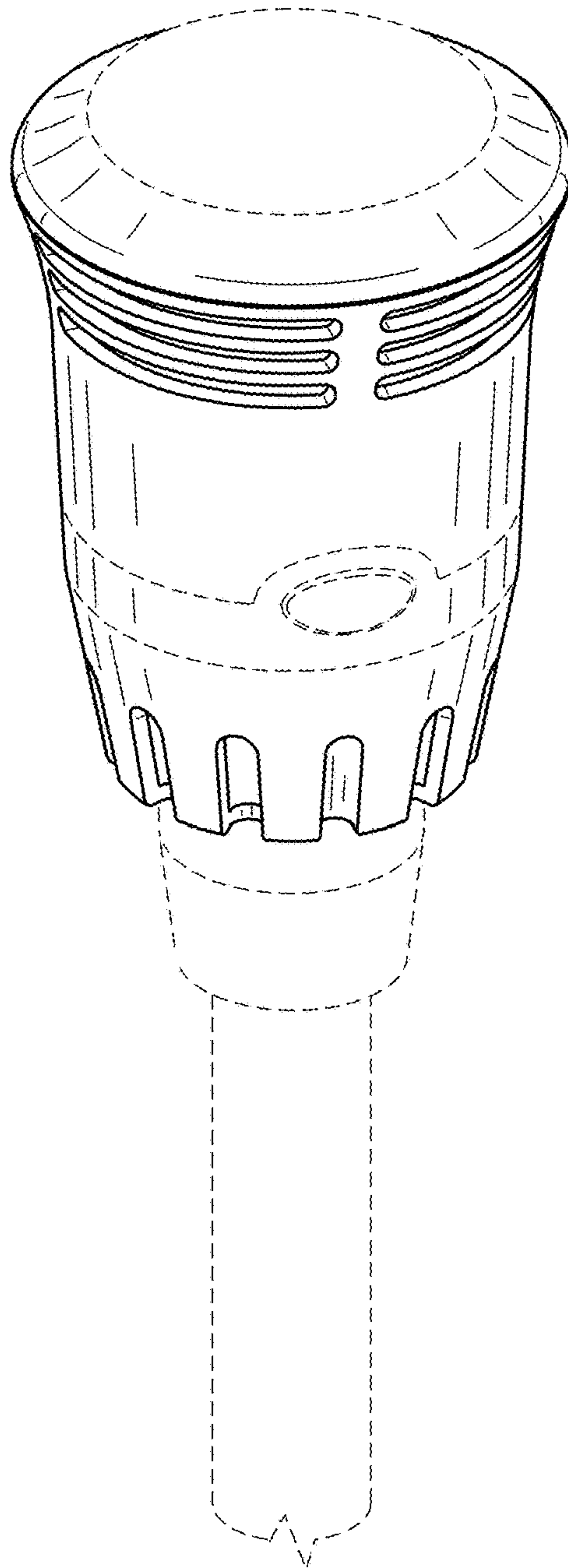

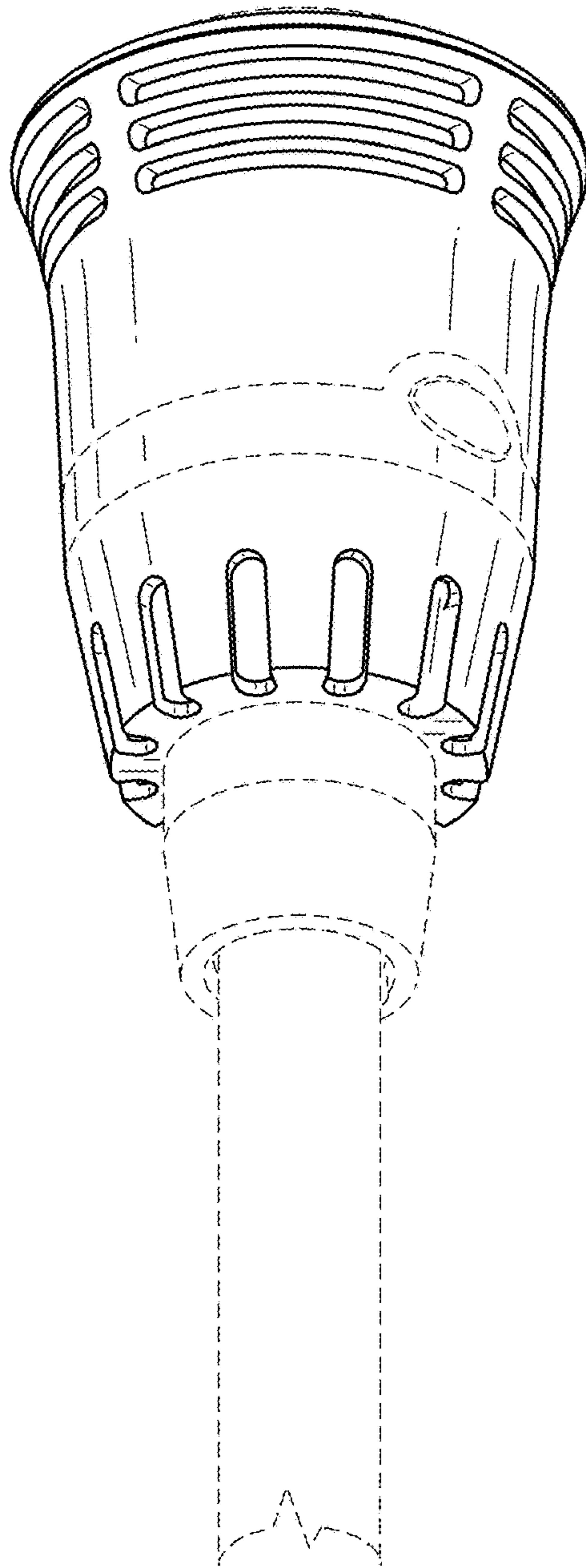

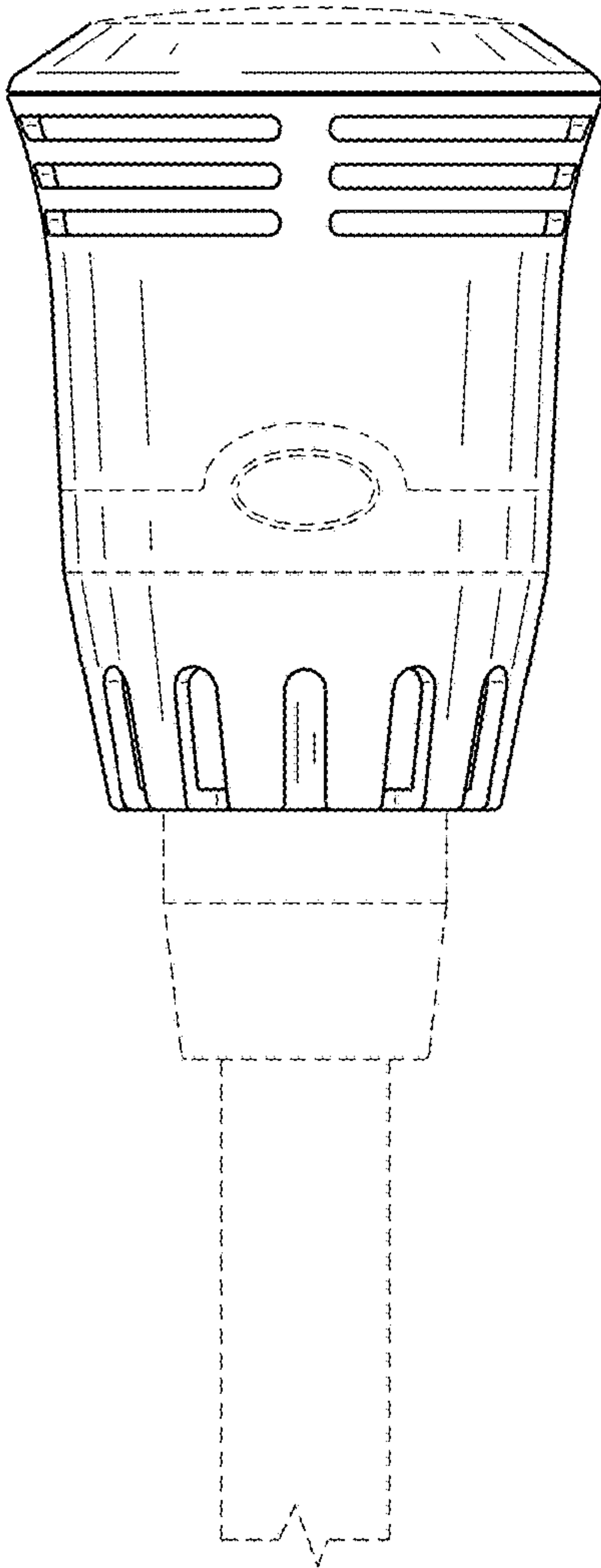

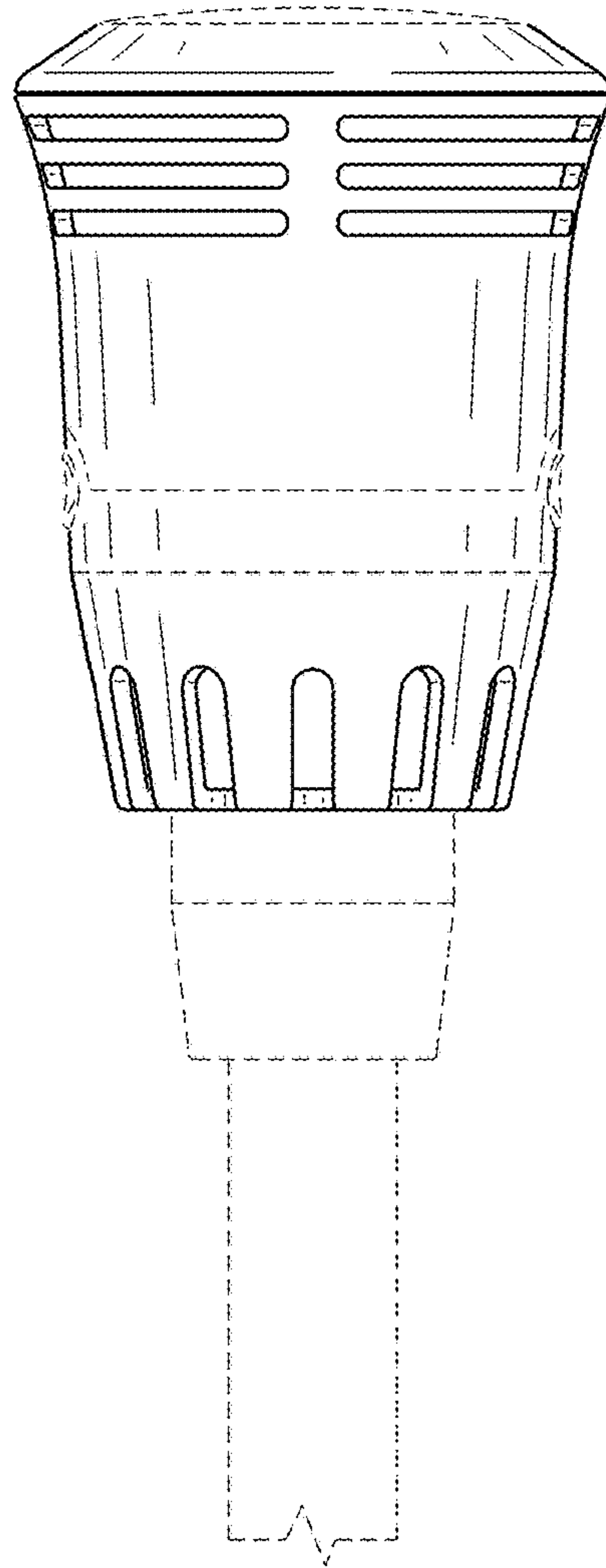

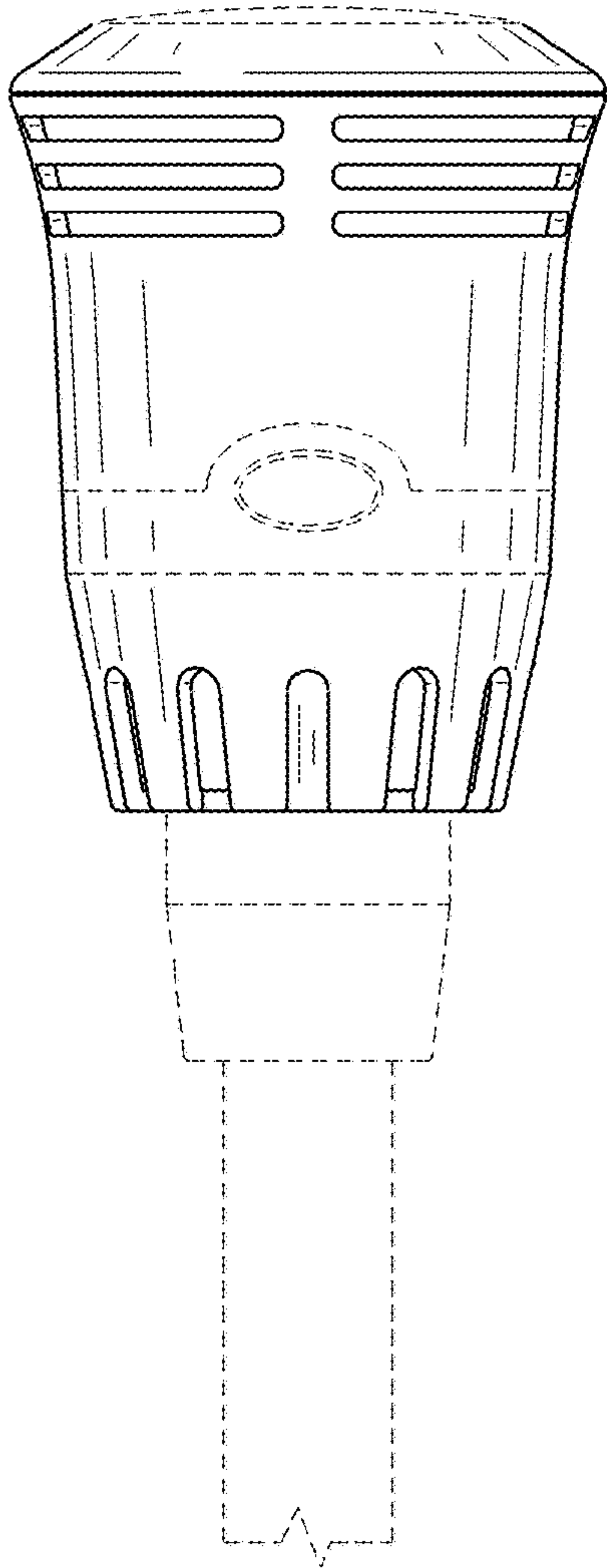

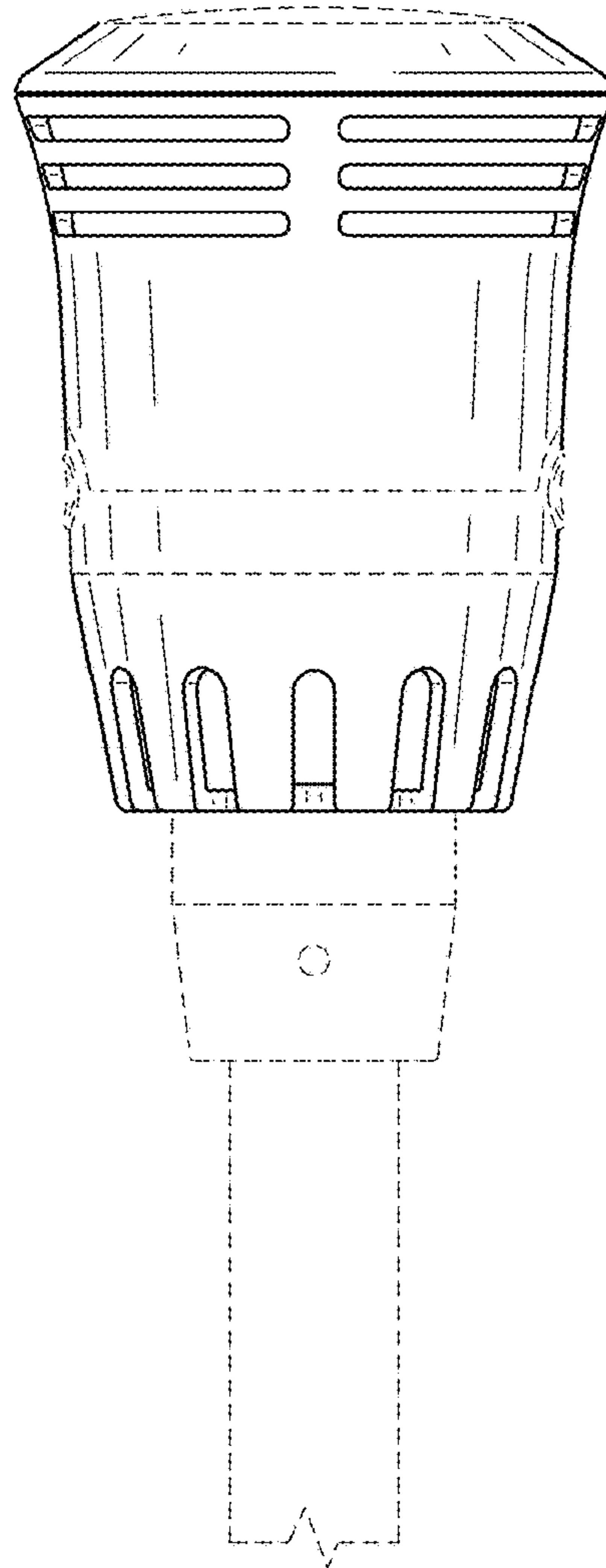

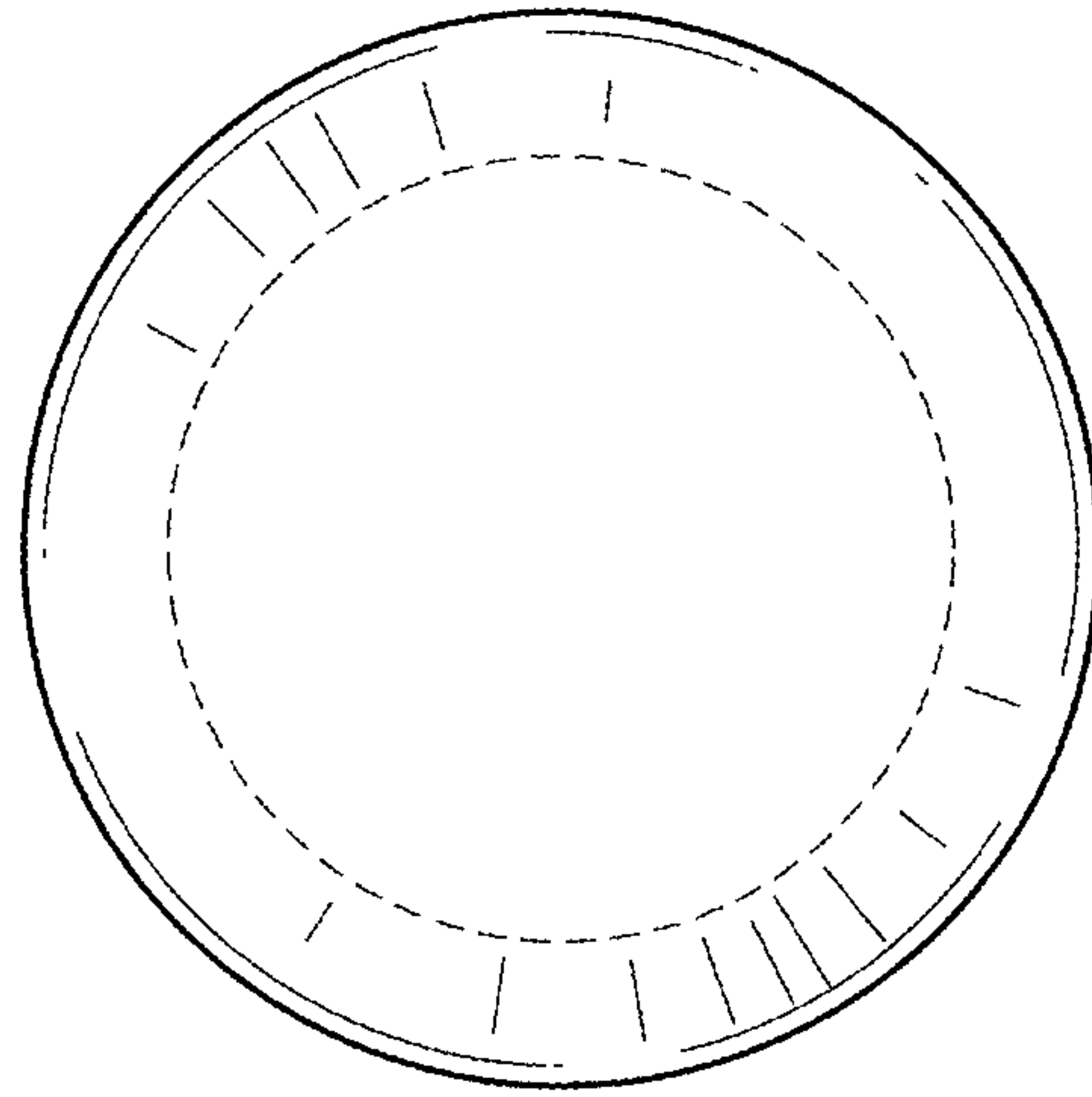

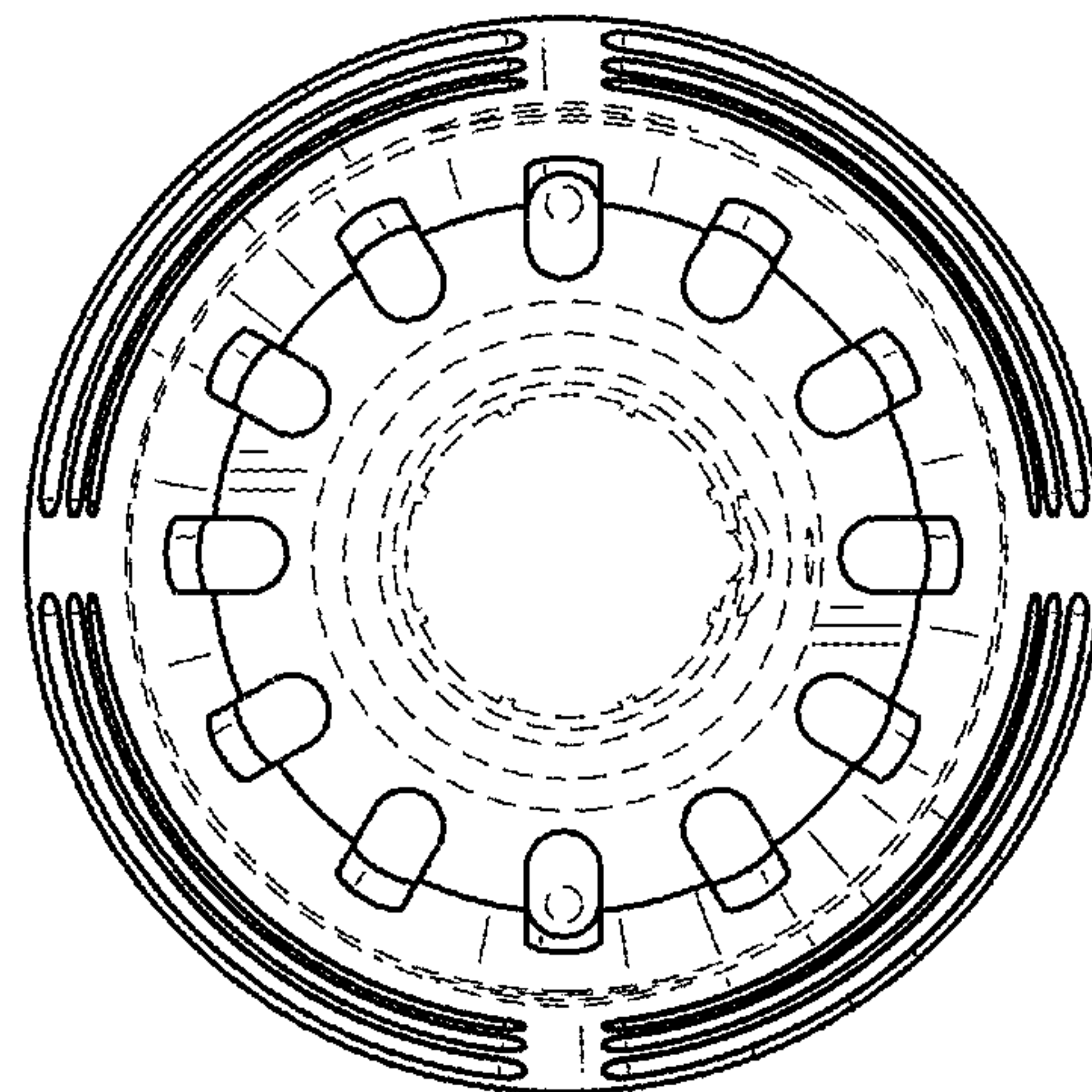
