DESCRIPTION

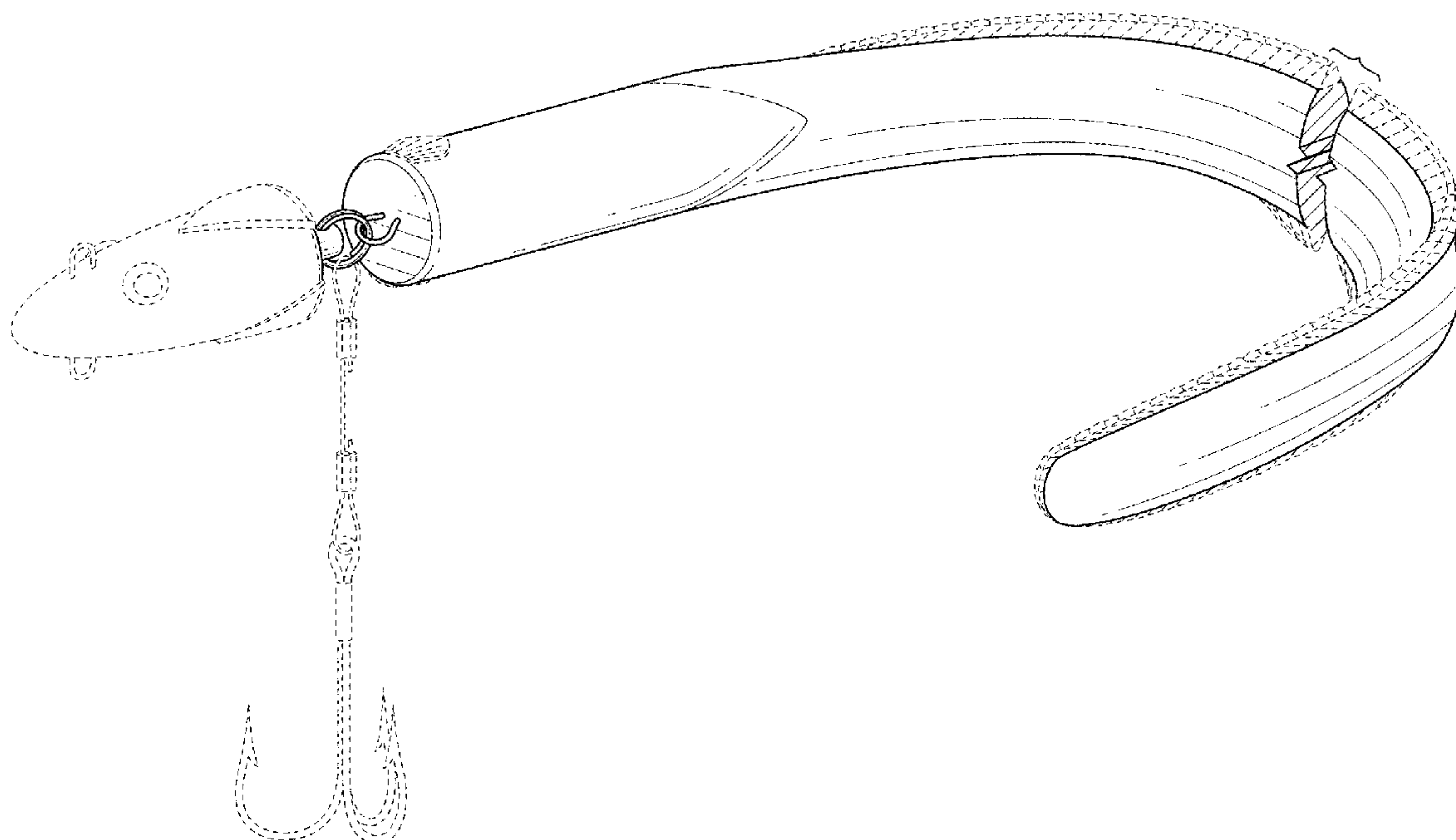
FIG. 1 is perspective view thereof of a fishing lure showing a new design;

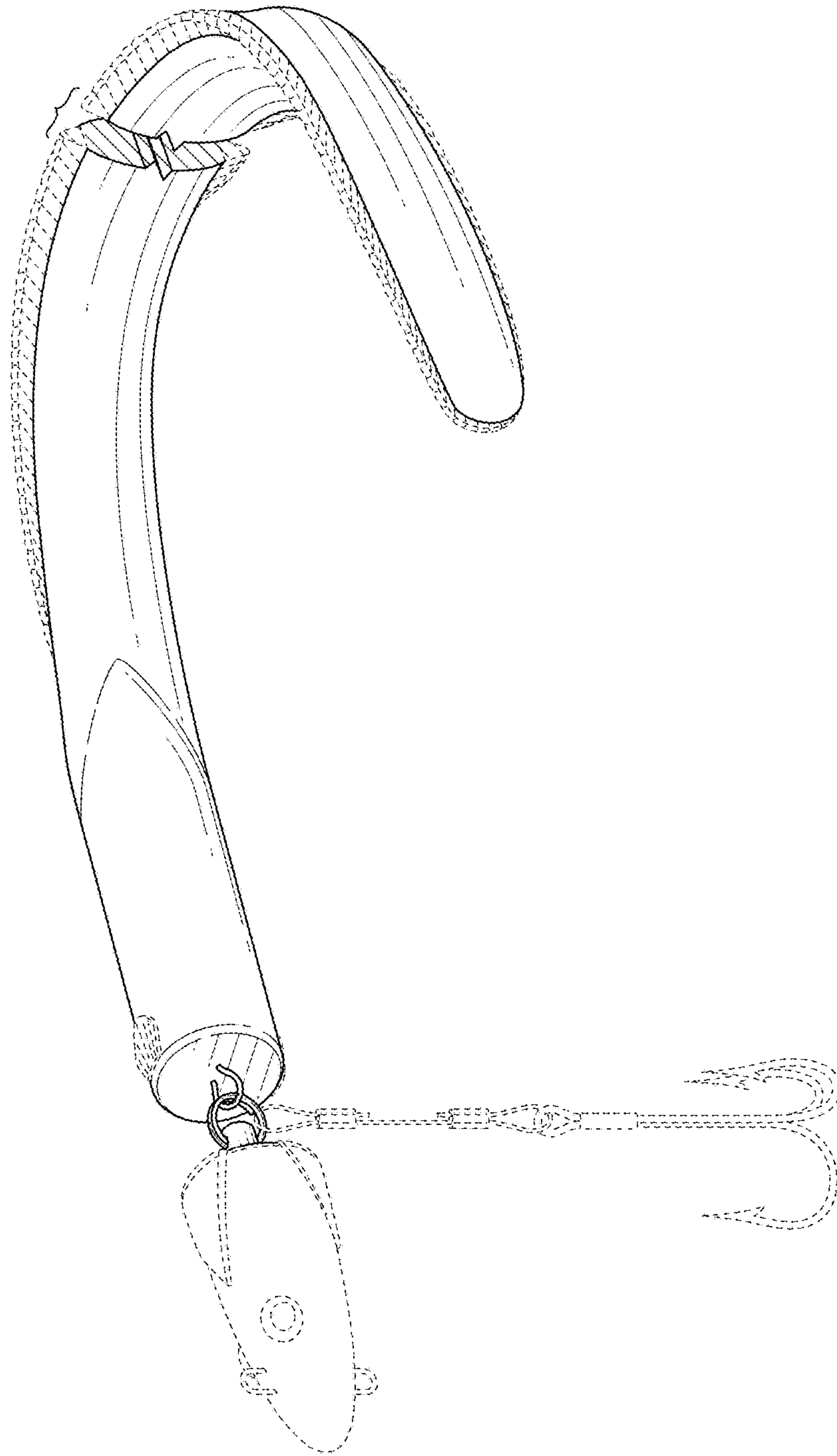

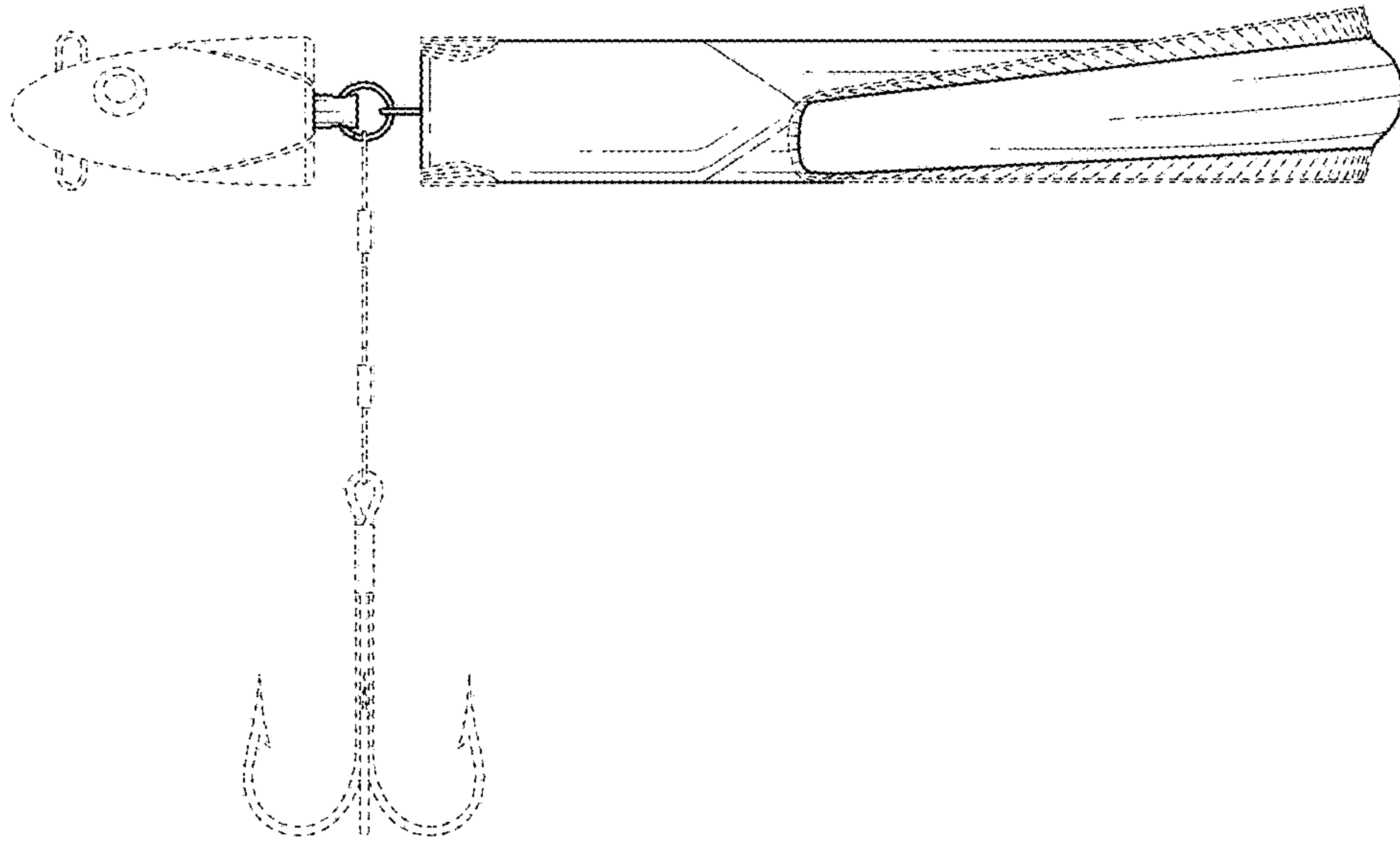

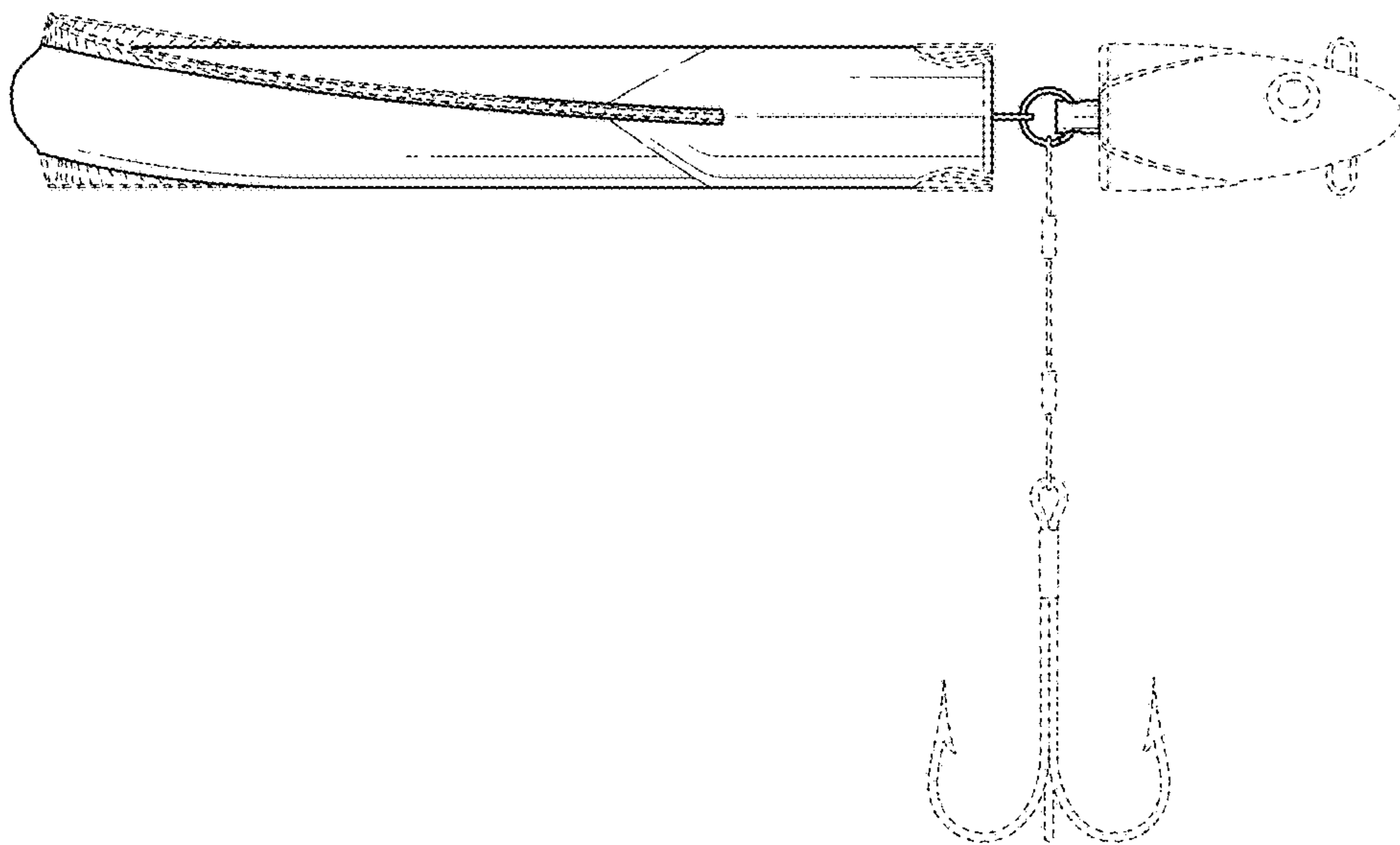

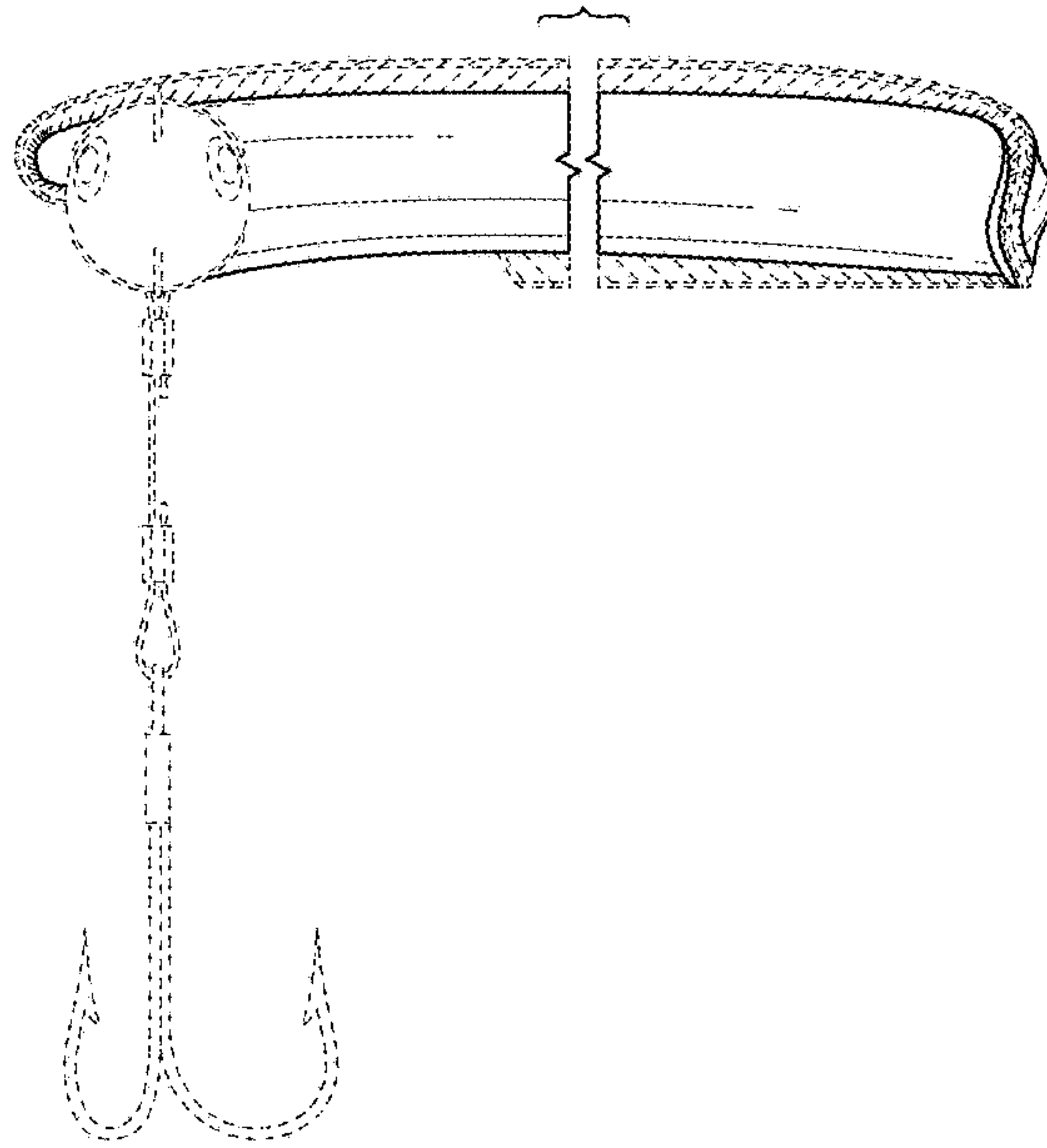

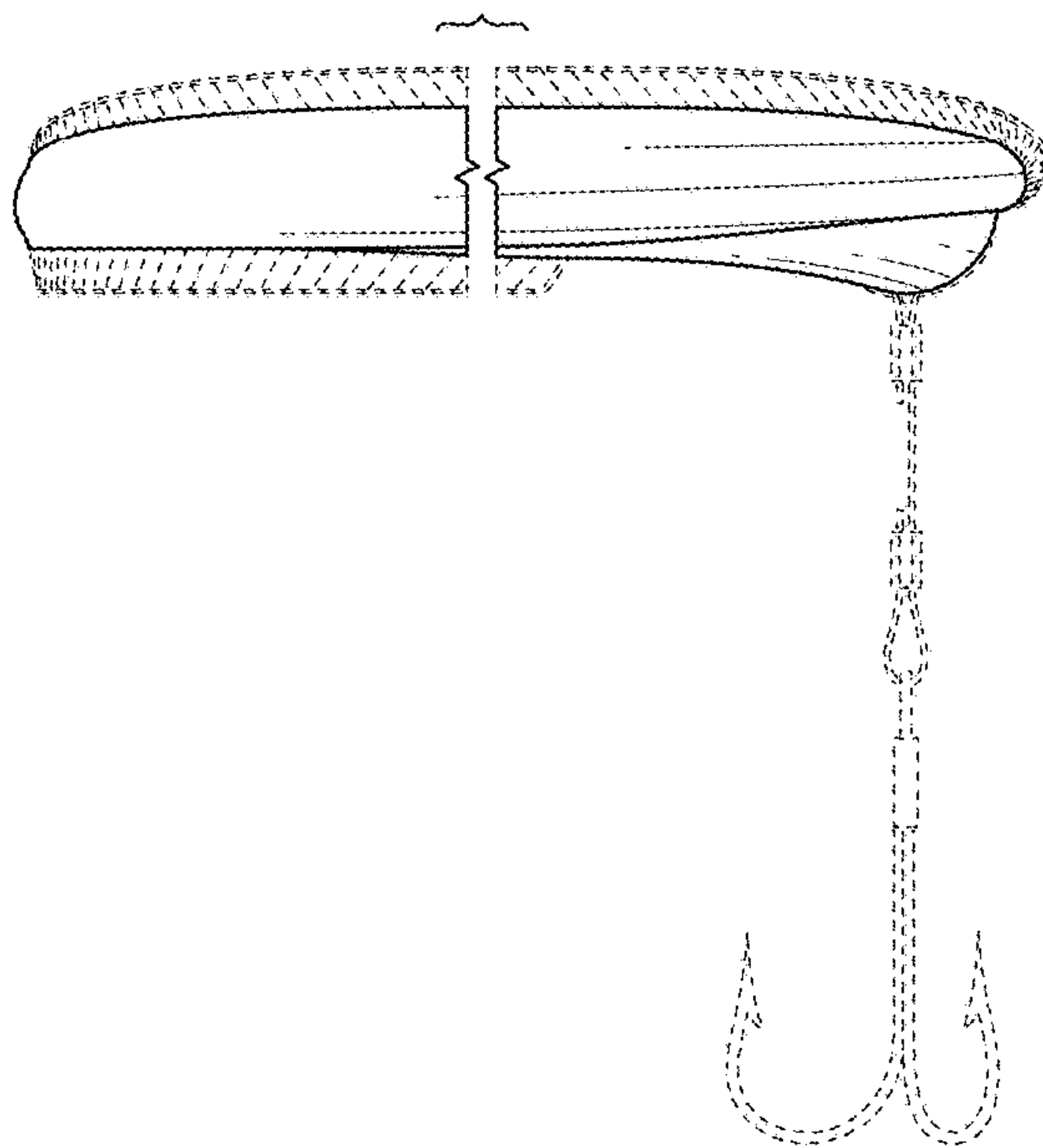

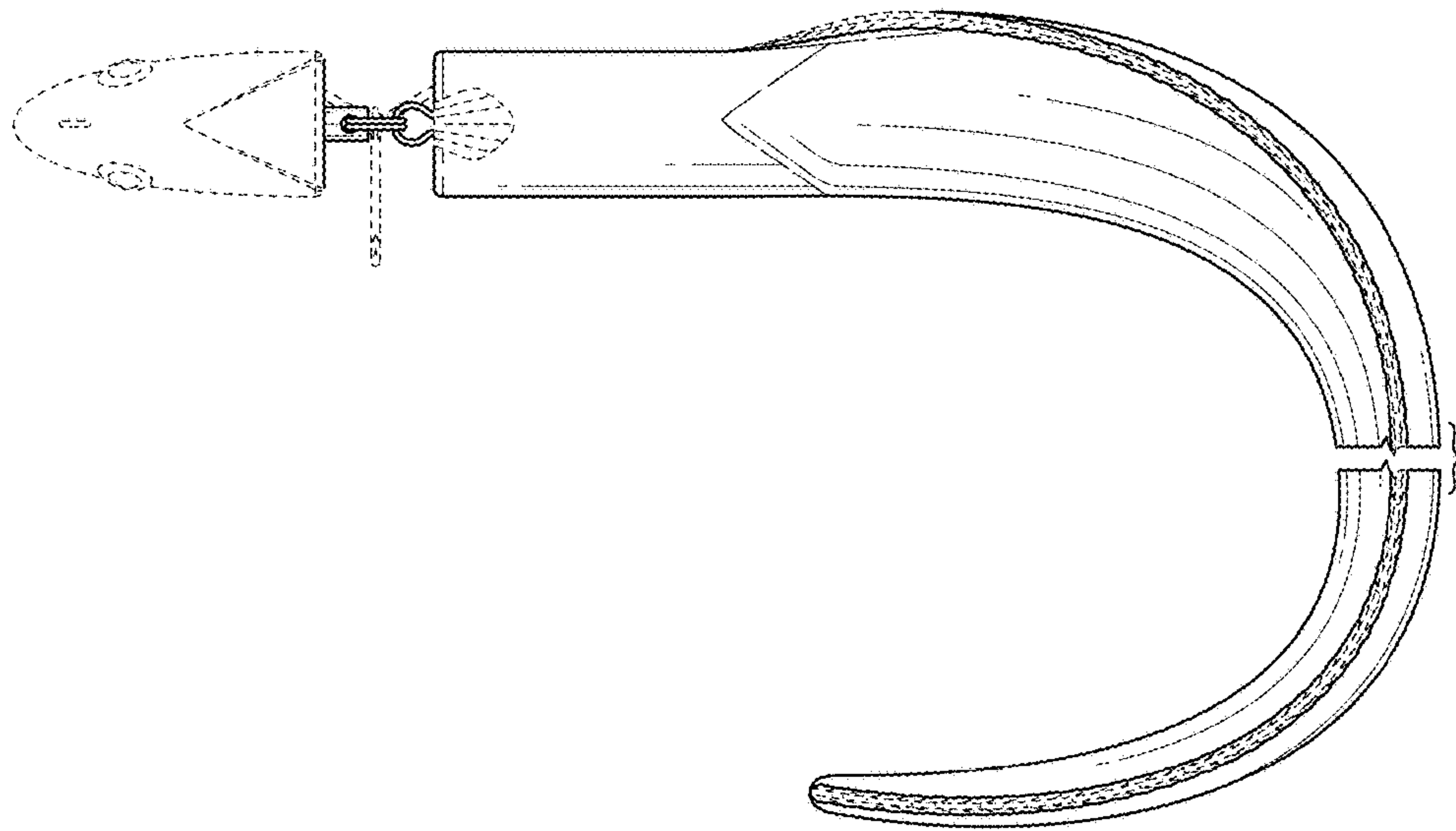

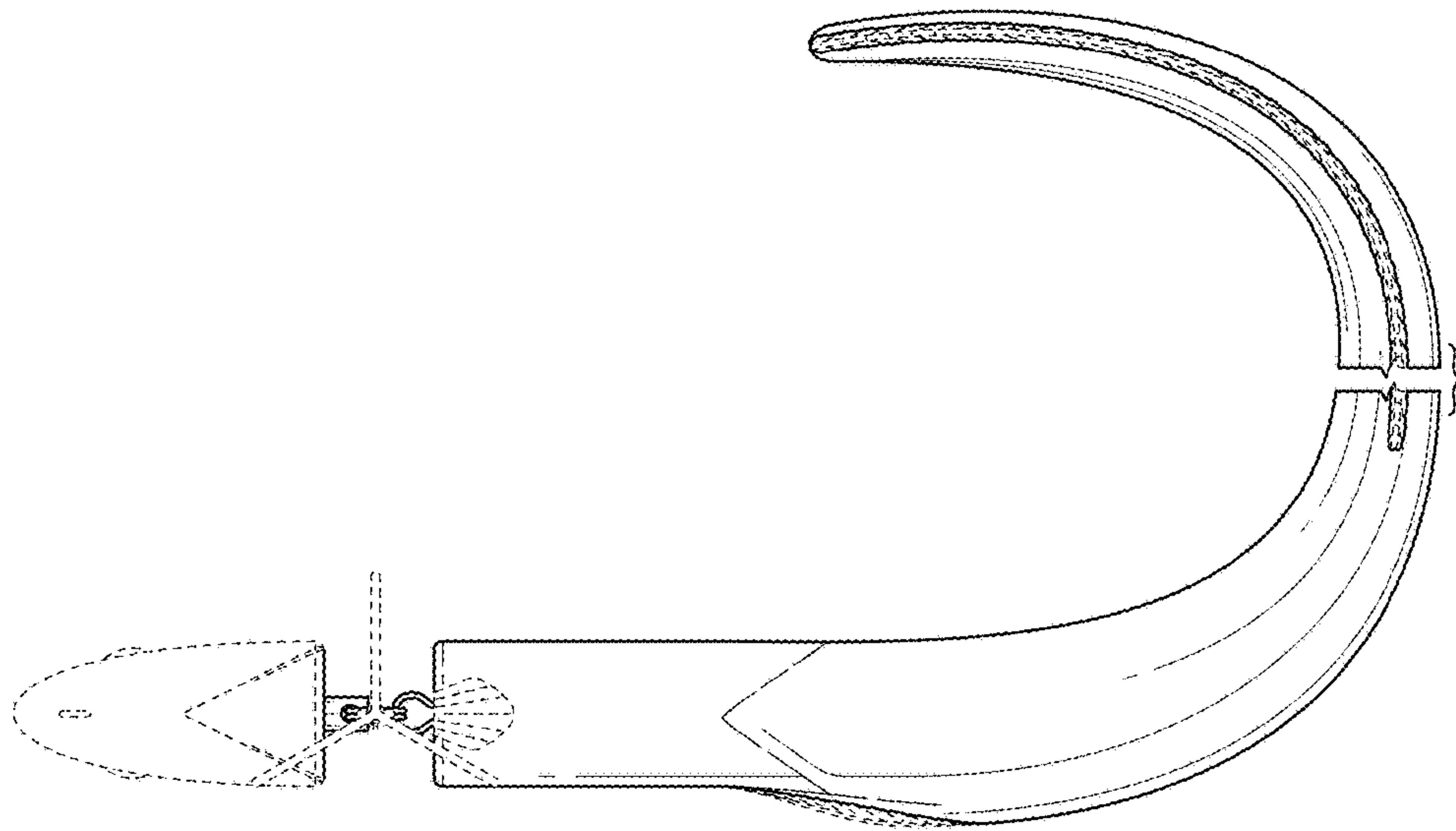

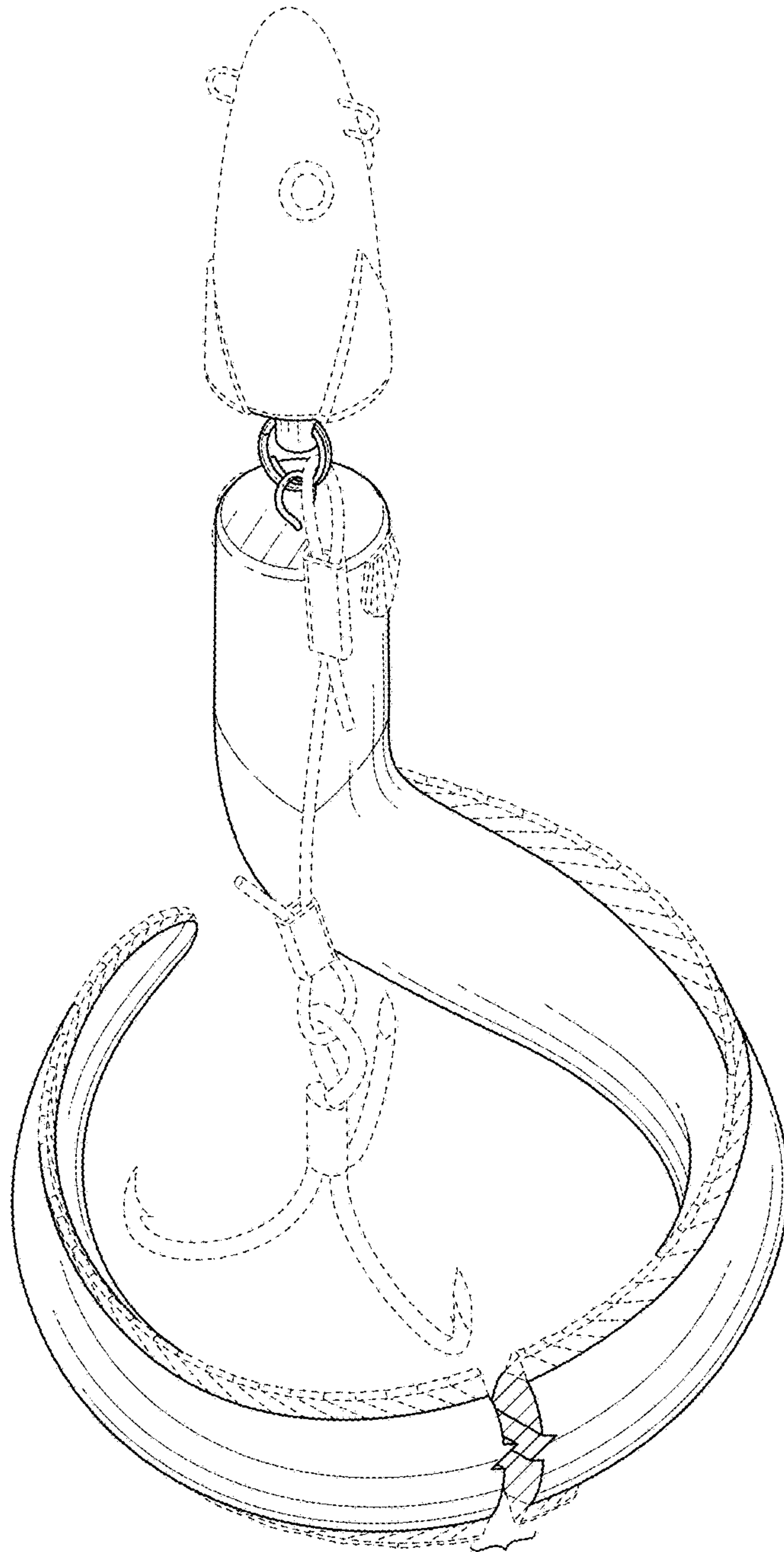
