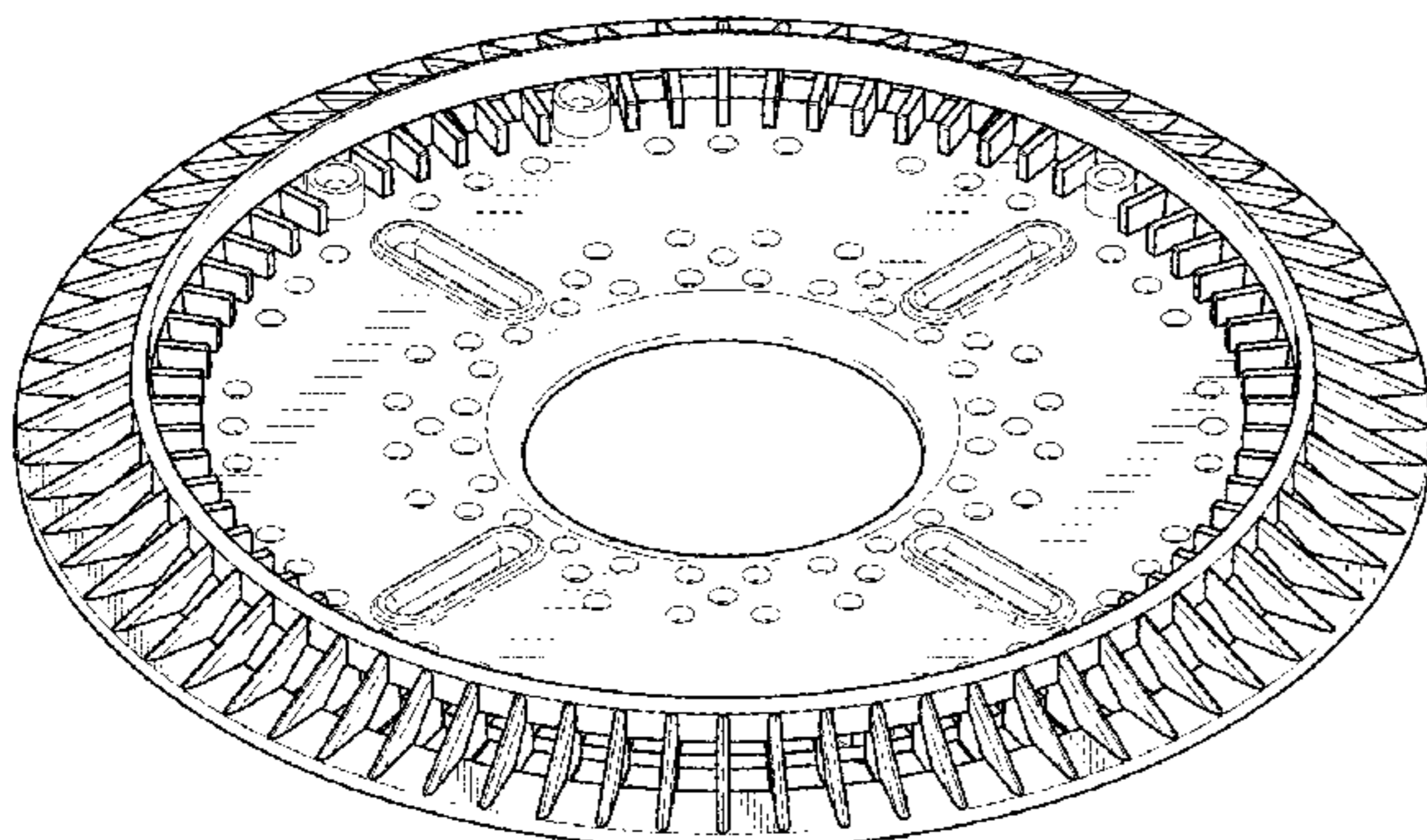
(57) **CLAIM**

The ornamental design for a riser ring for drain covers, as shown and described.

DESCRIPTION

FIG. 1 is a top-side isometric view of a riser ring for drain covers;

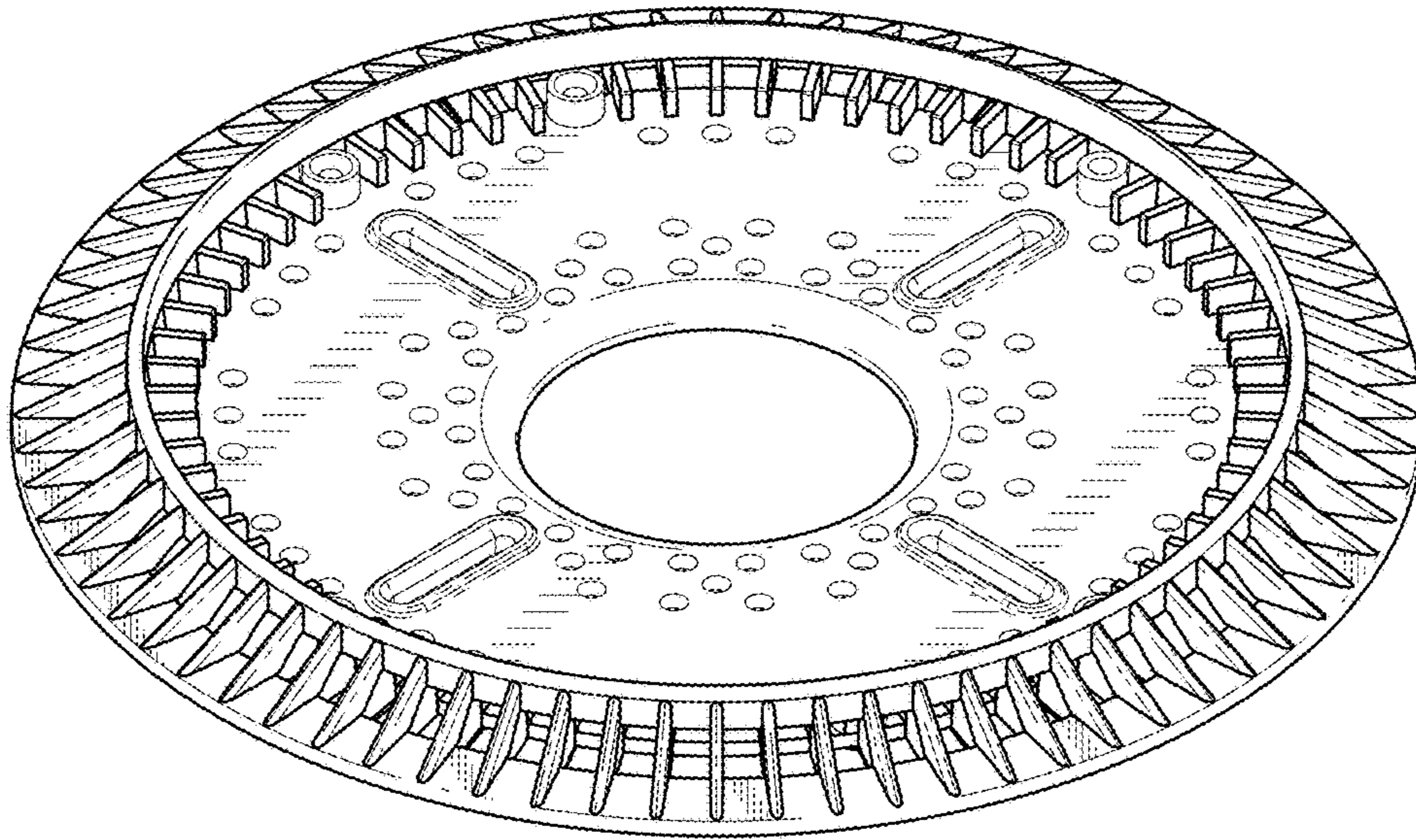

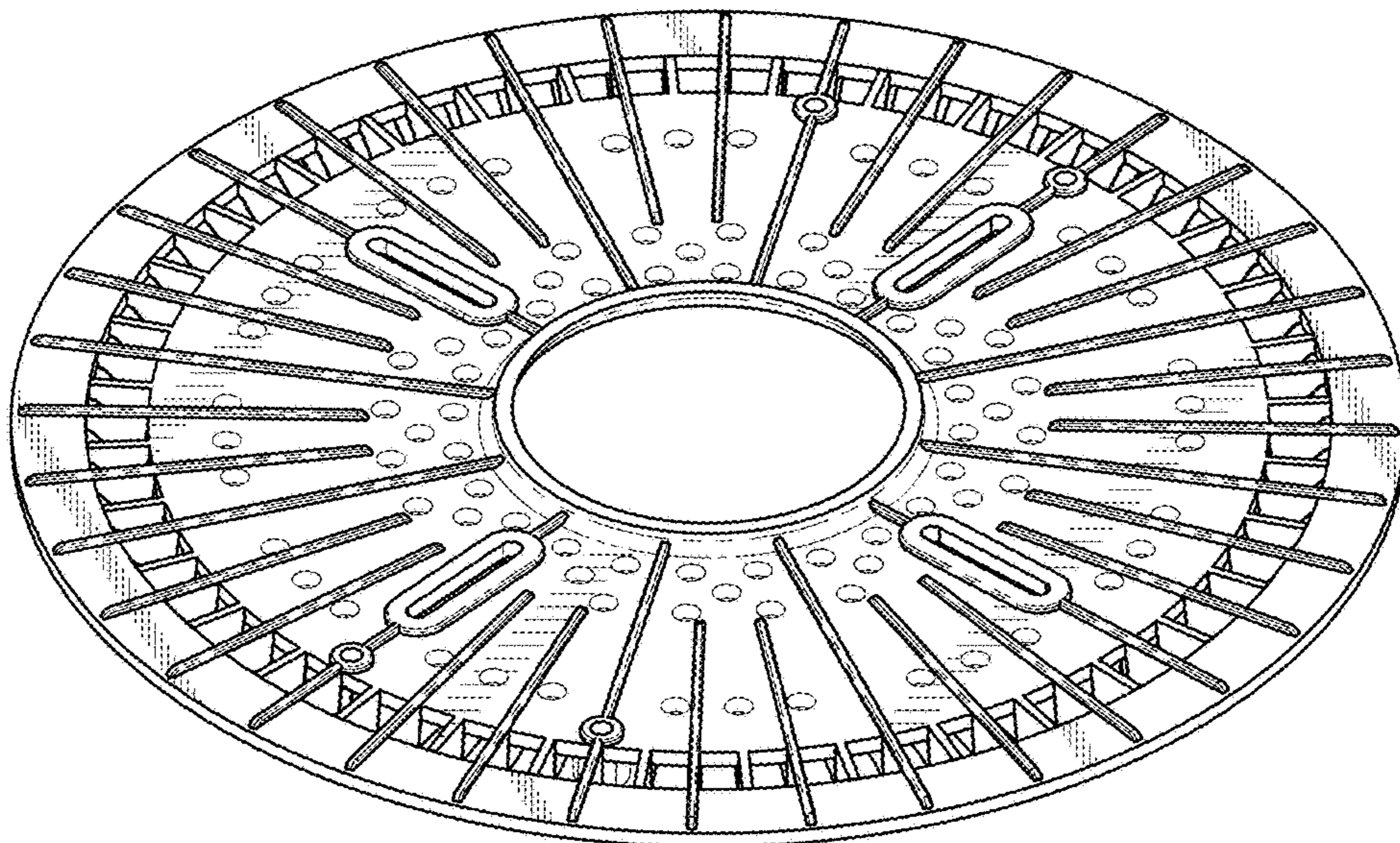

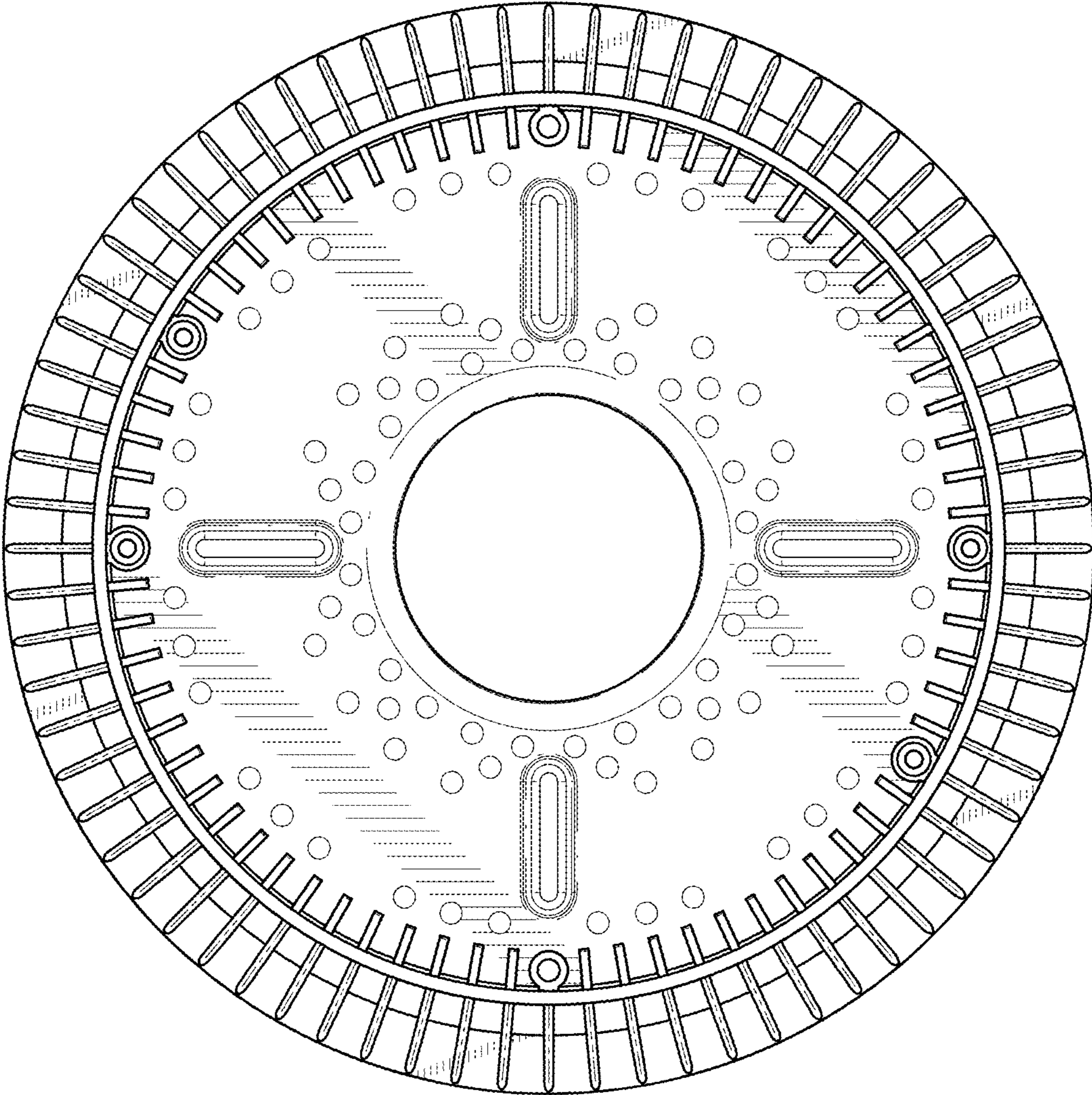

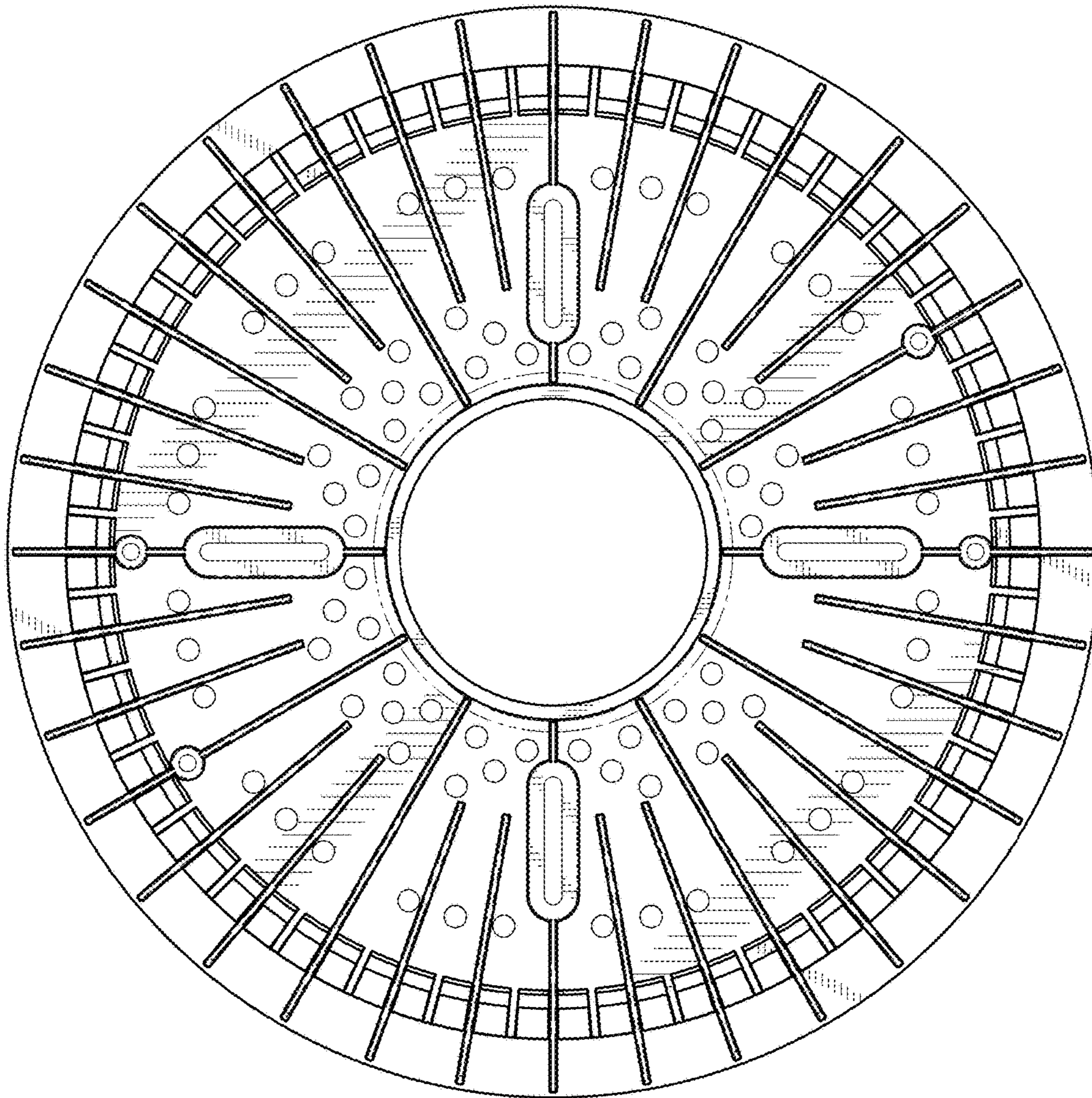
