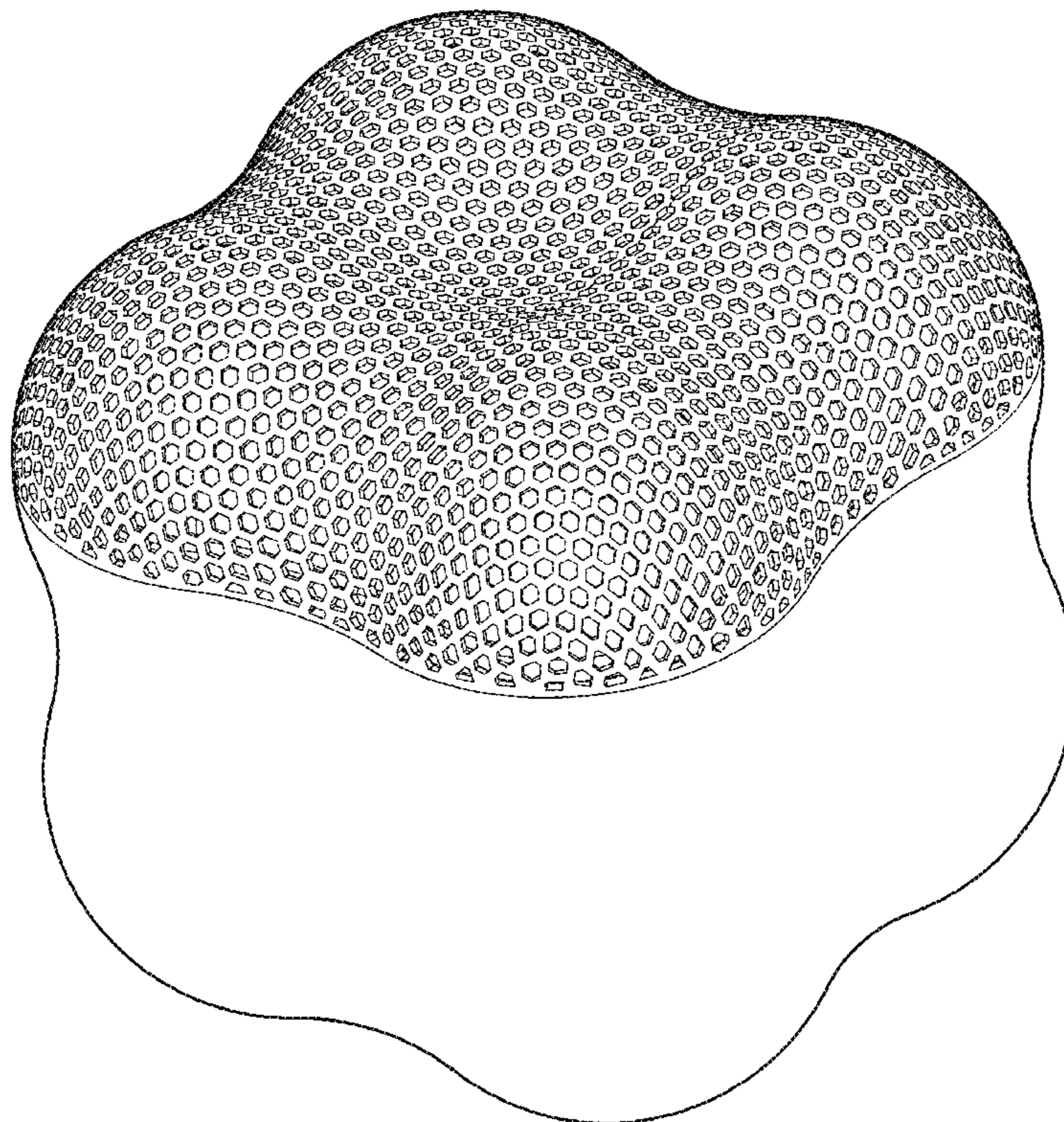
FIG. 1 is a perspective view of aroma diffuser showing my new design;

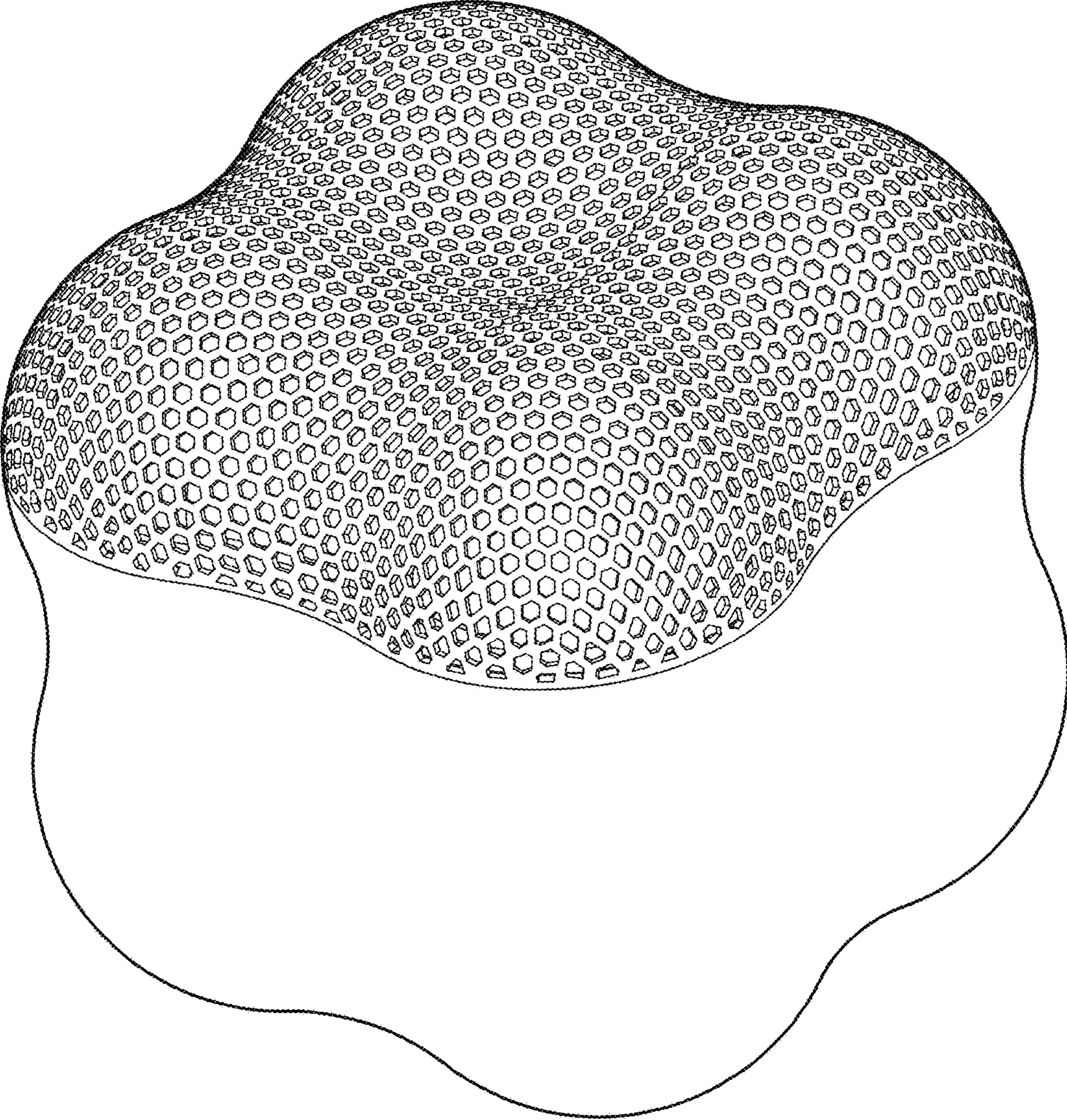

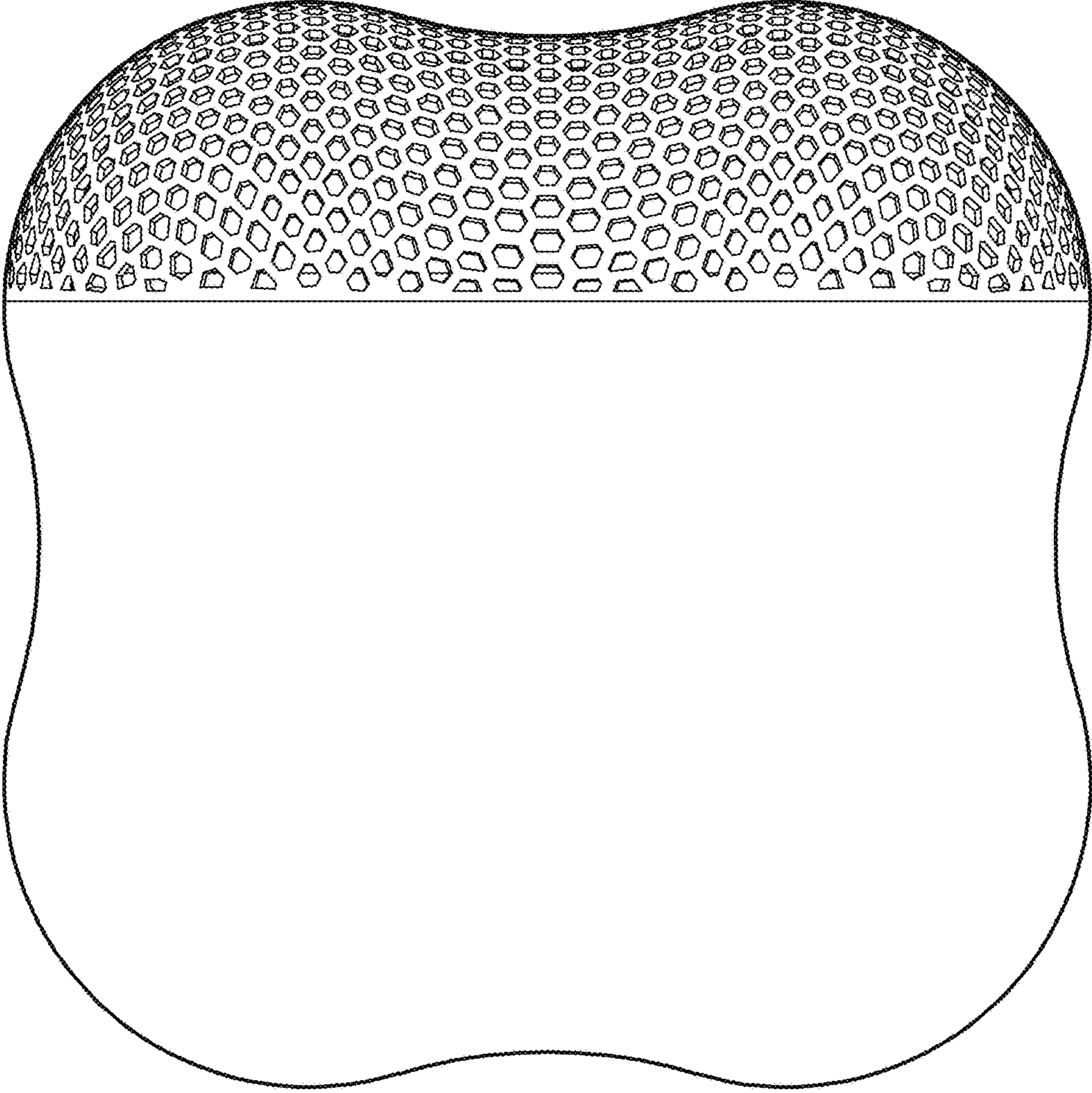

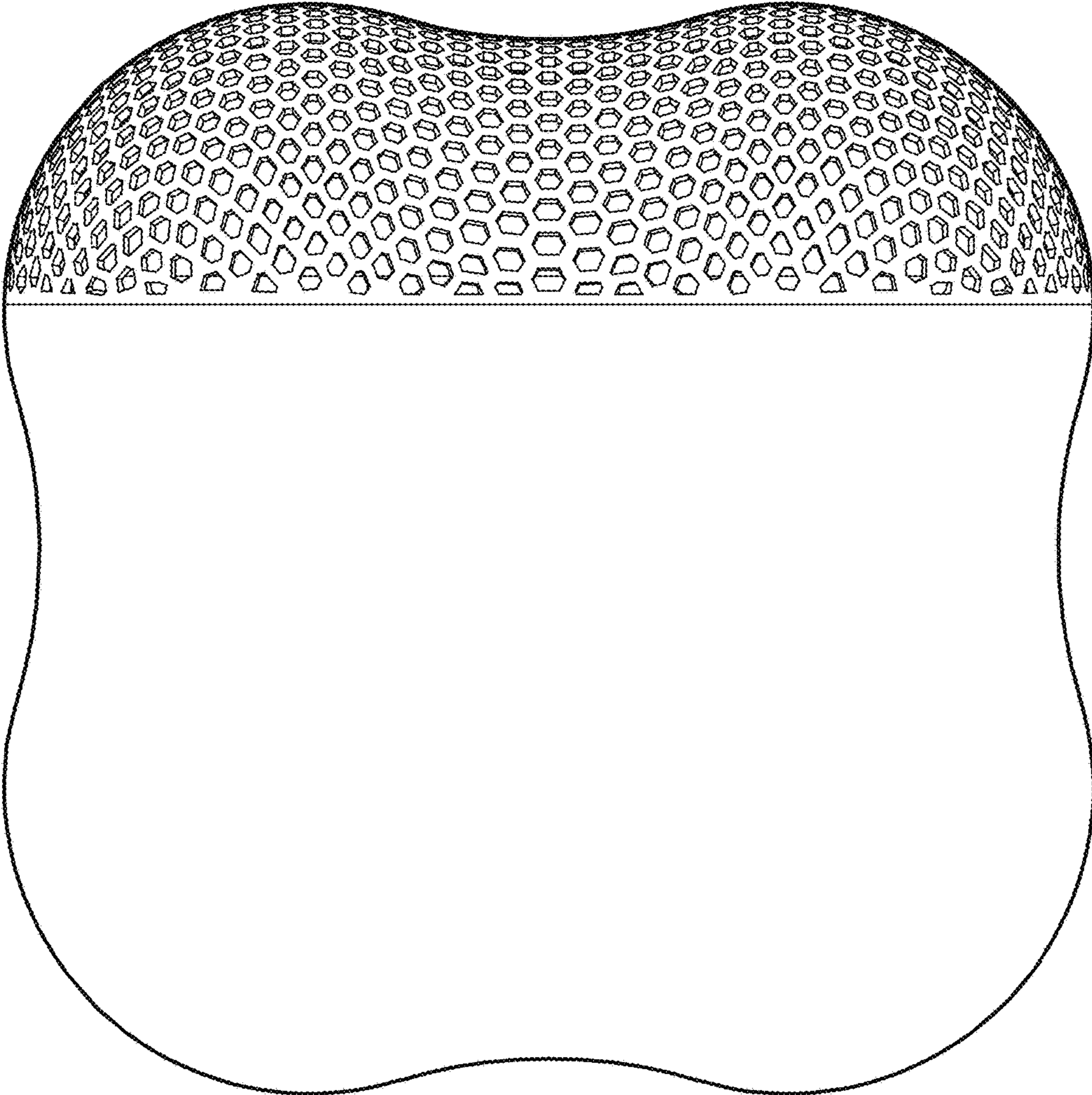

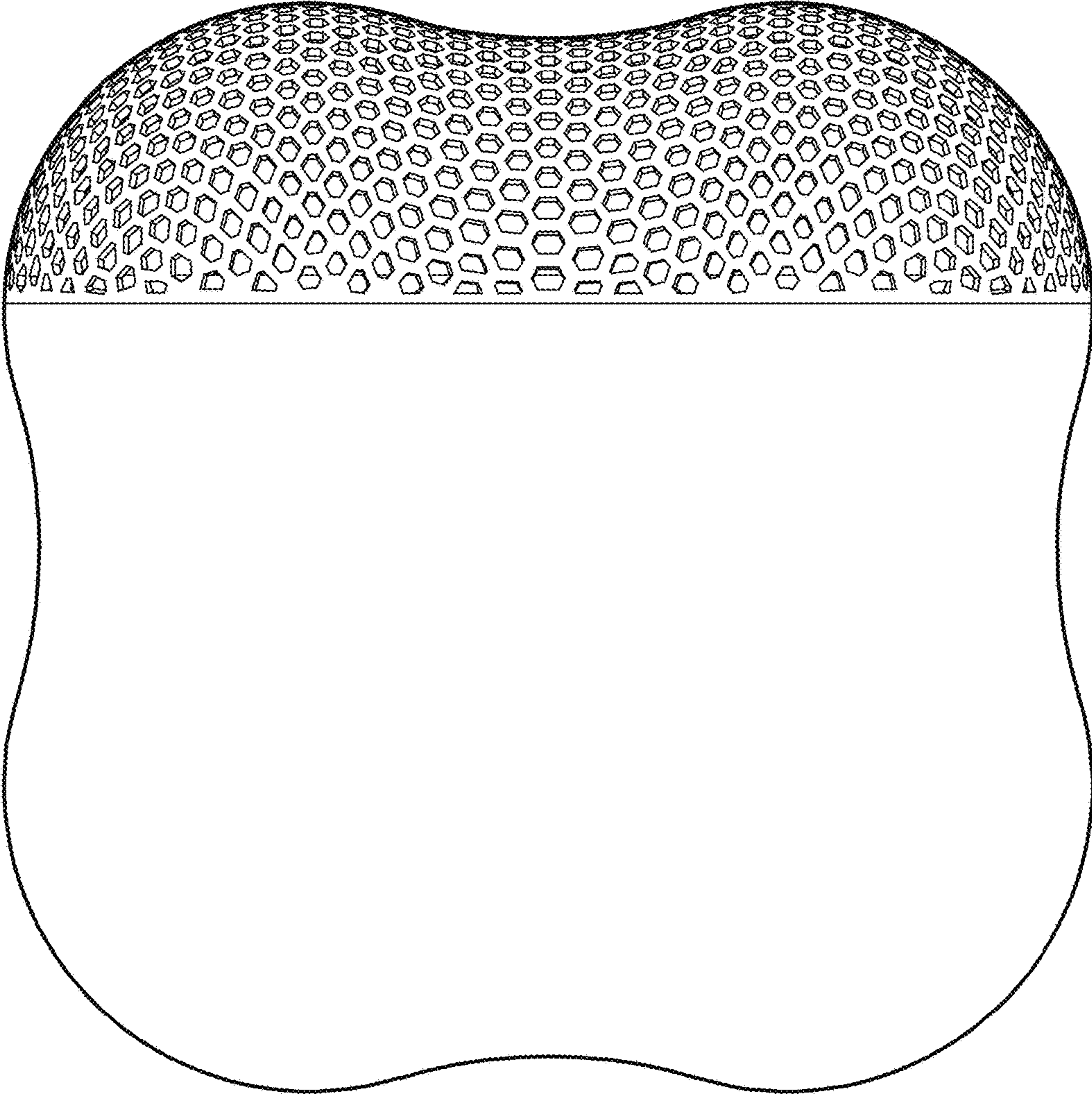

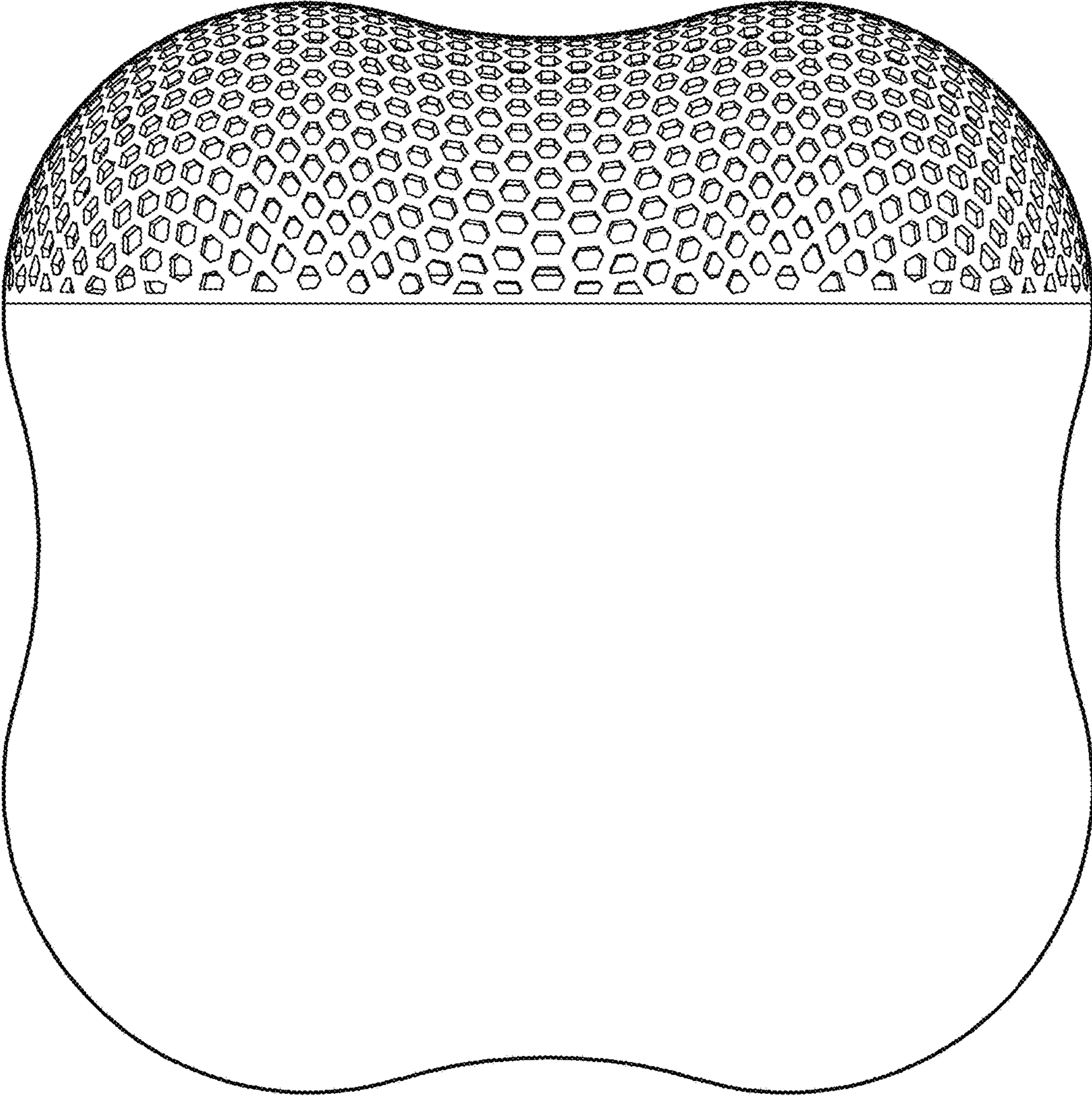

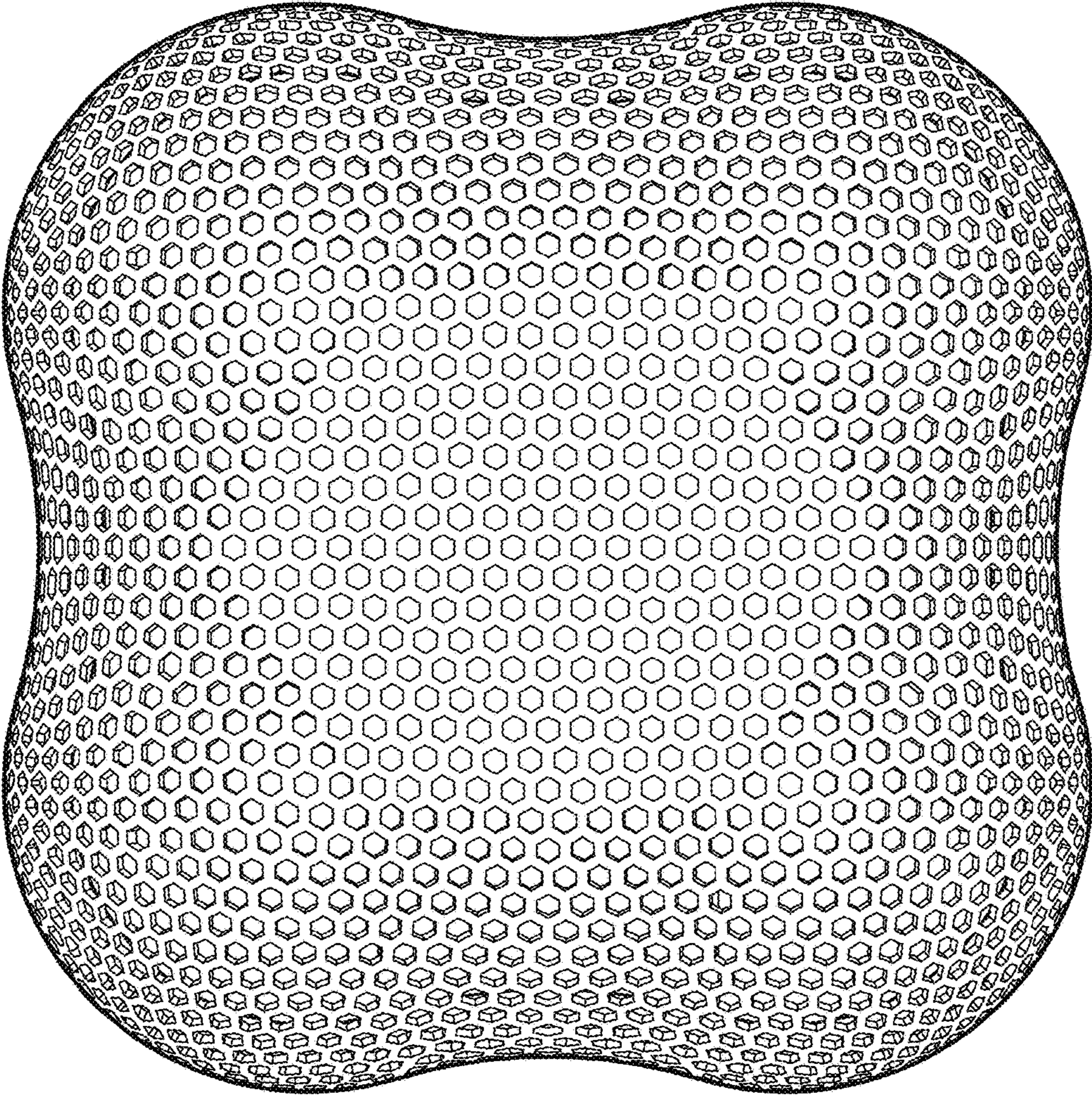

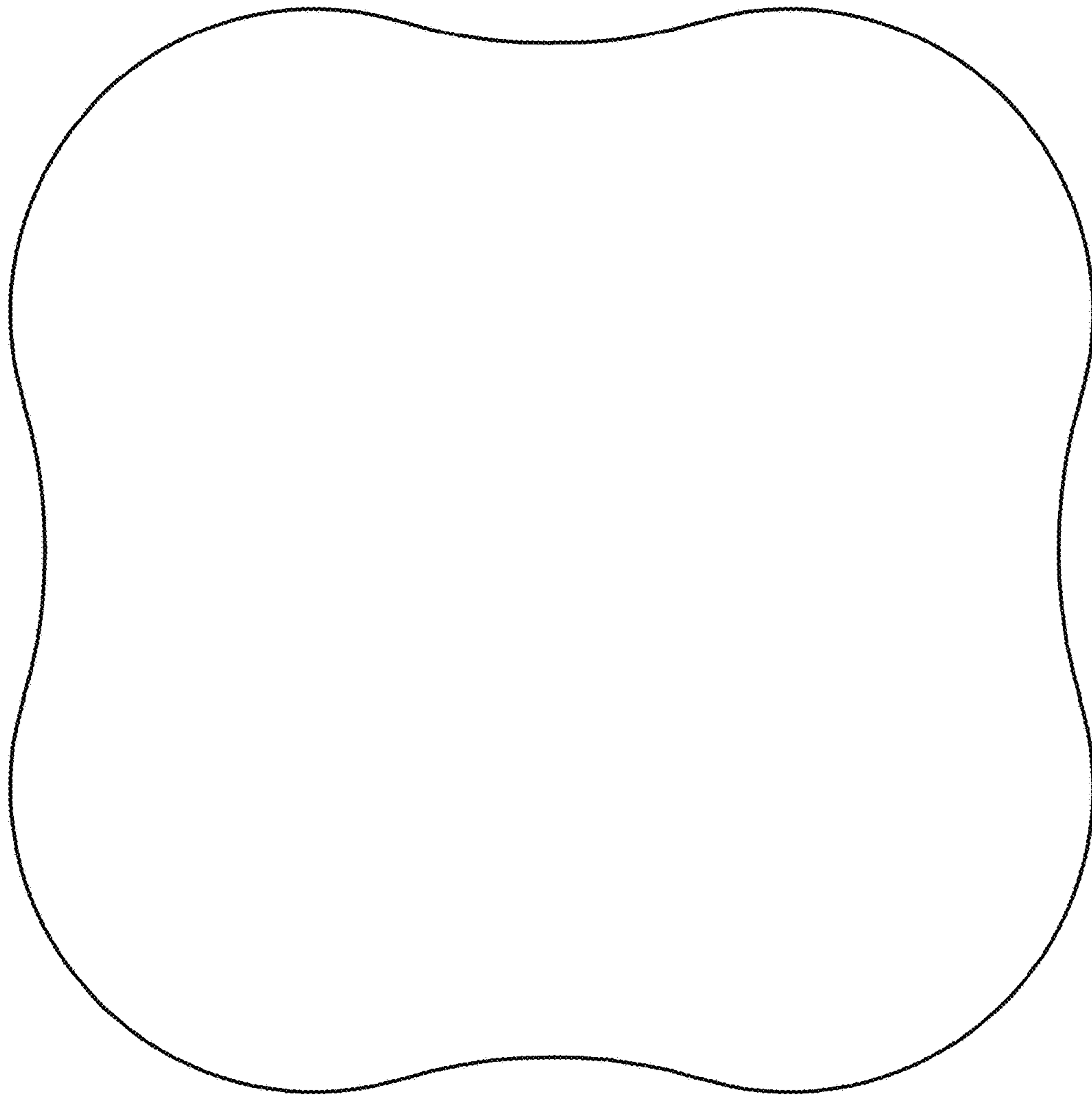
