(57) **CLAIM**

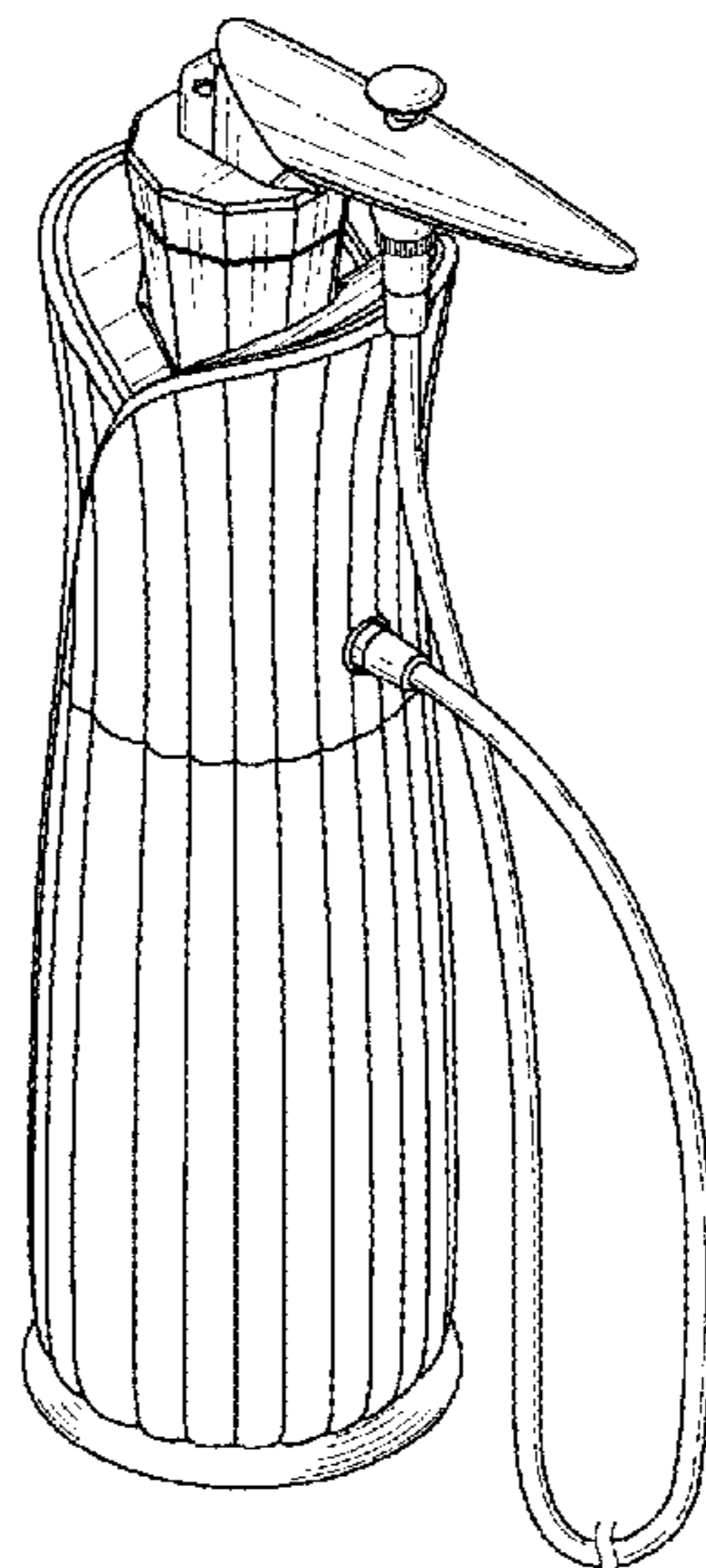
The ornamental design for mist generator for beauty treatment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of mist generator for beauty treatment showing my new design;

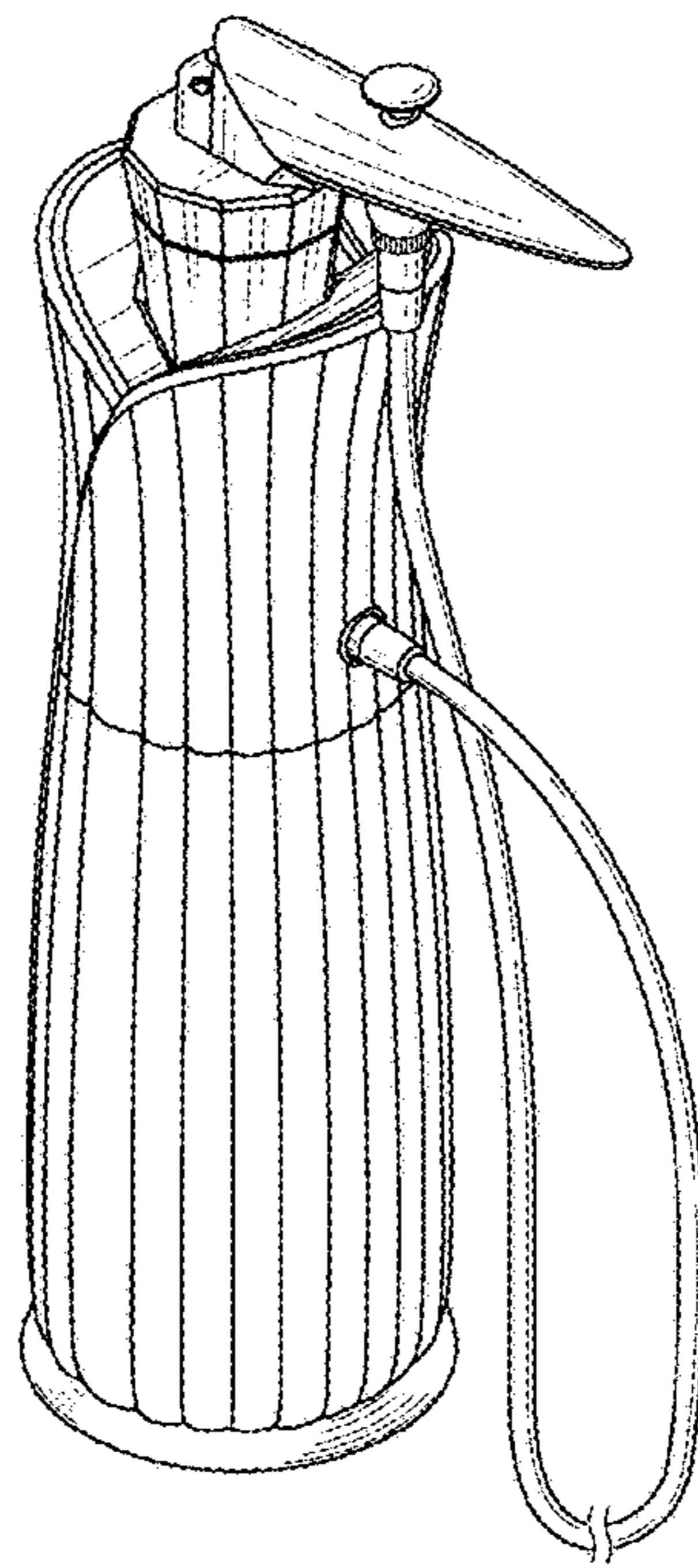

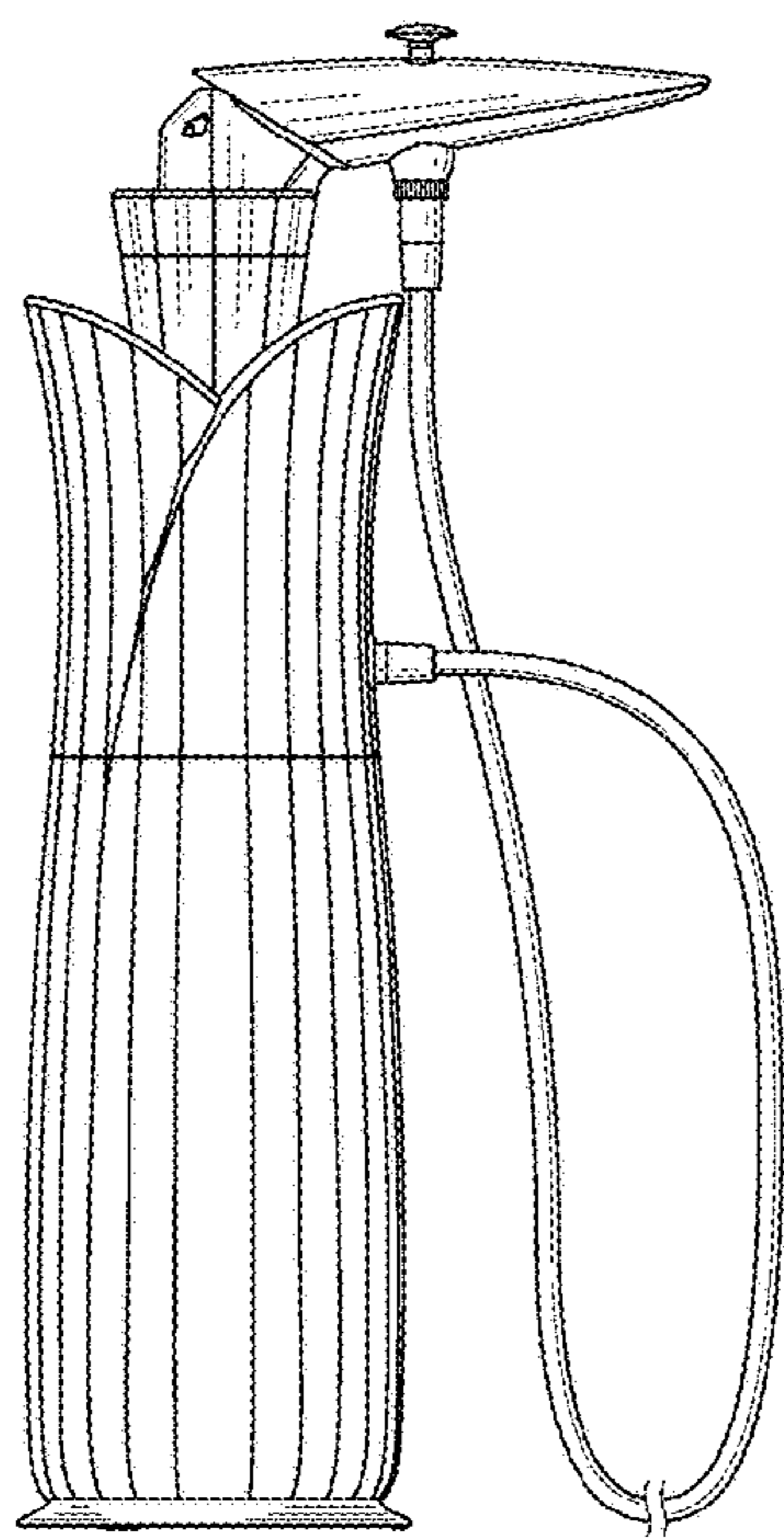

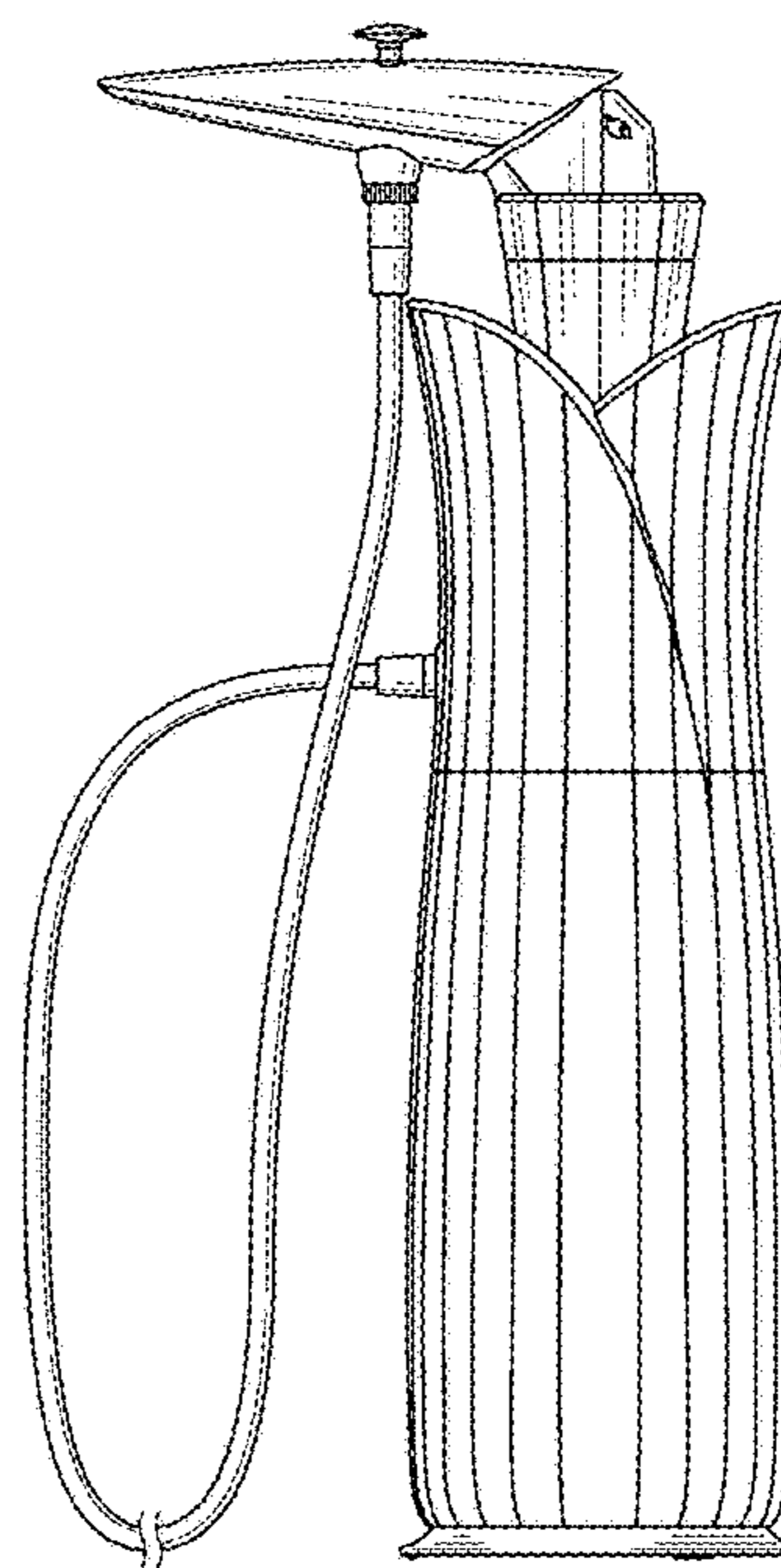

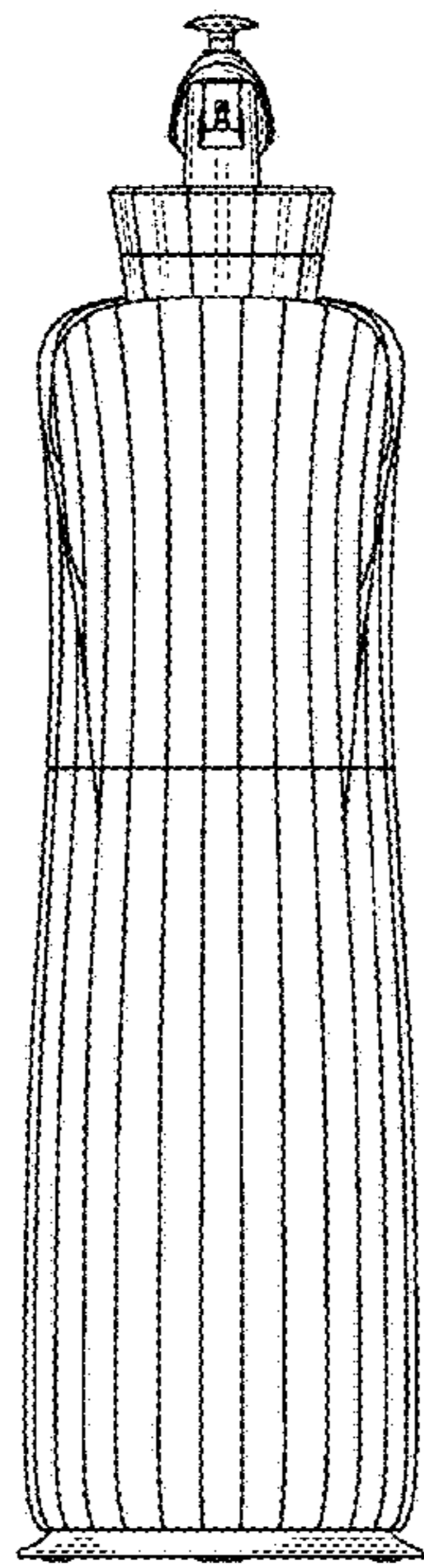

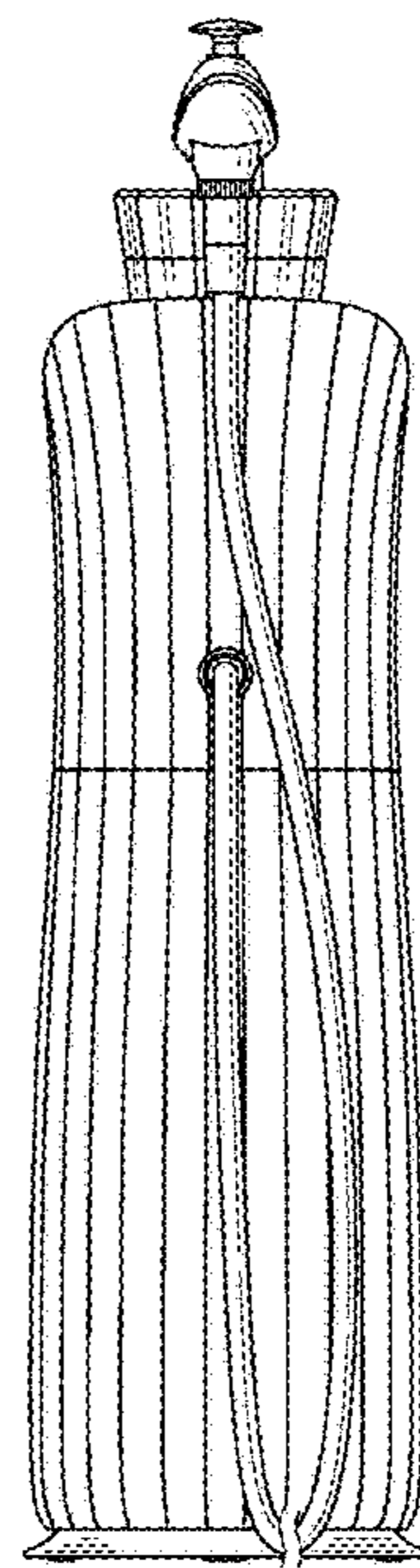

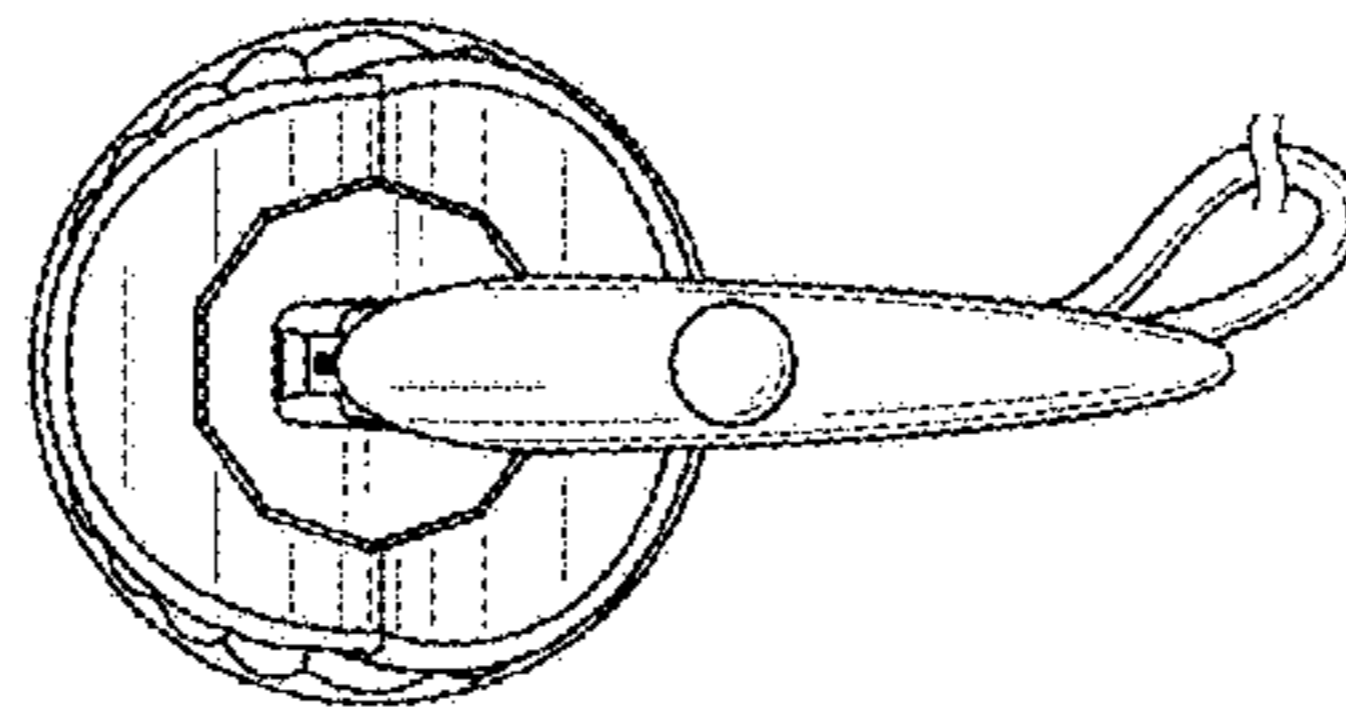

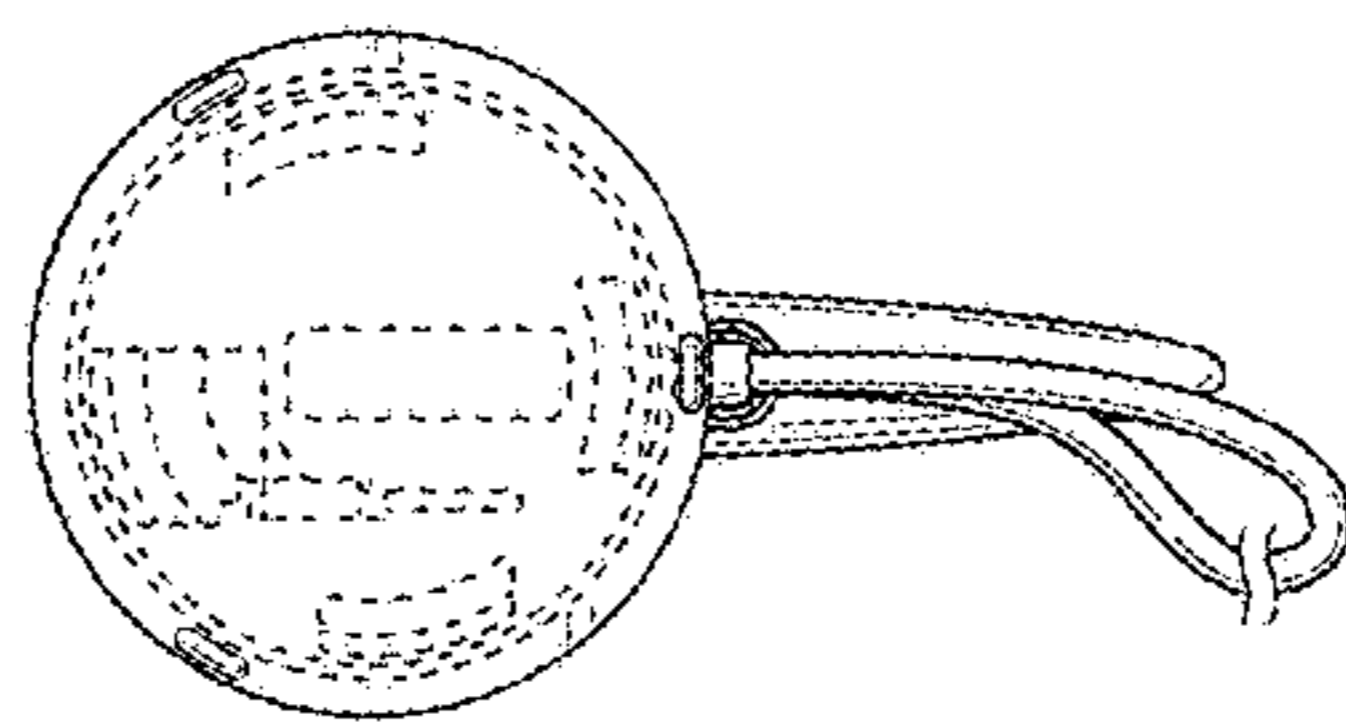

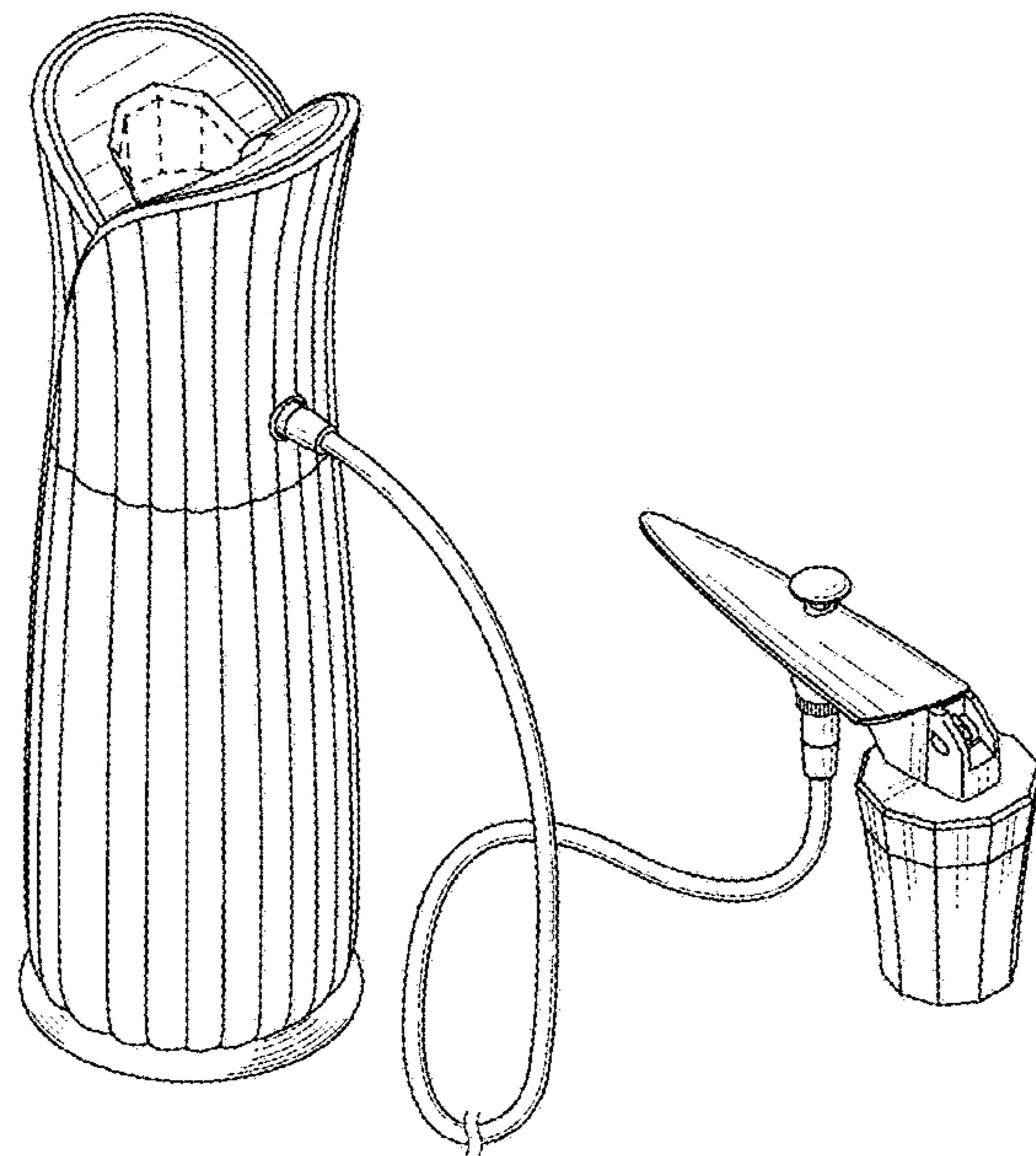

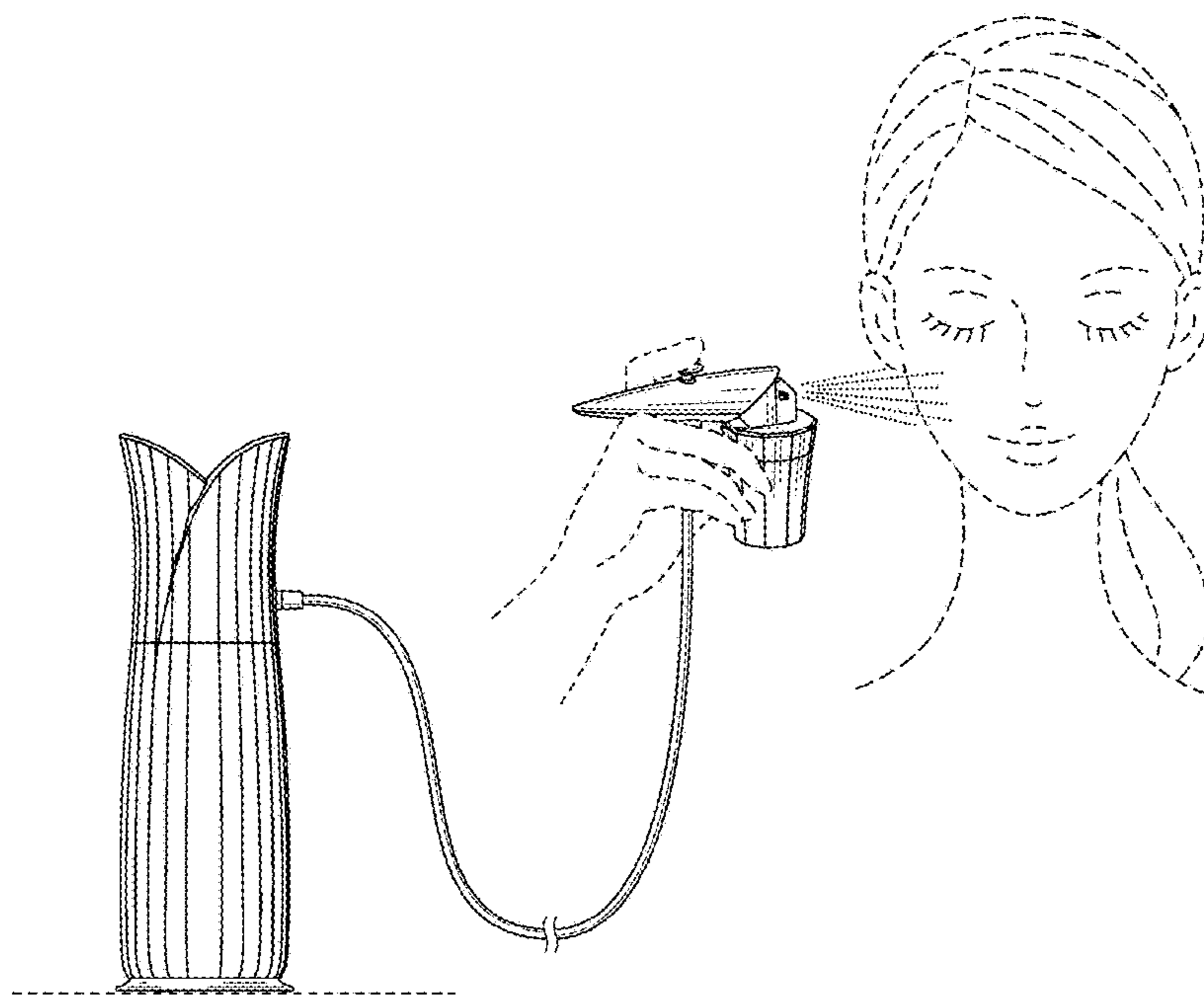
